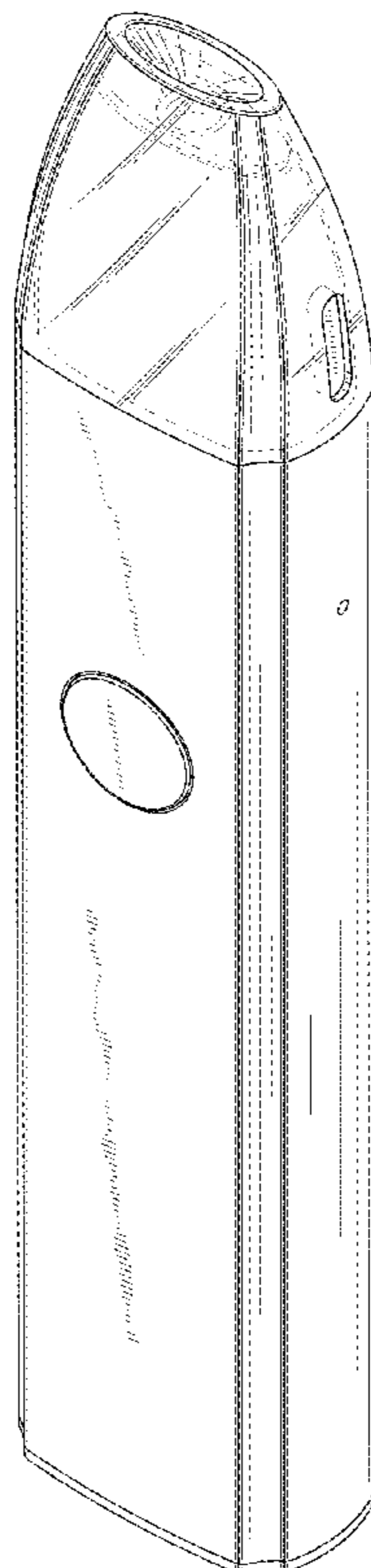

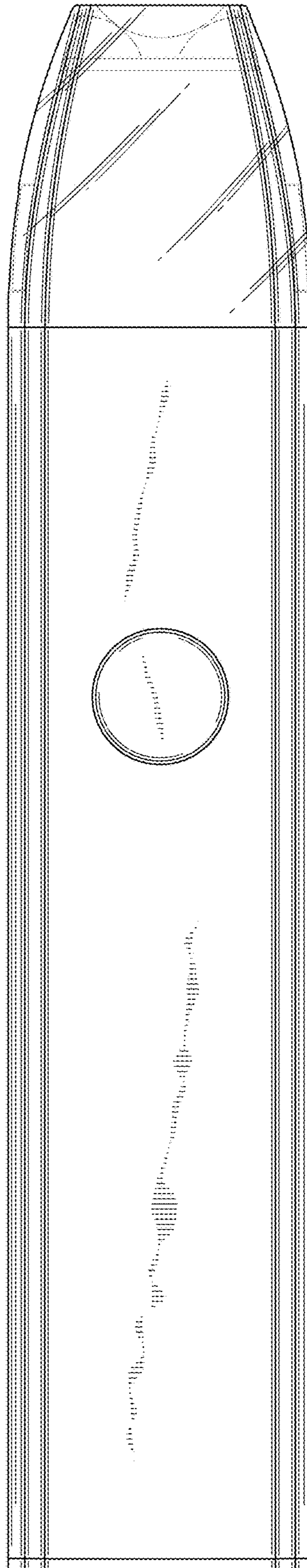
The ornamental design for an electronic cigarette, as shown and described.

**DESCRIPTION**

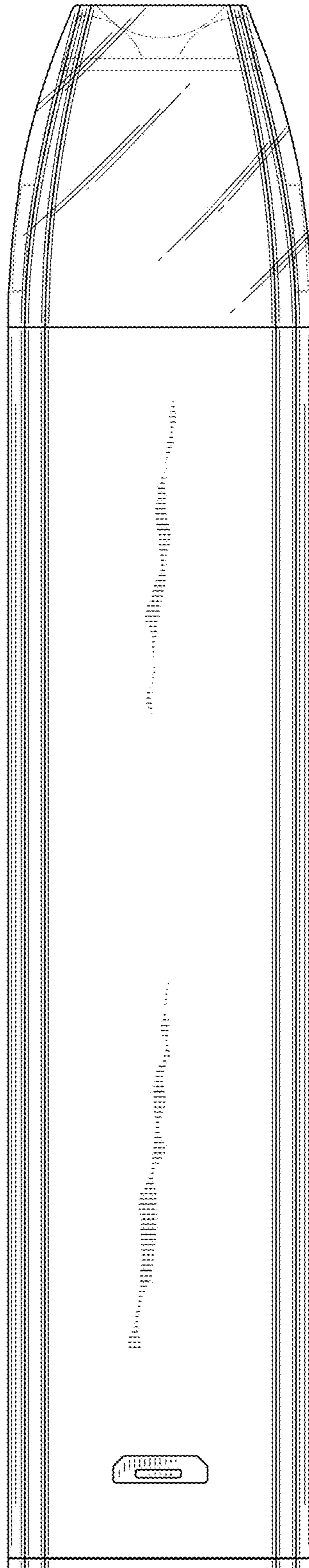
FIG. 1 is a front elevation view of an electronic cigarette;

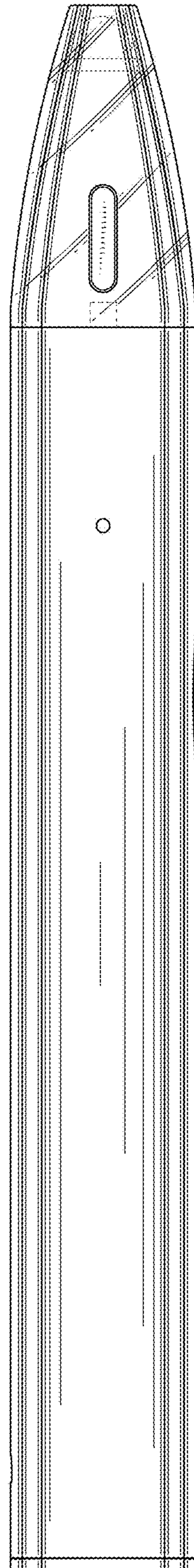

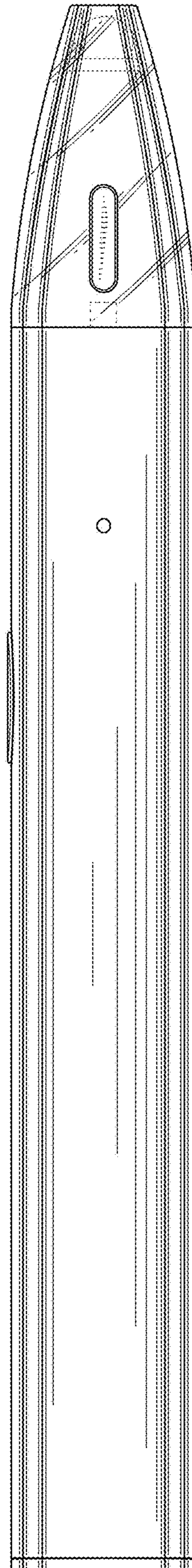

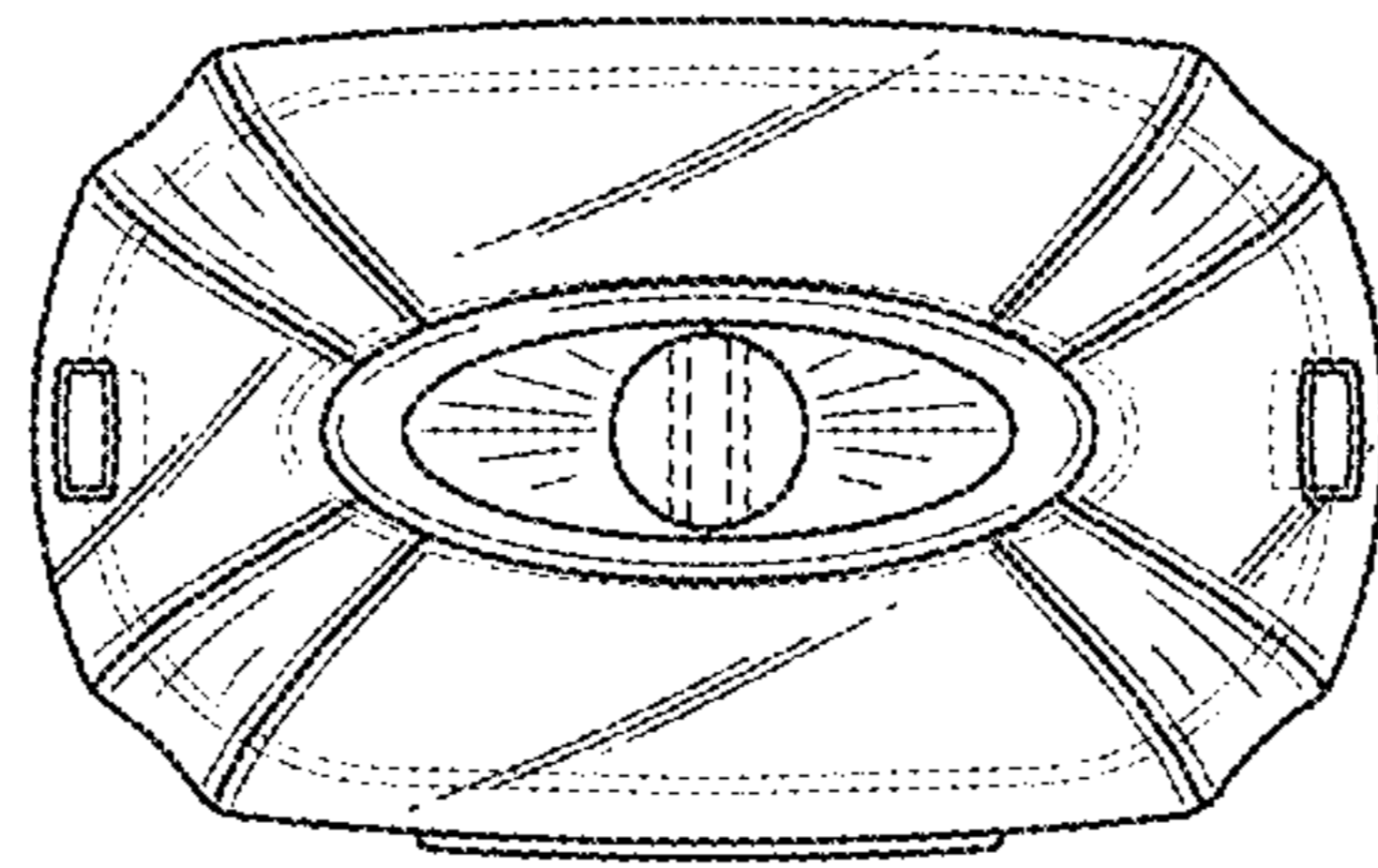




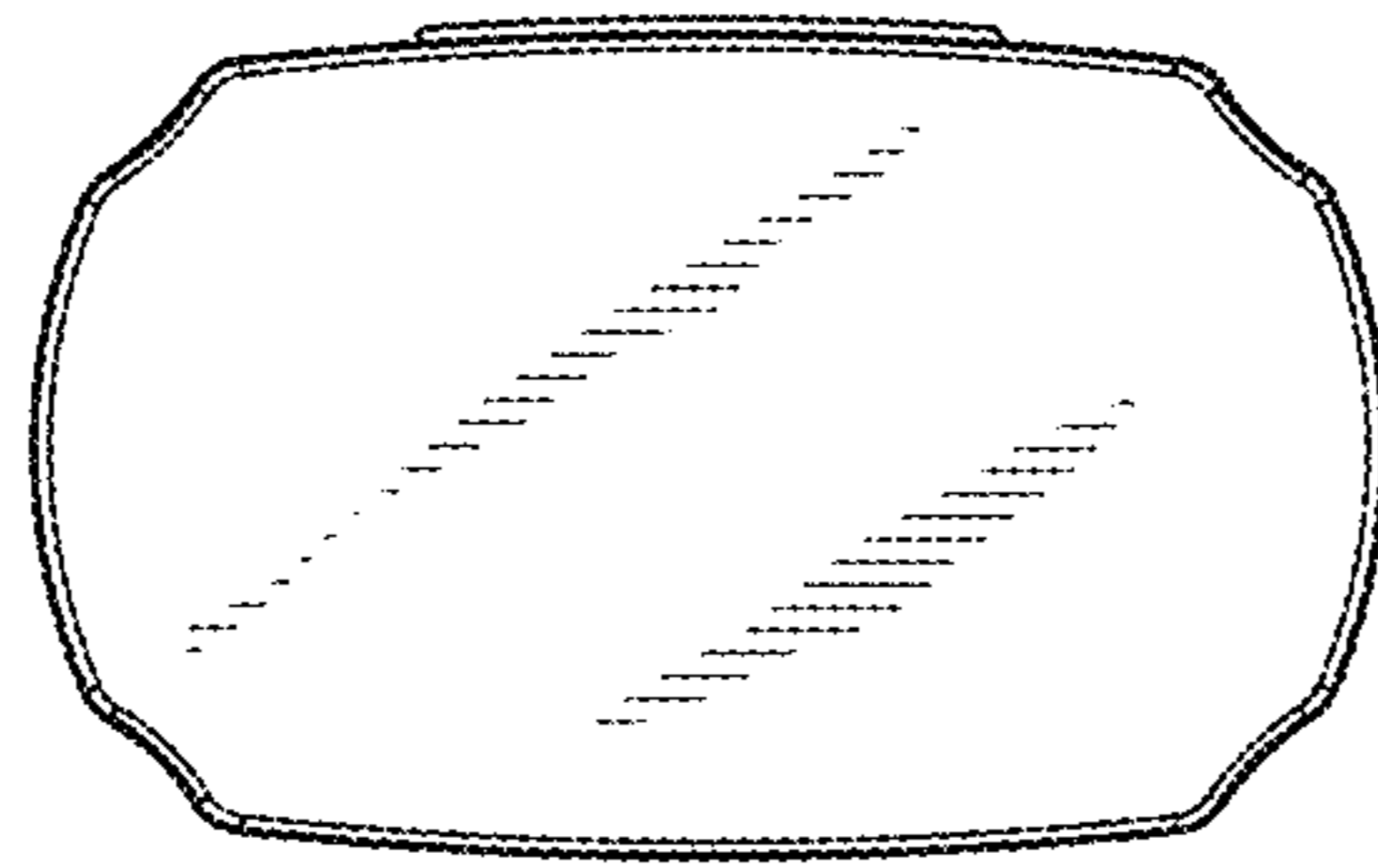

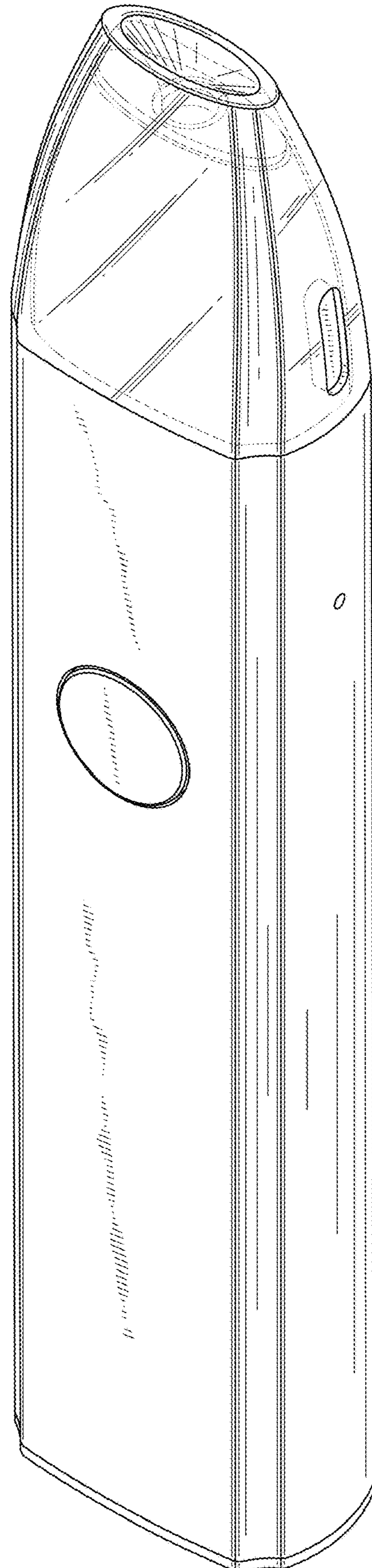

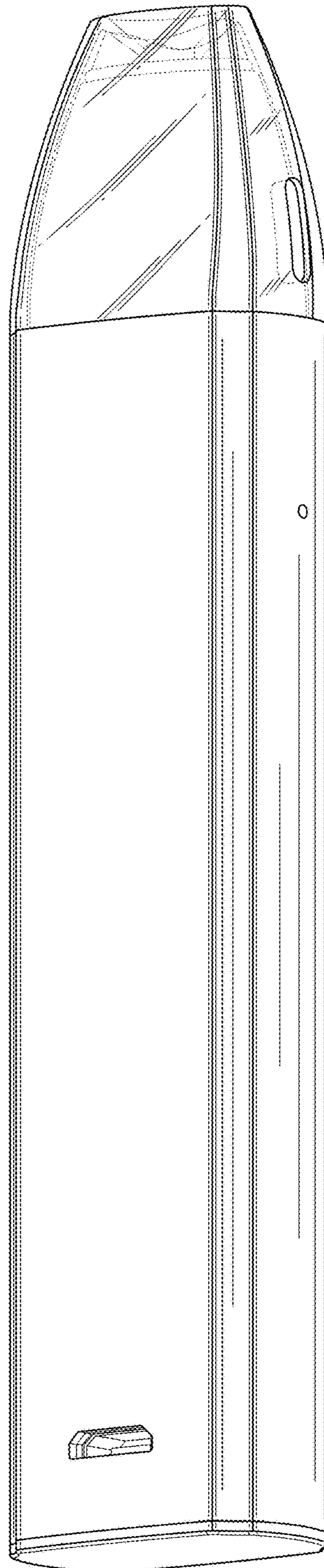
