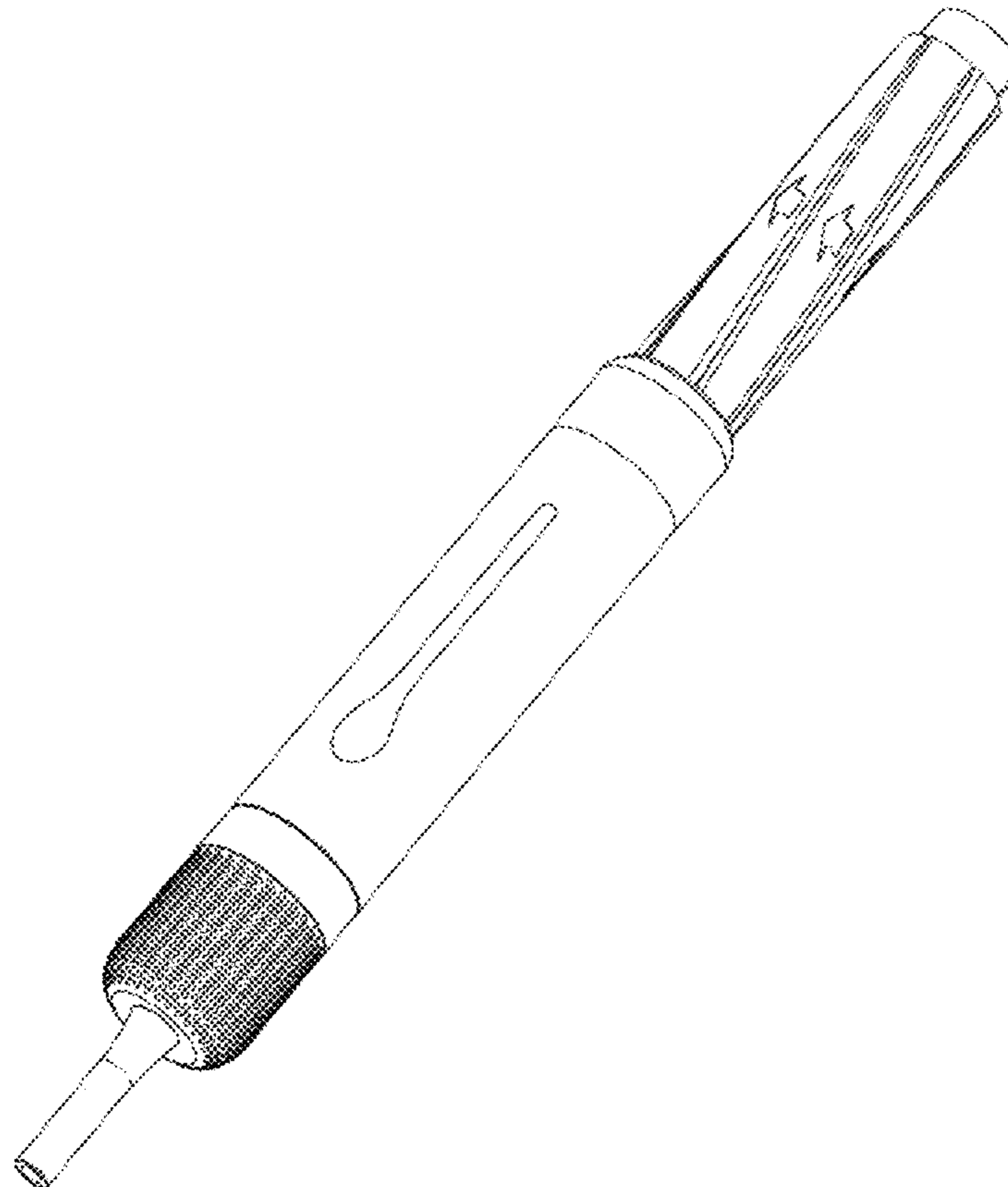
(57) **CLAIM**

The ornamental design for an automatic hair styler, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of an automatic hair styler. FIG. 2 is an enlarged top plan view of the automatic hair styler. FIG. 3 is a right elevation view of the automatic hair styler. FIG. 4 is a front-right perspective view of the automatic hair styler. FIG. 5 is a front perspective view of the automatic hair styler. FIG. 6 is a left elevation view of the automatic hair styler. FIG. 7 is an enlarged bottom plan view of the automatic hair styler; and, FIG. 8 is a back elevation view of the automatic hair styler.

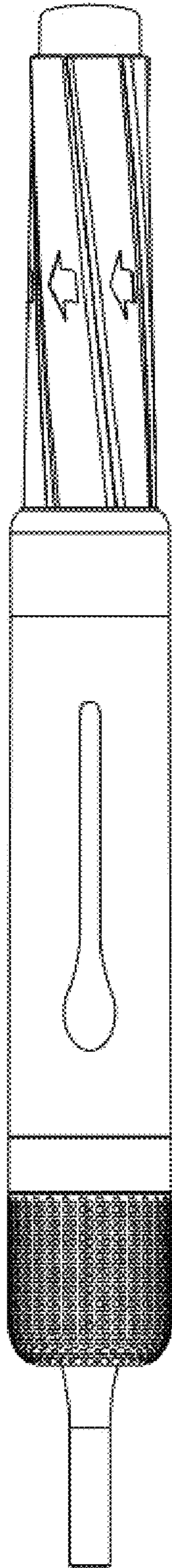

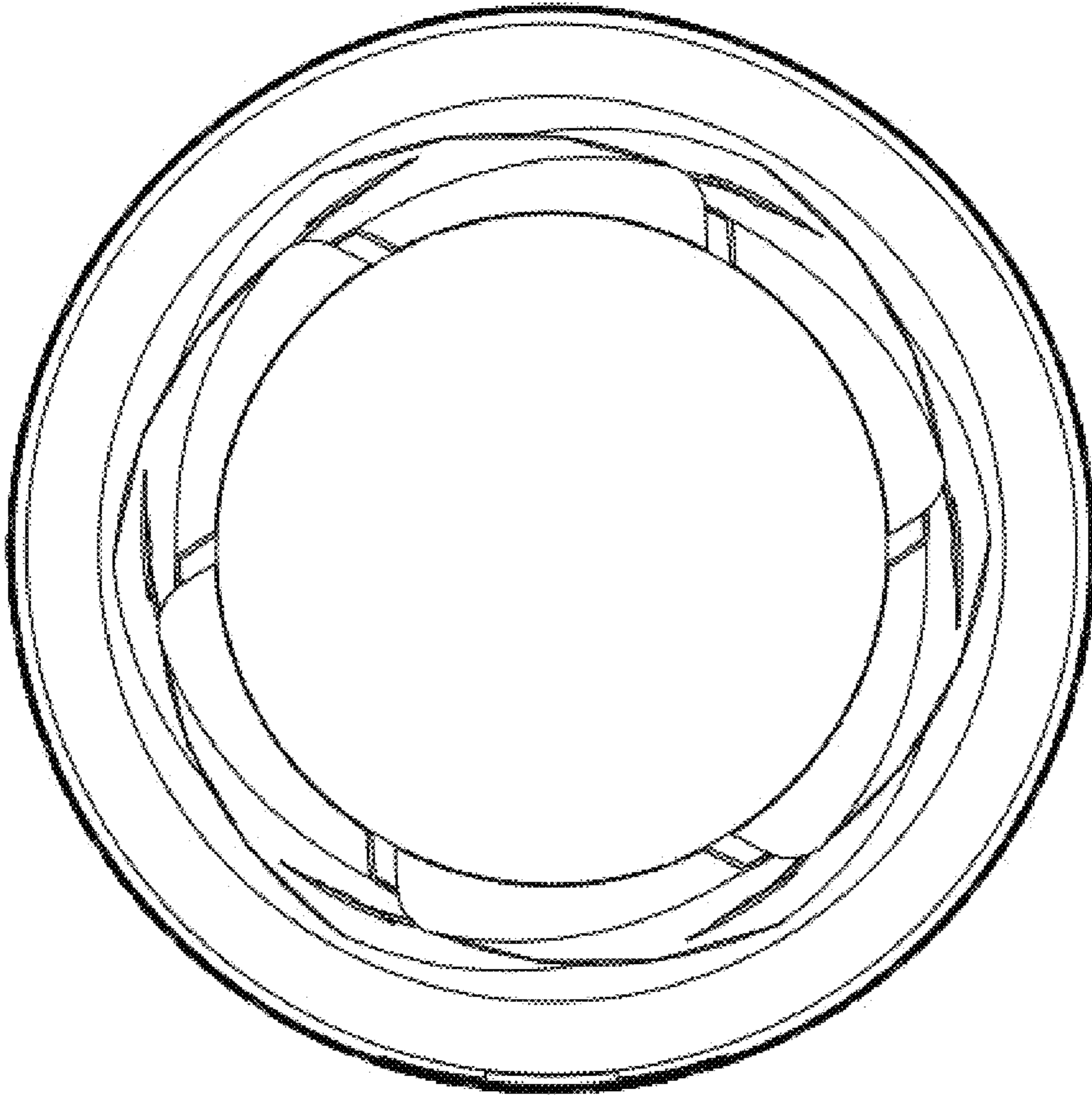

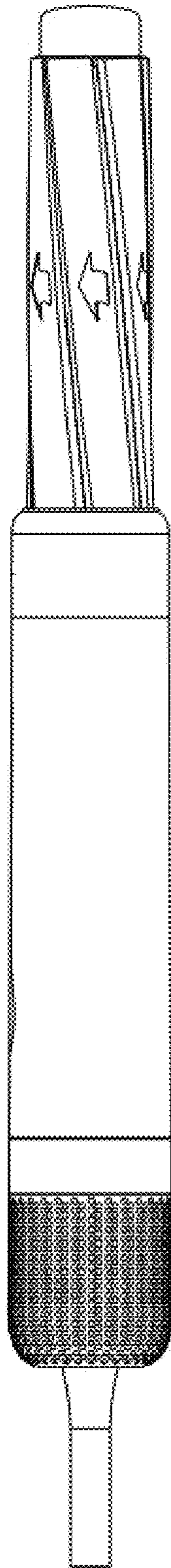

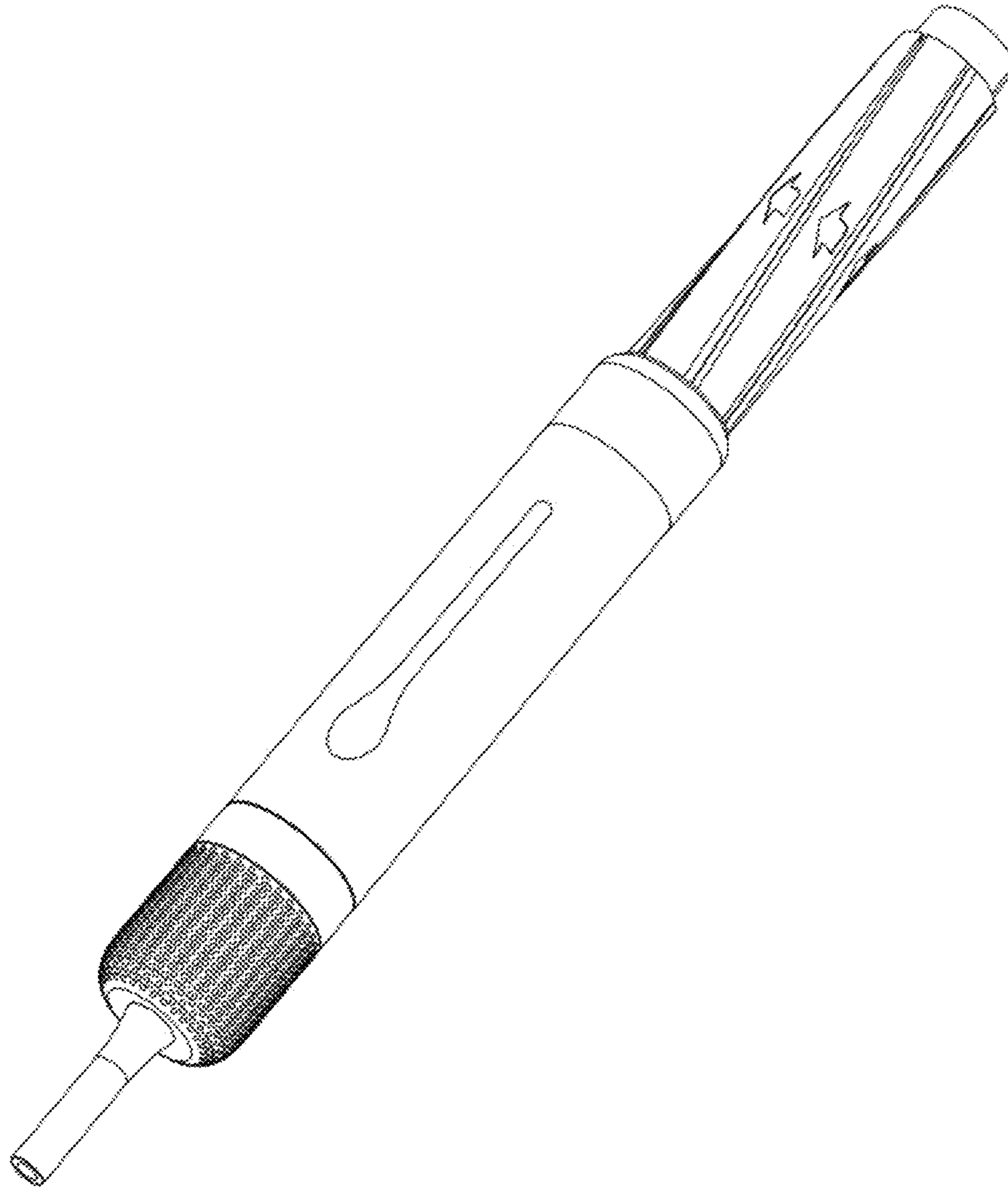

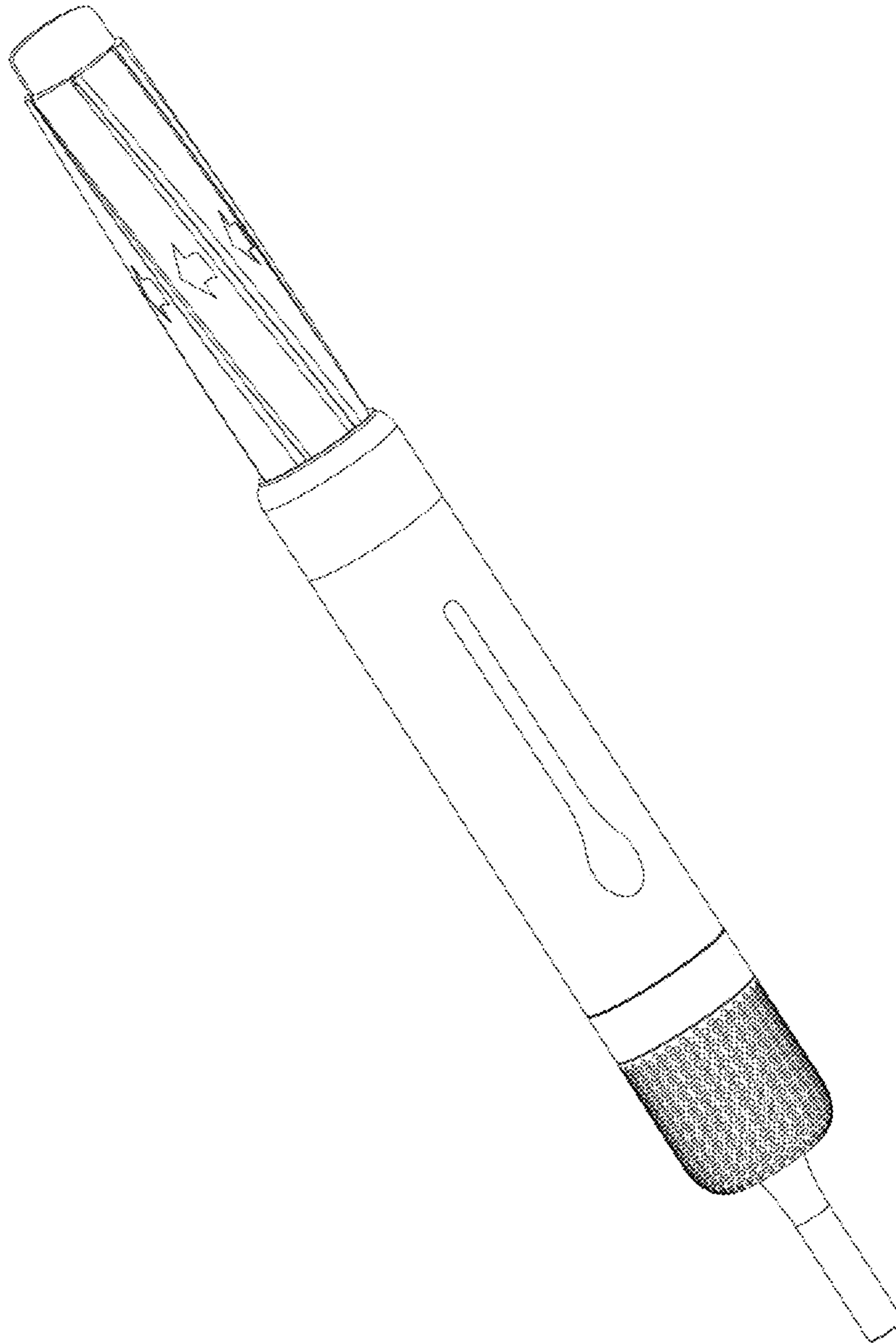

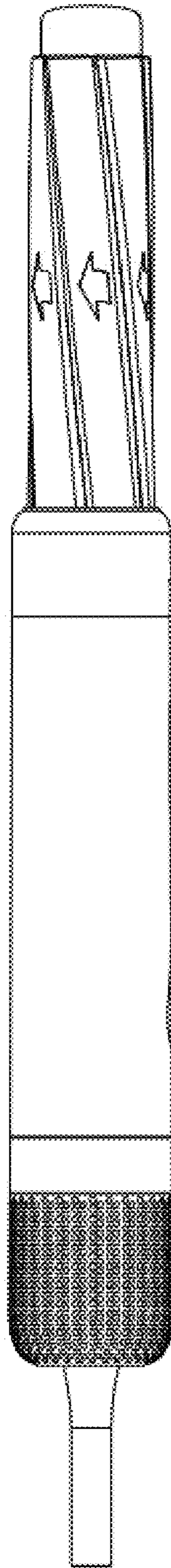

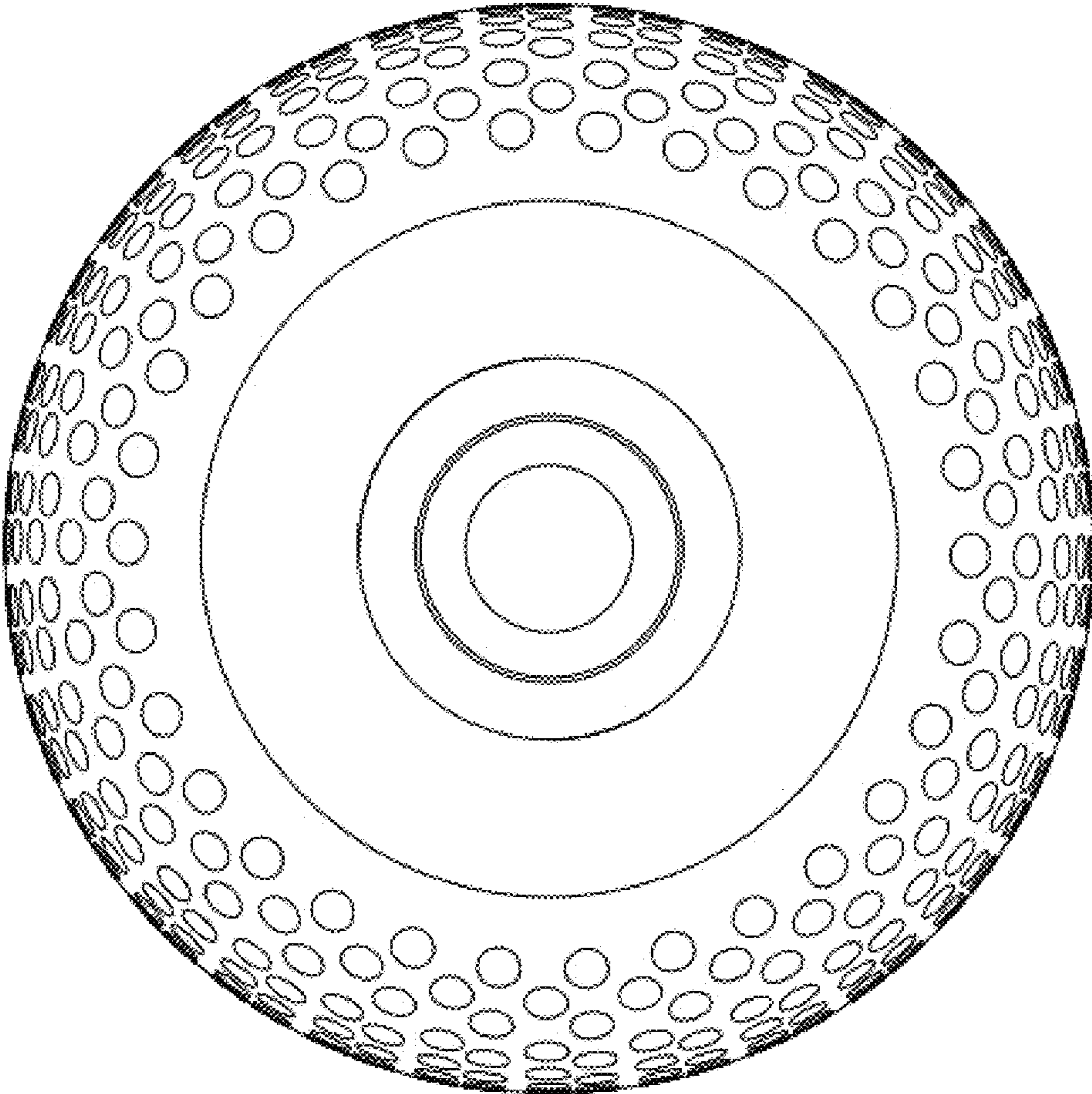

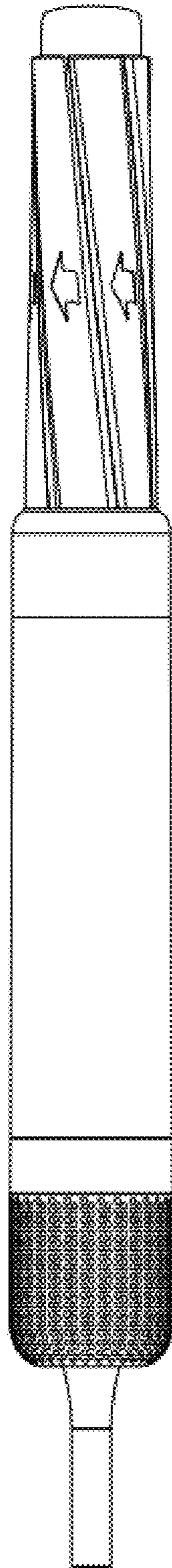
