(57) **CLAIM**

The ornamental design for a dog kennel mat, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a dog kennel mat showing my new design.

FIG. 2 is a bottom plan view of the dog kennel mat.

FIG. 3 is a back elevational view of the dog kennel mat.

FIG. 4 is a front elevational view of the dog kennel mat.

FIG. 5 is a left side elevational view of the dog kennel mat.

FIG. 6 is a right side elevational view of the dog kennel mat.

FIG. 7 is a cross-sectional front view of the dog kennel mat taken from the line 7-7 in FIG. 1.

FIG. 8 is a top, front perspective view of the dog kennel mat; and,

FIG. 9 is a bottom, front perspective view of the dog kennel mat.

The broken lines in the drawings are for the purposes of depicting parts of the dog kennel mat that form no part of the claimed design.

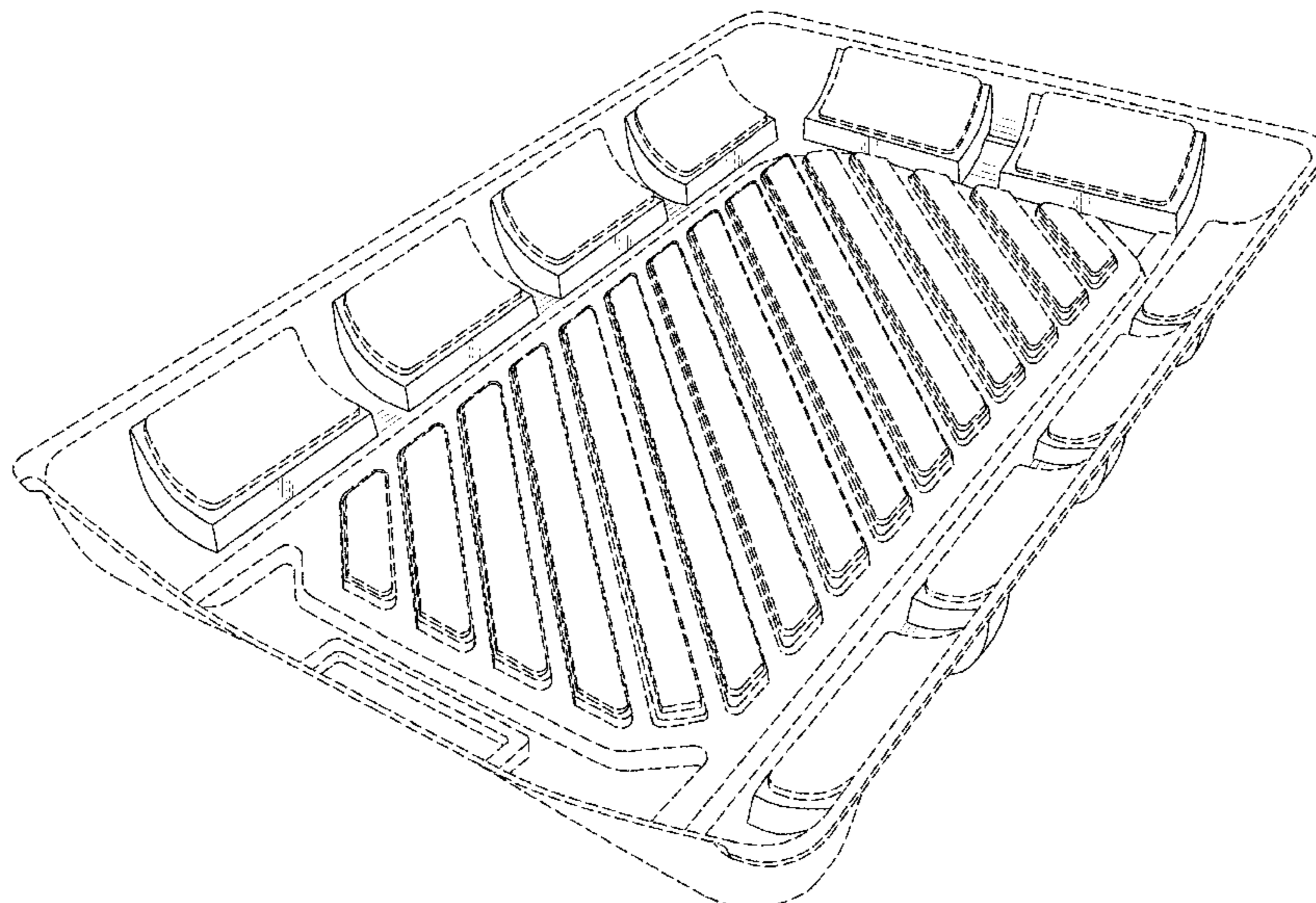

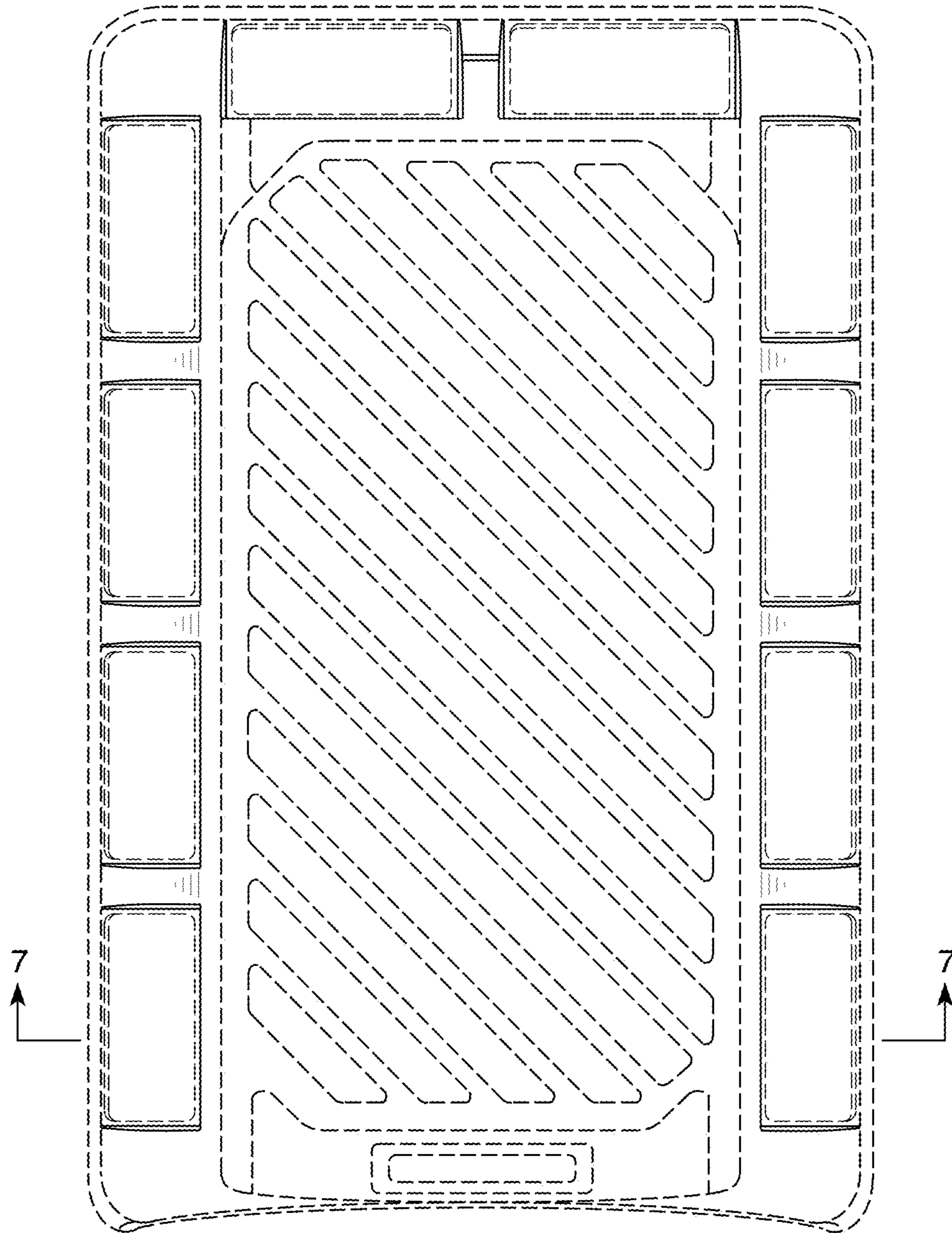

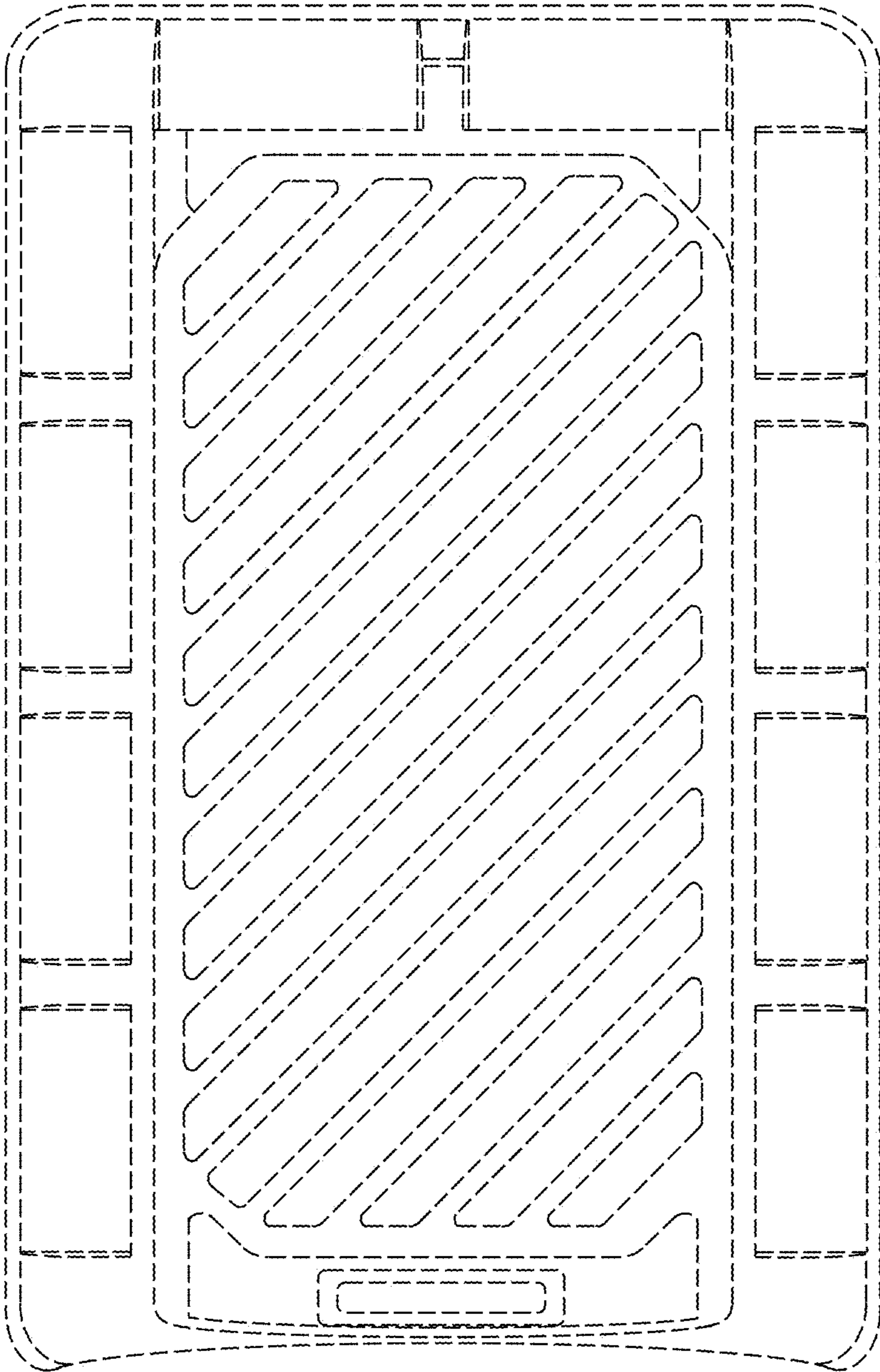

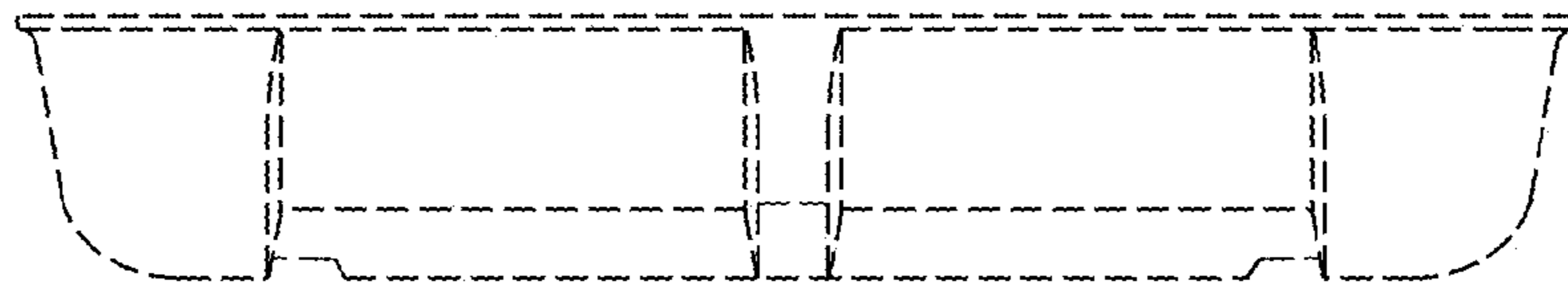

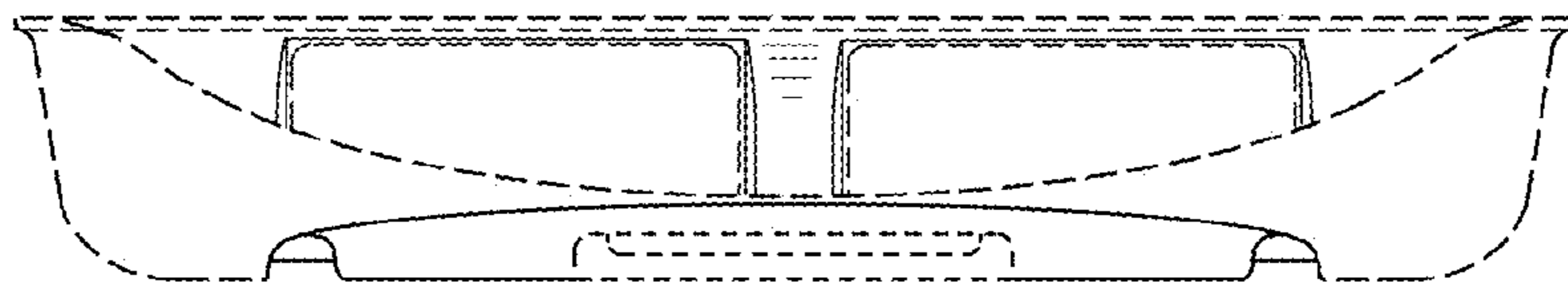

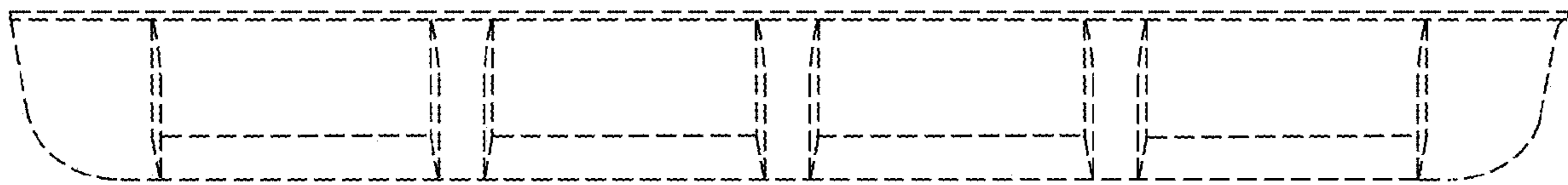

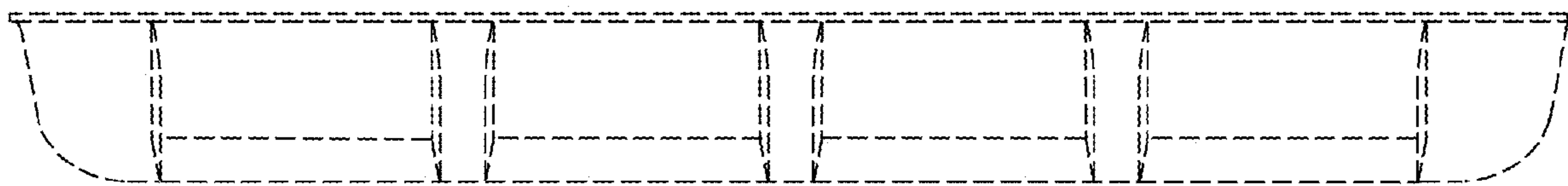

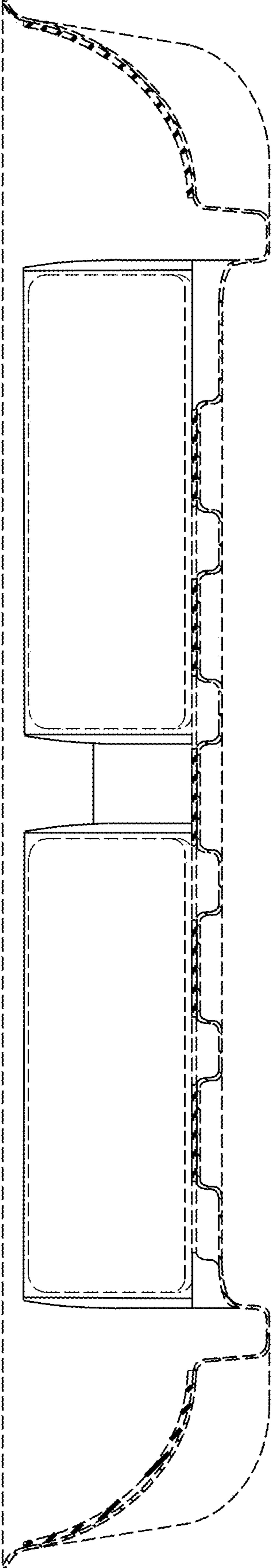

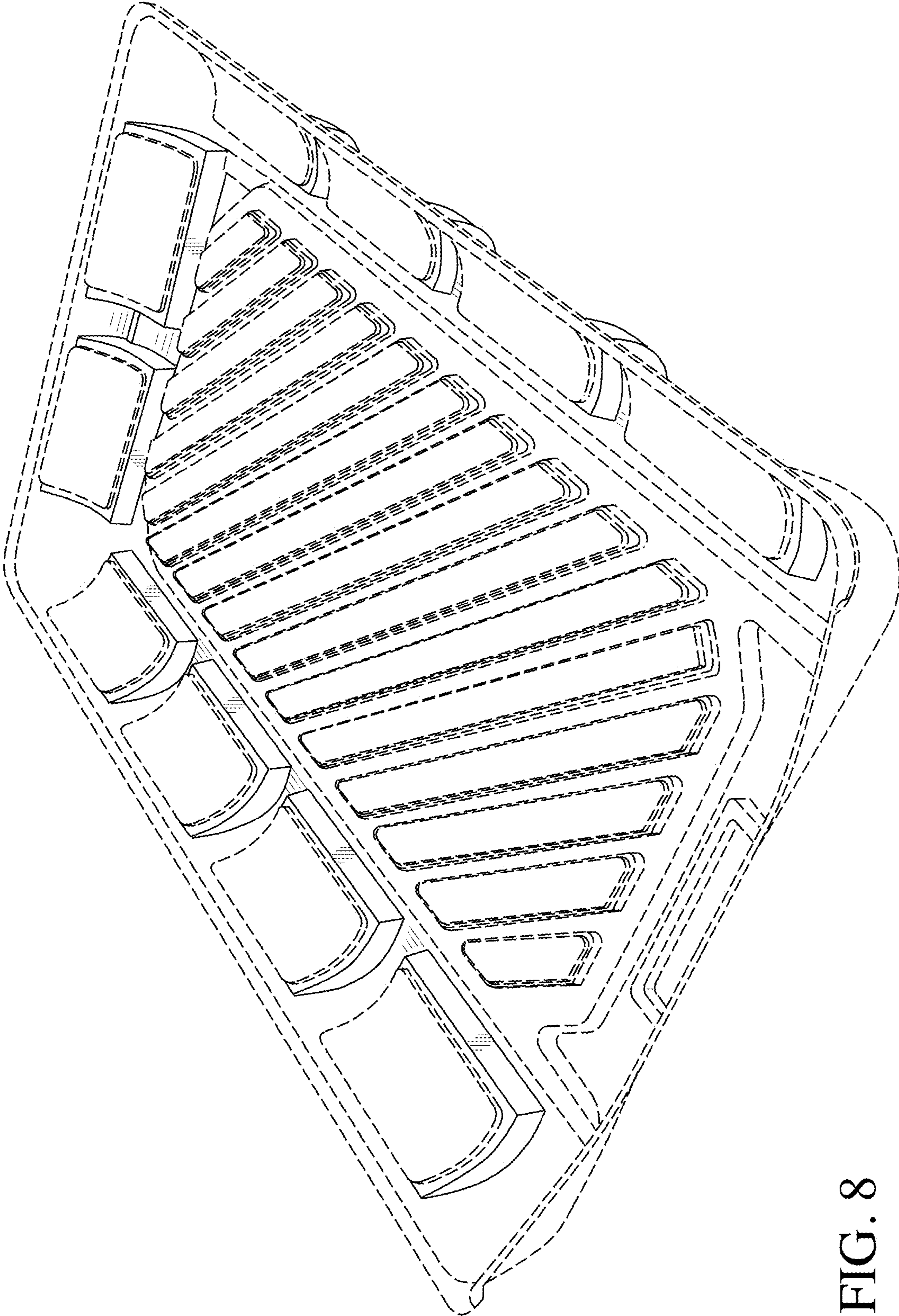

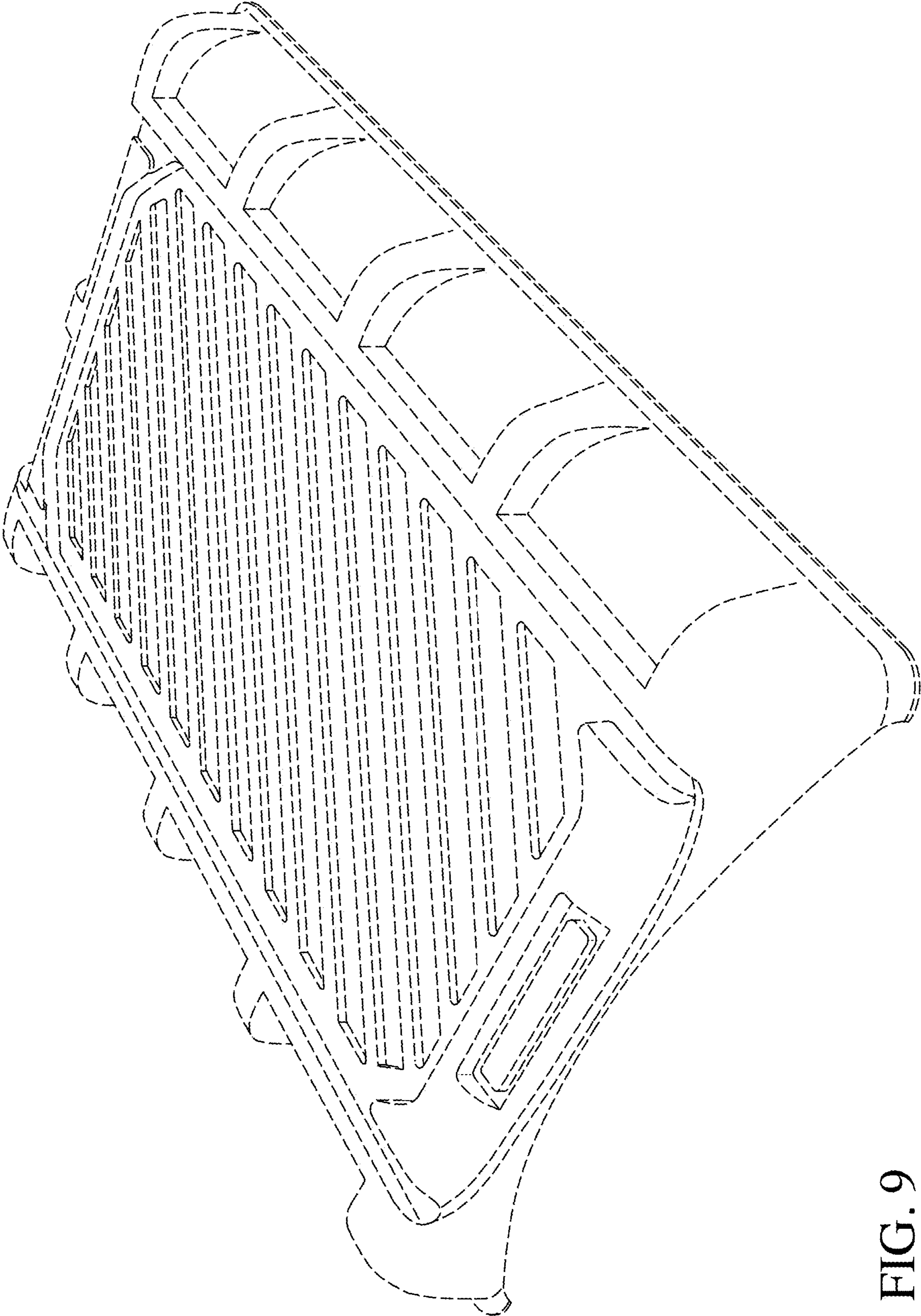
