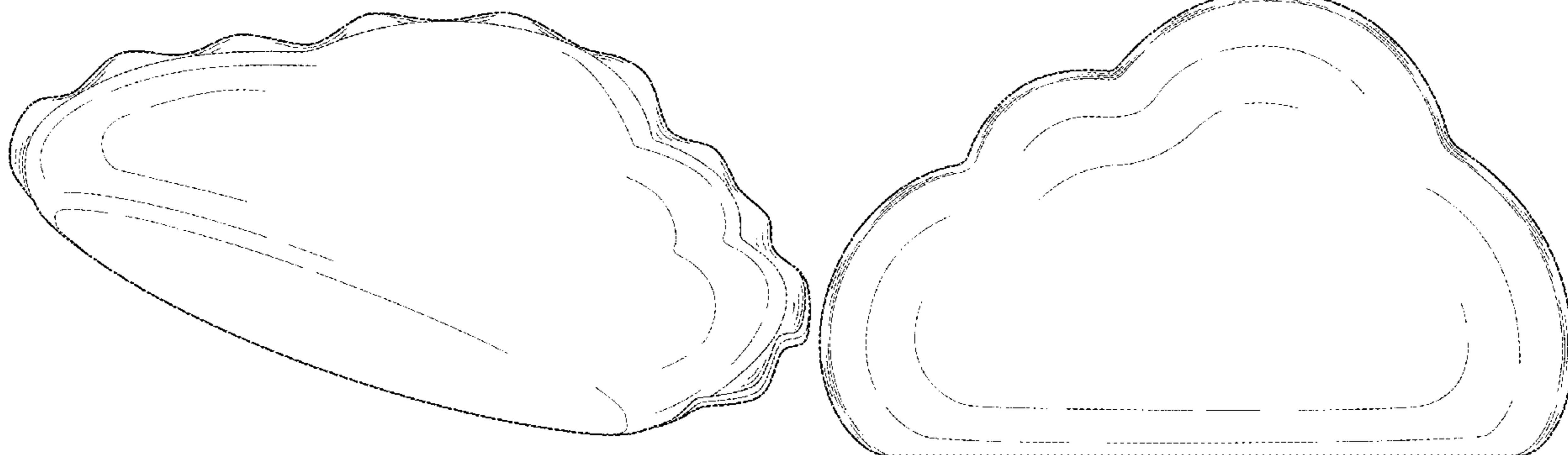
(57) **CLAIM**

The ornamental design for a sandwich, as shown and described.

DESCRIPTION

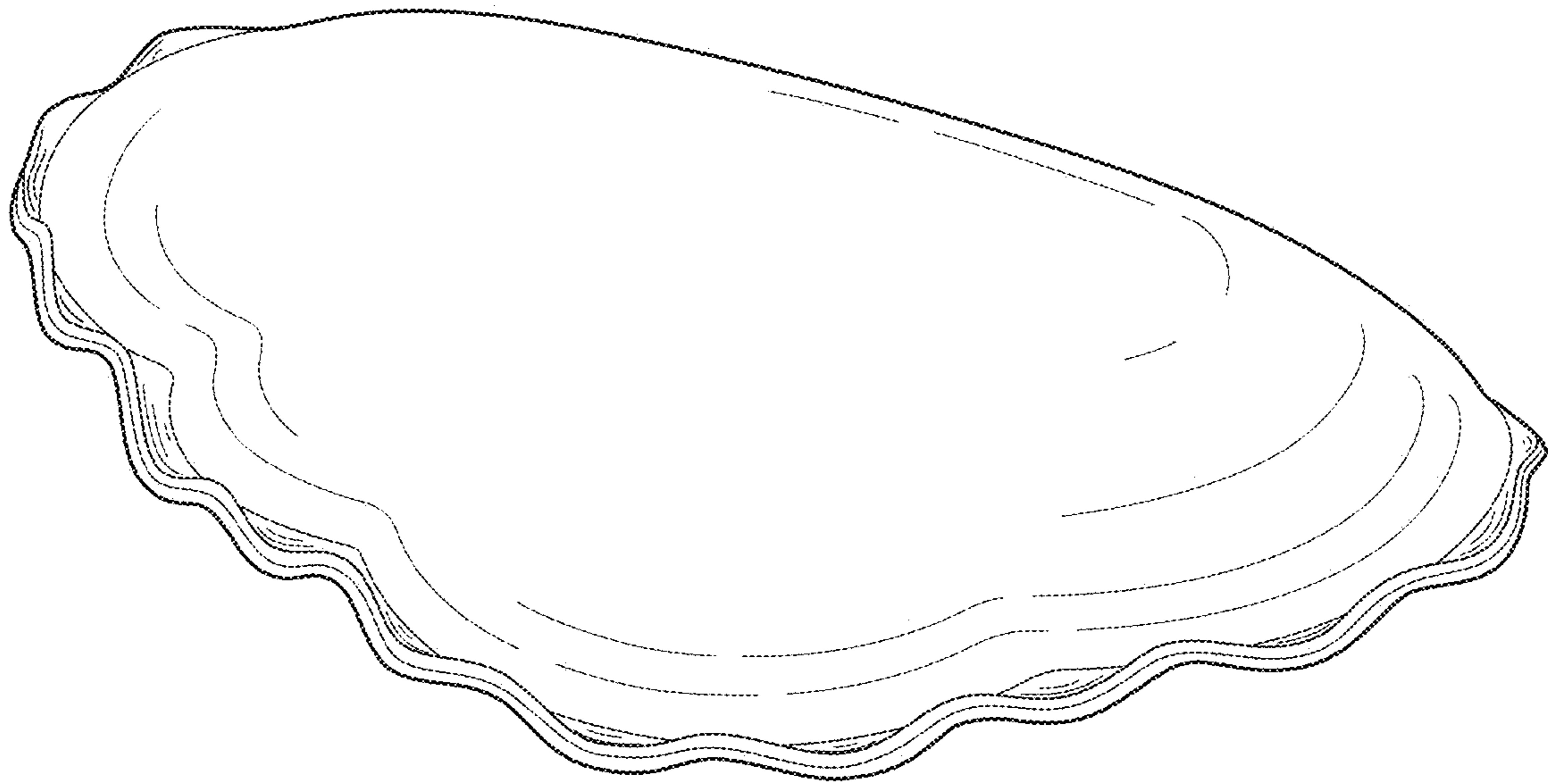

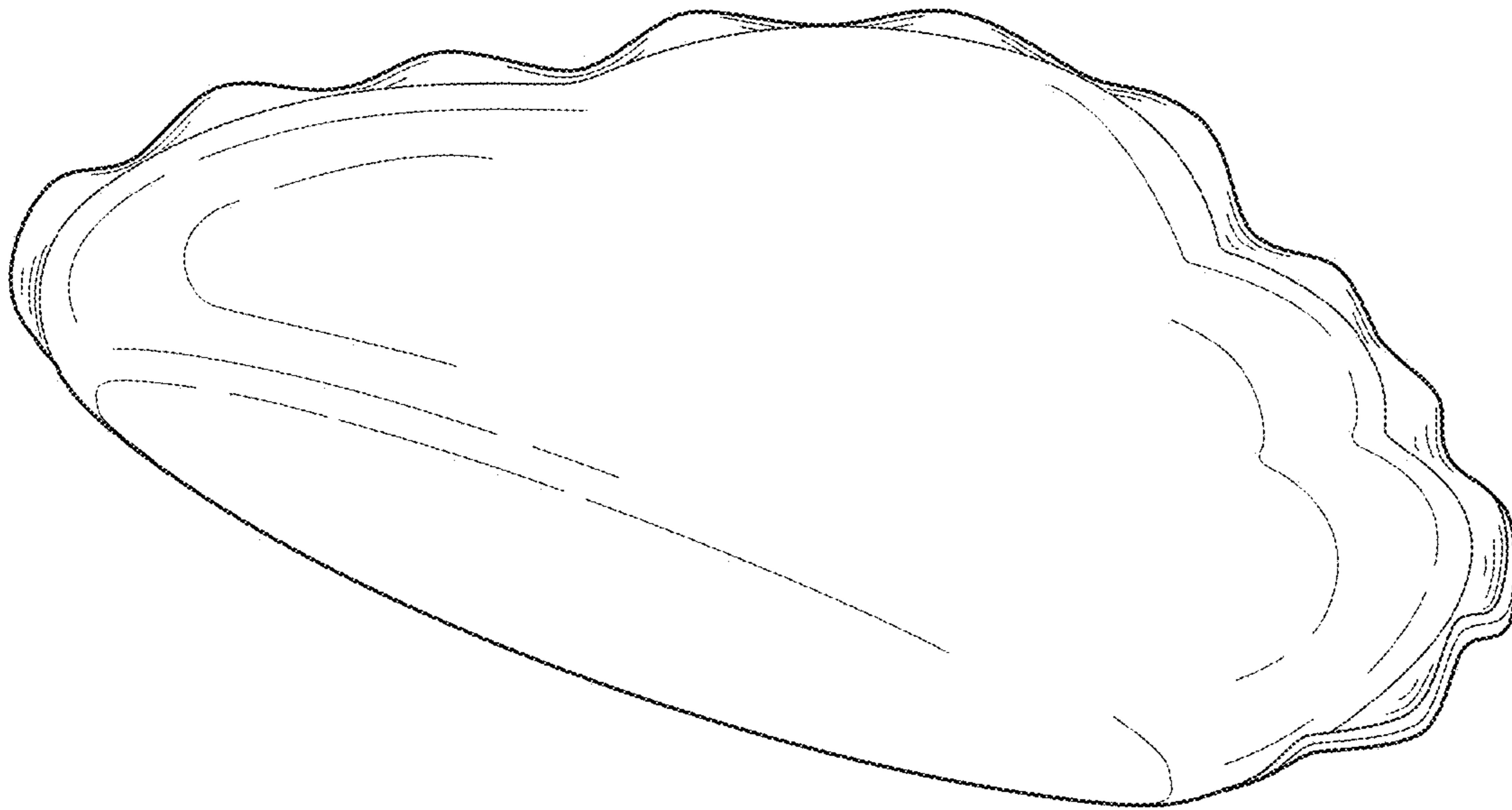

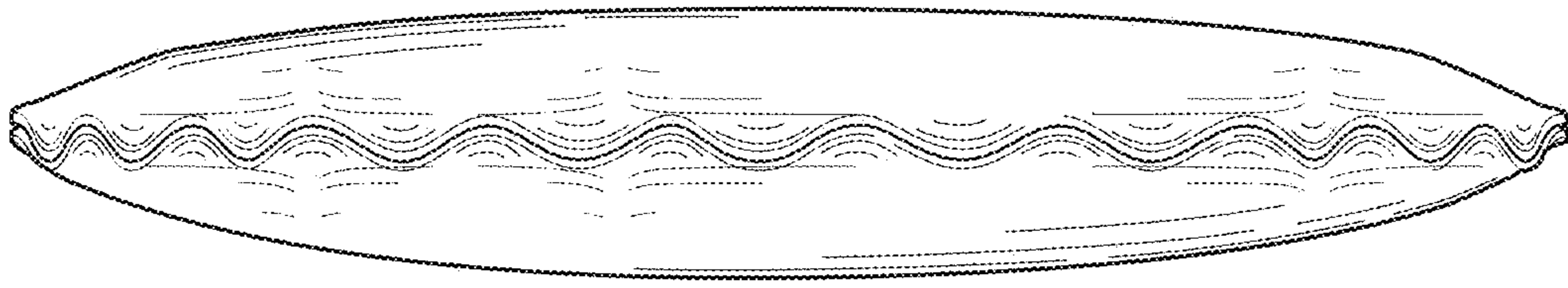

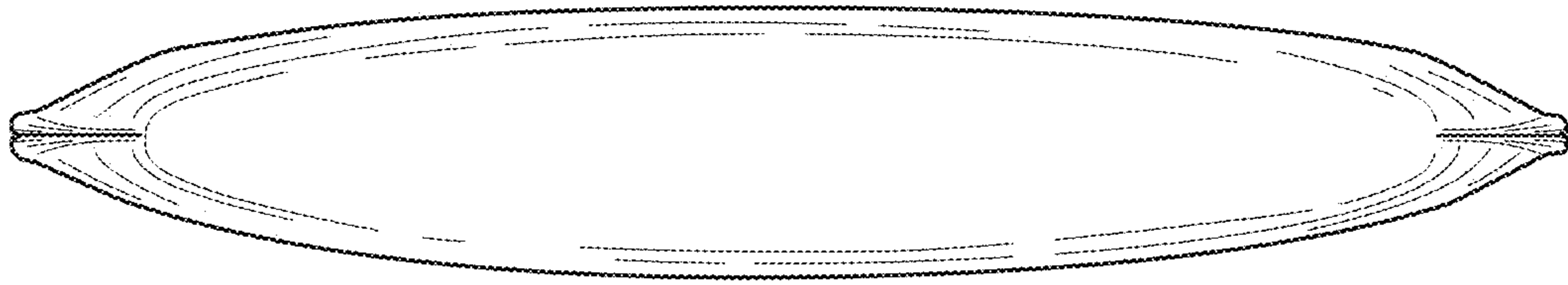

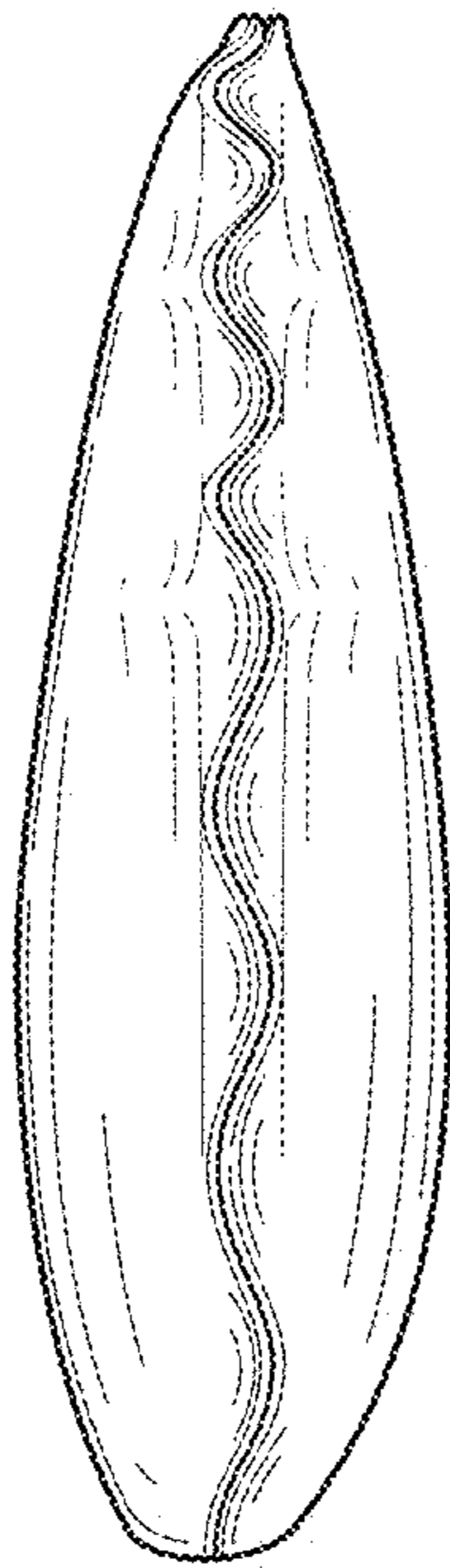

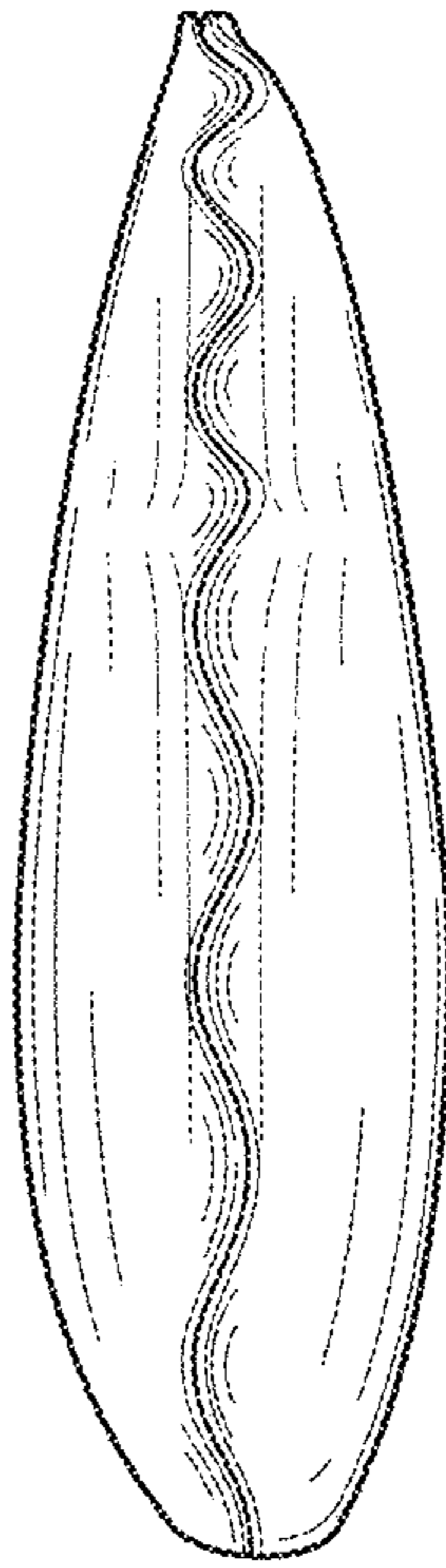

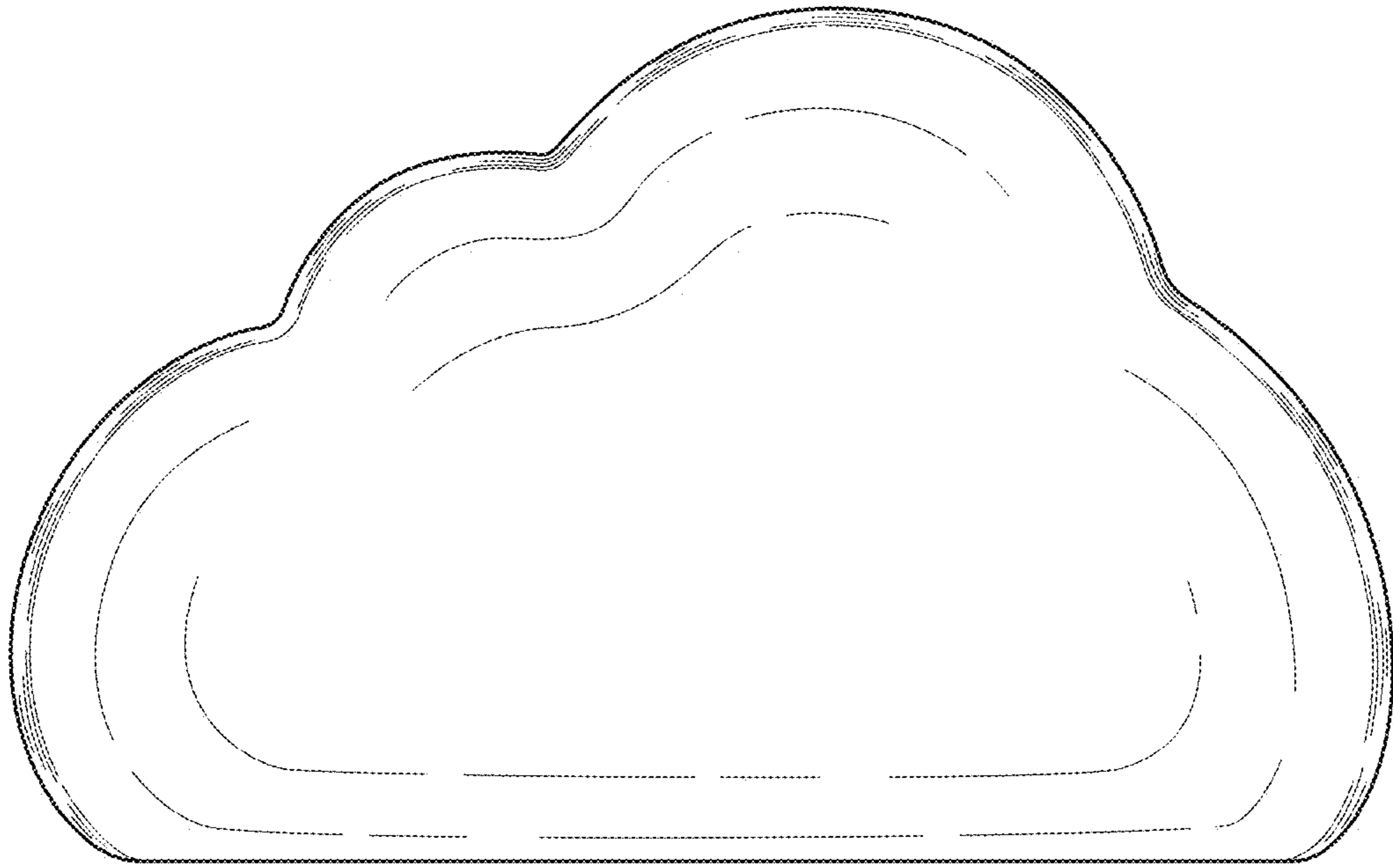

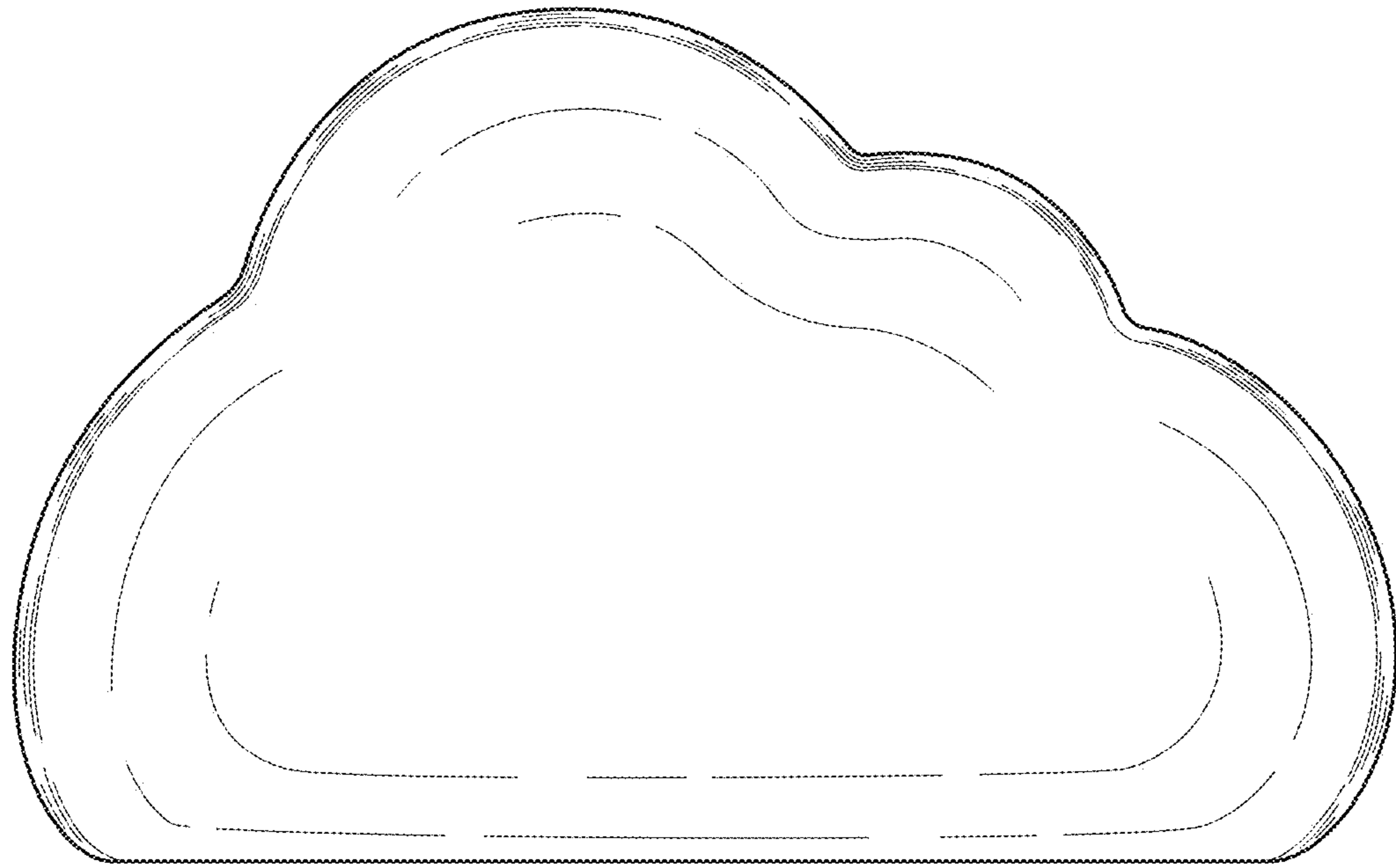

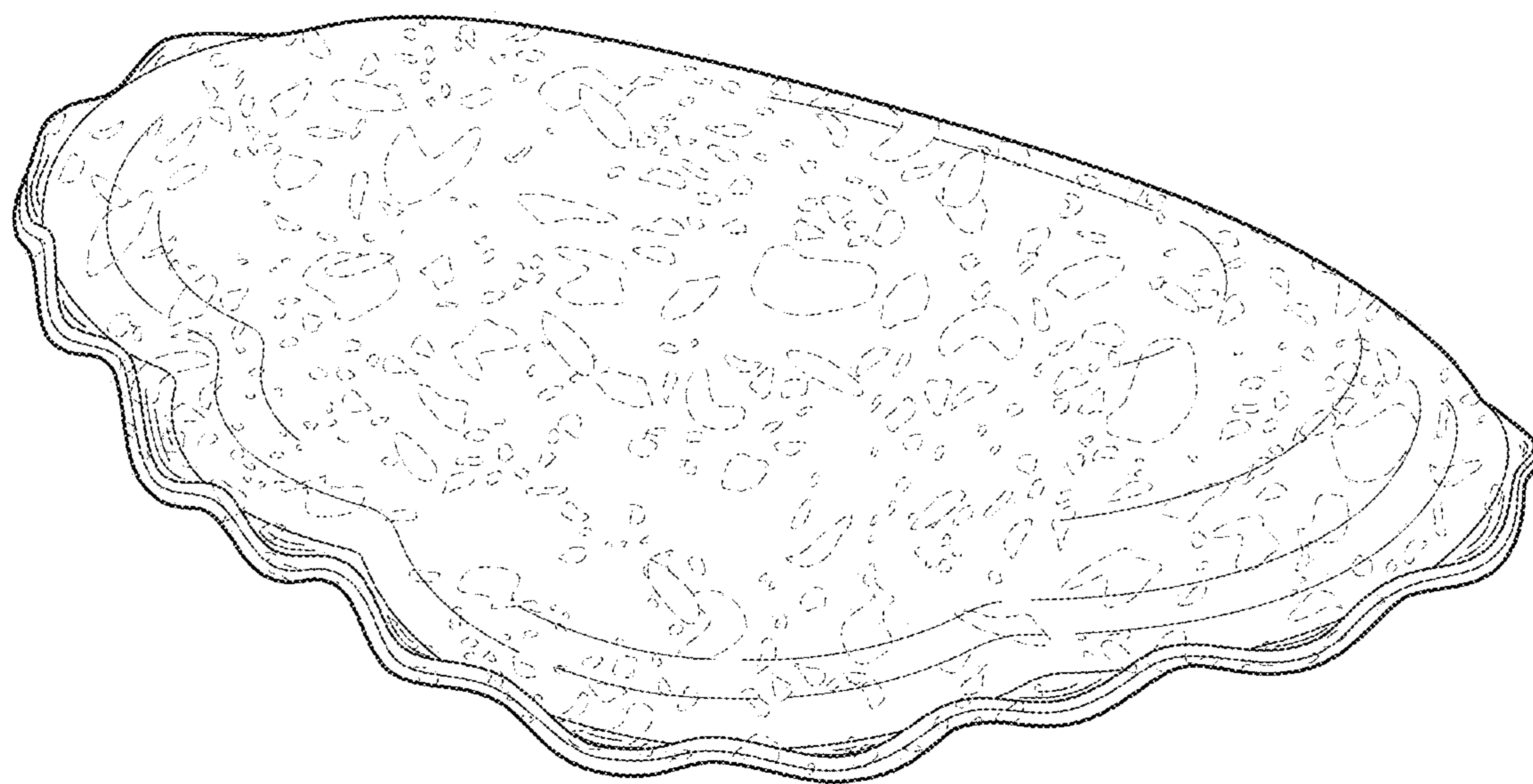

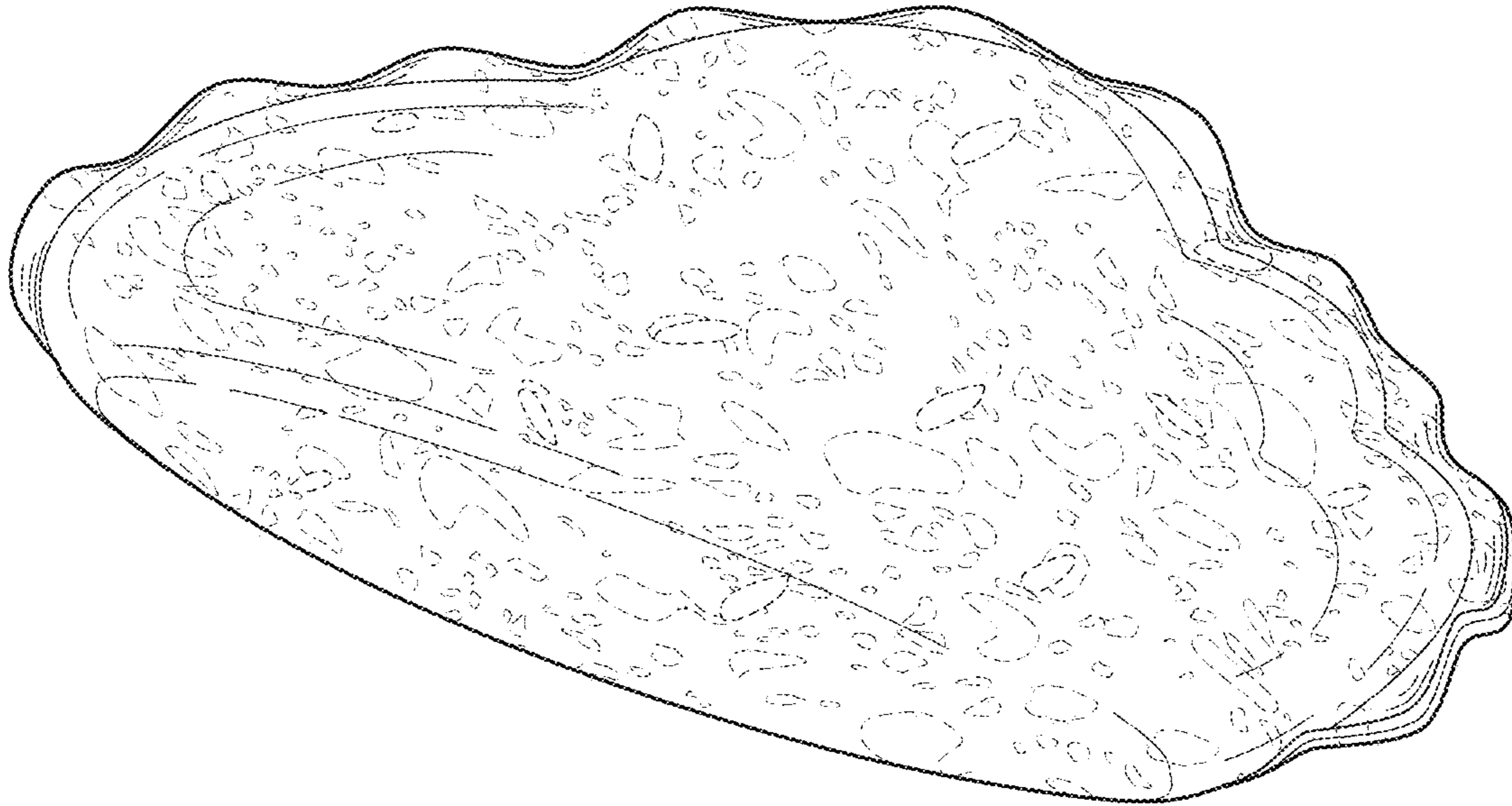

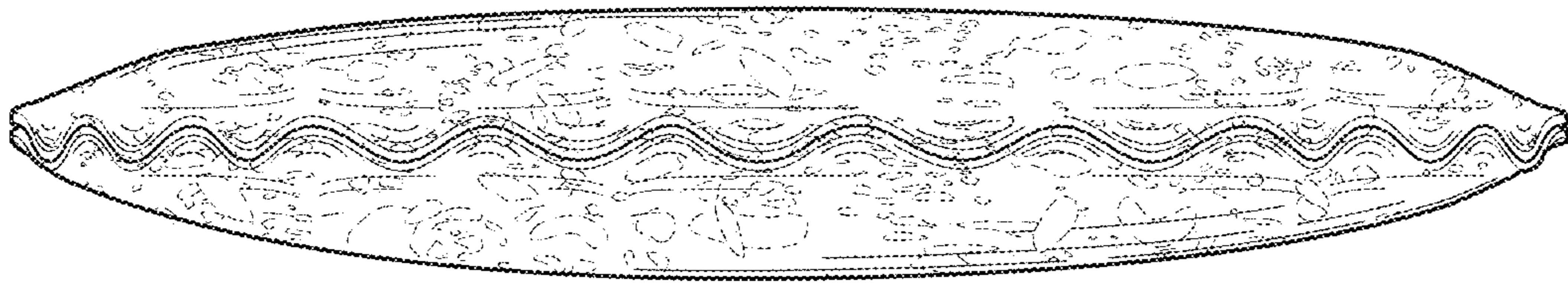

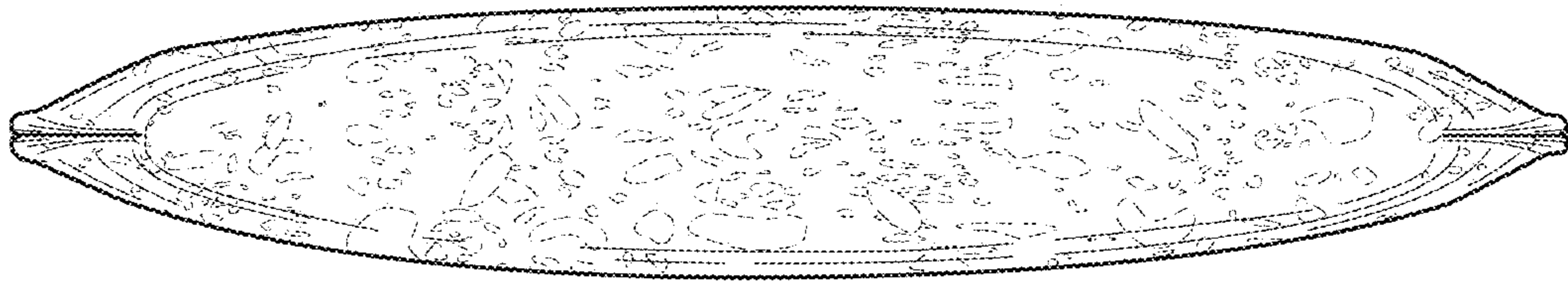

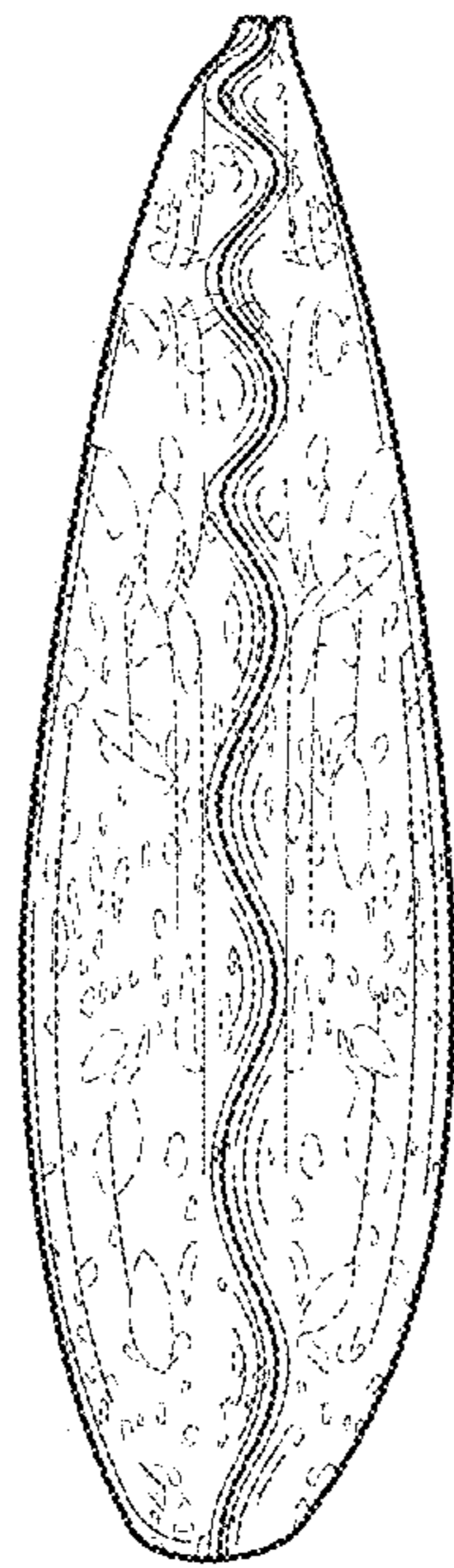

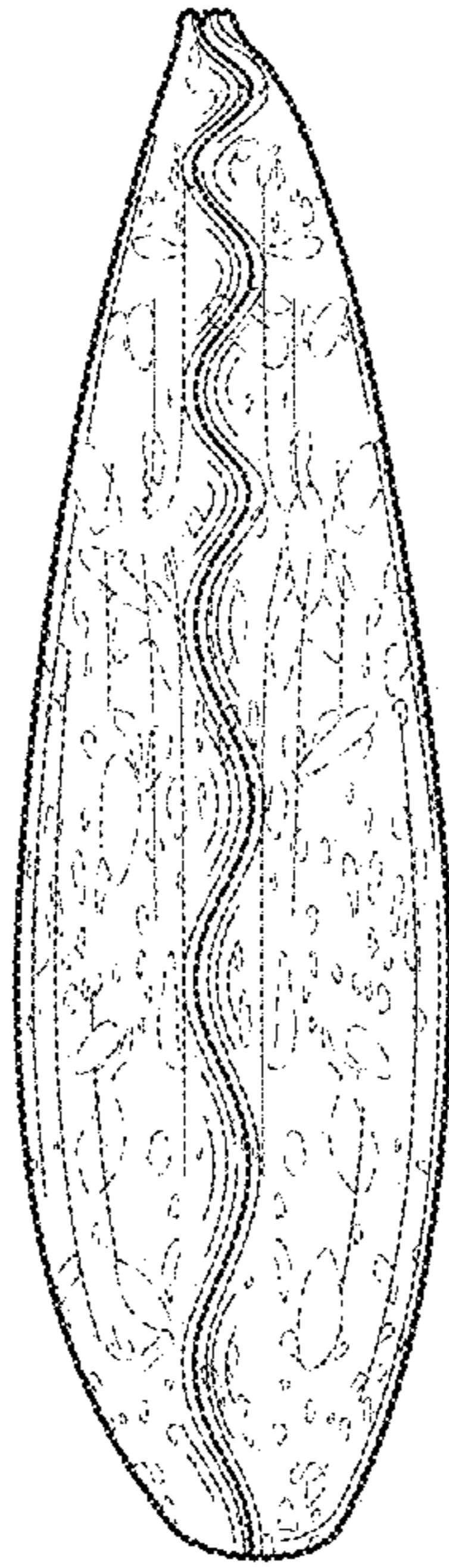

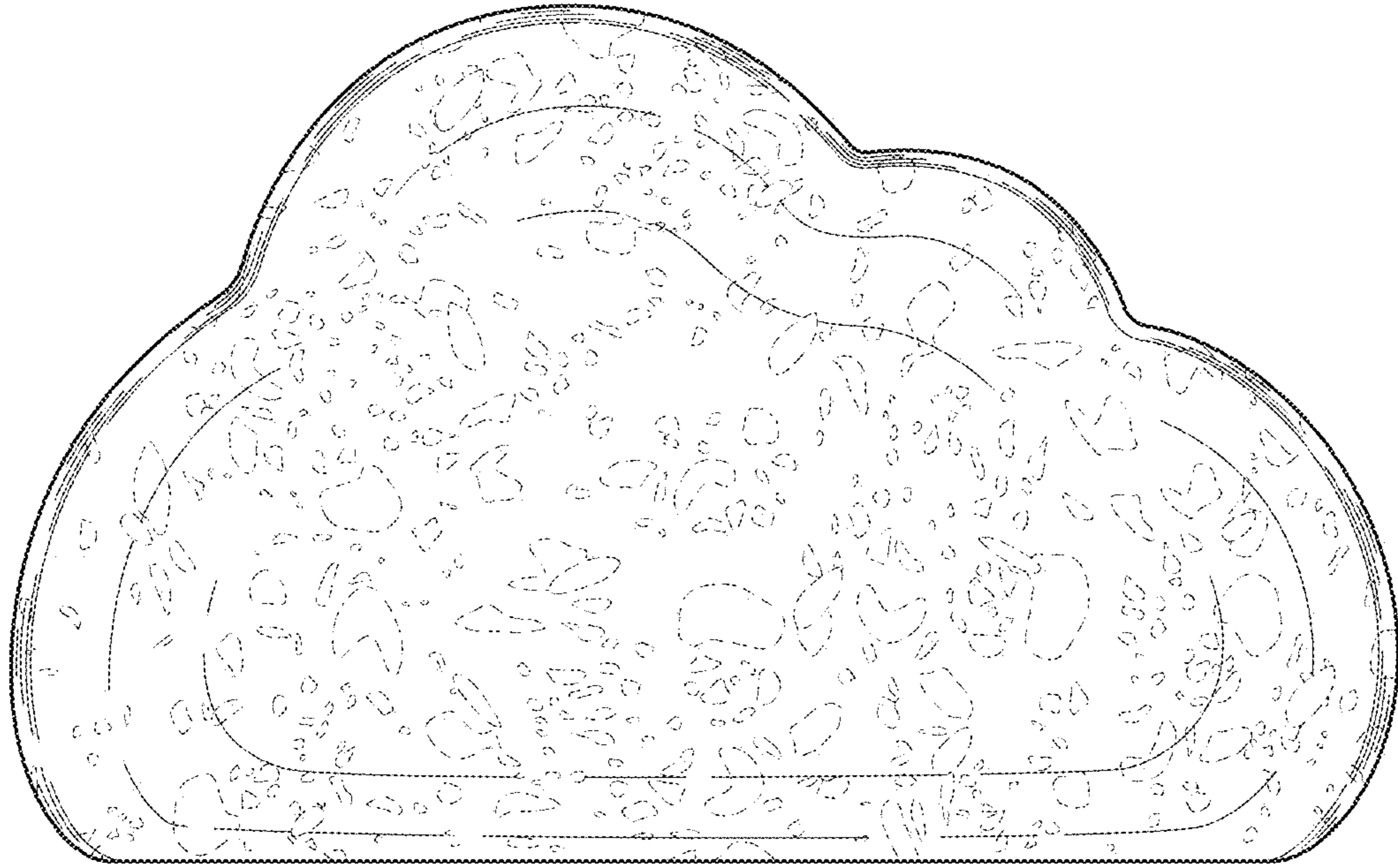

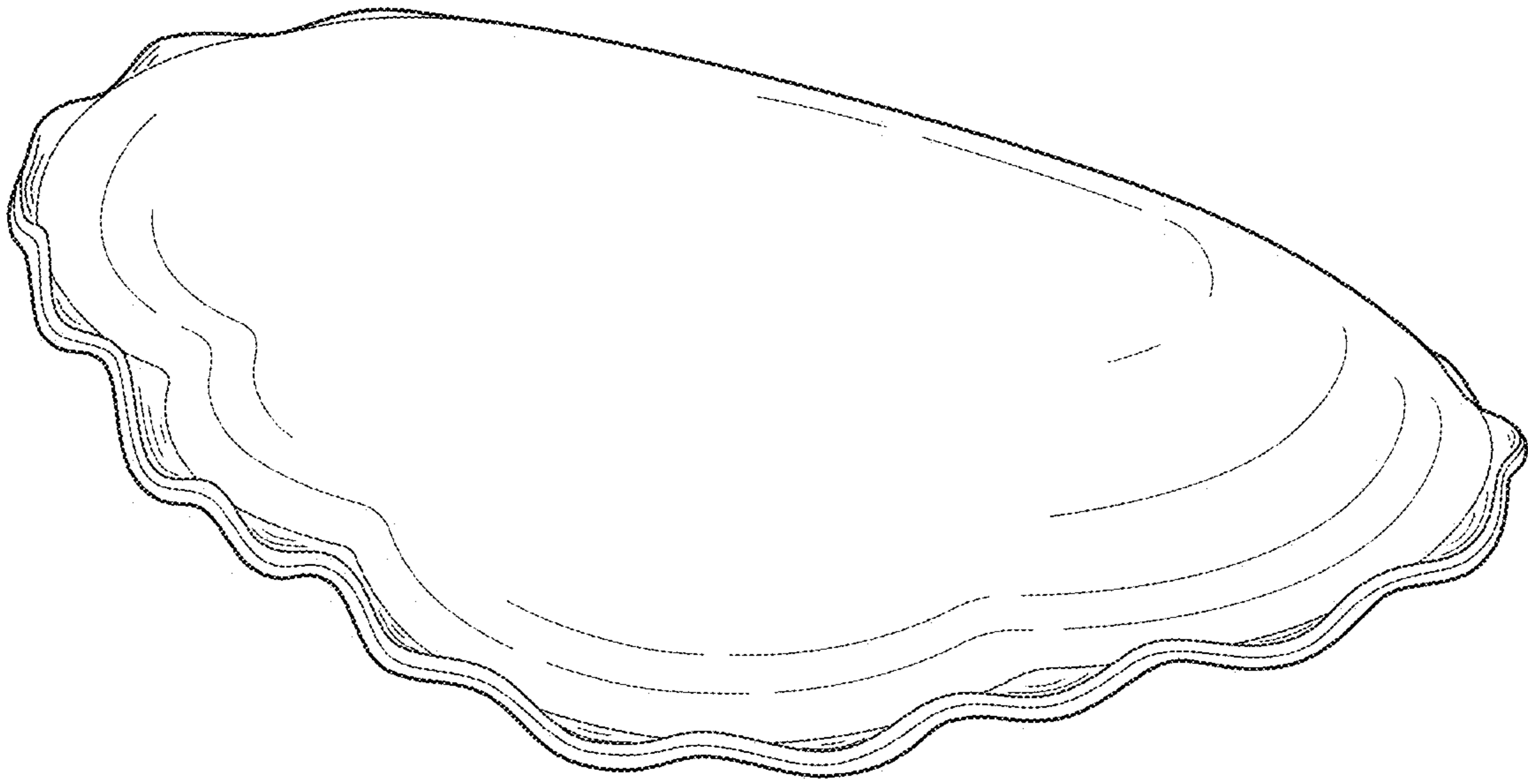

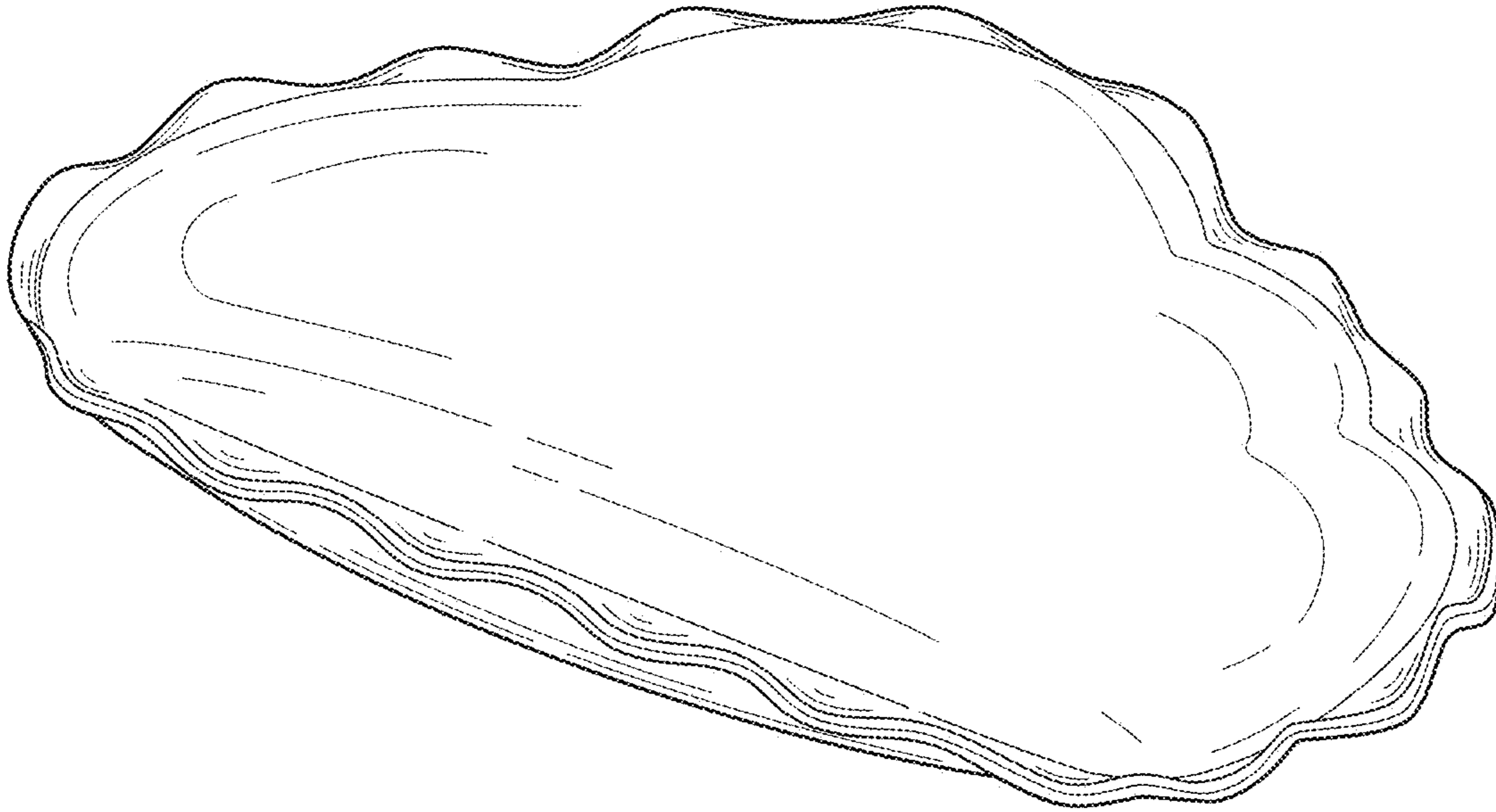

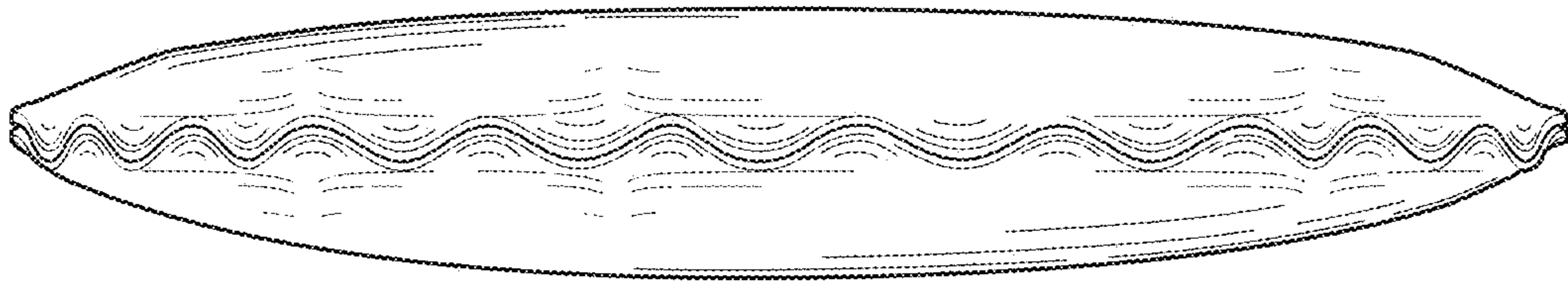

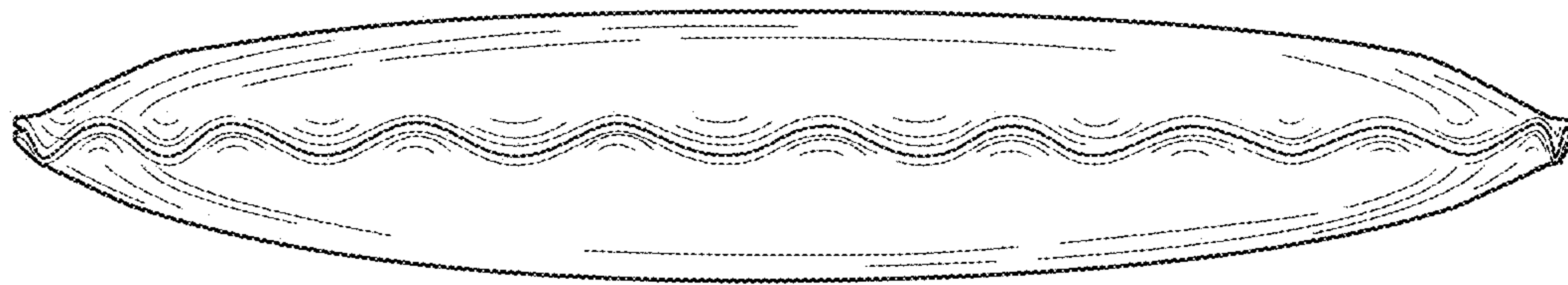

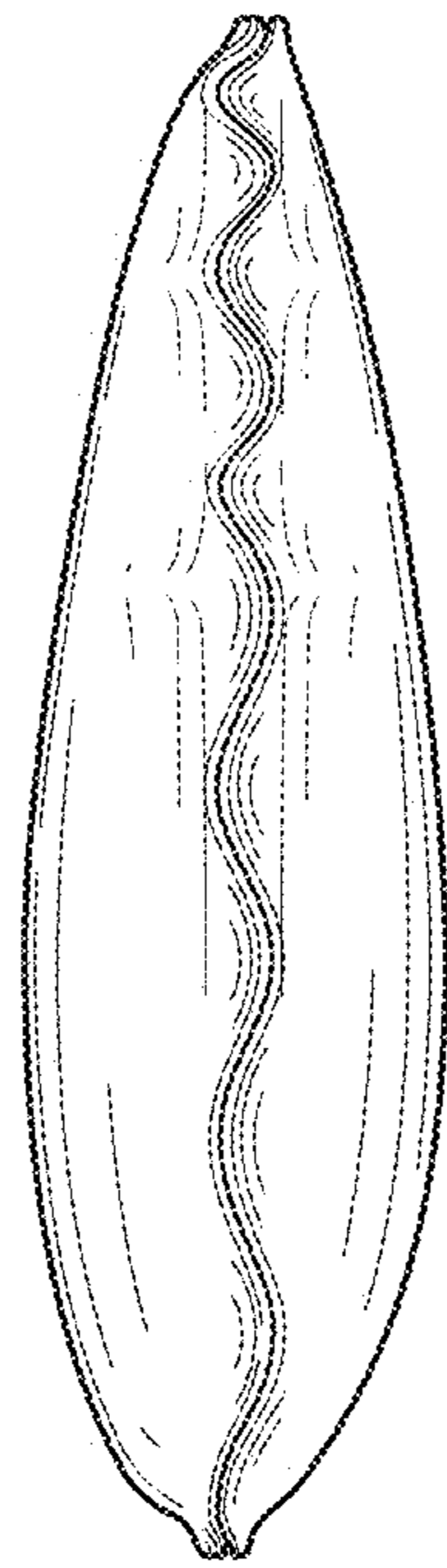

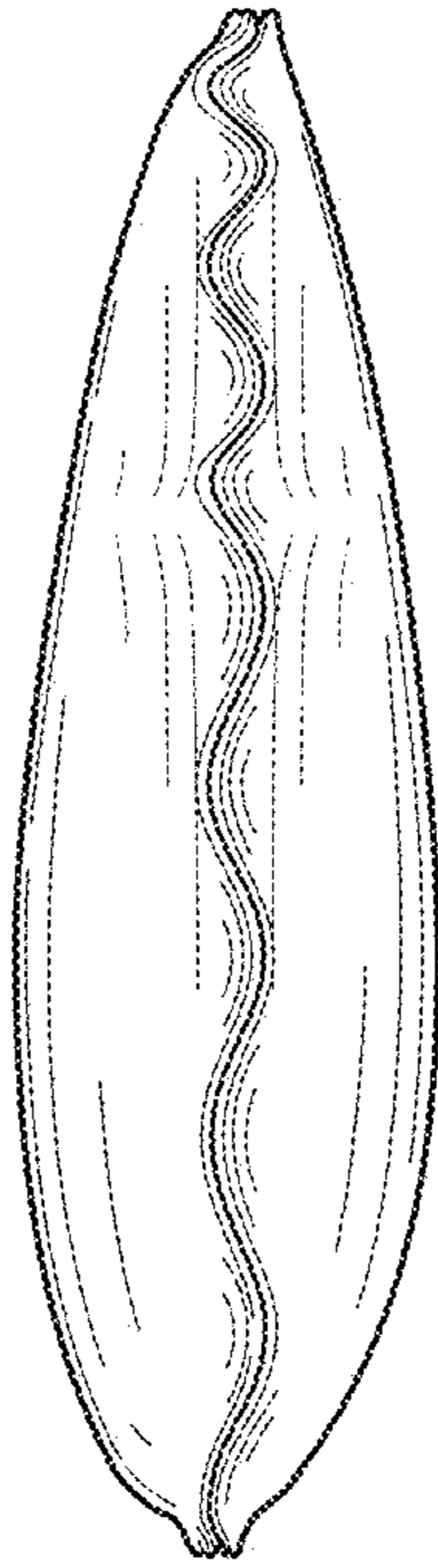

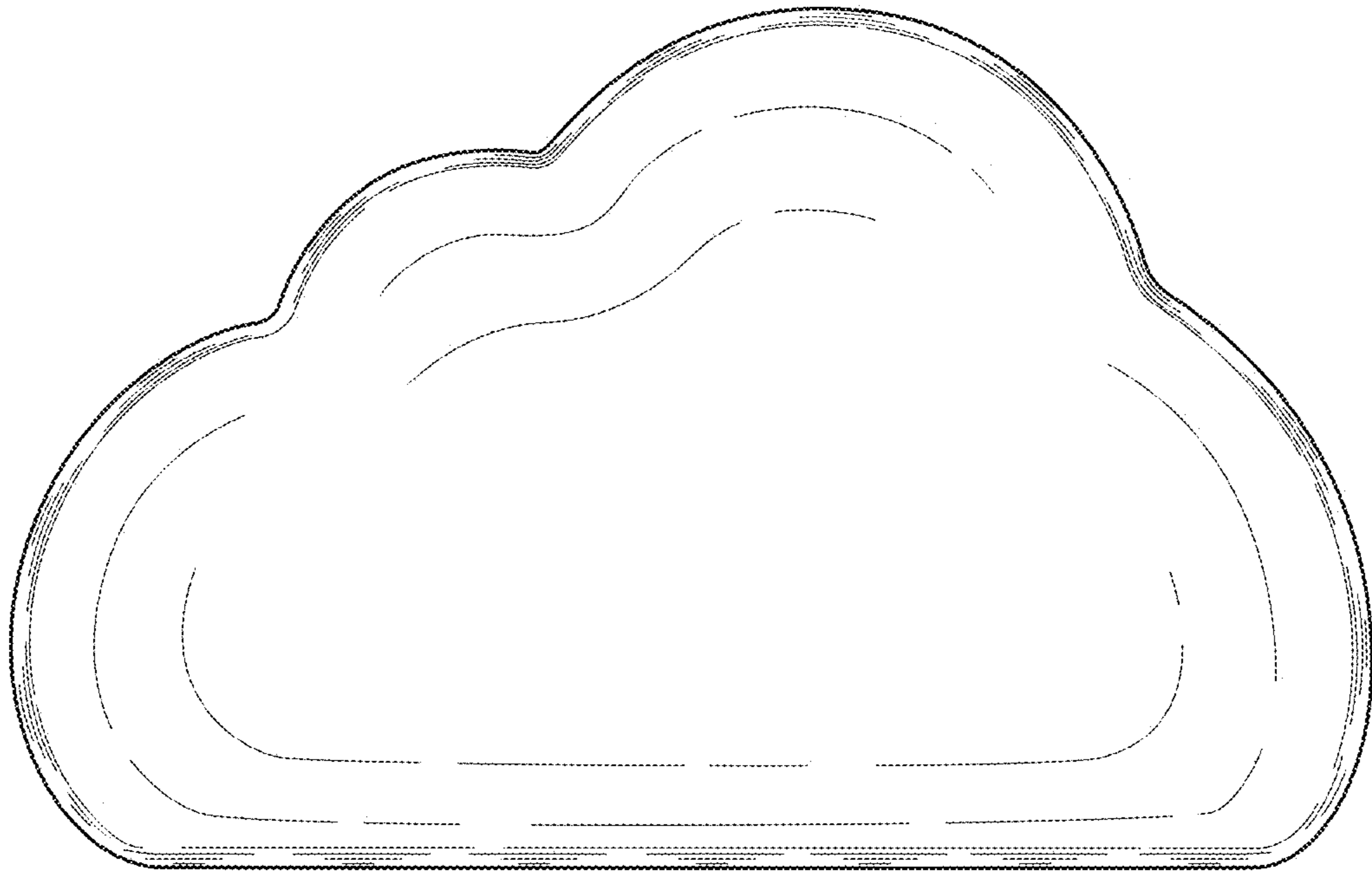

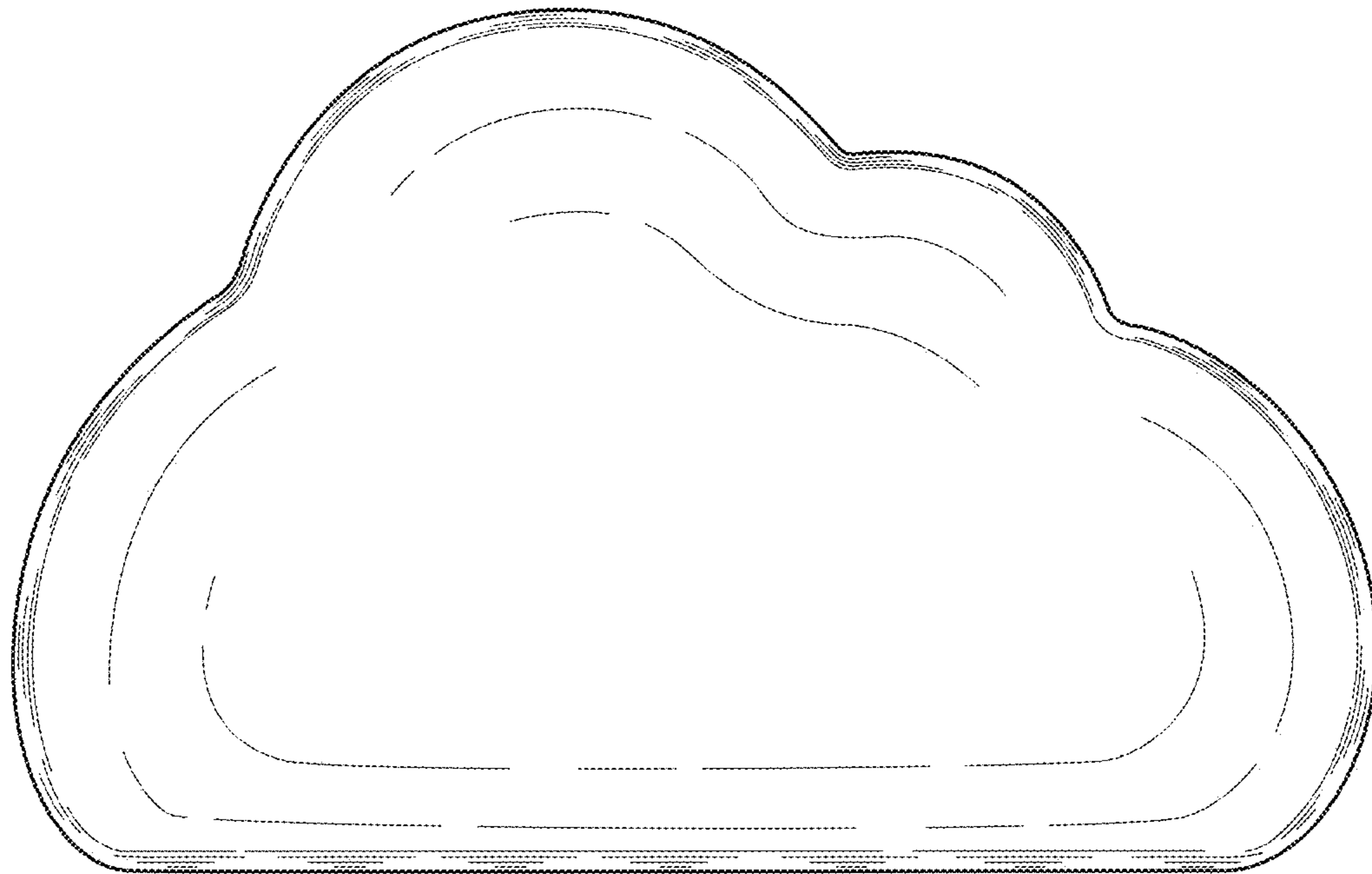

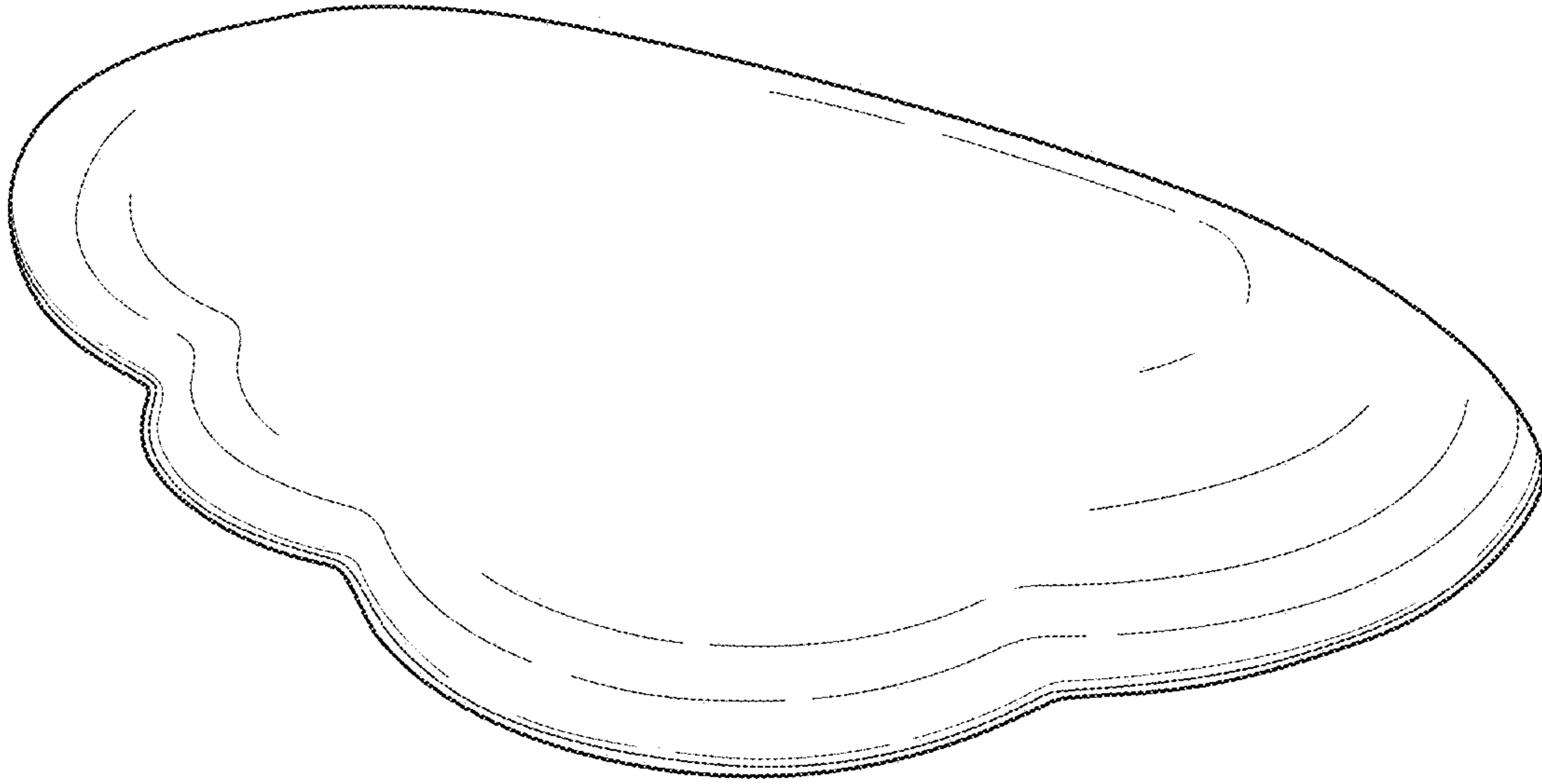

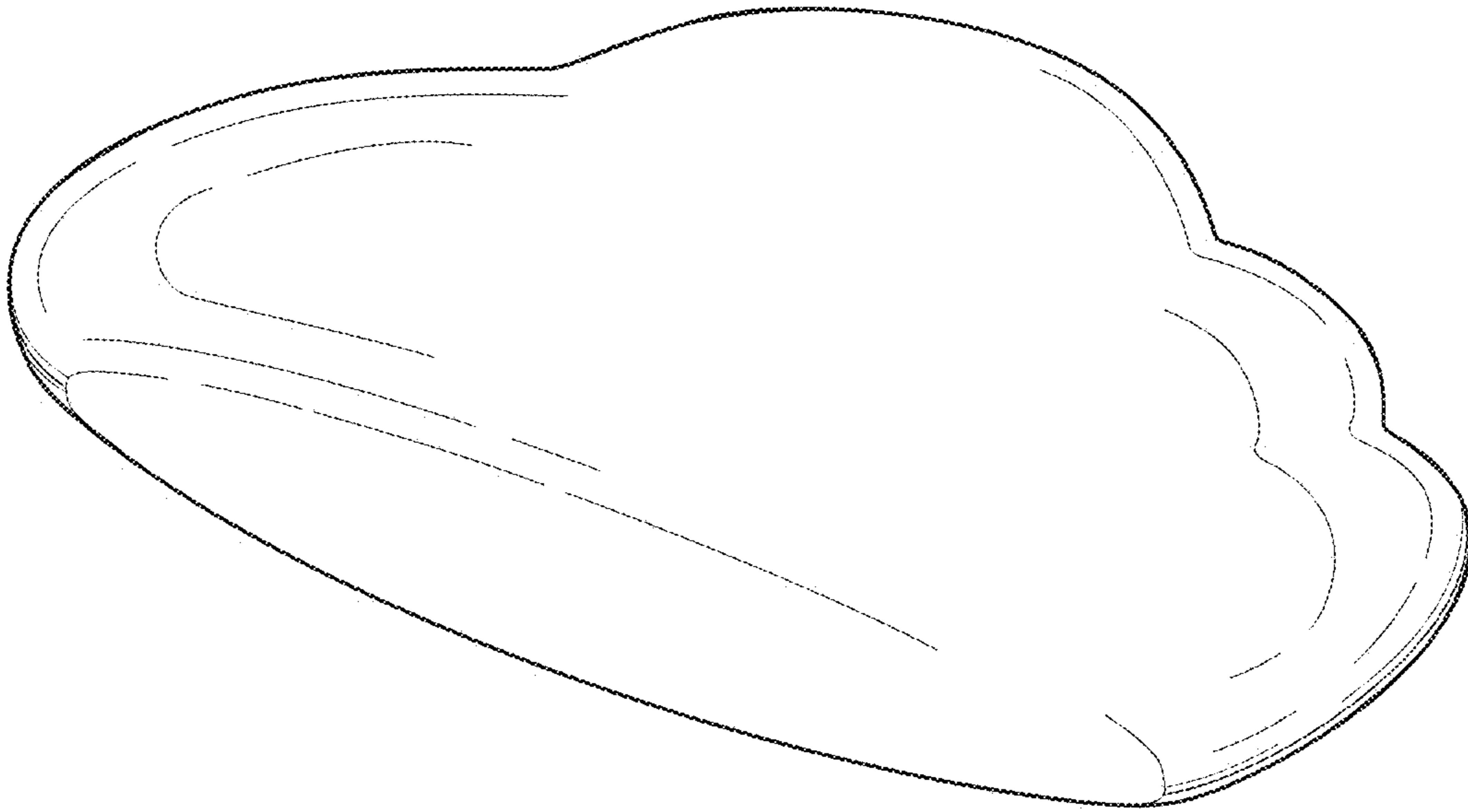

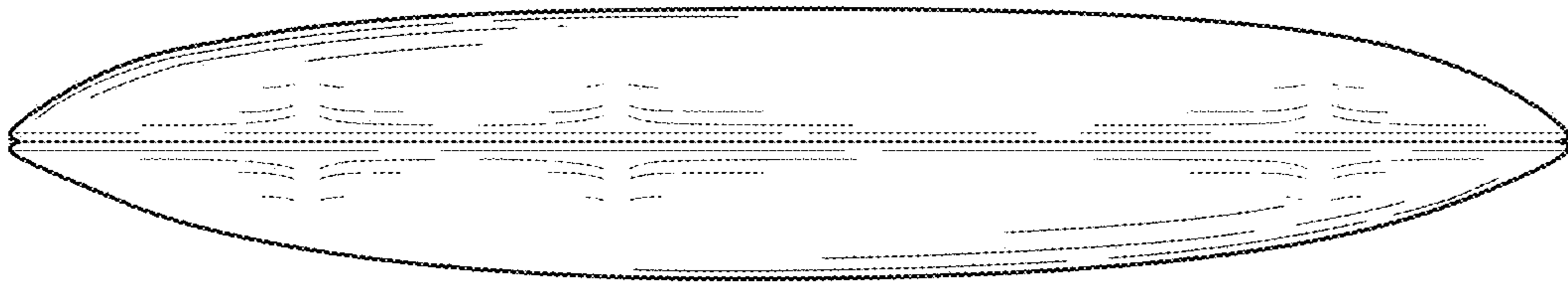

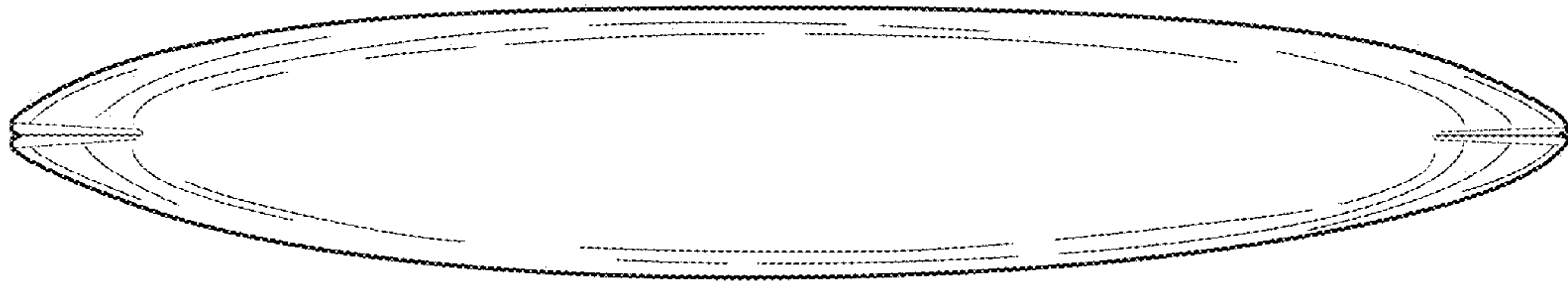

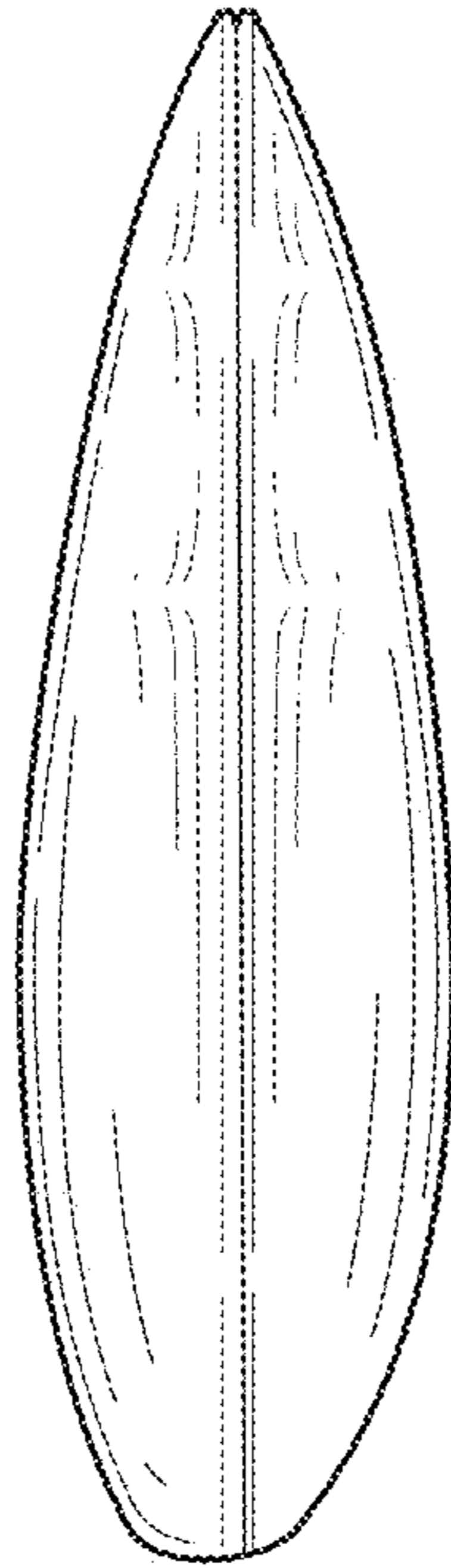

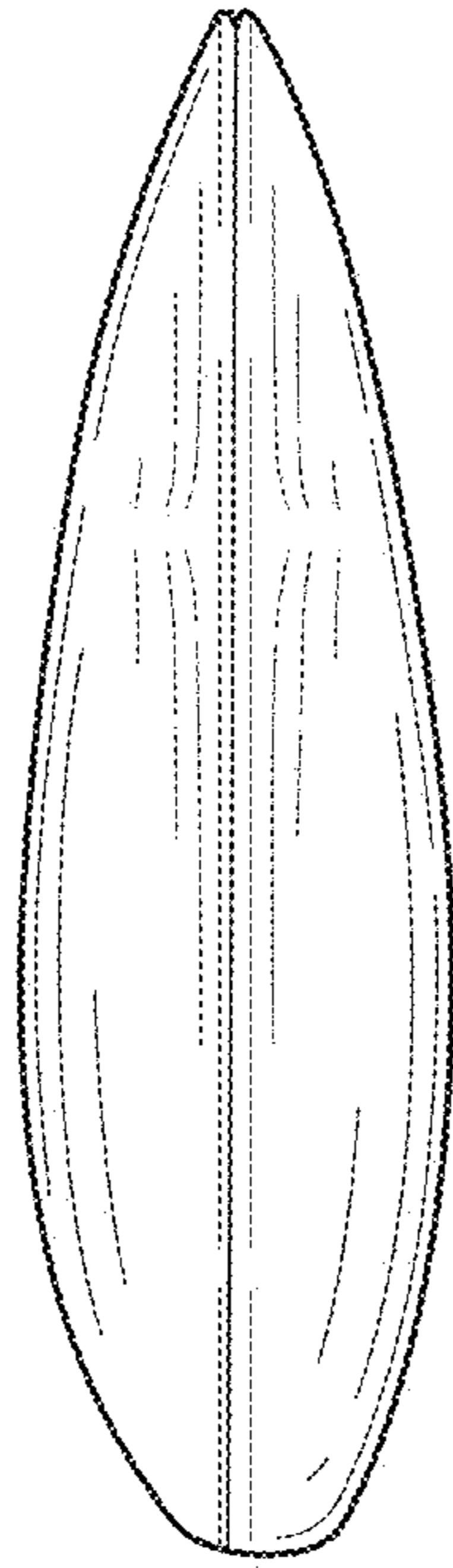

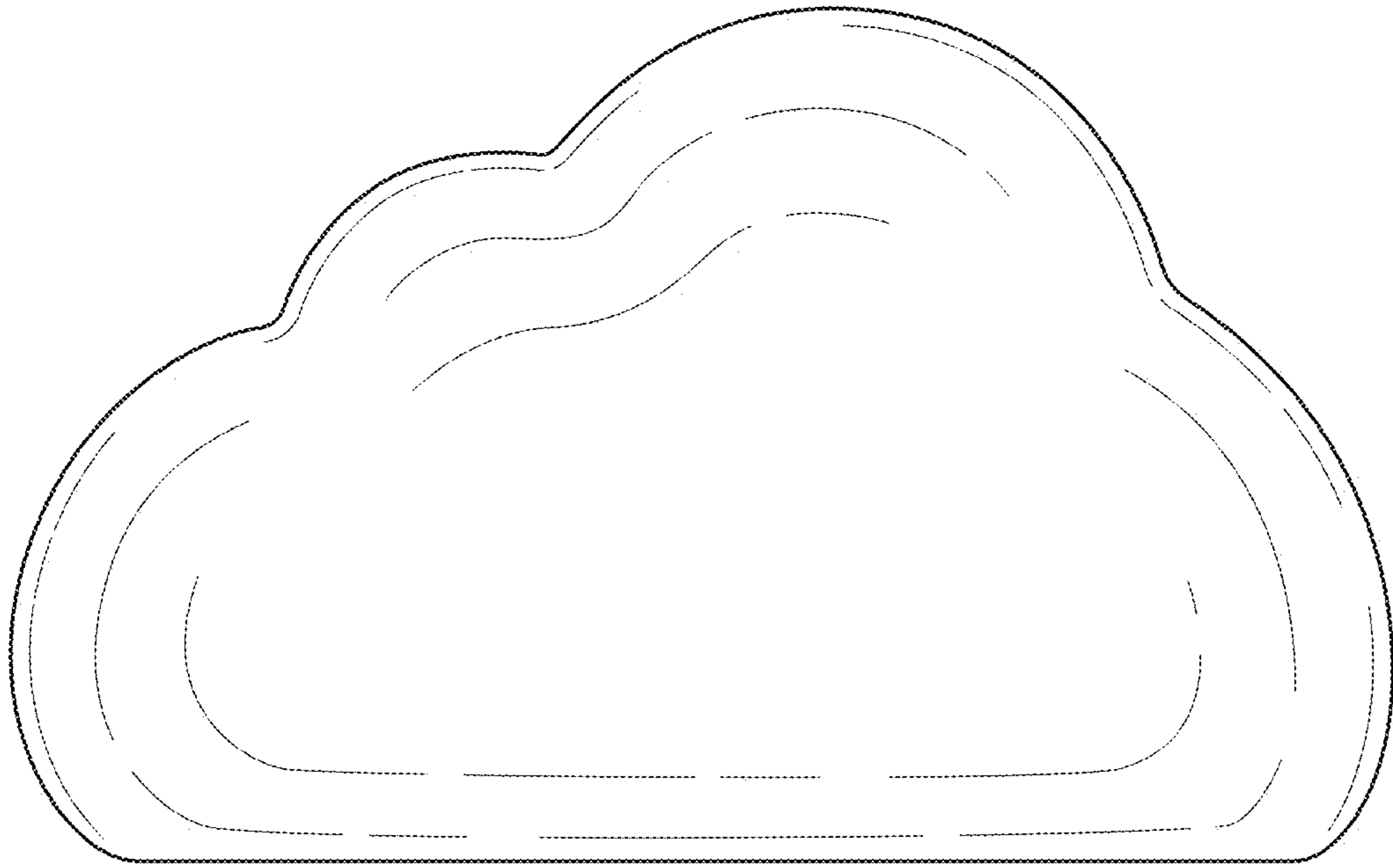

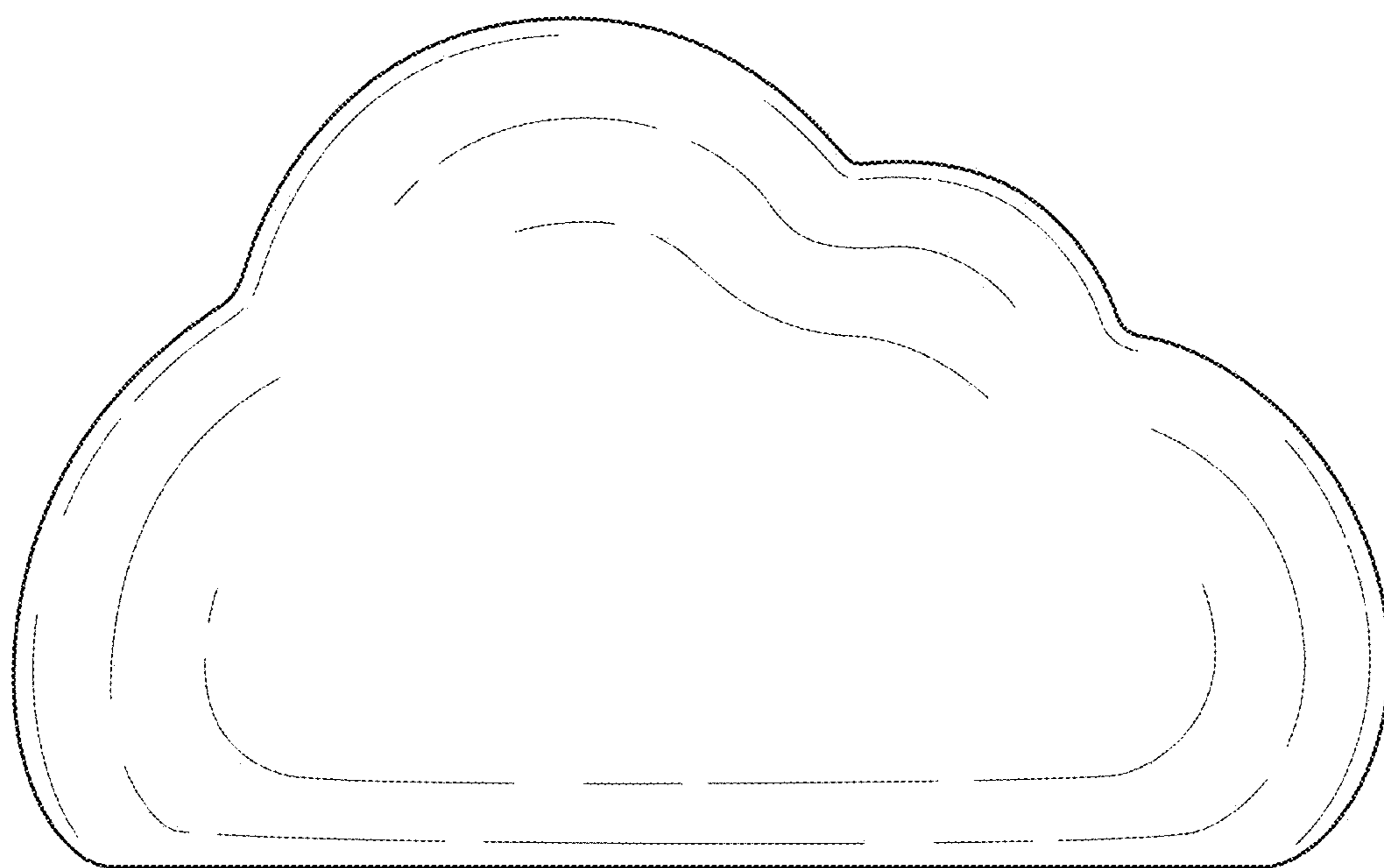
