FIG. 3 is a top view of the shoe.

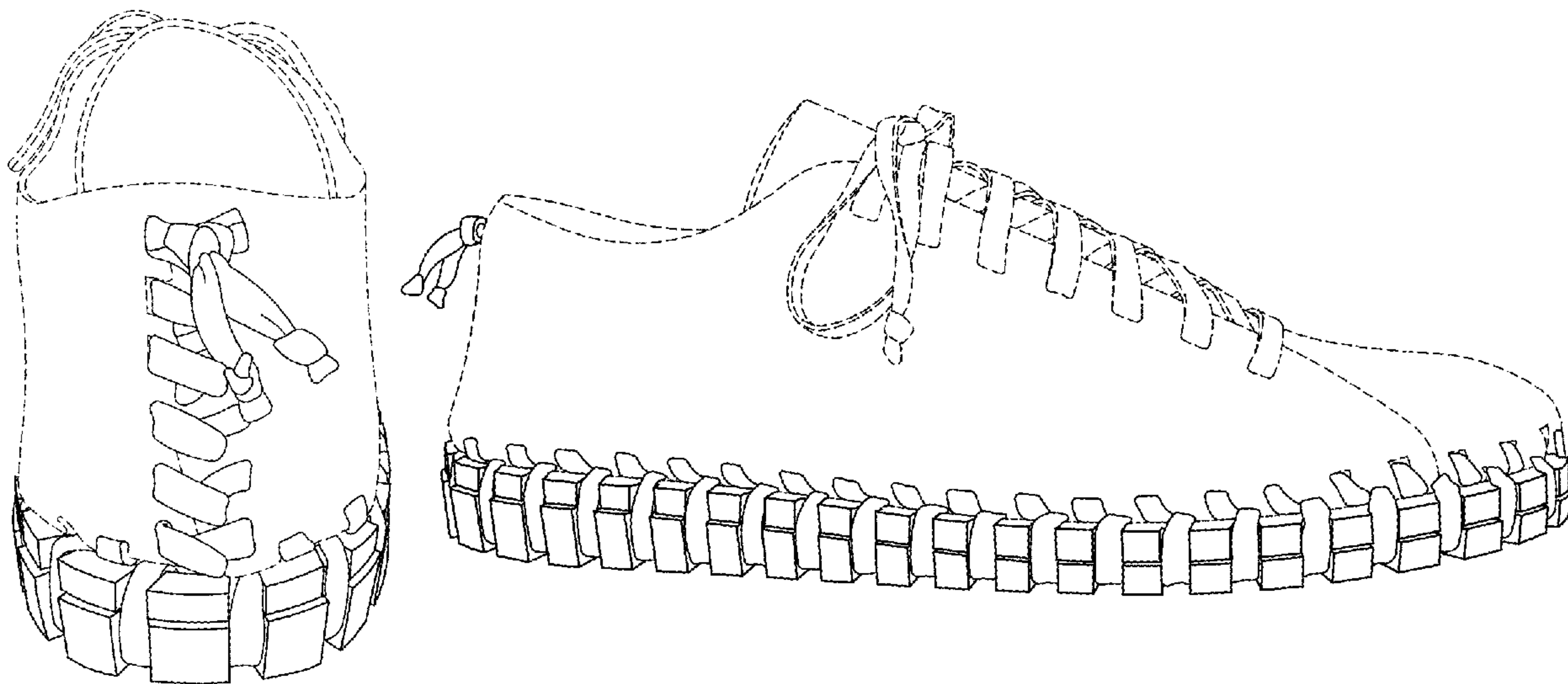
FIG. 4 is a bottom view of the shoe.

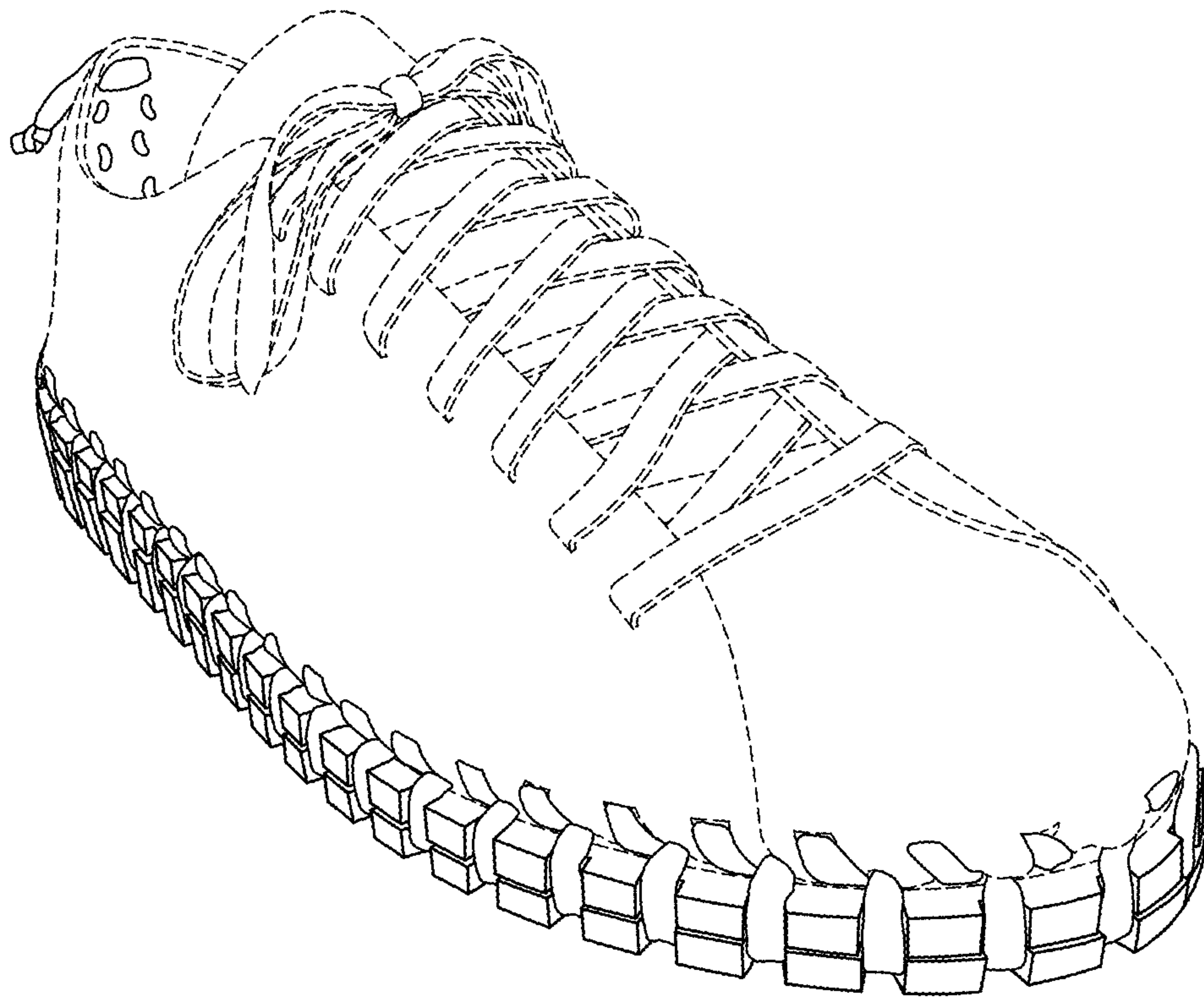

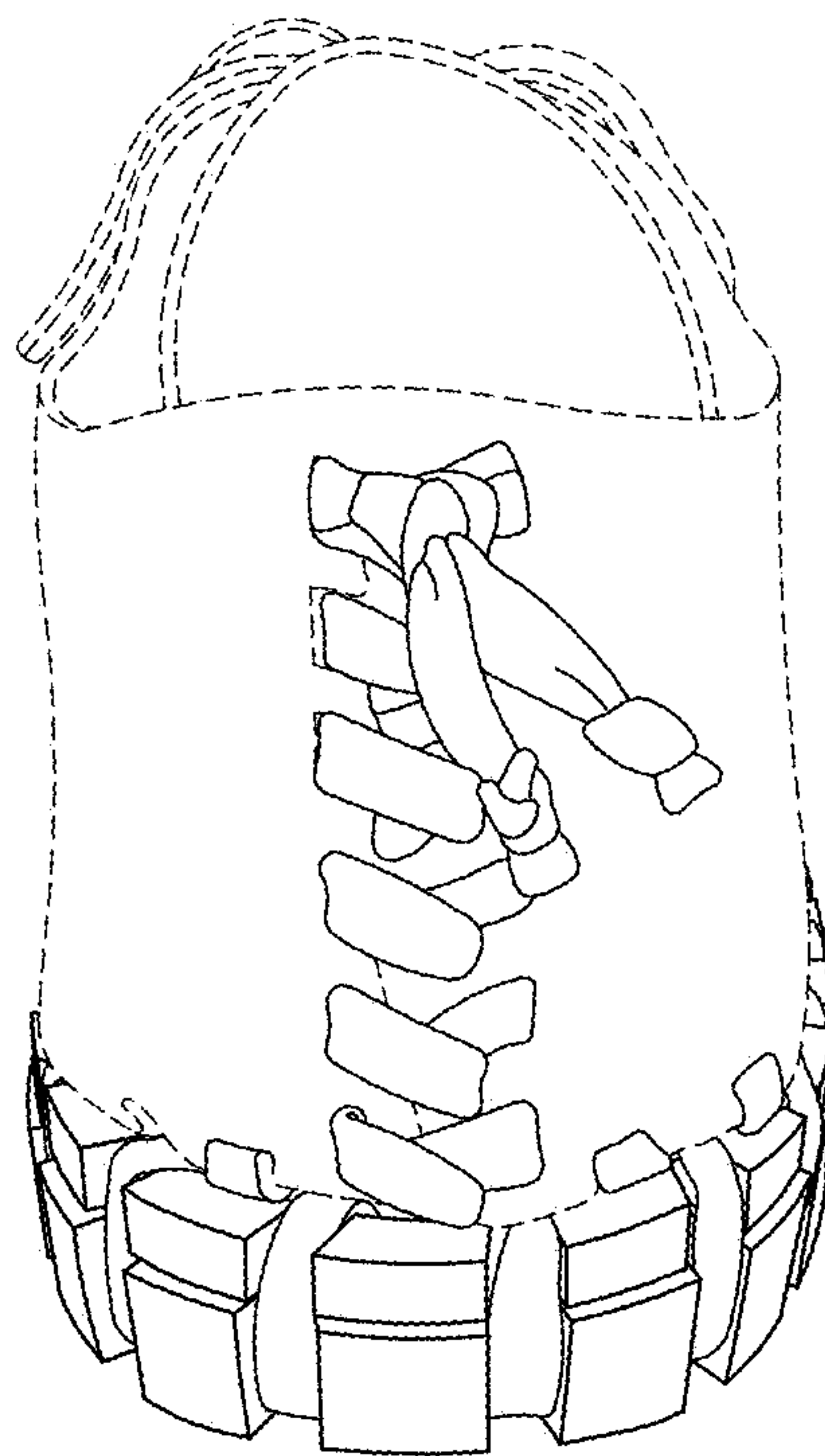

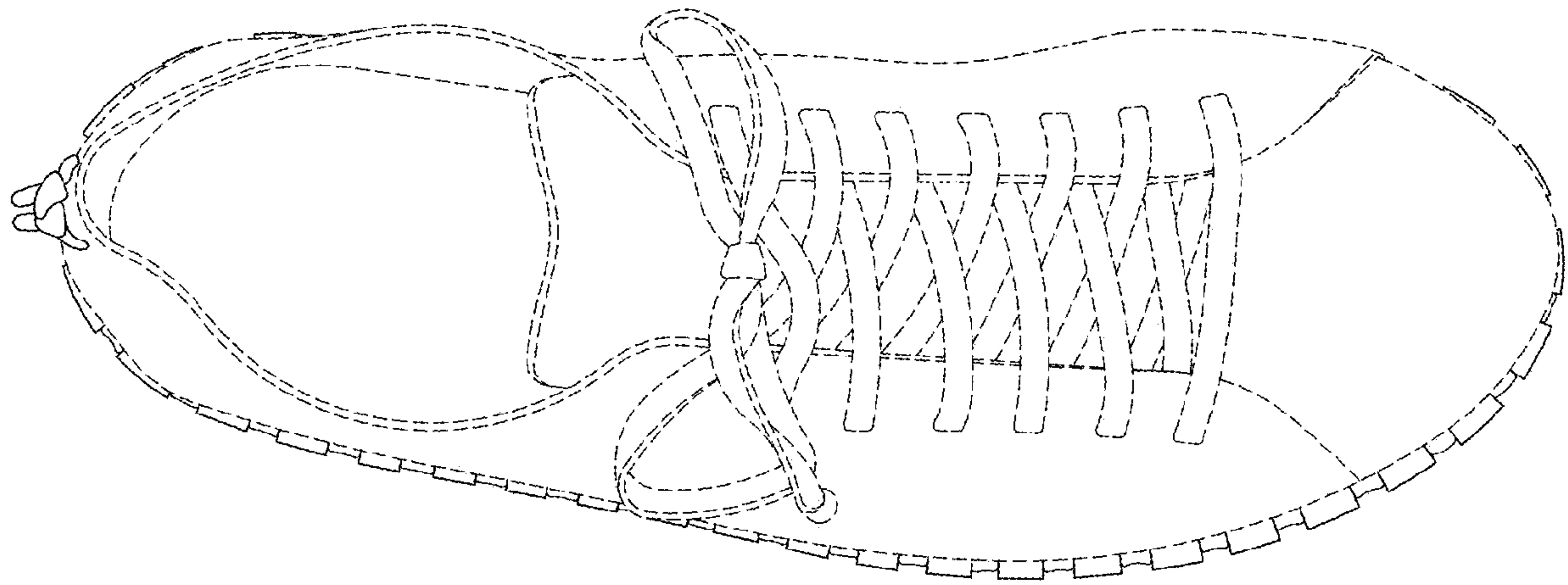

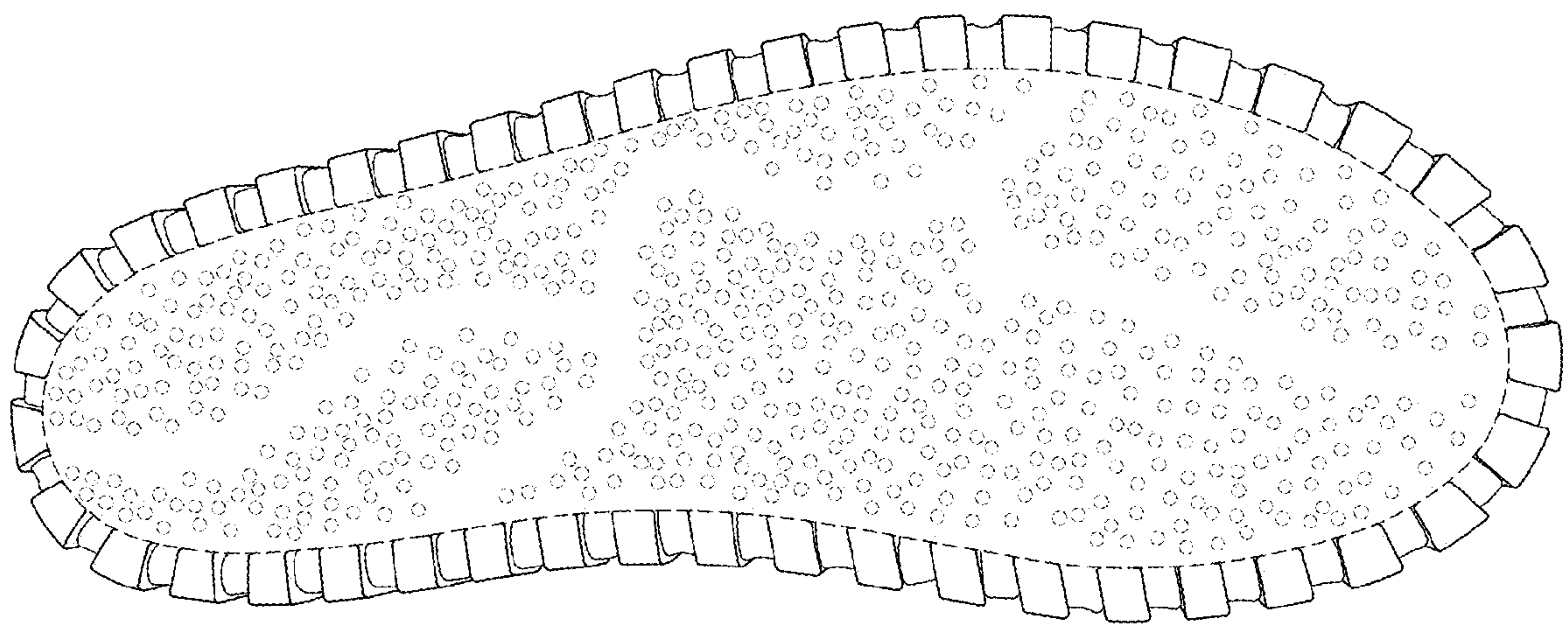

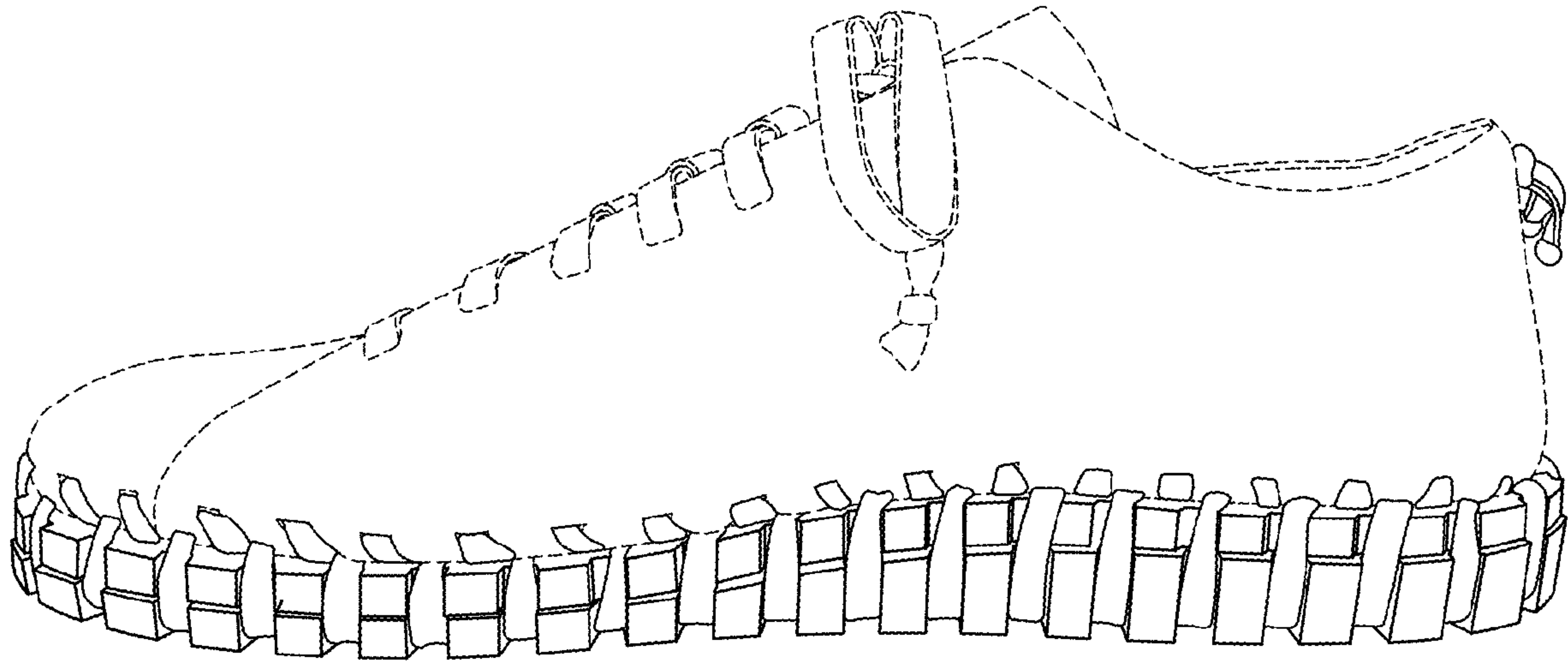

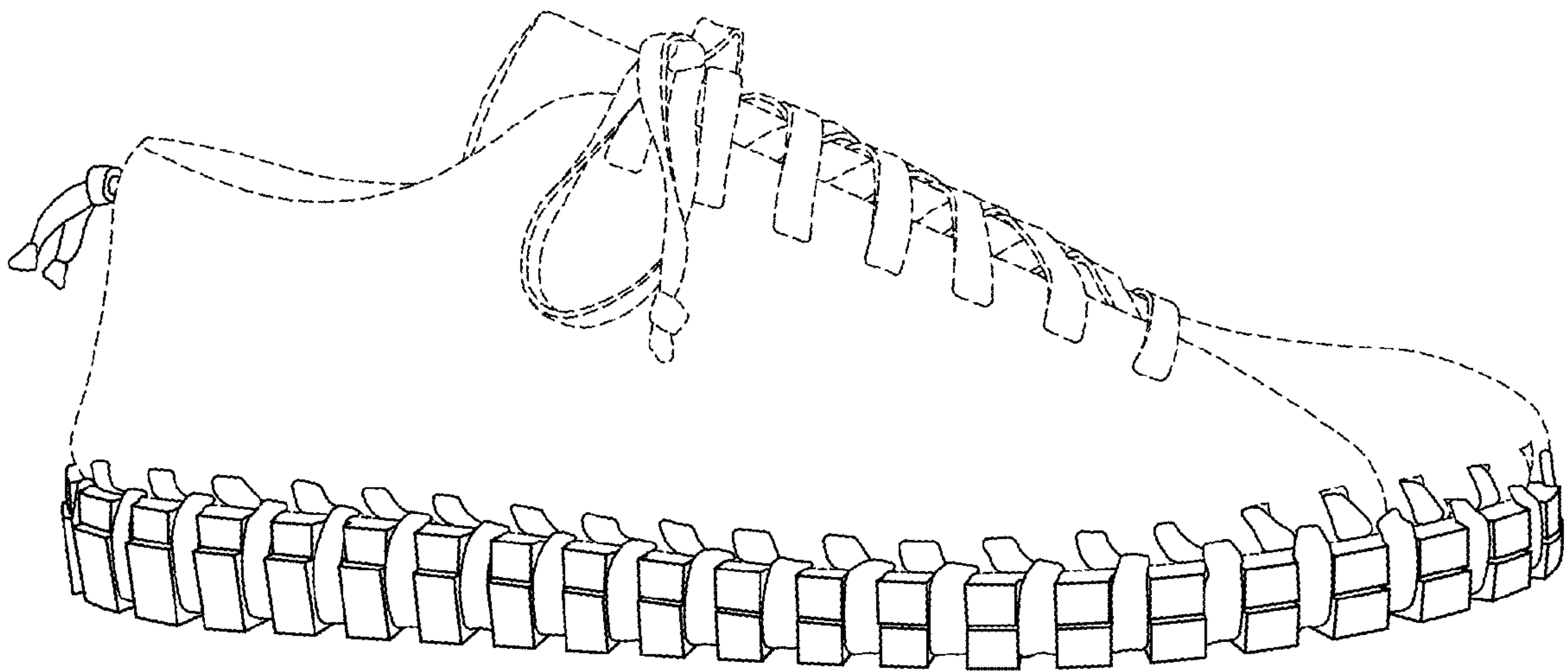
