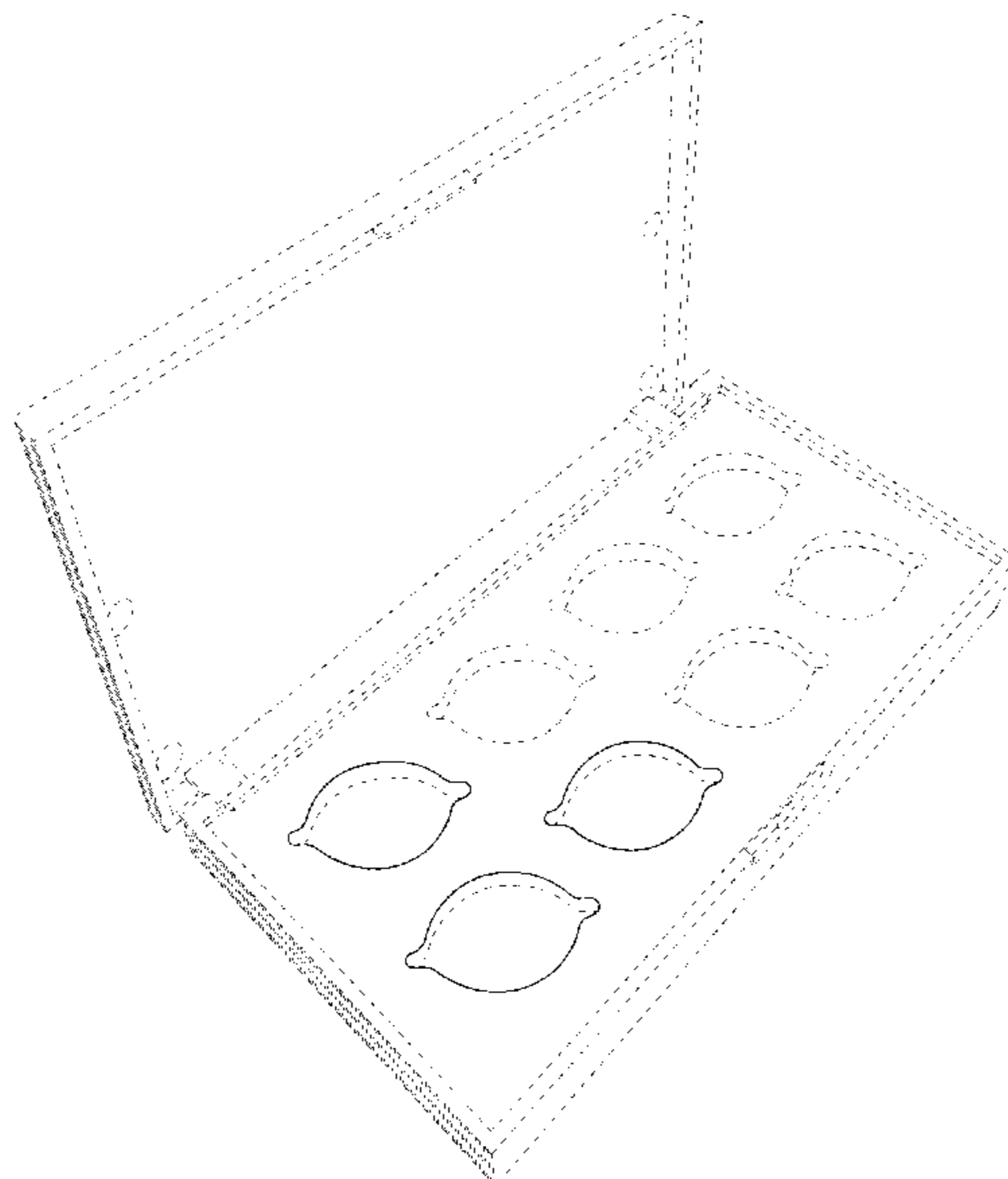
(57) **CLAIM**

An ornamental design for a case for eyelash cartridges, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a case for eyelash cartridges; FIG. 2 is a top perspective view thereof; FIG. 3 is a left-side perspective view thereof; FIG. 4 is a right-side perspective view thereof; FIG. 5 is a front perspective view thereof; FIG. 6 is a rear perspective view thereof; FIG. 7 is a bottom perspective view thereof; and, FIG. 8 is a perspective view of a case for eyelash cartridges, shown in a state of use storing an eyelash cartridge. The broken lines illustrate portions of the case for eyelash cartridges that form no part of the claimed design.

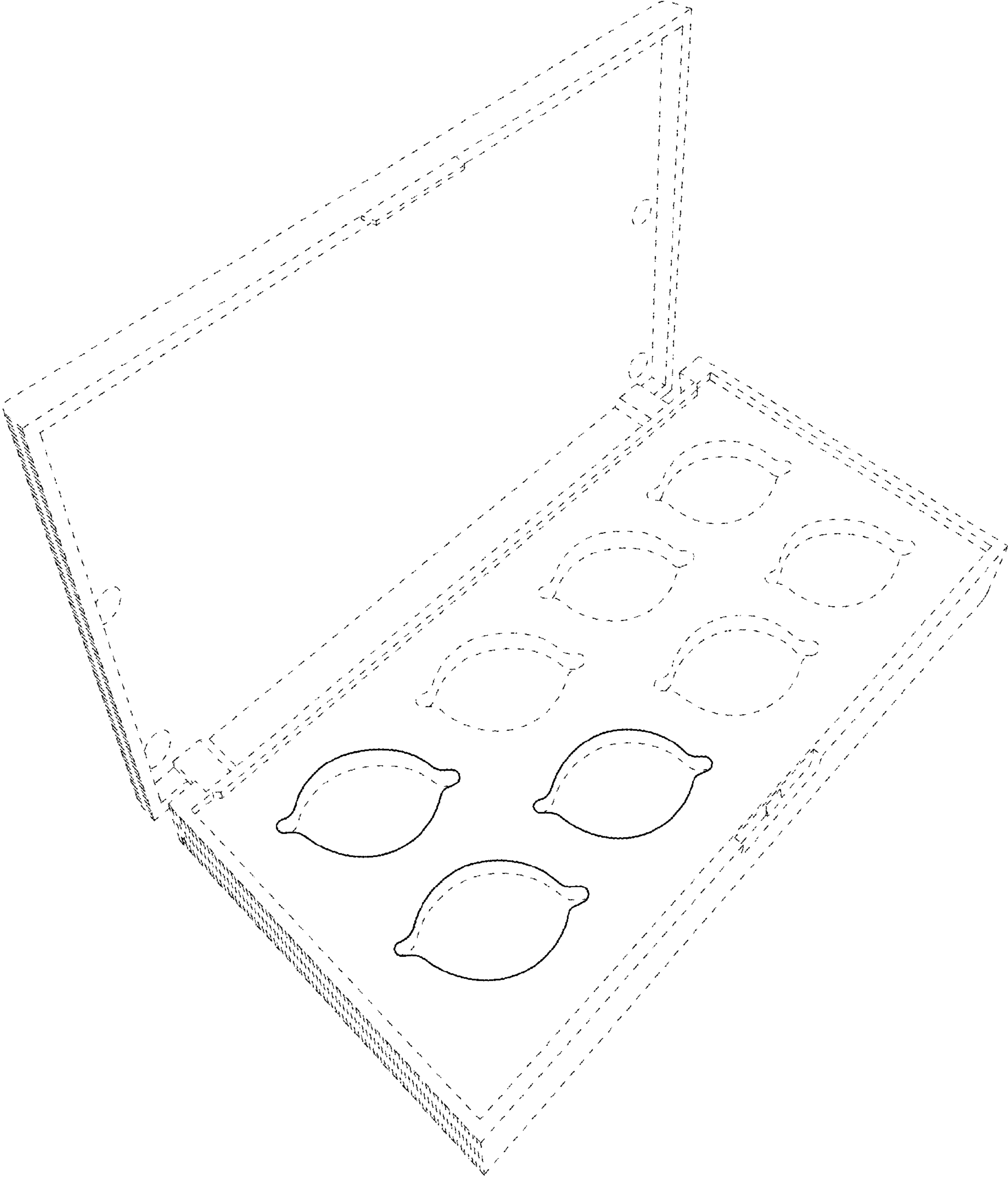

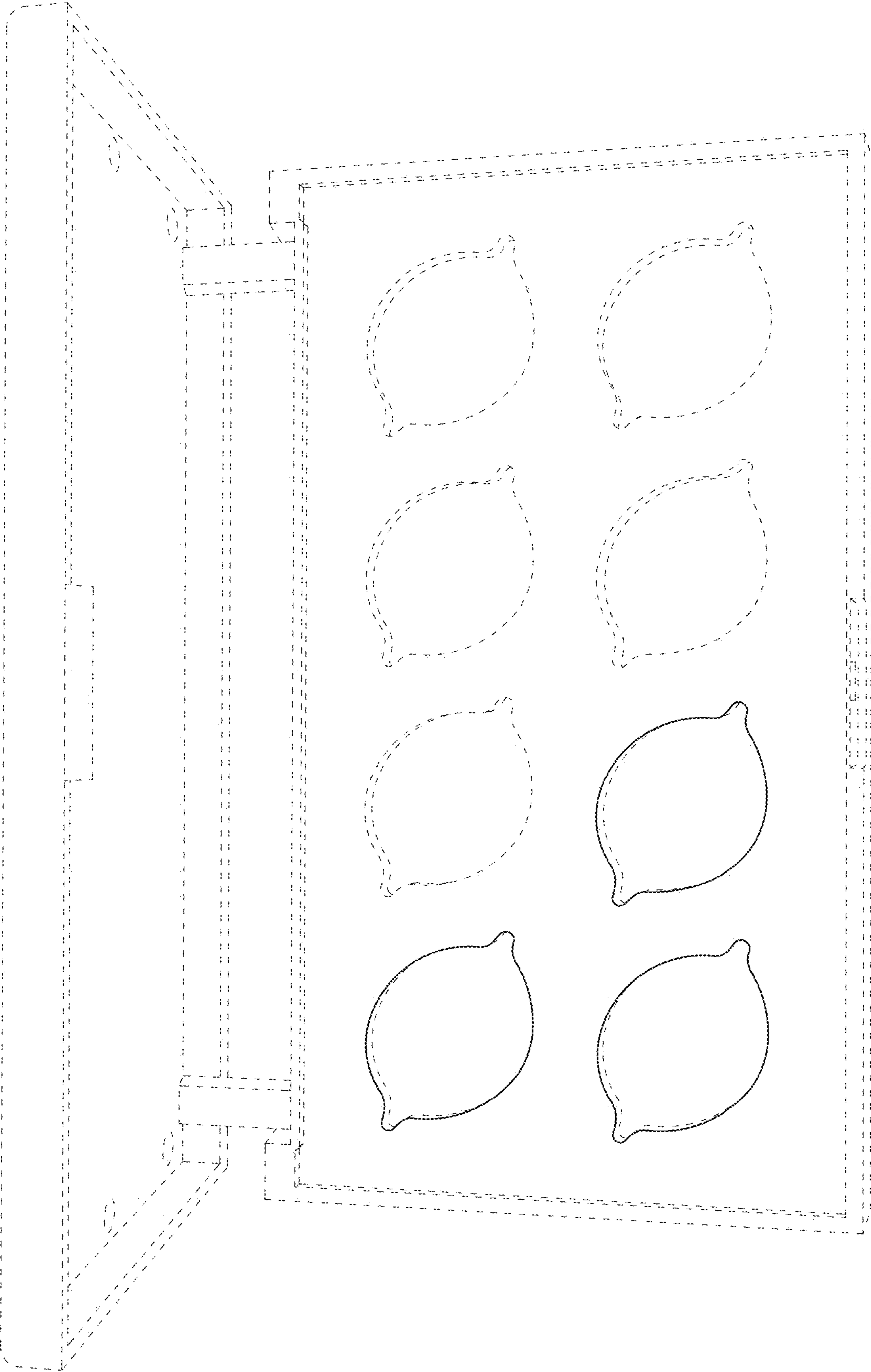

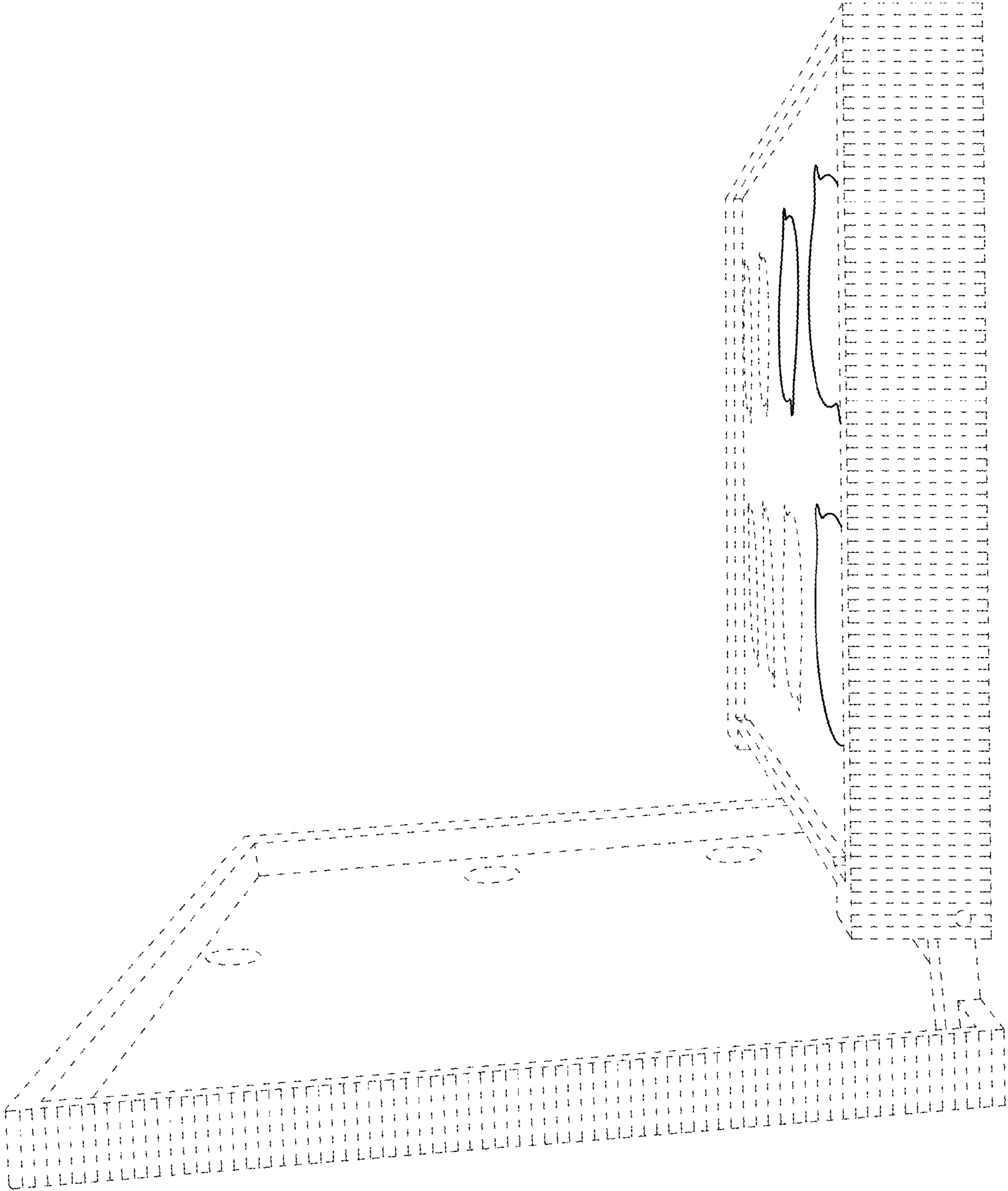

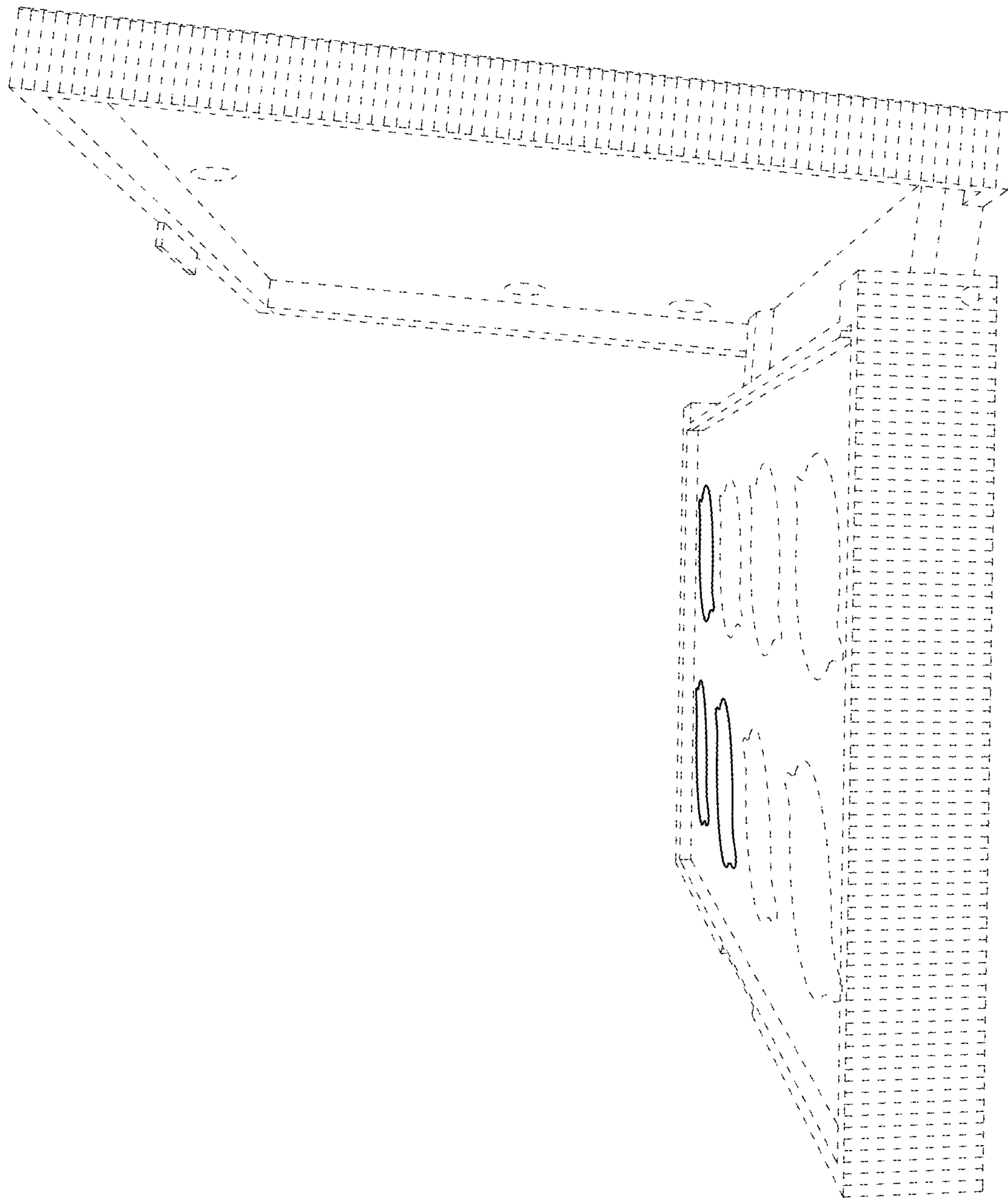

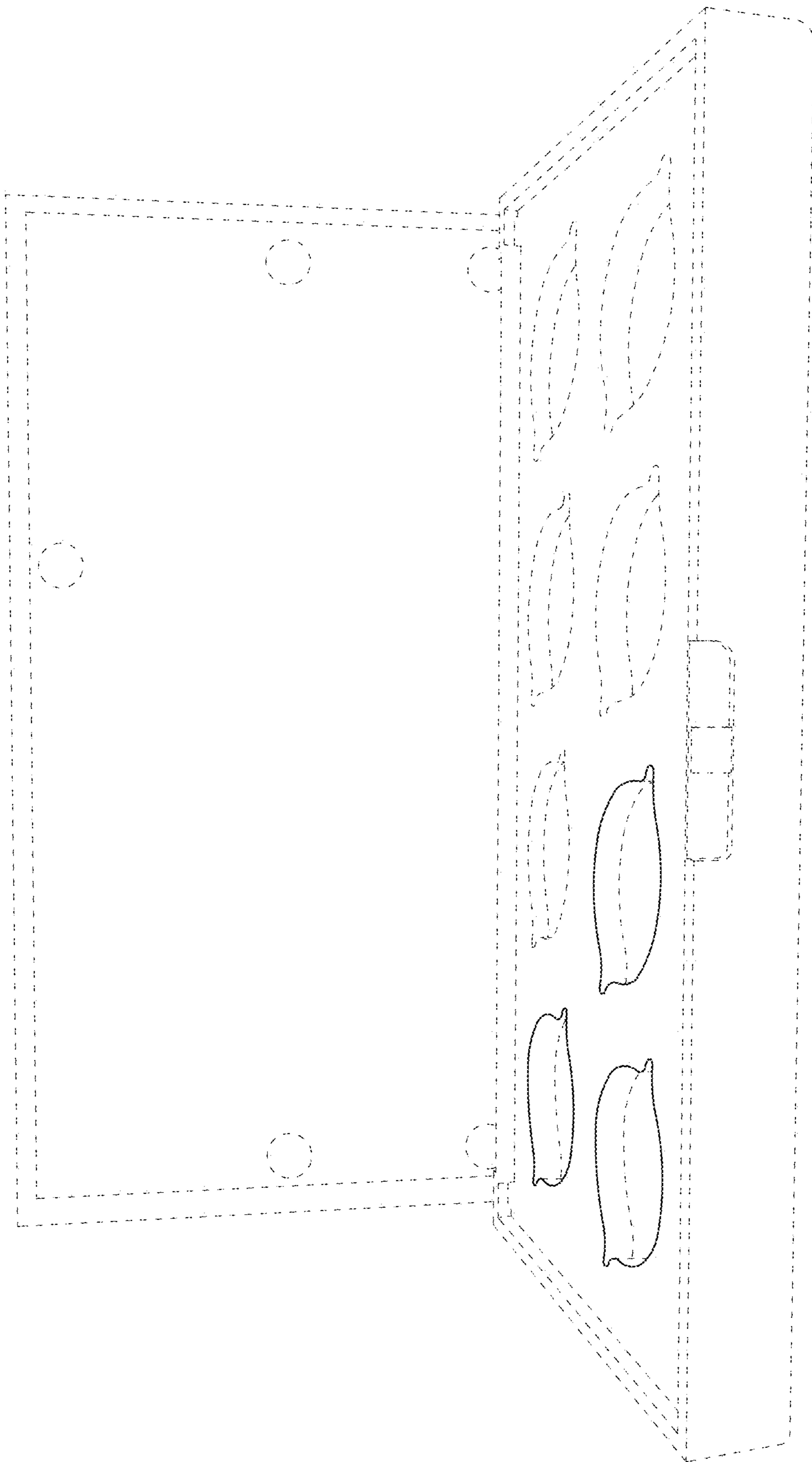

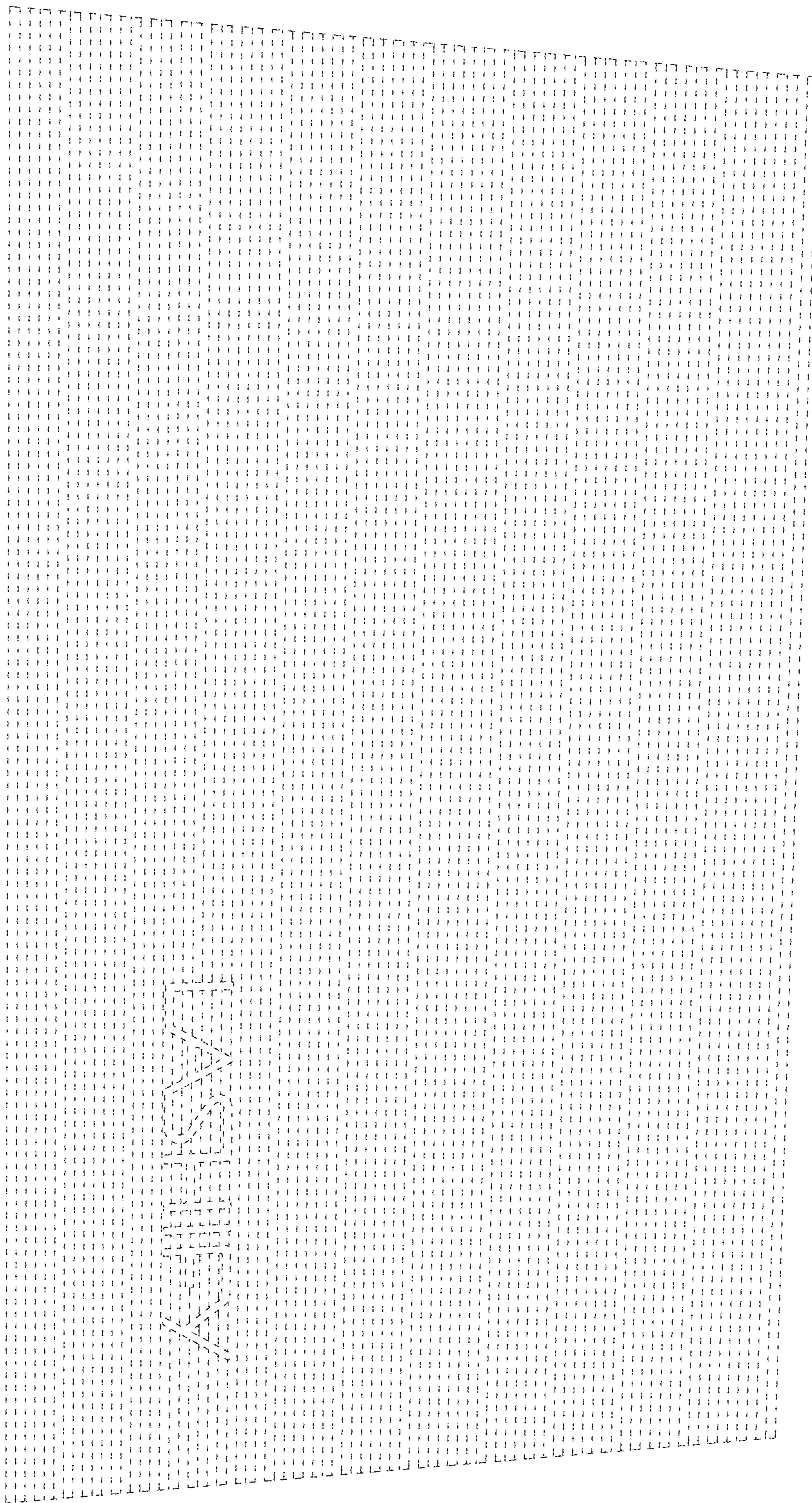

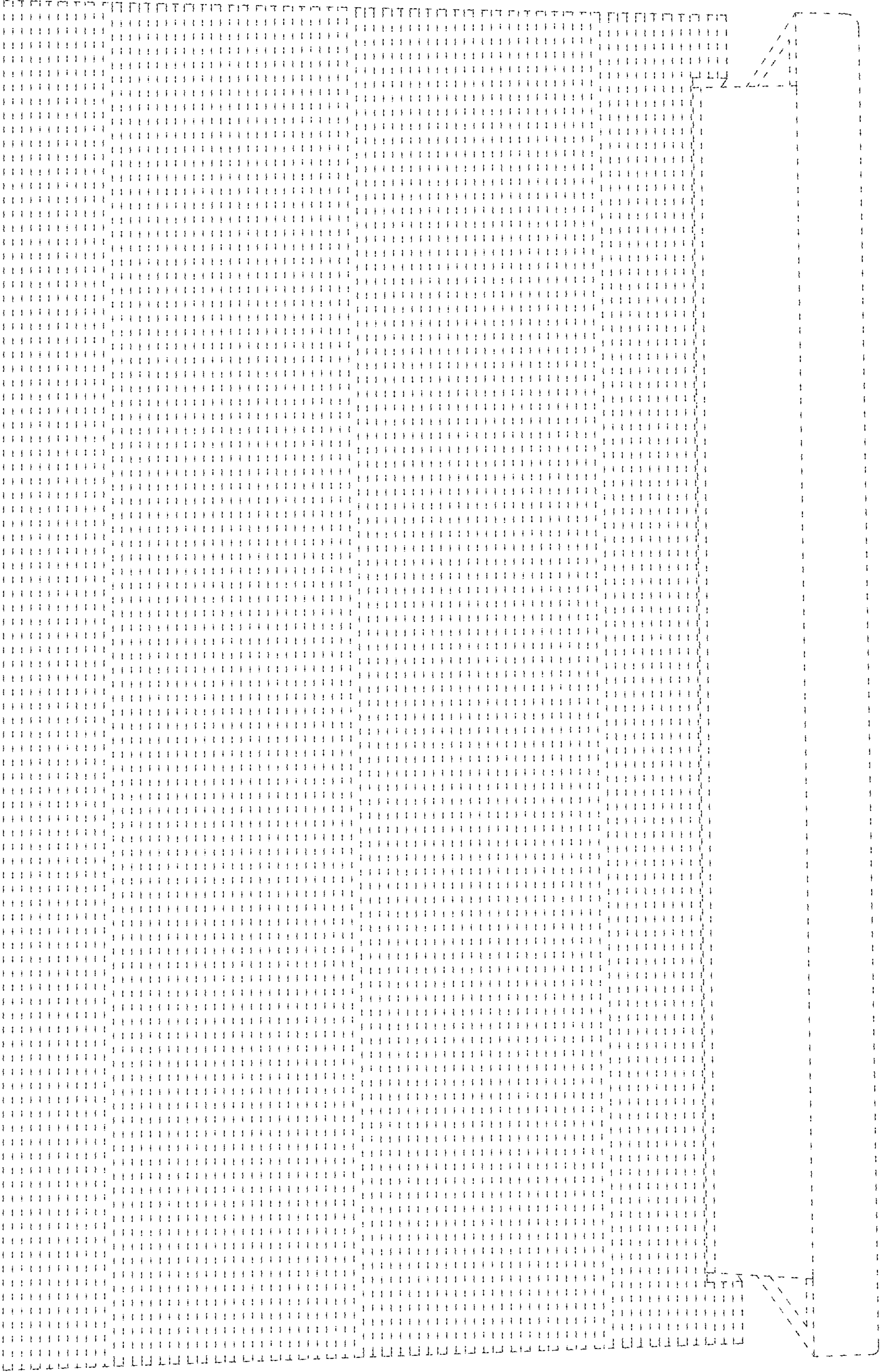

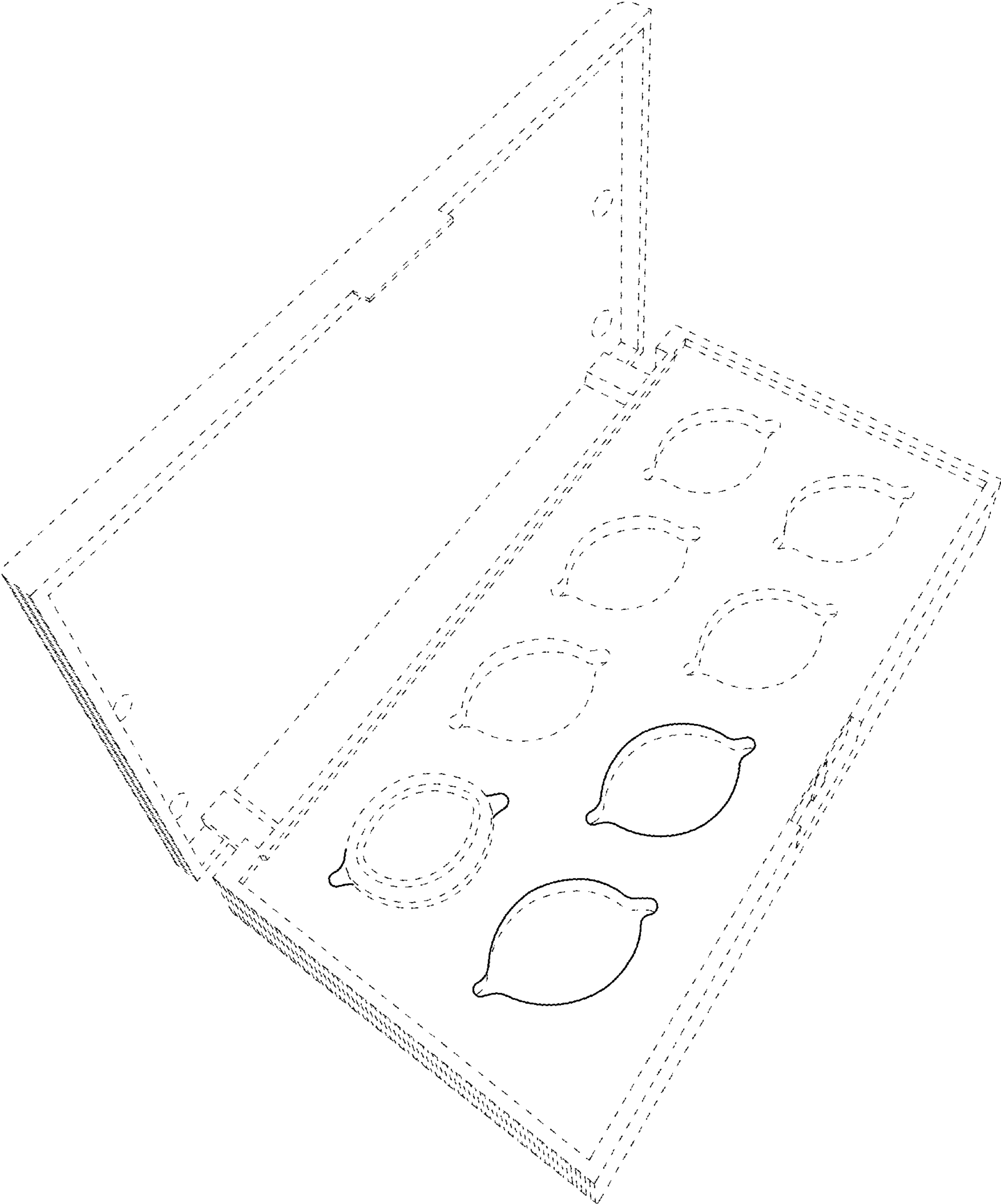
