(57) **CLAIM**

We claim the ornamental design for a bed with mattress, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bed with mattress showing the new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a left side elevation view thereof;

FIG. 5 is a right side elevation view thereof;

FIG. 6 is a top plan view thereof; and,

FIG. 7 is a bottom plan view thereof.

The broken lines shown in the drawings depict portions of the bed with mattress that form no part of the claimed design.

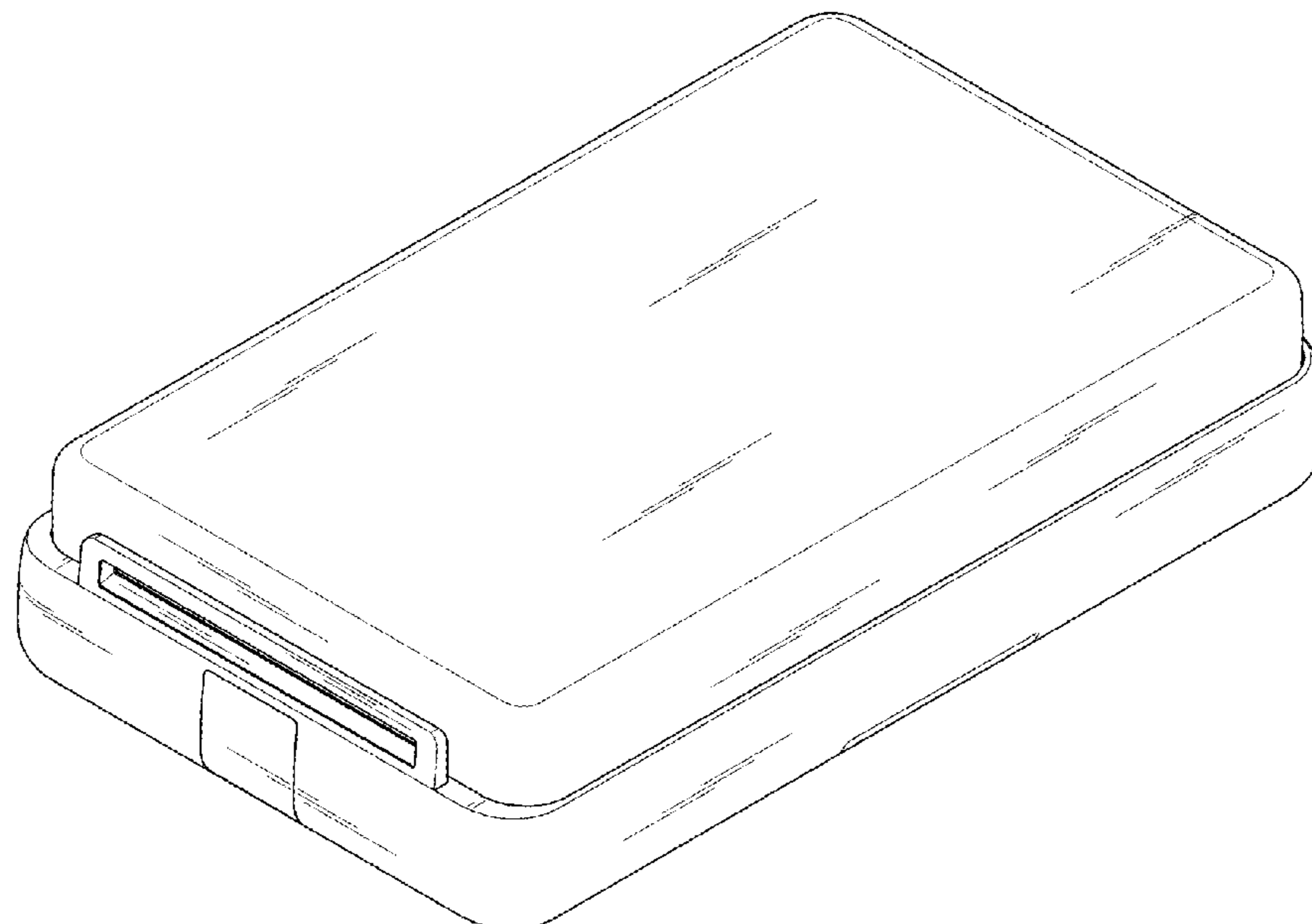

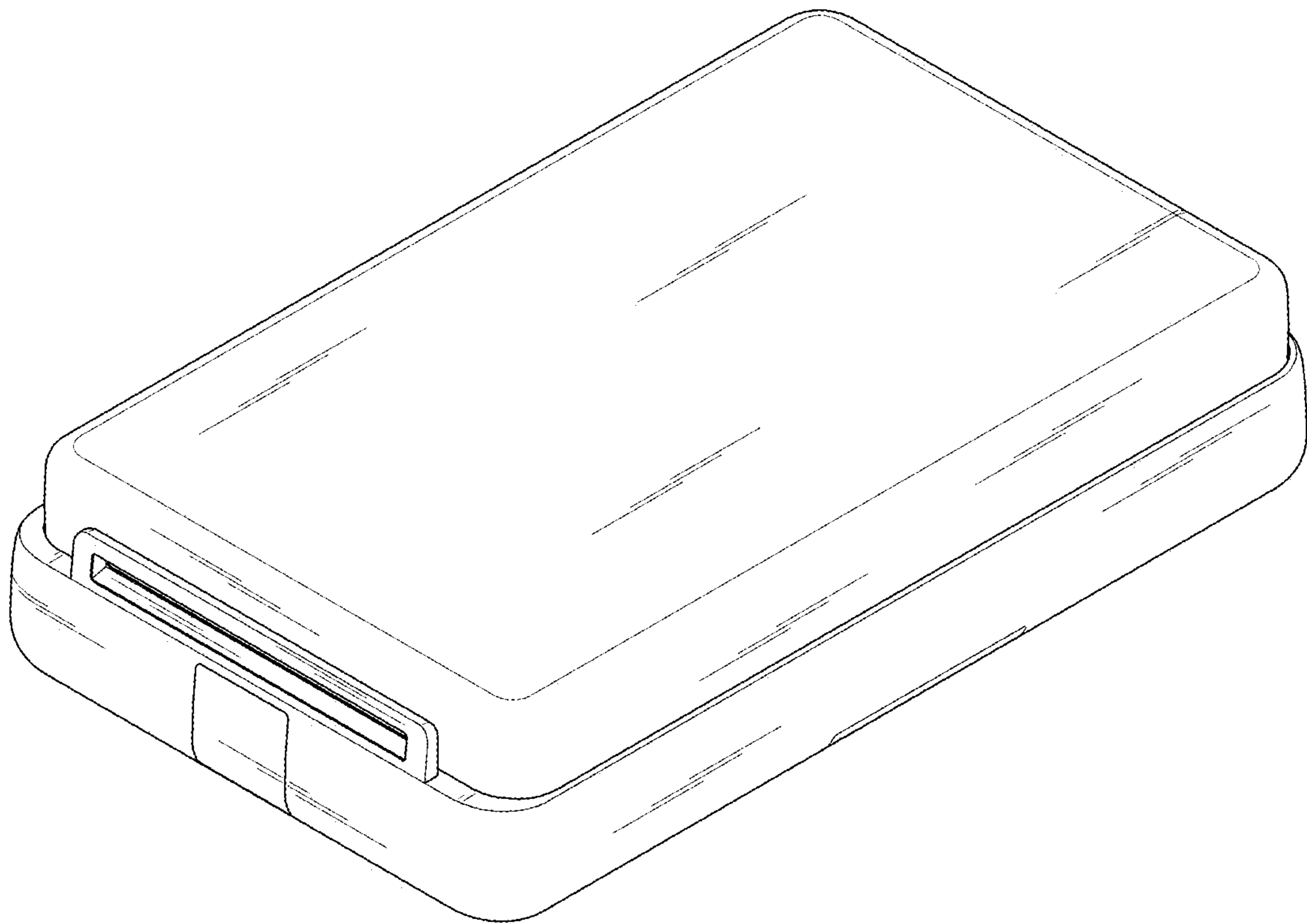

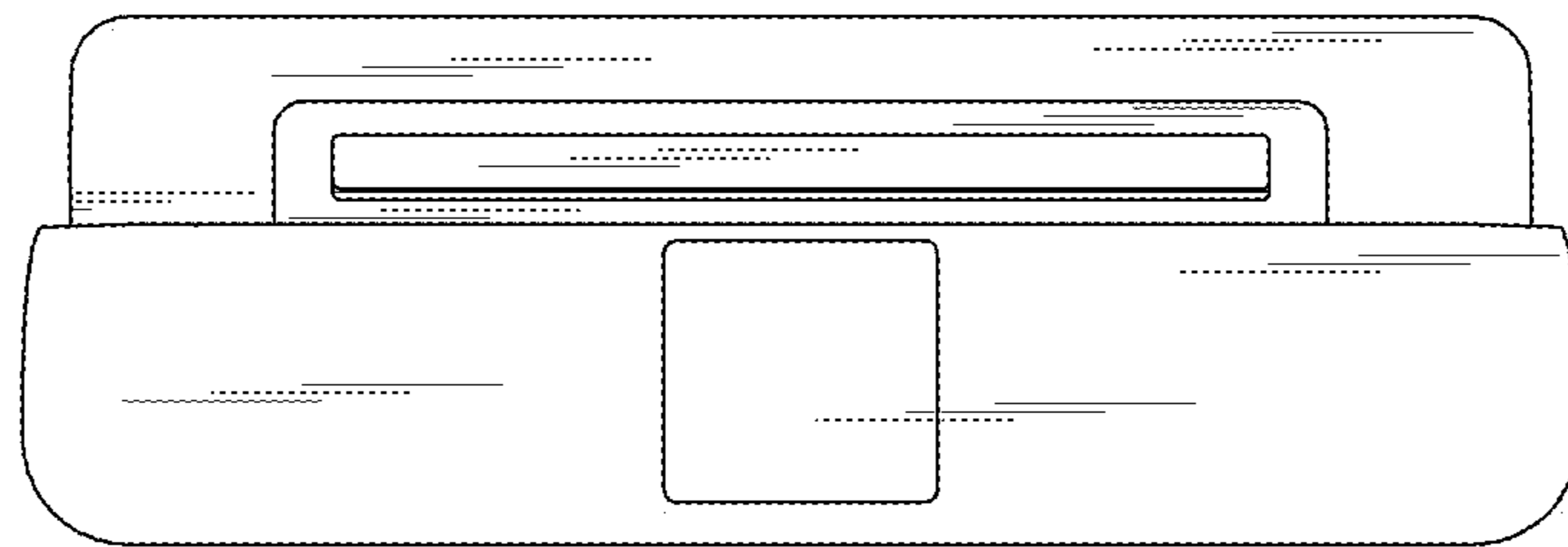

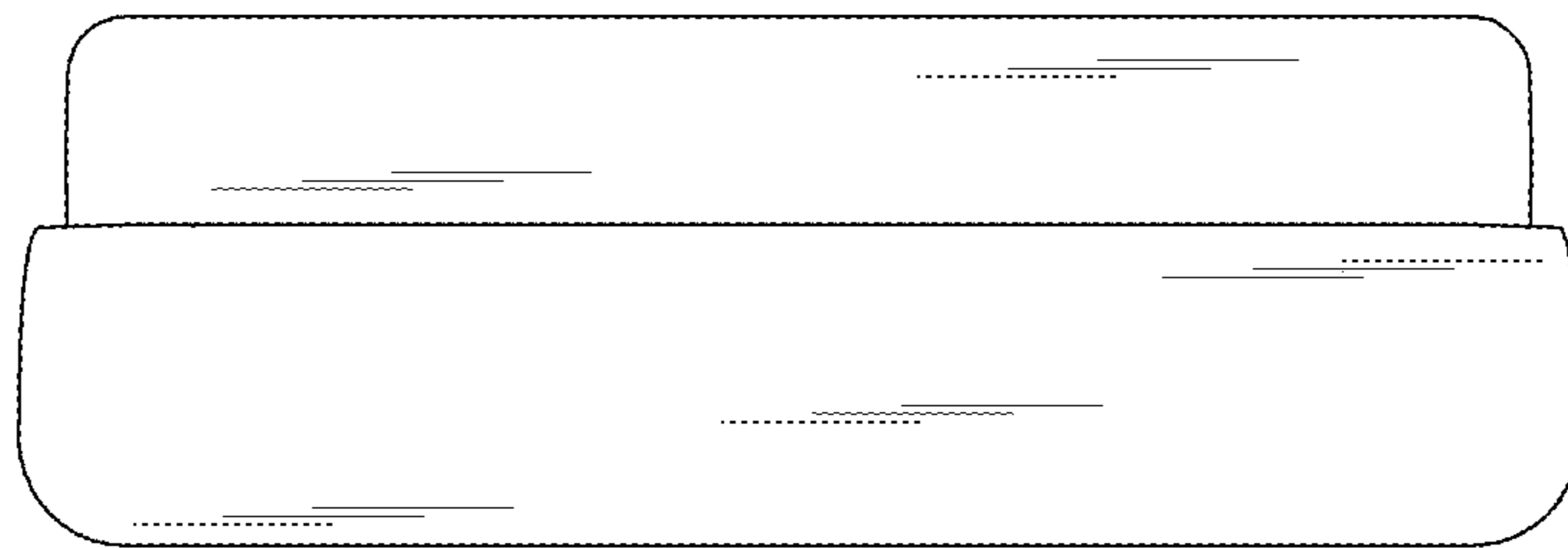

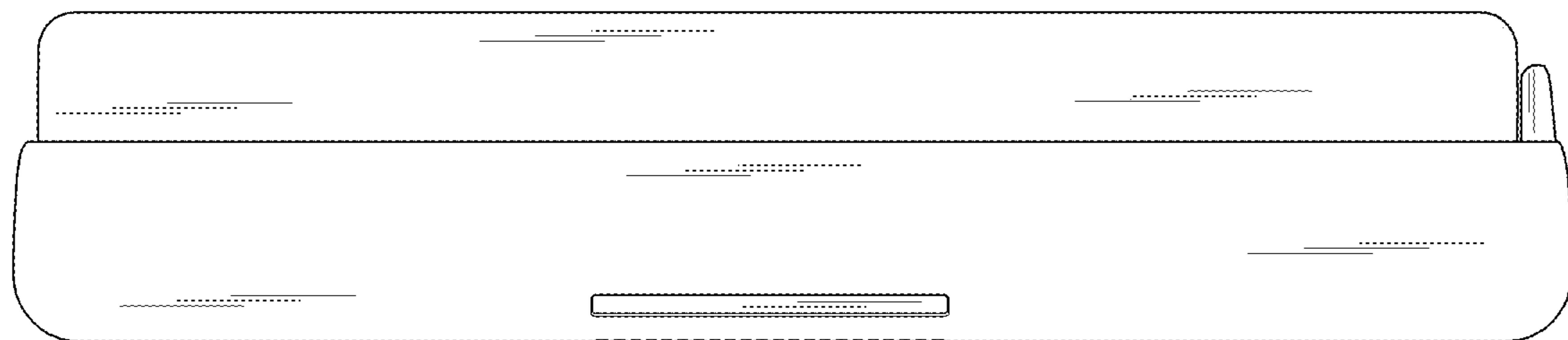

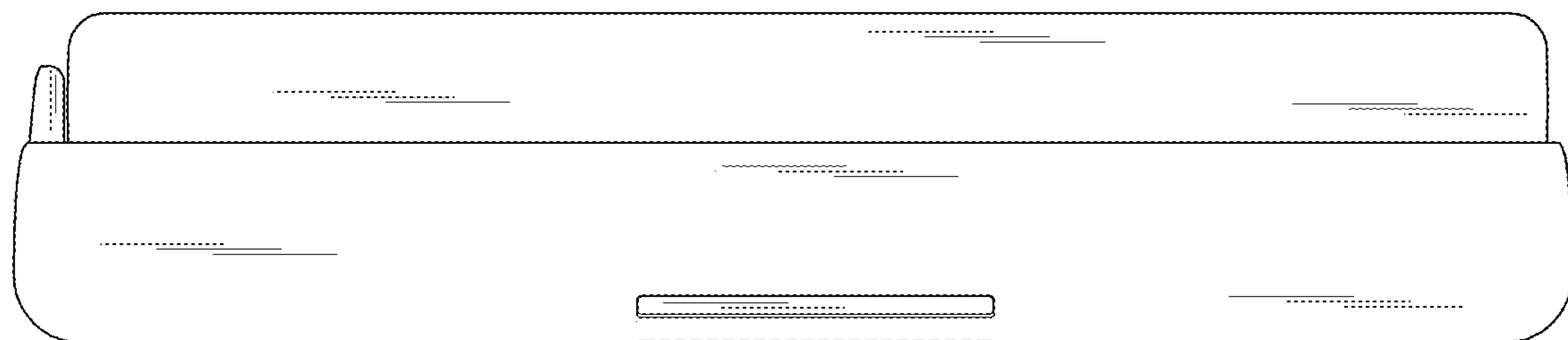

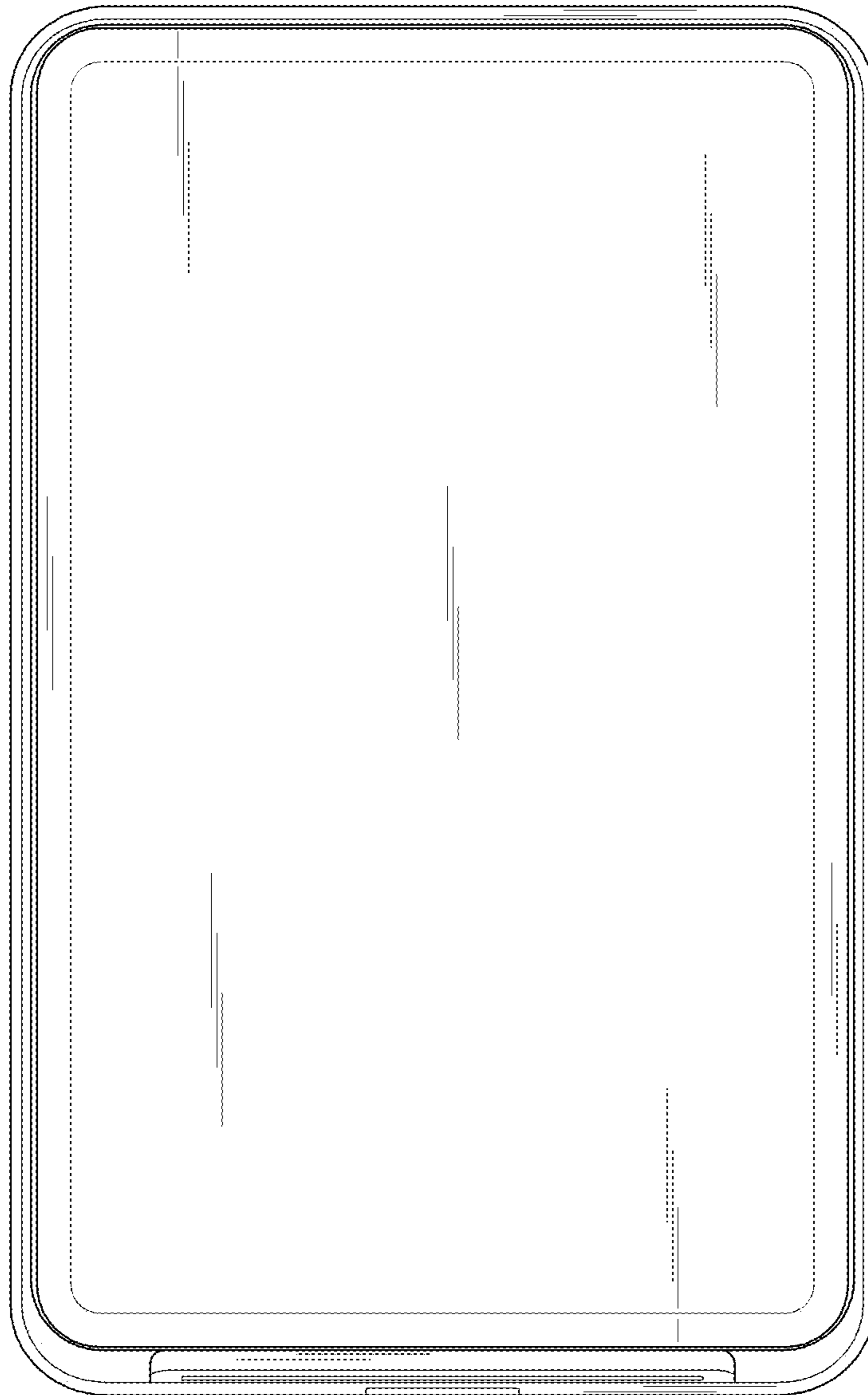
