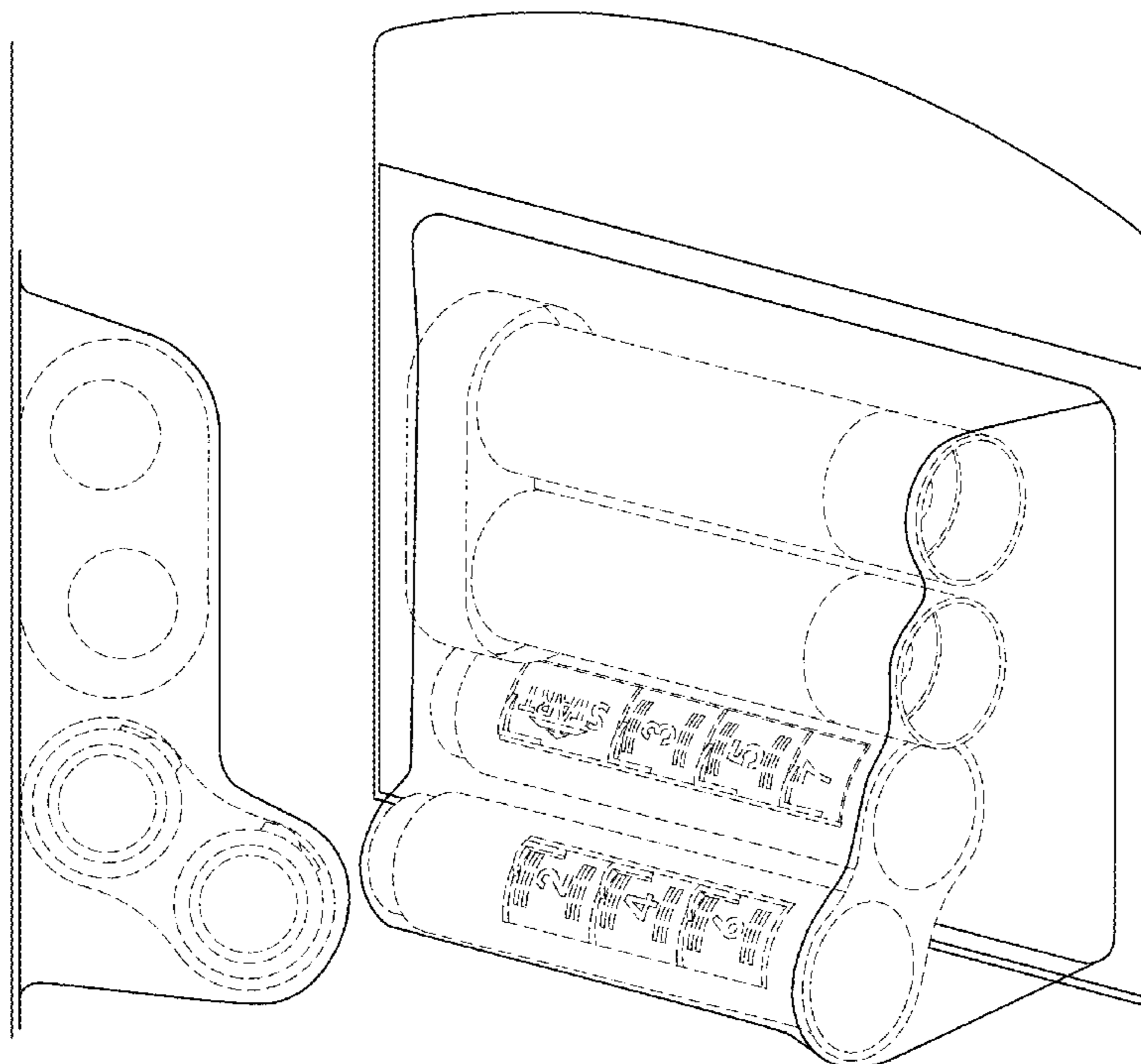

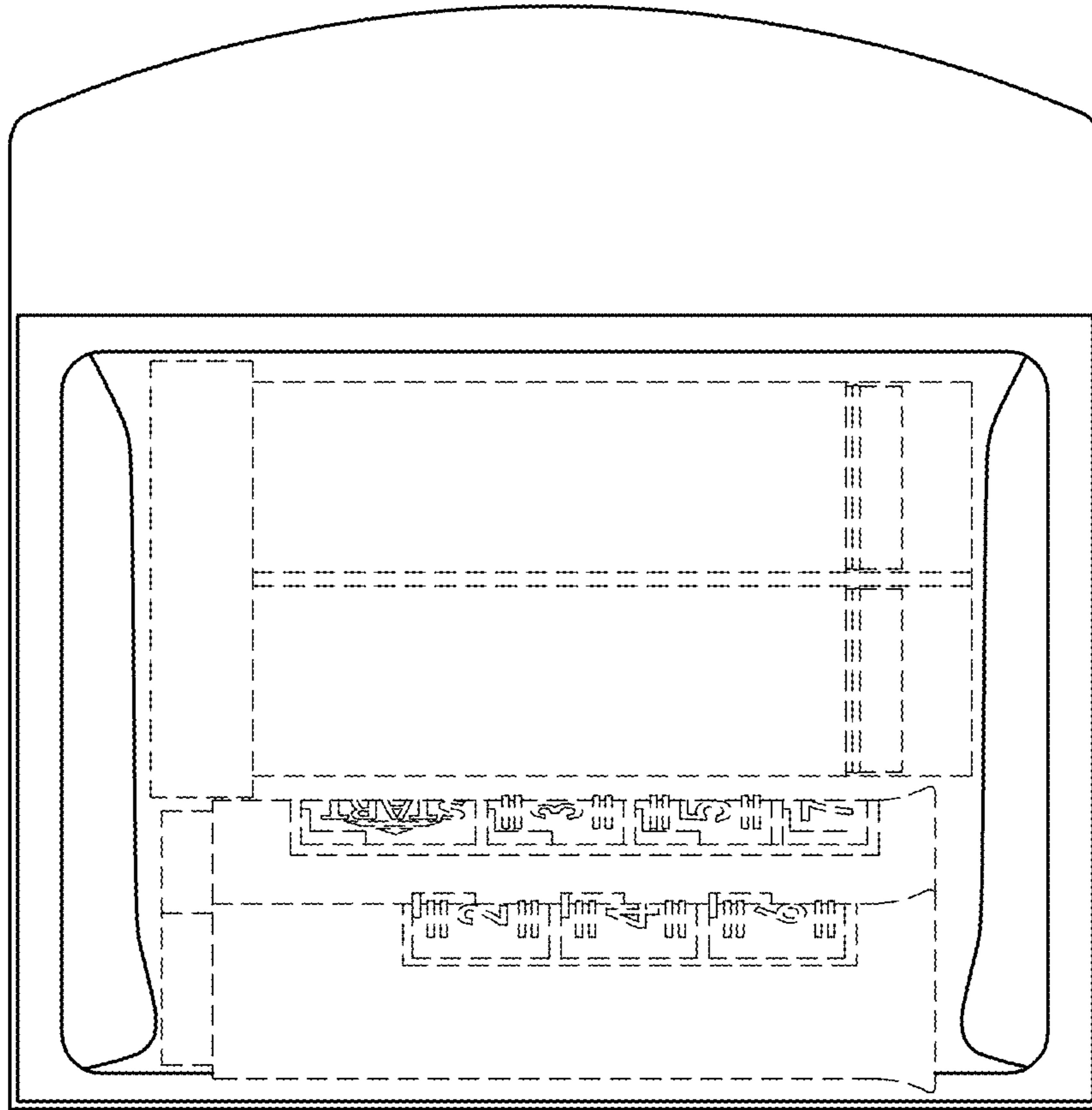

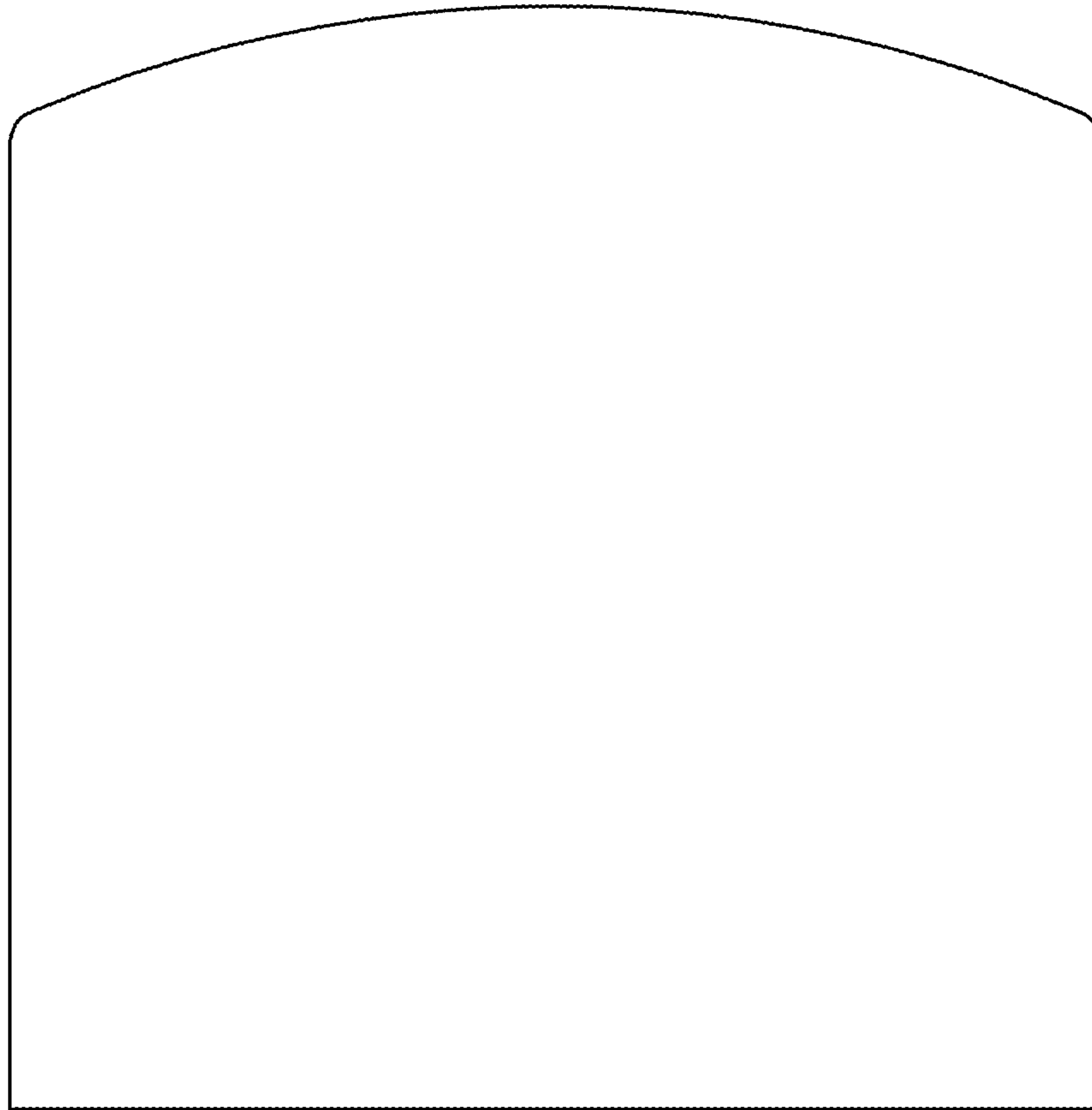
1. Blister package

The portions of the blister package shown in broken lines form no part of the claimed design.

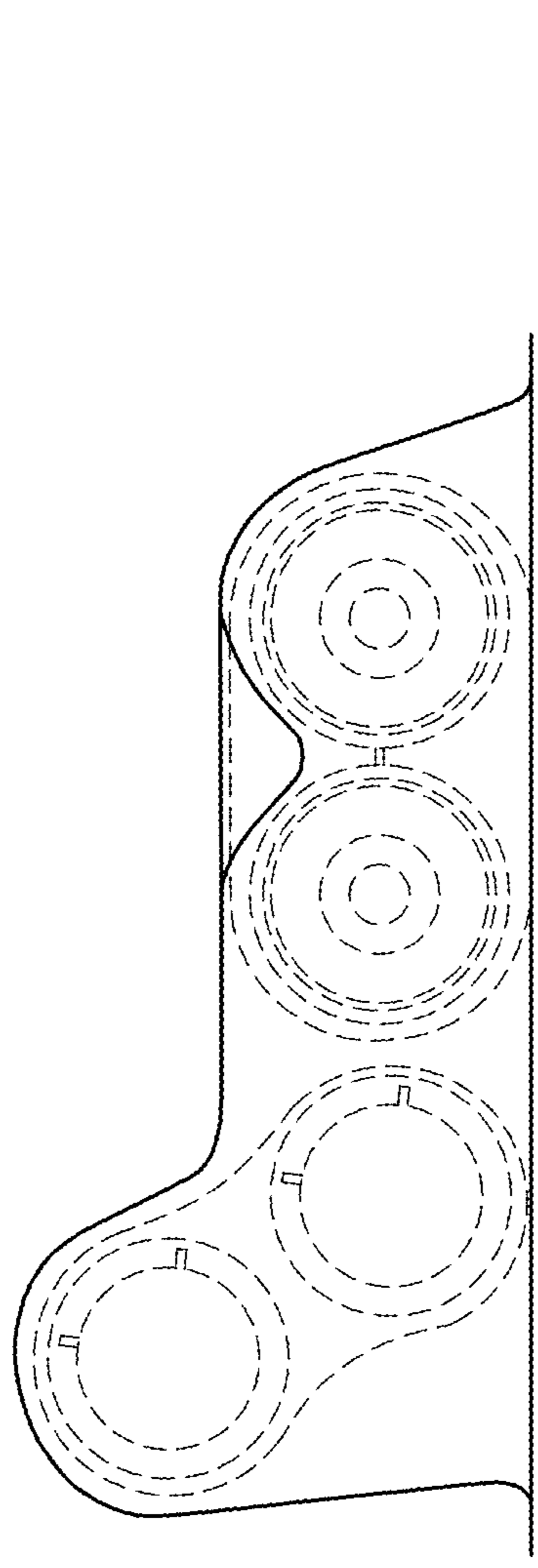

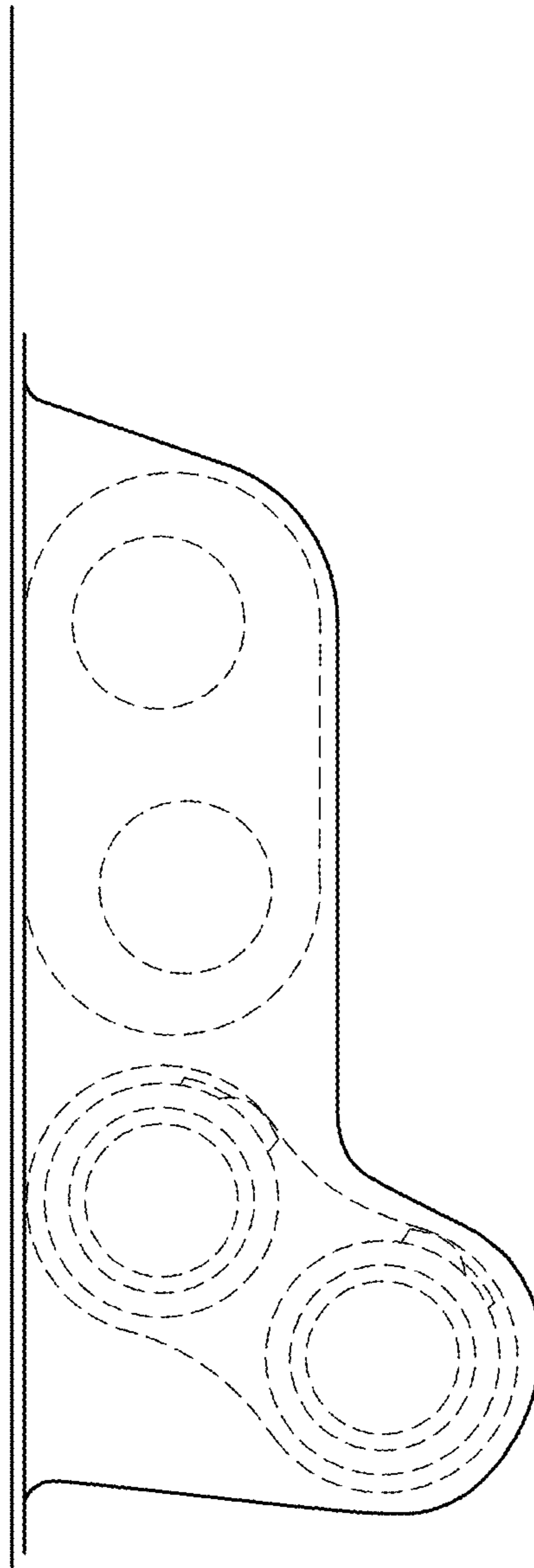

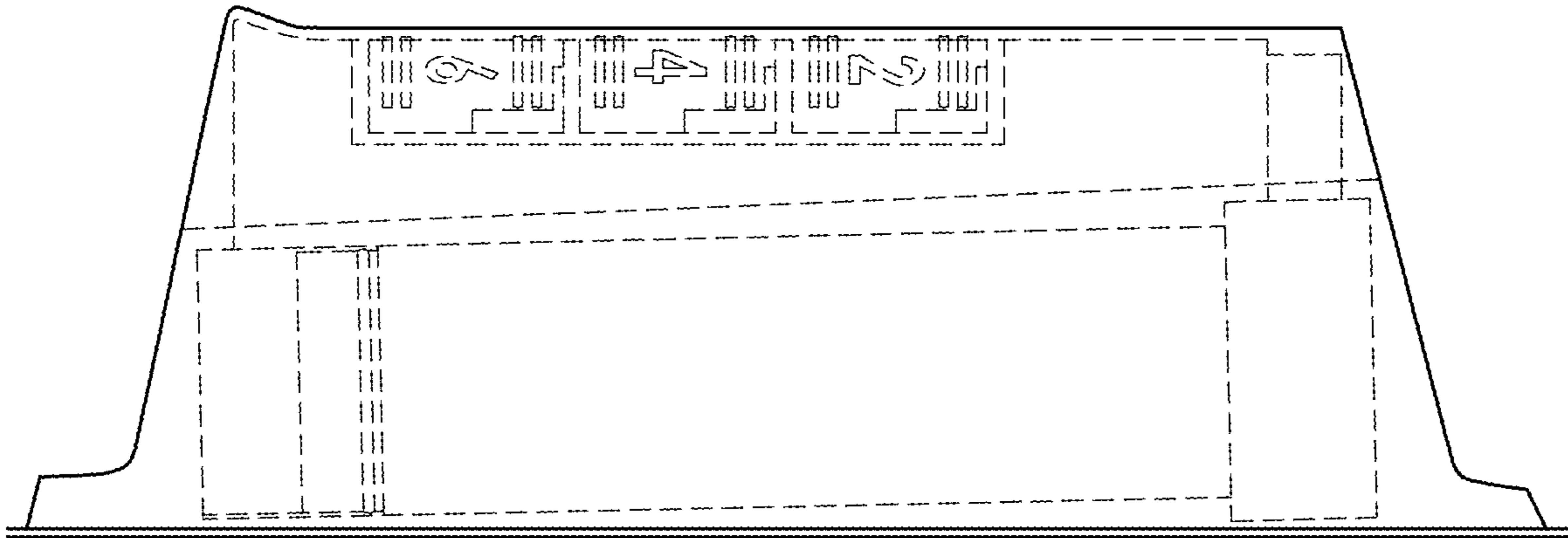




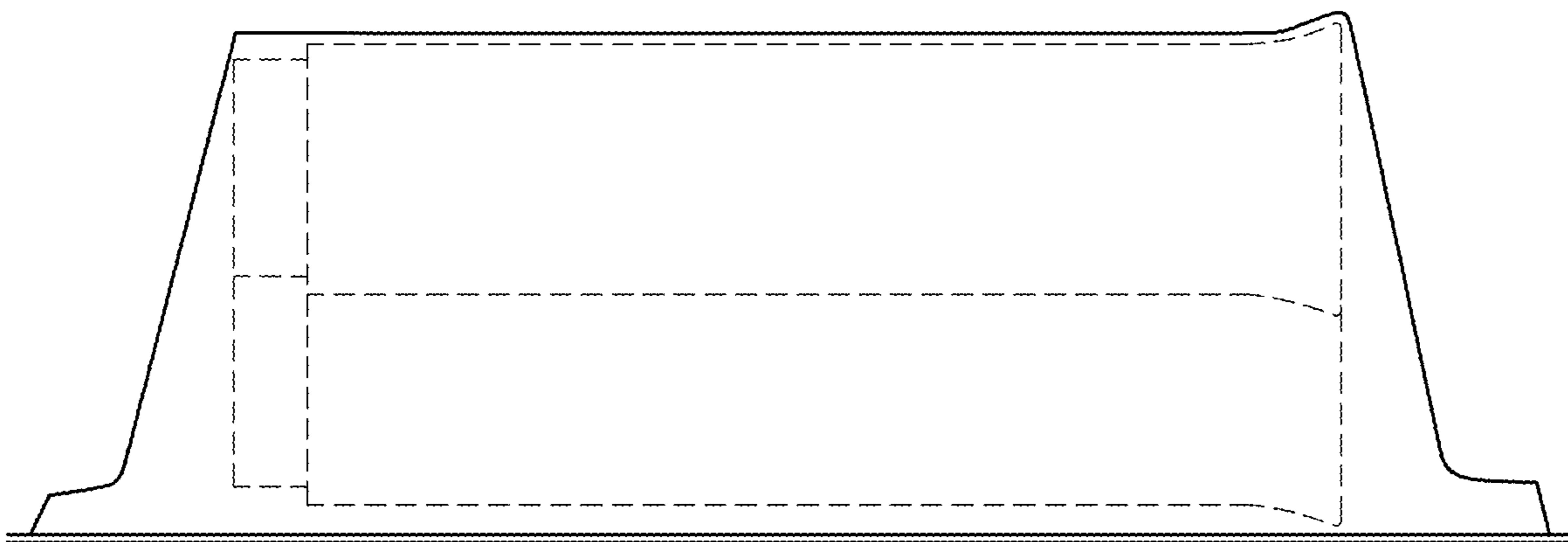
