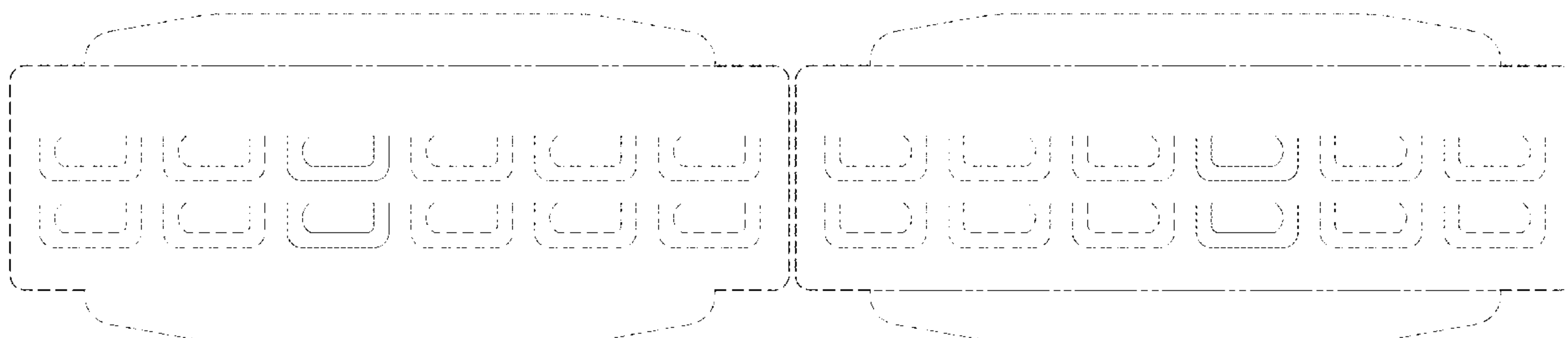

DESCRIPTION

FIG. 1 is a top view of a surgical procedure pack showing
our new design;
FIG. 2 is a bottom view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a front side view thereof; and,
FIG. 6 is a rear side view thereof.

The evenly broken lines illustrate portions of the surgical
procedure pack that form no part of the claimed design. The
dot-dot-dash lines represent the boundaries of the claim and
form no part thereof. The area of the wings between the
outer dotted lines and the dash-dot lines forms no part of the
claimed design. The surface of the central rectangular area

is claimed, but dashed lines shown in the central rectangular area are unclaimed tab border lines.

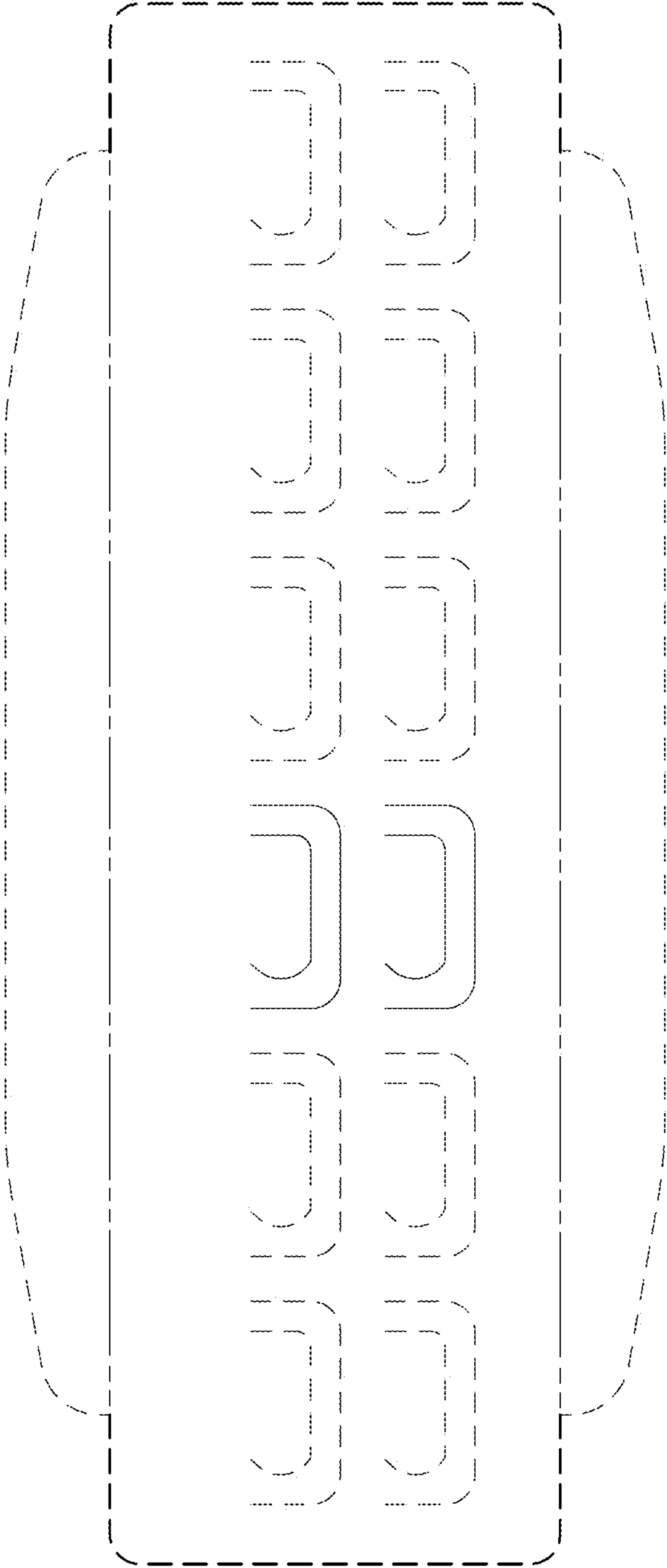

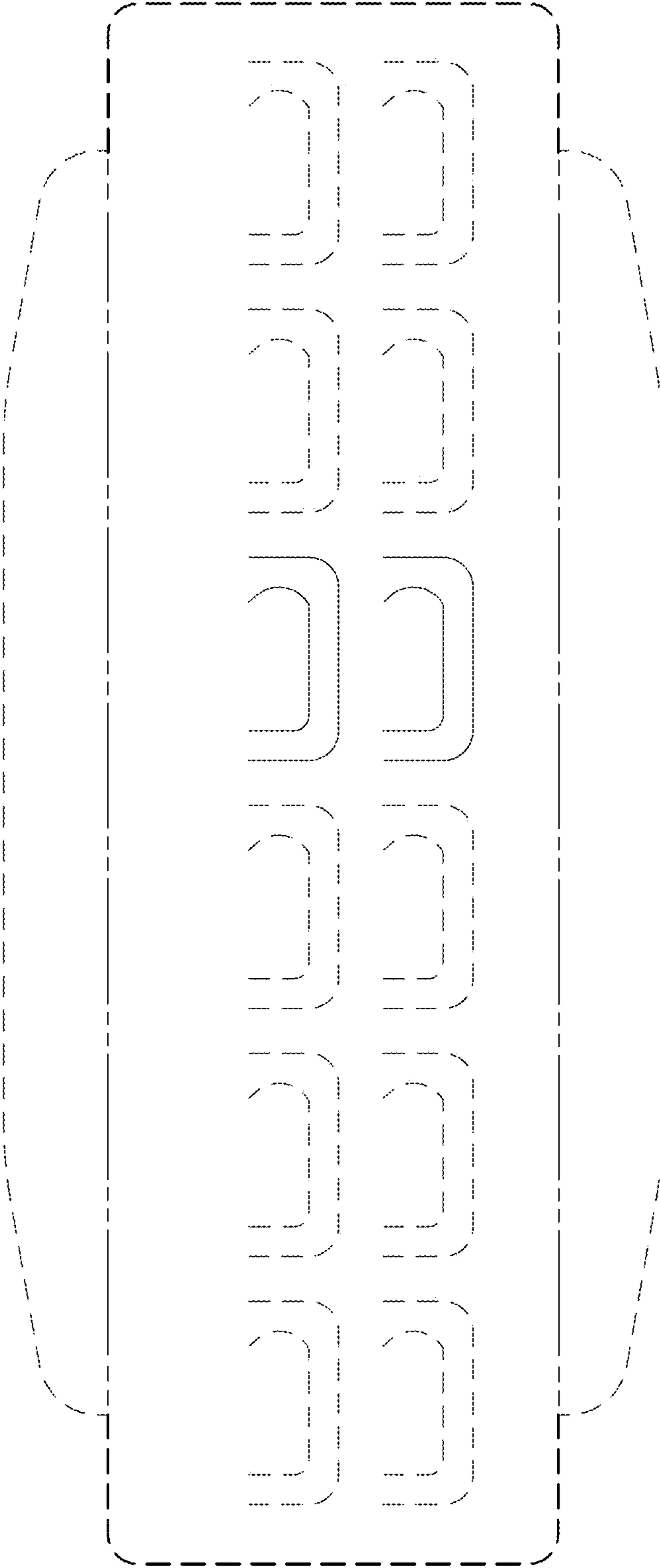

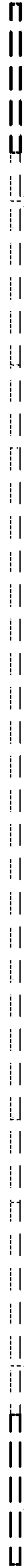

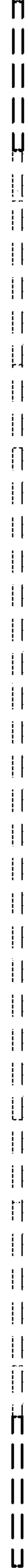

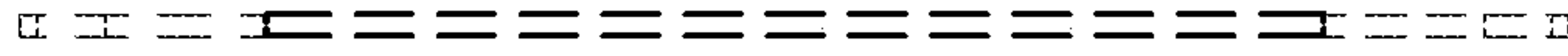

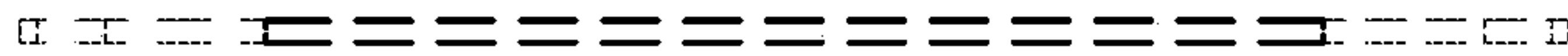
