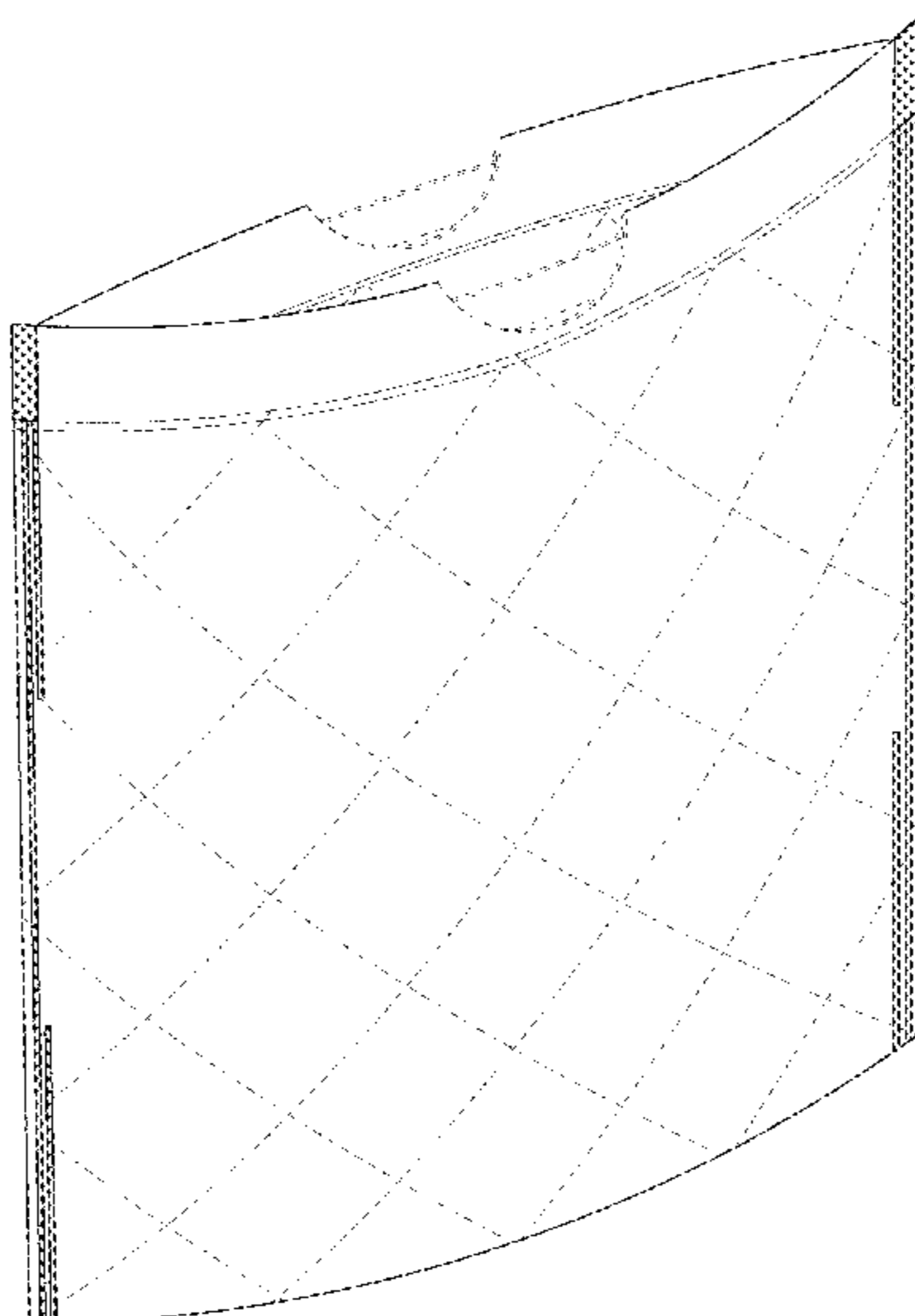
FIG. 1 is a top front perspective view of a bag showing the claimed design in an open configuration;

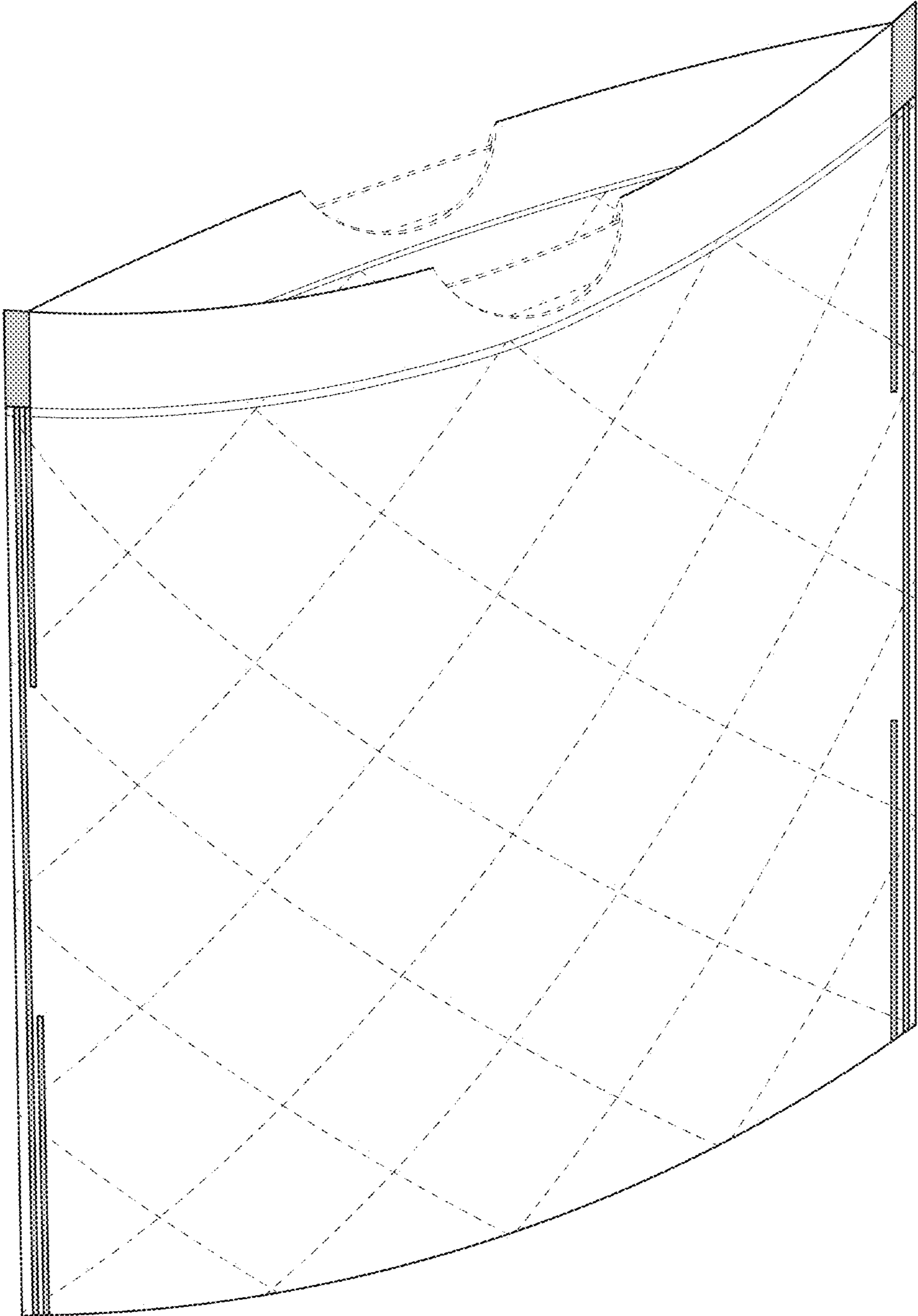

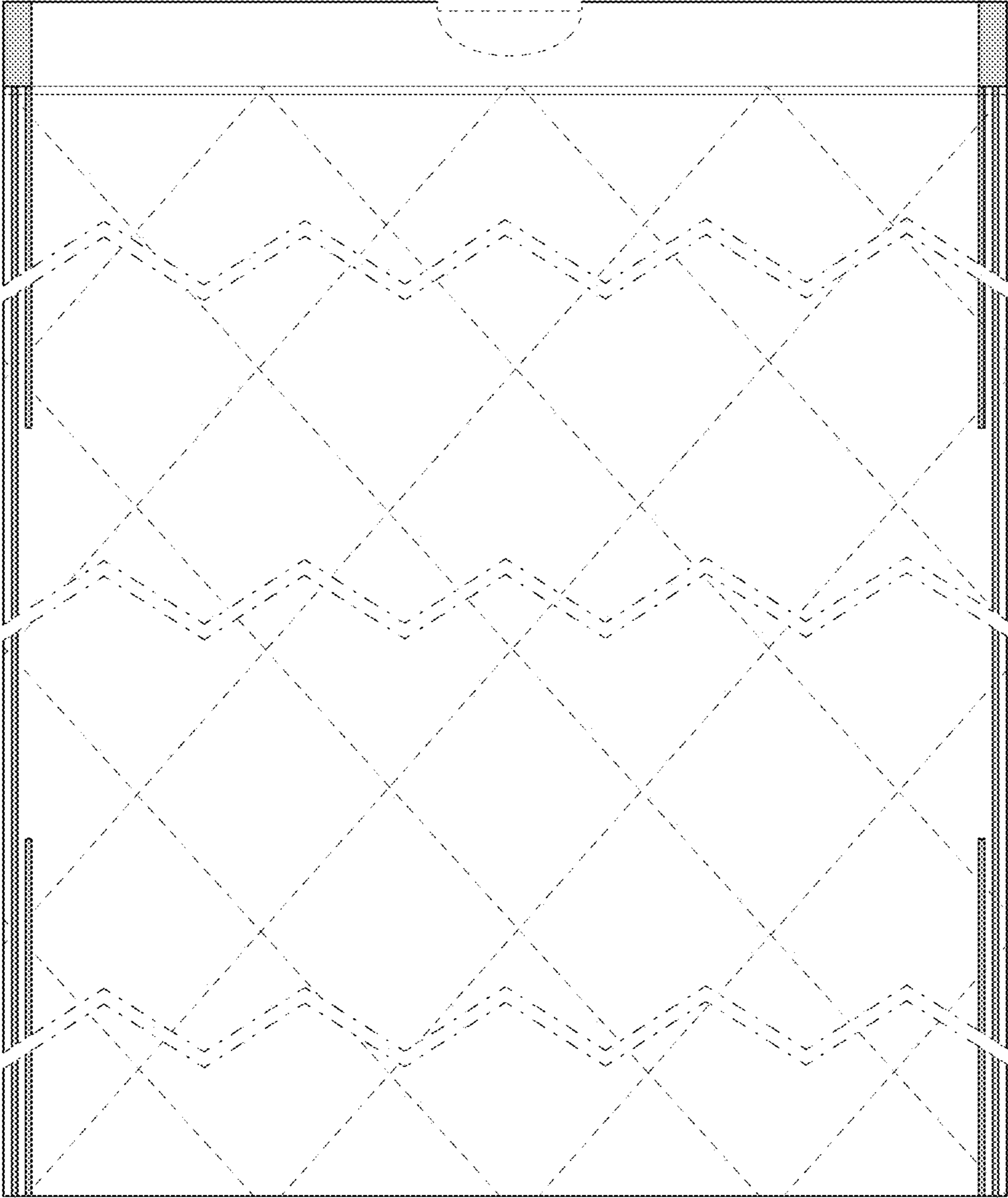

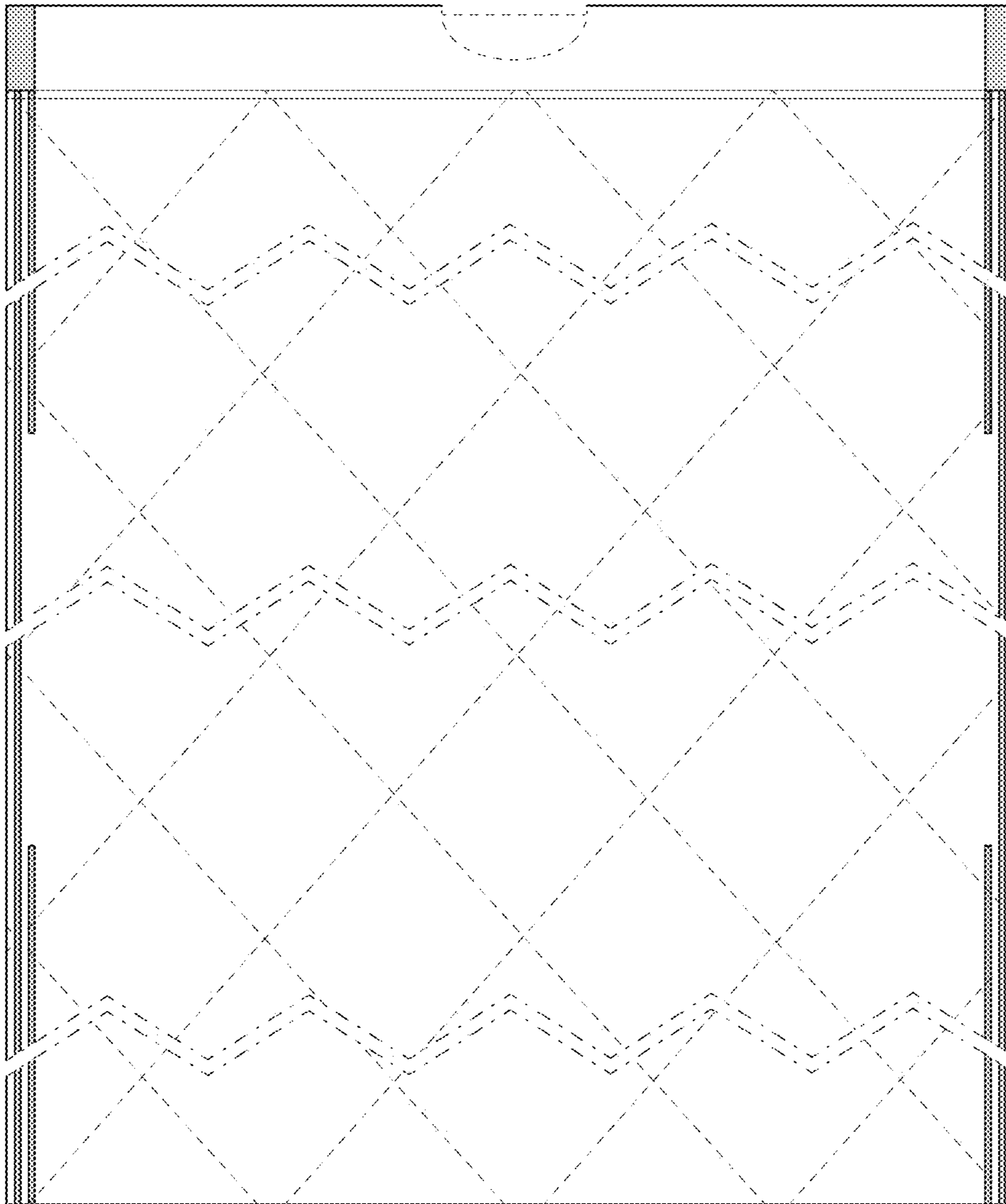

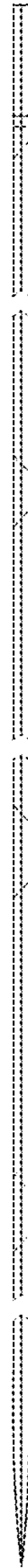

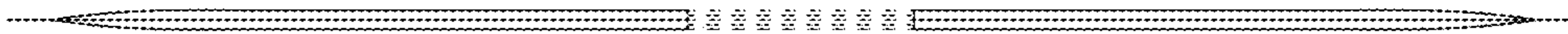

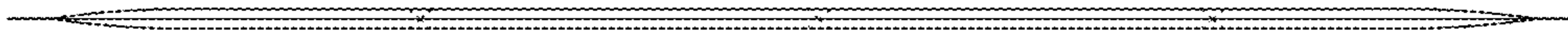
