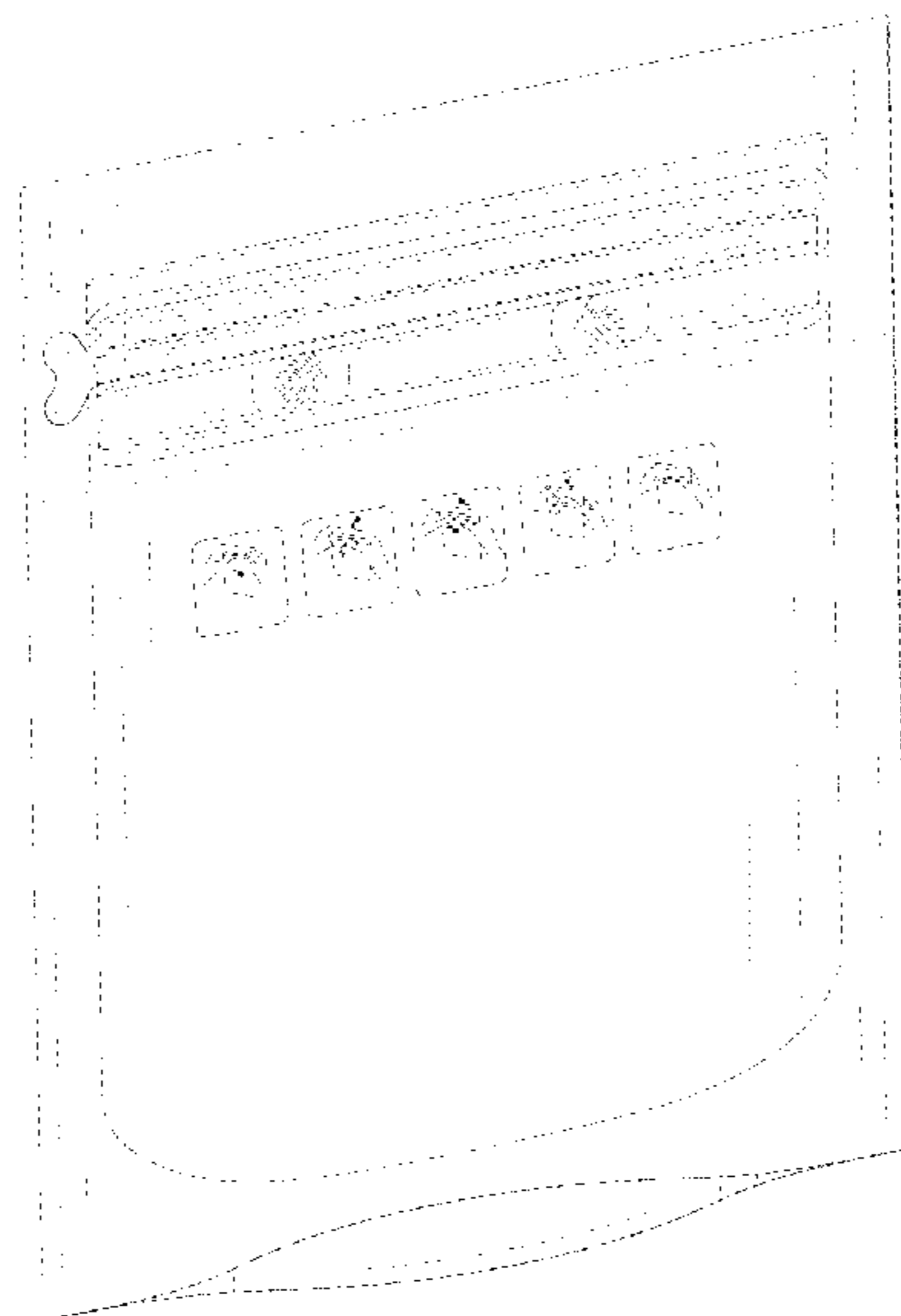
(57) **CLAIM**

The ornamental design for a child resistant tamper evident side open zipper bag, as shown and described.

DESCRIPTION

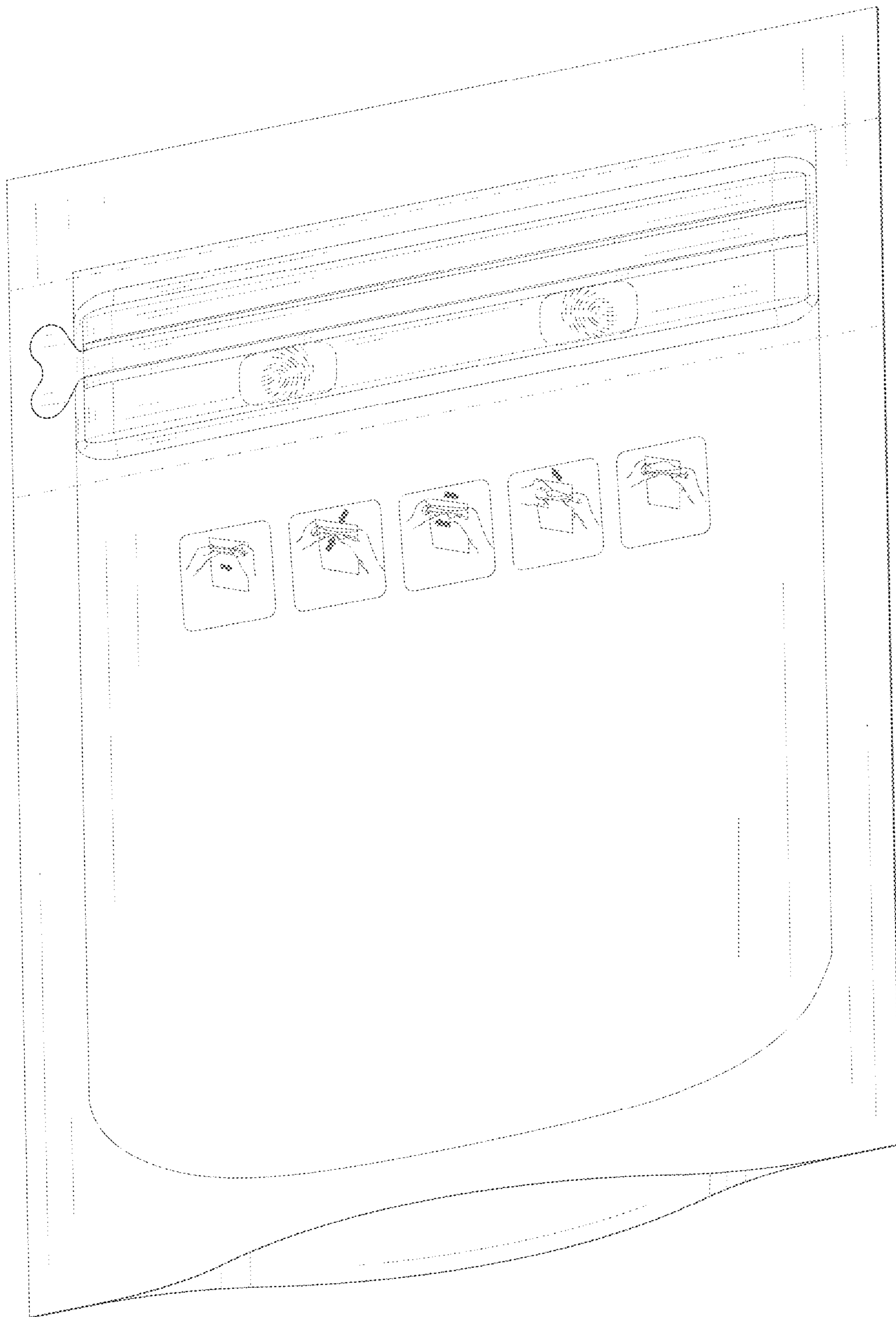

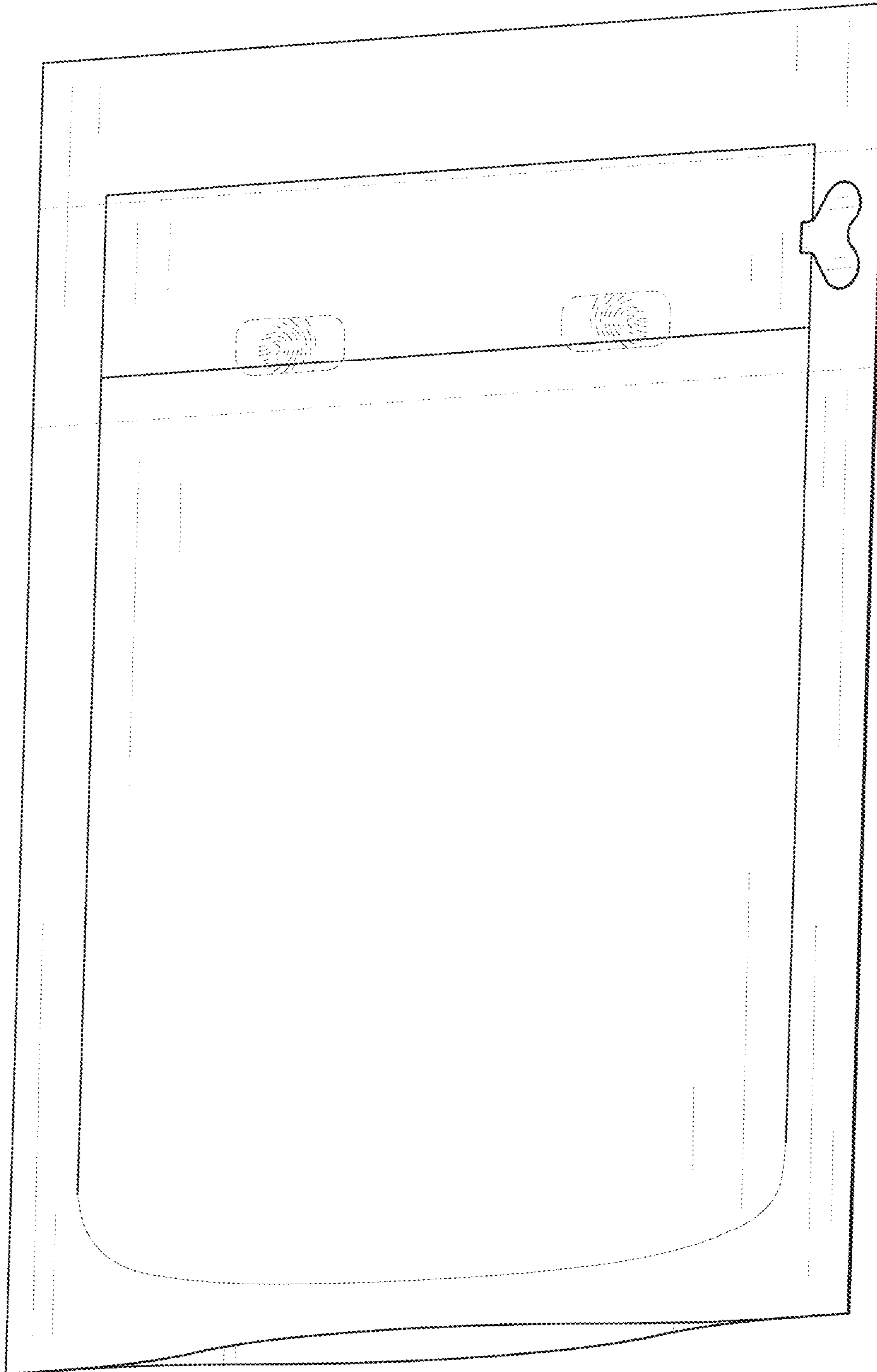

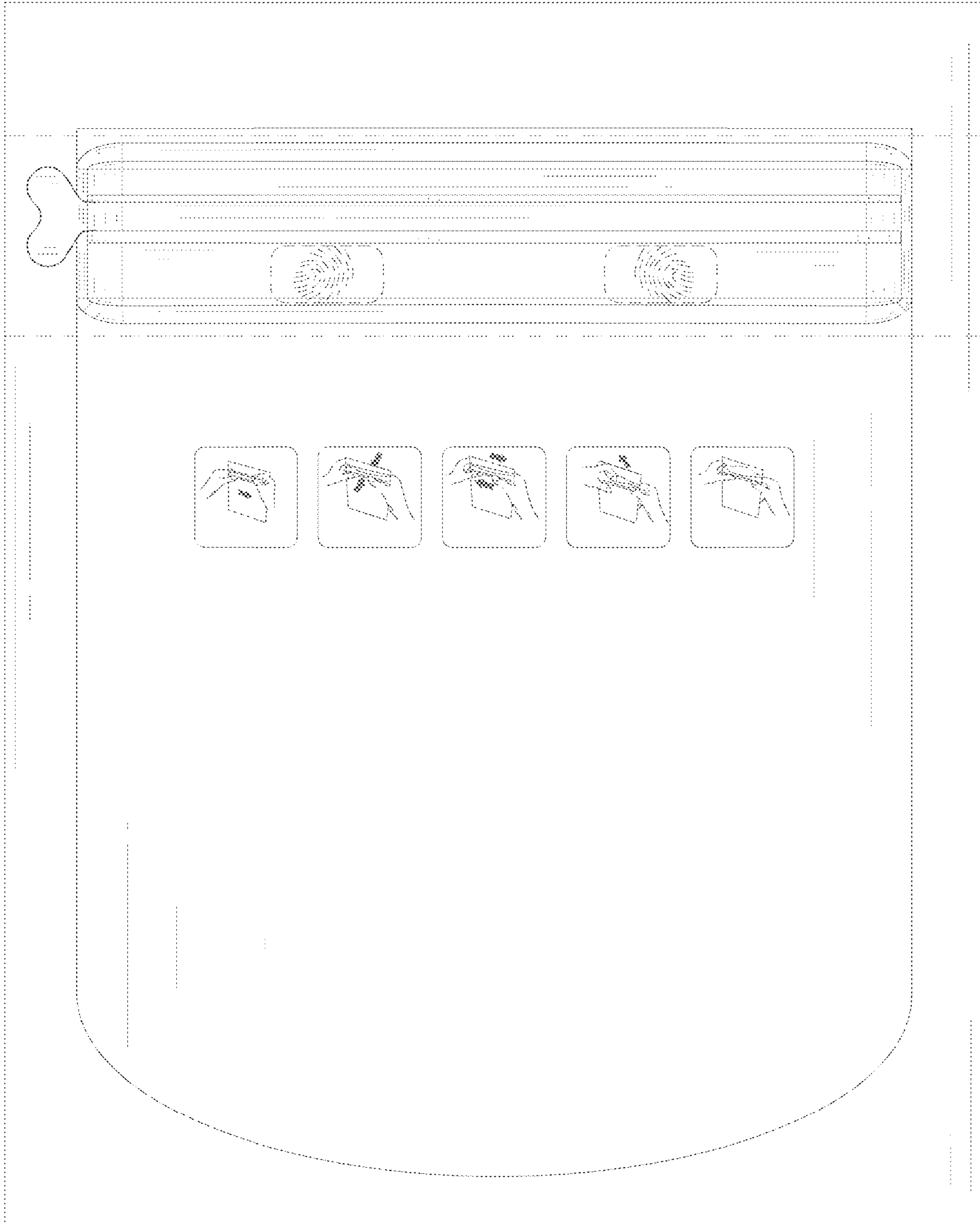

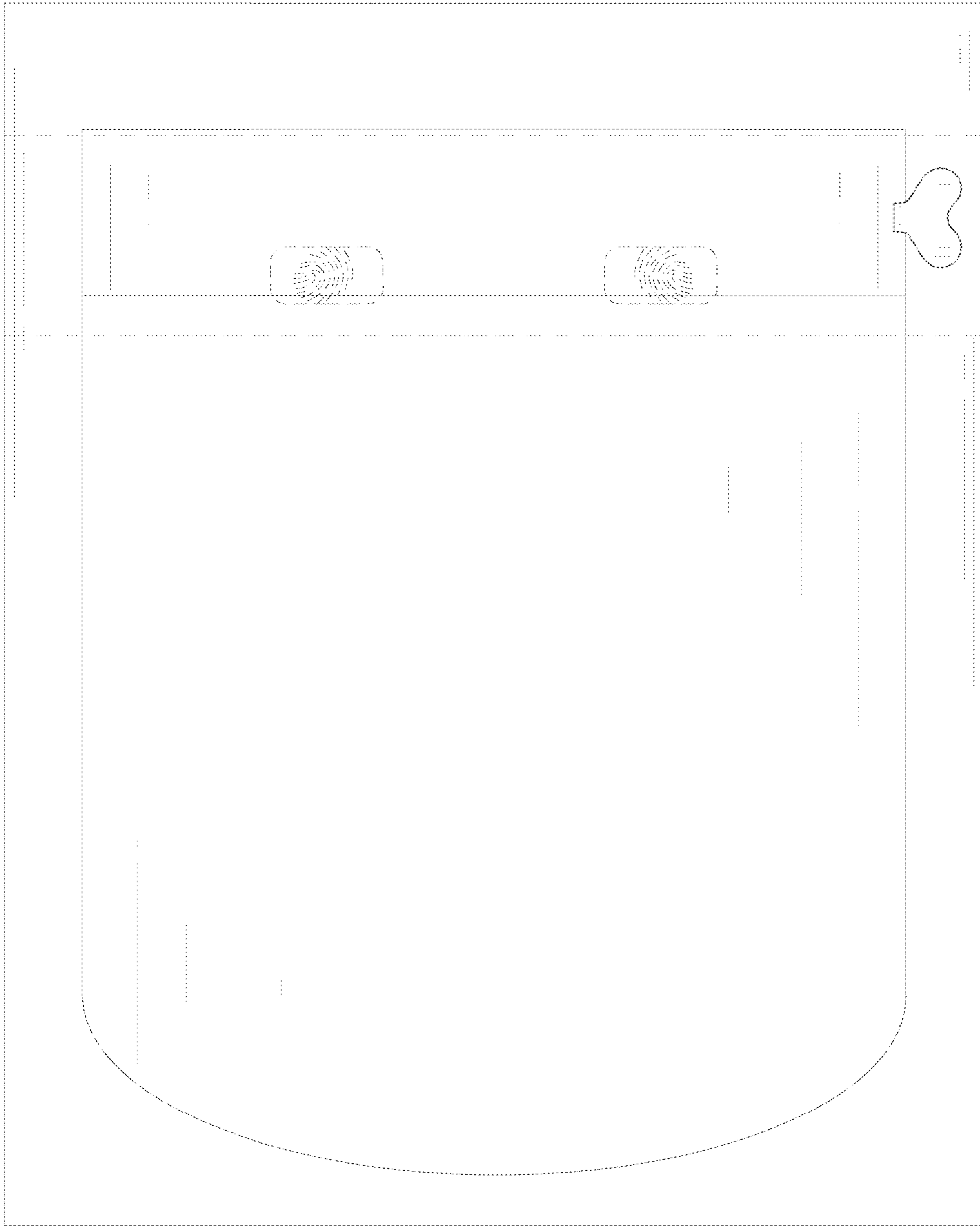

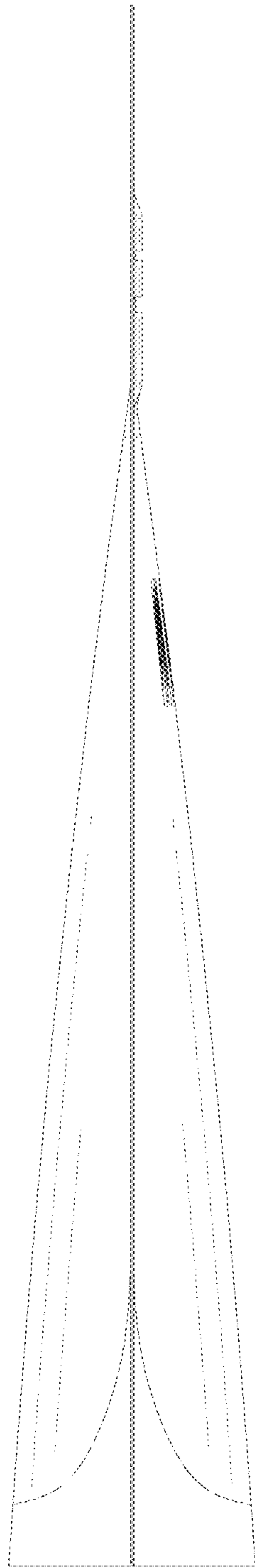

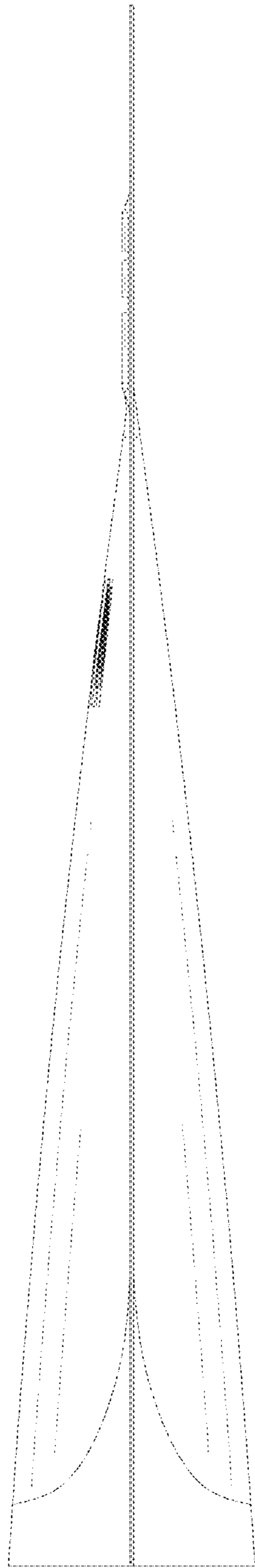

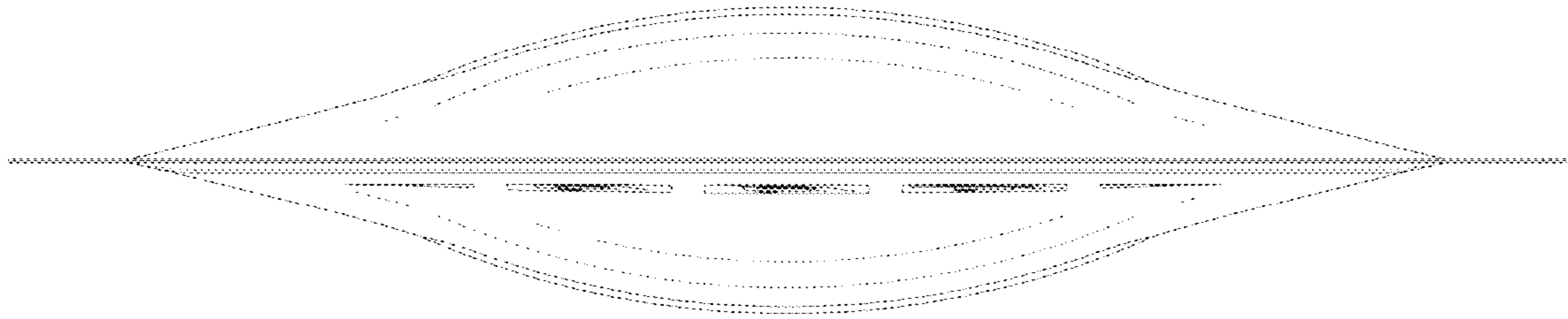

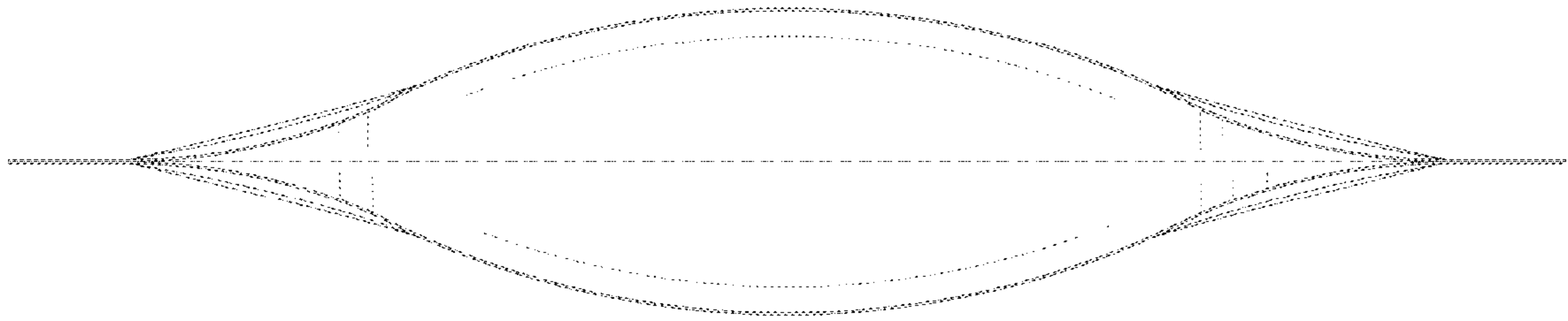
