(57) **CLAIM**

The ornamental design for a bottle having dual configuration, as shown and described.

DESCRIPTION

FIG. 1 is a front left side perspective view showing the new design for a bottle having dual configuration; FIG. 2 is a front, bottom side perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a right side view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof. The broken lines shown illustrate portions of the bottle having dual configuration and form no part of the claimed design.

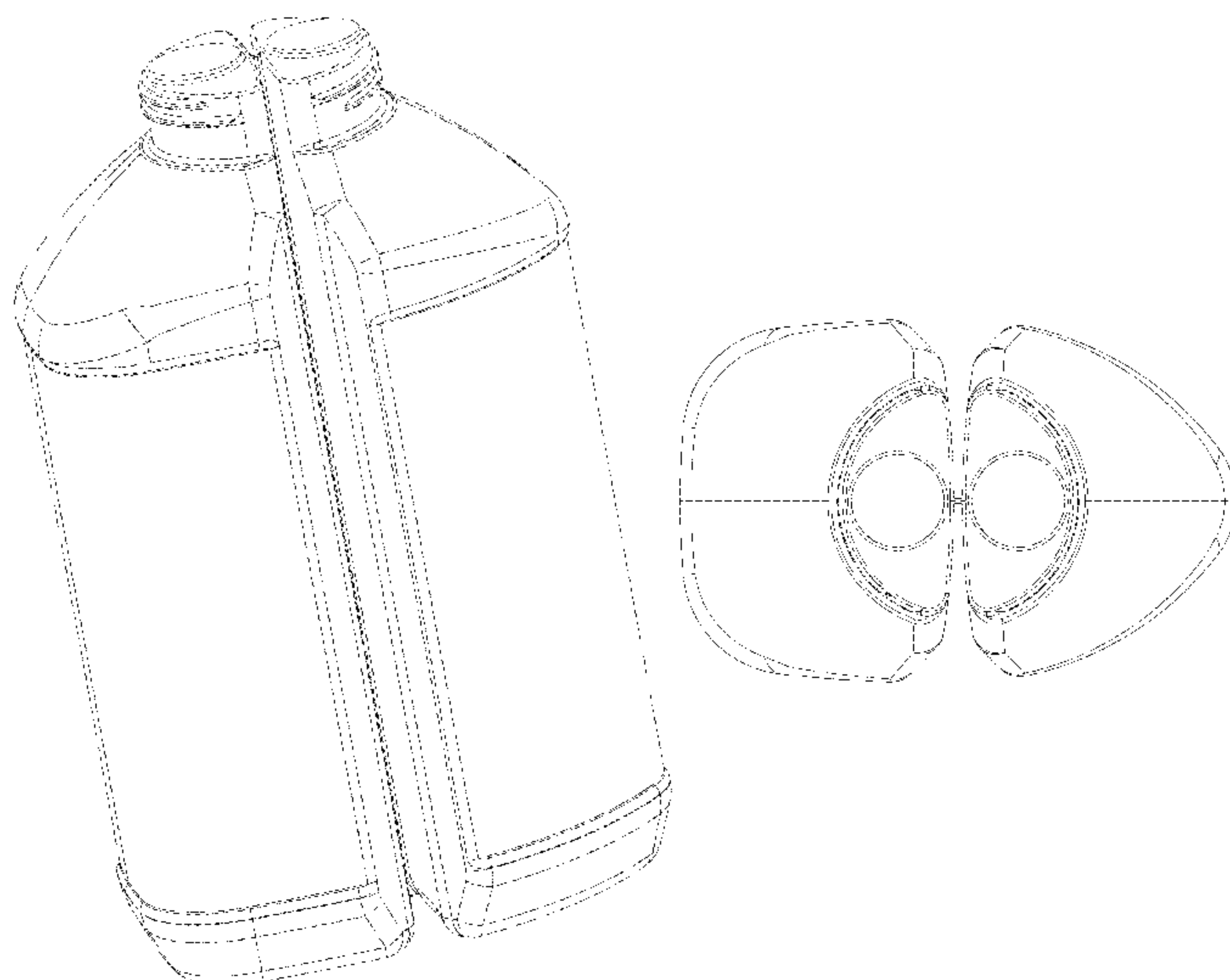

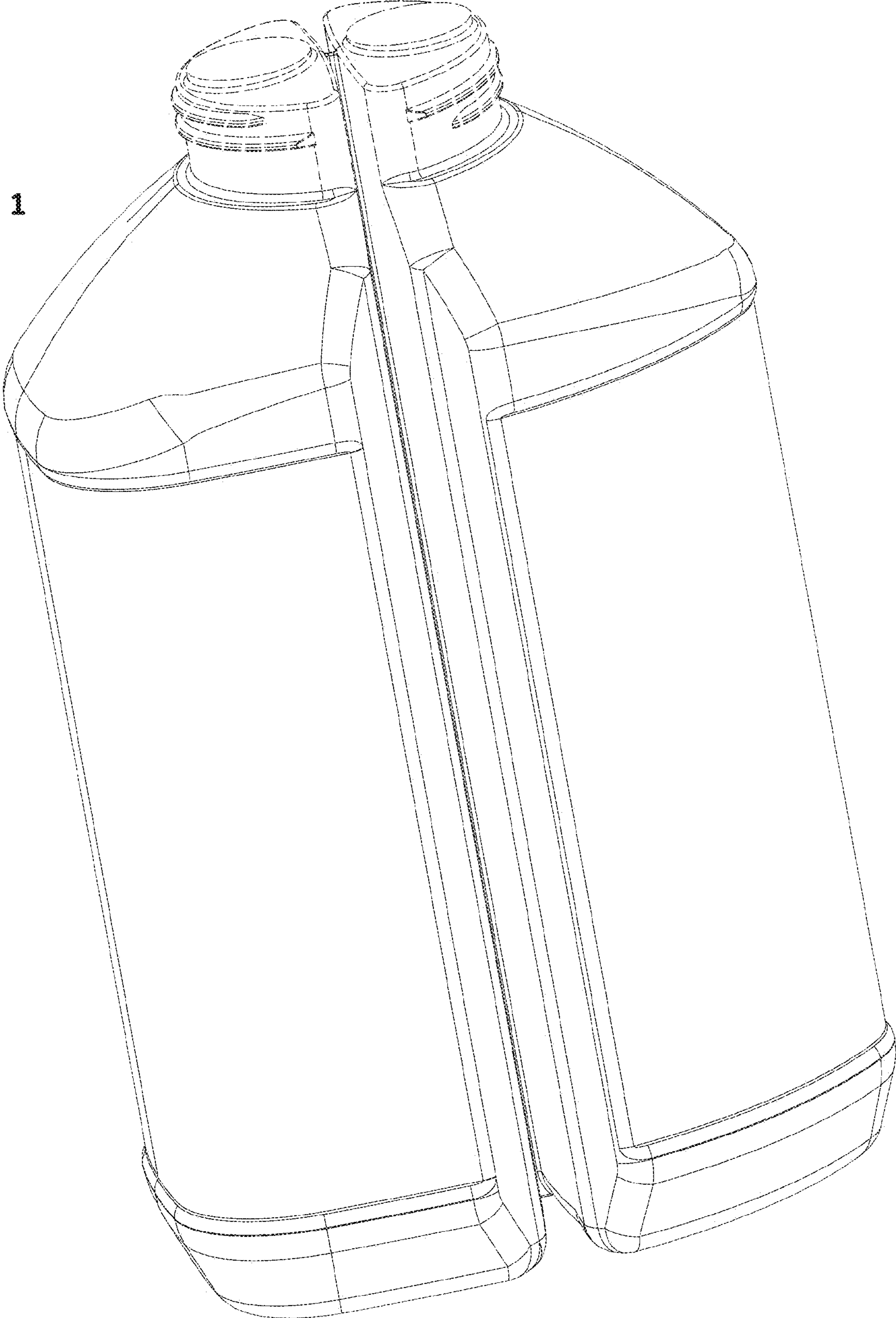

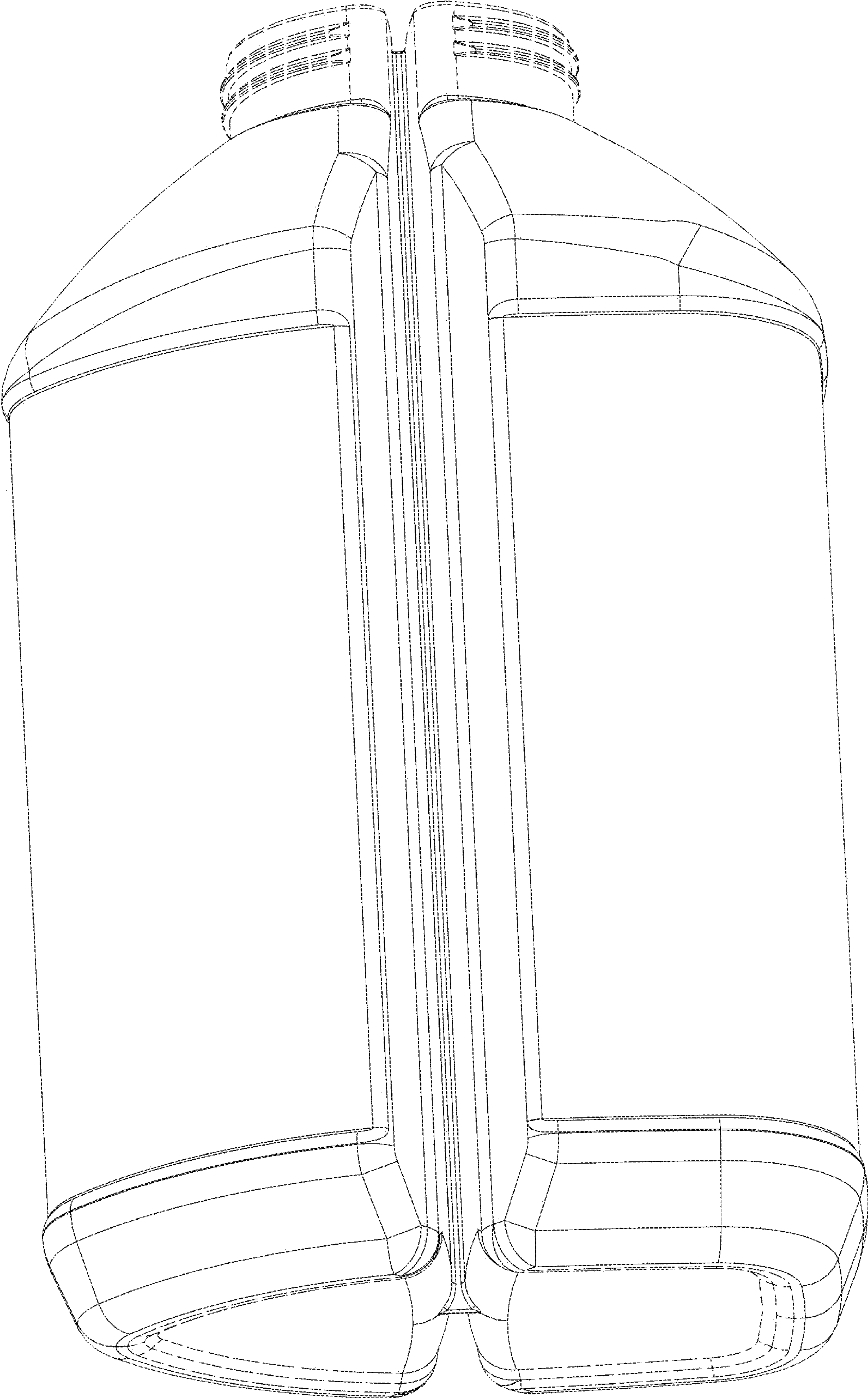

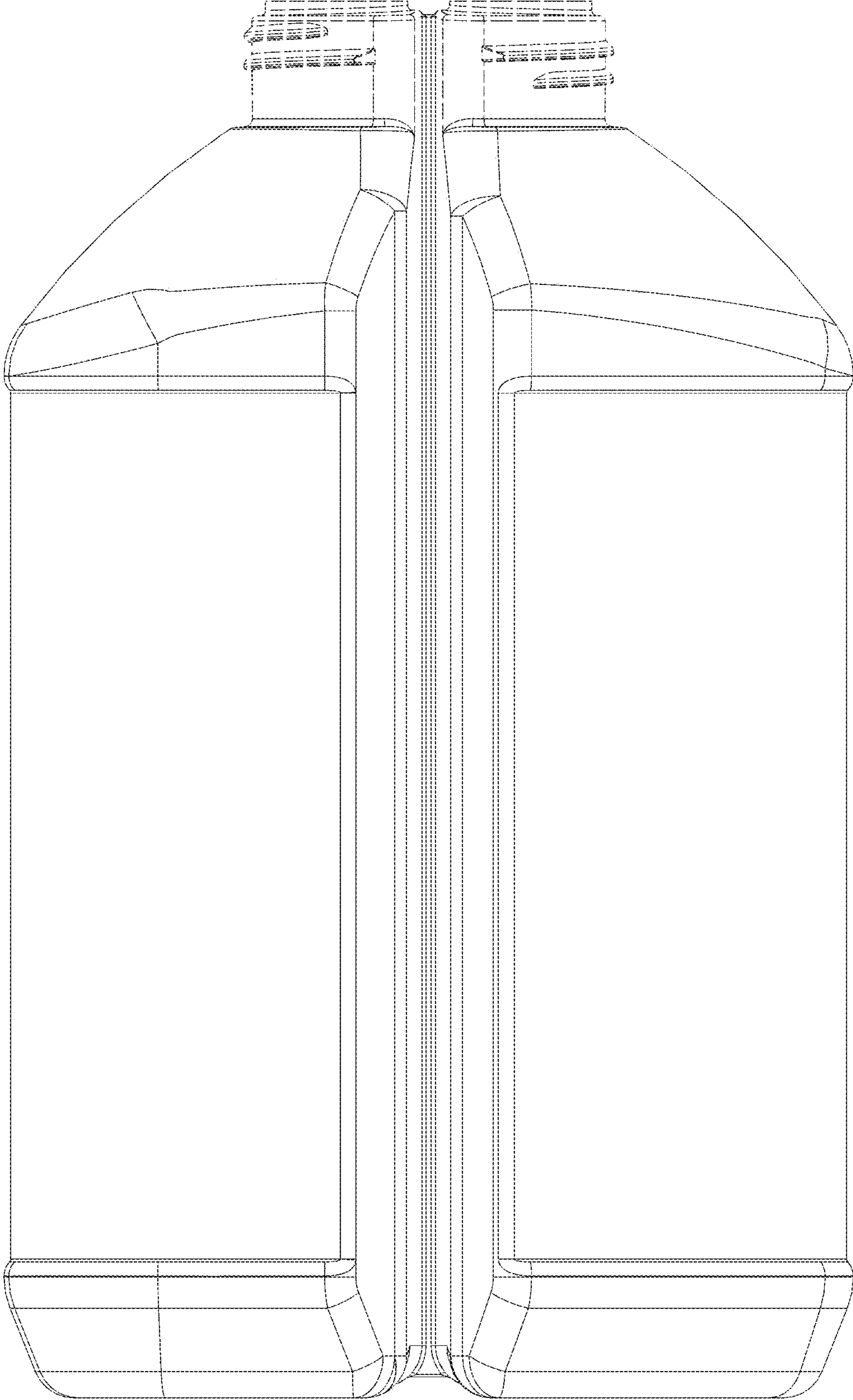

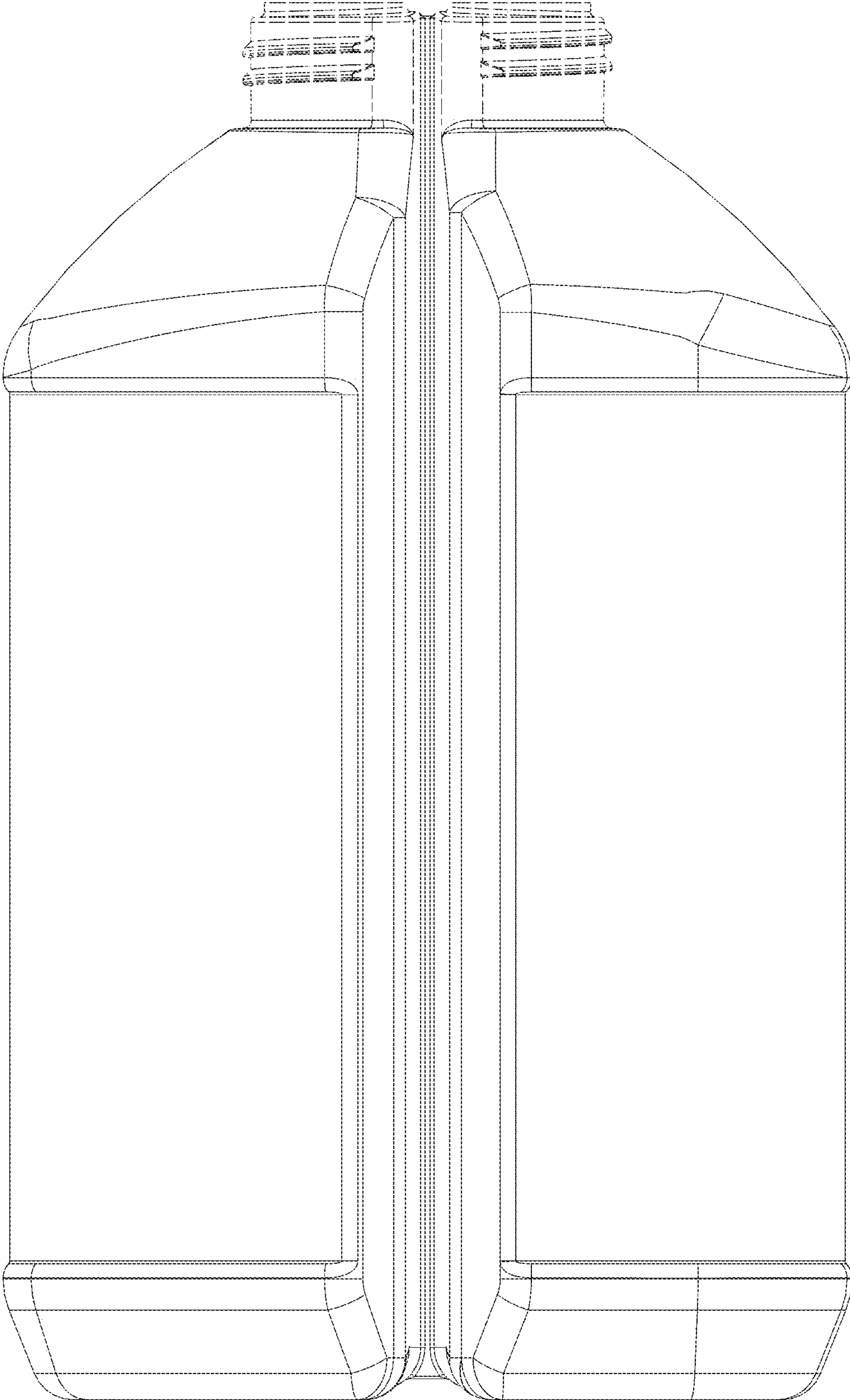

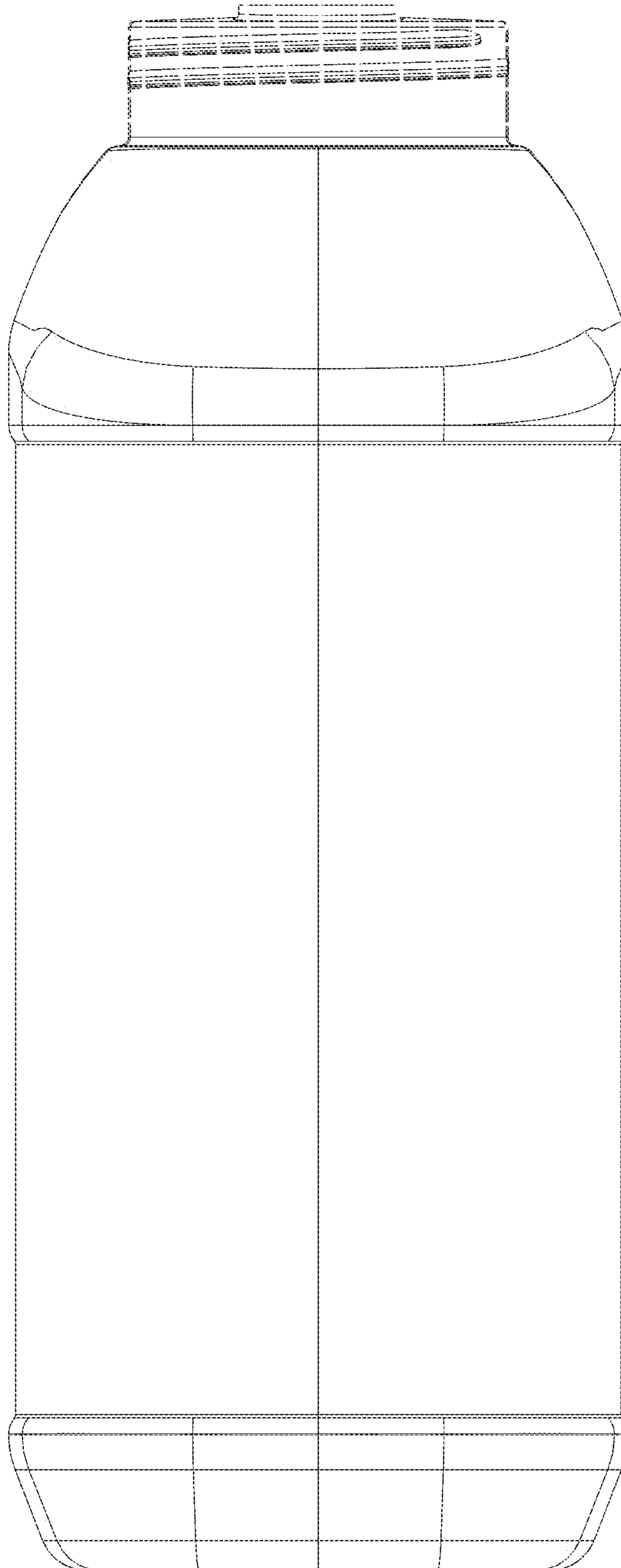

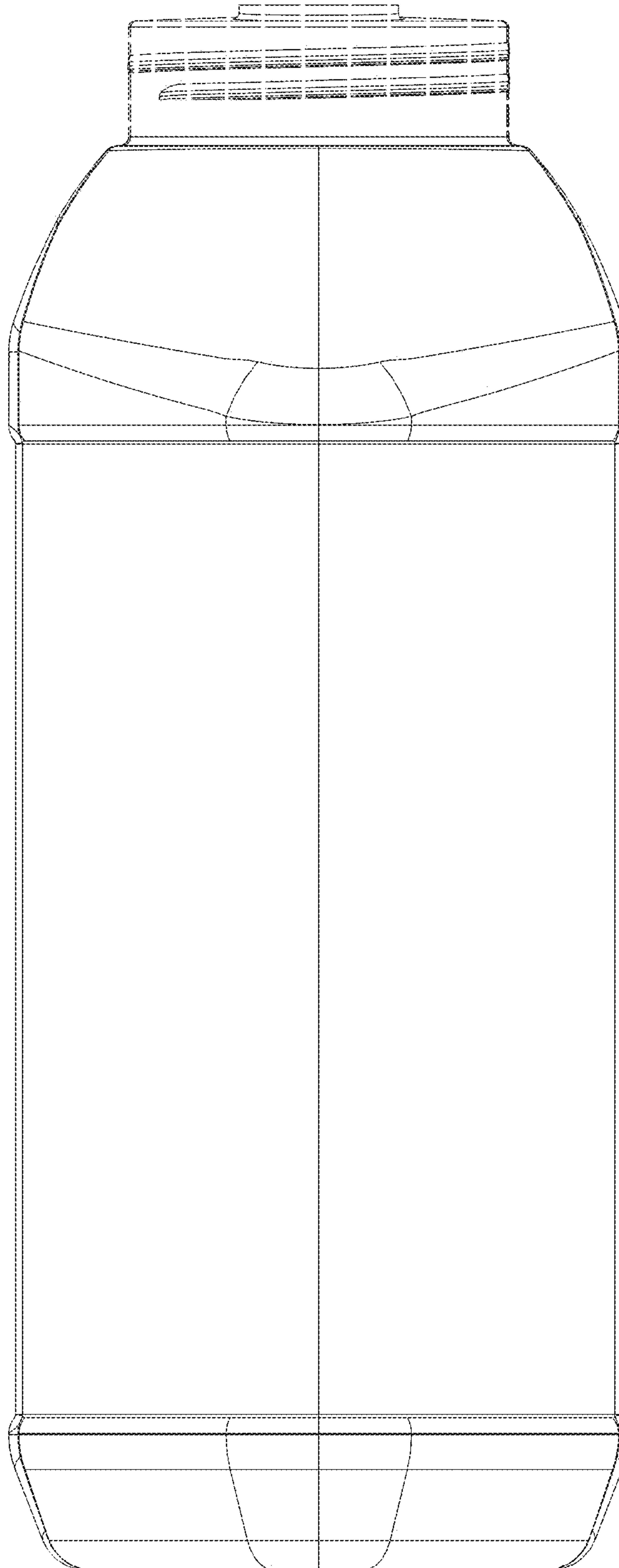

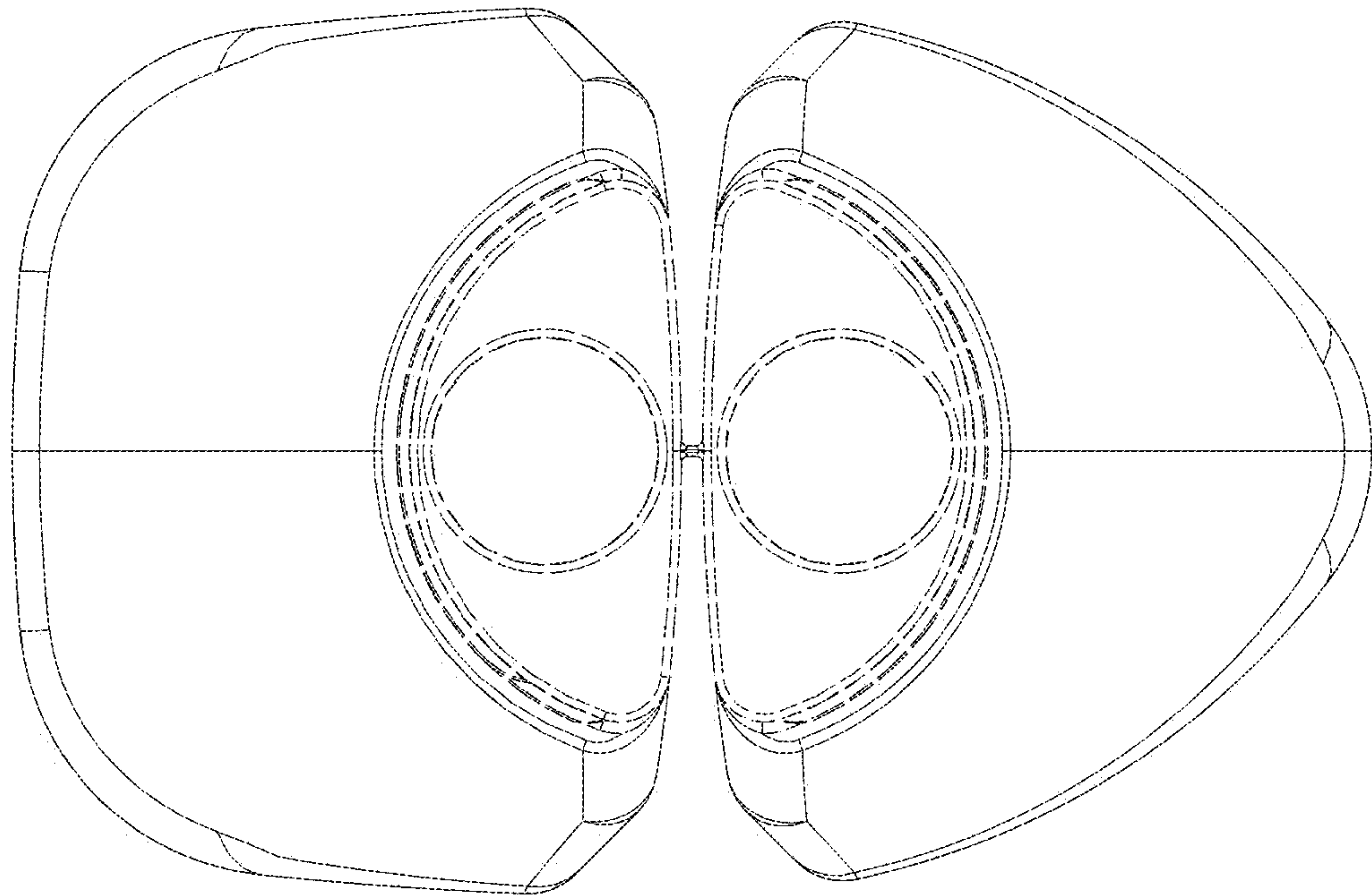
