The ornamental design for a belt buckle, as shown.

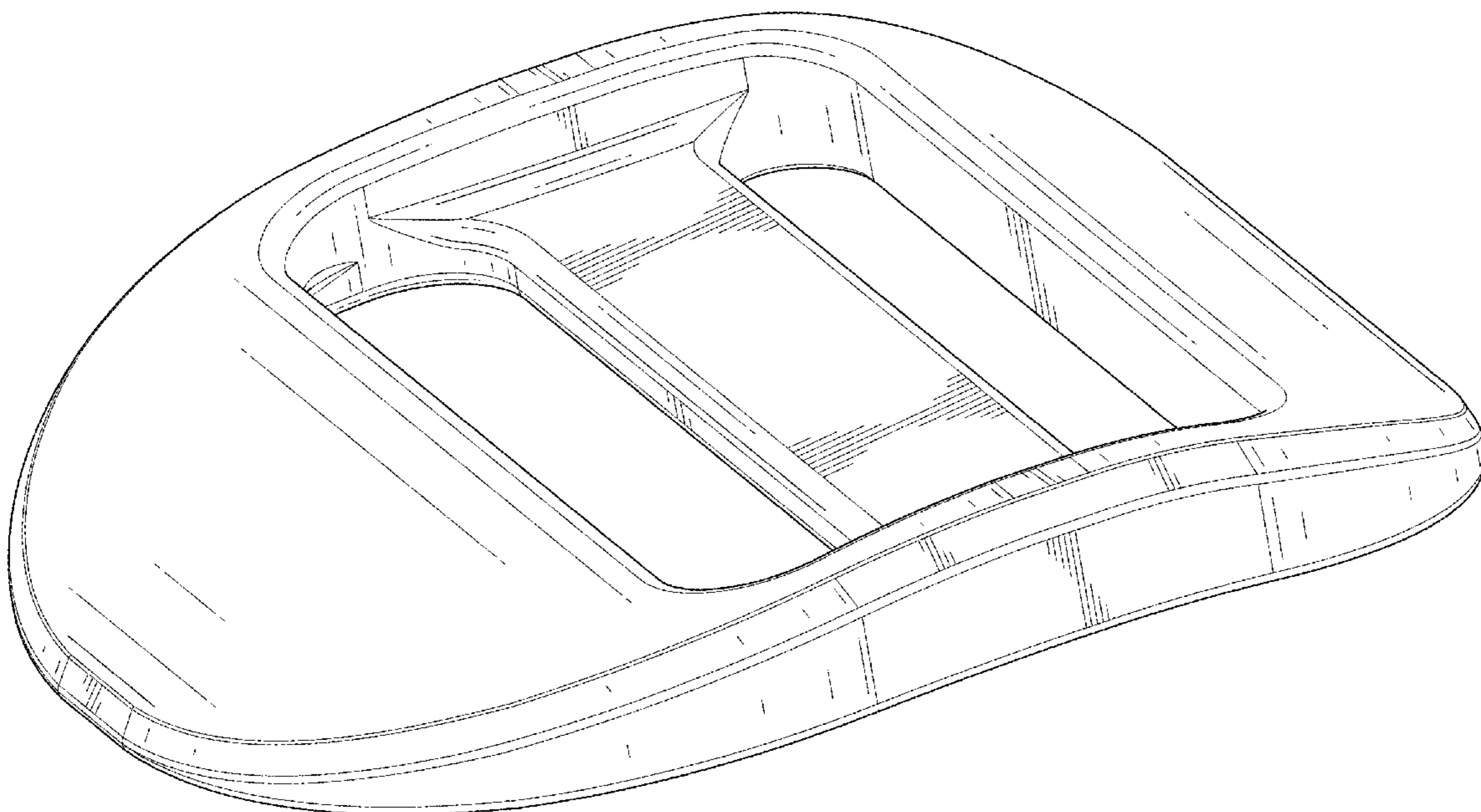
DESCRIPTION

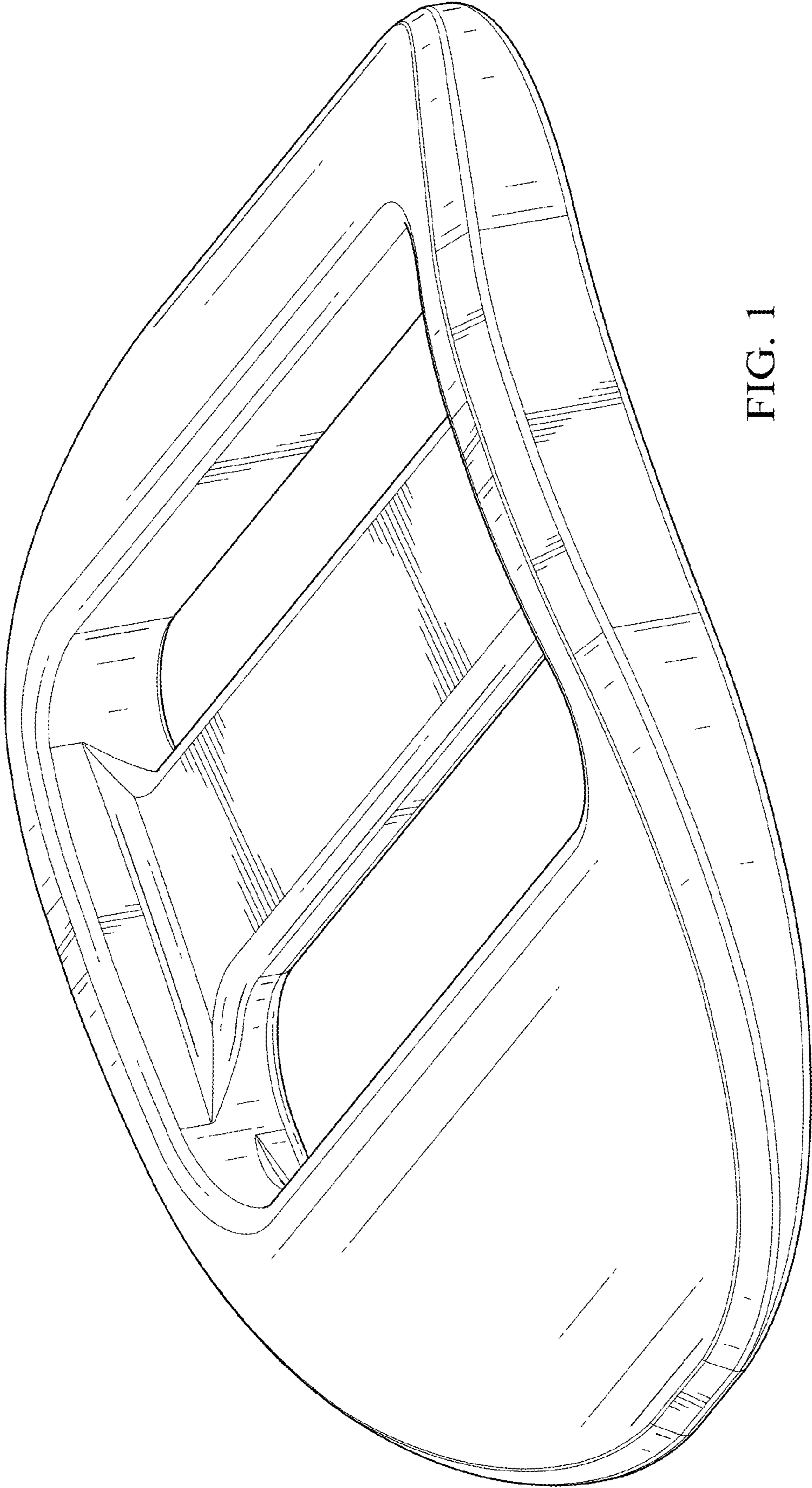

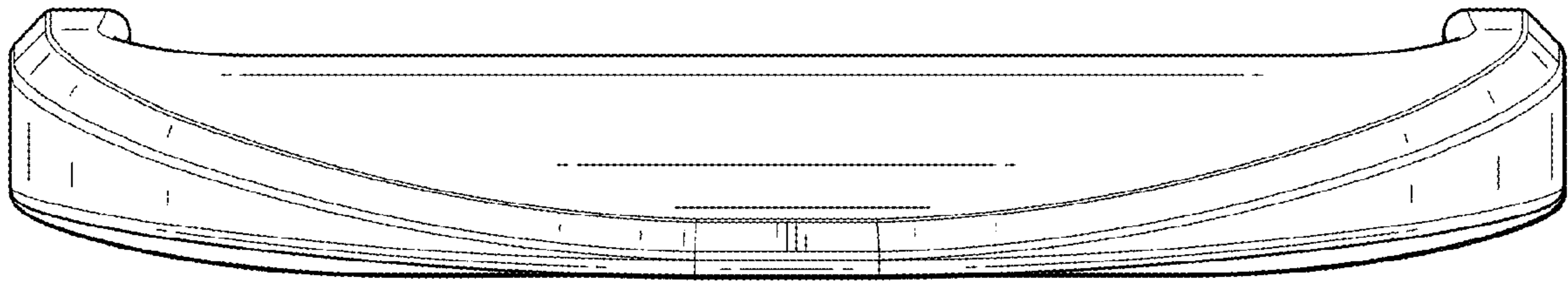

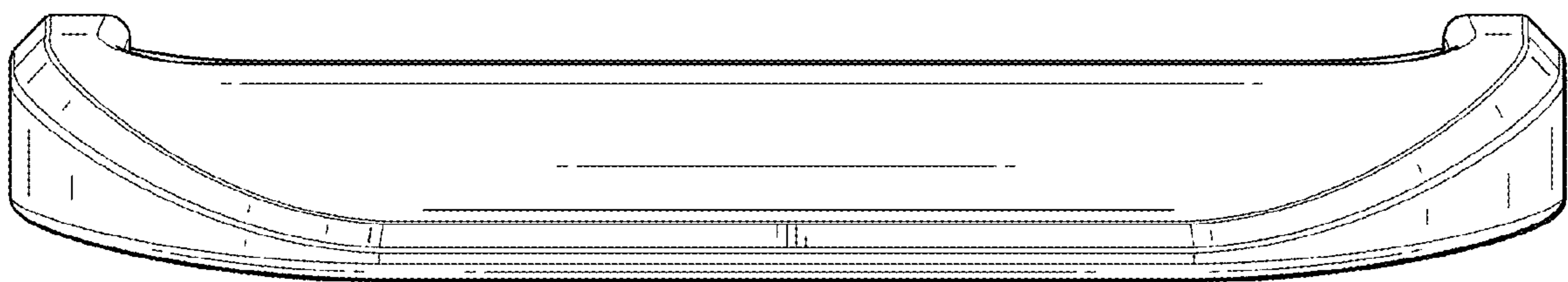

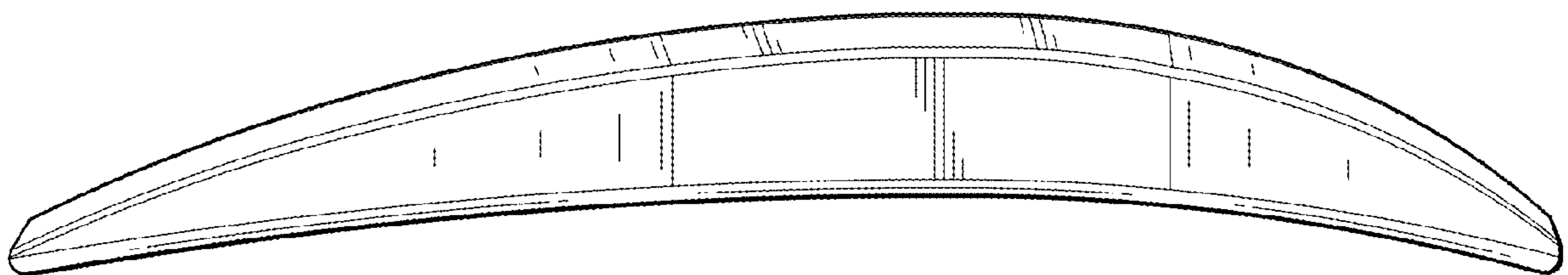

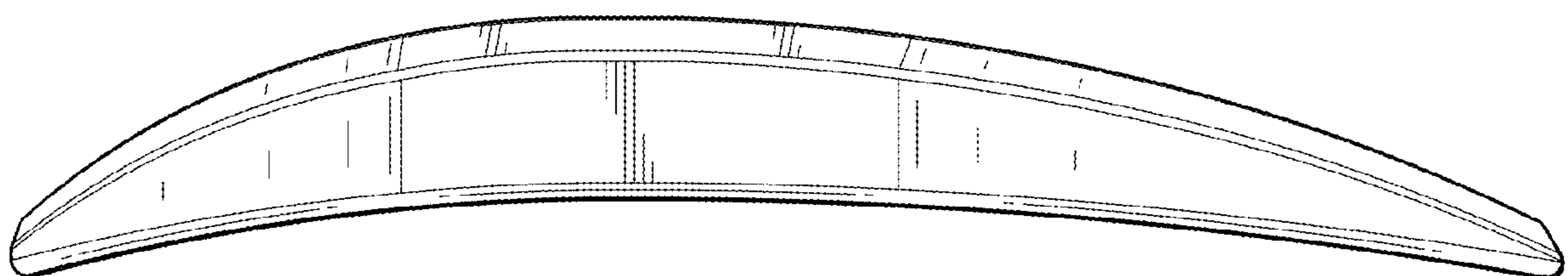

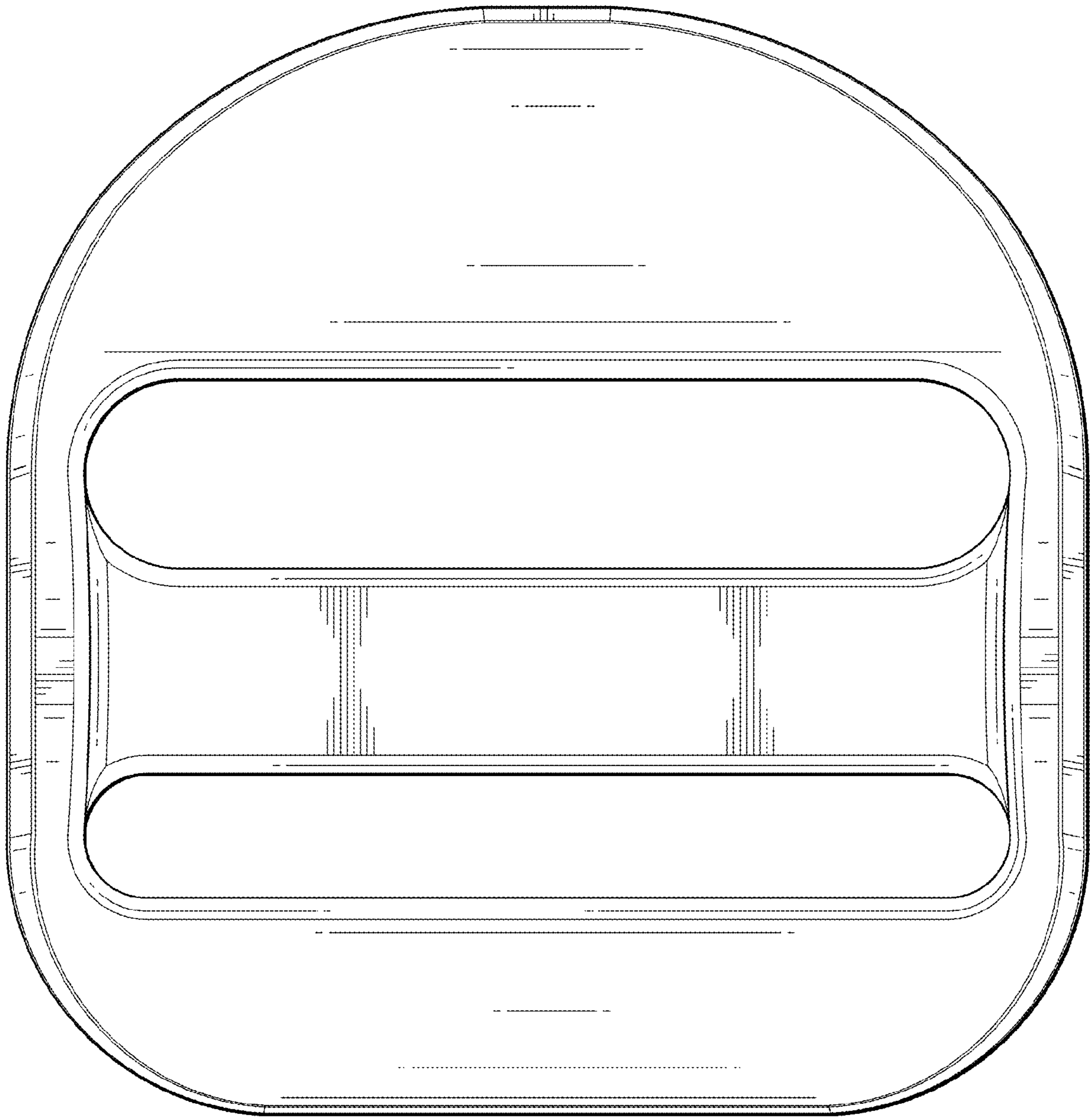

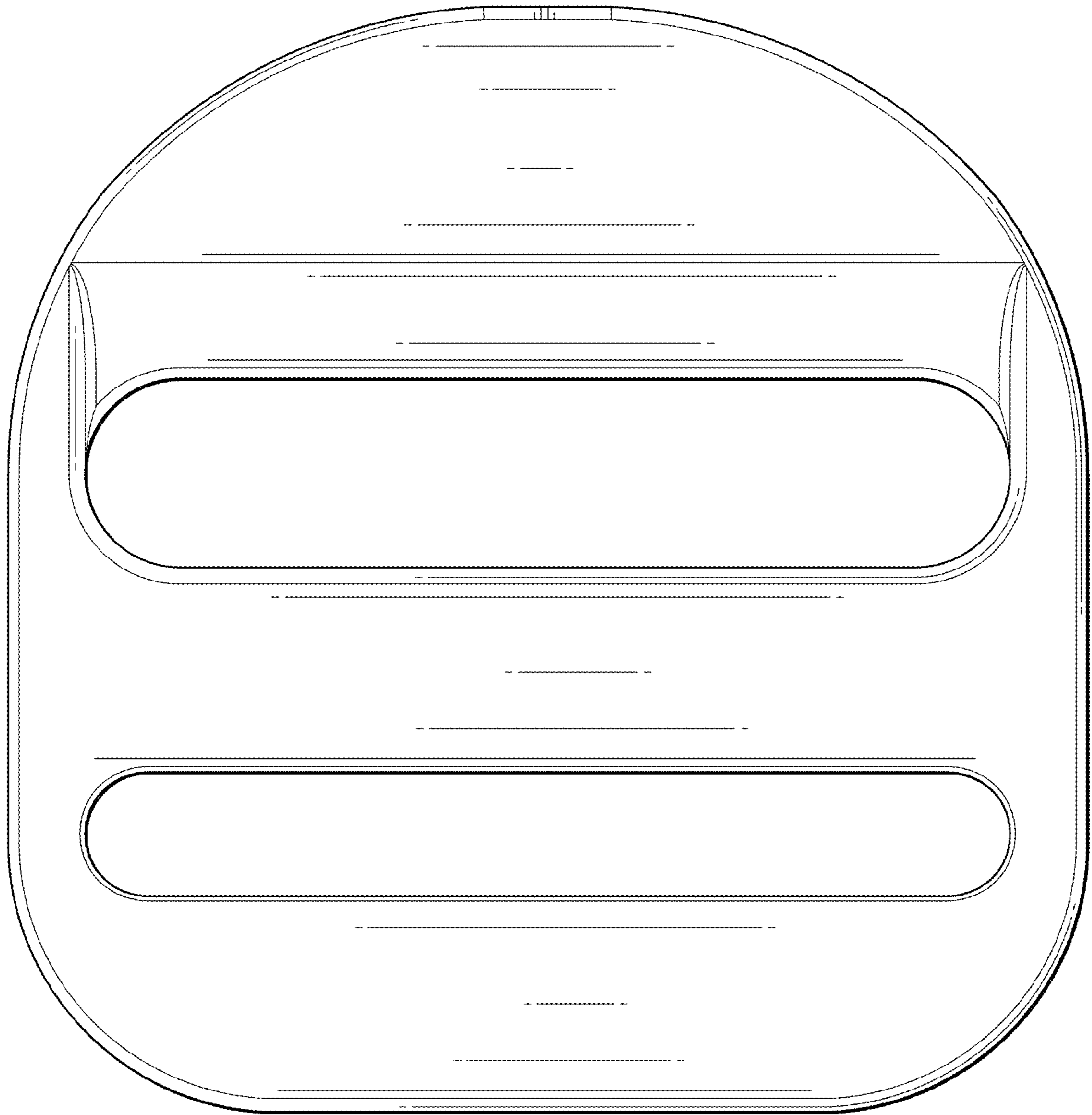

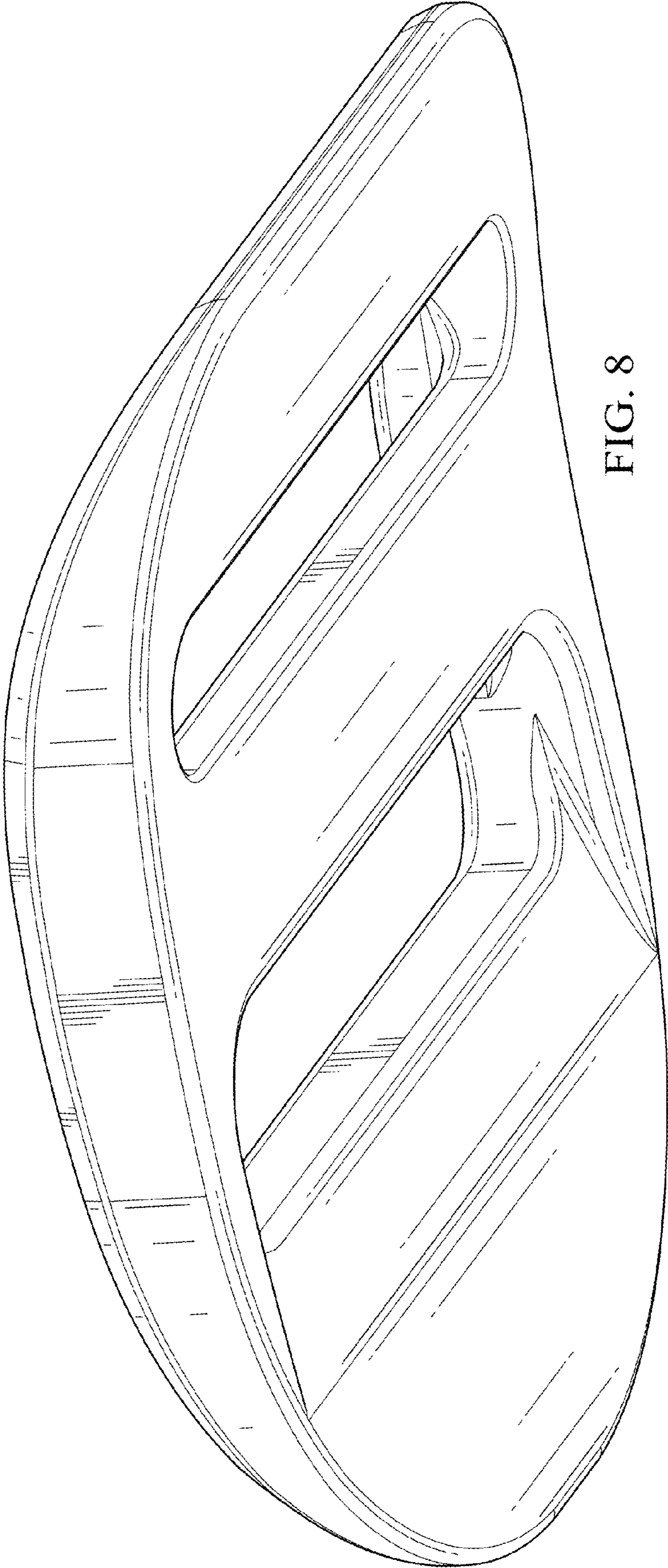
