(57) **CLAIM**

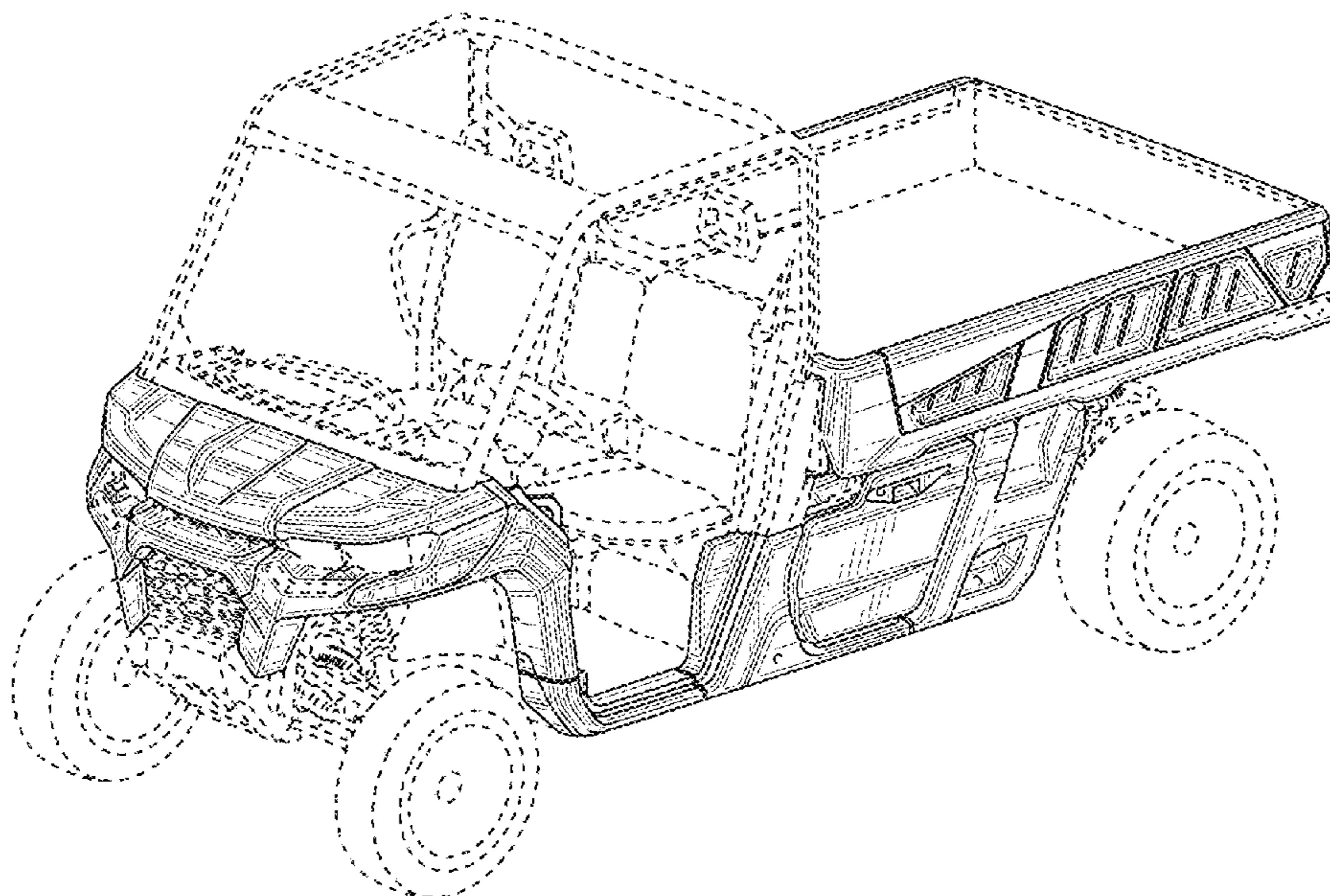
The ornamental design for an off-road vehicle body, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view taken from a front, left side of an off-road vehicle body according to our design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The broken lines in the drawings illustrate portions of the off-road vehicle body that form no part of the claimed design.

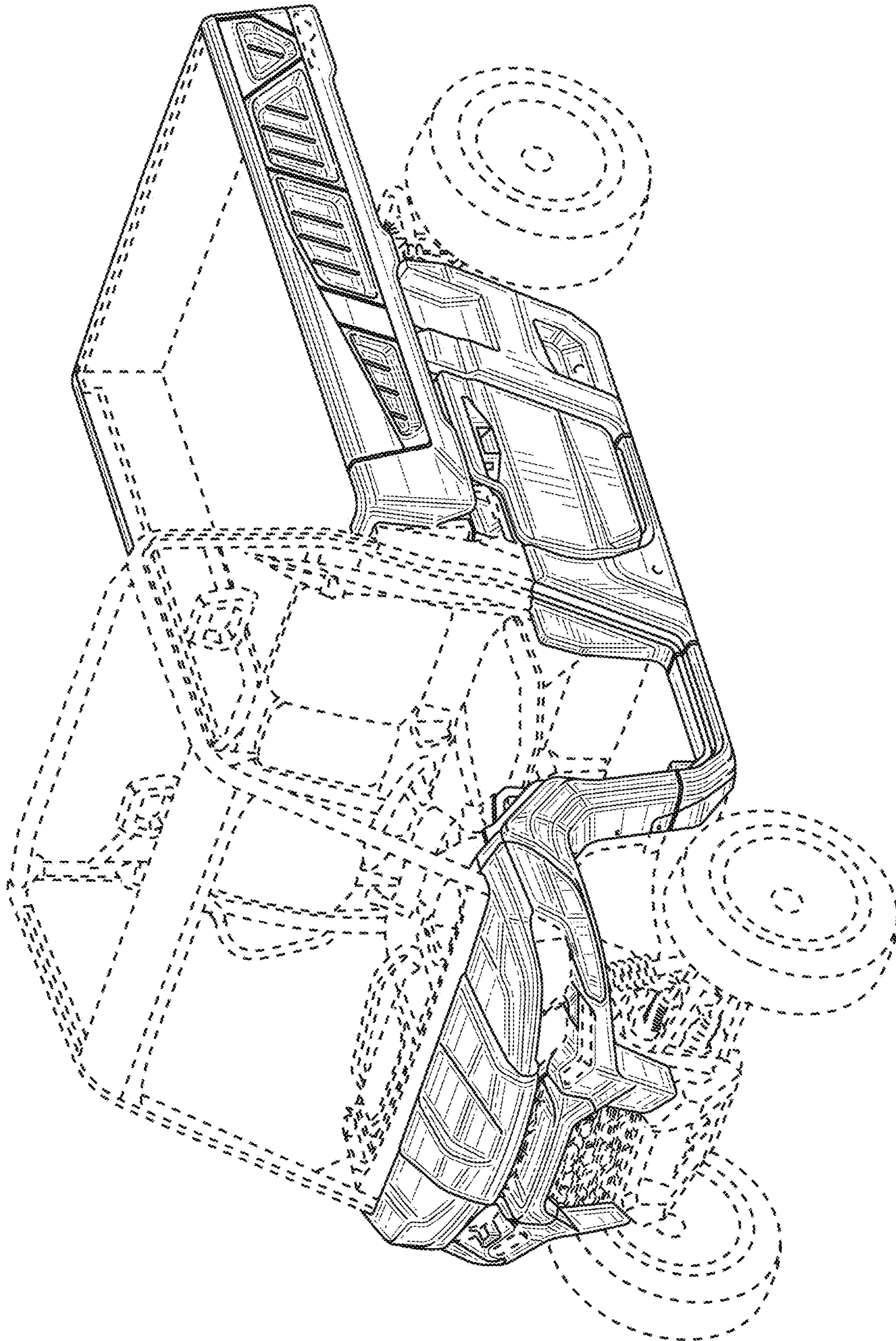

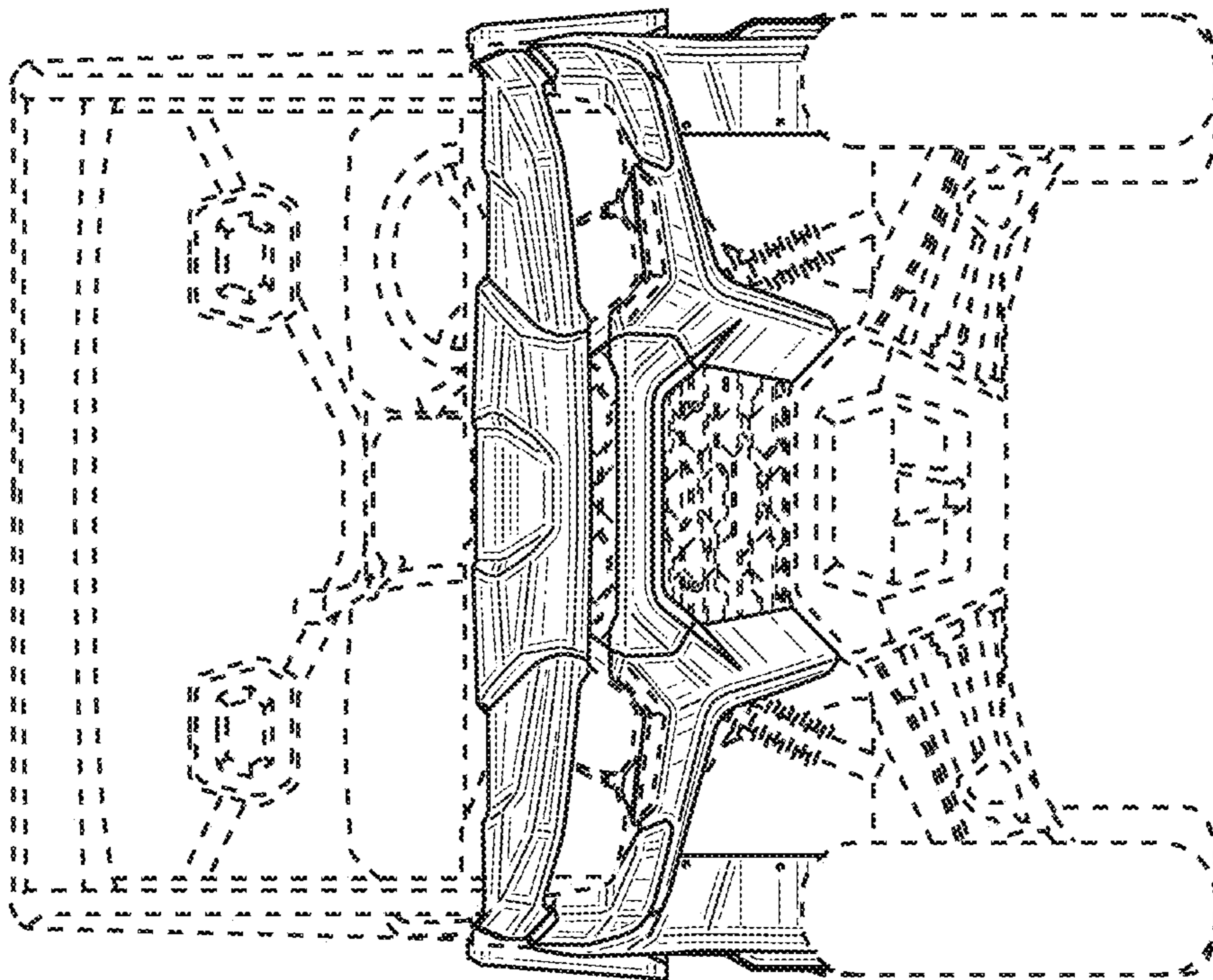

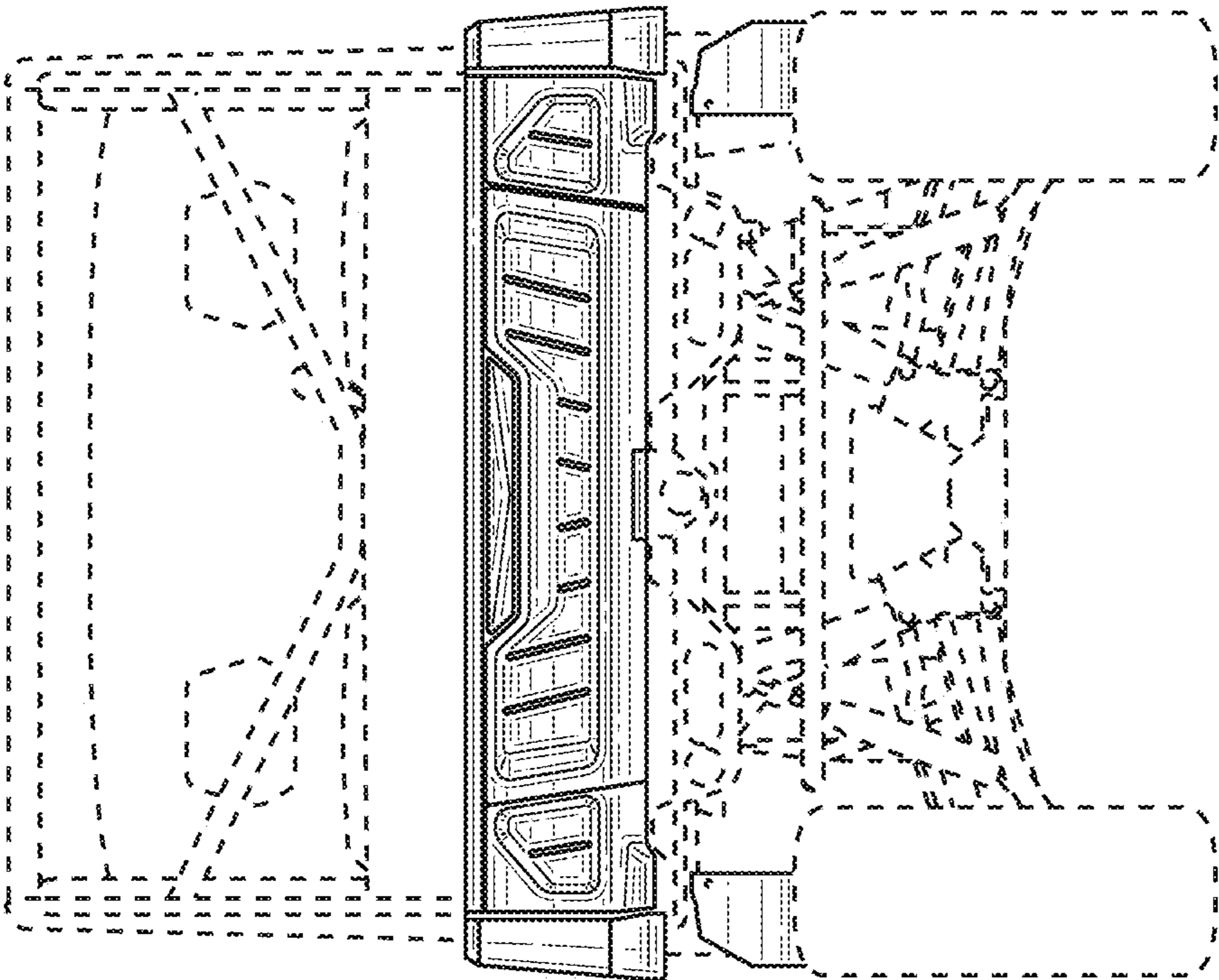

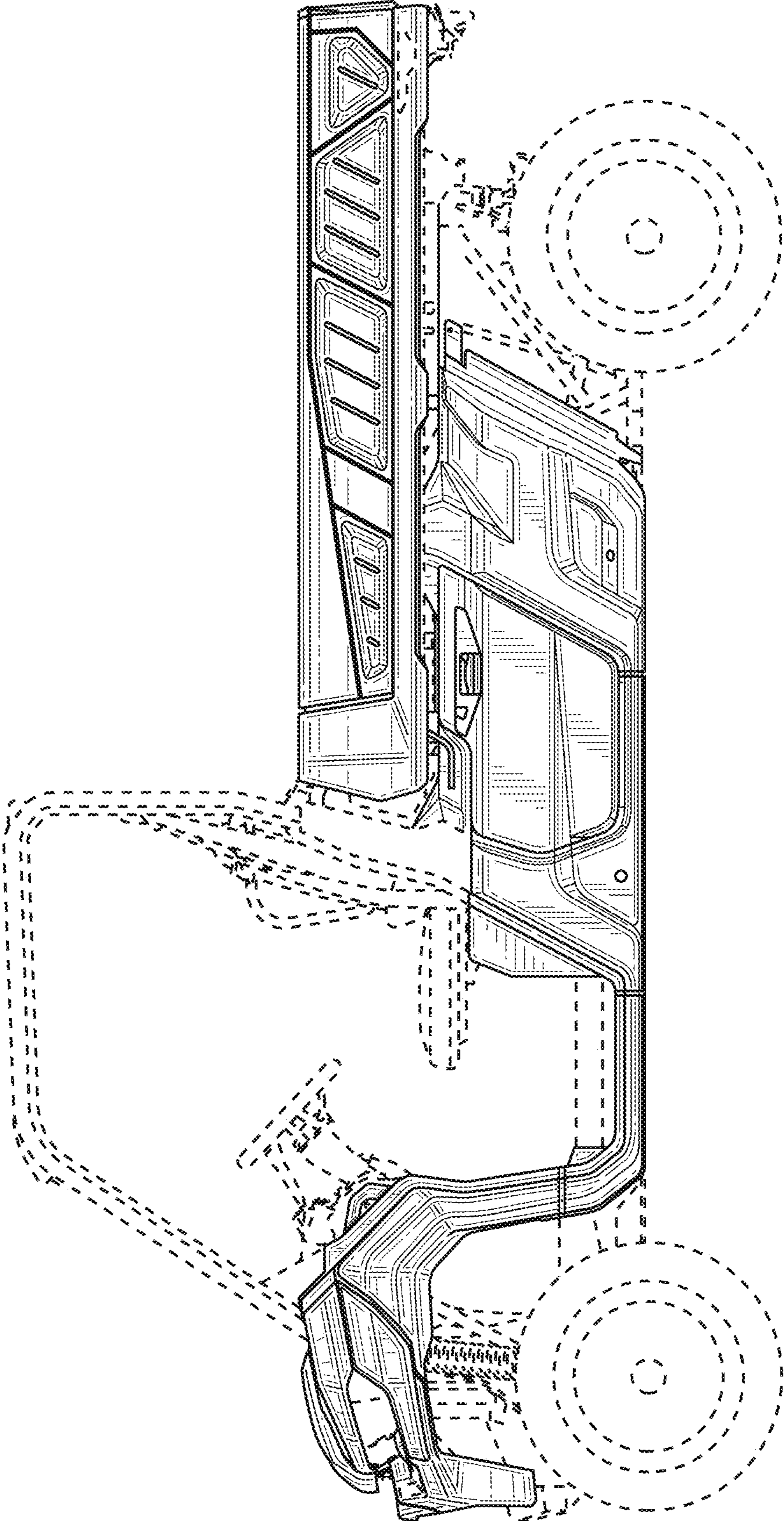

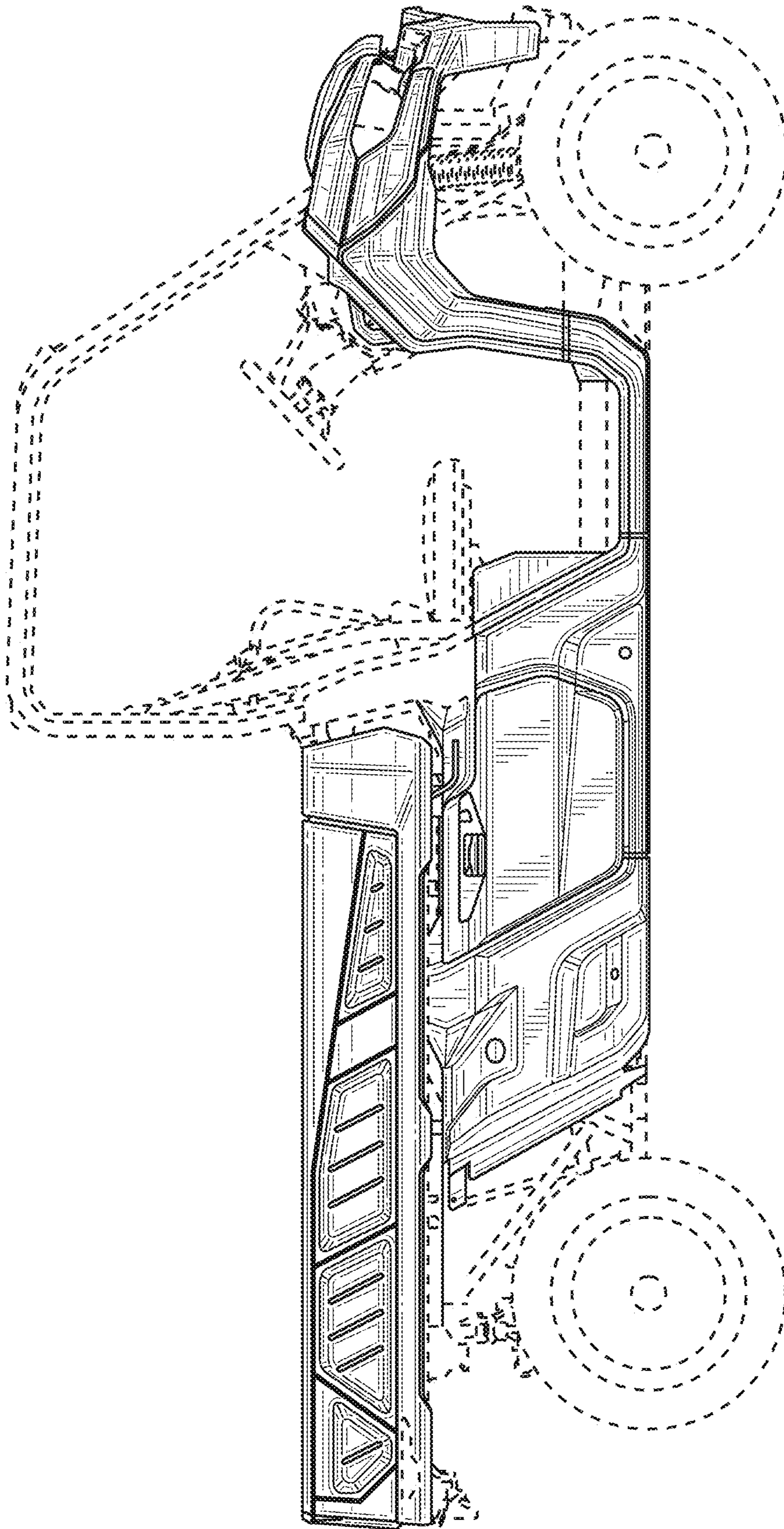

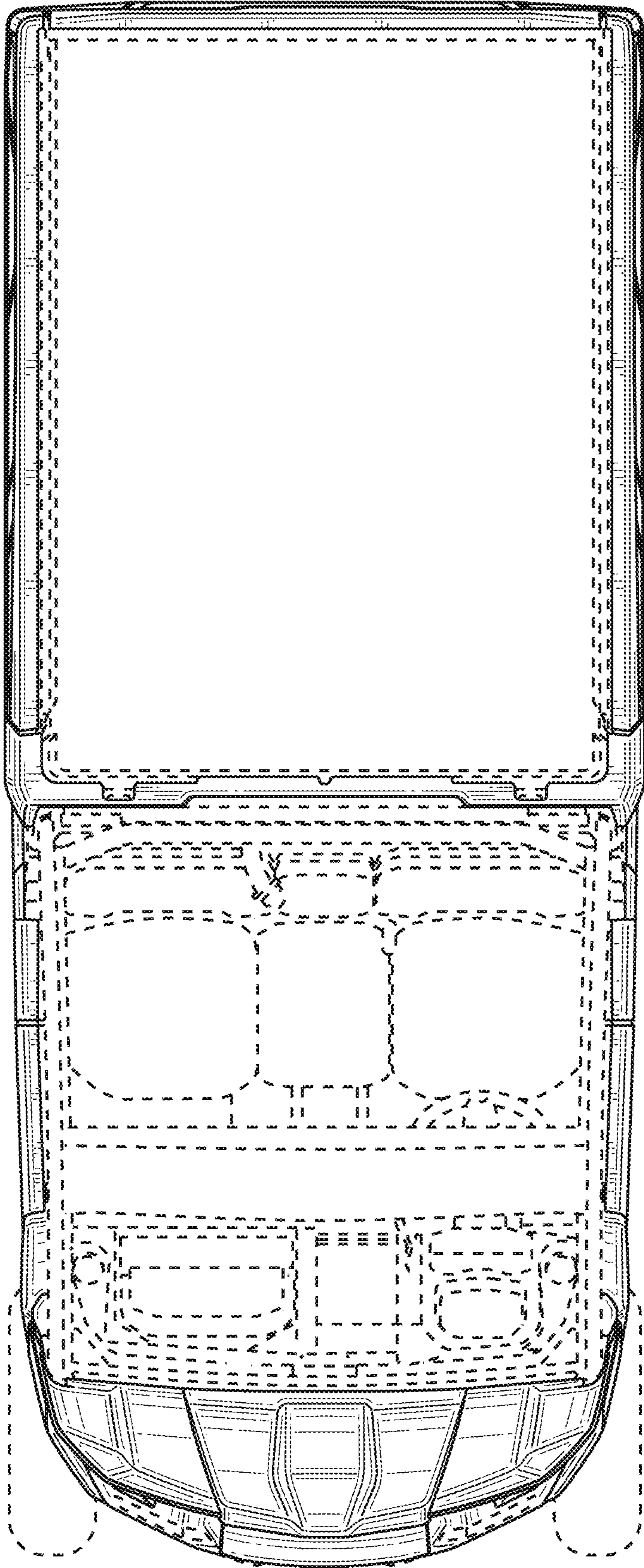

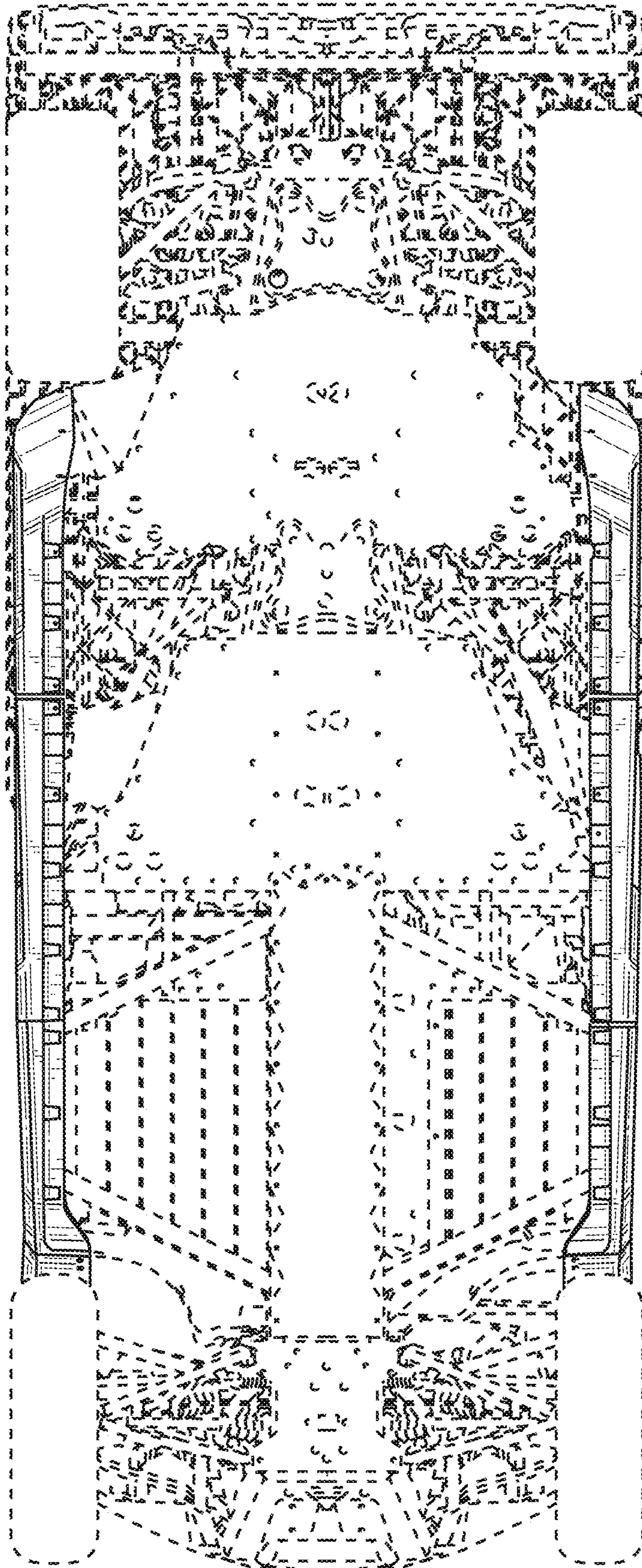
