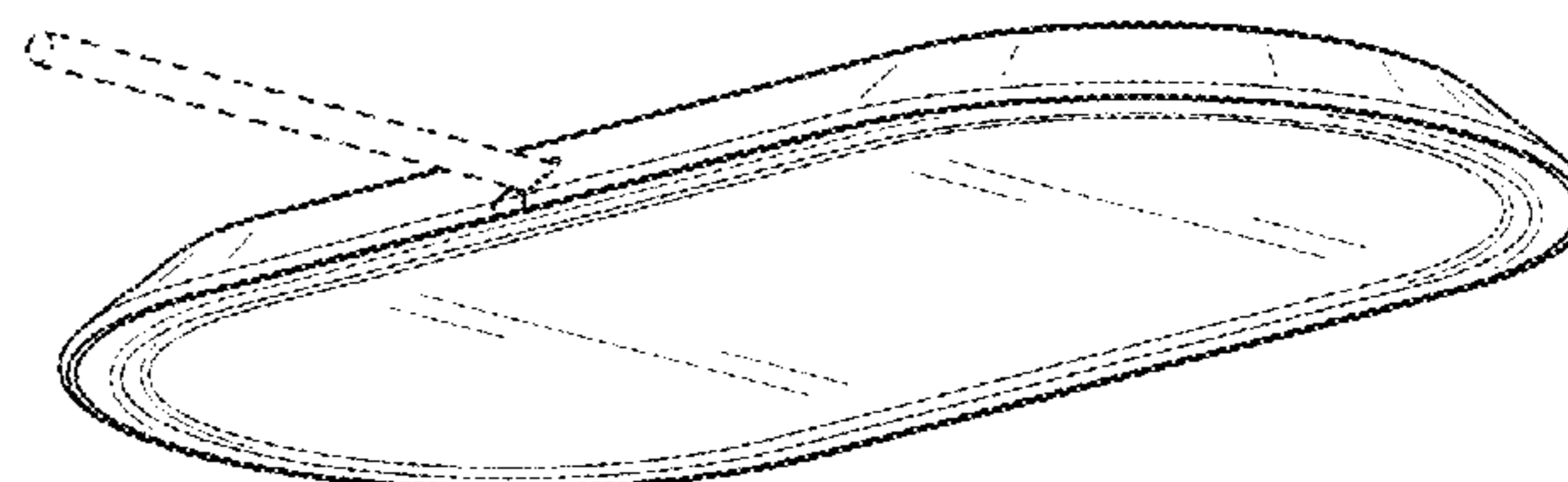
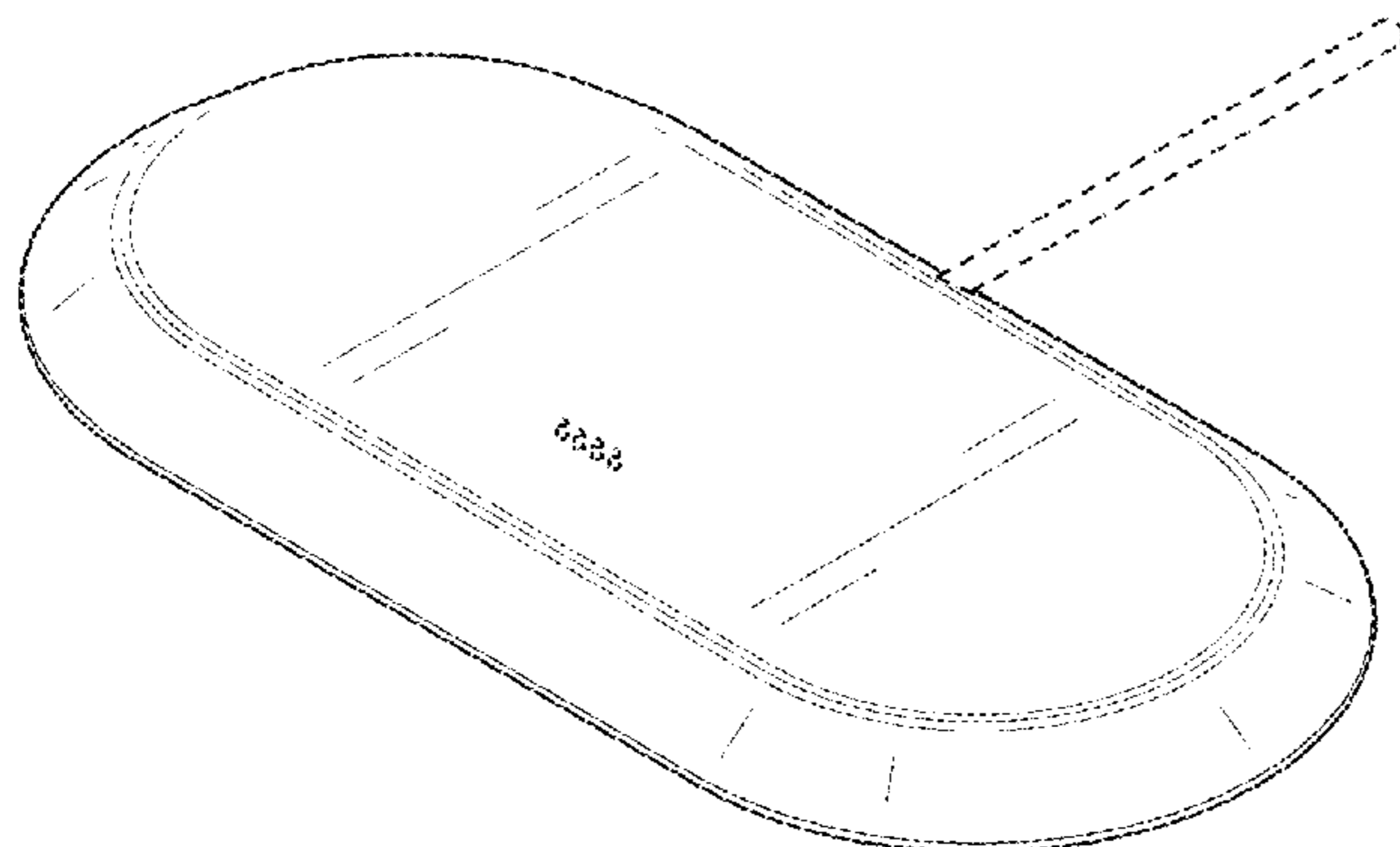
(57) **CLAIM**

The ornamental design for a charging plate for audio player, as shown and described.

DESCRIPTION

FIG. 1 is a top left front perspective view of a first embodiment of a charging plate for audio player showing our new design.
FIG. 2 is a bottom right rear perspective view thereof.
FIG. 3 is a front elevation view thereof.
FIG. 4 is a rear elevation view thereof.
FIG. 5 is a right side elevation view thereof.

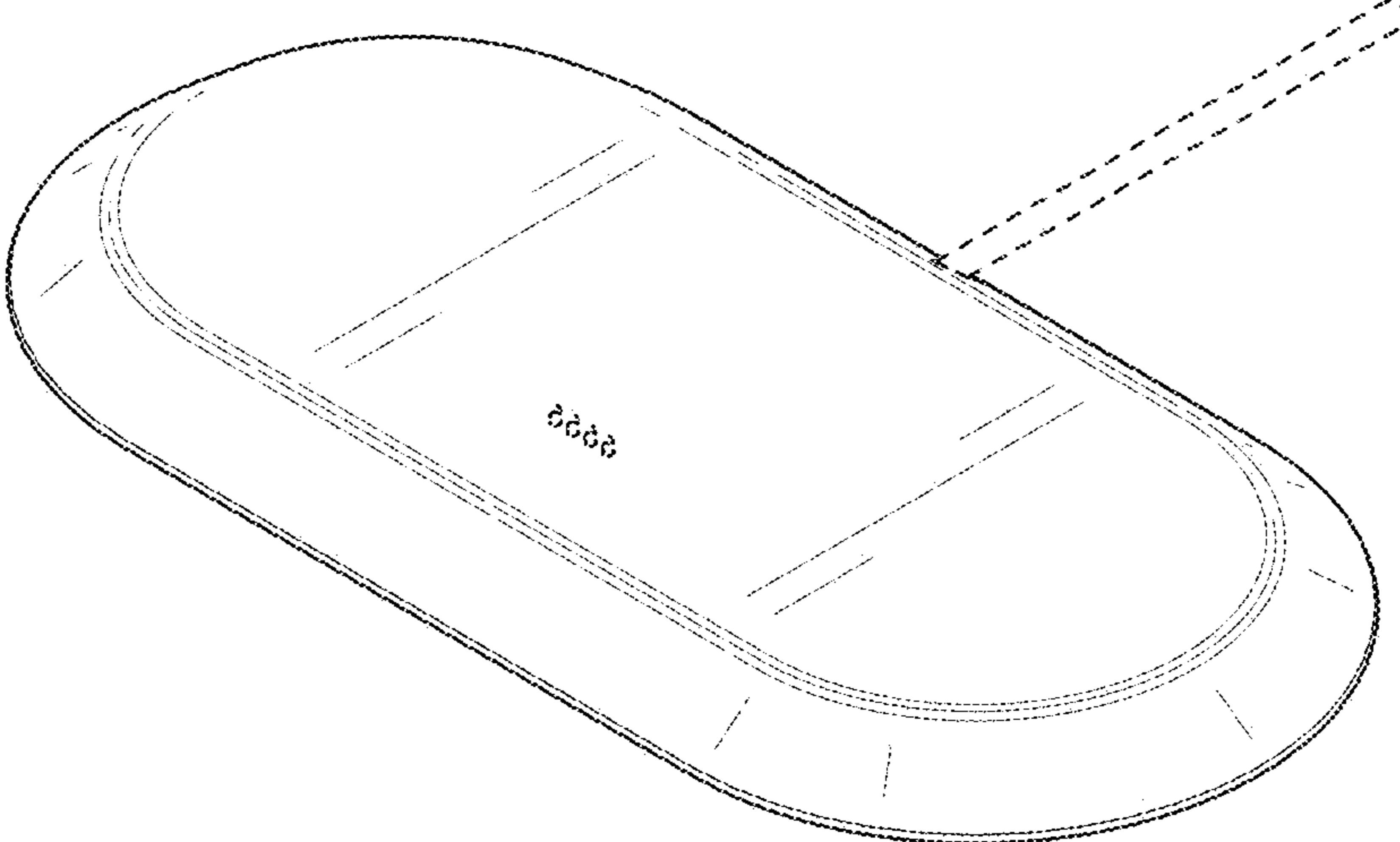

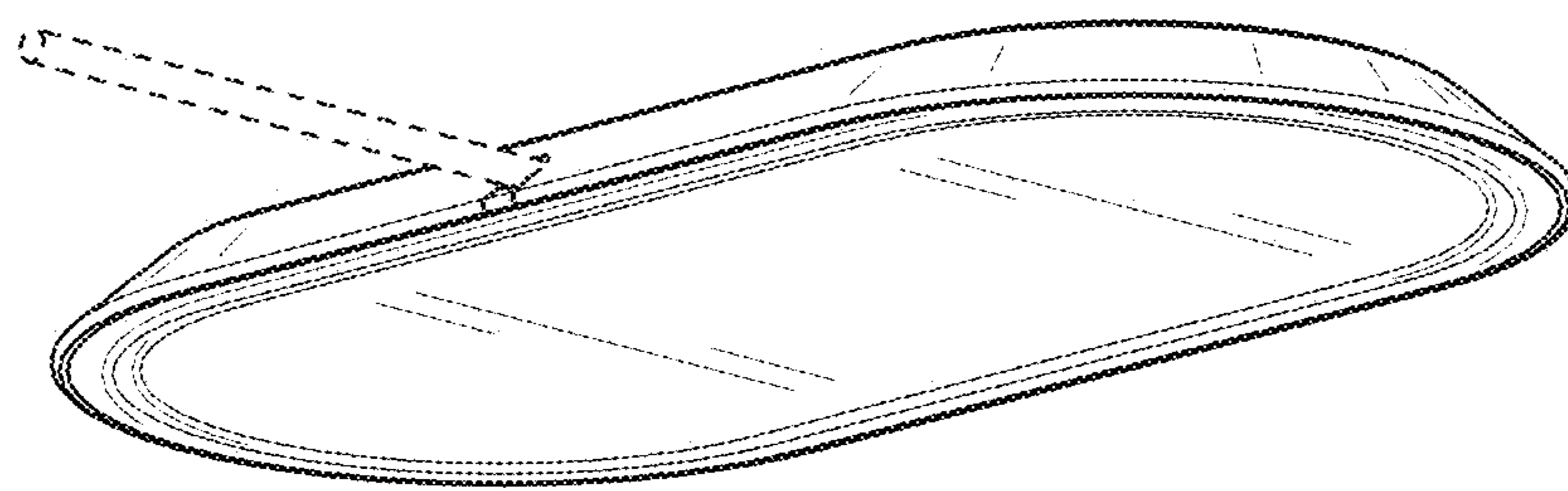

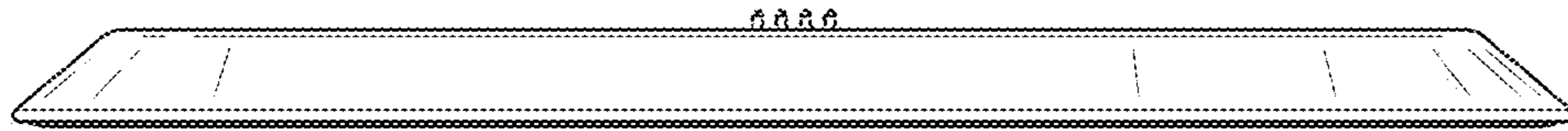

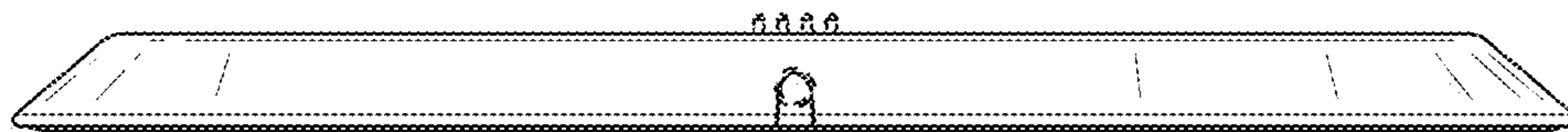

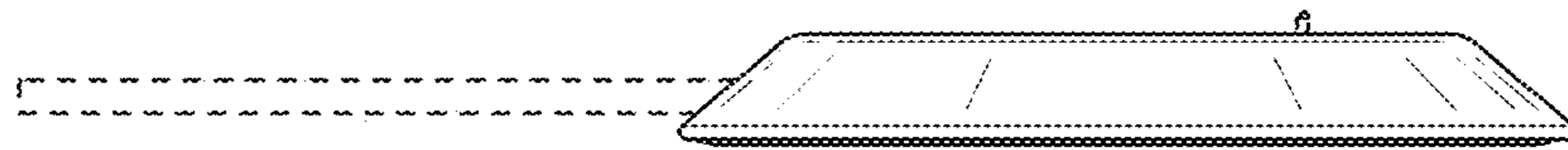

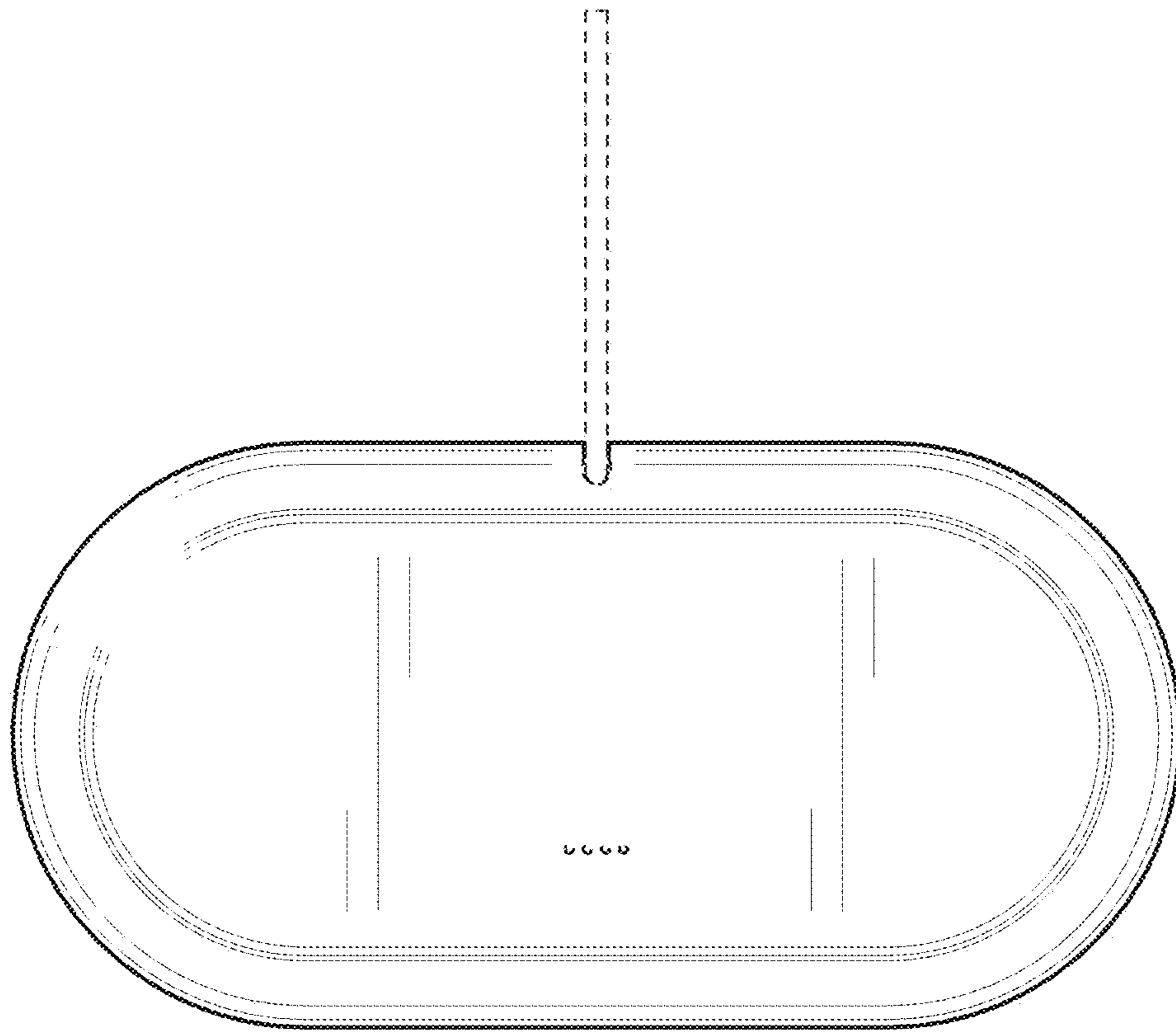

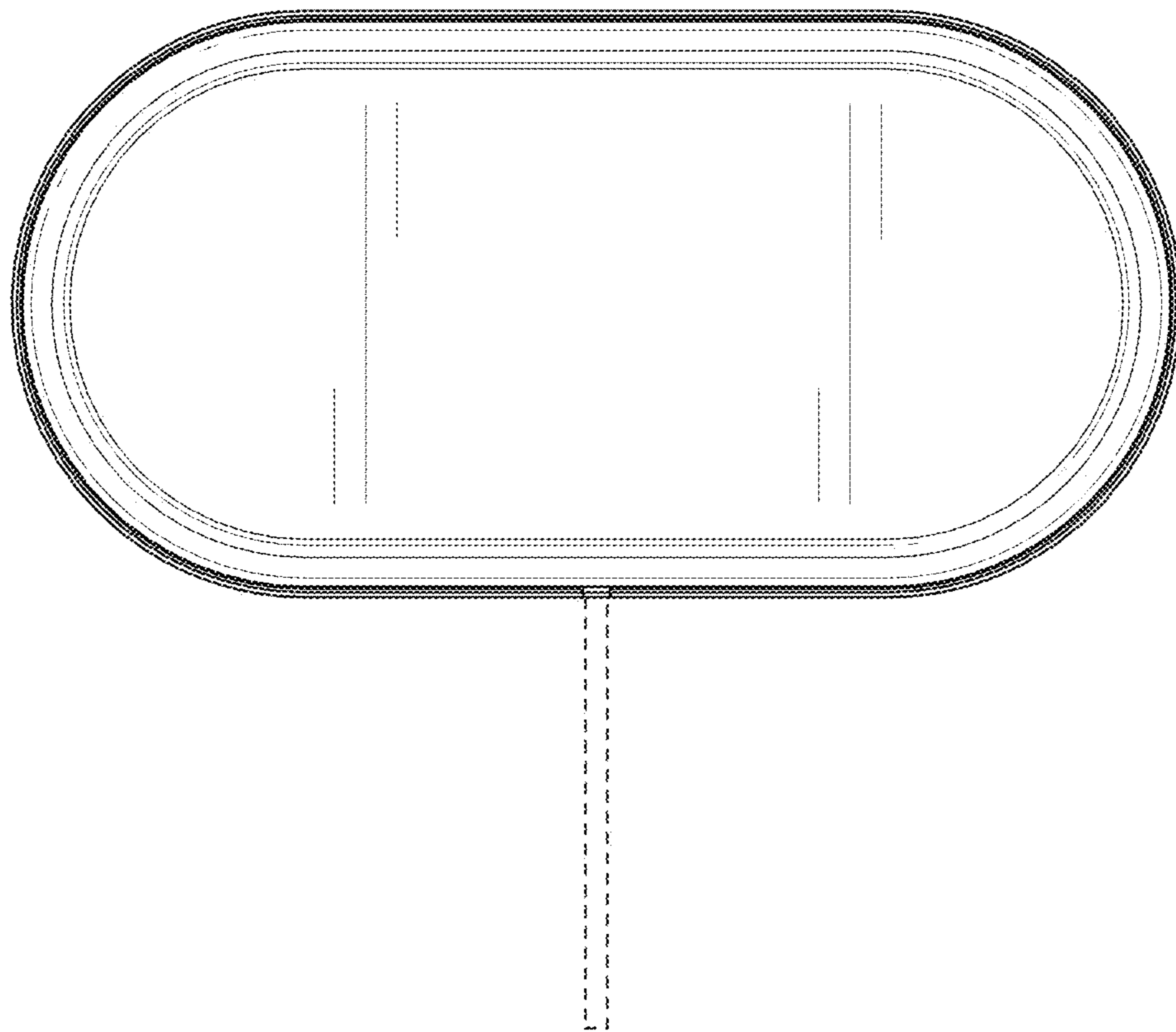

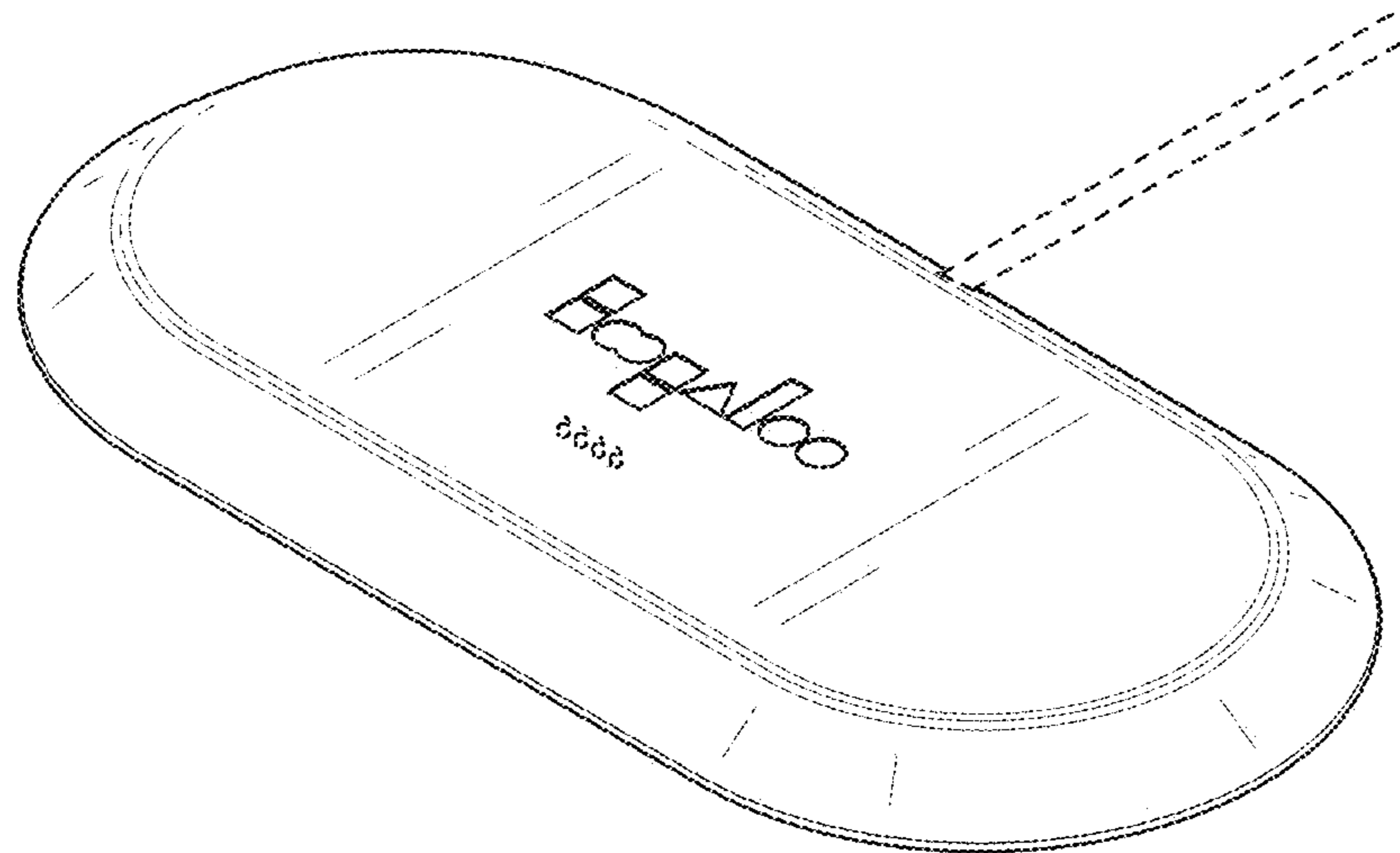

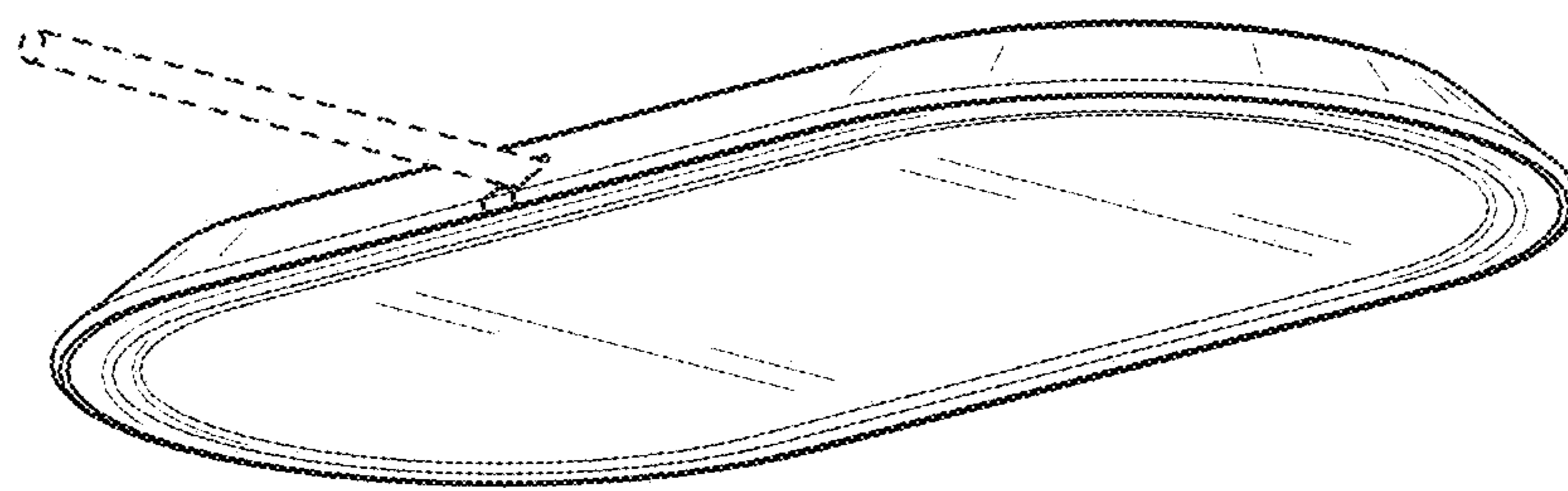

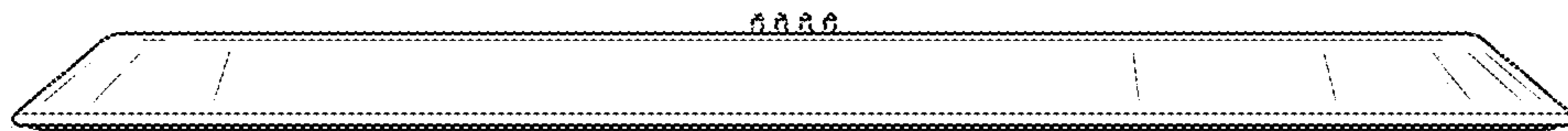

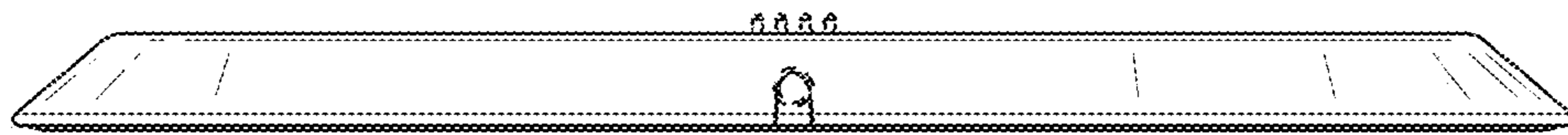

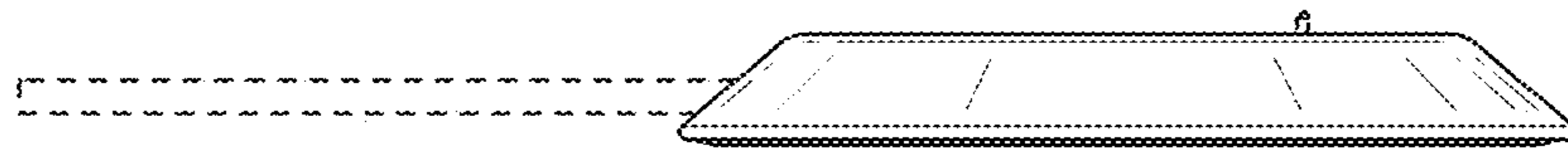

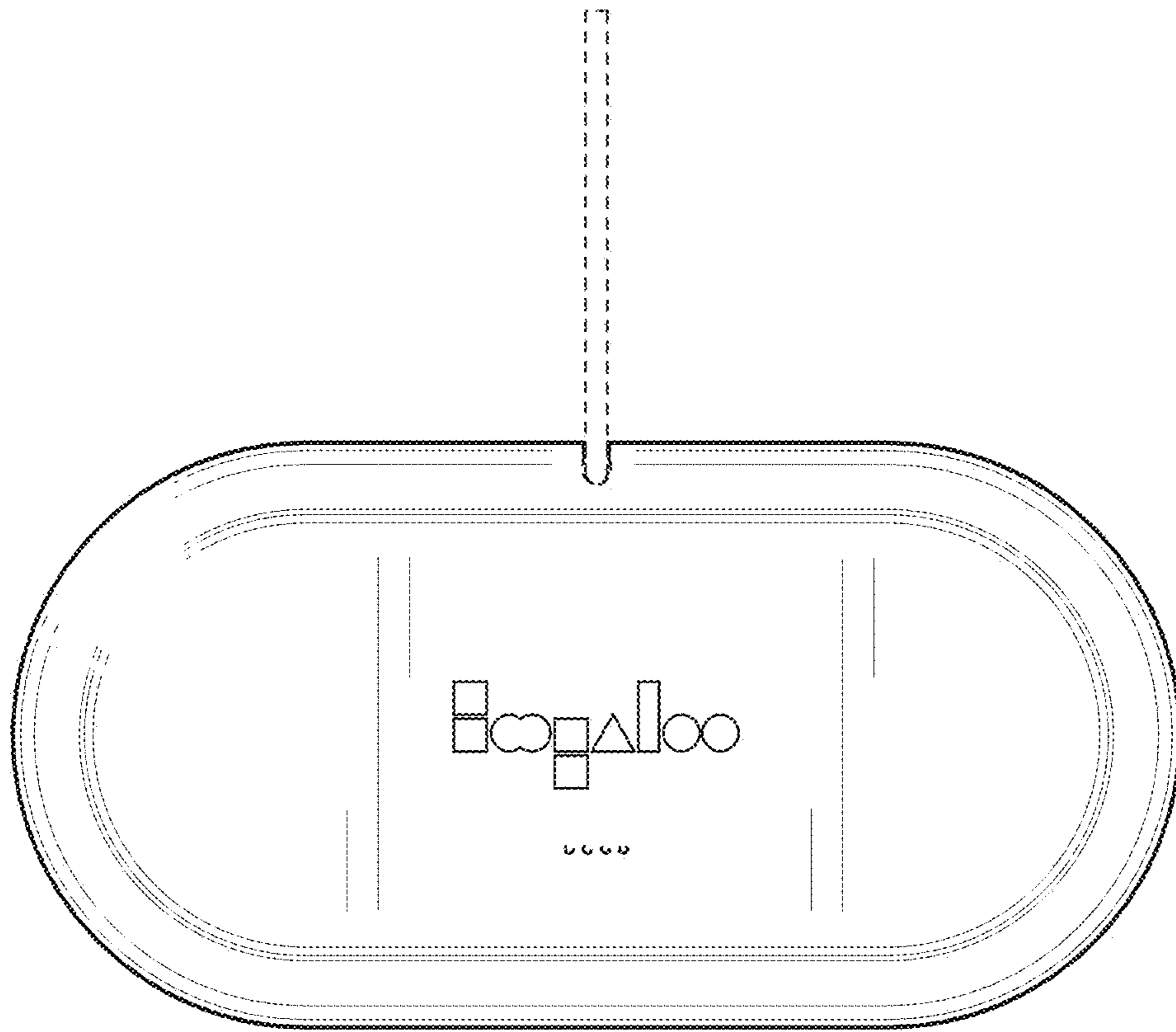

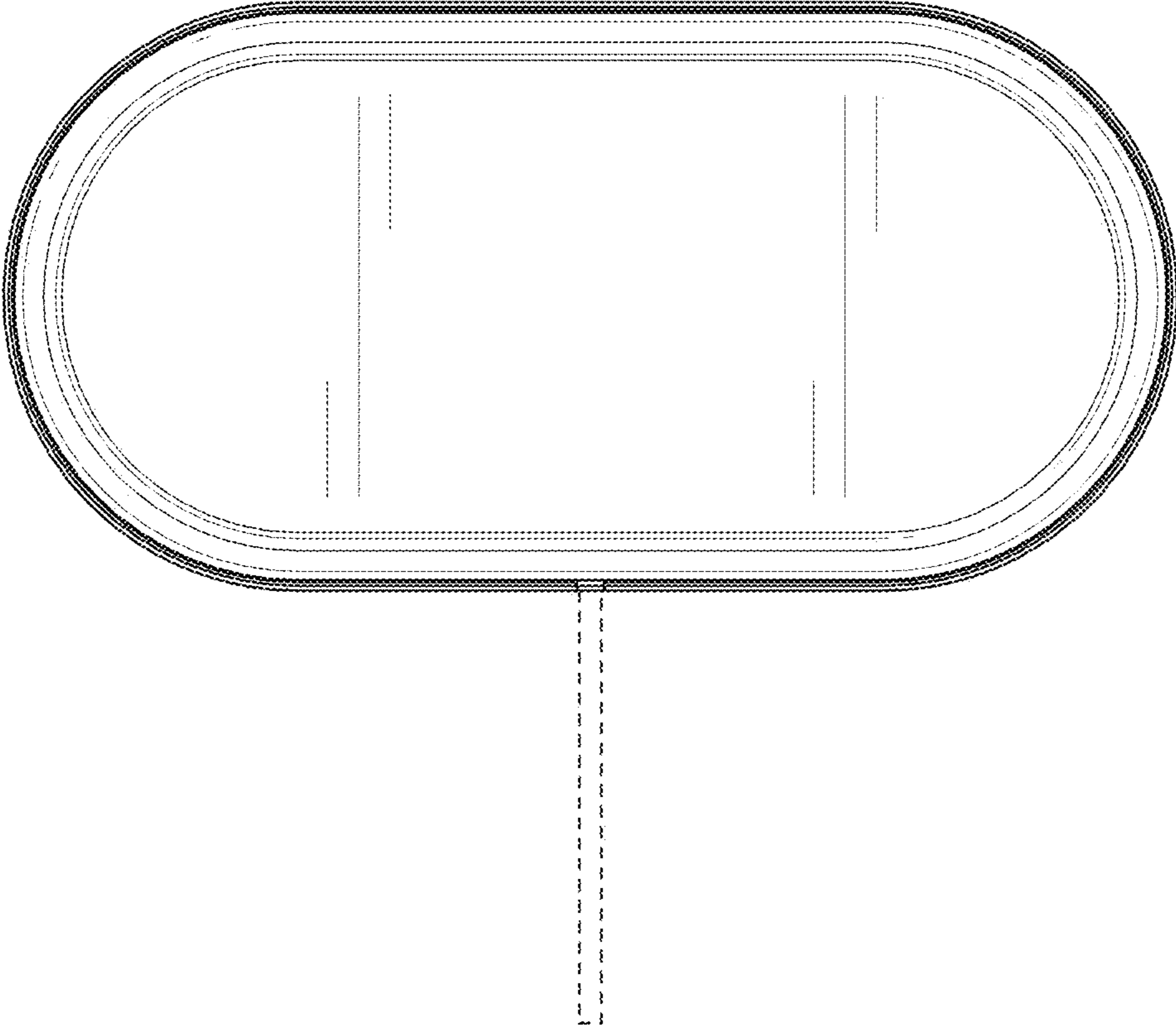
