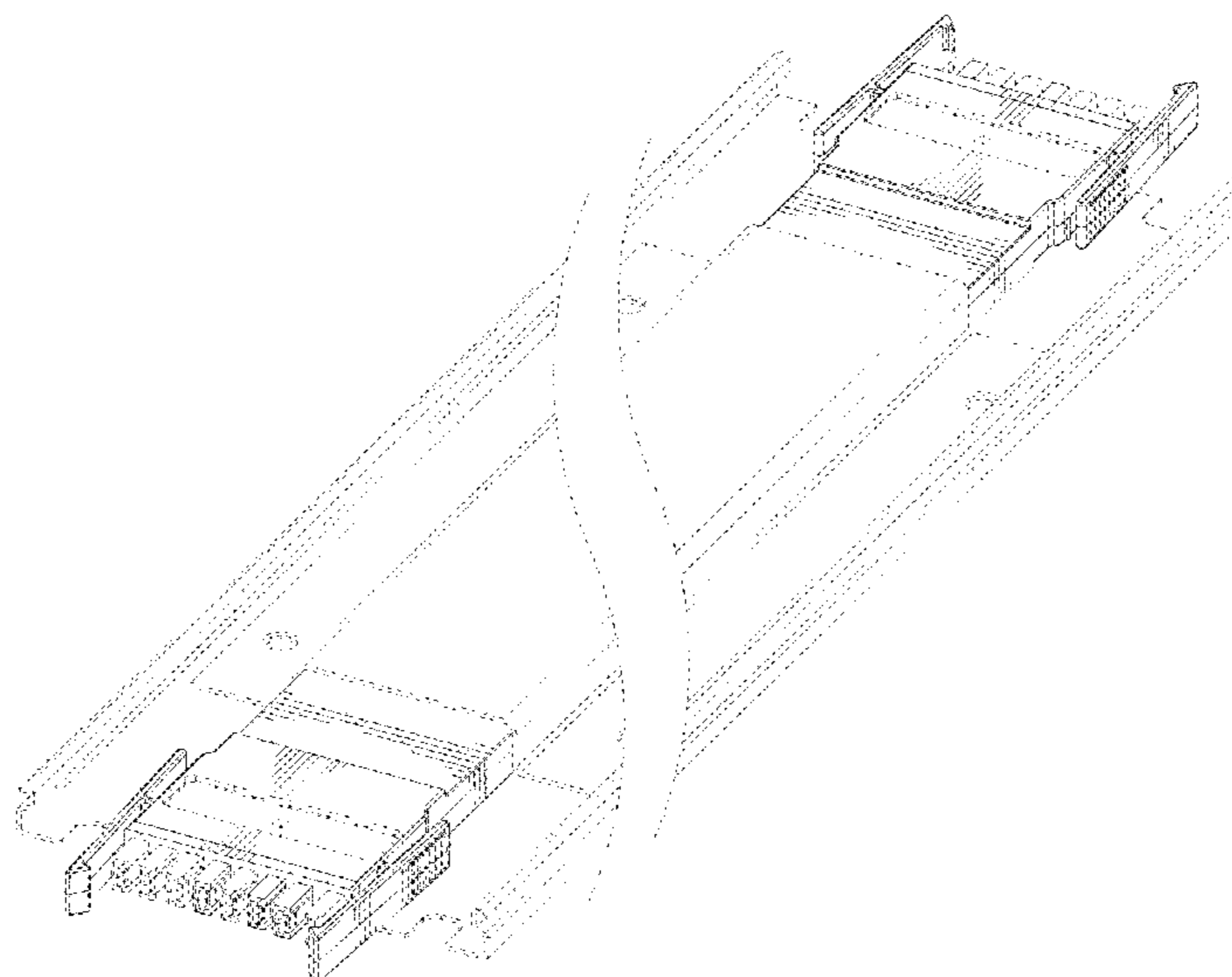

(57) **CLAIM**
The ornamental design for a connector for raceway, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left side perspective view of a connector for raceway, shown in a first condition for use; FIG. 2 is a top, front perspective view thereof; FIG. 3 is a top, front perspective view of the connector for raceway of FIG. 1, shown in a second condition for use; FIG. 4 is a bottom elevation view of the connector for raceway of FIG. 1, shown in the first condition for use; FIG. 5 is a left side elevation view thereof; FIG. 6 is a front elevation view of the connector for raceway of FIG. 1, shown in a third condition for use; and, FIG. 7 is a front elevation view of the connector for a raceway of FIG. 1, shown in the first condition for use. The broken lines on the connector depict portions of the connector for raceway that do not form a part of the claimed design. All other broken lines depict environmental subject matter that form no part of the claimed design.

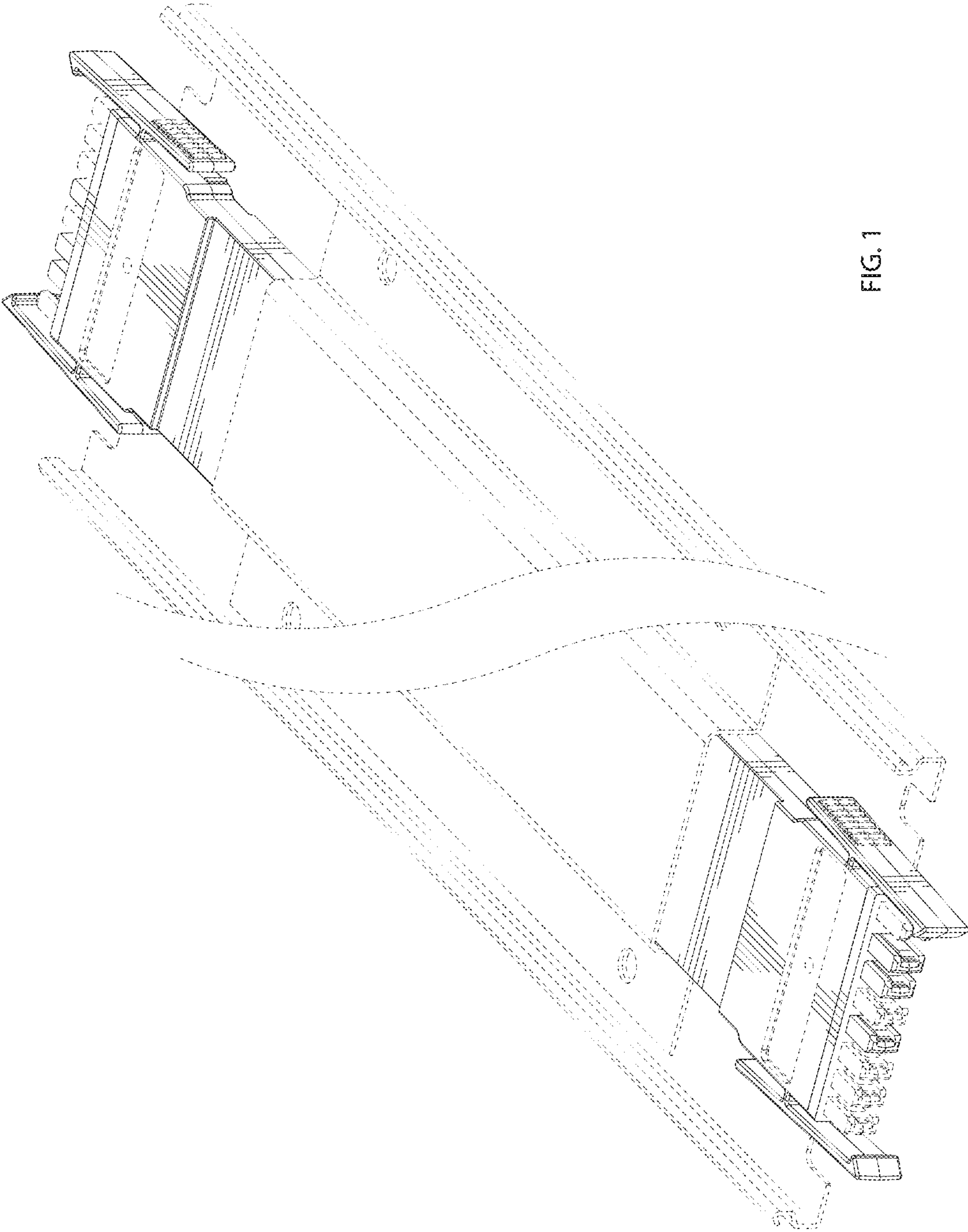

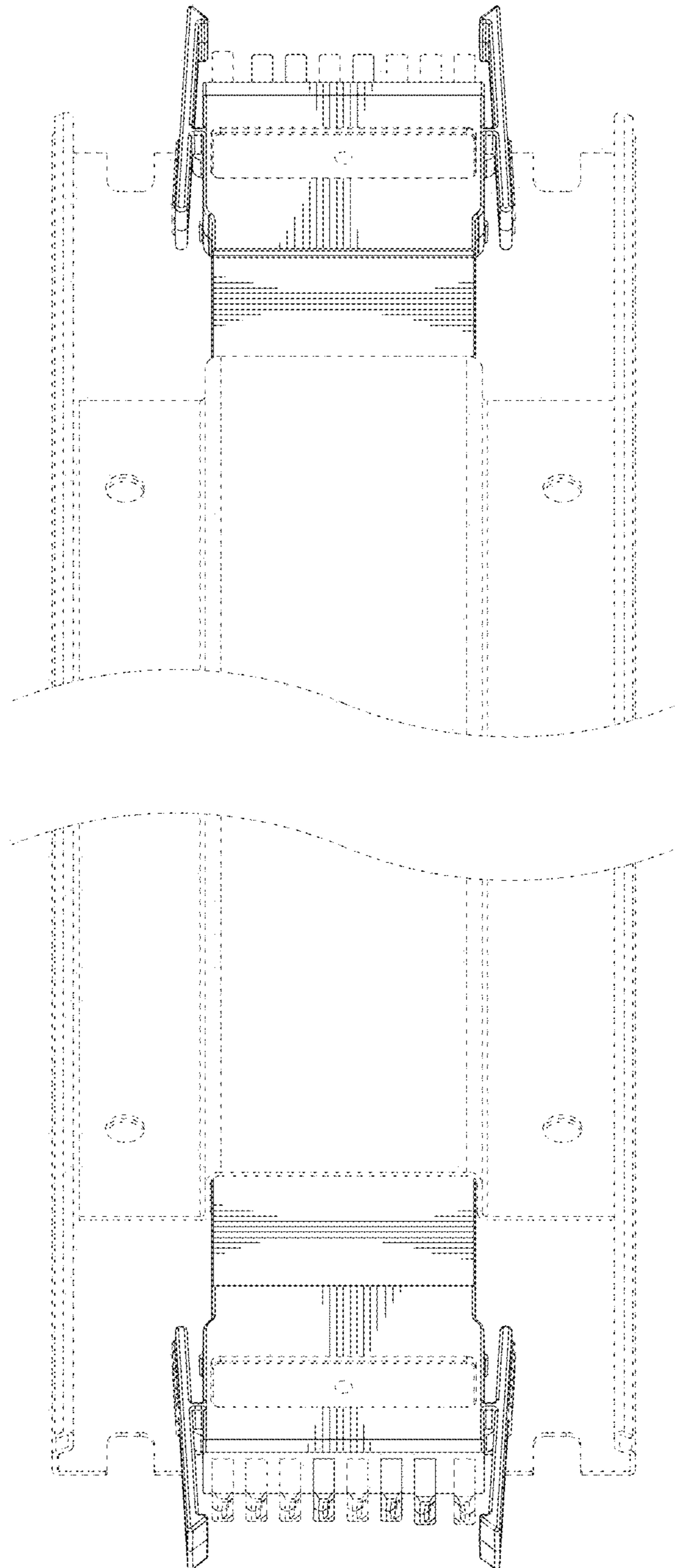

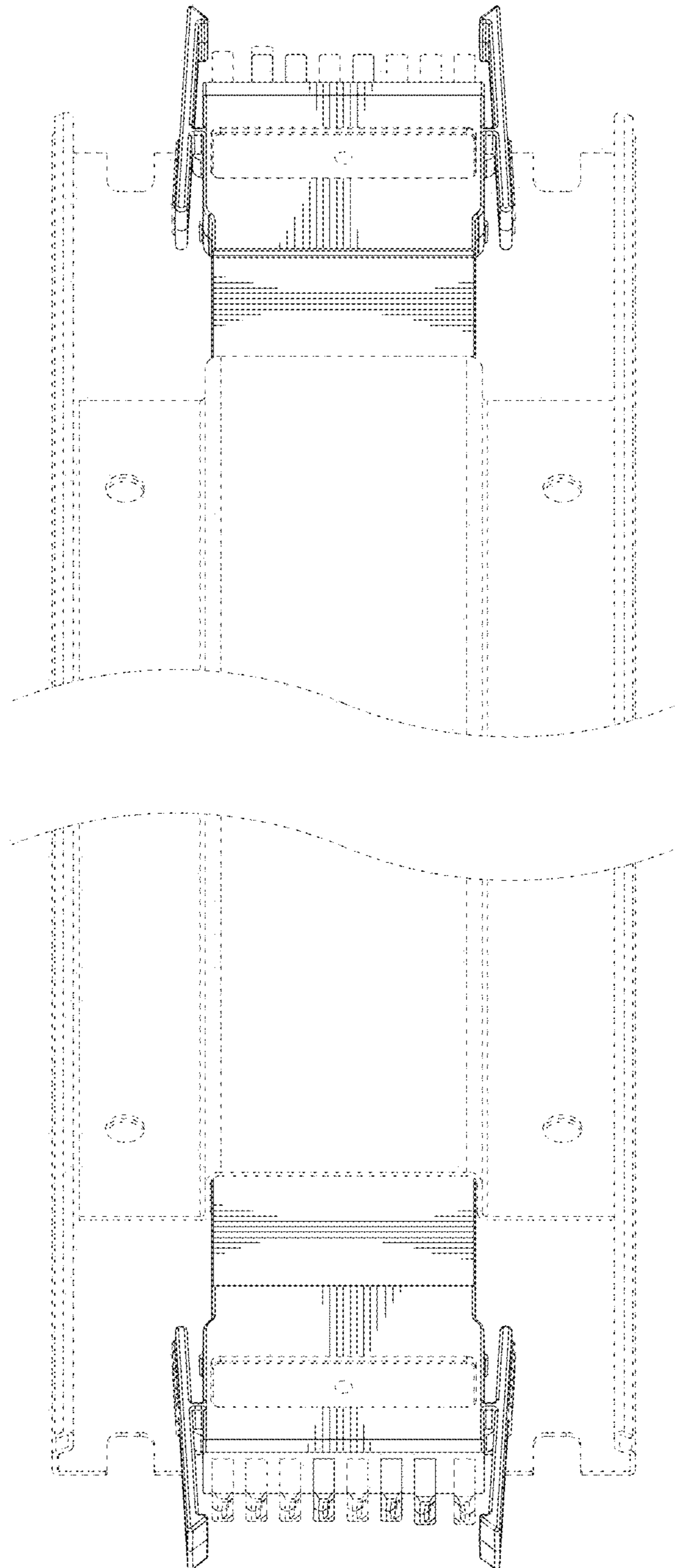

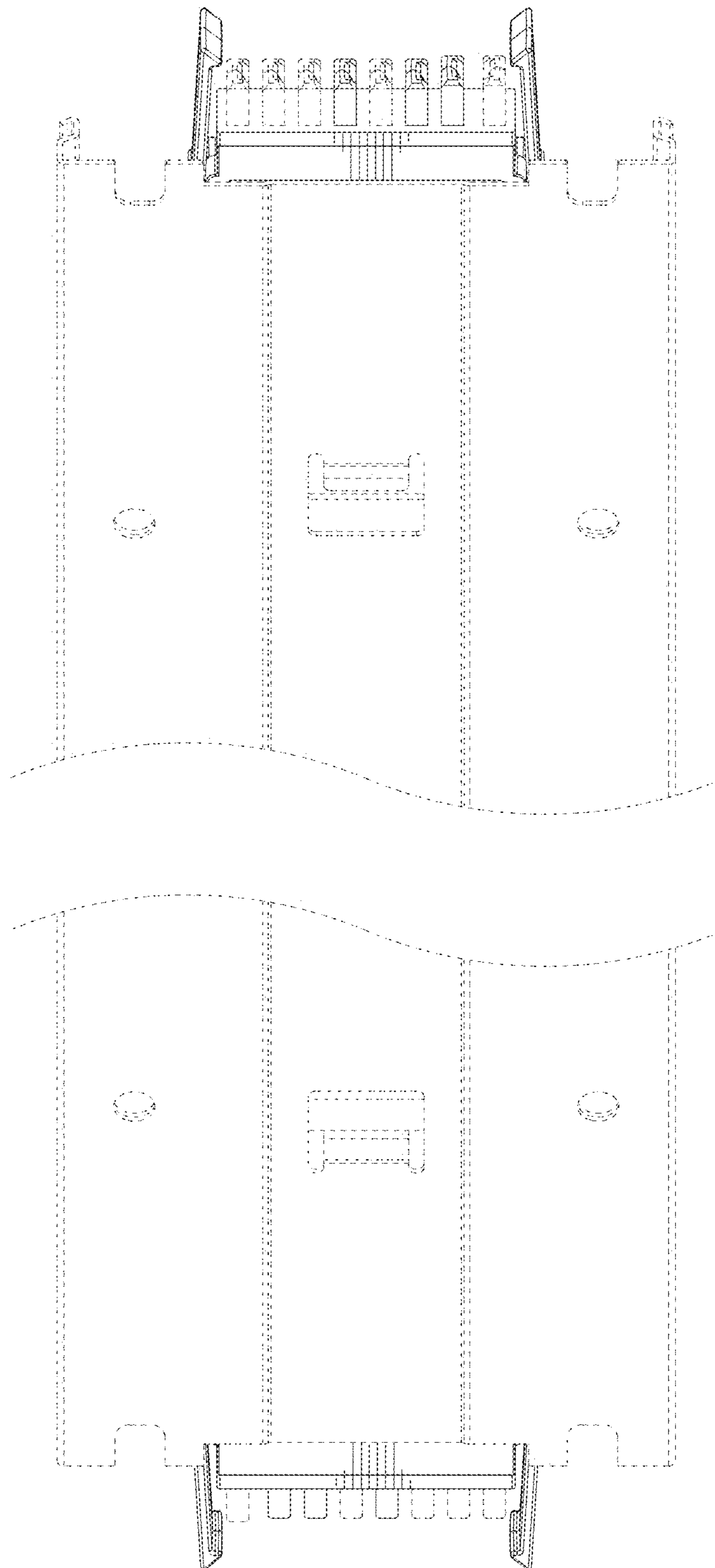
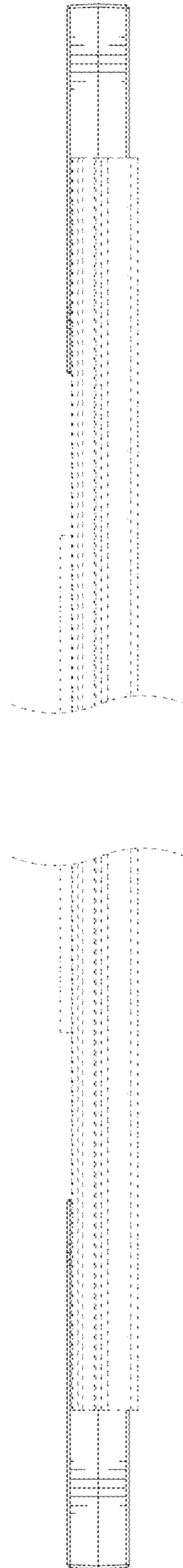

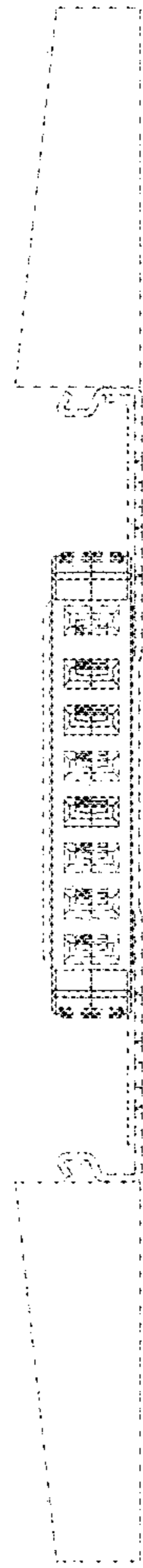
