**DESCRIPTION**

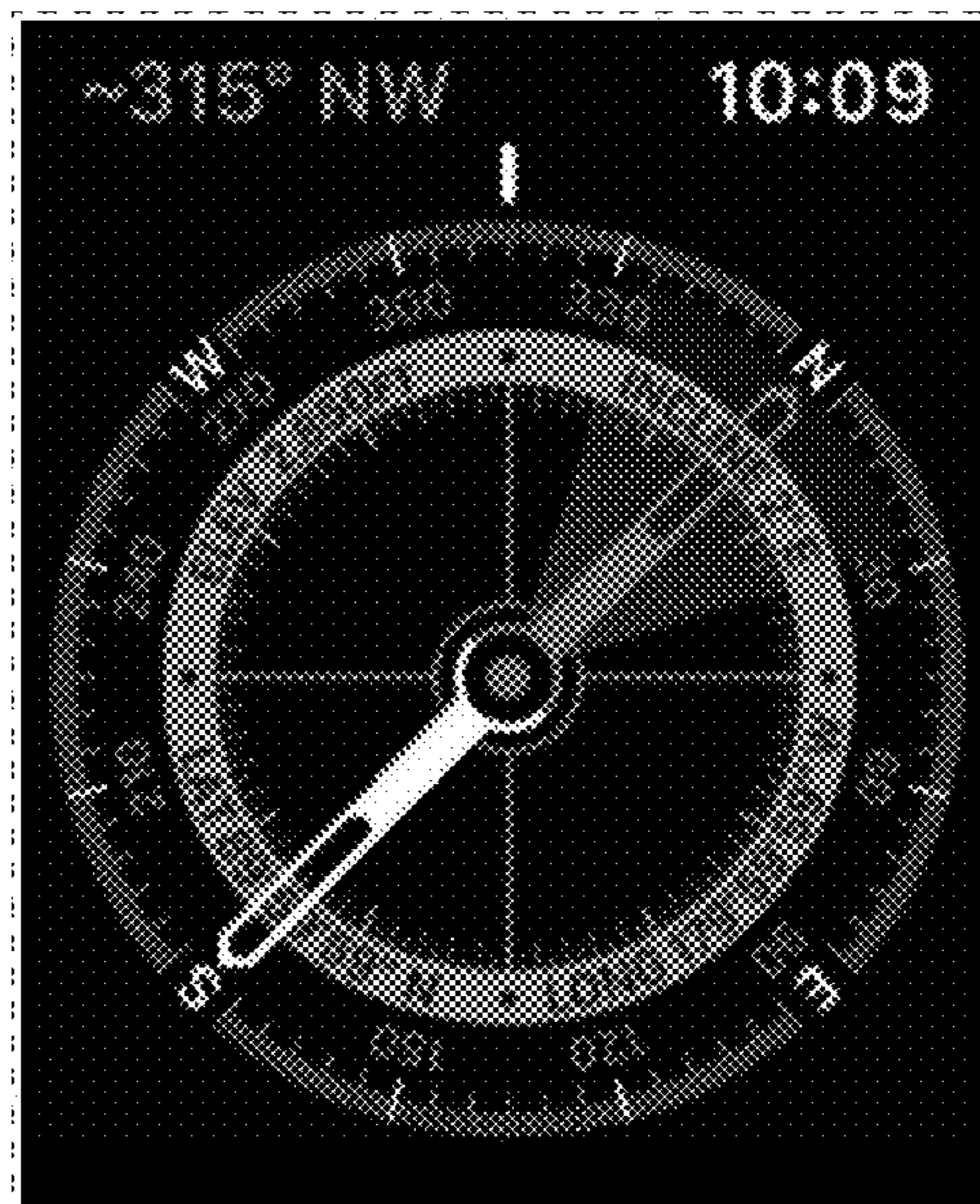
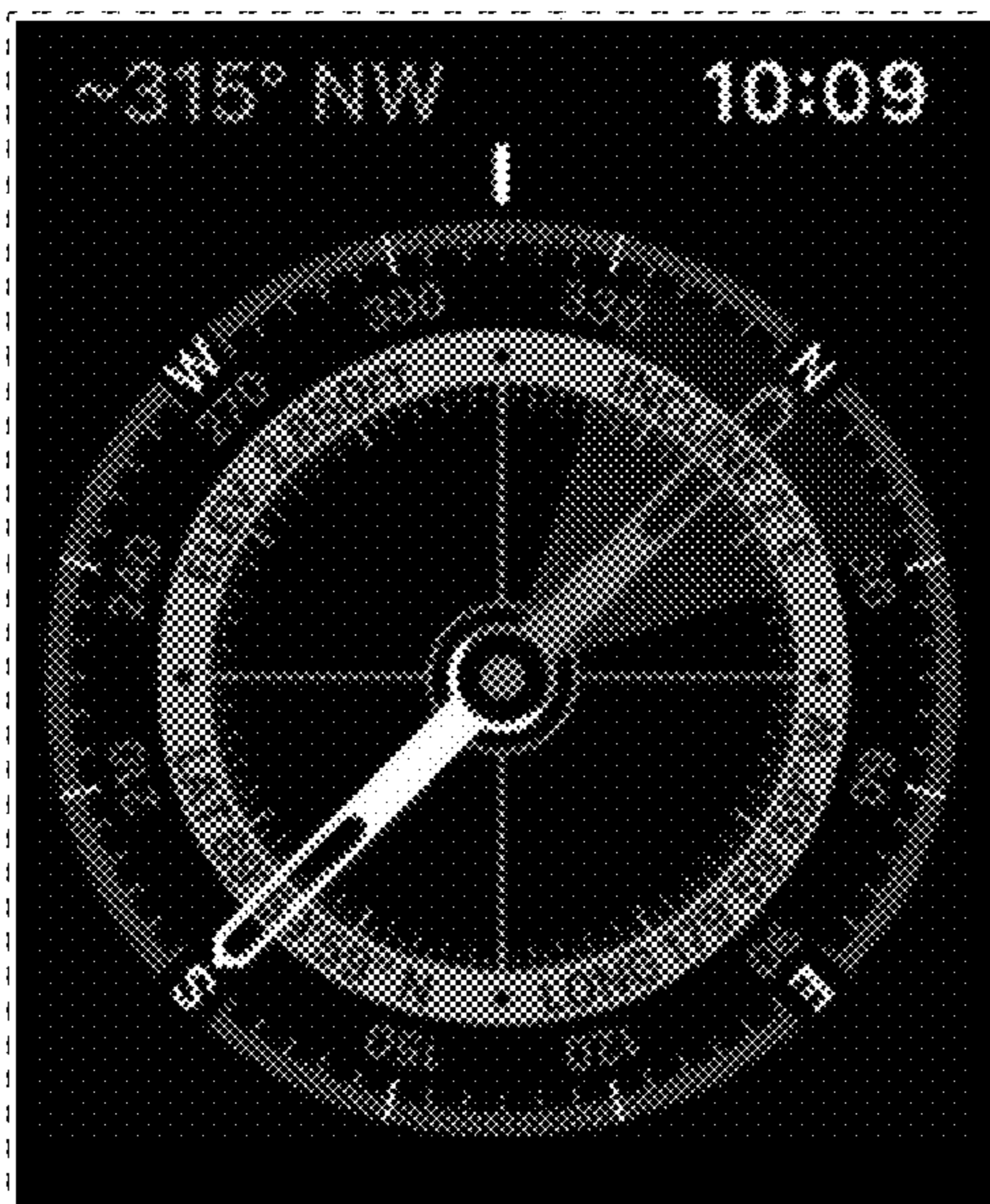

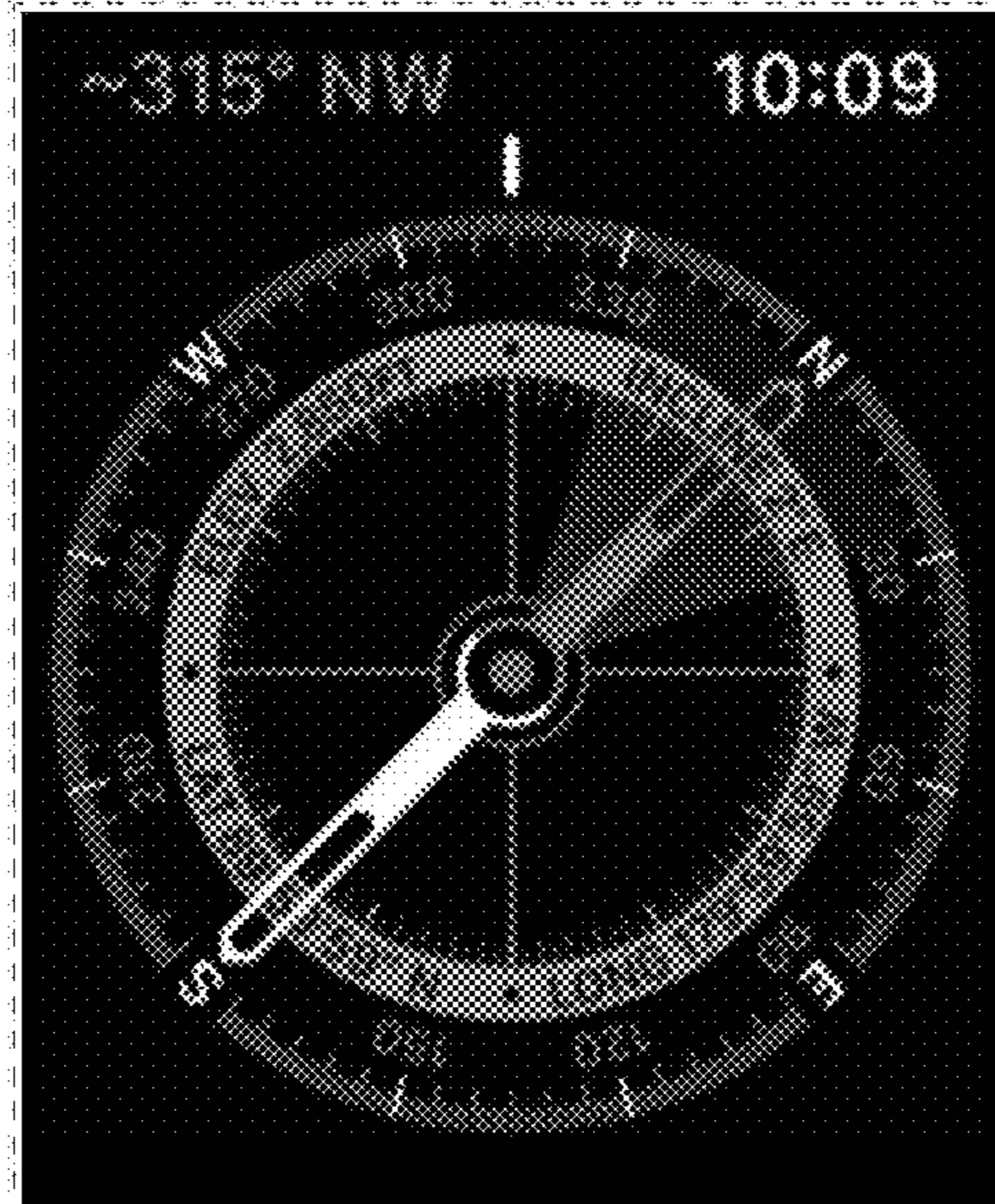

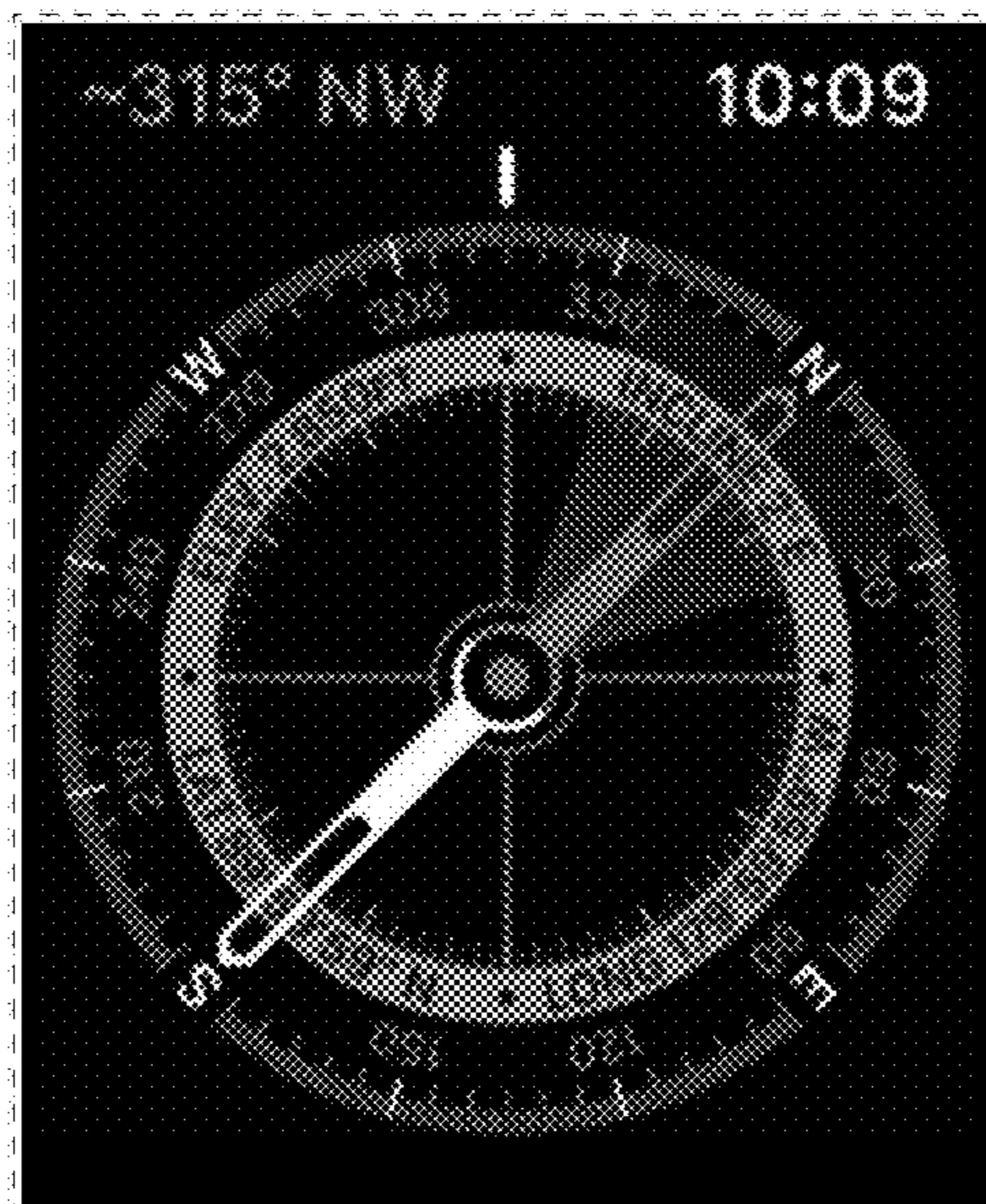
