
(57) **CLAIM**


The ornamental design for a transmission cooler for automotive applications, as shown and described.

**DESCRIPTION**

FIG. 1 is a top front perspective view of the transmission cooler for automotive applications showing my new design; FIG. 2 is a front elevation view thereof; FIG. 3 with the rear elevation view being a mirror image thereof; FIG. 4 is a right elevation view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The broken lines shown in the drawings illustrate portions of the transmission cooler for automotive applications that form no part of the claimed design.











