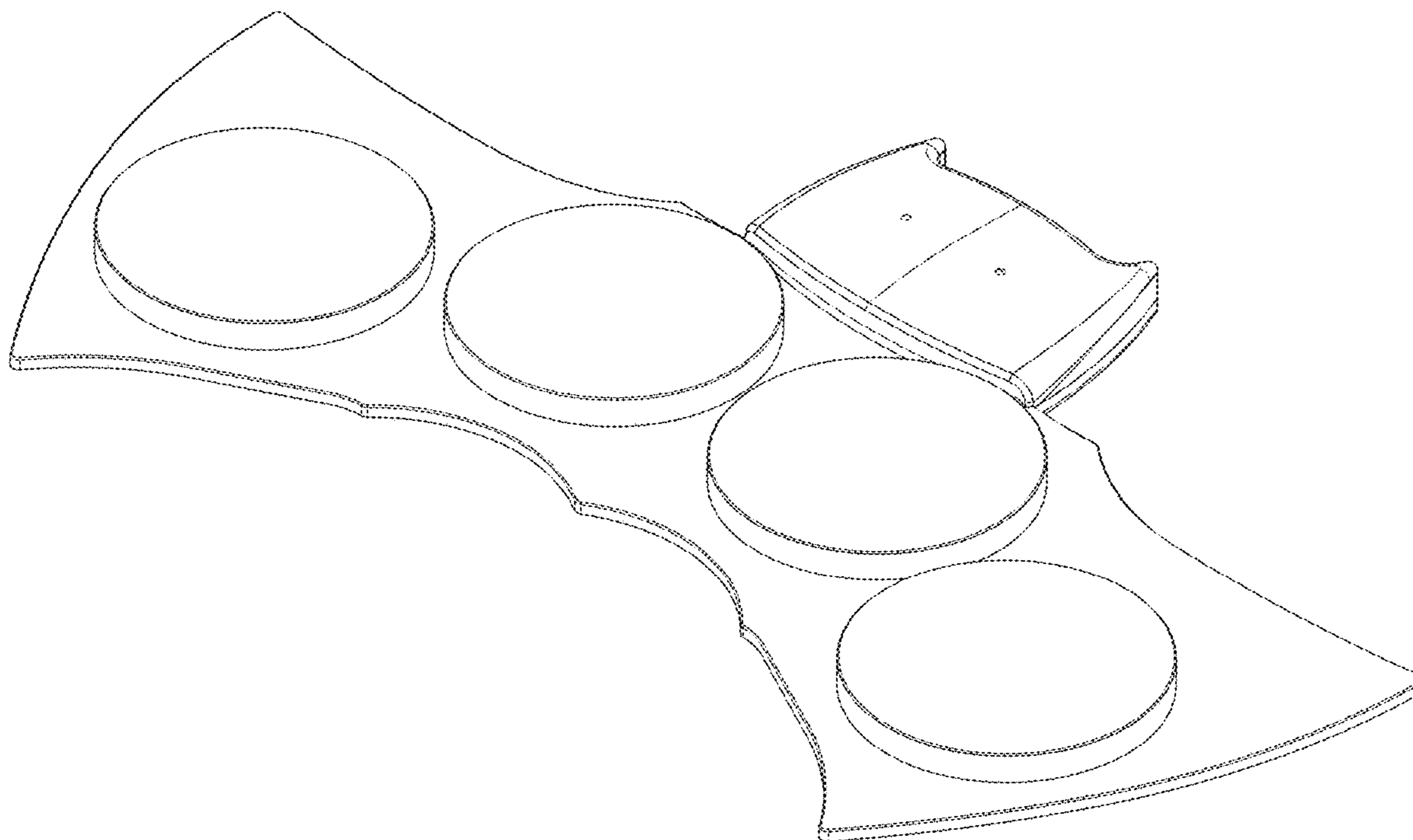
The ornamental design for a game controller, as shown and described.

**DESCRIPTION**

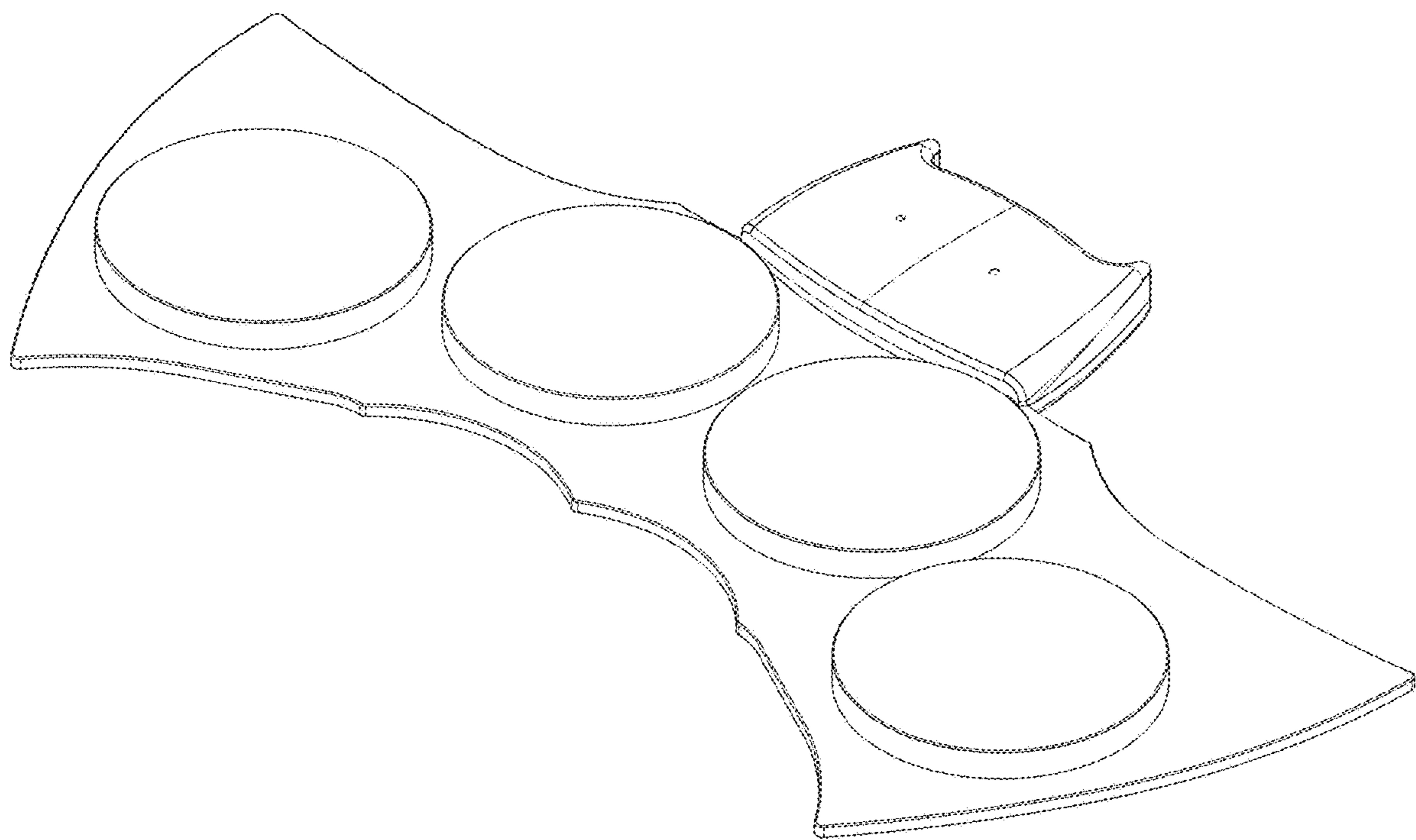

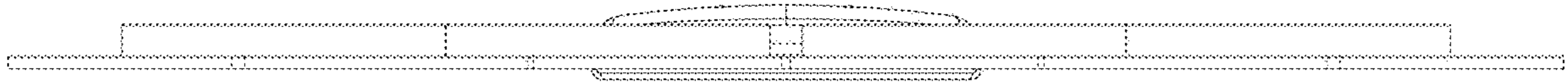

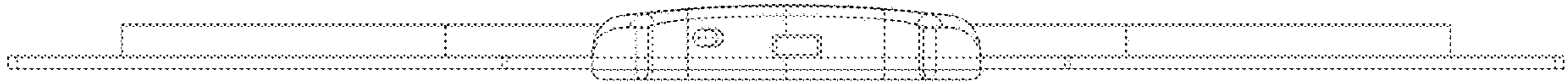

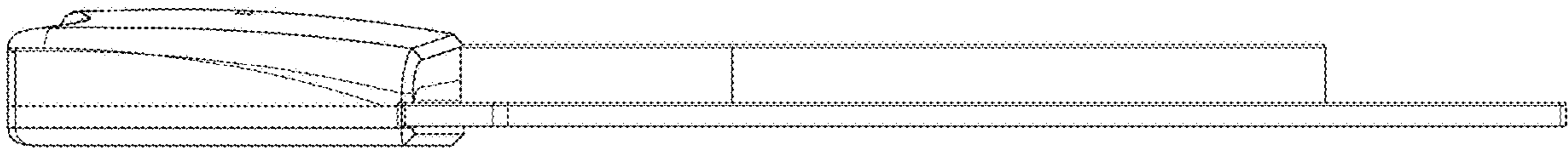

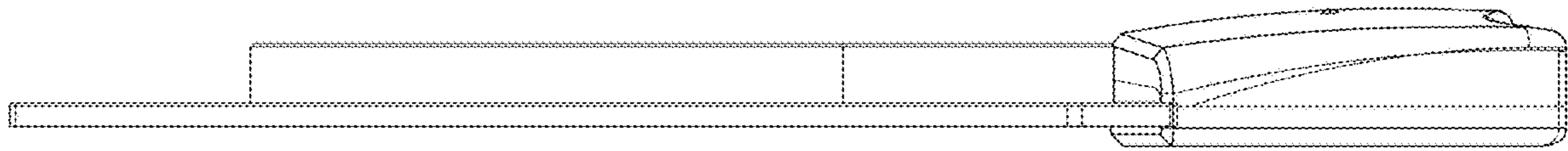

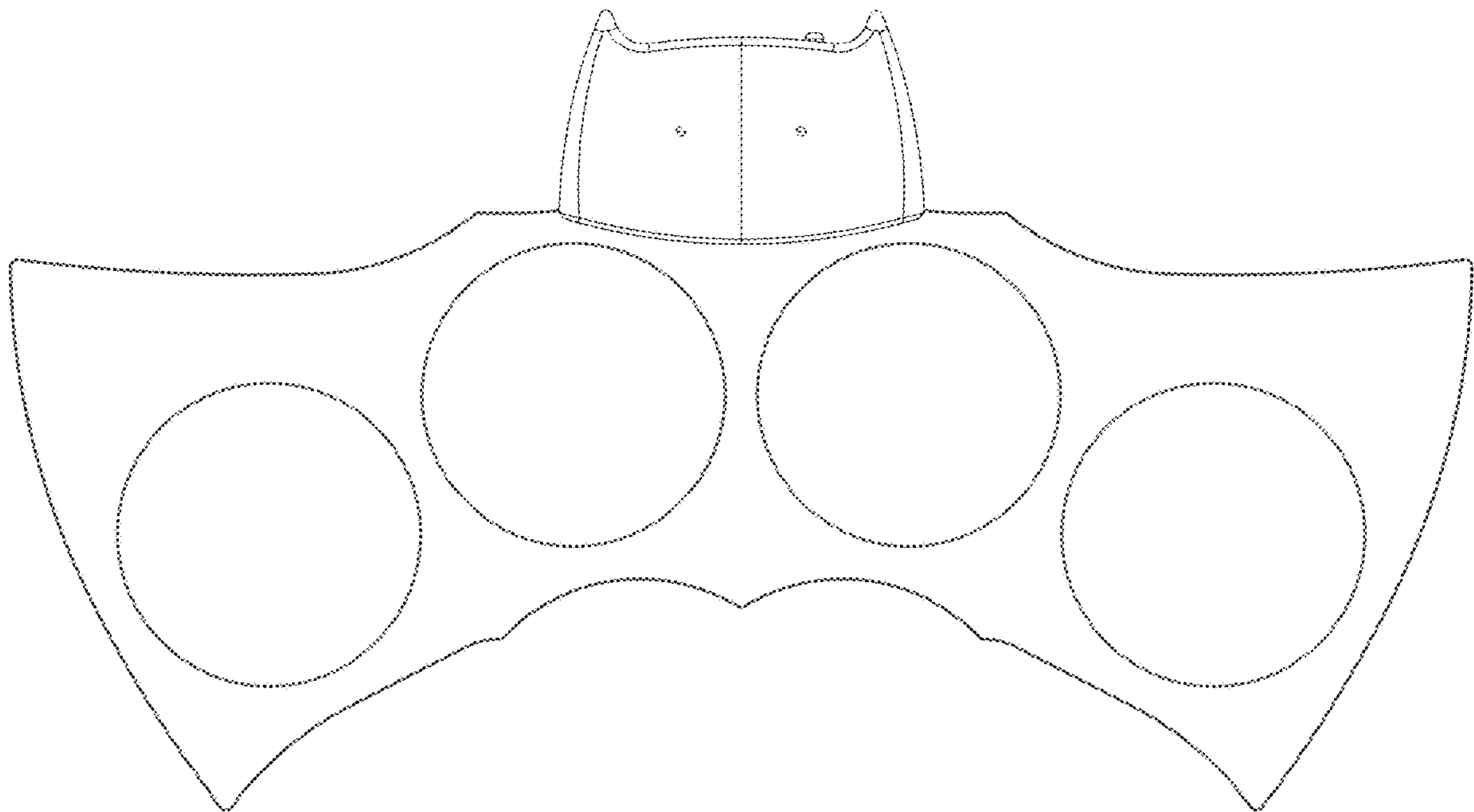
