The ornamental design for an electric scooter, as shown and described.

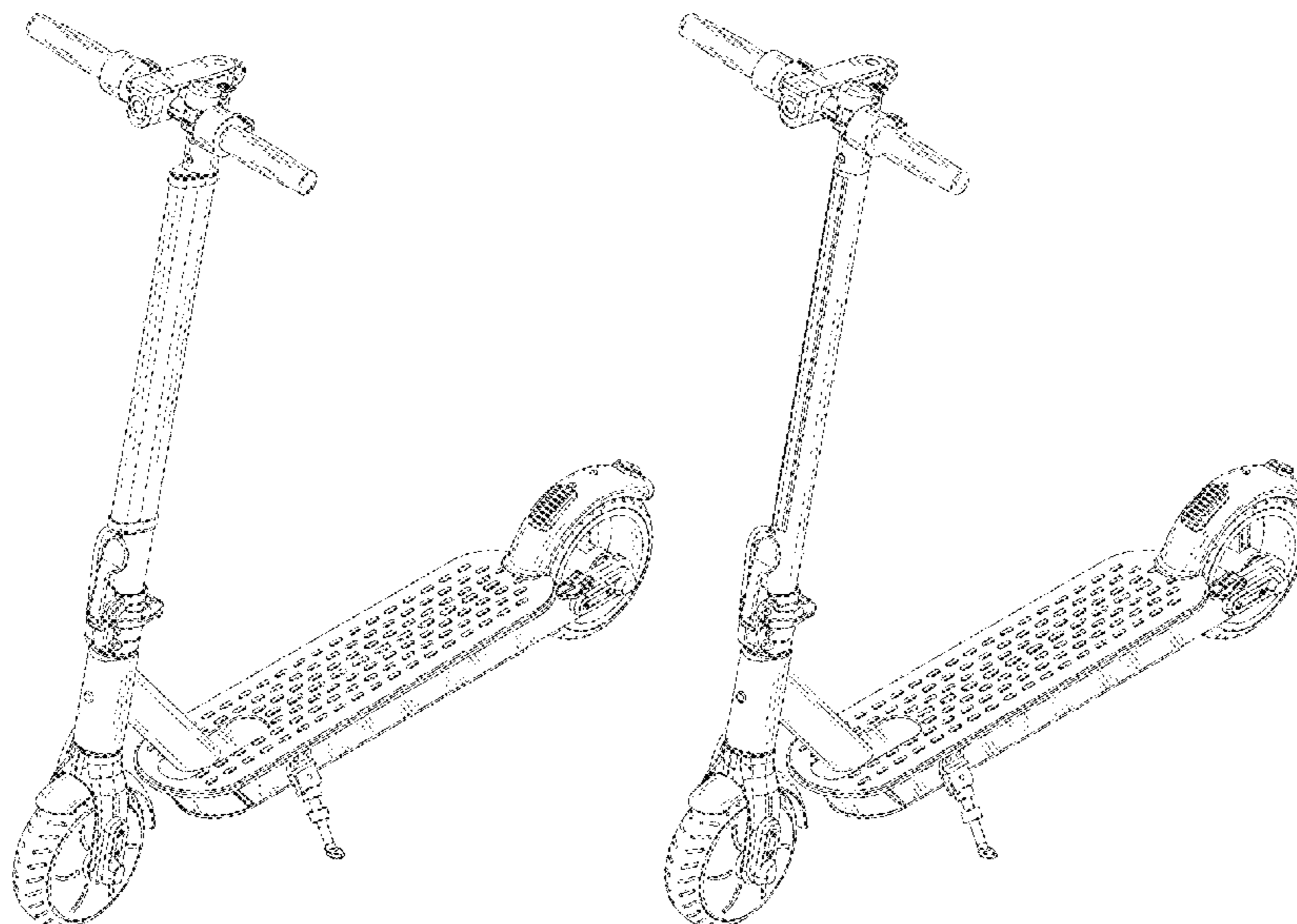
**DESCRIPTION**

FIG. 1 is a front perspective view of a first embodiment of an electric scooter showing our new design; FIG. 2 is a rear perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a bottom plan view thereof; FIG. 9 is an enlarged partial view of the handle bar stem taken from FIG. 1; FIG. 10 is a front perspective view of a second embodiment of the electric scooter; FIG. 11 is a rear perspective view of the electric scooter of FIG. 10; FIG. 12 is a front elevational view of the electric scooter of FIG. 10; FIG. 13 is a rear elevational view of the electric scooter of FIG. 10; FIG. 14 is a left side elevational view of the electric scooter of FIG. 10; FIG. 15 is a right side elevational view of the electric scooter of FIG. 10; FIG. 16 is a top plan view of the electric scooter of FIG. 10; FIG. 17 is a bottom plan view of the electric scooter of FIG. 10; and, FIG. 18 is an enlarged partial view of the handle bar stem taken from FIG. 10.

The dash-dash broken lines in the drawings illustrate portions of the electric scooter which form no part of the claimed design.

The dash-dot broken lines represent the boundaries of the enlarged partial views of FIGS. 9 and 18 and form no part of the claimed design.

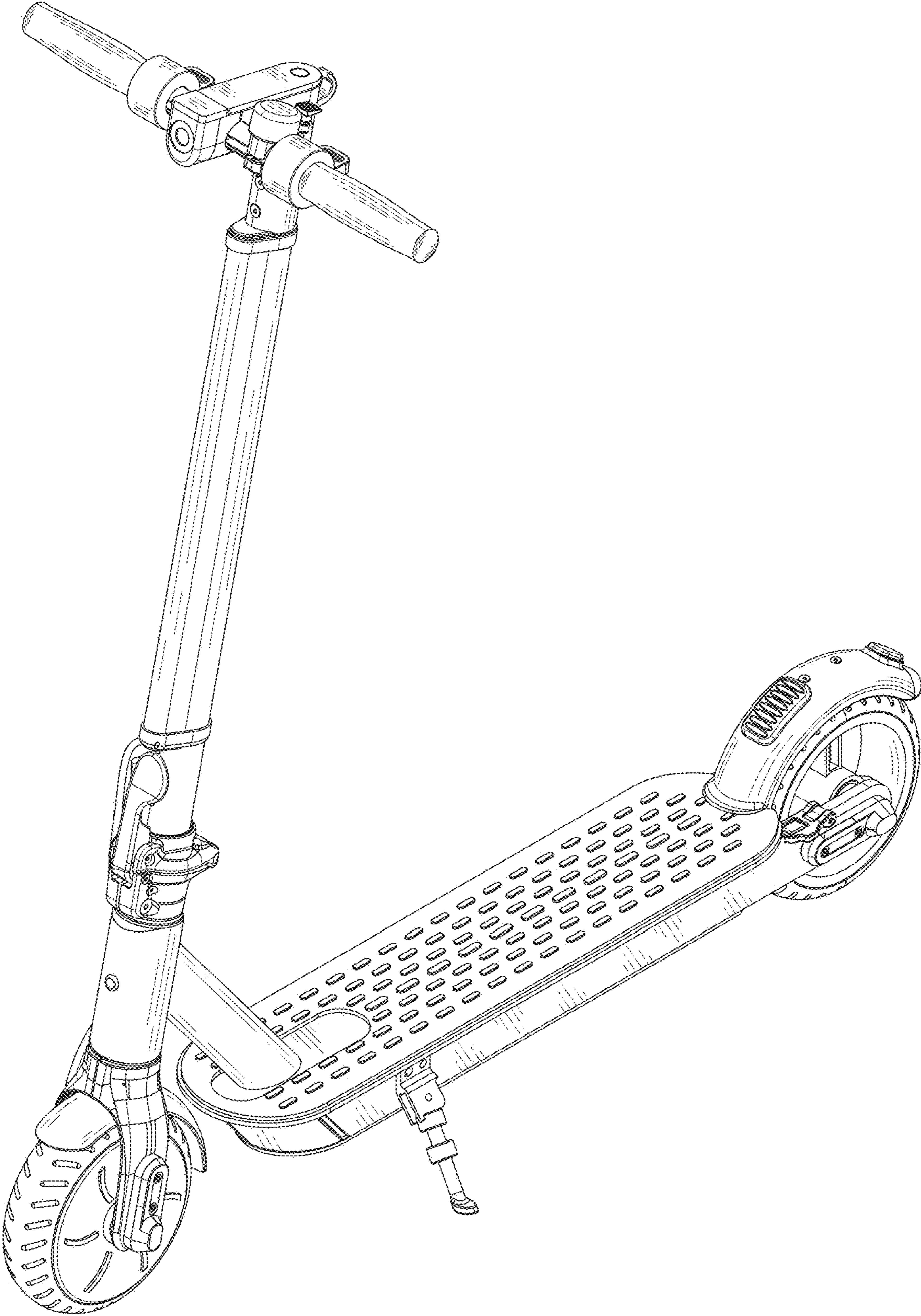

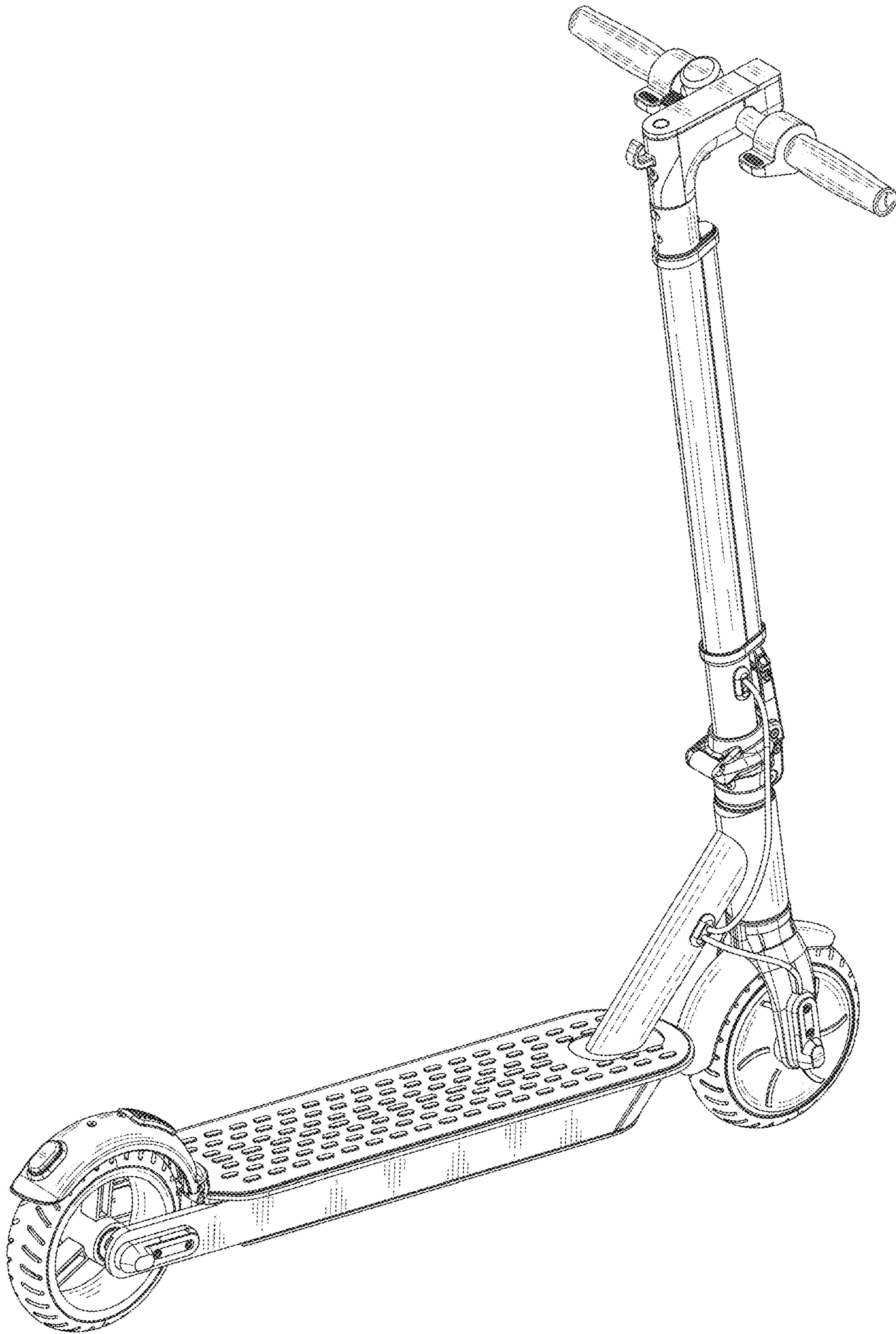

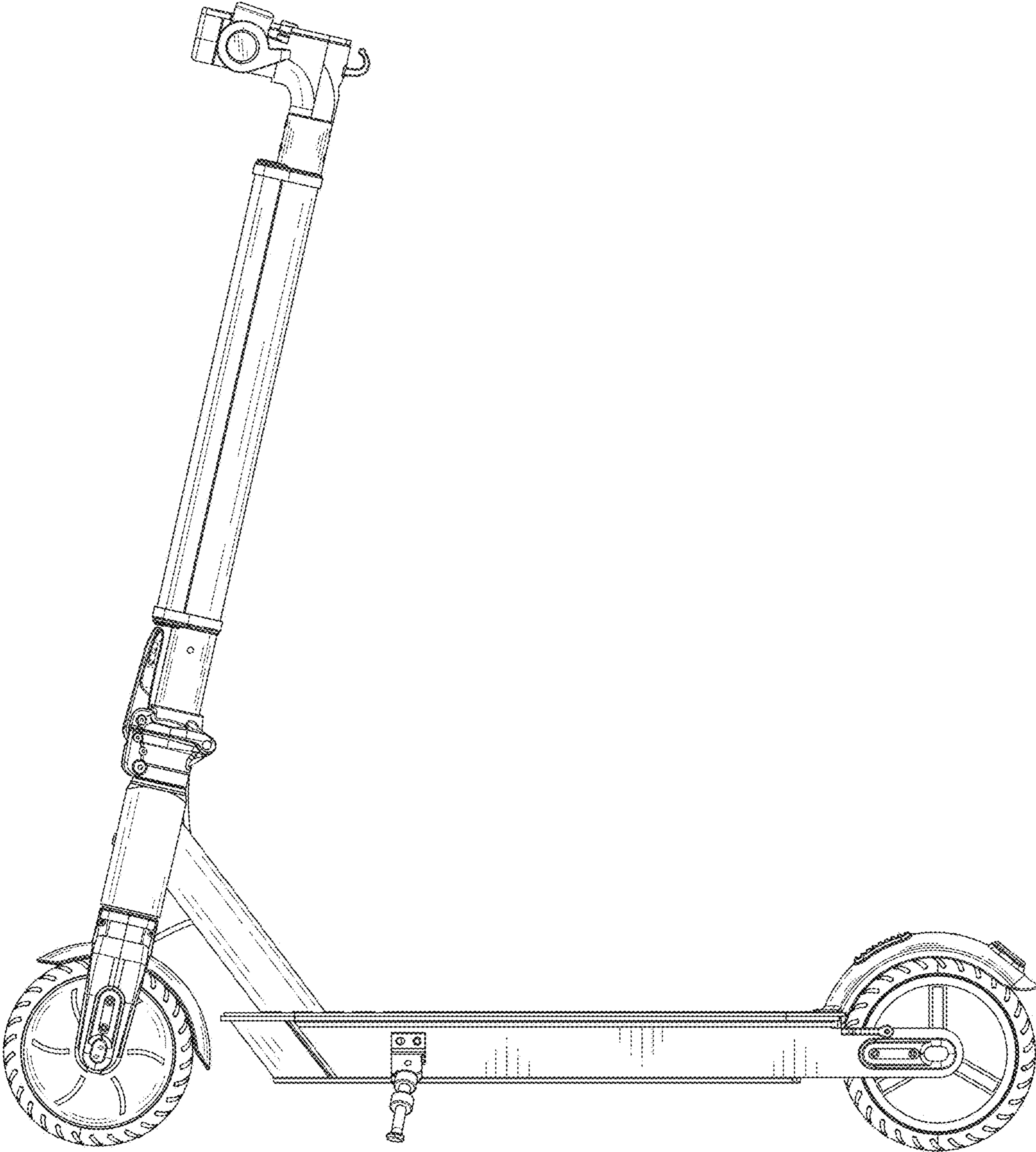

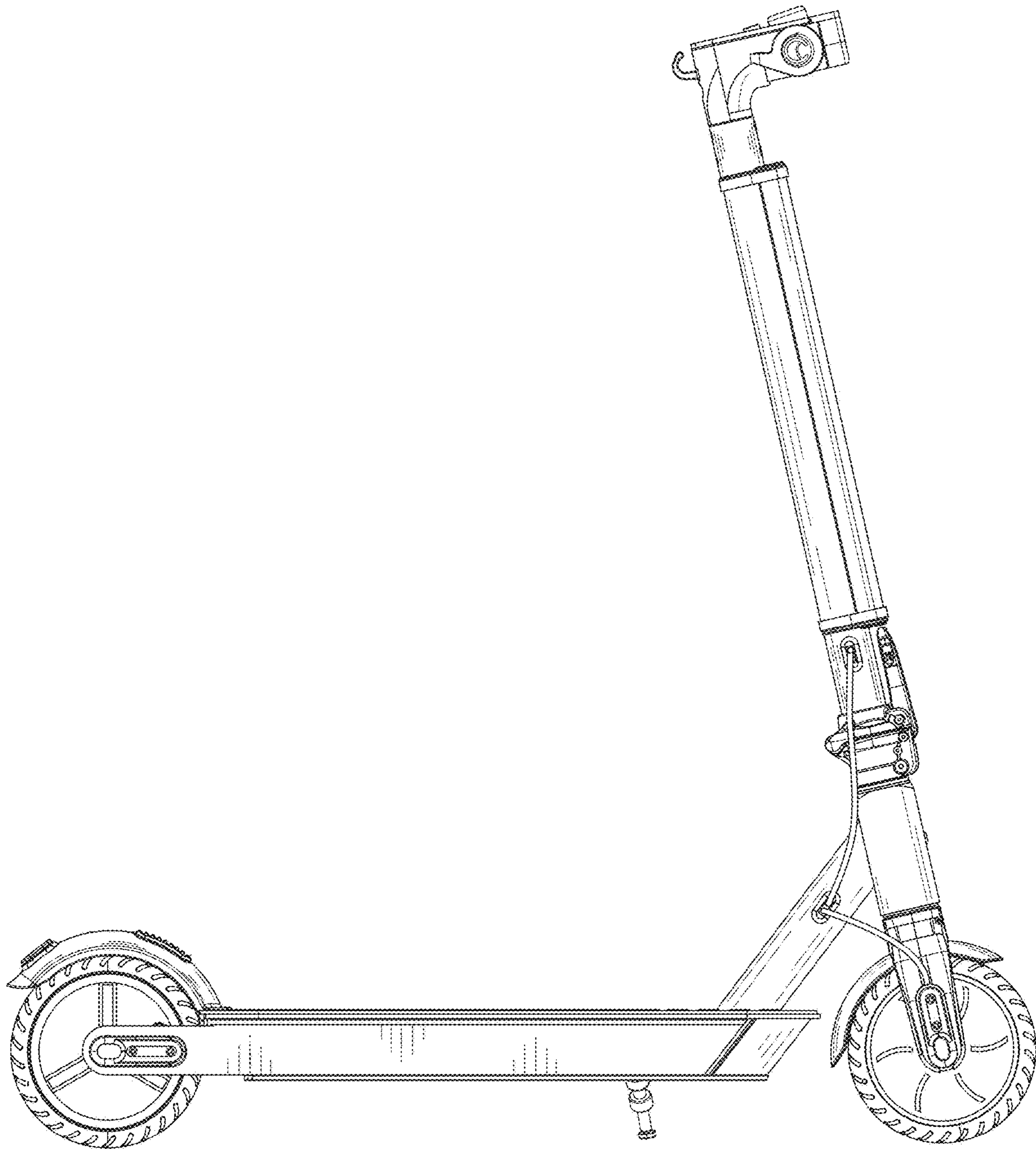

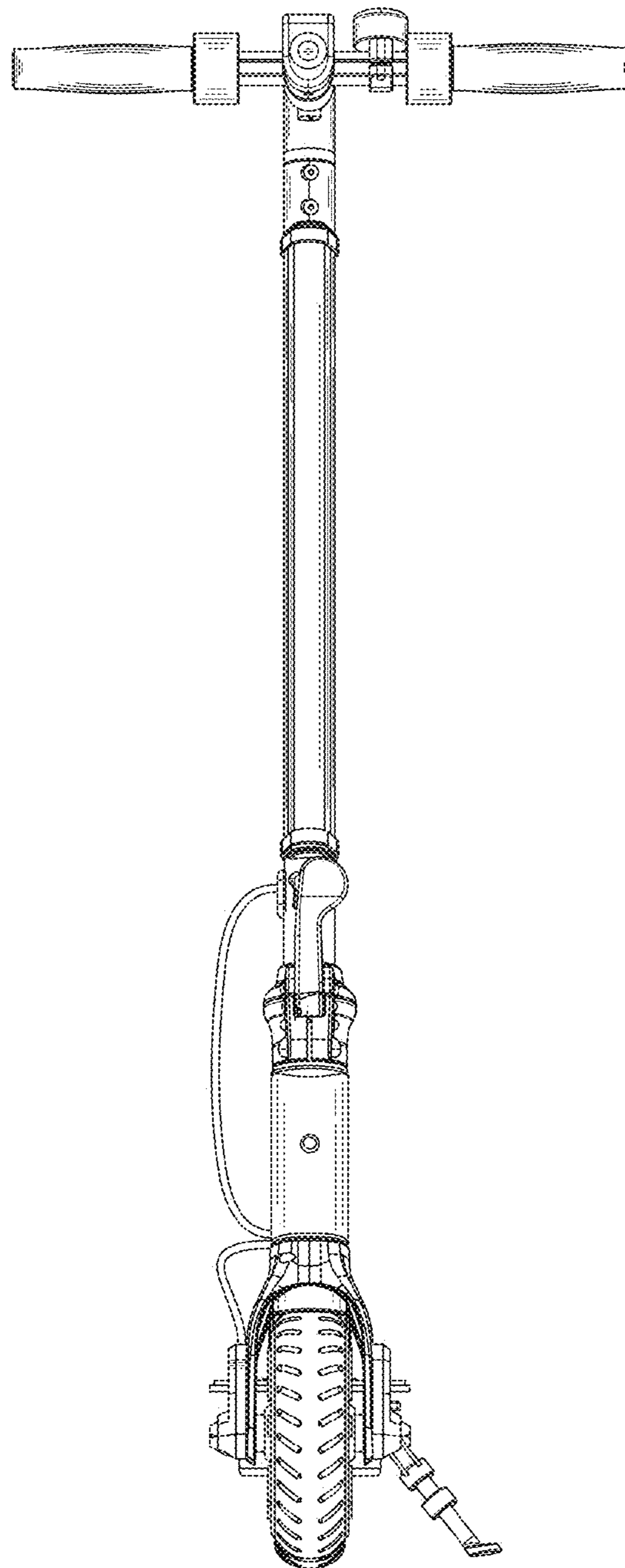

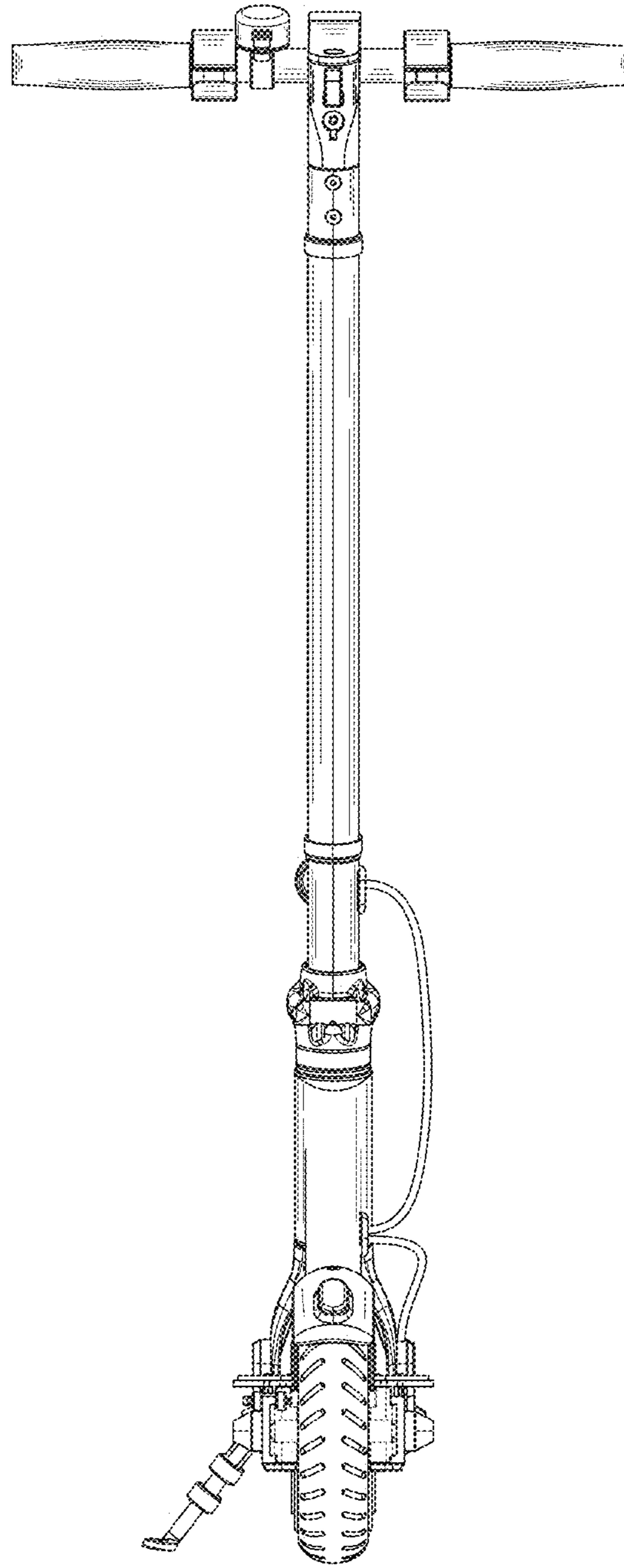

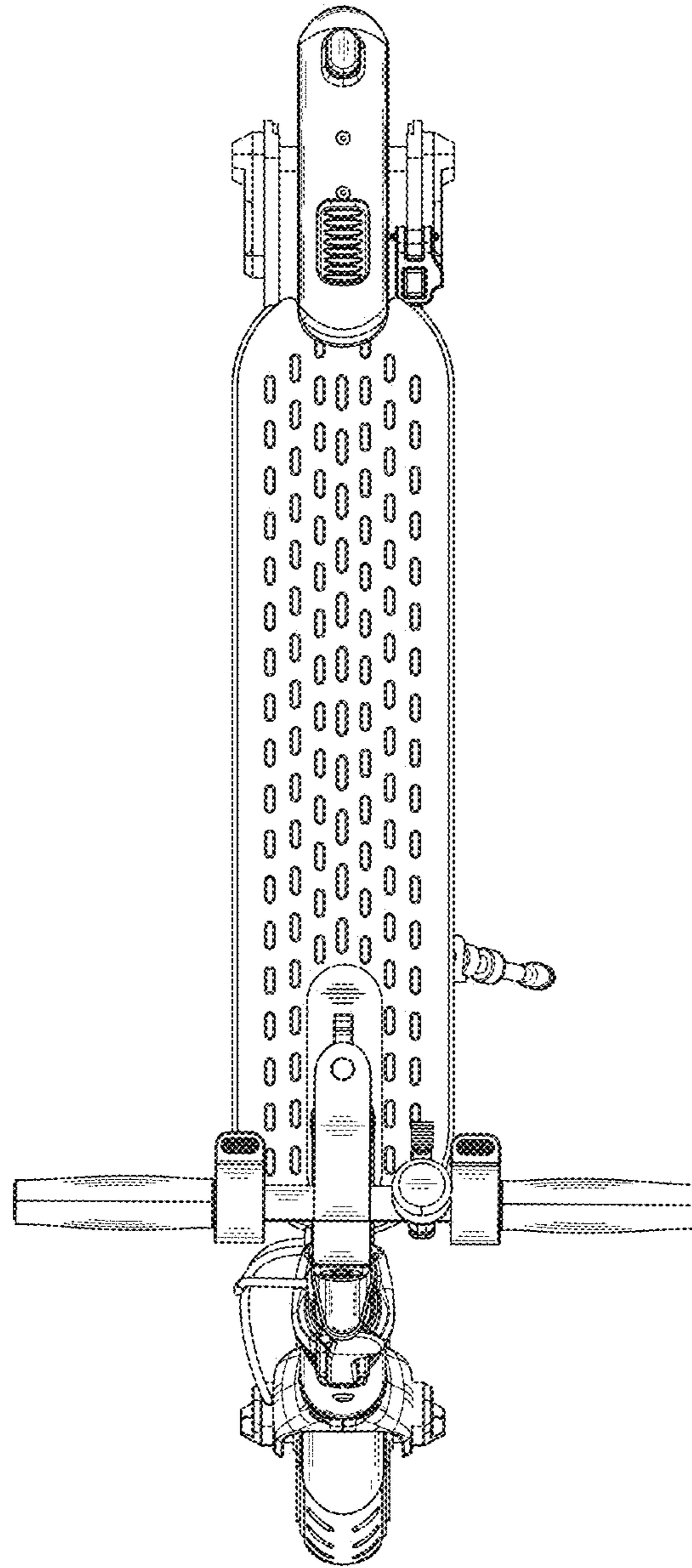

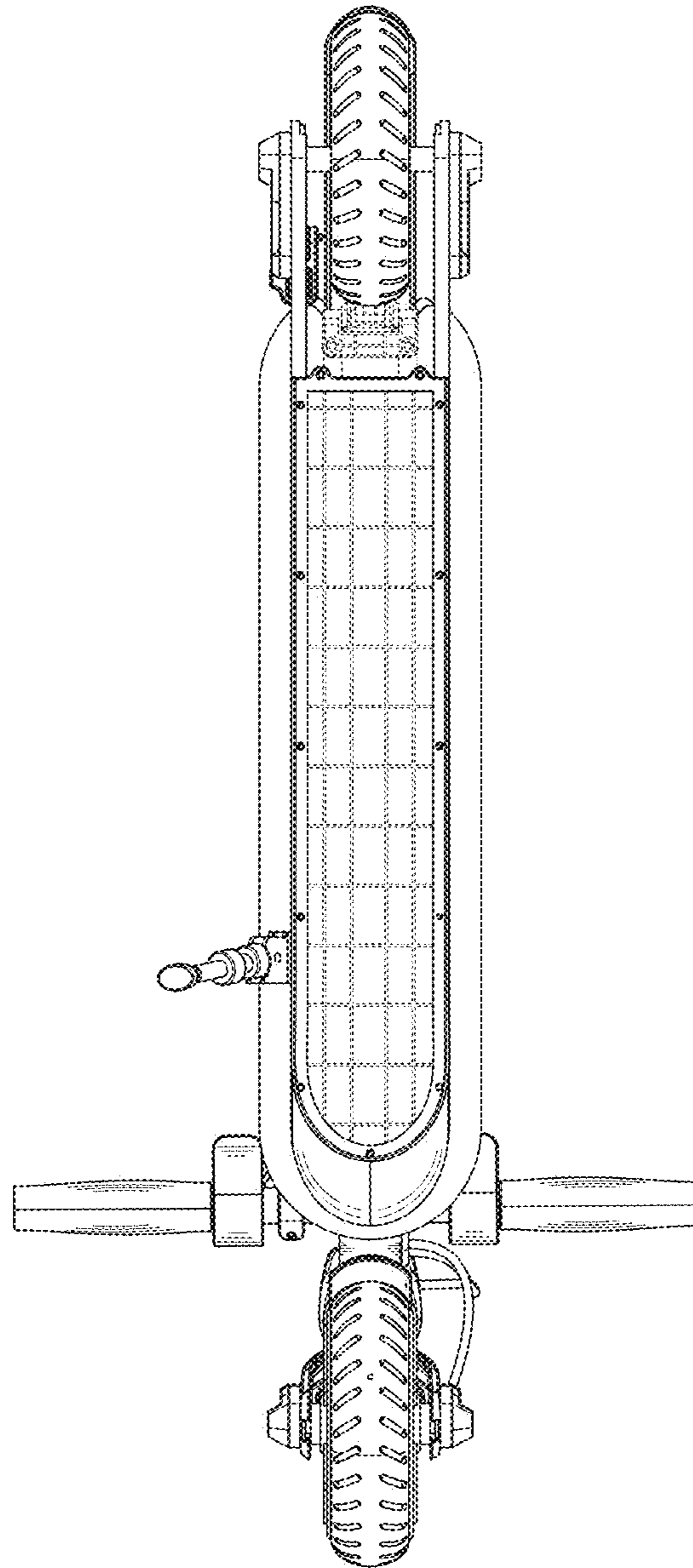

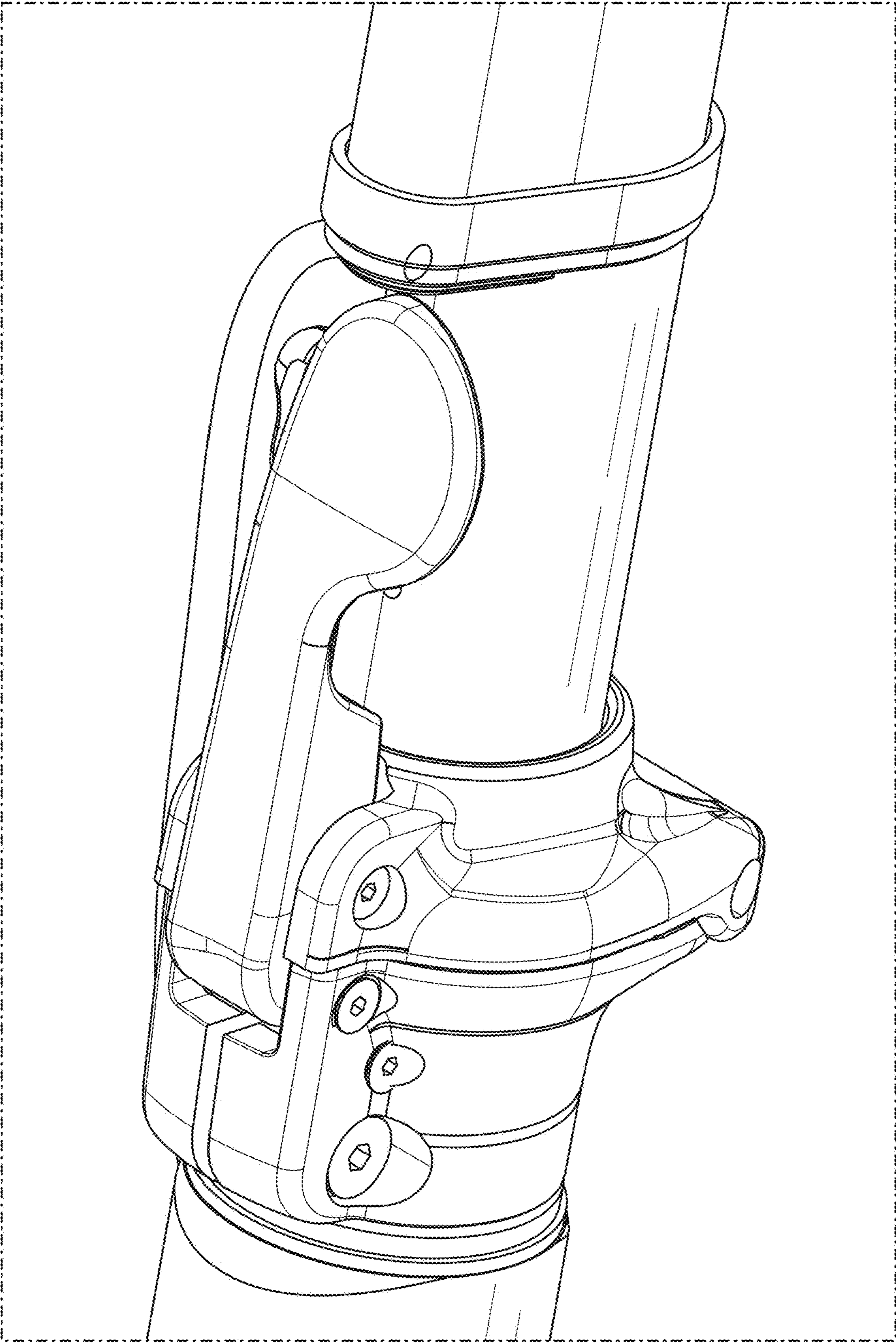

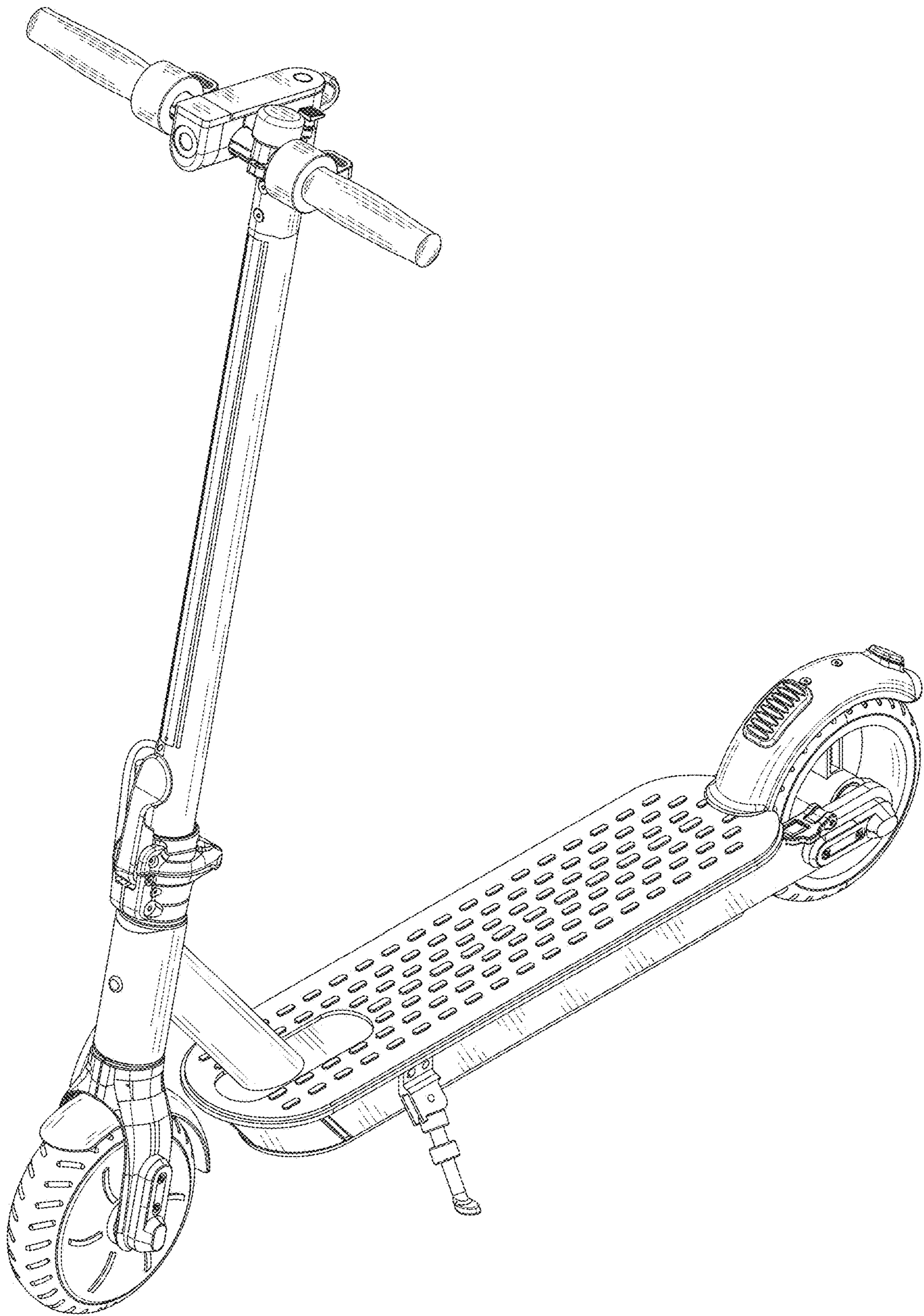

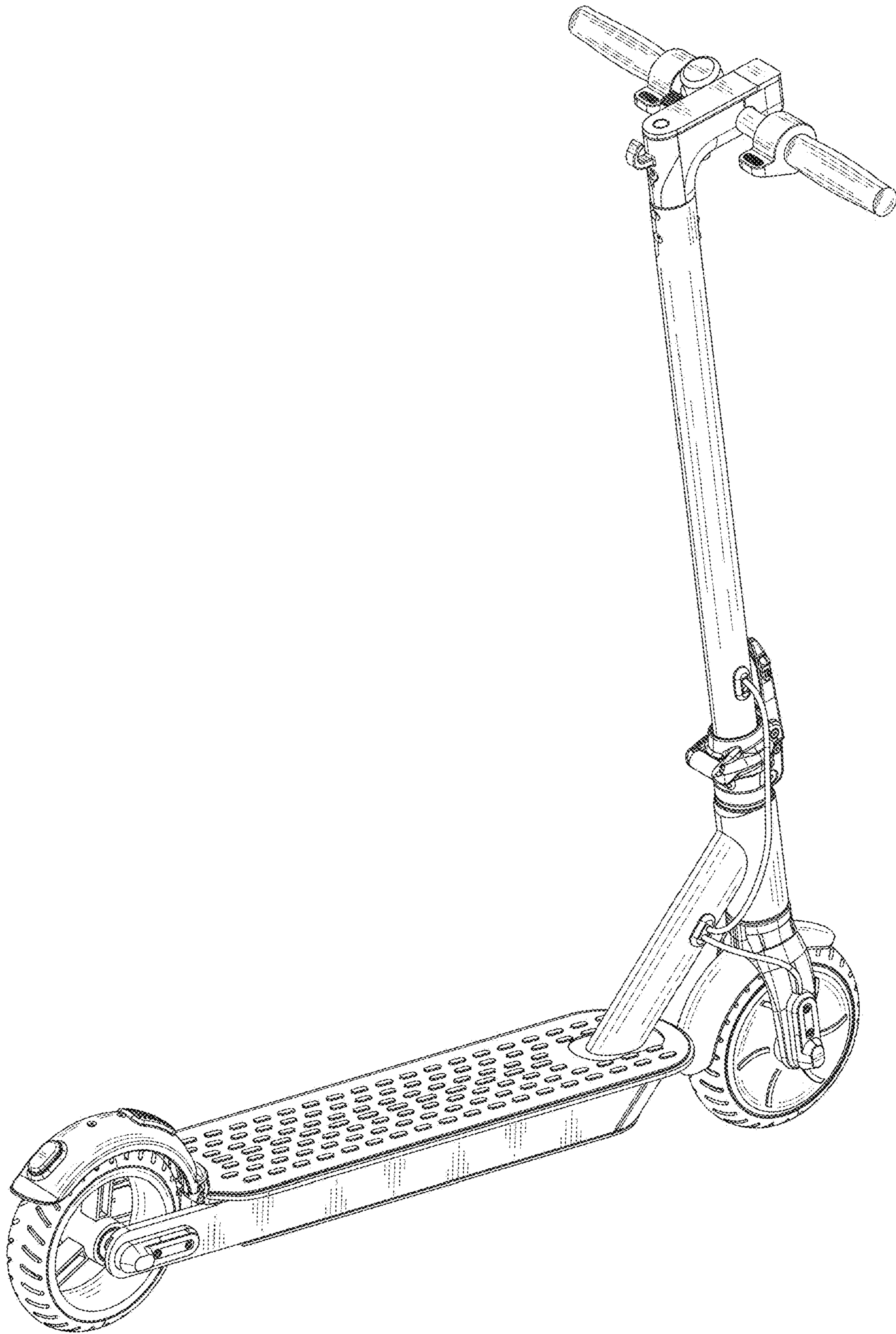

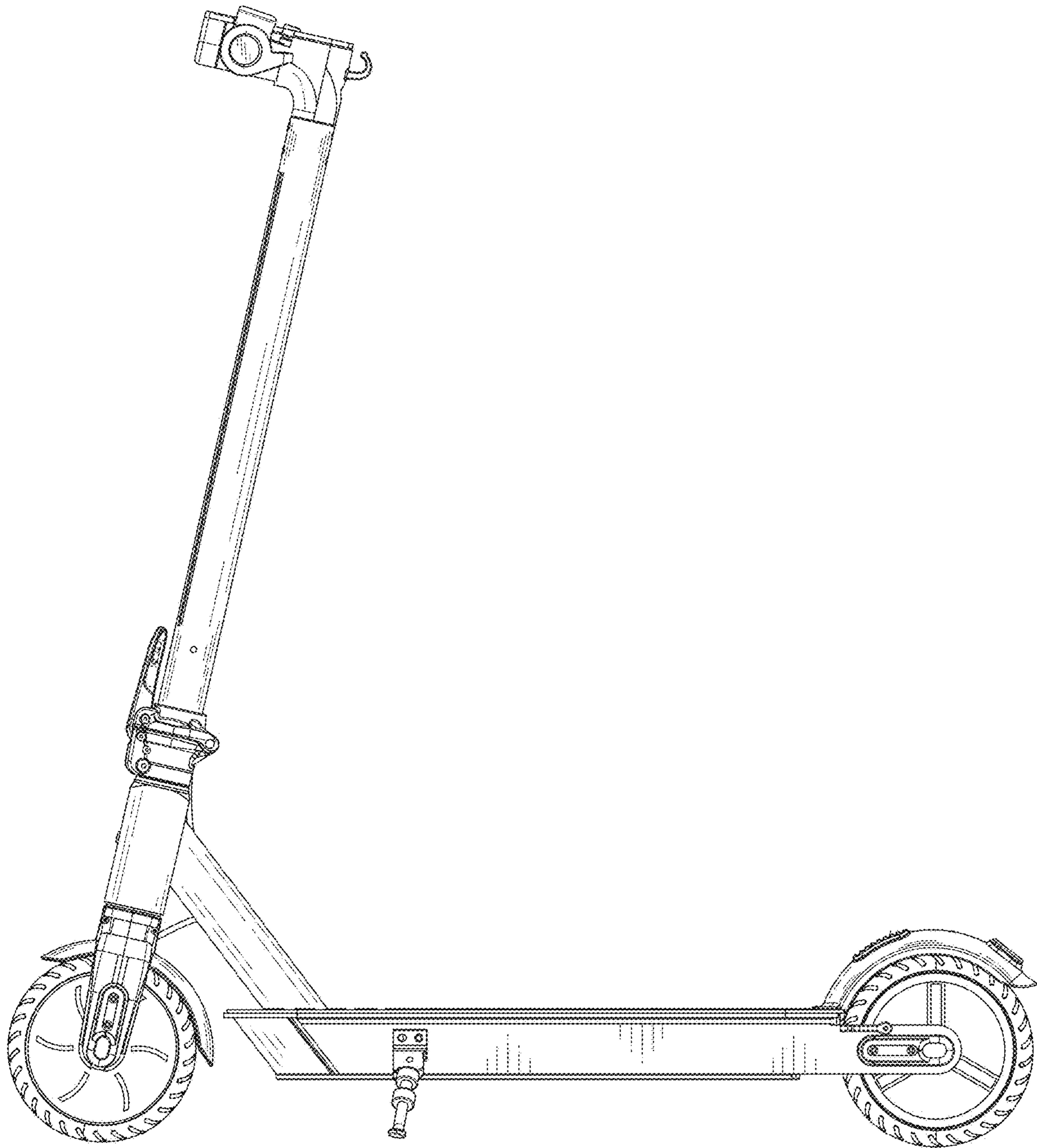

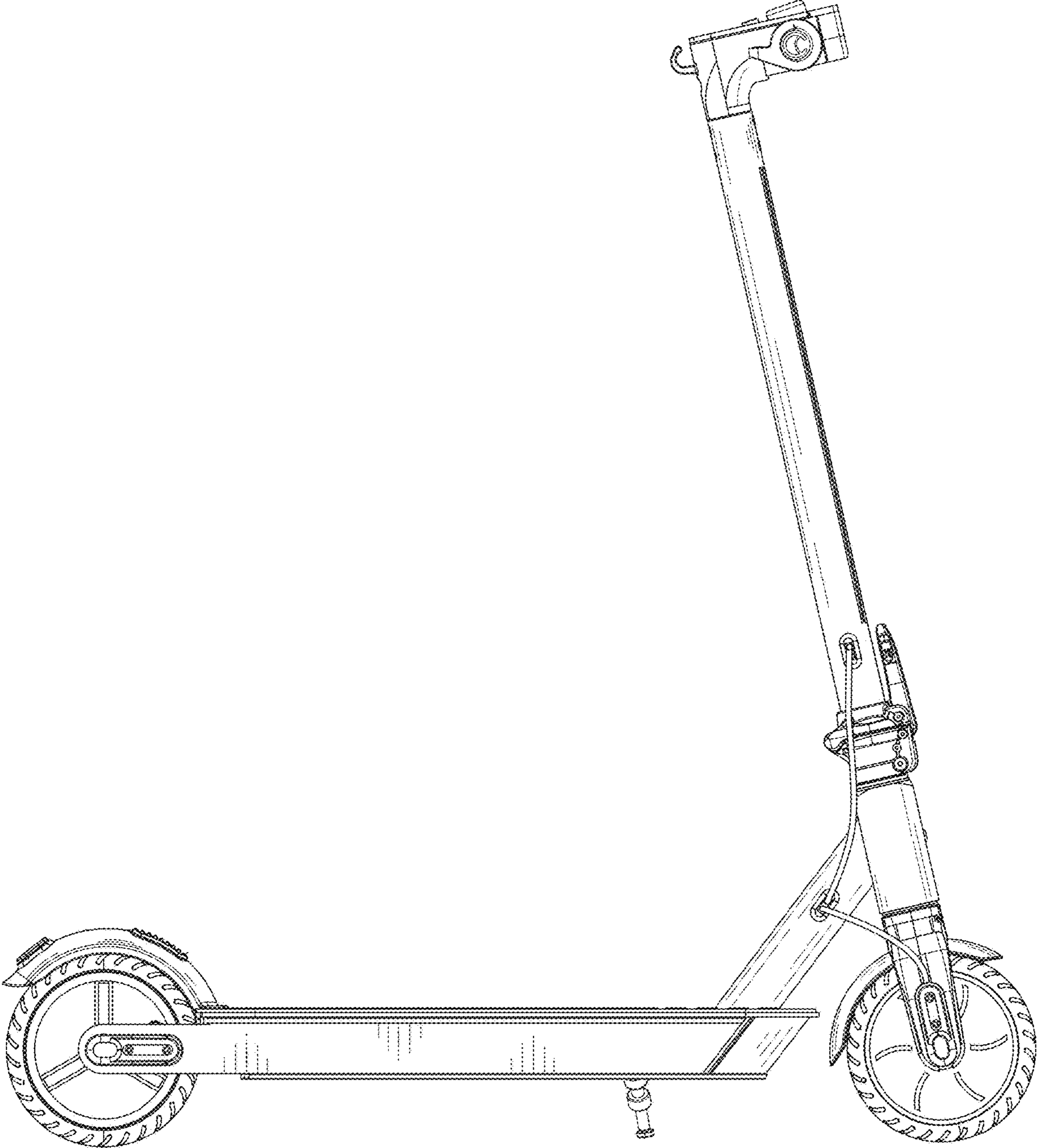

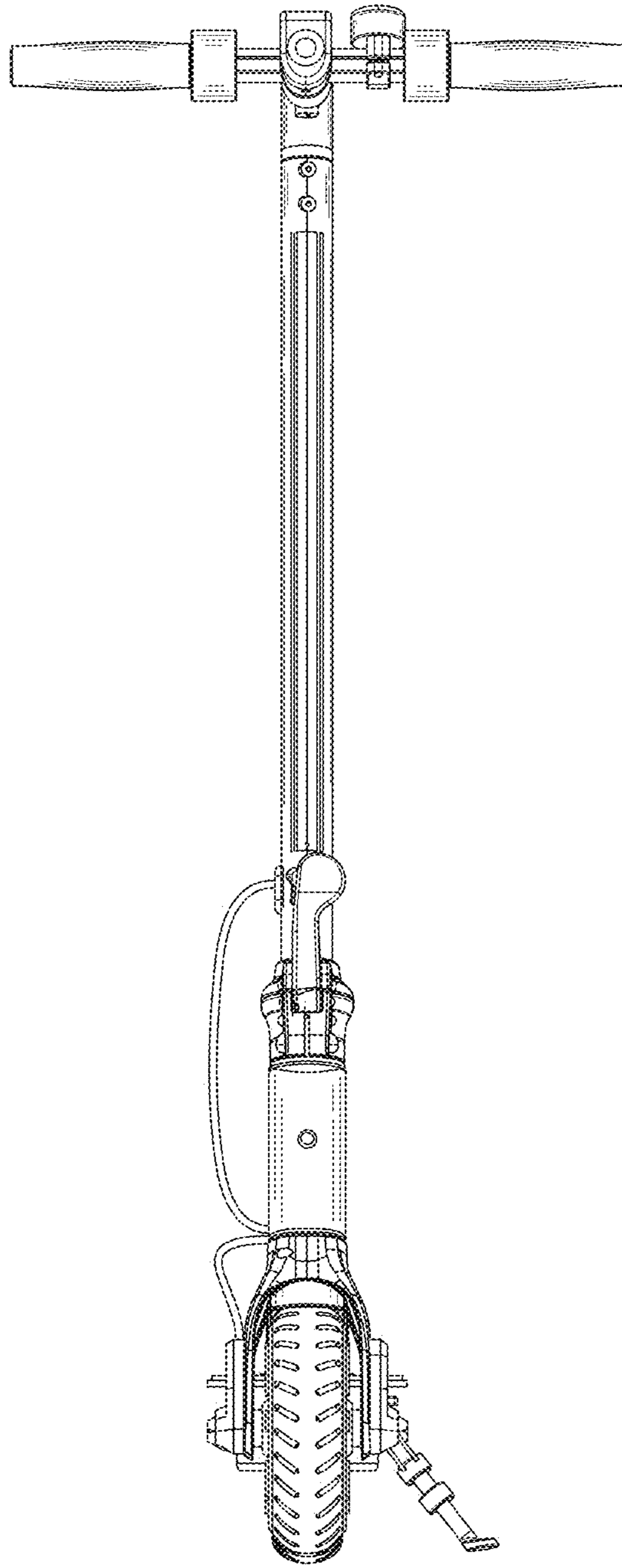

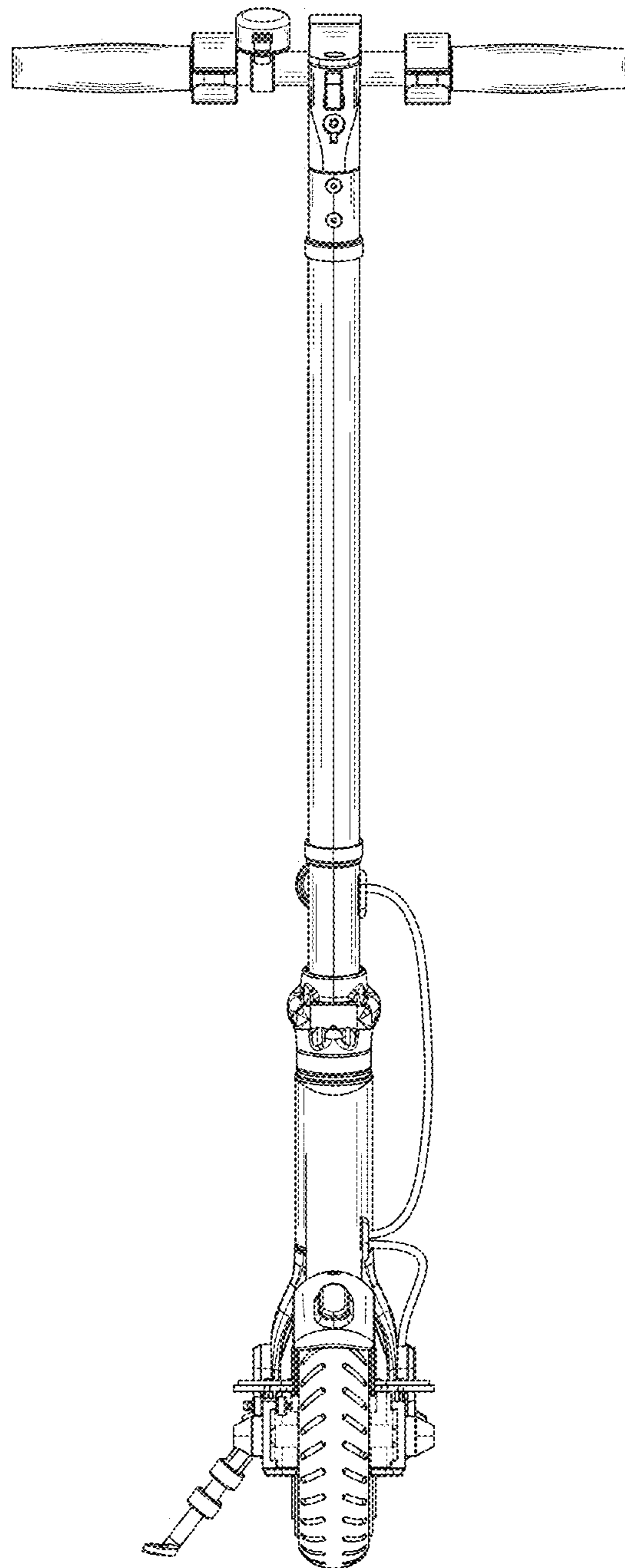

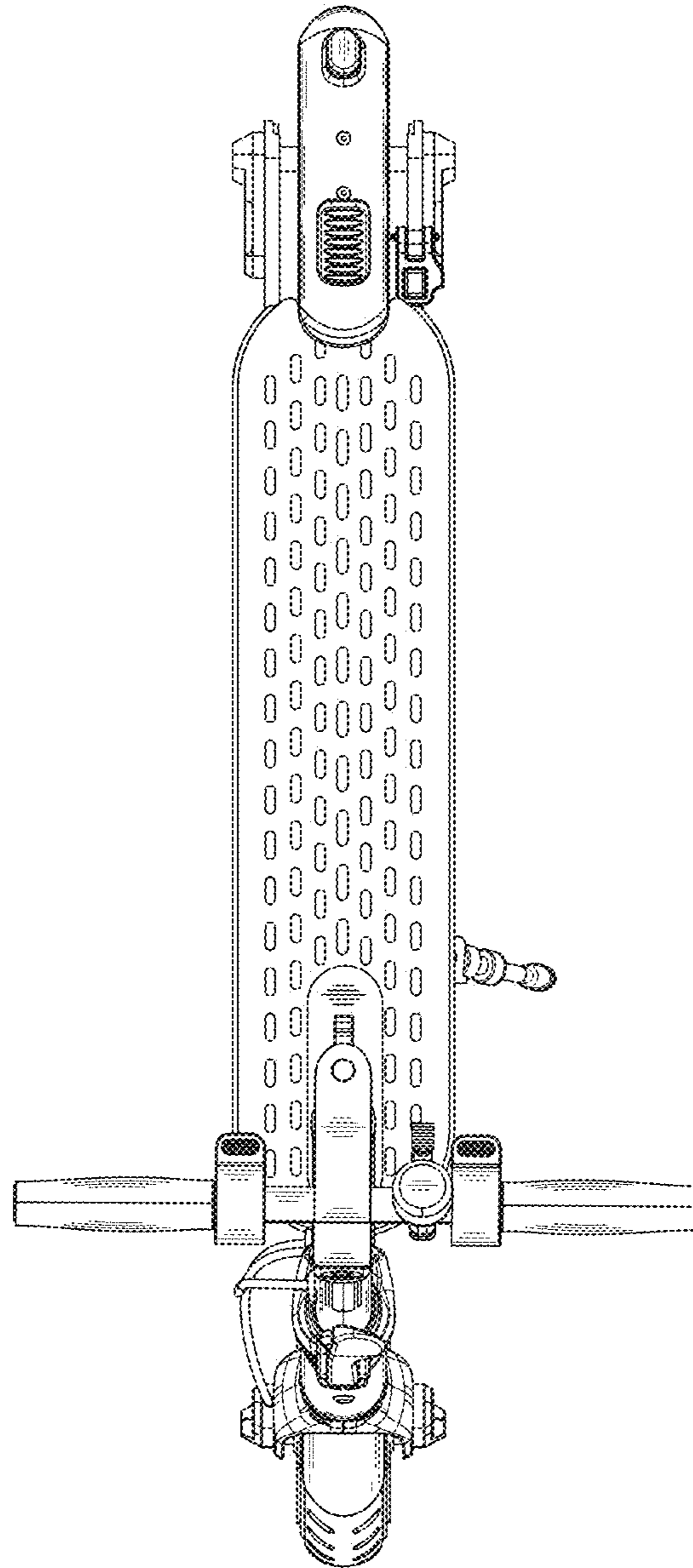

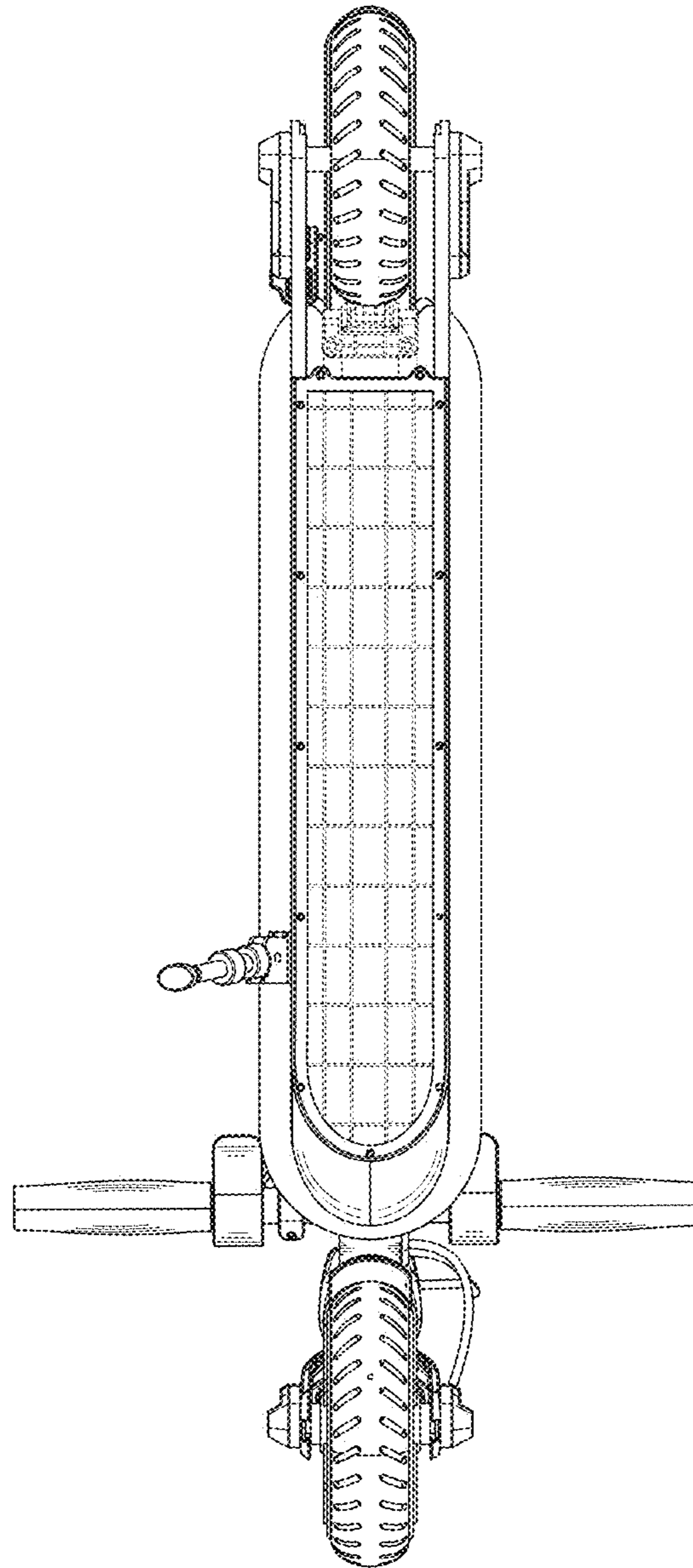

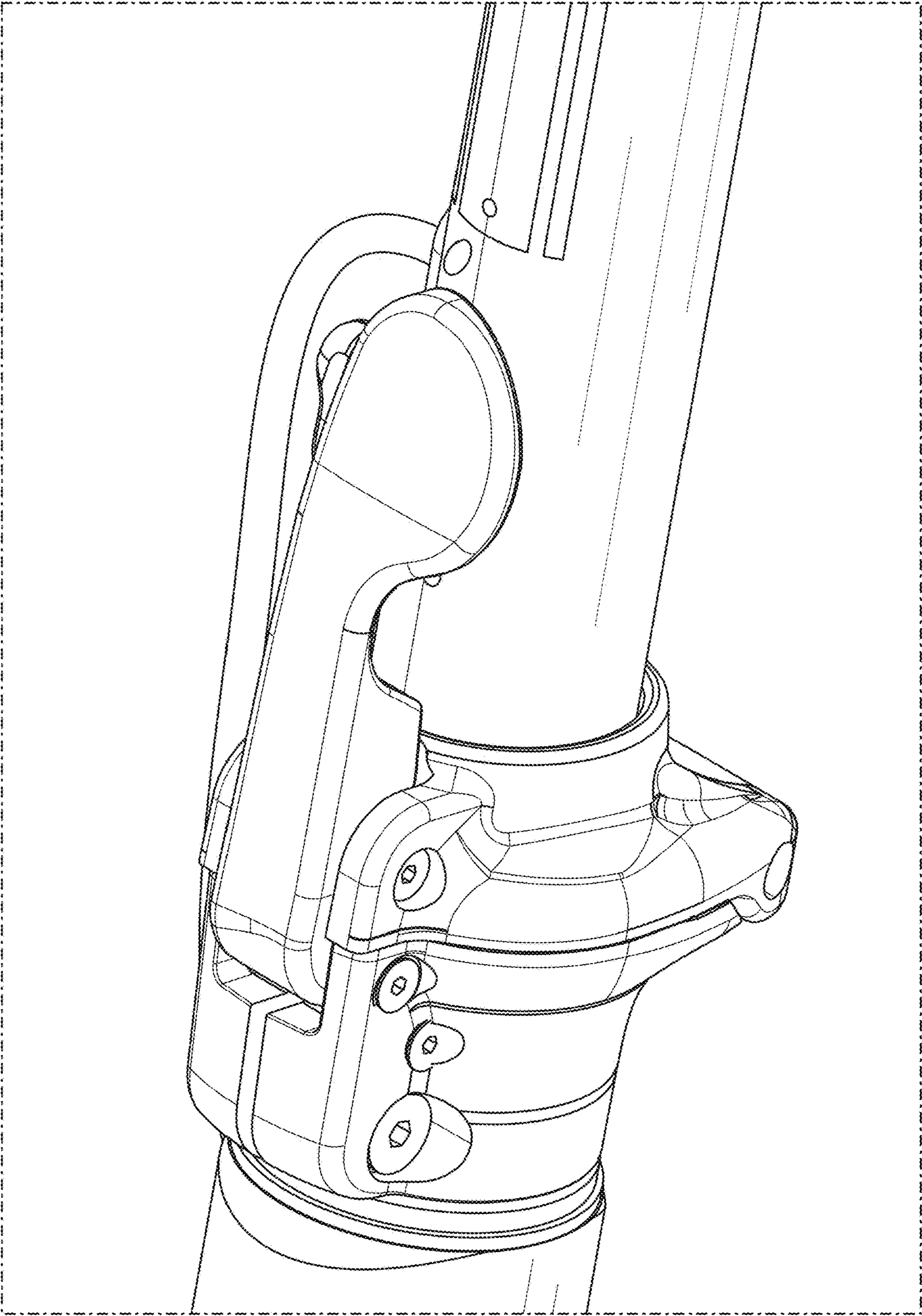
