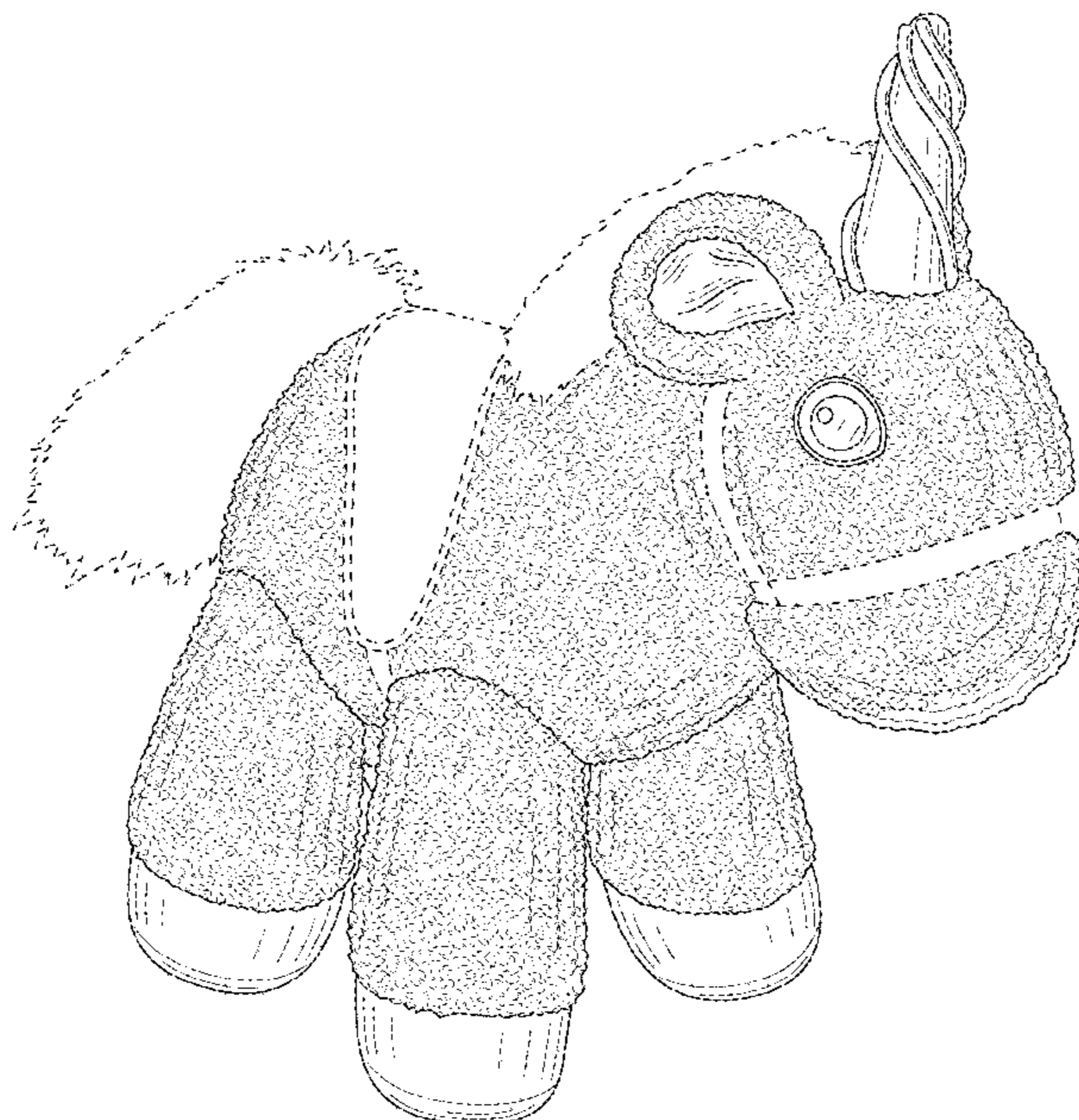

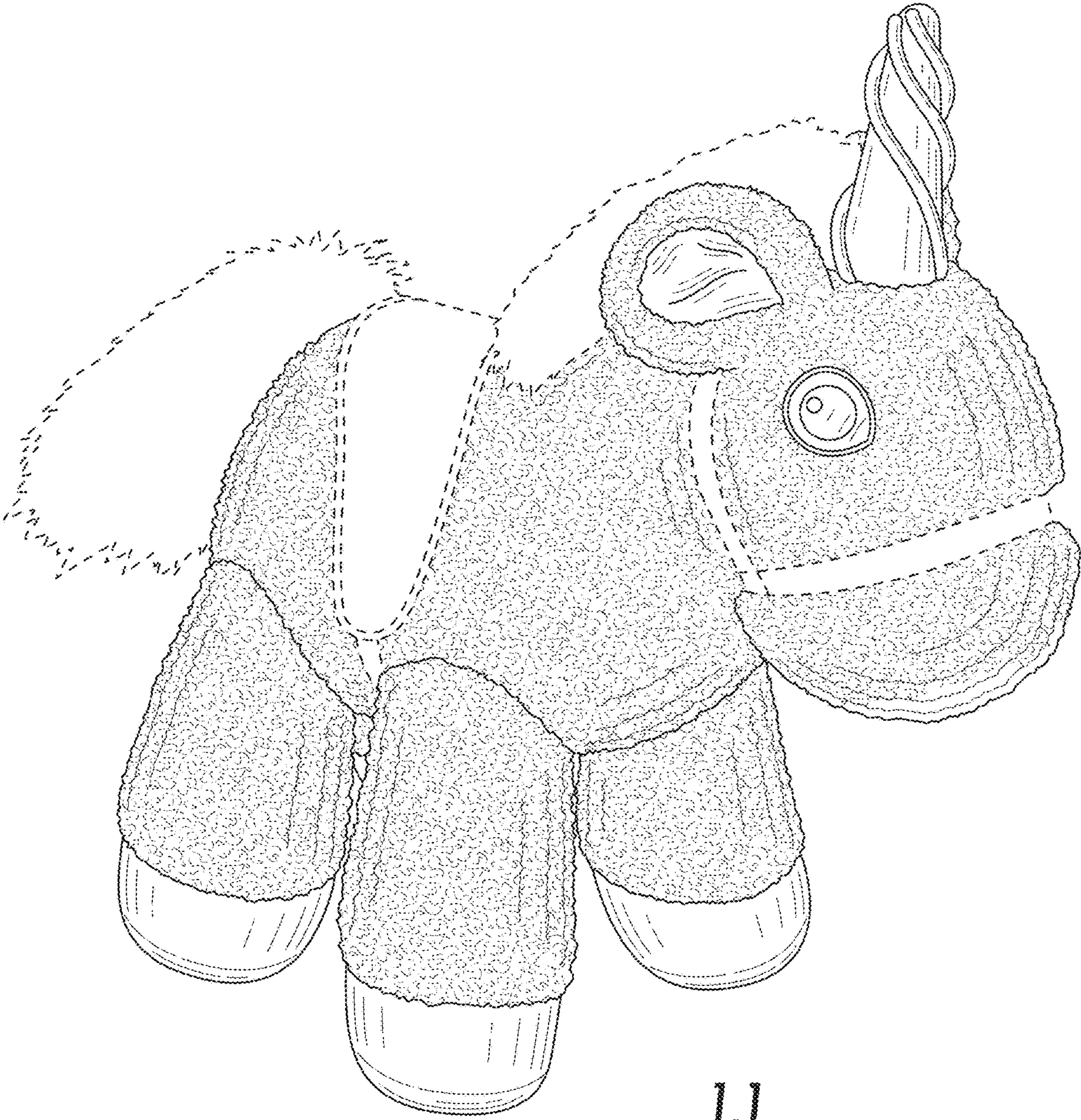

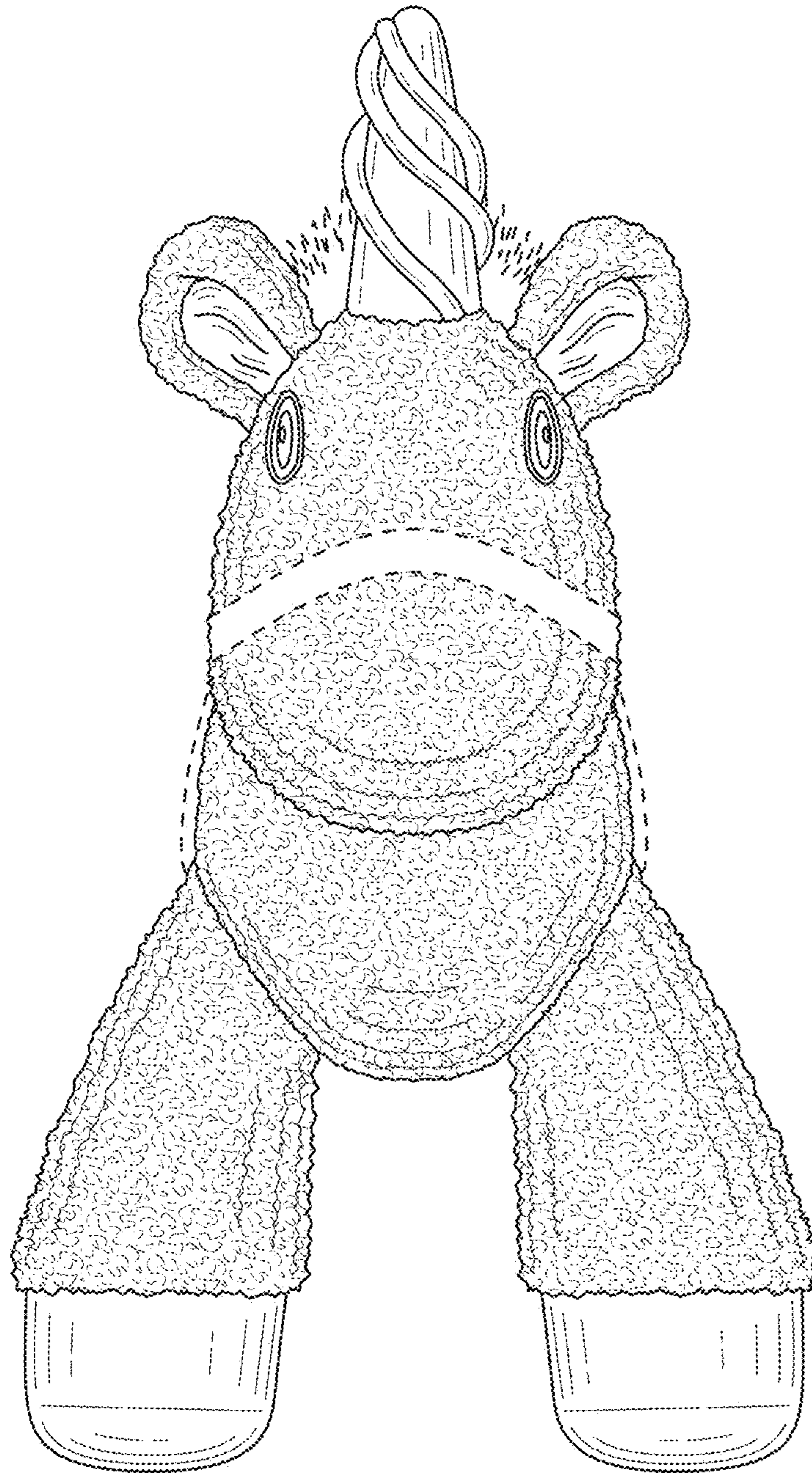

The broken line disclosures in the views represent portions of the plush unicorn toy which form no part of the claimed design.

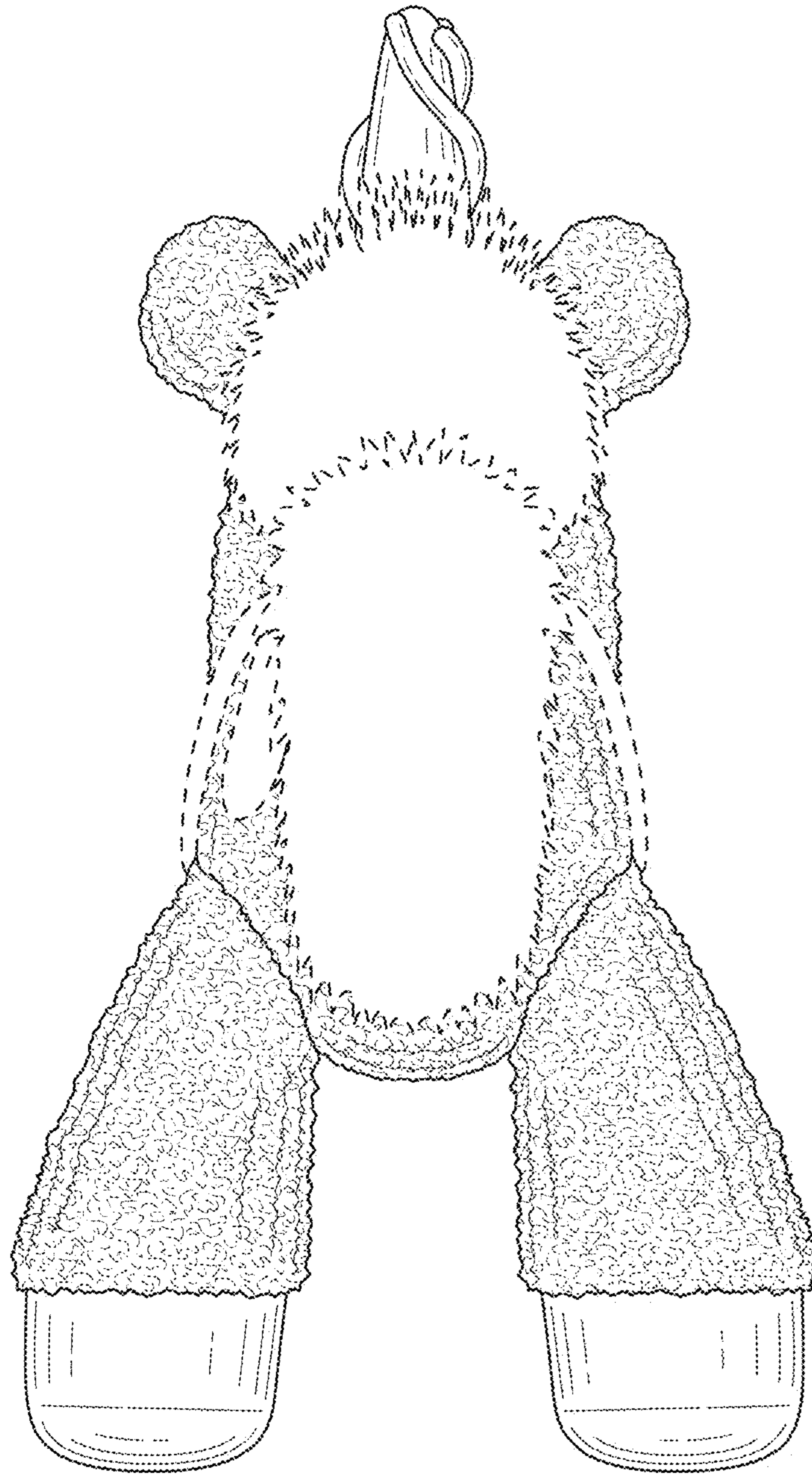

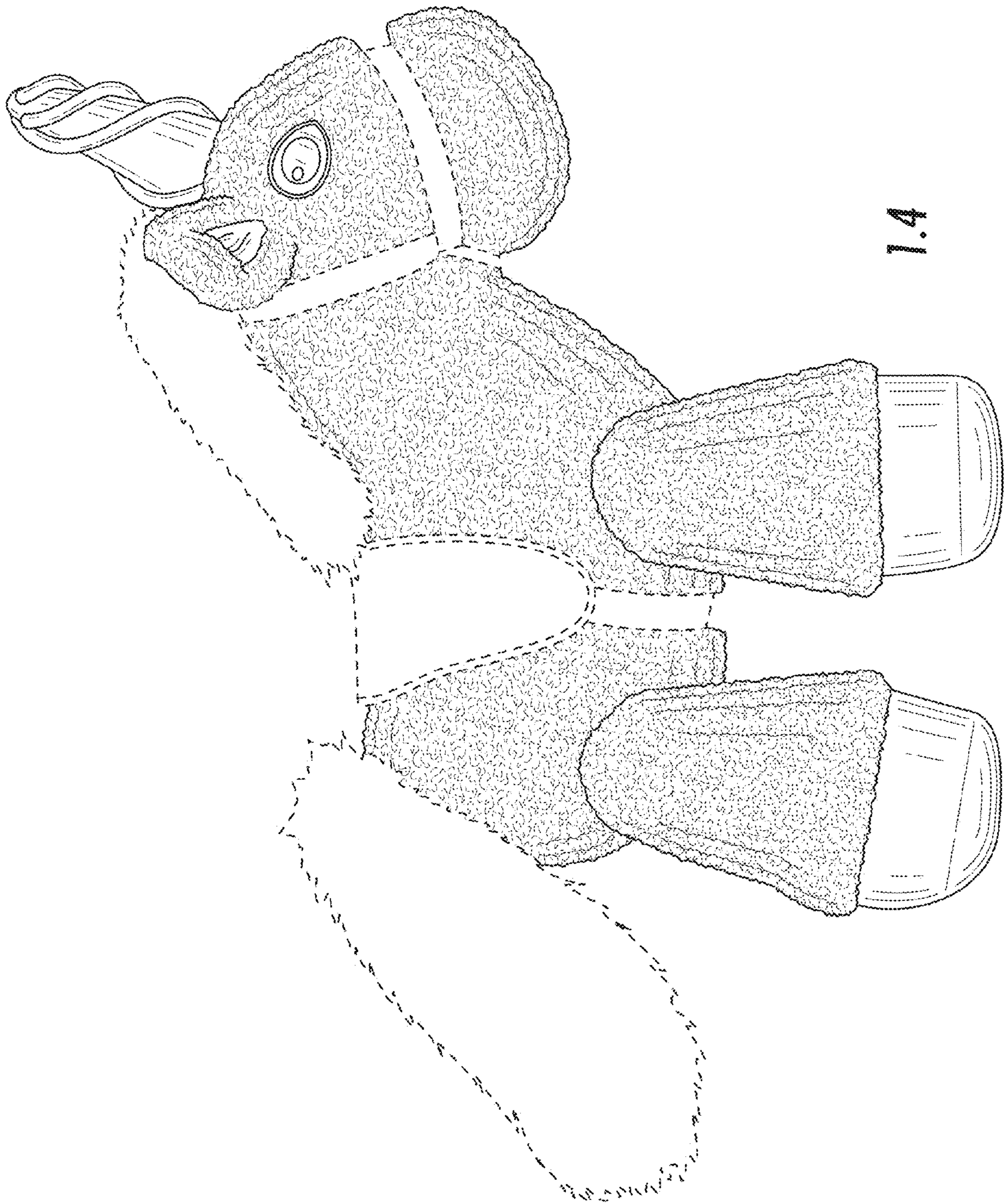


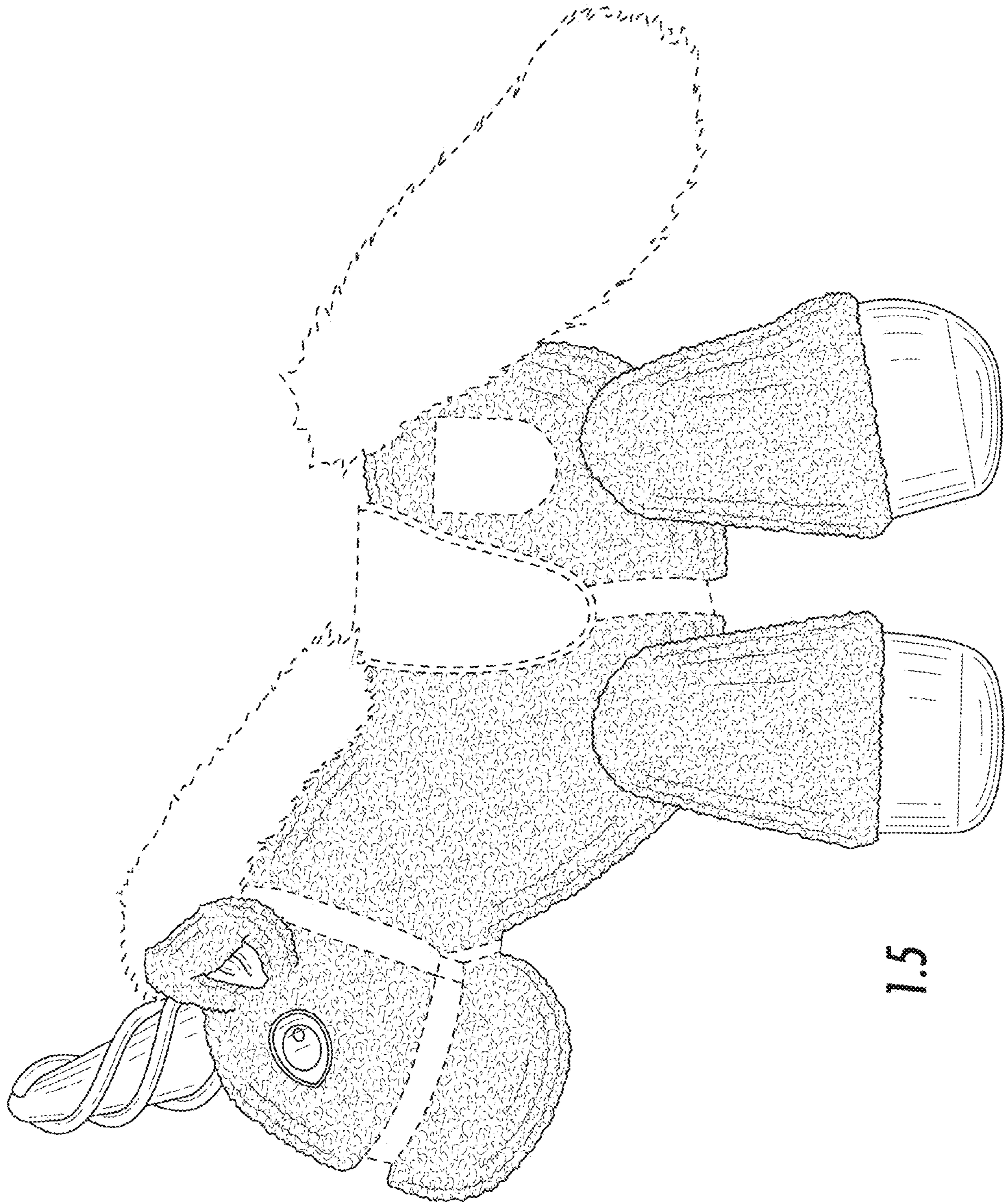

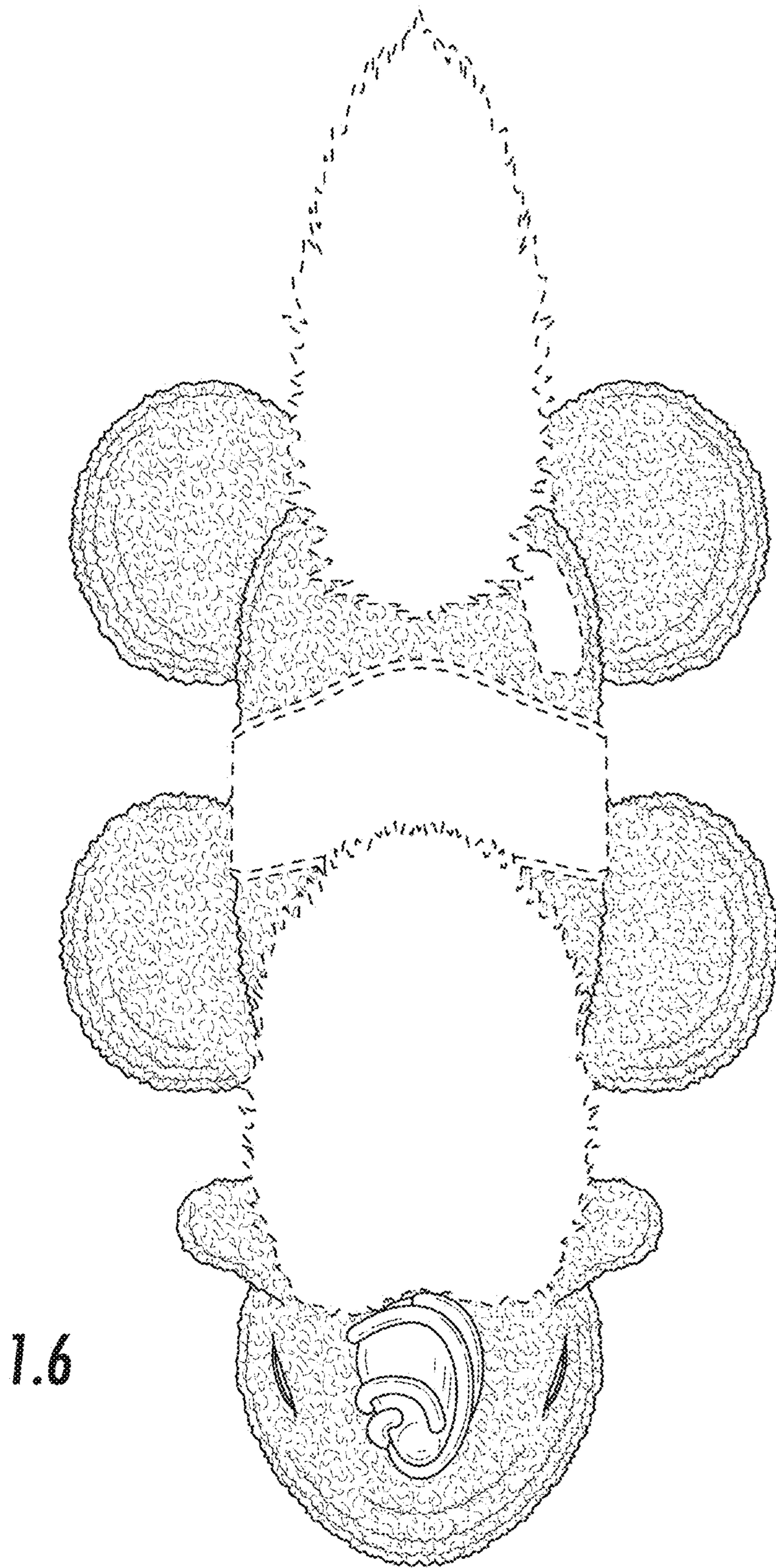


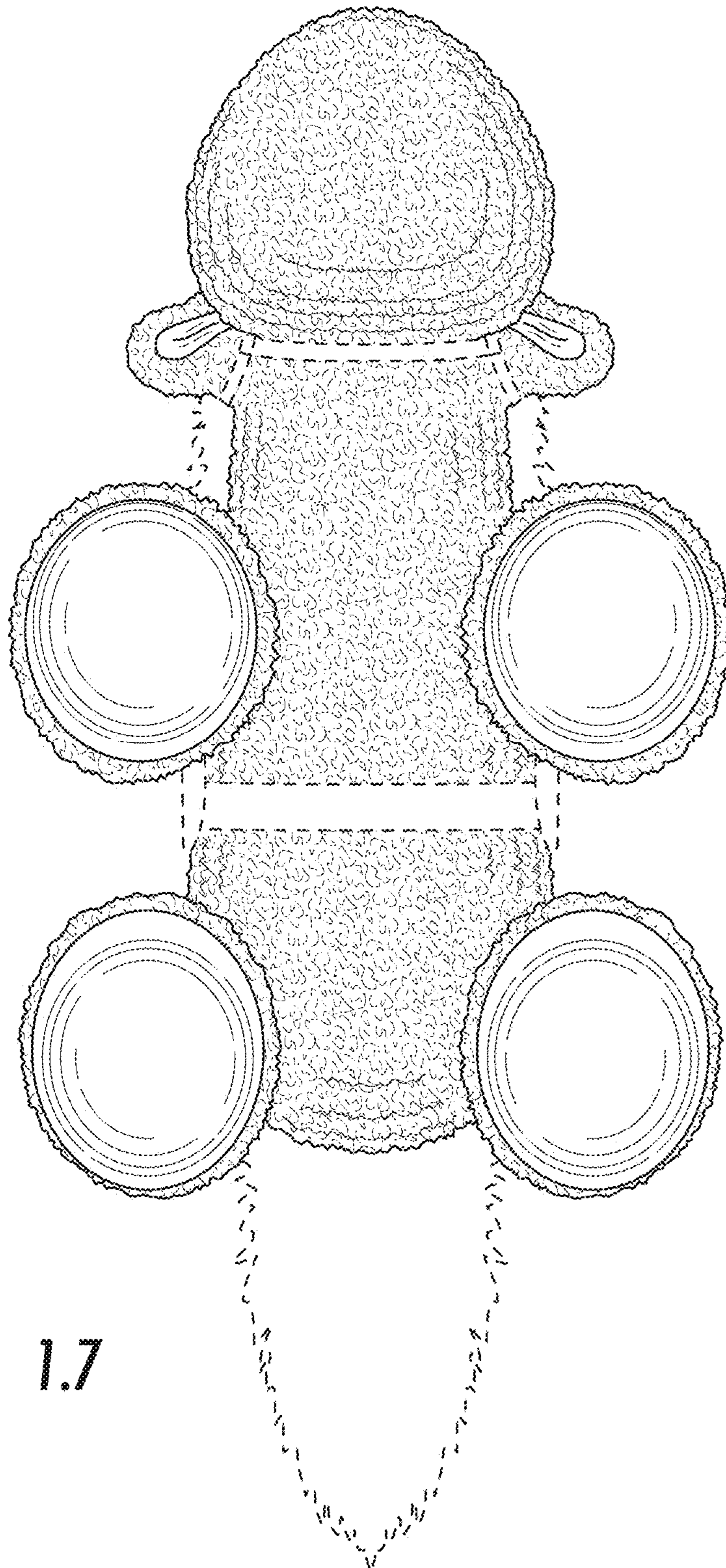
