FIG. 7 is a bottom view of the vehicle-used refrigeration unit housing.

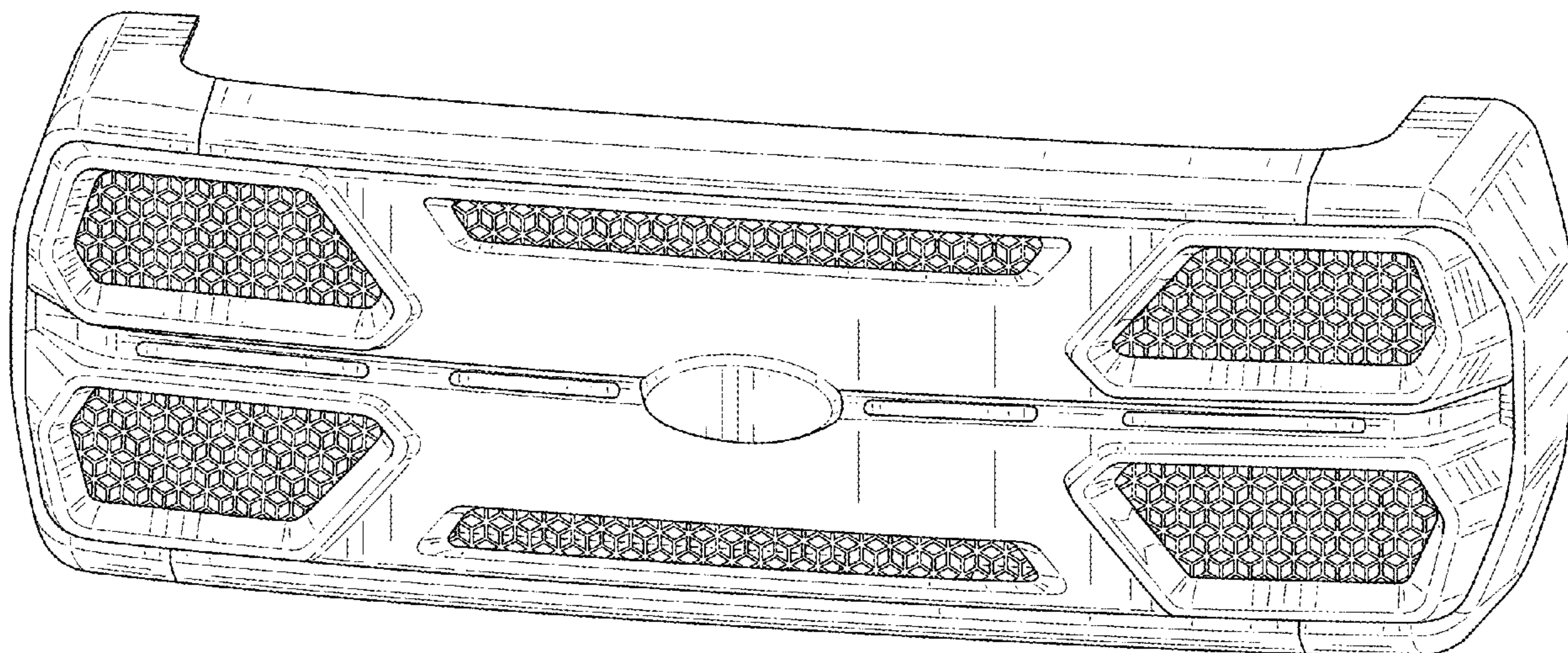

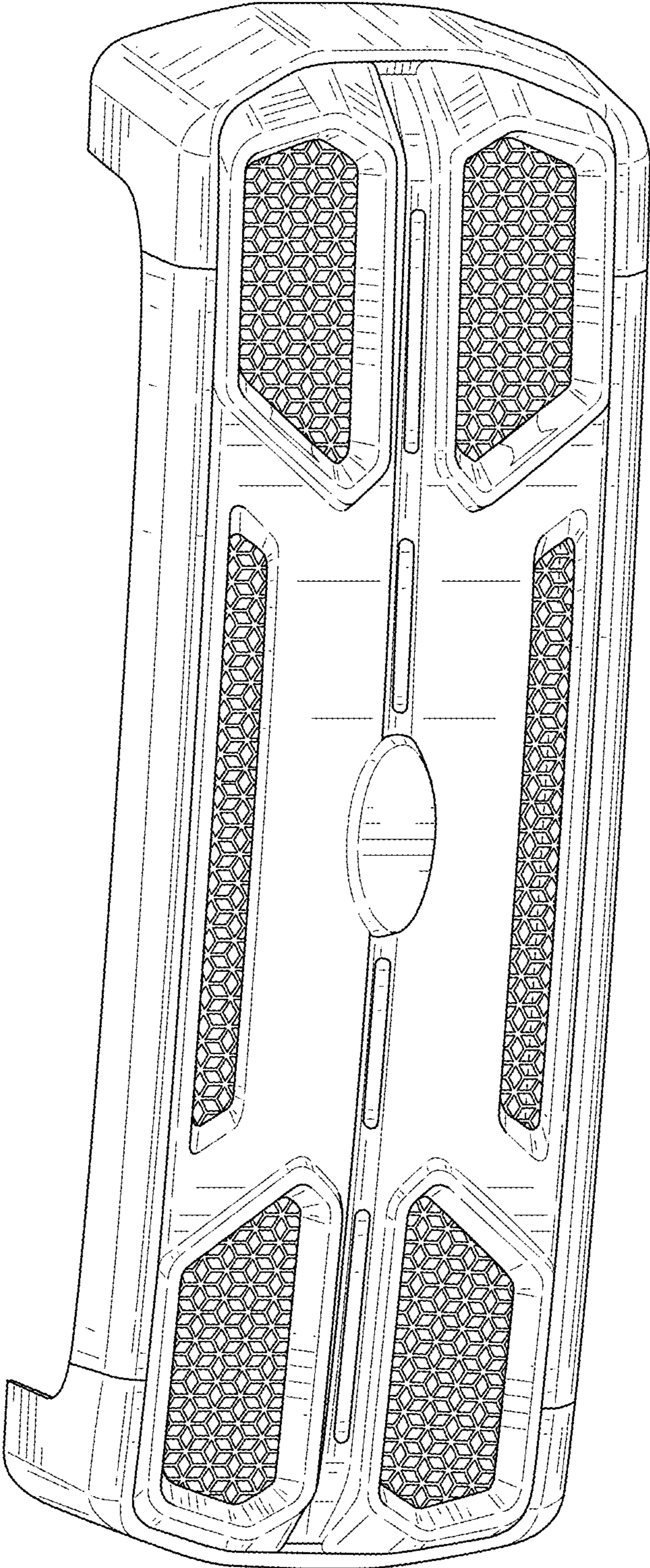

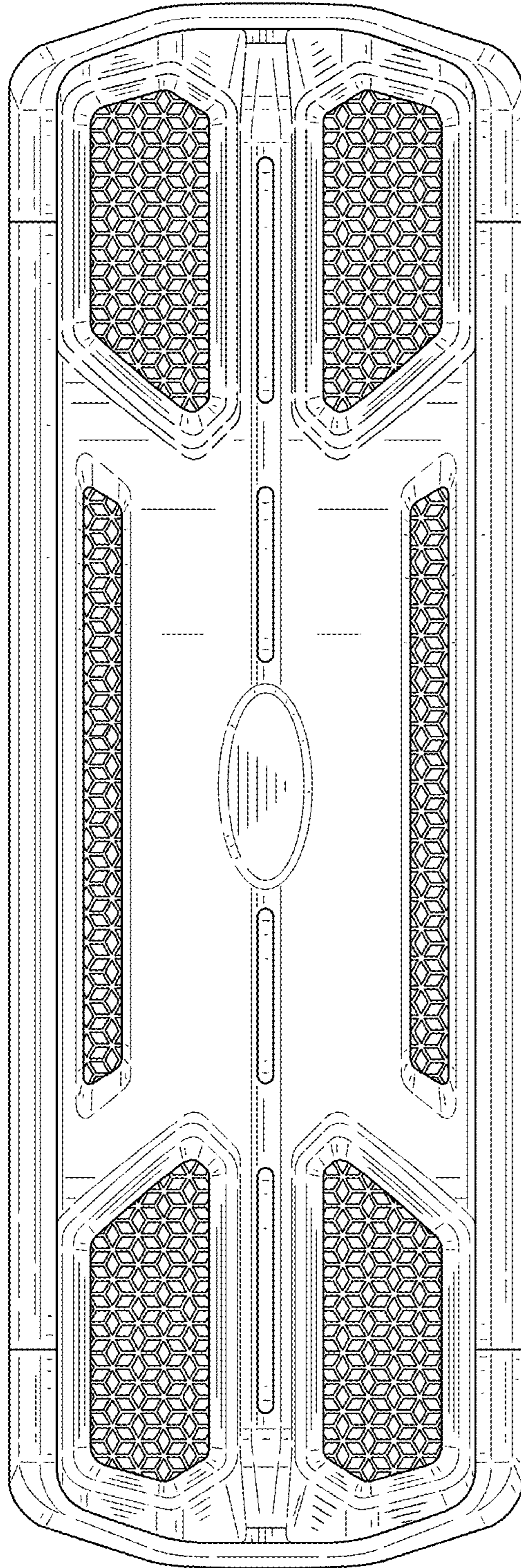

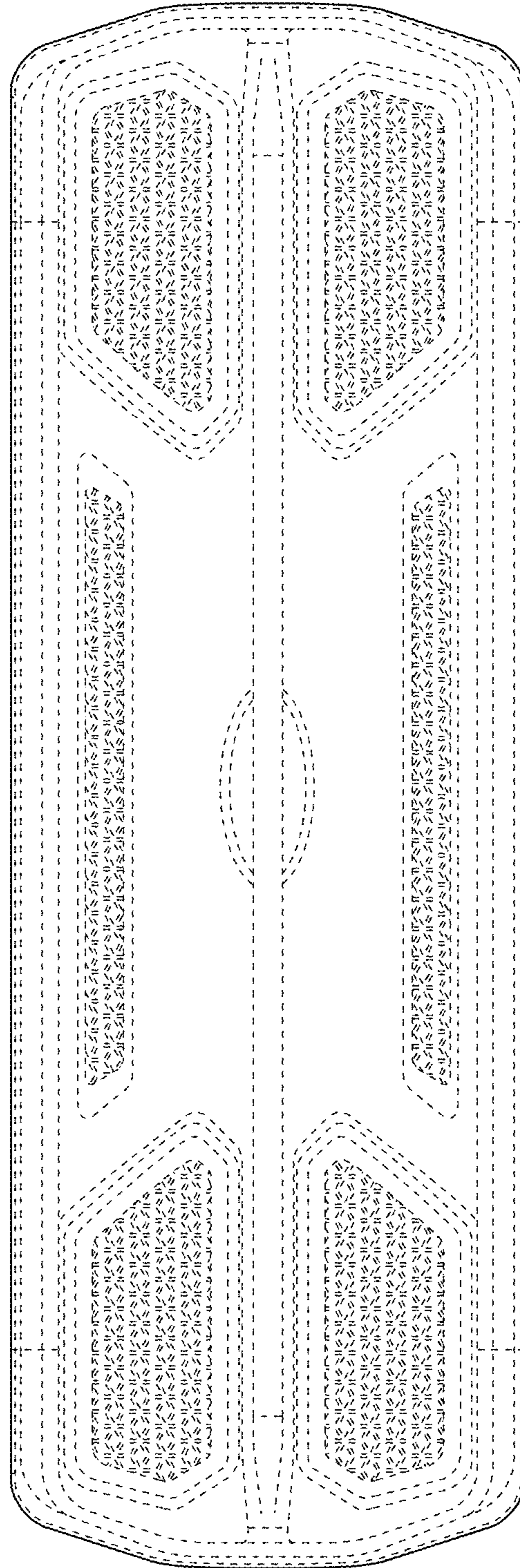

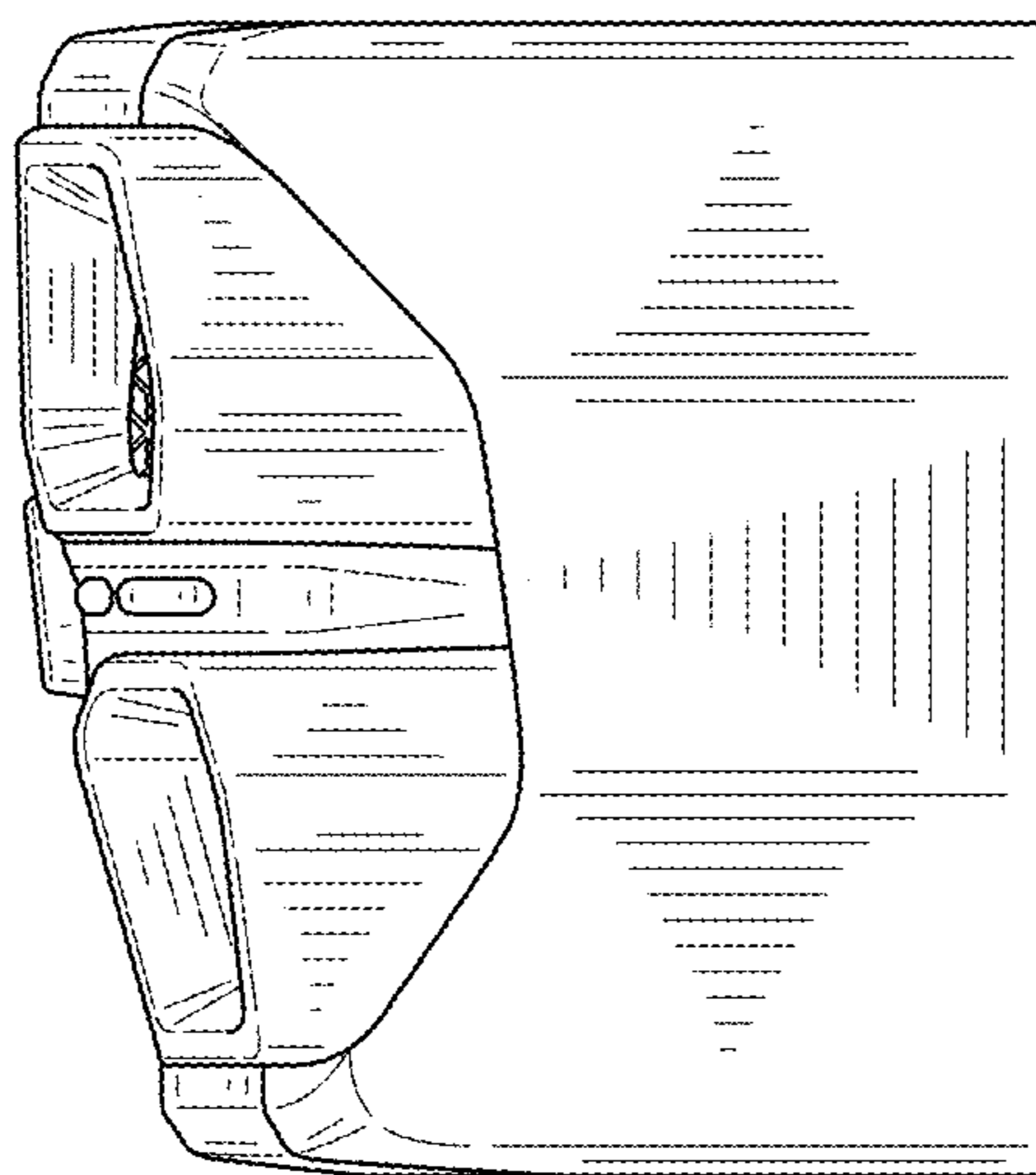

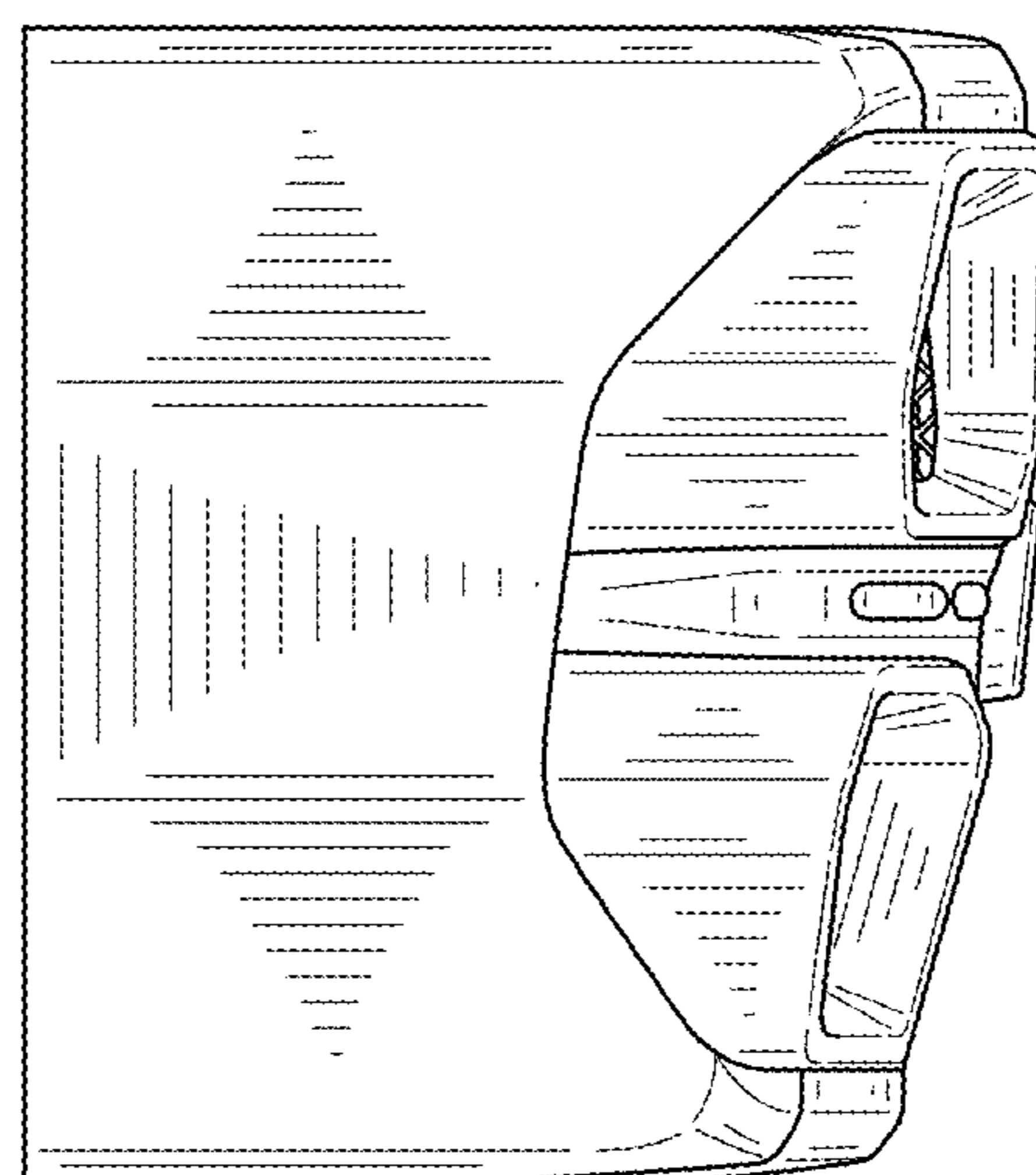

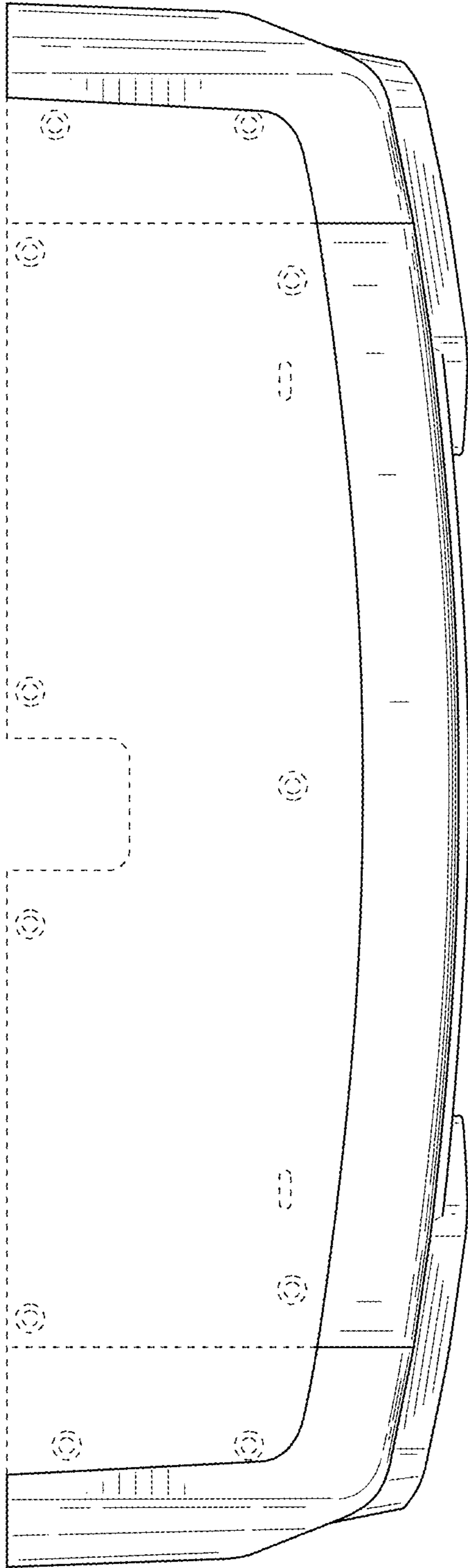

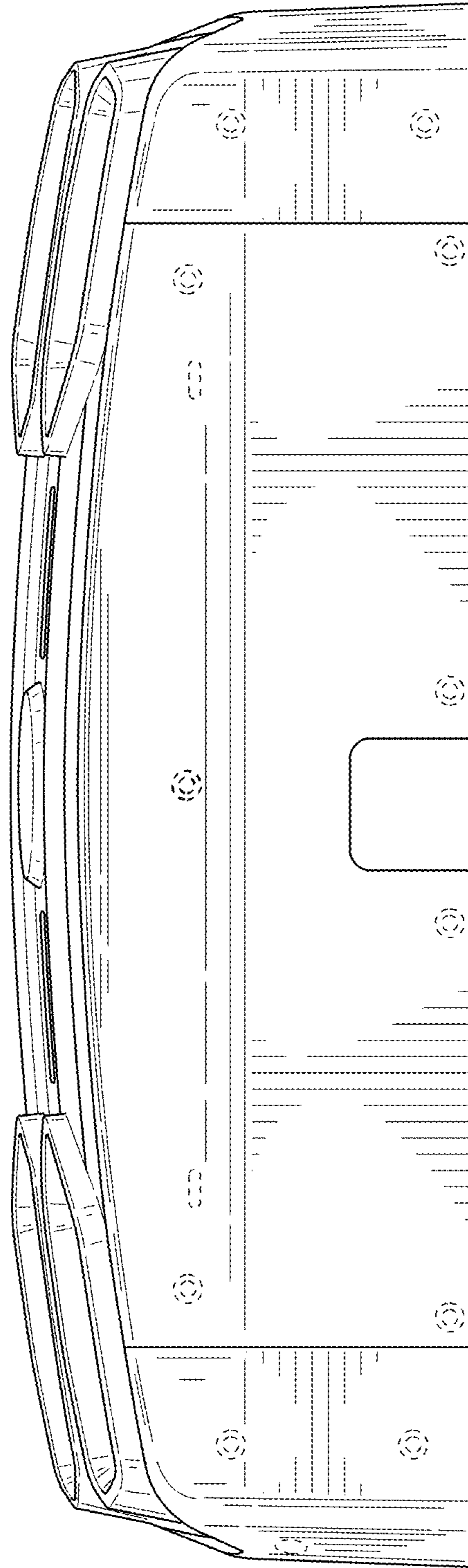
