The ornamental design for handle for swab, as shown and described.

DESCRIPTION

FIG. 1 is a line-drawing perspective-view of a handle for a swab, showing my new design from a first perspective; FIG. 2 is a line-drawing perspective-view of the handle for the swab of FIG. 1, showing my new design from a second perspective;

FIG. 3 is a line-drawing plan-view of the handle for the swab of FIG. 1, showing my new design from the top;

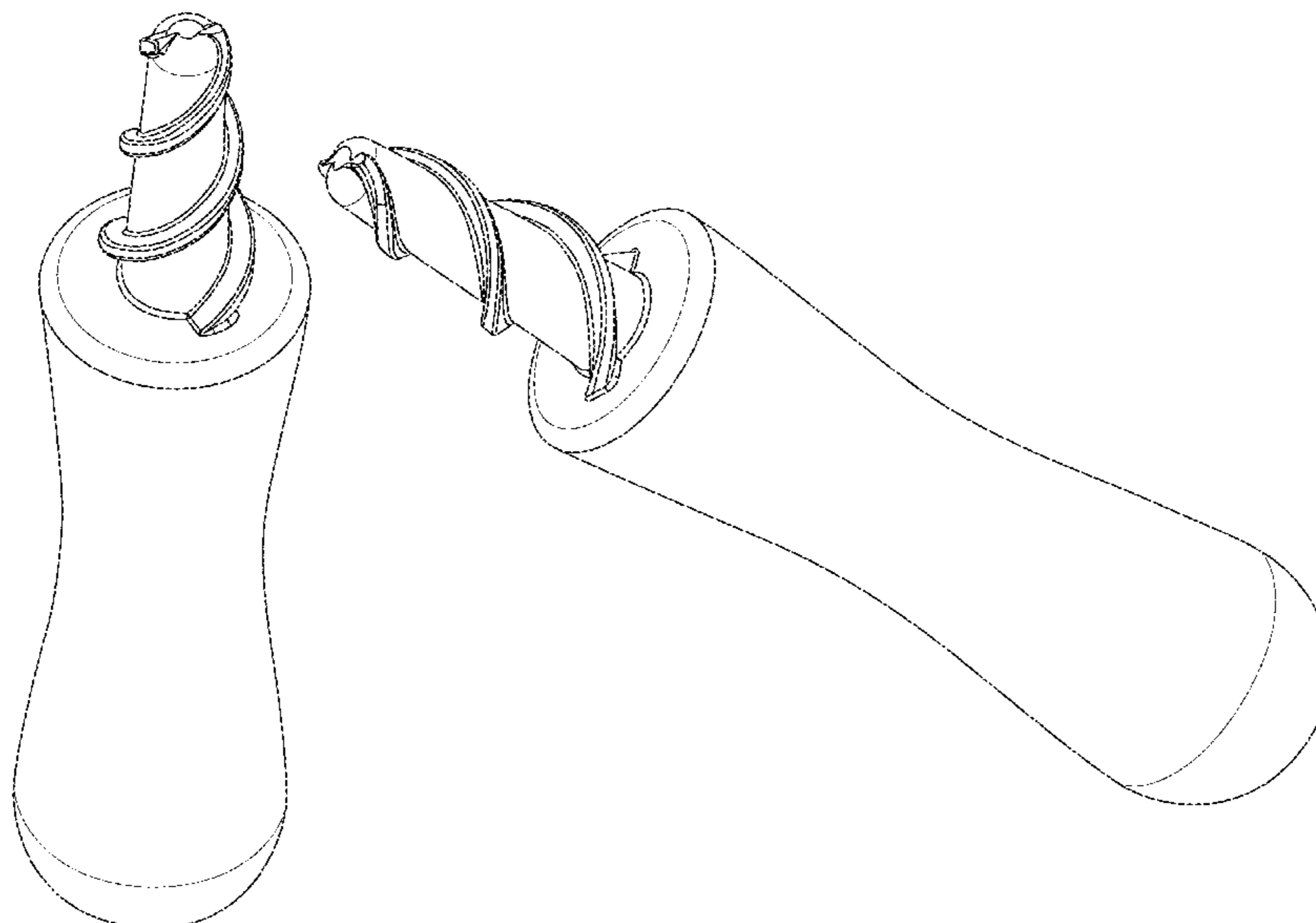
FIG. 4 is a line-drawing plan-view of the handle for the swab of FIG. 1, showing my new design from the bottom;

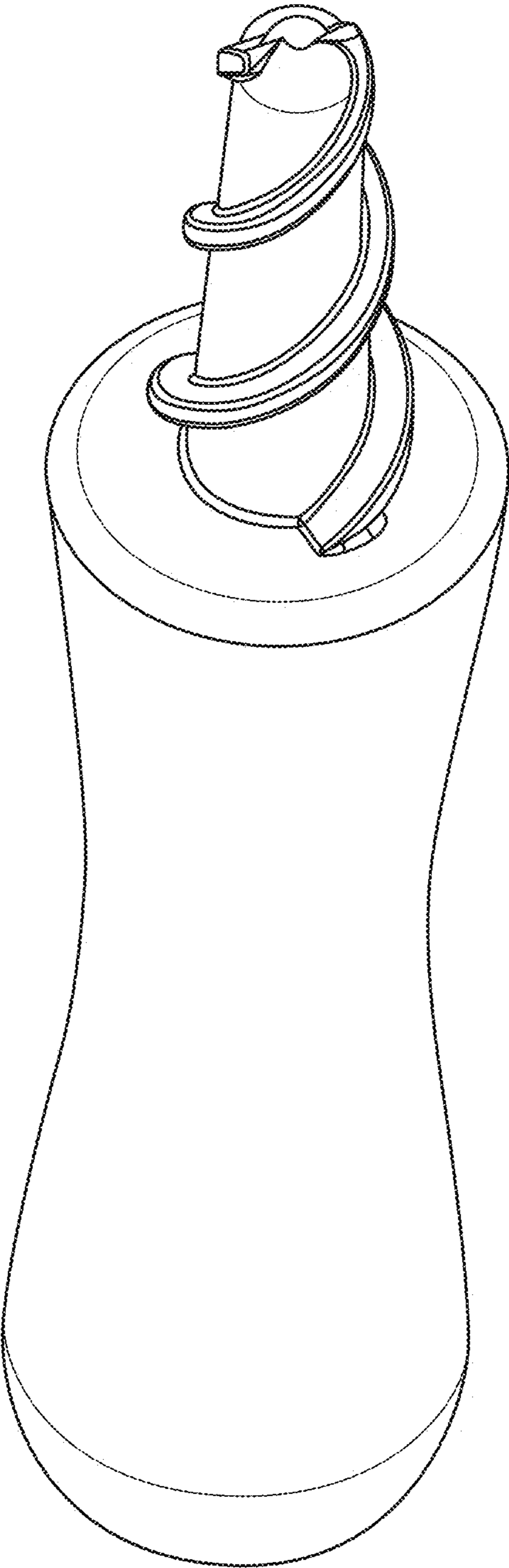

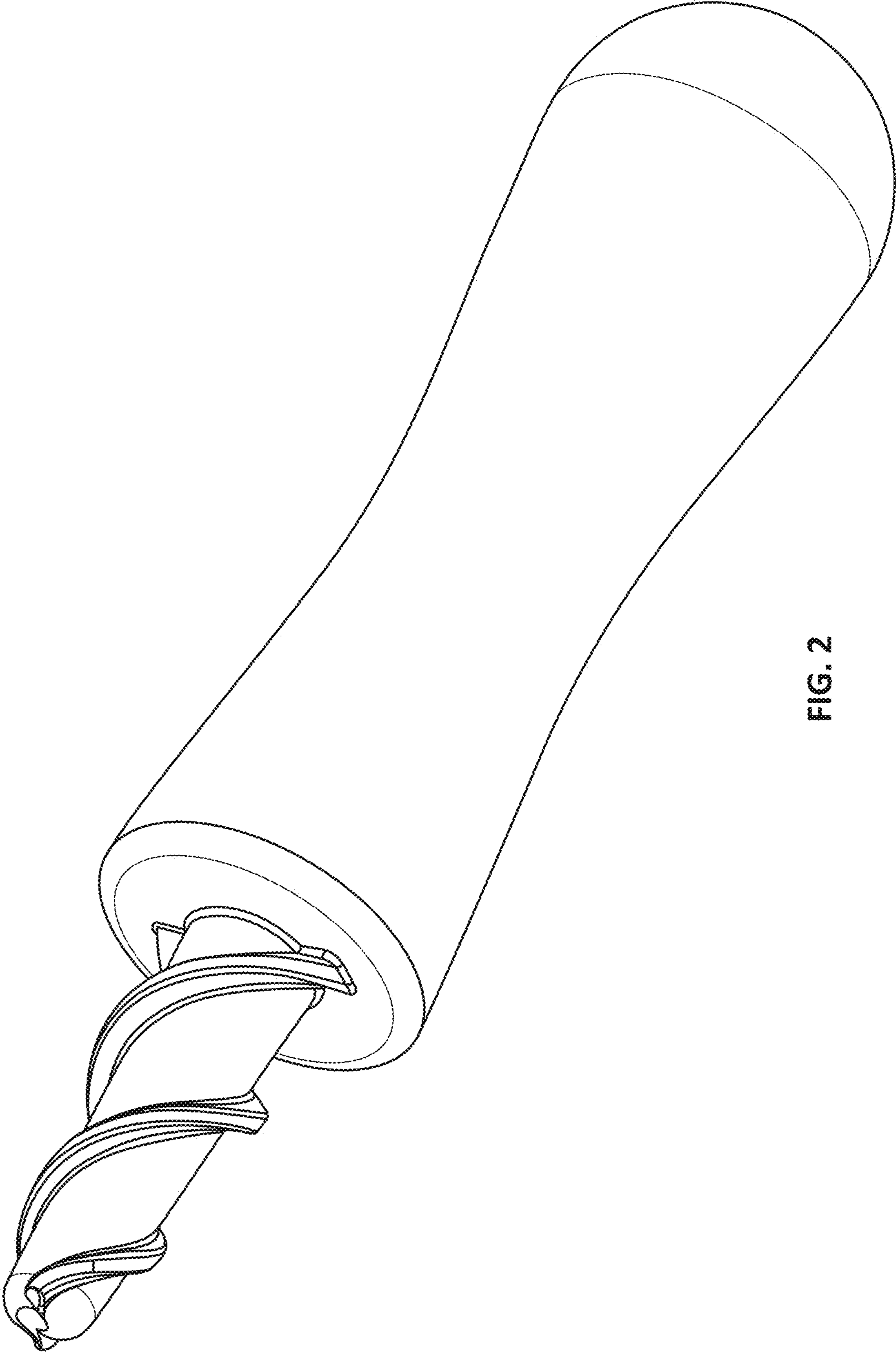

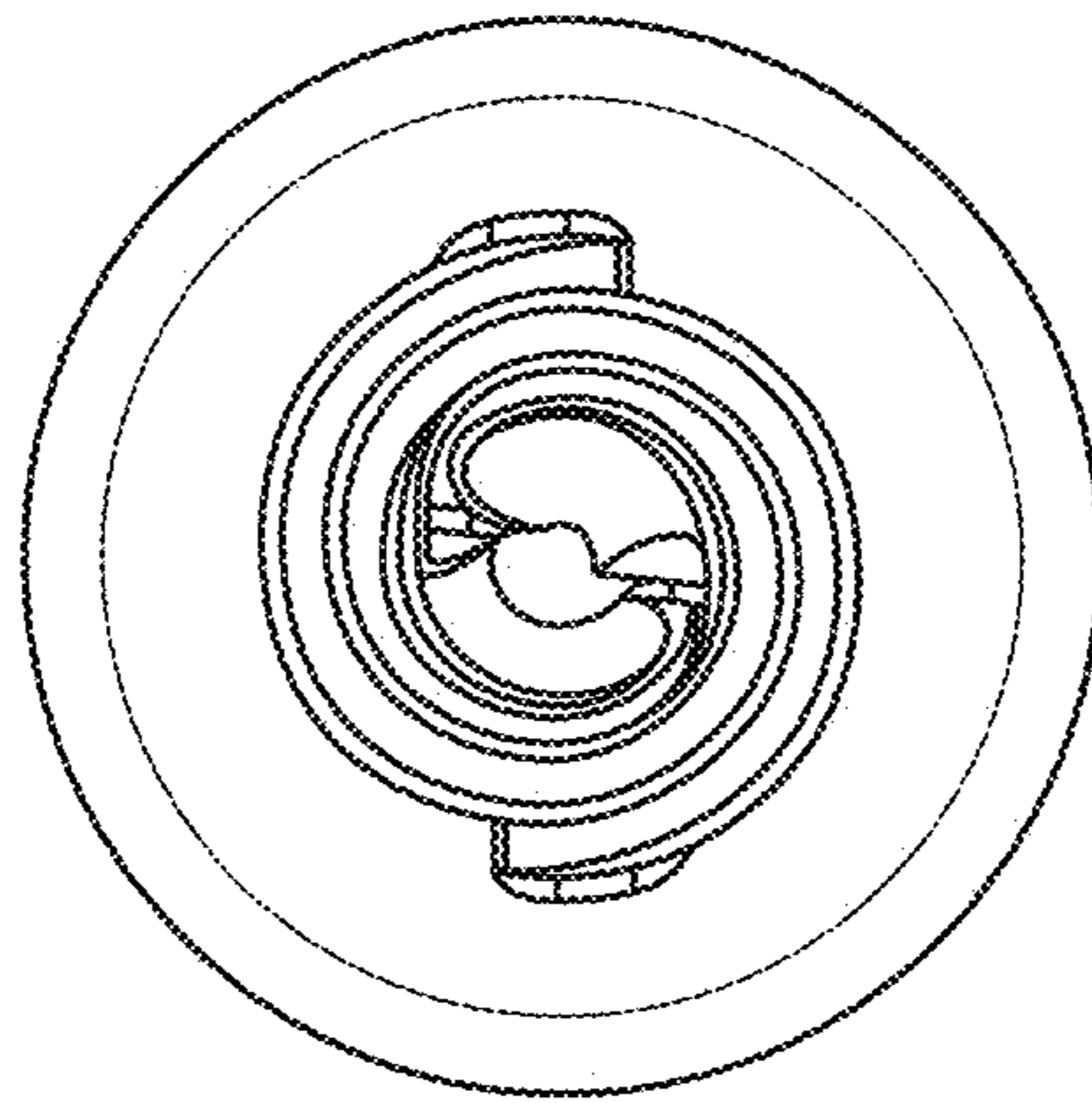

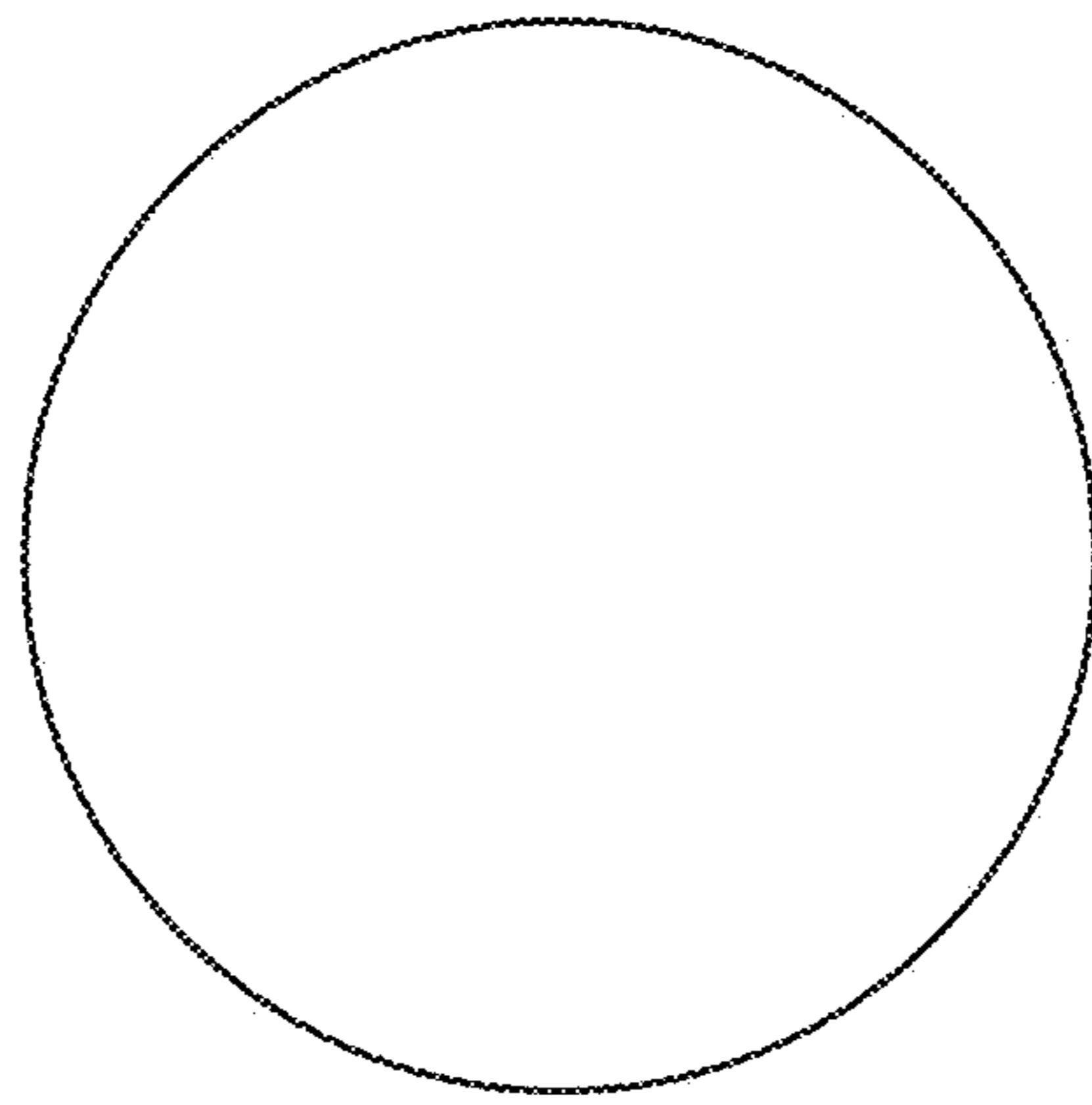

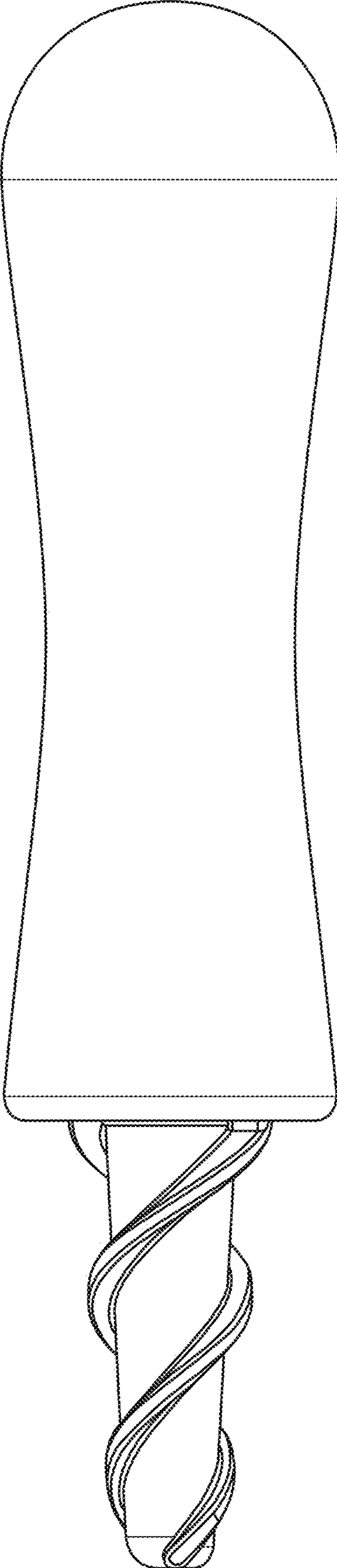

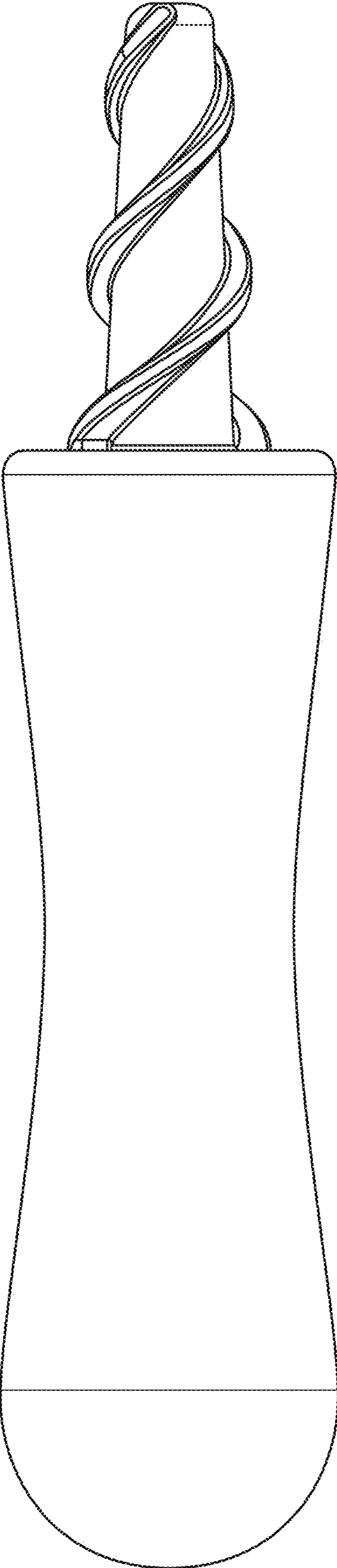
