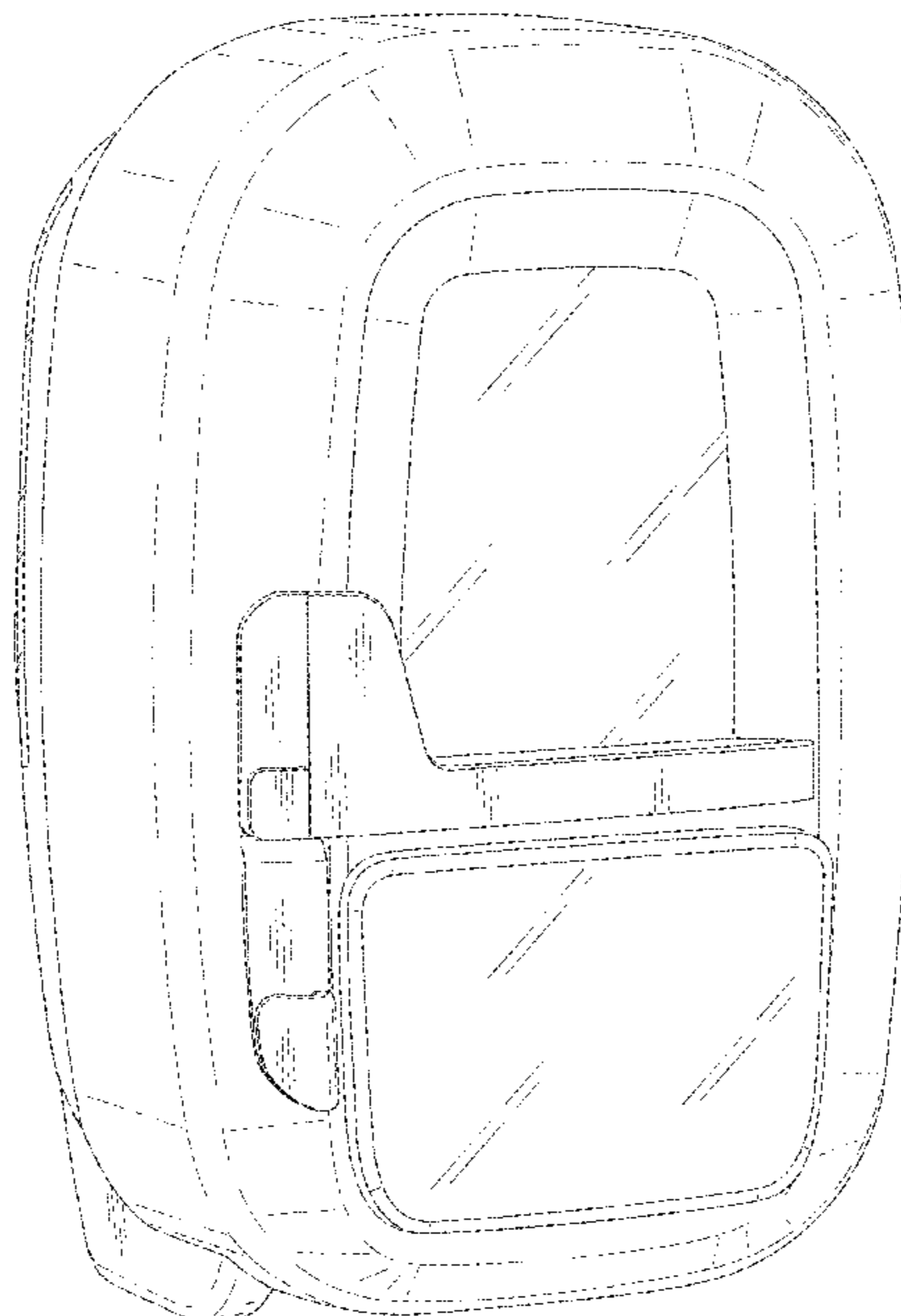
(57) **CLAIM**

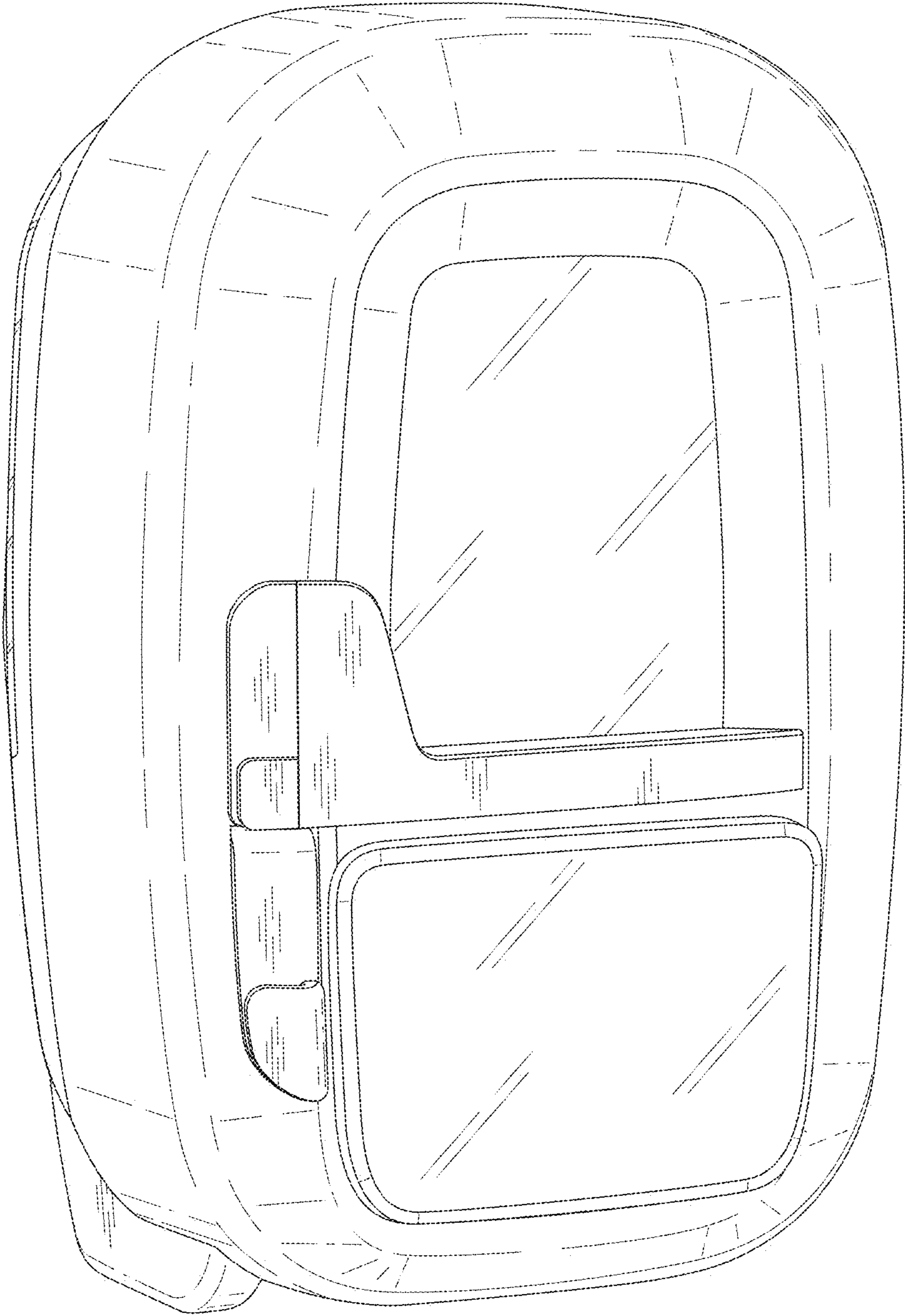
The ornamental design for a hemodialysis device, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a hemodialysis device of our design;

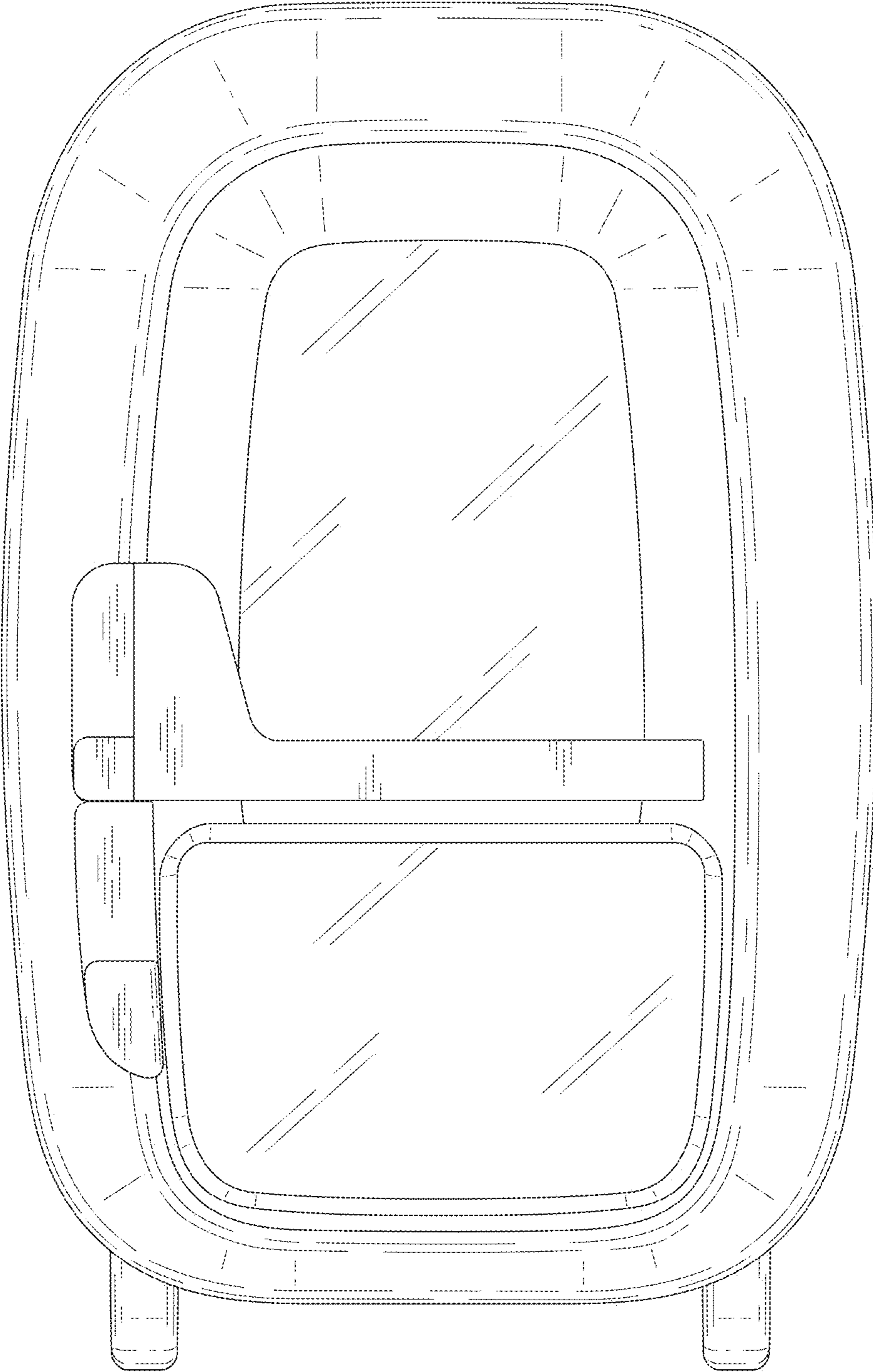




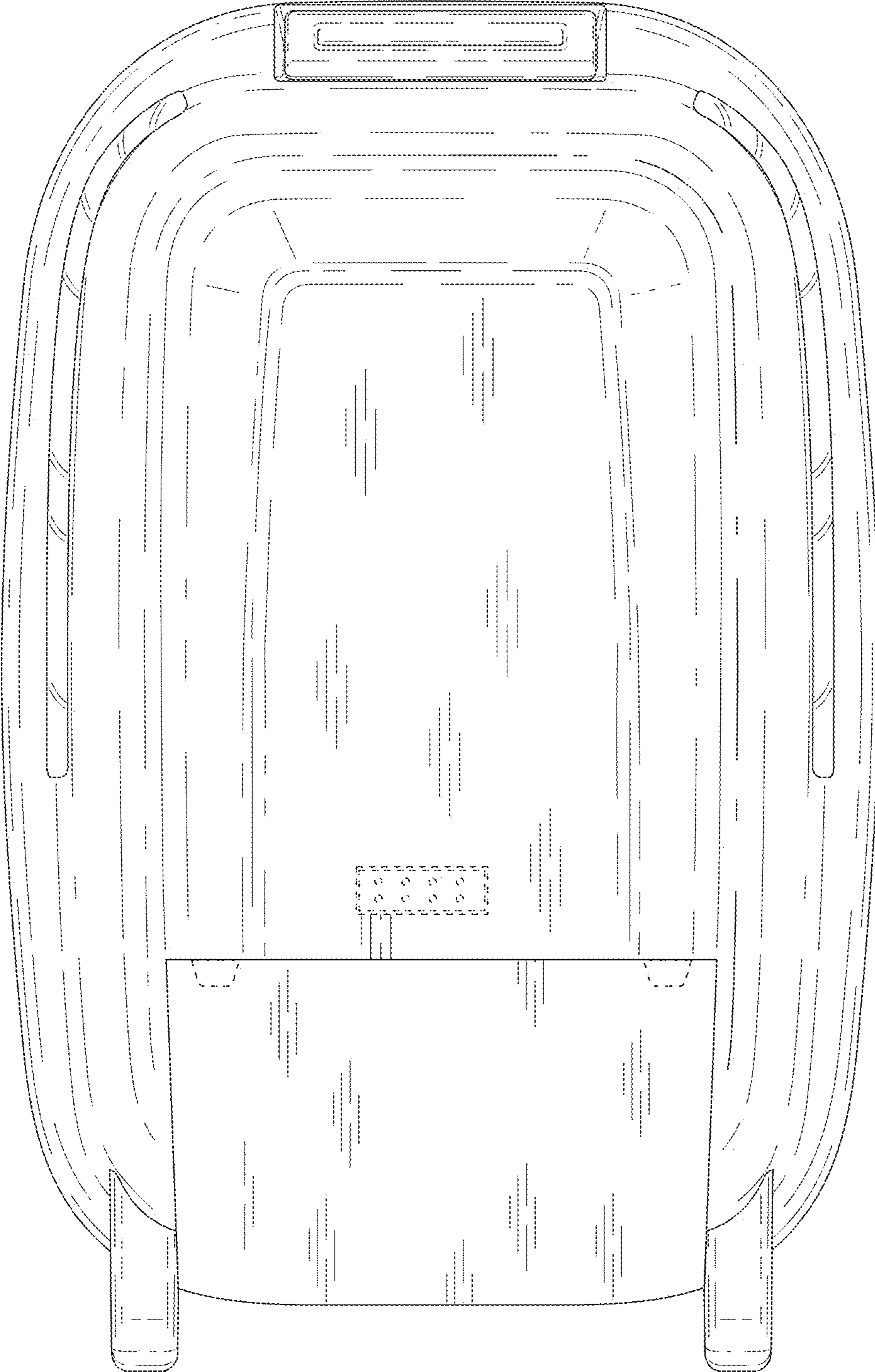

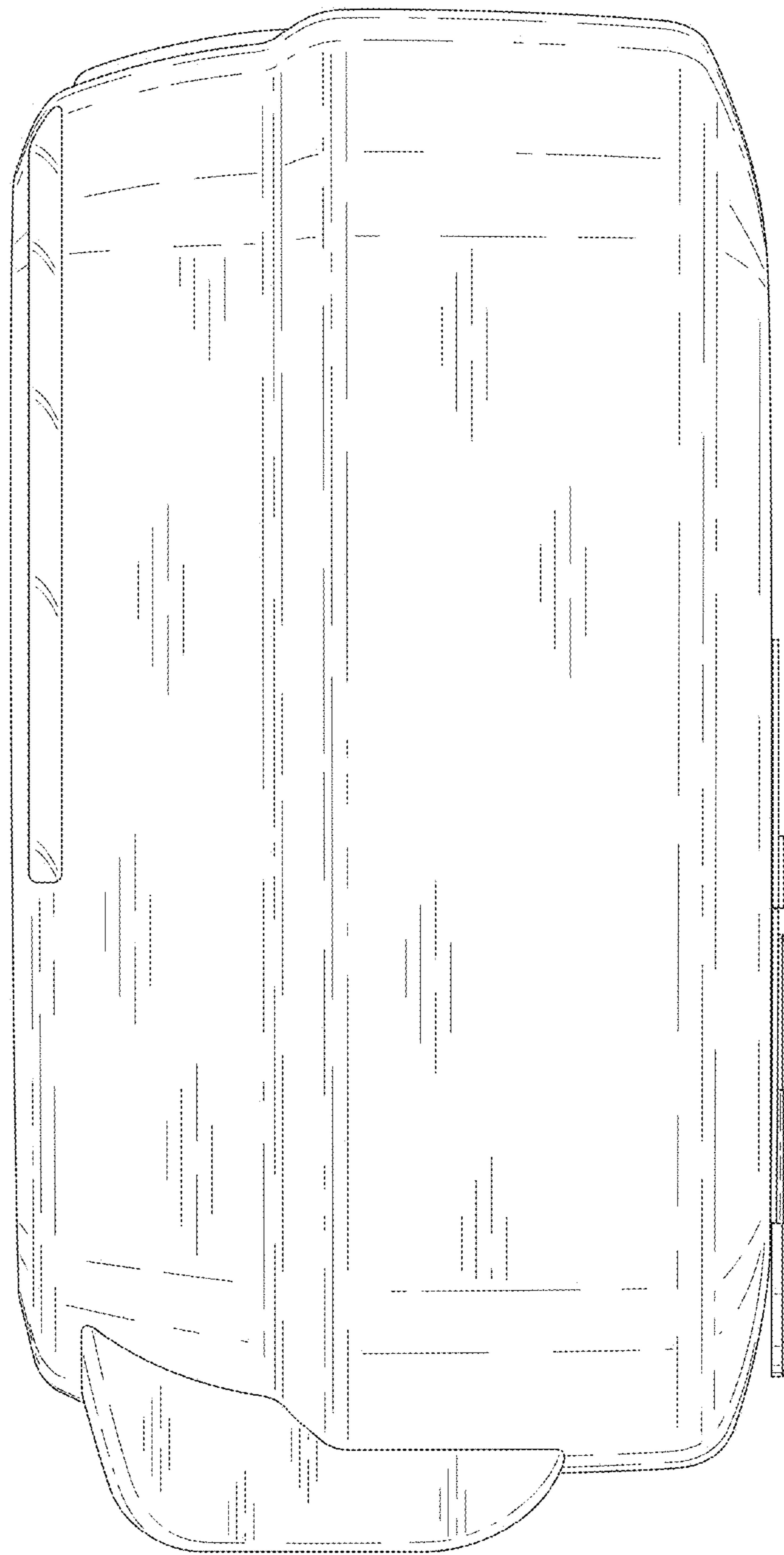

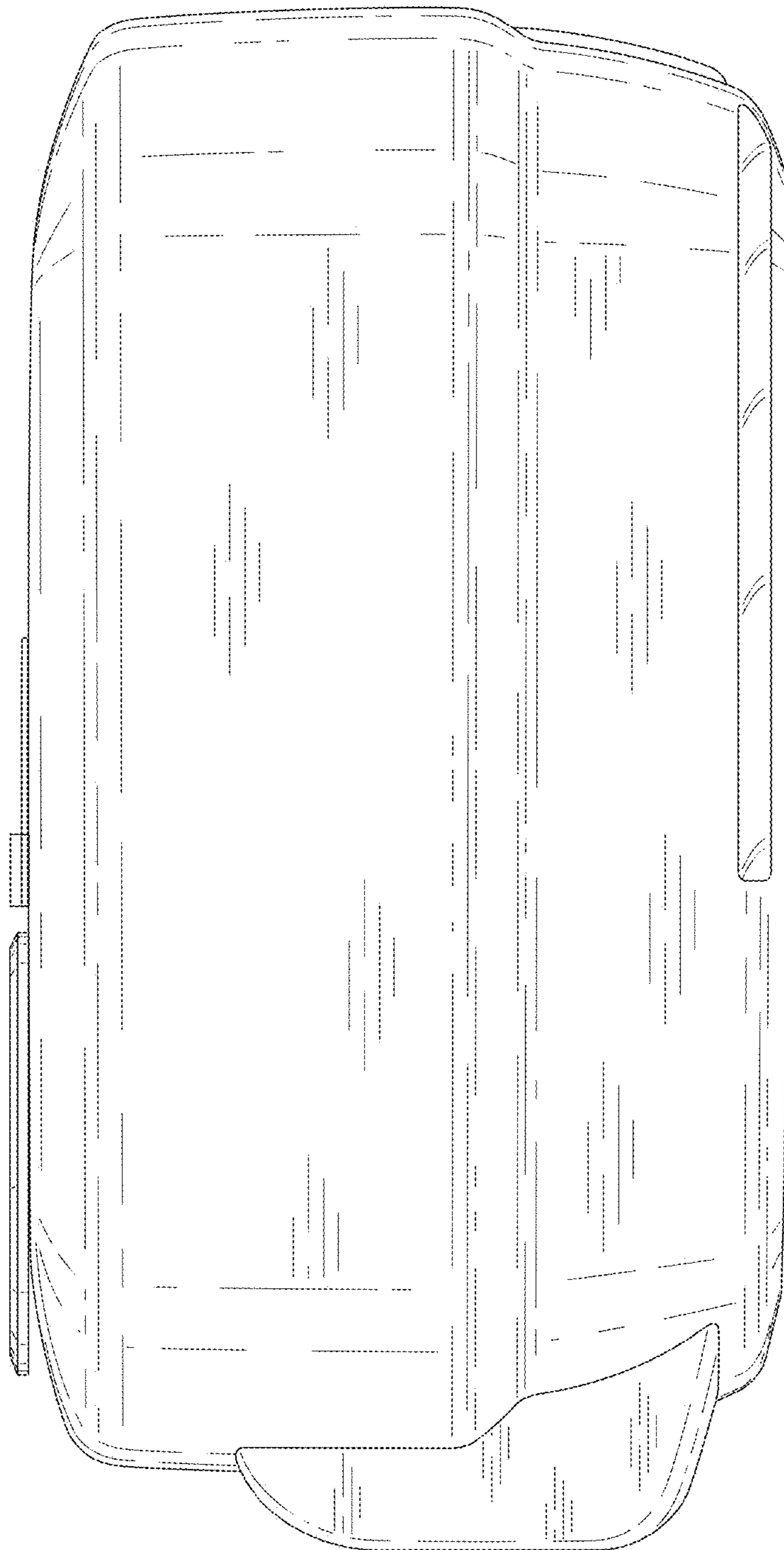

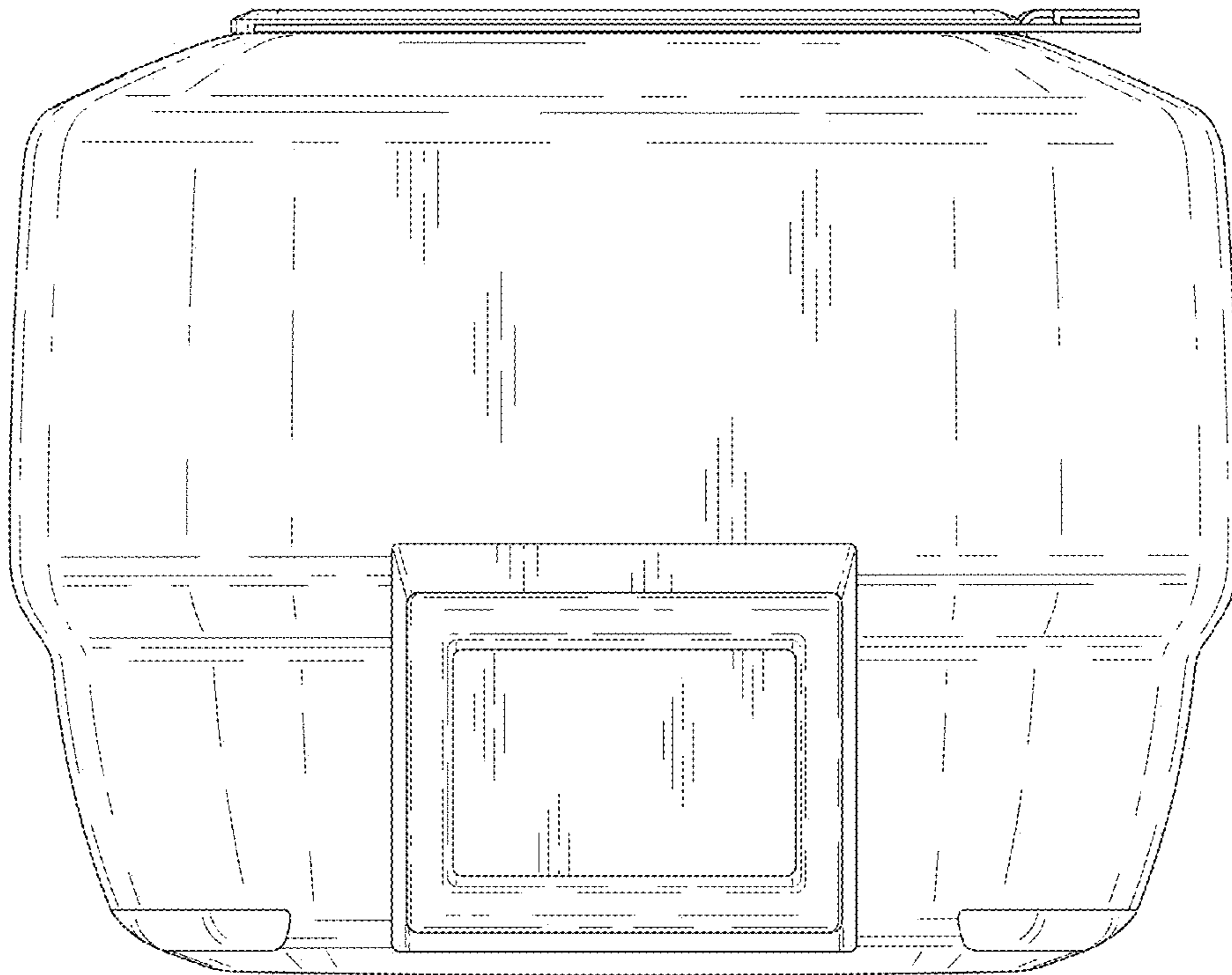

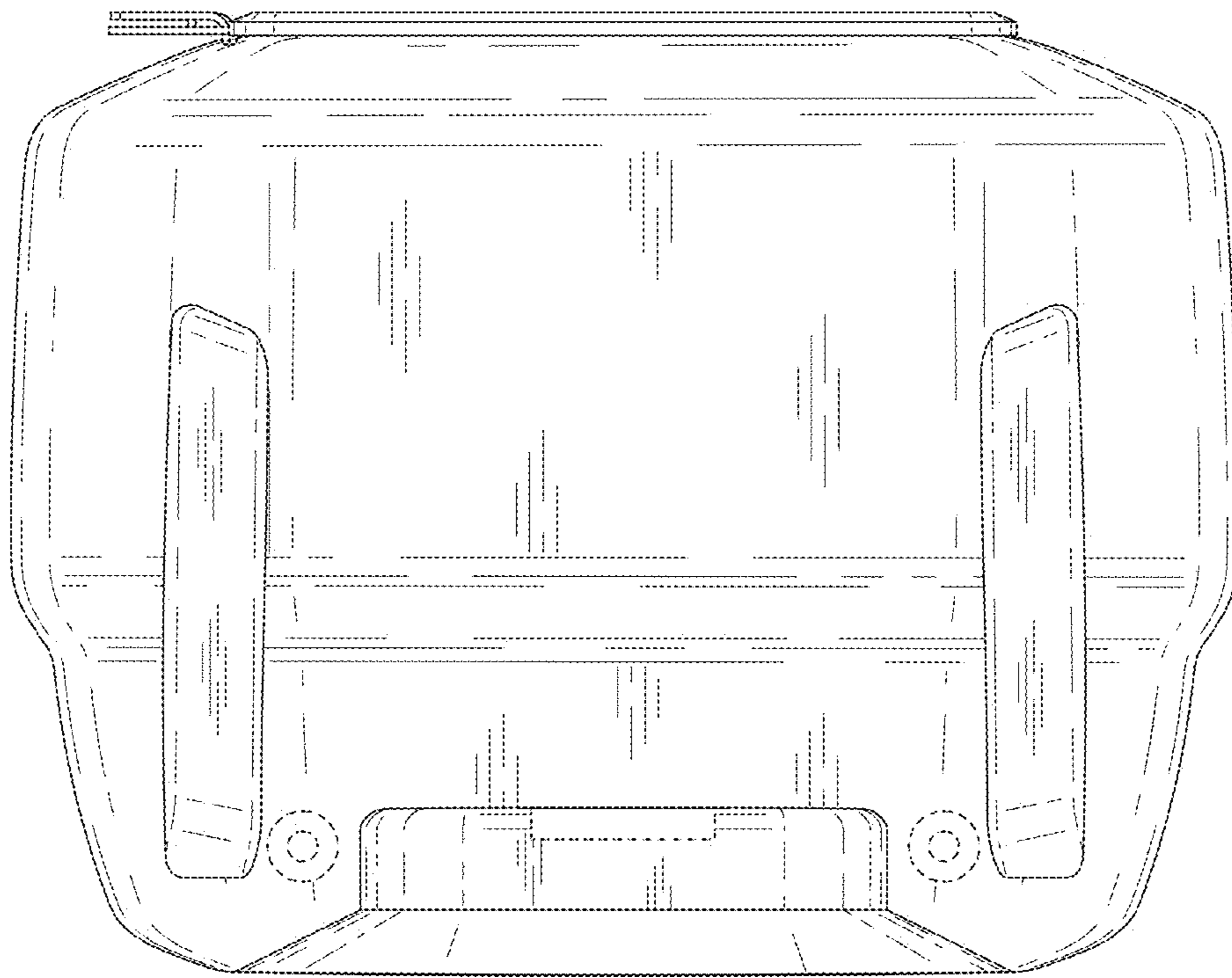
