(57) **CLAIM**

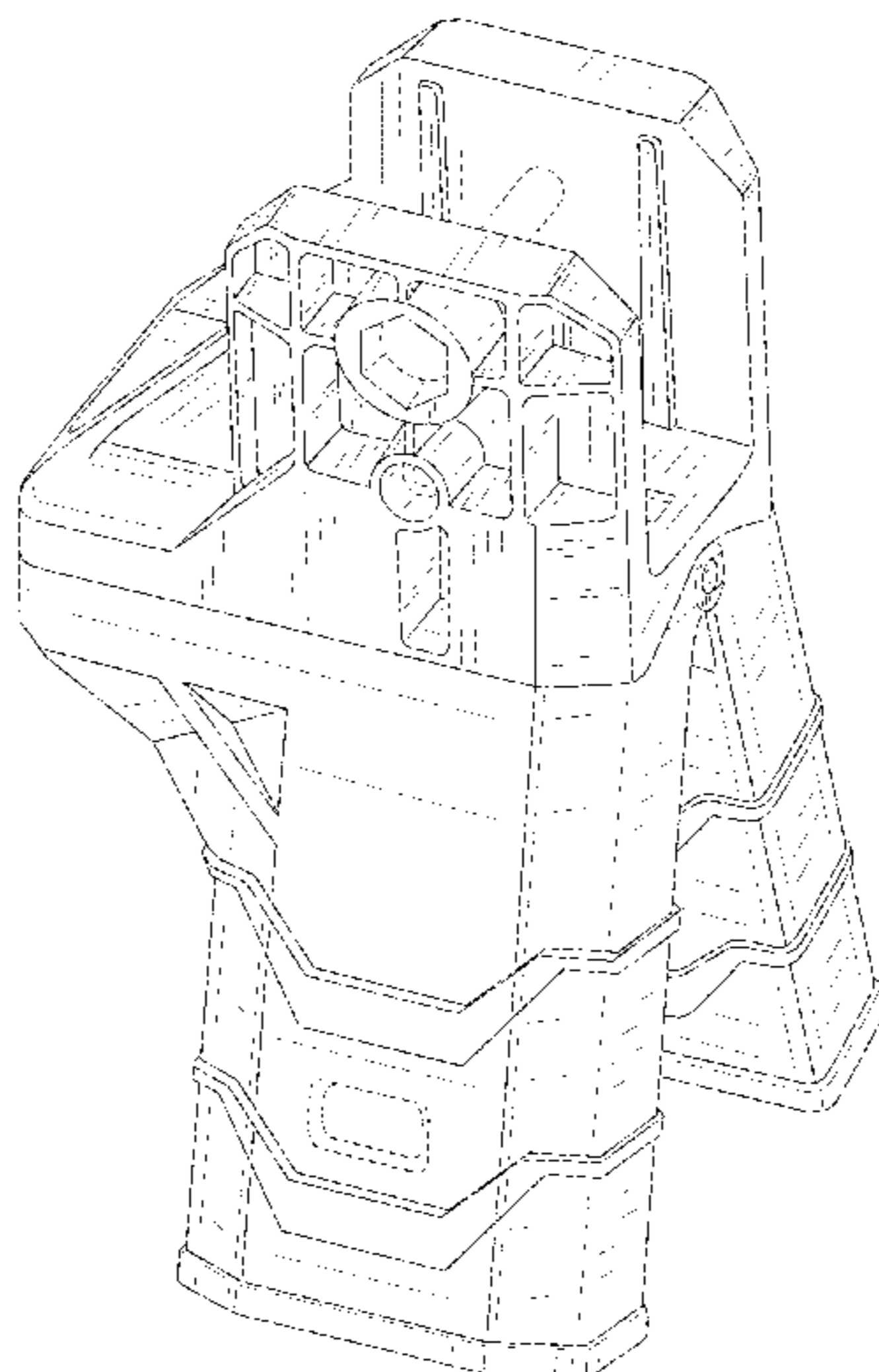
The ornamental design for a sawhorse bracket, as shown and described.

DESCRIPTION

FIG. 1 is a front, top, and right side perspective view of a design for a sawhorse bracket;
 FIG. 2 is a rear elevational view of the design as seen in FIG. 1;
 FIG. 3 is a front elevational view of the design as seen in FIG. 1;
 FIG. 4 is a left side elevational view of the design as seen in FIG. 1;
 FIG. 5 is a right side elevational view of the design as seen in FIG. 1;
 FIG. 6 is a top plan view of the design as seen in FIG. 1; and,
 FIG. 7 is a bottom plan view of the design as seen in FIG. 1.

The parts of the sawhorse bracket shown in broken lines form no part of the claimed design. The dash-dot-dash lines between the solid line portions and the broken line portions show the boundaries of the claimed design and form no part of the claimed design.

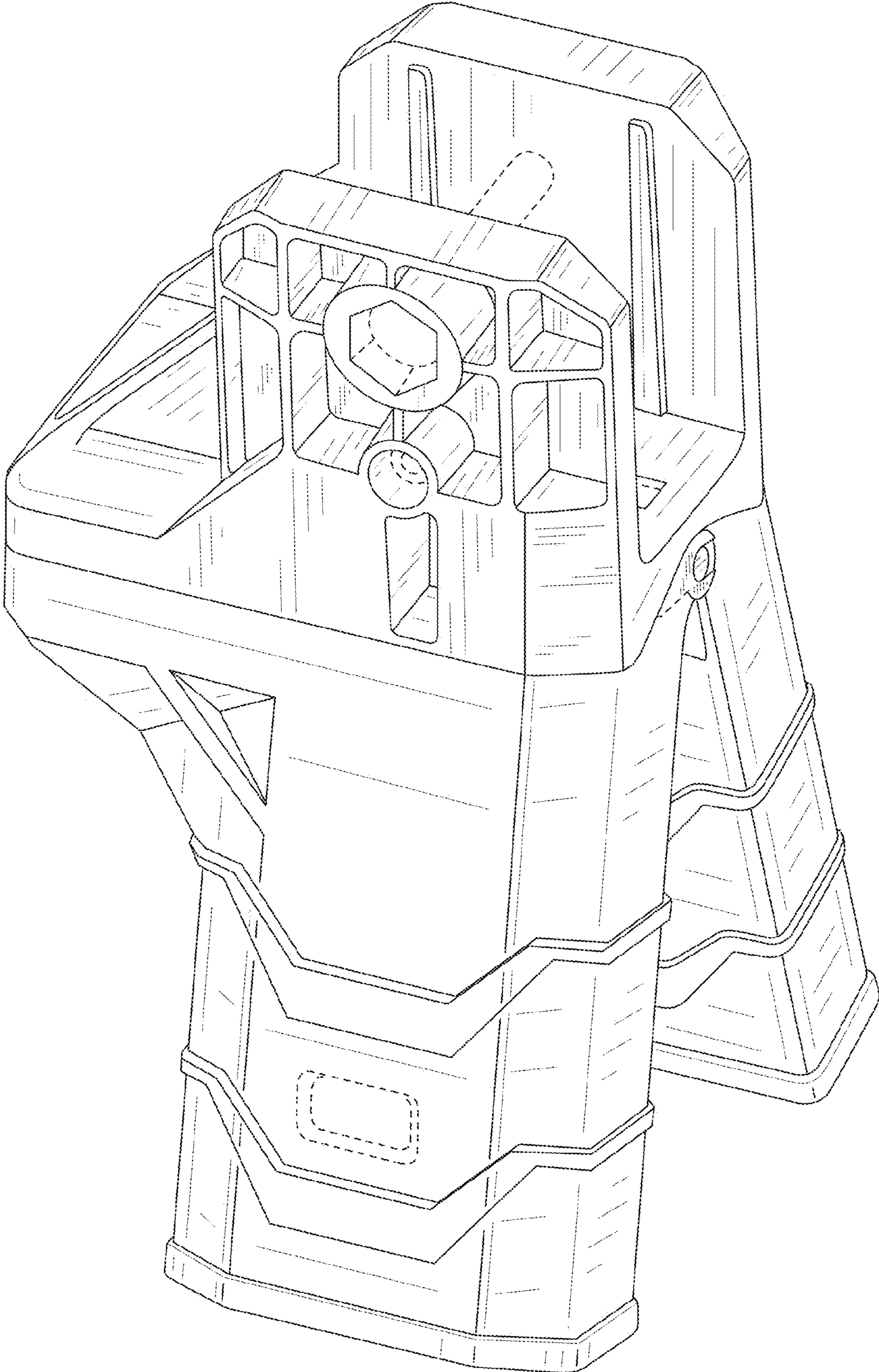

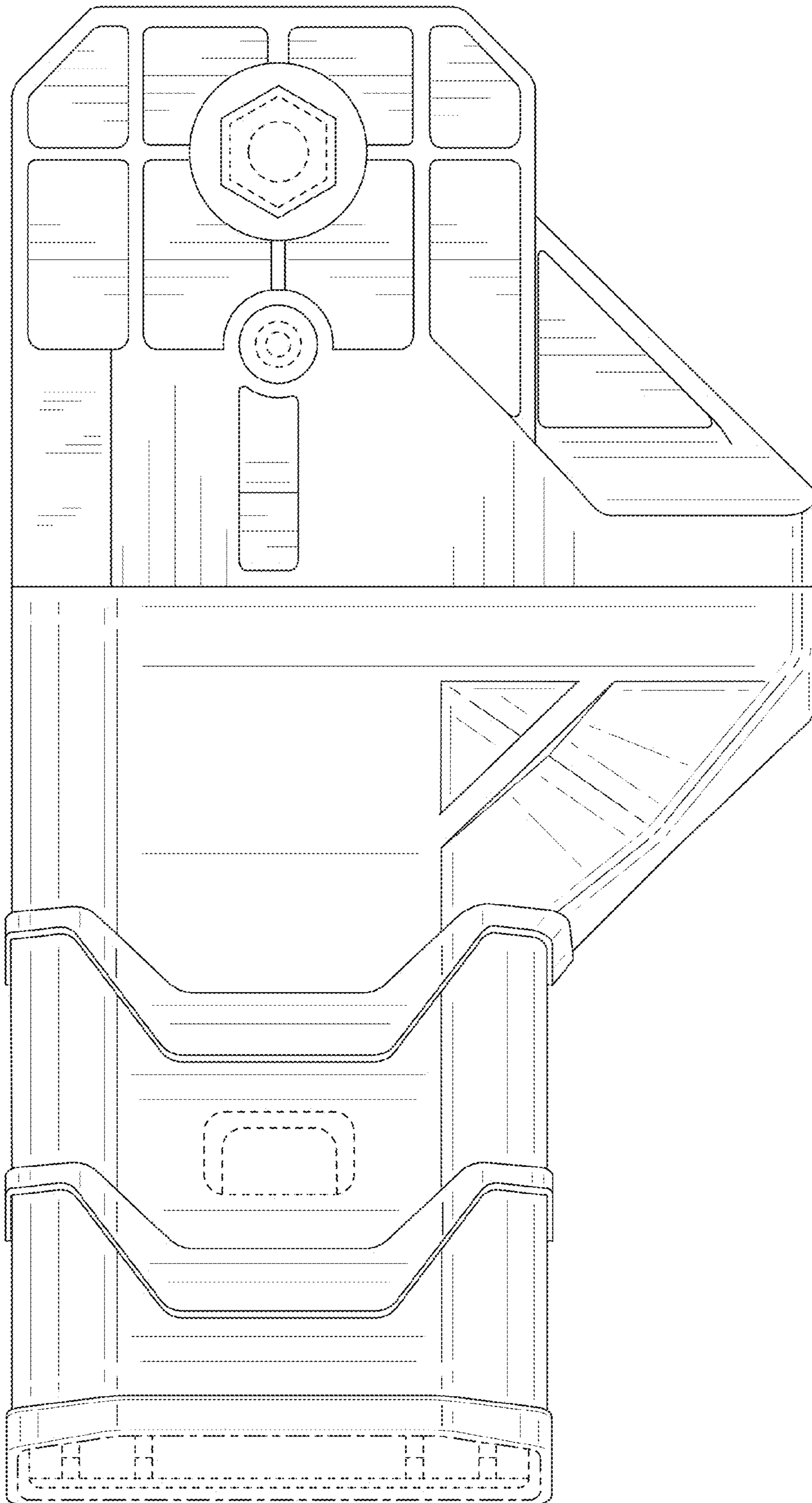

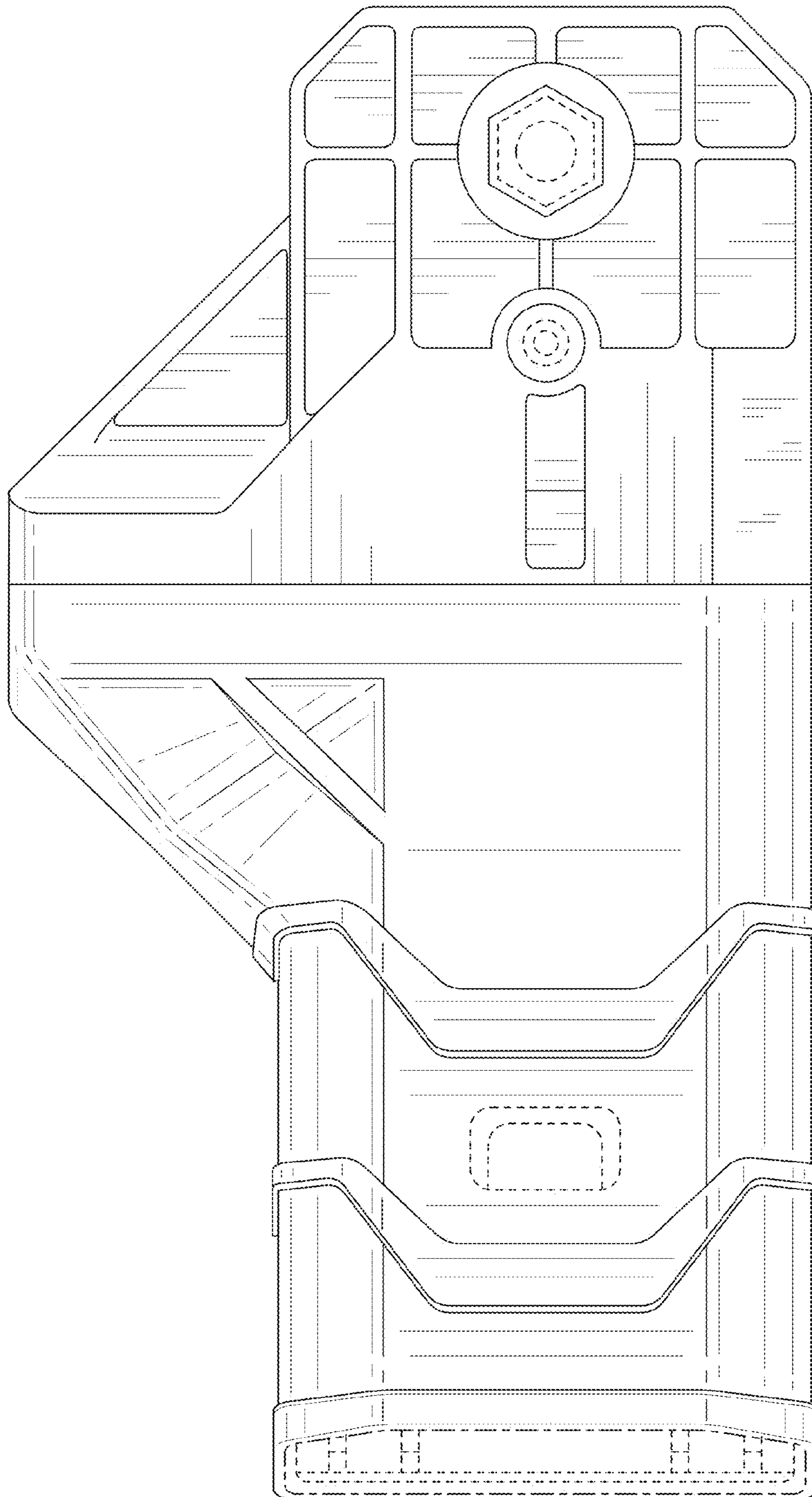

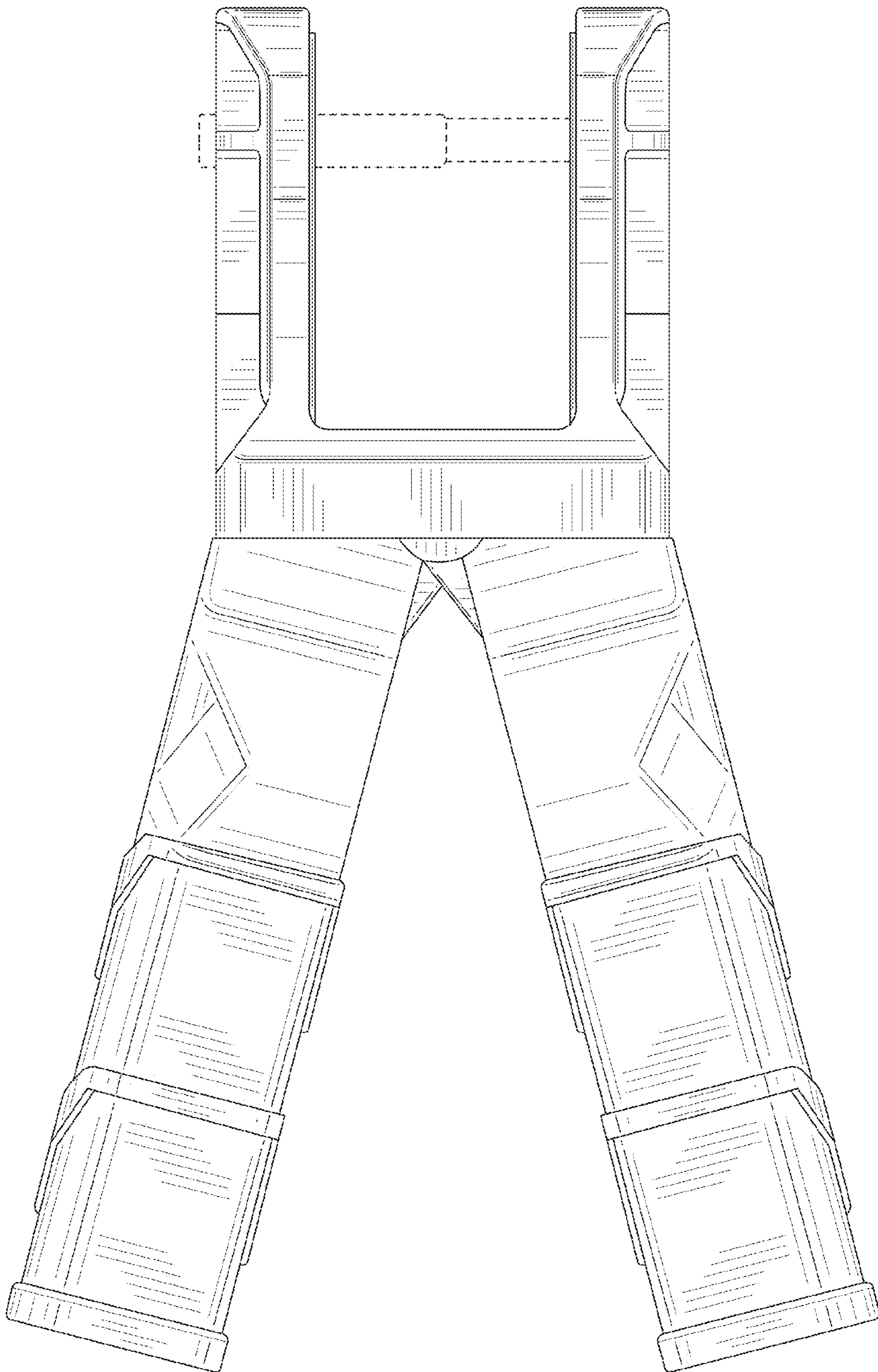

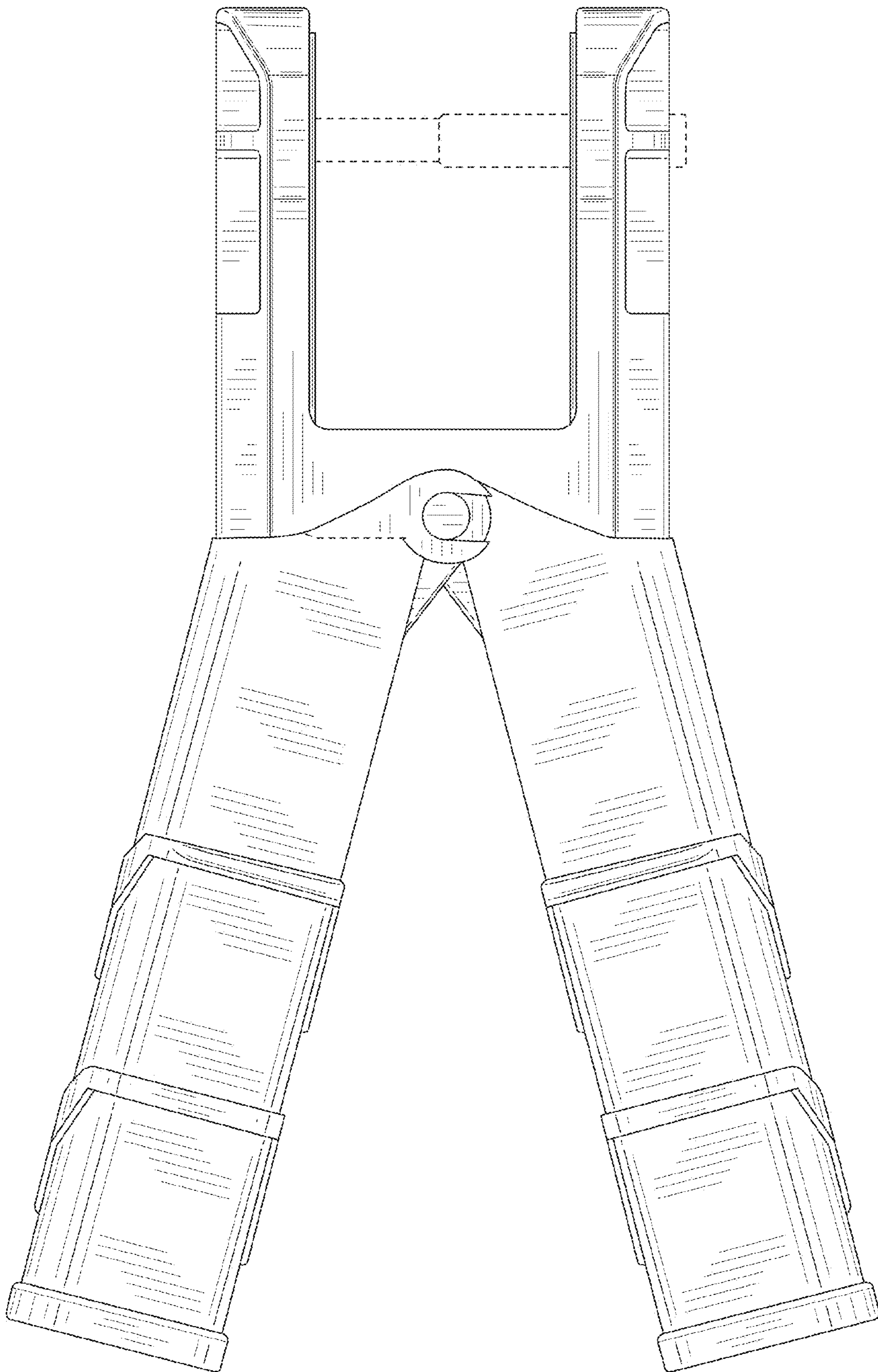

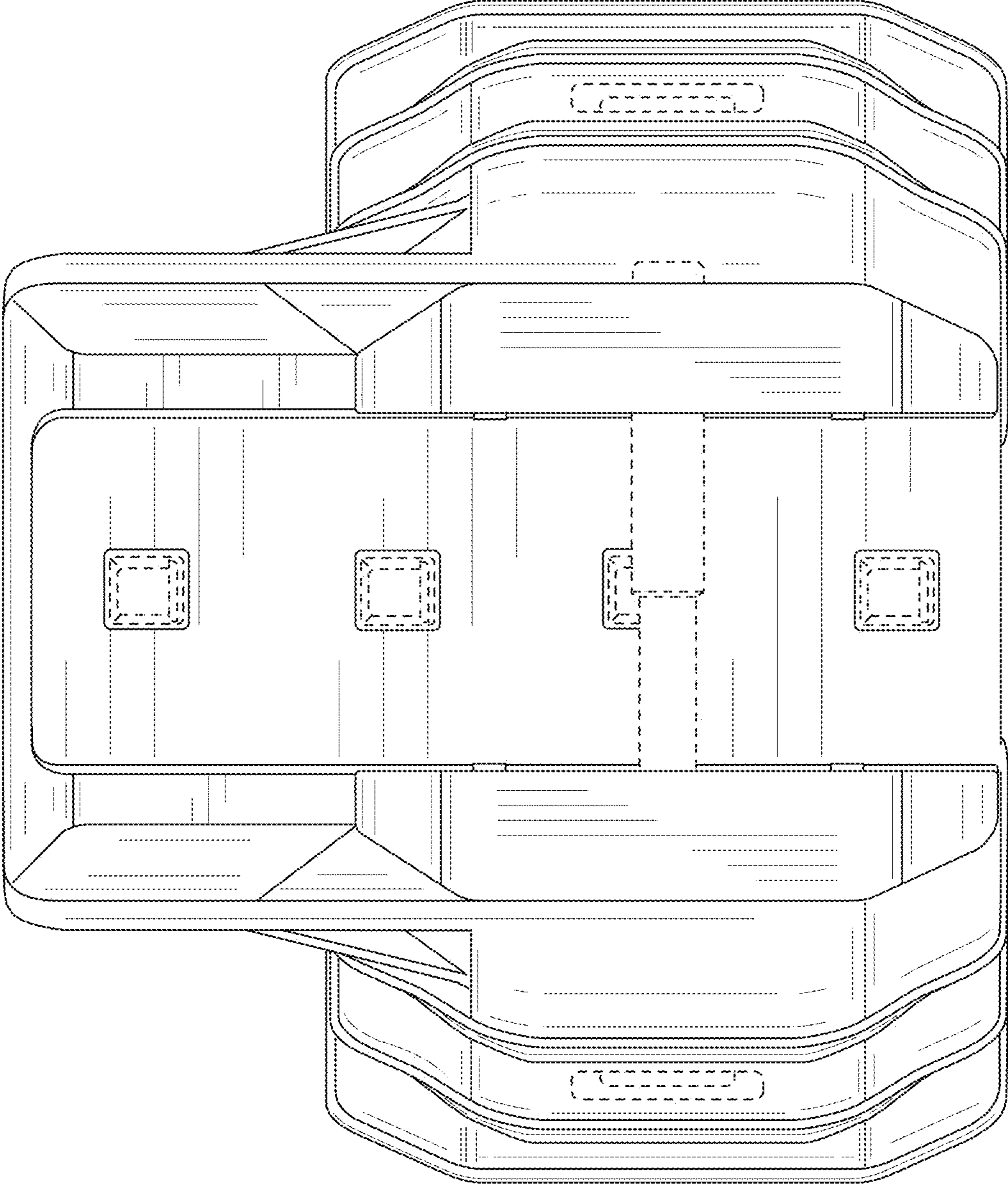

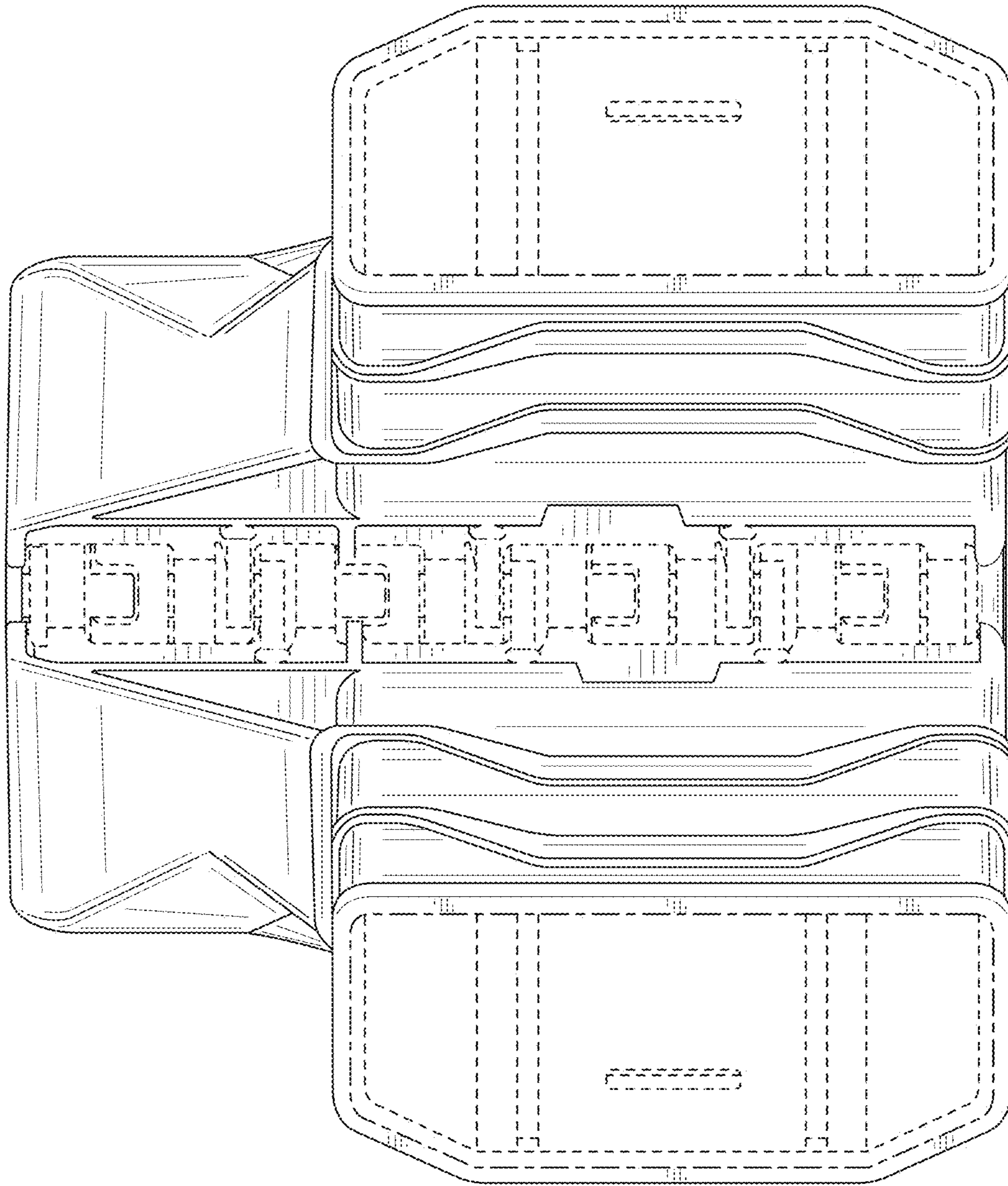
