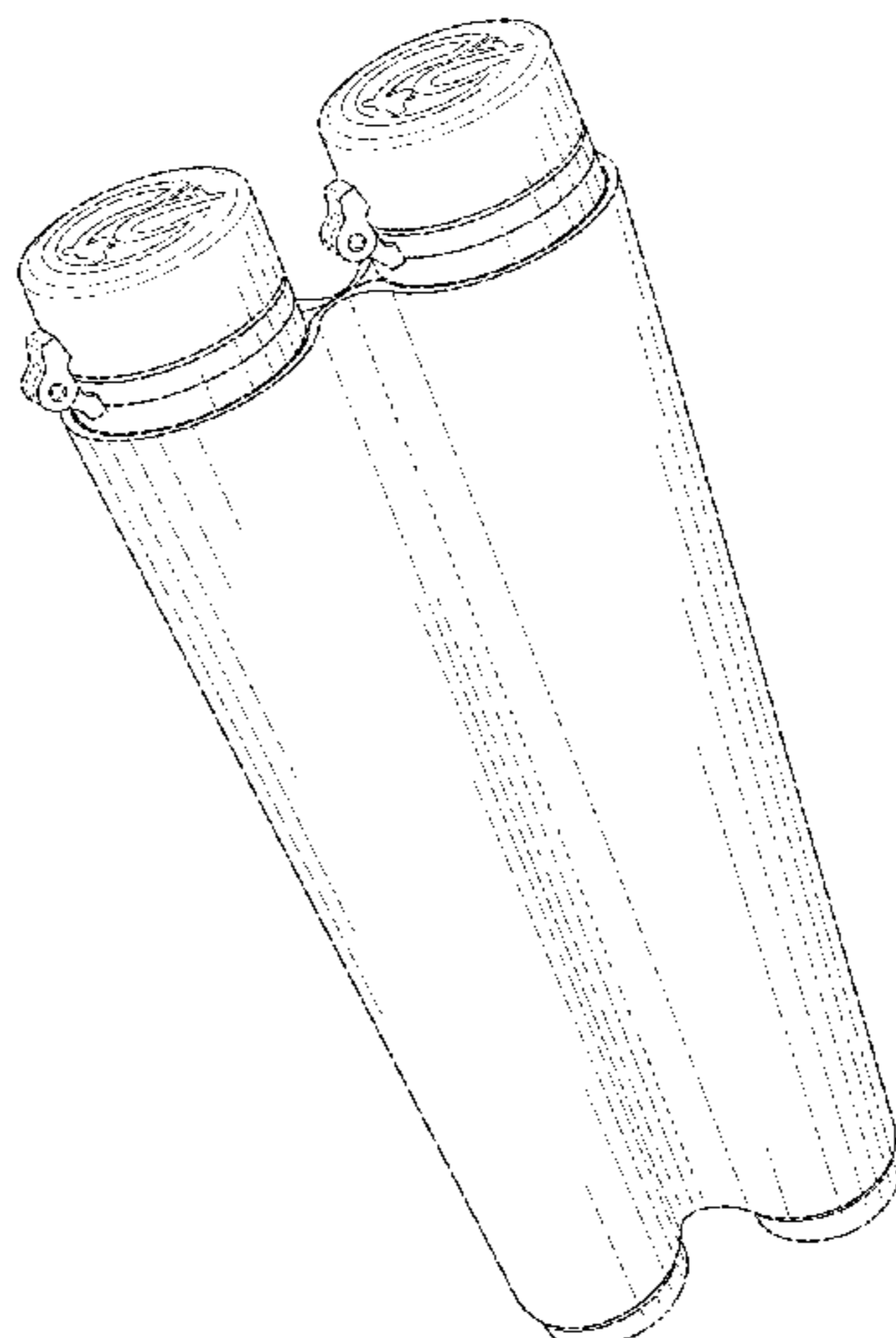
(57) **CLAIM**

The ornamental design for a case for smoking articles, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of the case for smoking articles, showing my new design;
FIG. 2 is a bottom rear perspective view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a right side view thereof;
FIG. 7 is a top view thereof; and,
FIG. 8 is a bottom view of the case for smoking articles.

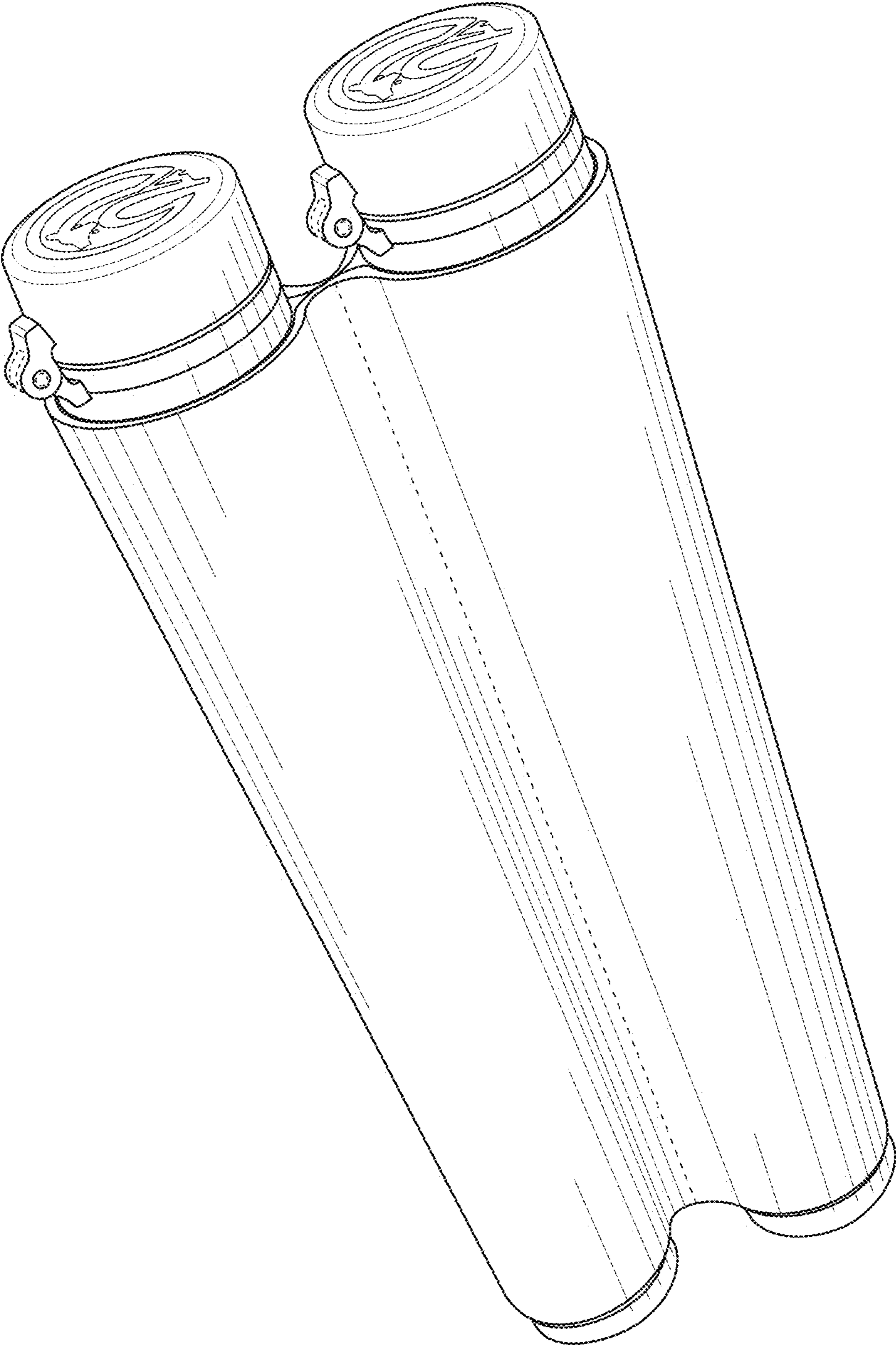

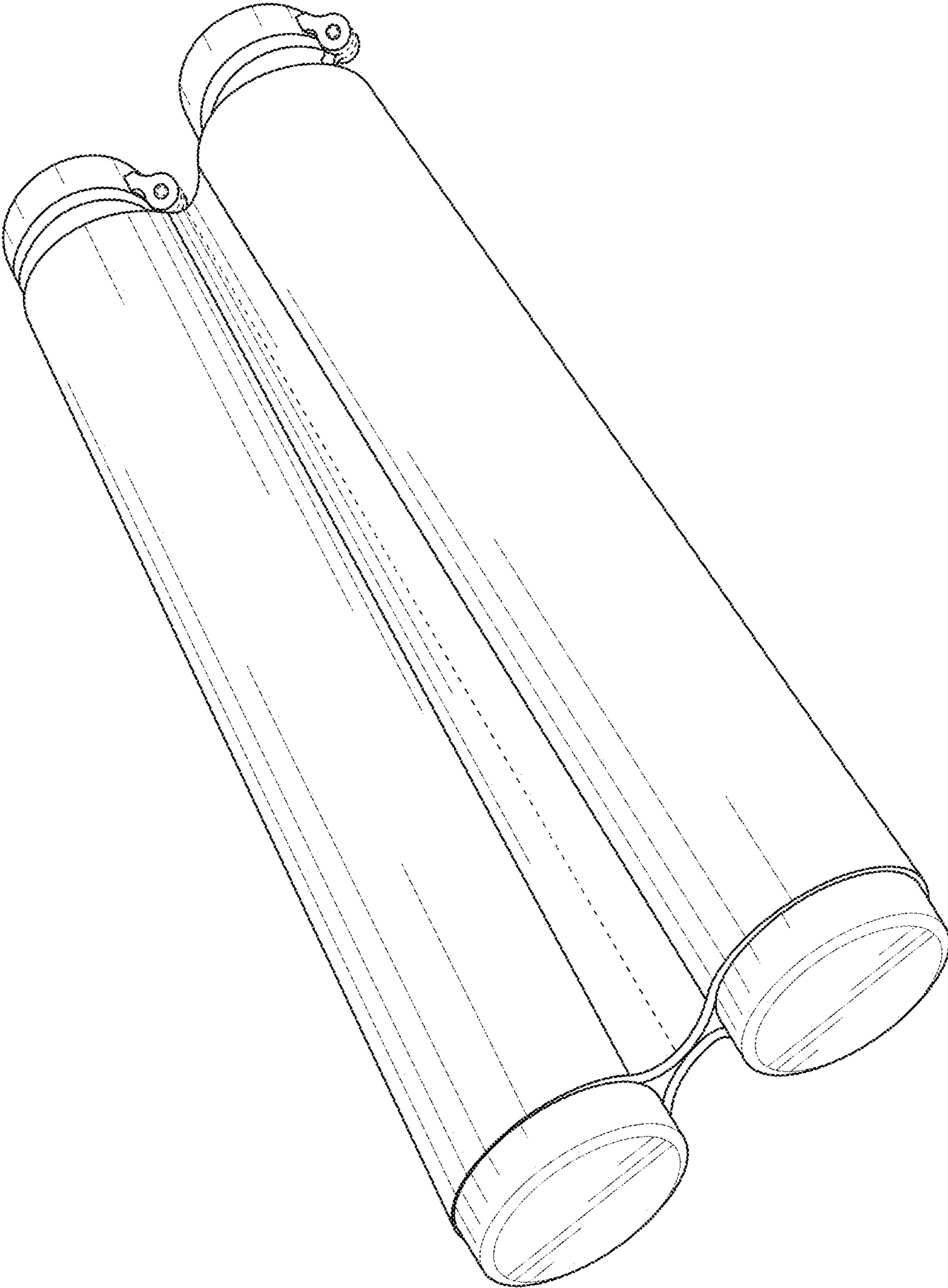

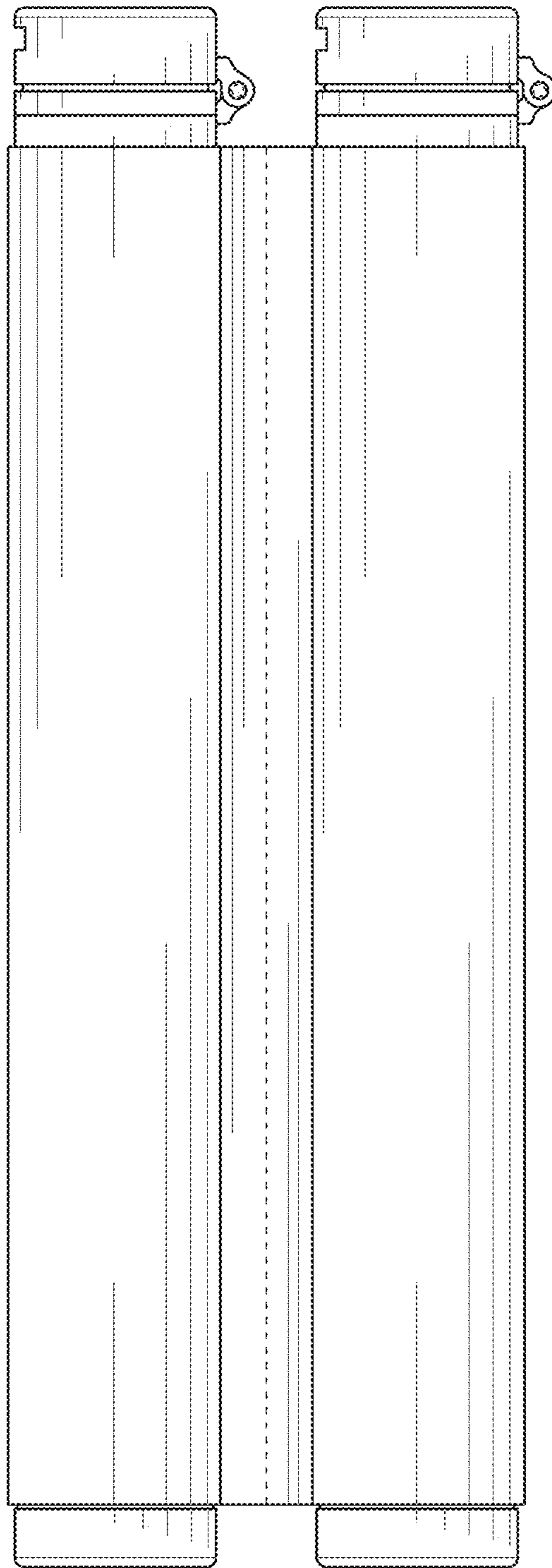

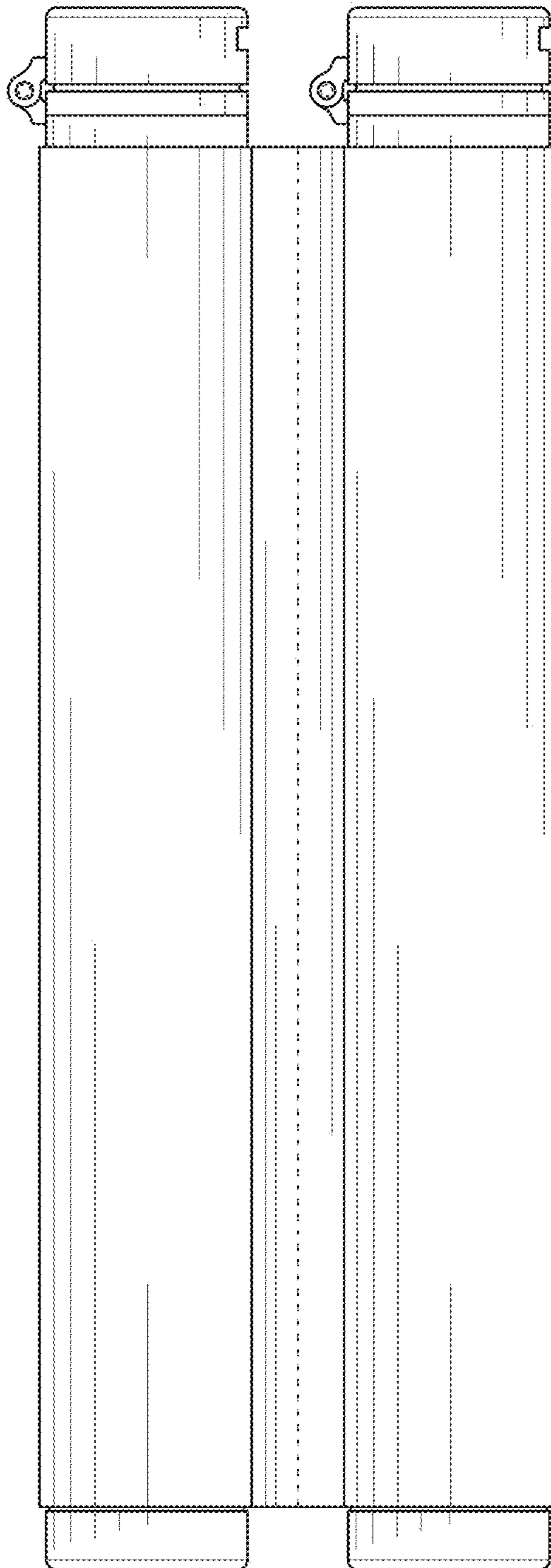

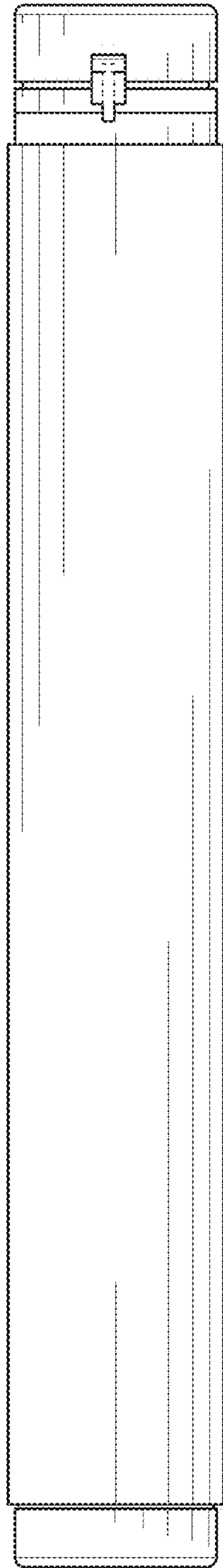

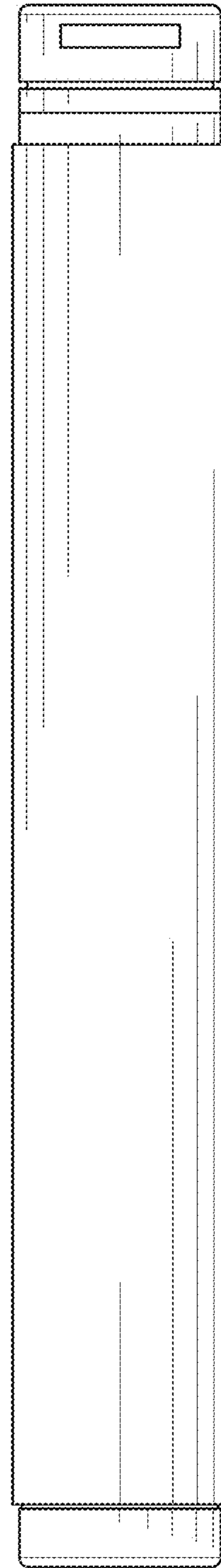

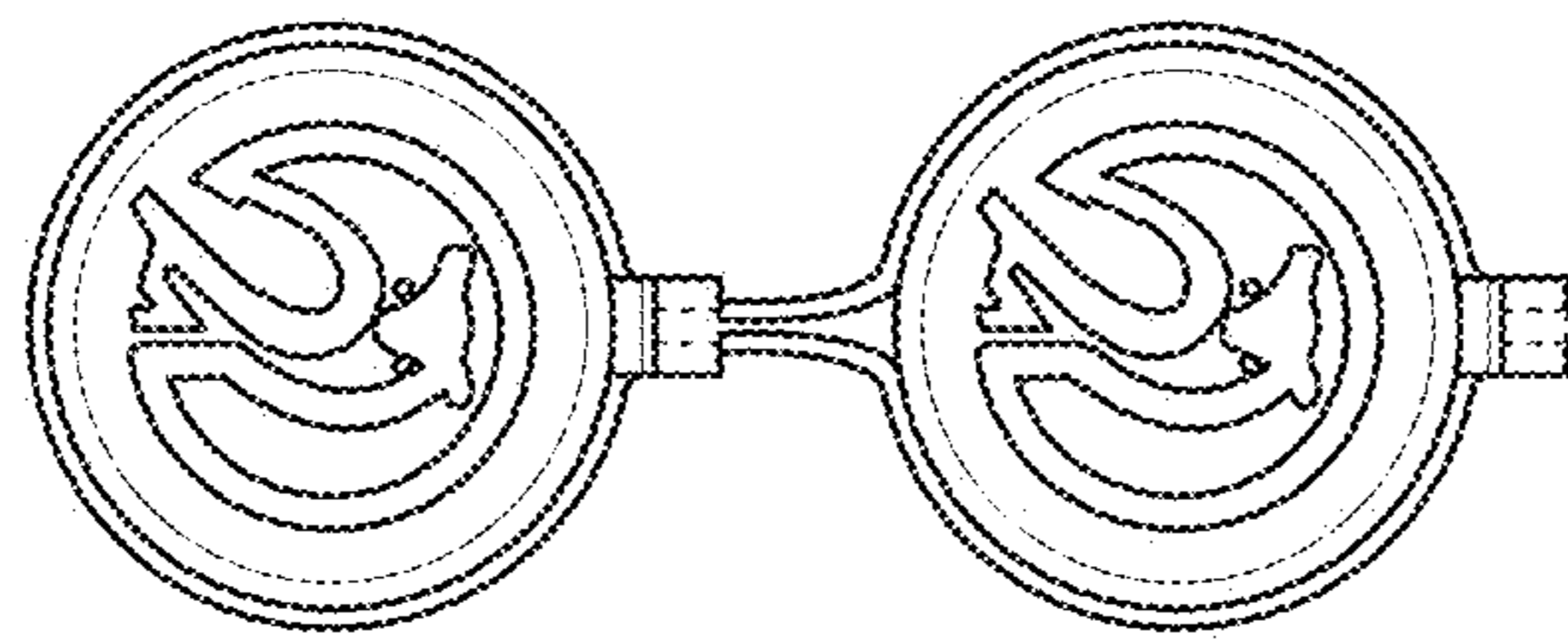

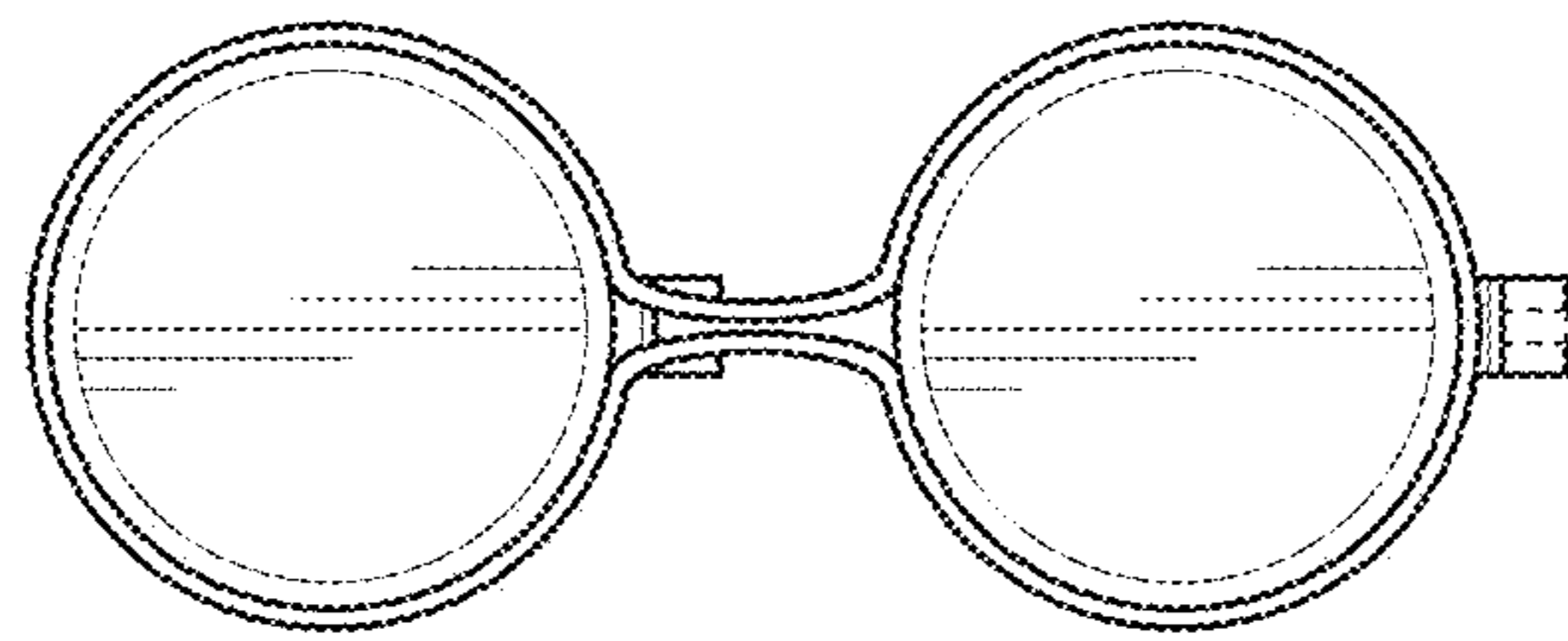
