(57) **CLAIM**

The ornamental design for a pet waste receptacle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a pet waste receptacle, showing my new design shown in environmental use; FIG. 2 is a perspective view thereof; FIG. 3 is a right side elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a rear elevation view thereof; FIG. 6 is a front elevation view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof.

The broken lines in the figures illustrate portions of the pet waste receptacle that form no part of the claimed design. The broken line showing of a dog in FIG. 1 illustrates environmental subject matter that forms no part of the claimed design.

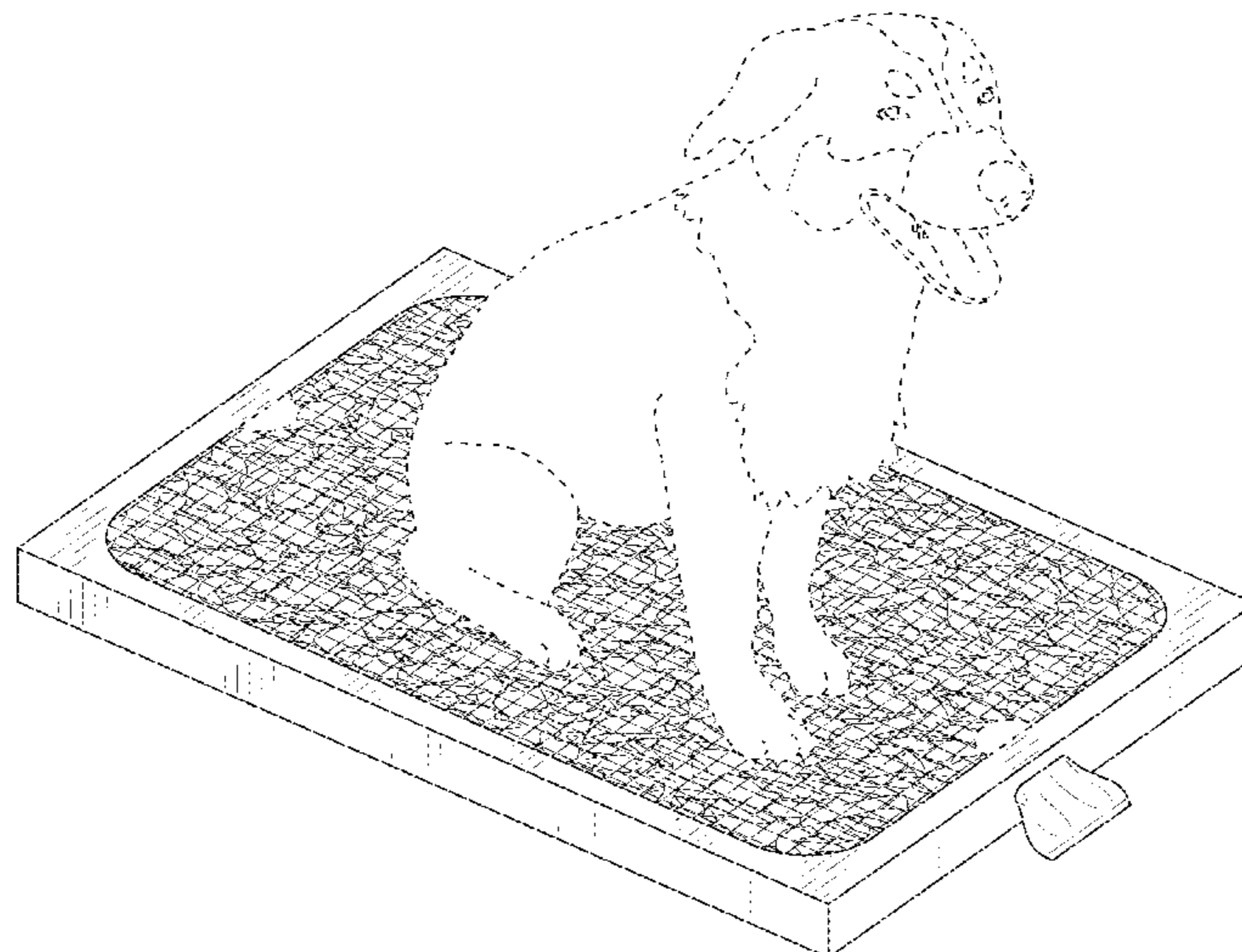

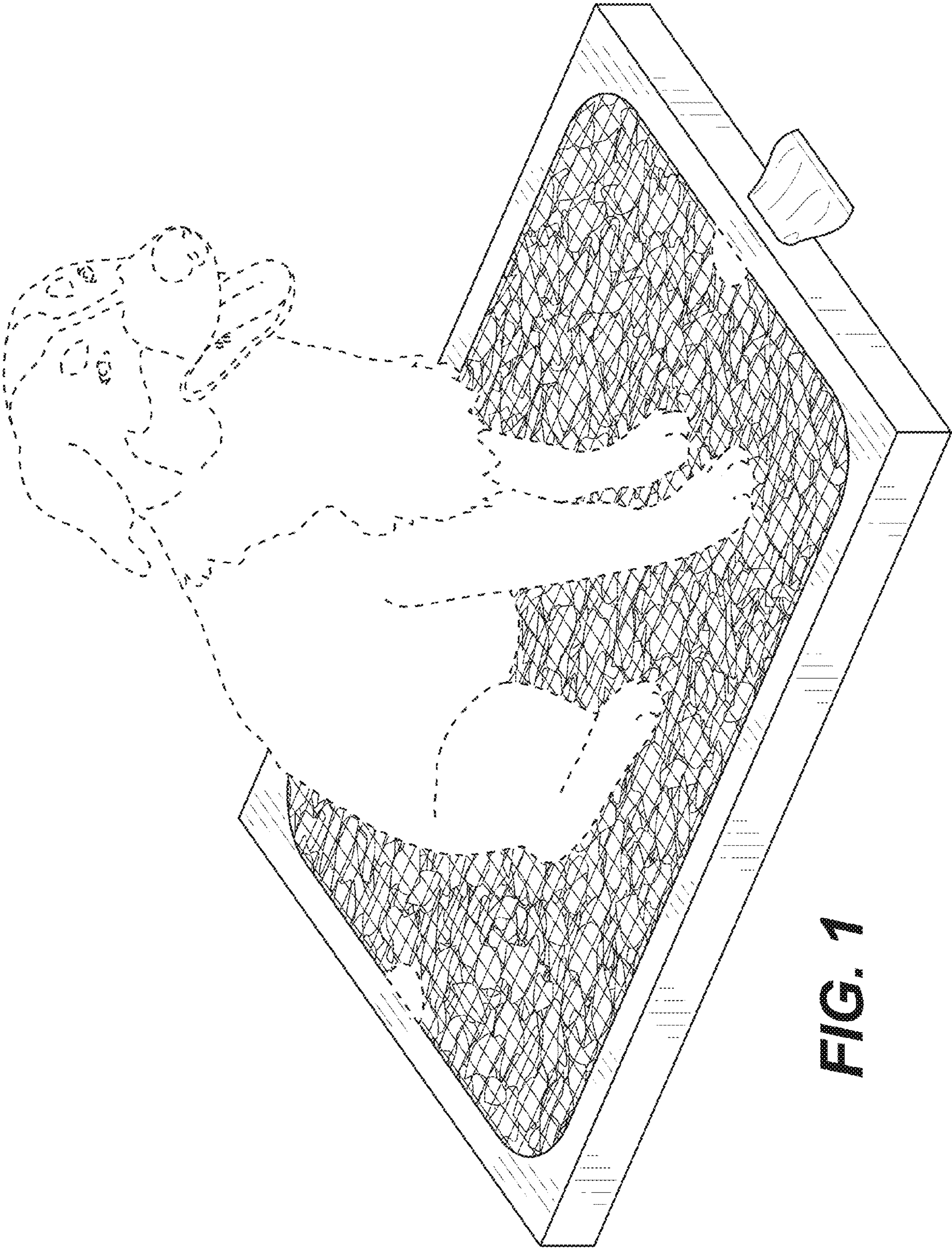

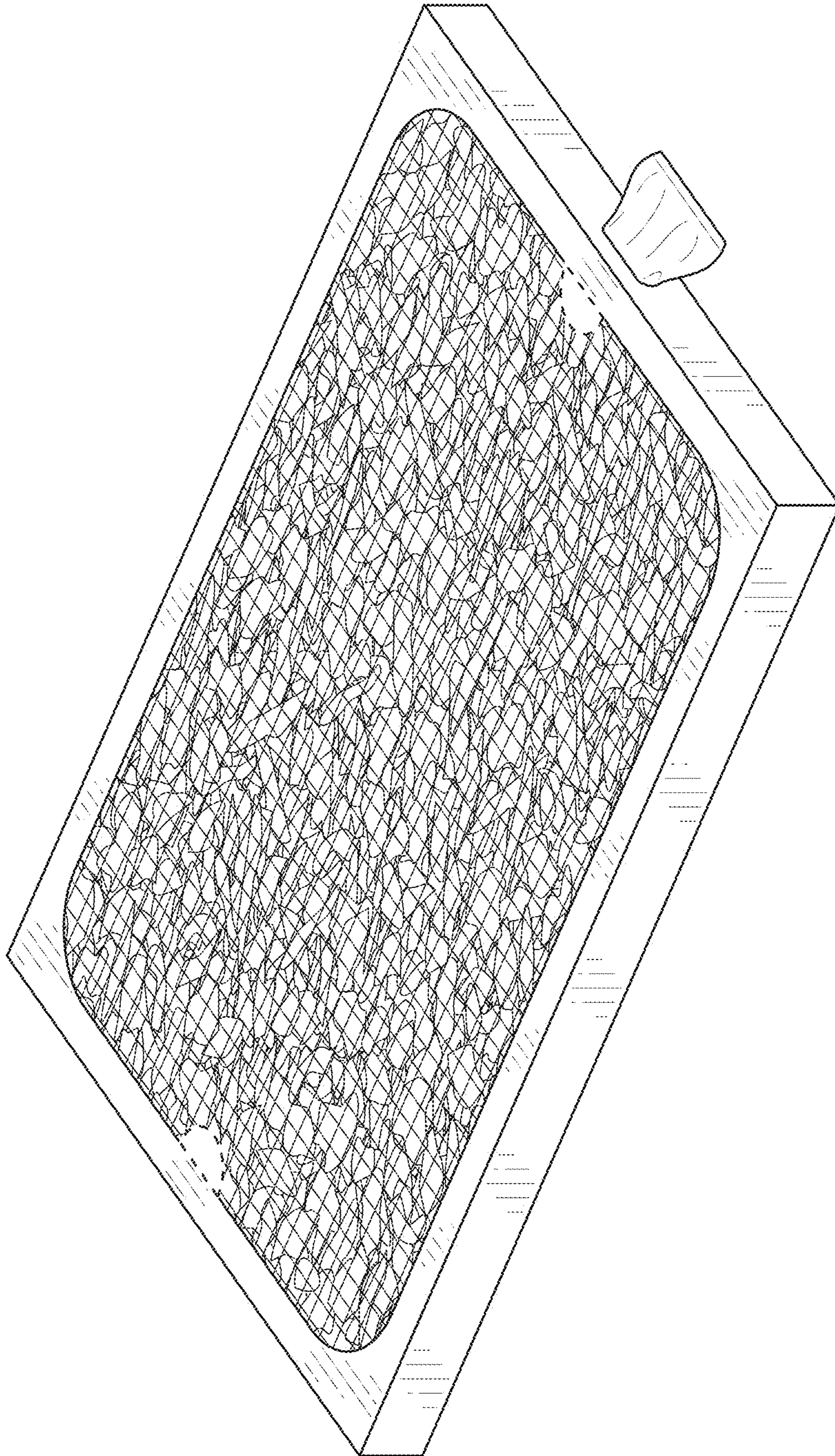
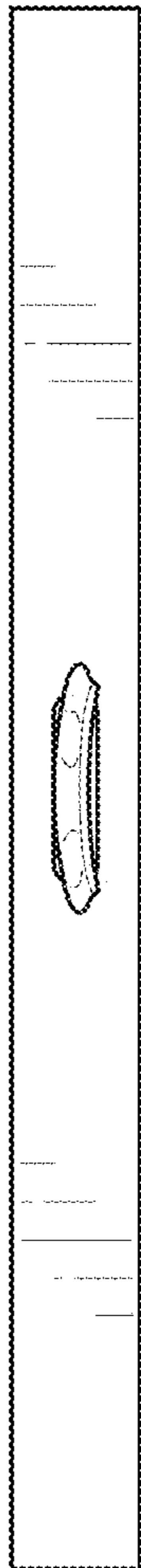

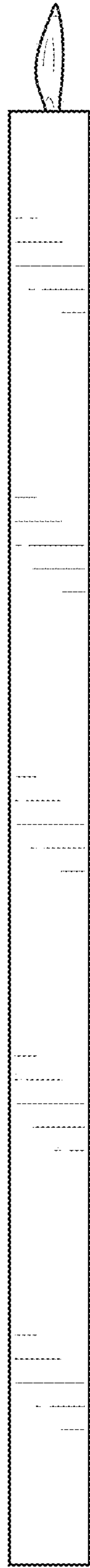

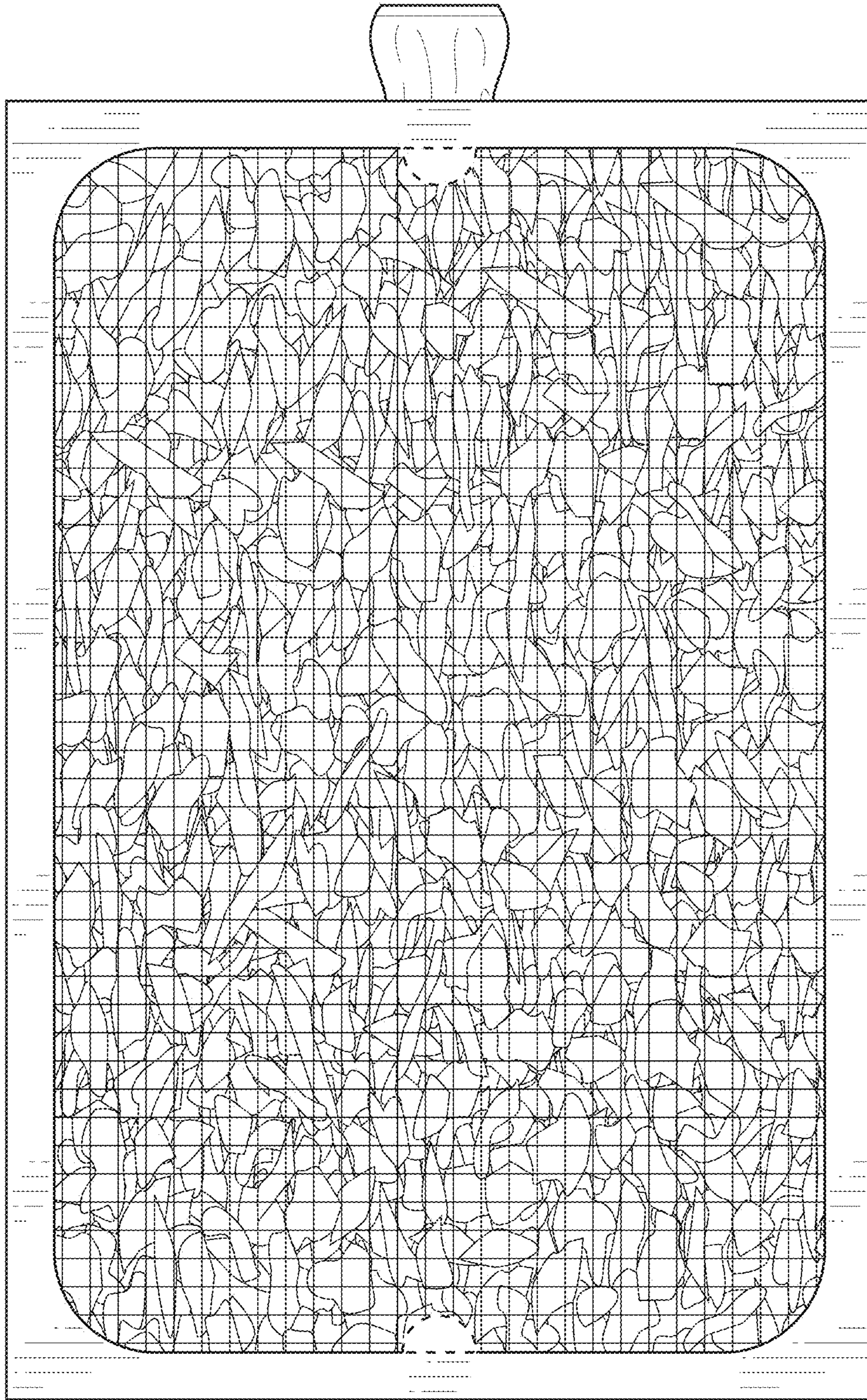
