(57) **CLAIM**

The ornamental design for a tee shirt with pockets, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a tee shirt with 2 pockets that will be used for business cards on each side of a short sleeve tee shirt, showing a first embodiment of the design.

FIG. 2 is a back view of the short sleeve shirt with the business card pockets

FIG. 3 is a right side view of the short sleeve shirt with the business card pockets

FIG. 4 is a left side view of the short sleeve shirt with the business card pockets

FIG. 5 is the top view of the short sleeve shirt with the business card pockets.

FIG. 6 is a front view of the short sleeve shirt with the business card pockets shown in use.

FIG. 7 is a perspective view of a tee shirt with 2 pockets that will be used for business cards on each side of the long sleeve tee shirt, showing a first embodiment of the design.

FIG. 8 is a back view of the long sleeve shirt with the business card pockets.

FIG. 9 is a right side view of the long sleeve shirt with the business card pockets.

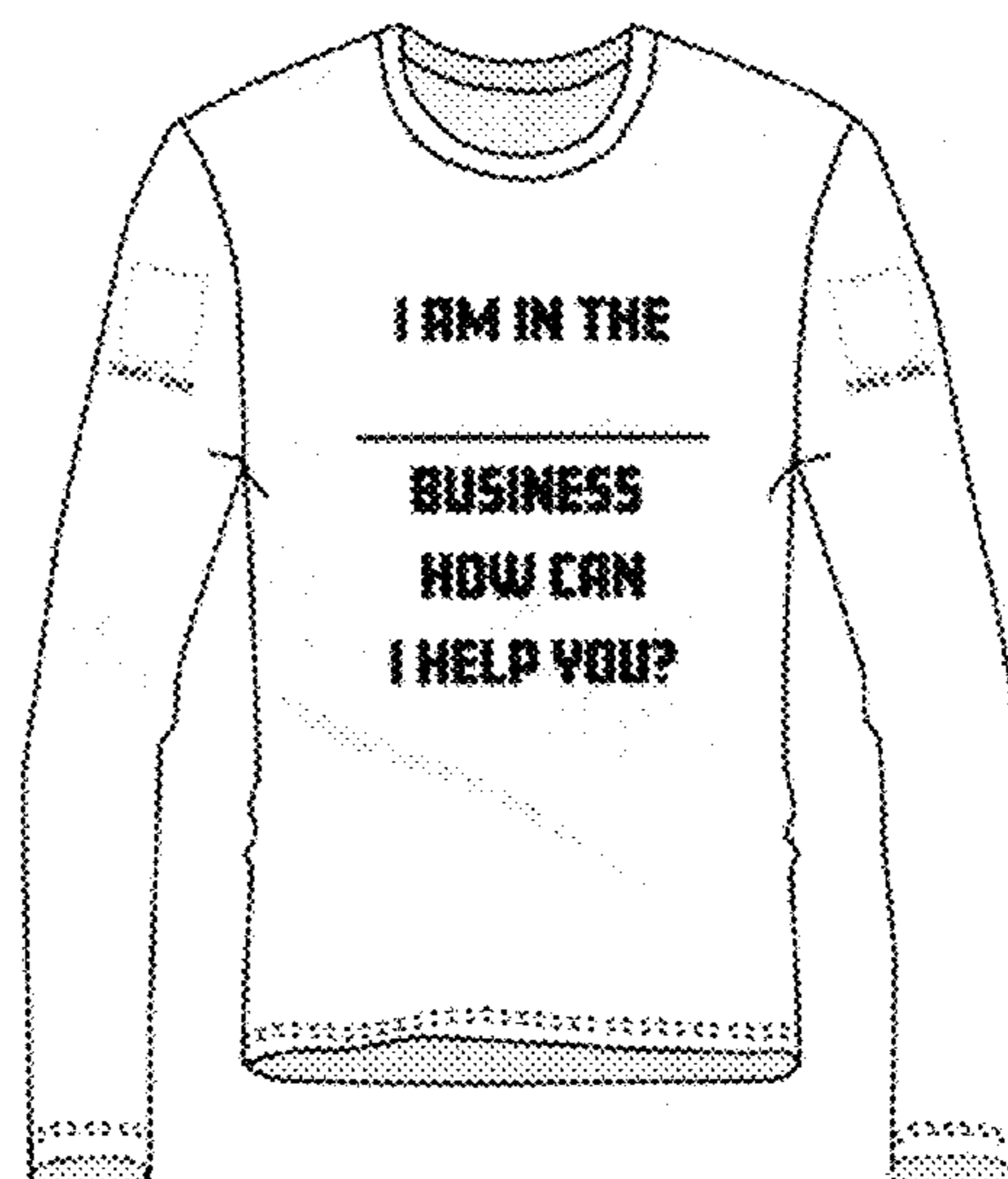
FIG. 10 is a left side view of the long sleeve shirt with the business card pockets.

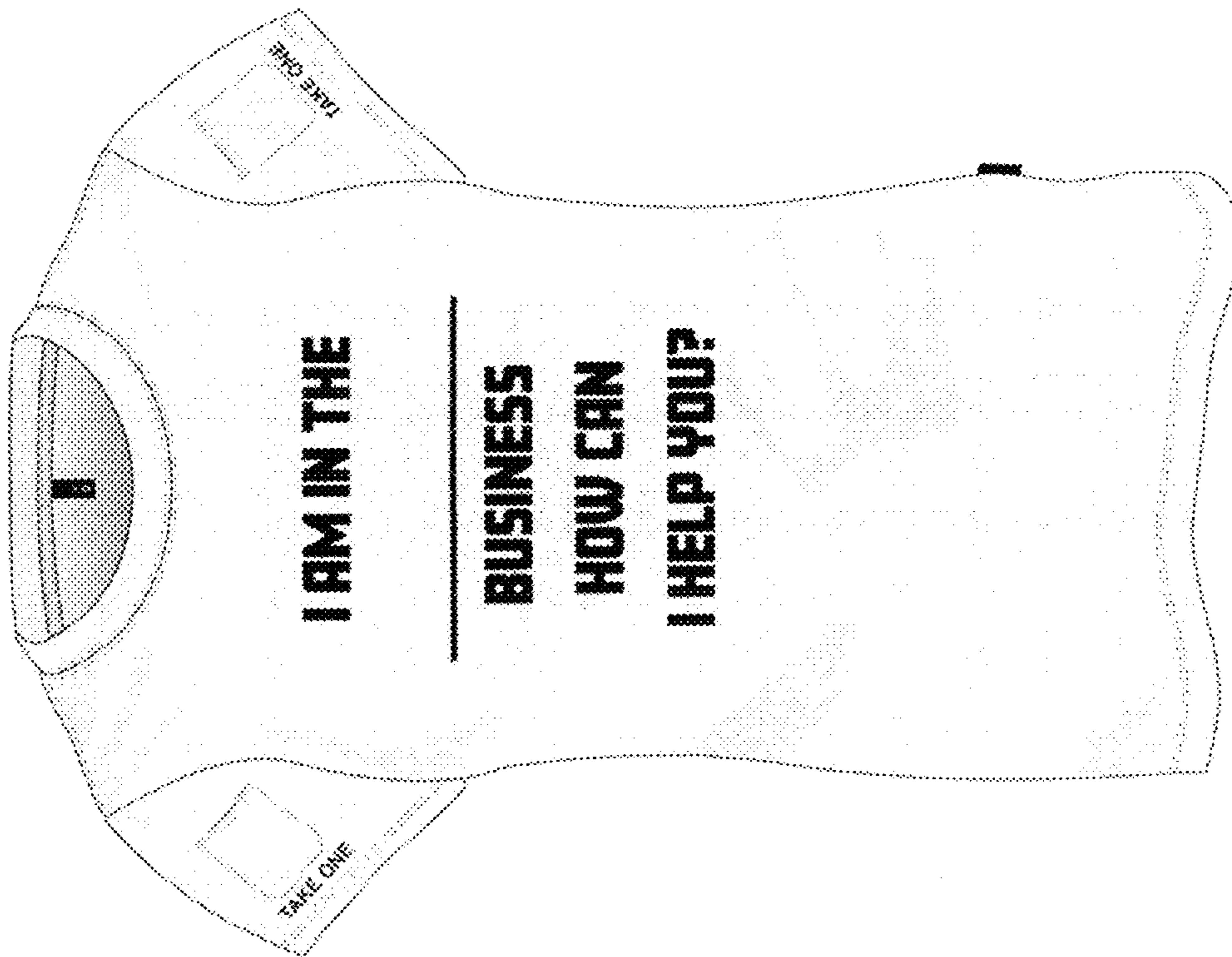

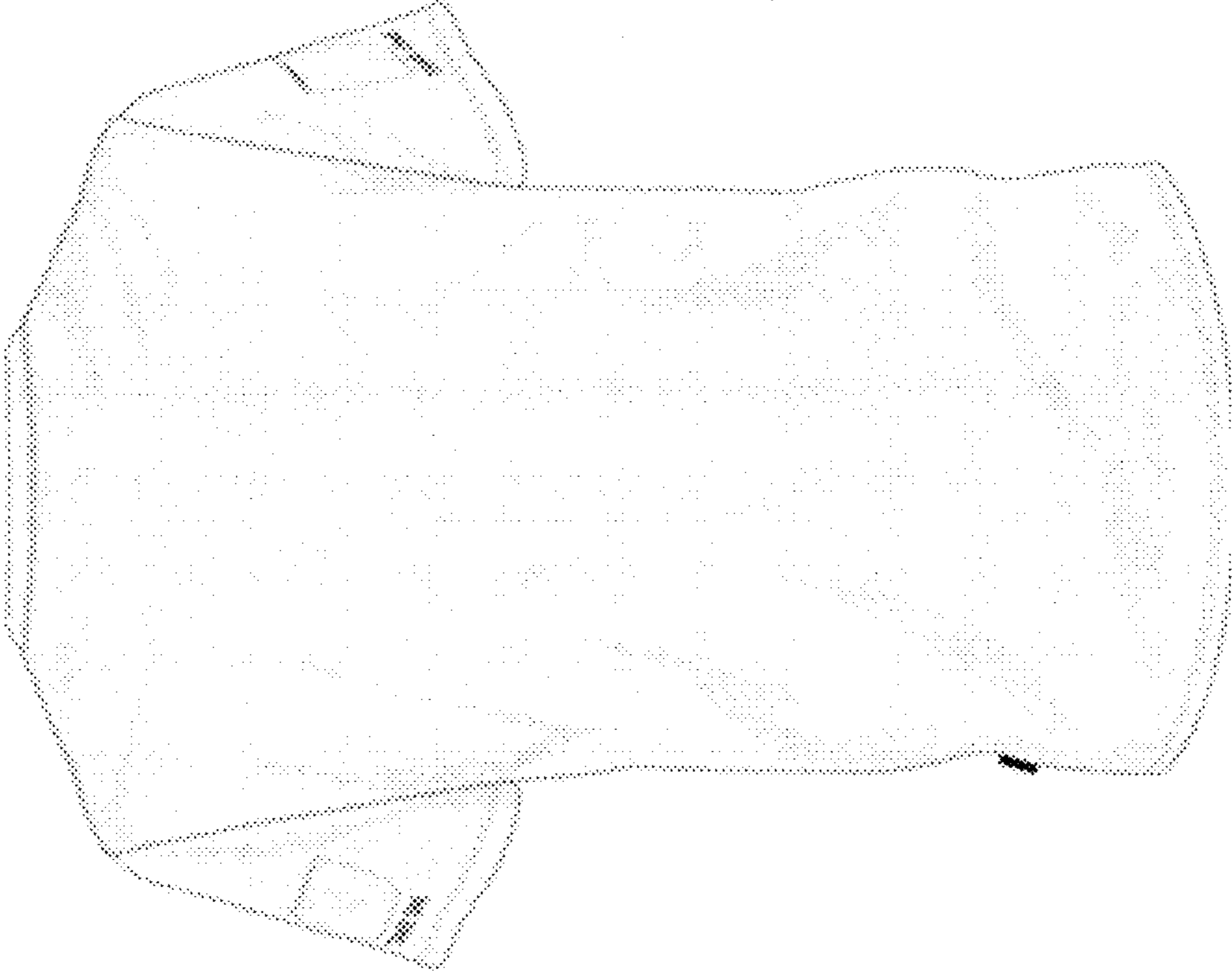

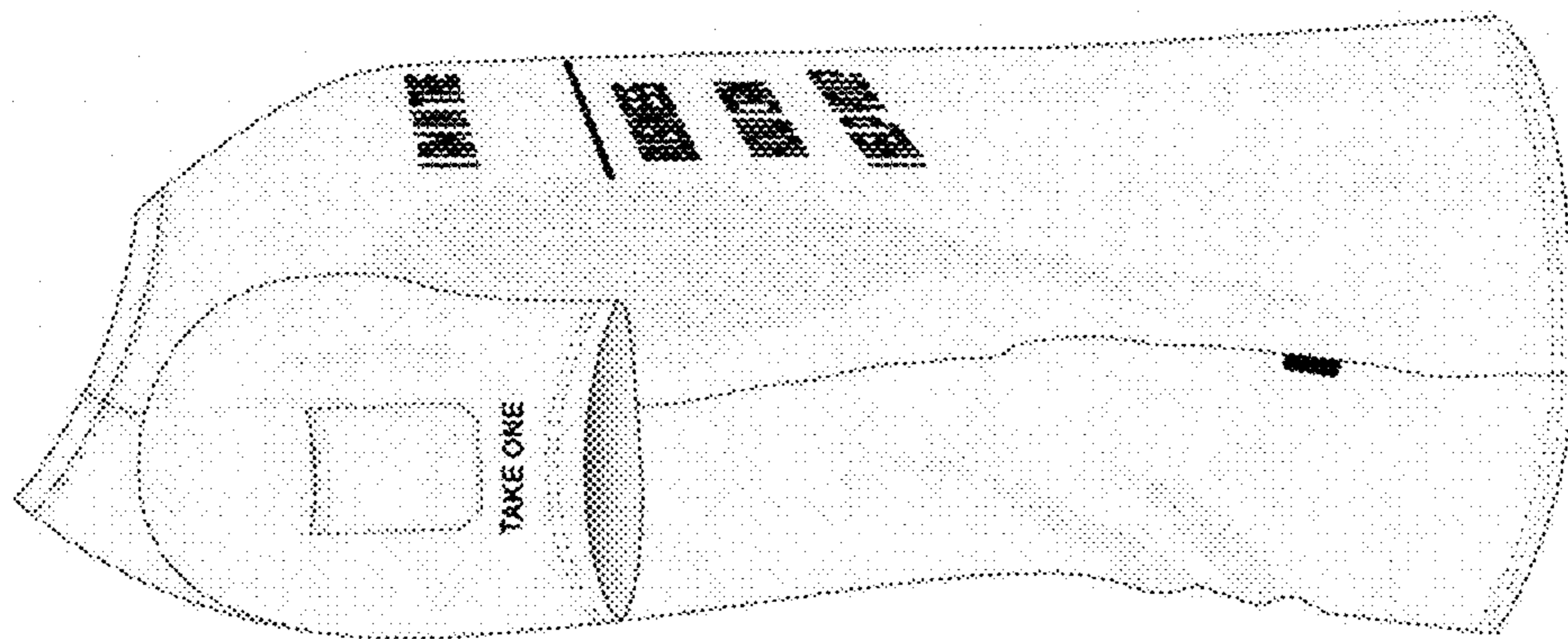

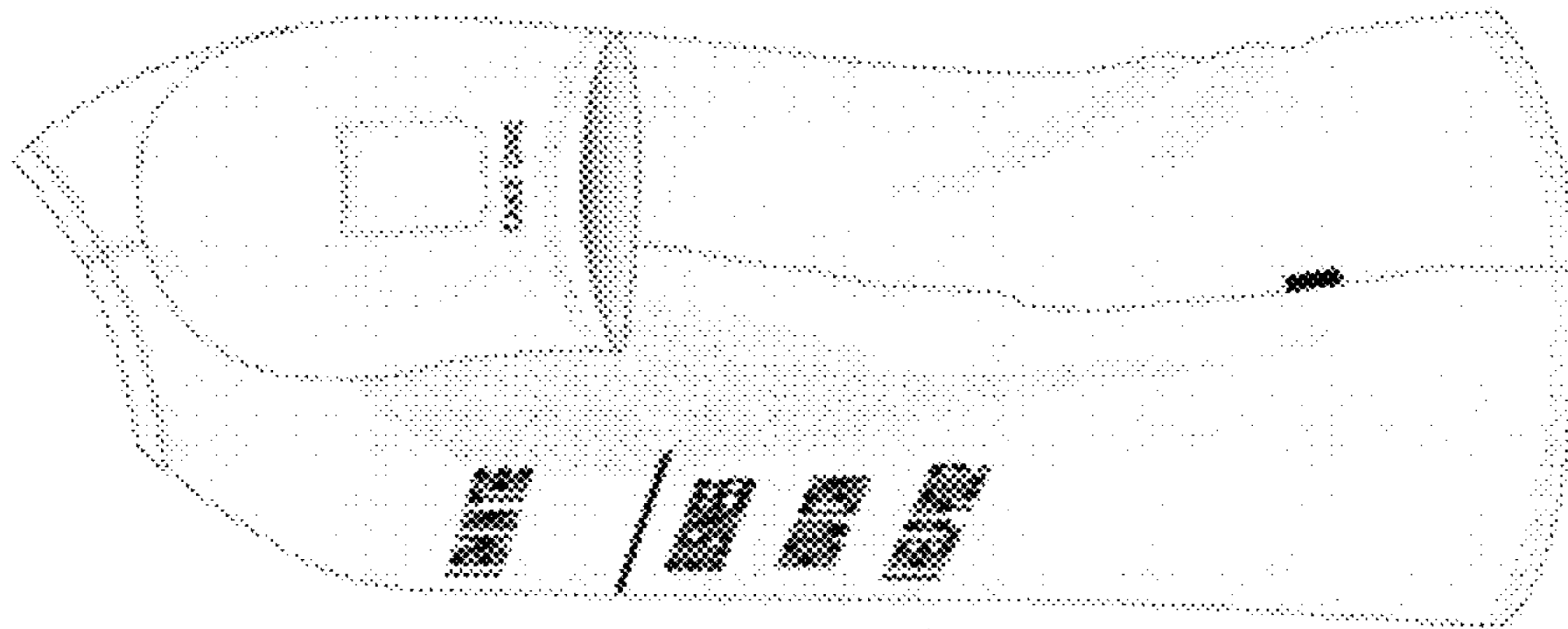

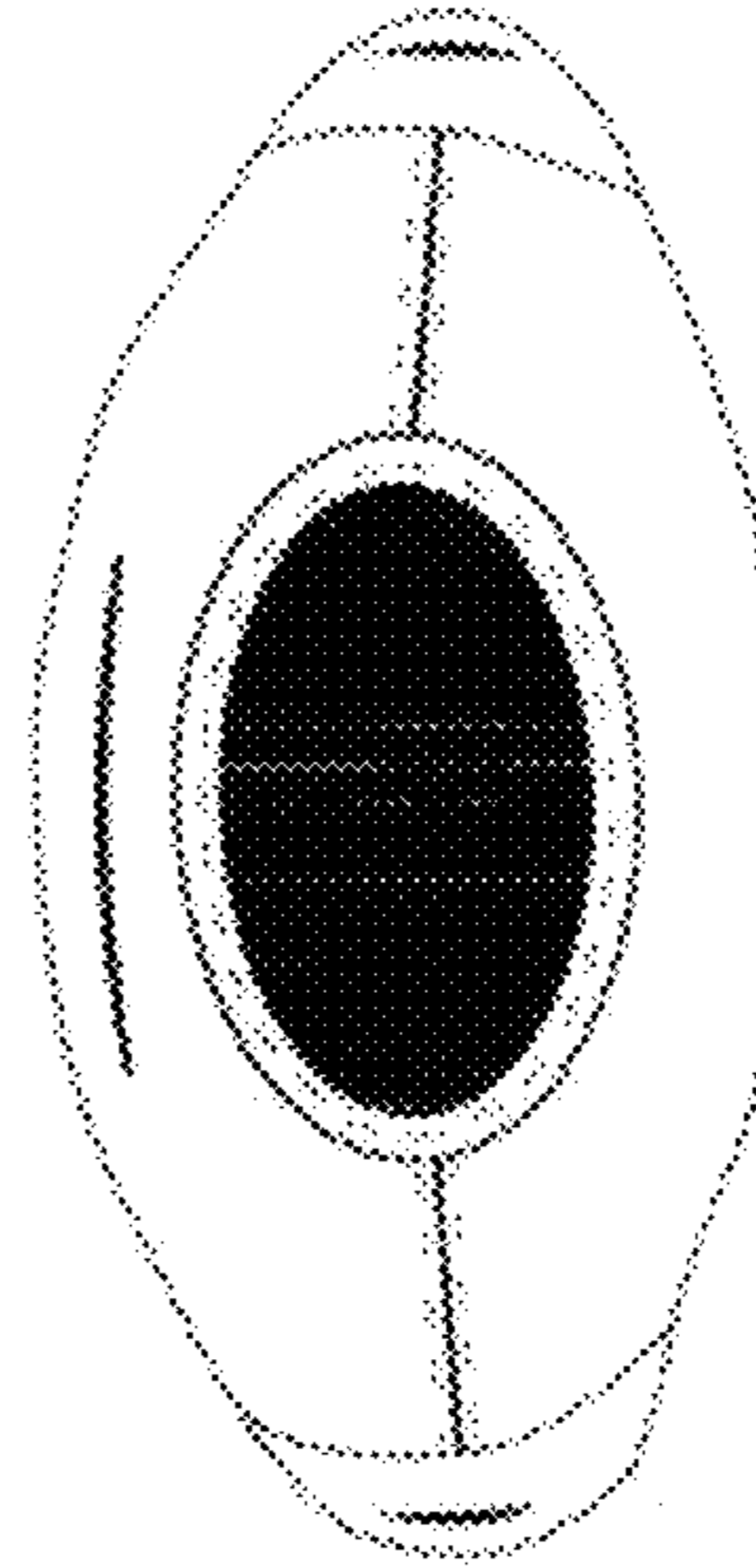

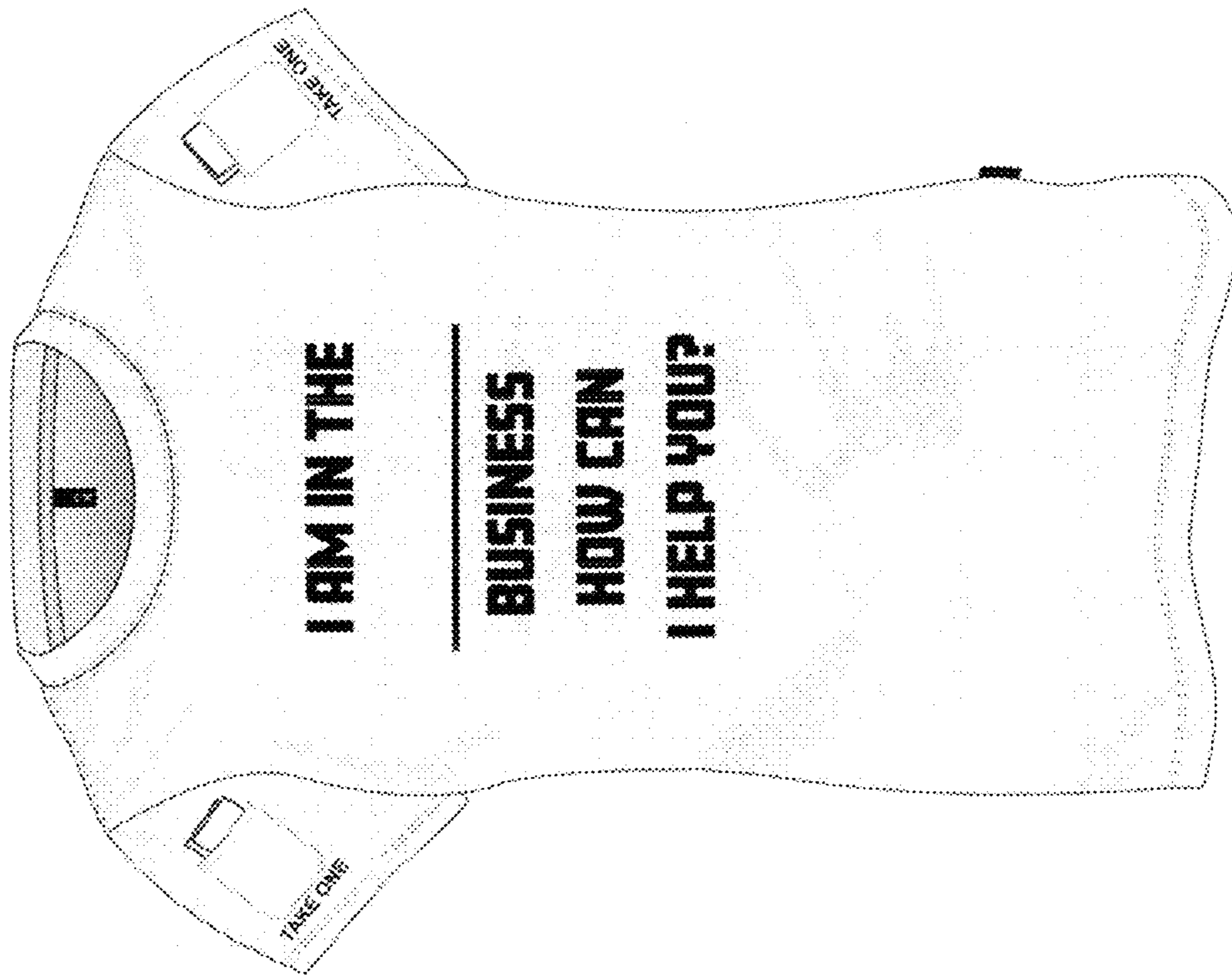

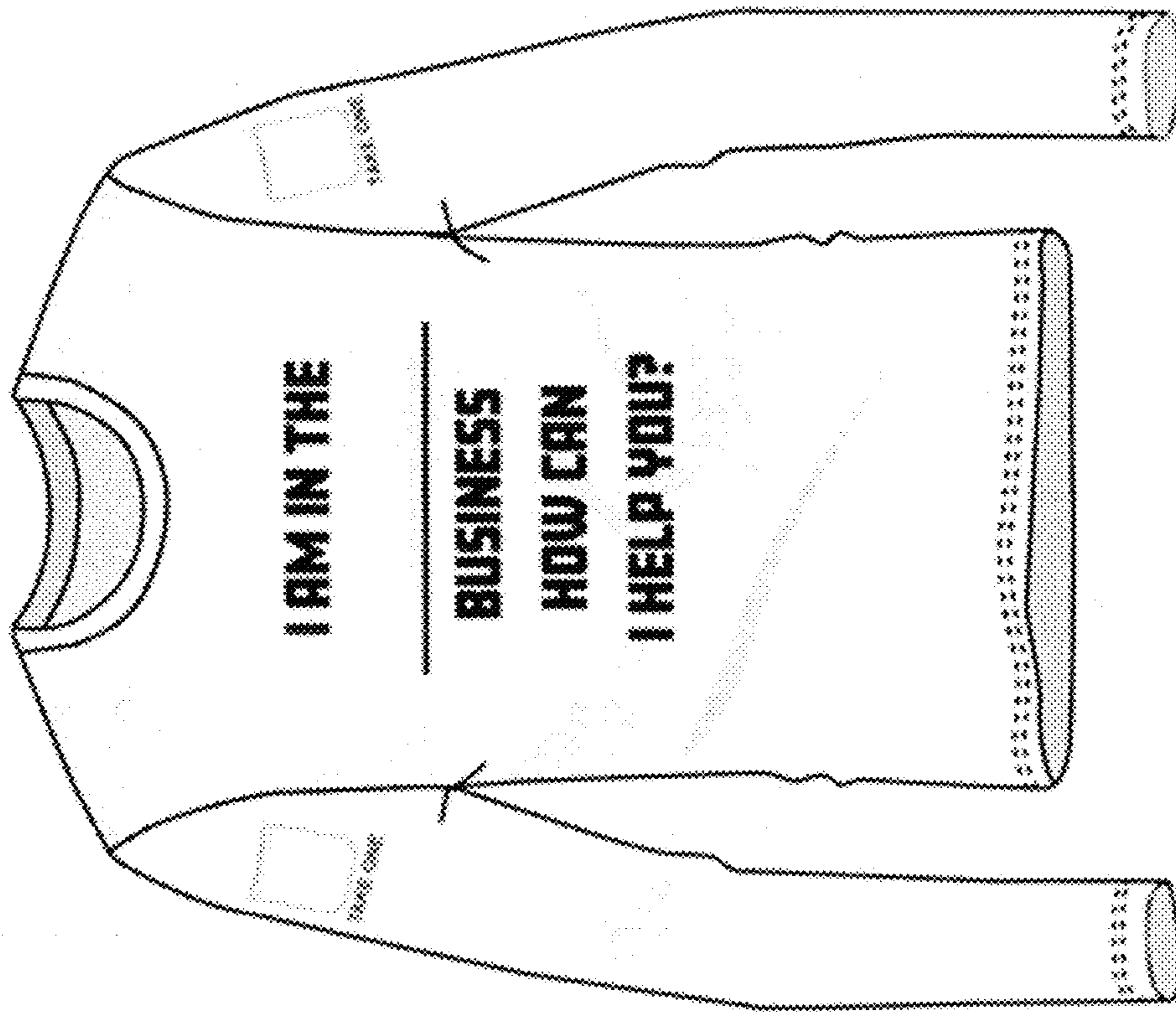

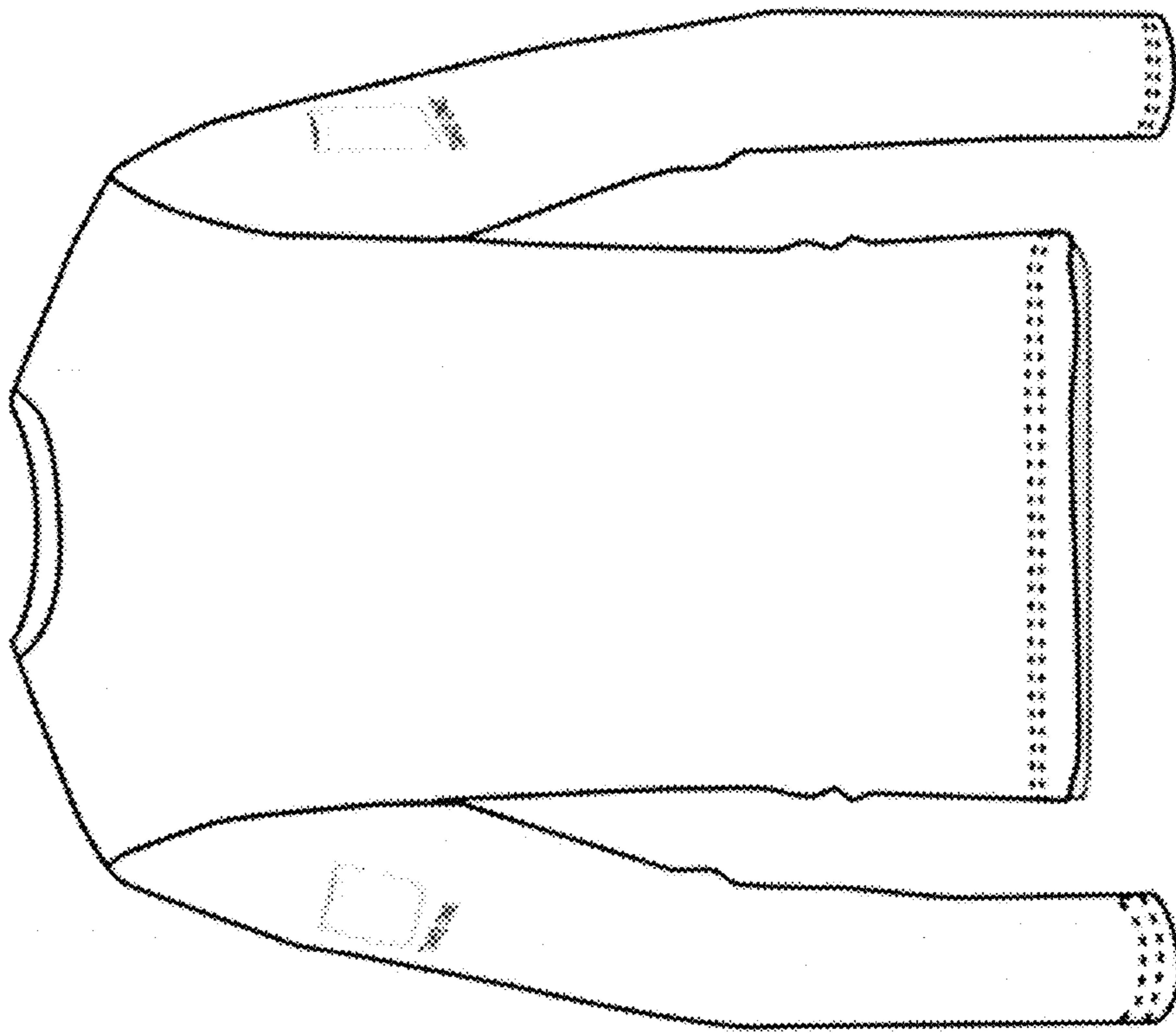

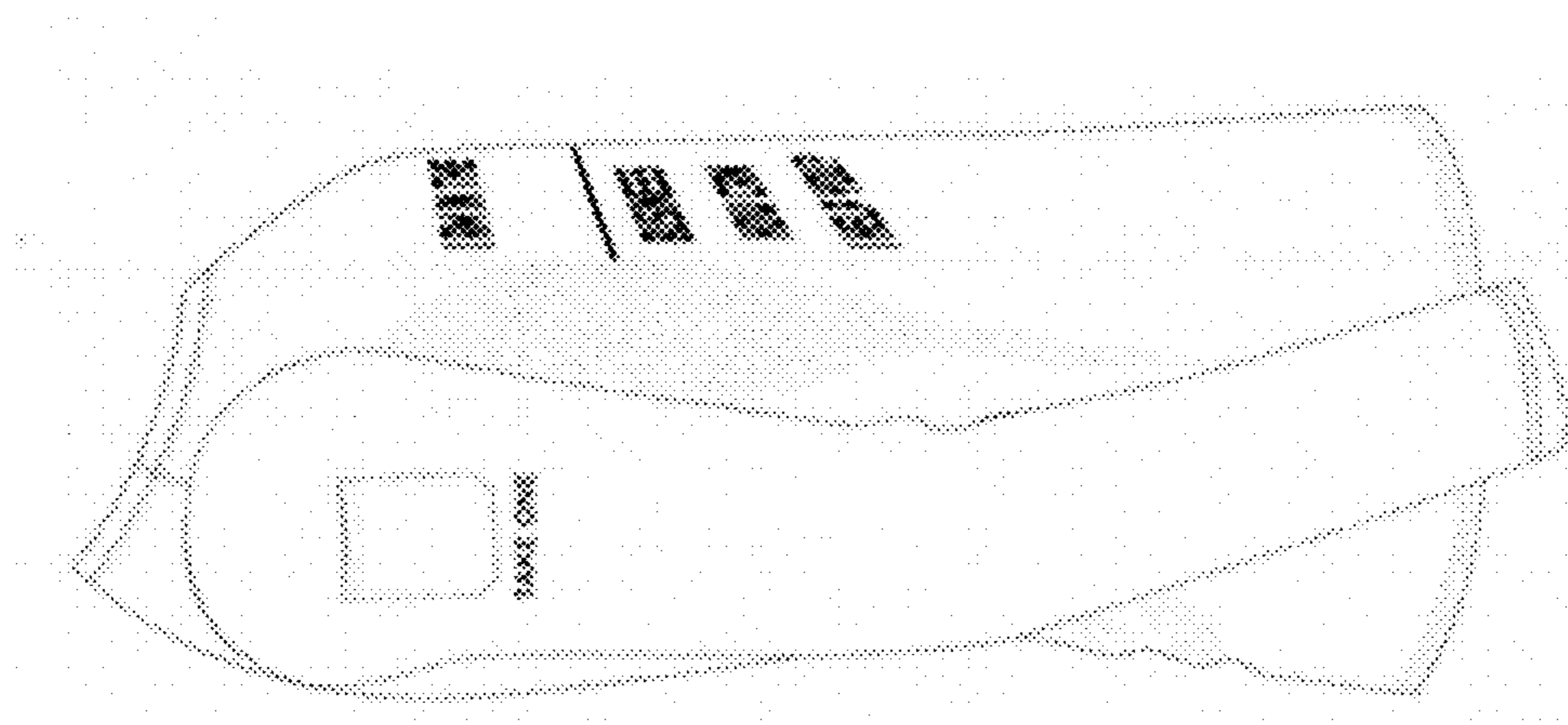


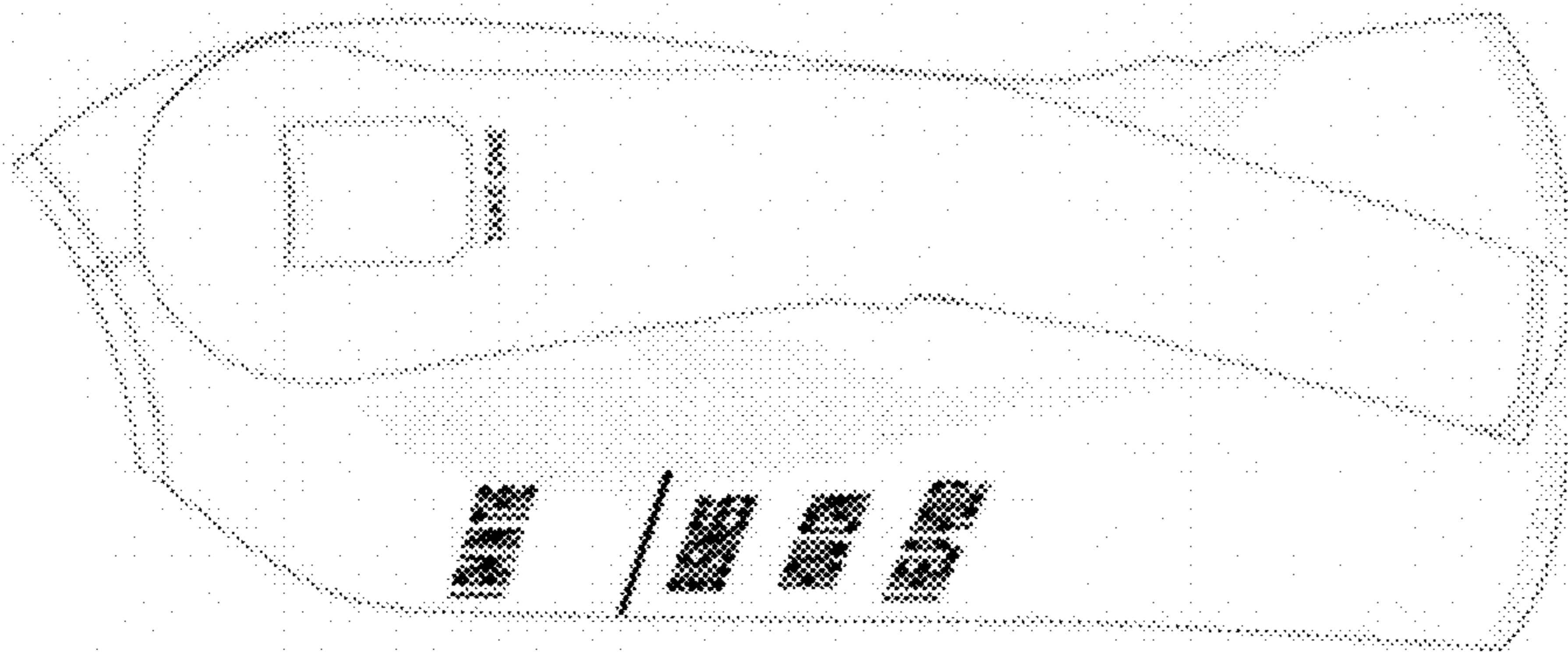

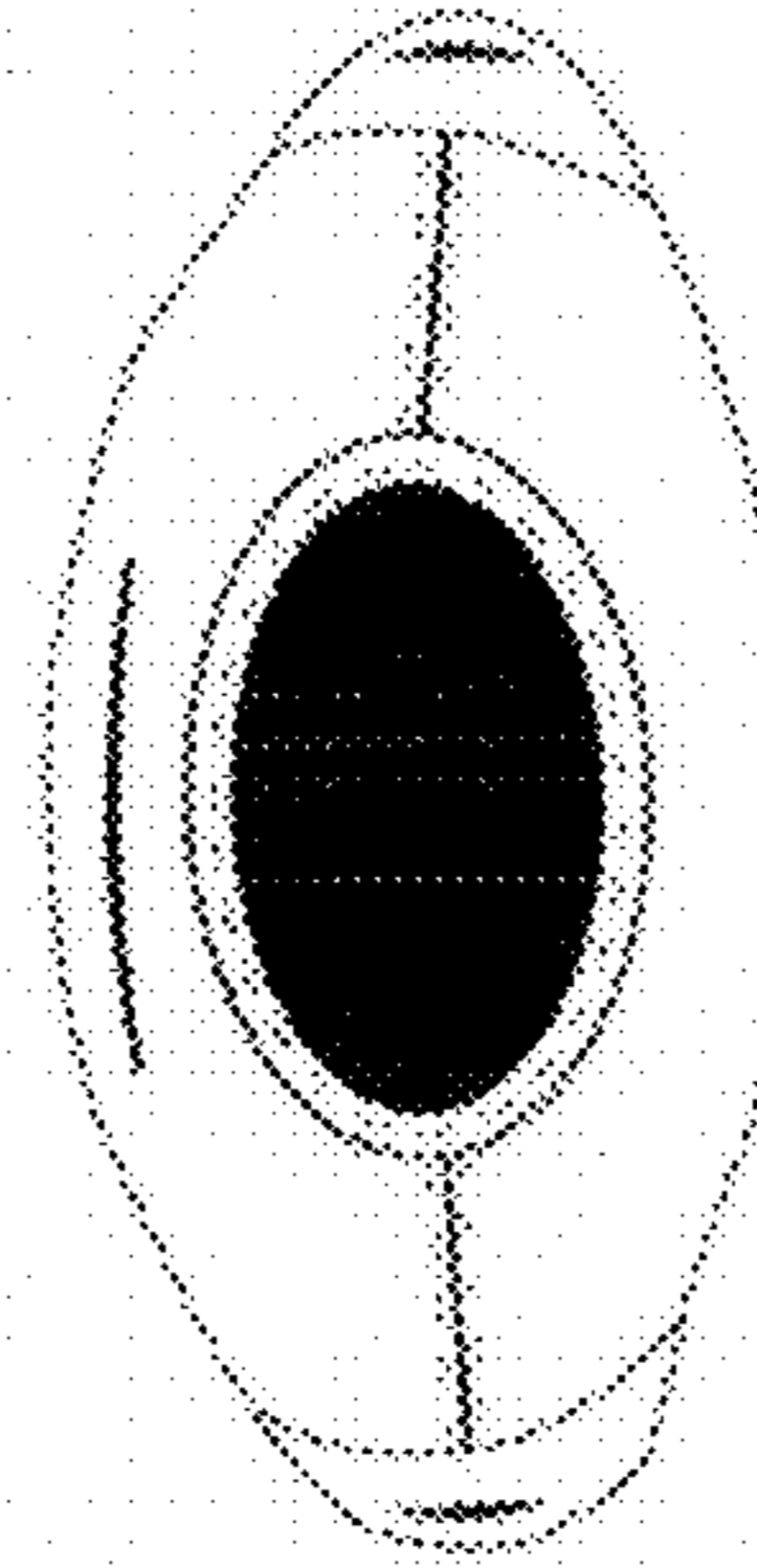
