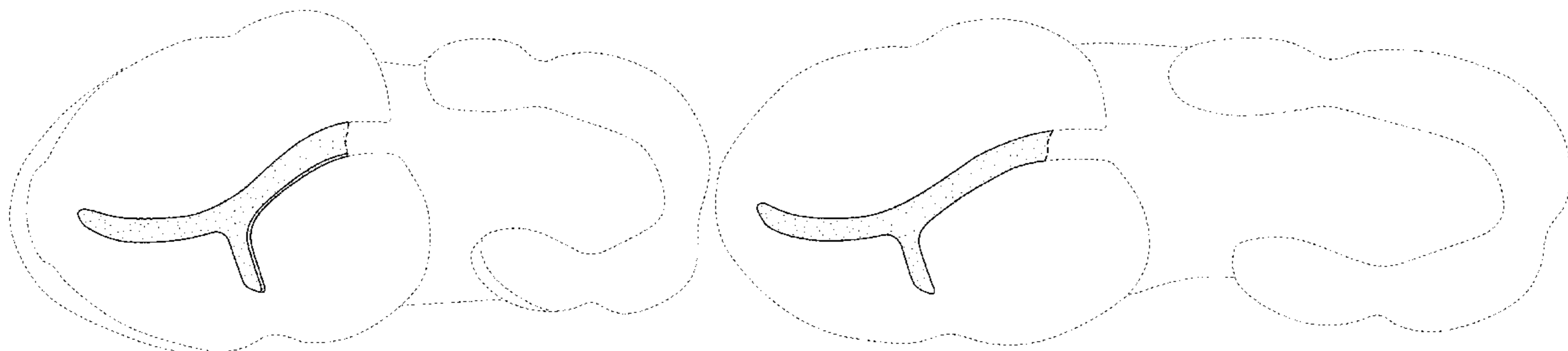
(57) **CLAIM**

I claim the ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front, bottom perspective view of a shoe, showing my new design;
FIG. 2 is a bottom view thereof; and,
FIG. 3 is a rear, bottom perspective view thereof.
The broken line adjacent to the shaded area represents an unclaimed boundary of the claimed design. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

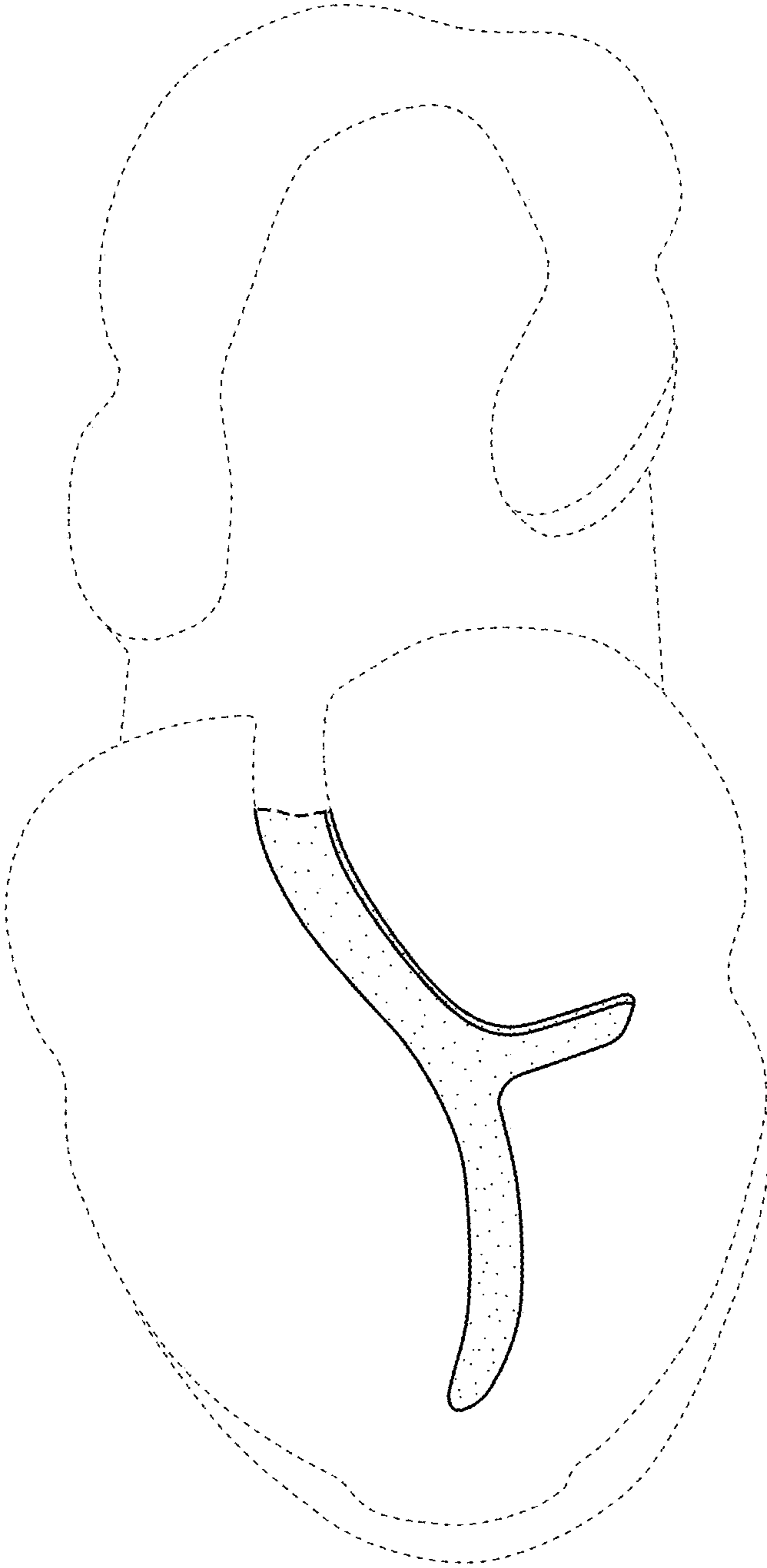

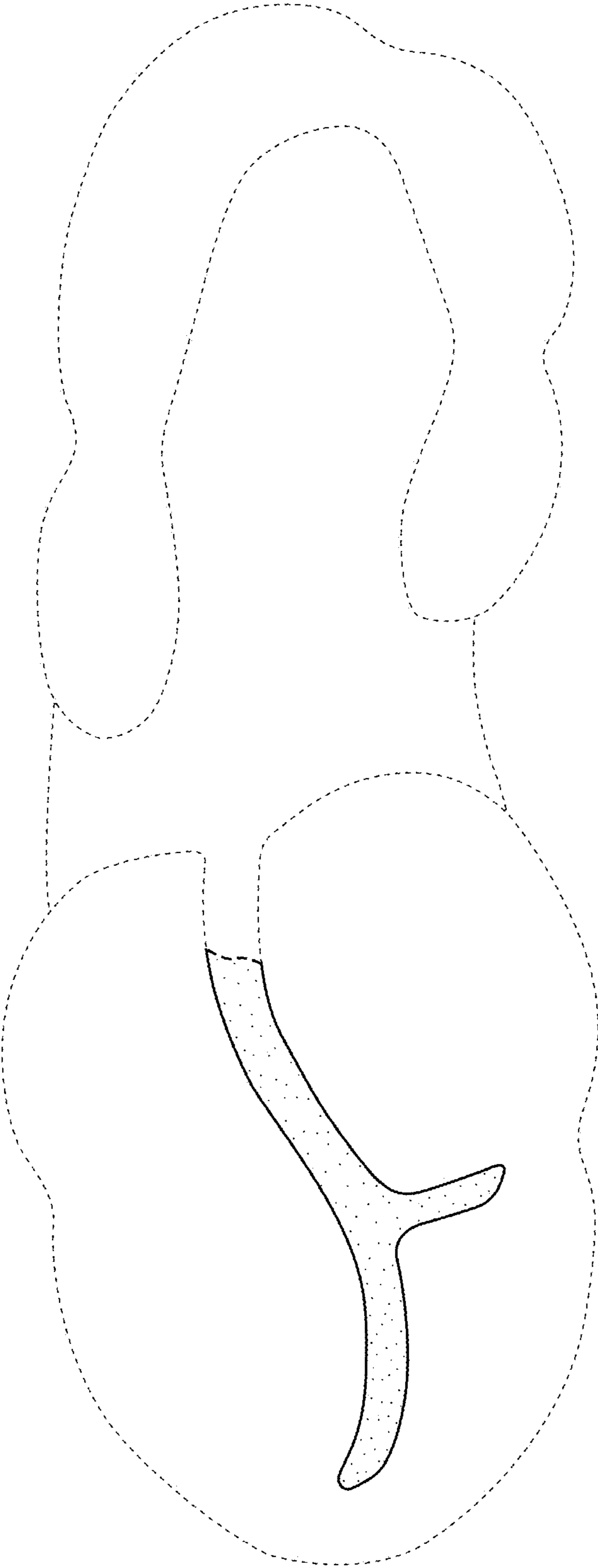

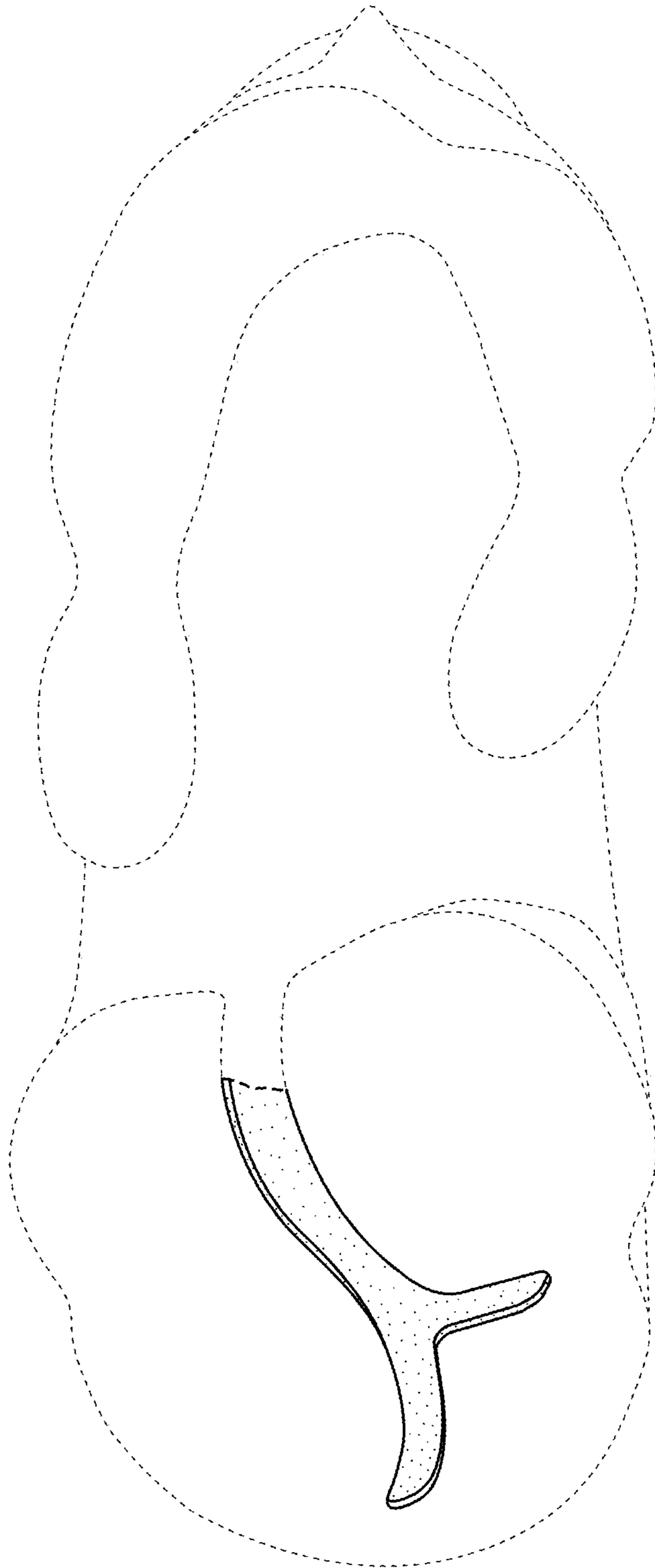
