DESCRIPTION

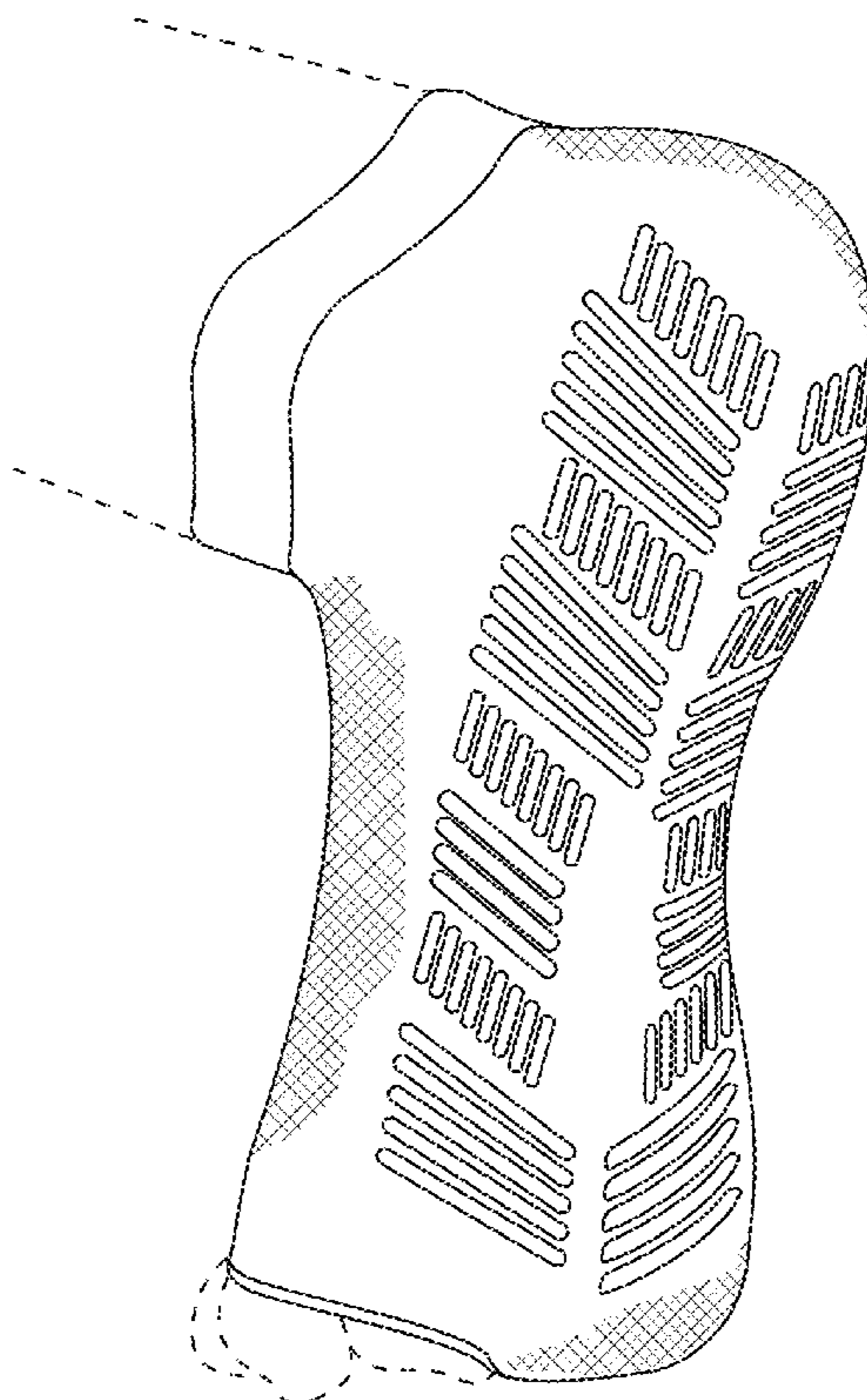
FIG. 1 is a perspective view of the bottom of the claimed design for a split-toe exercise sock;

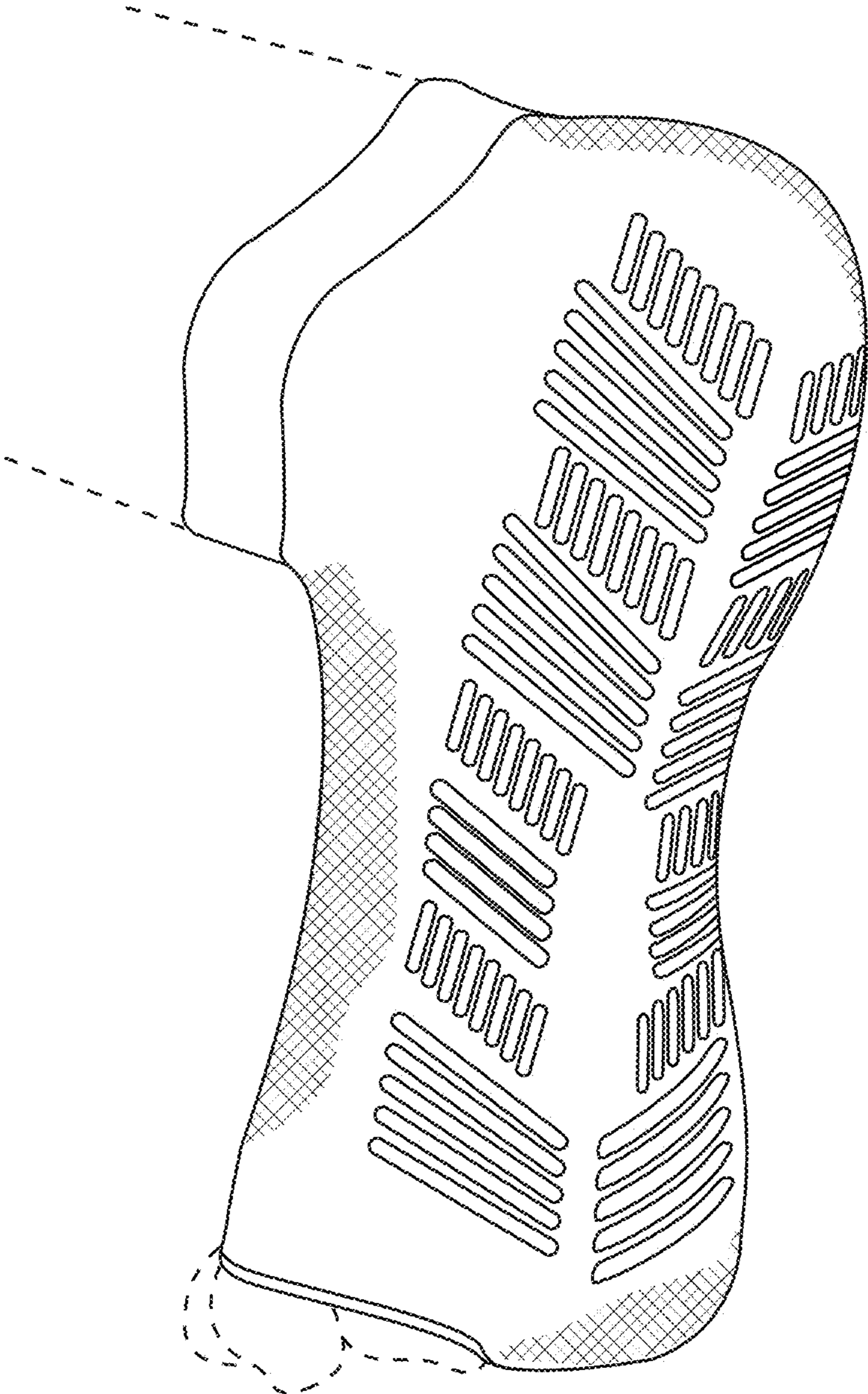

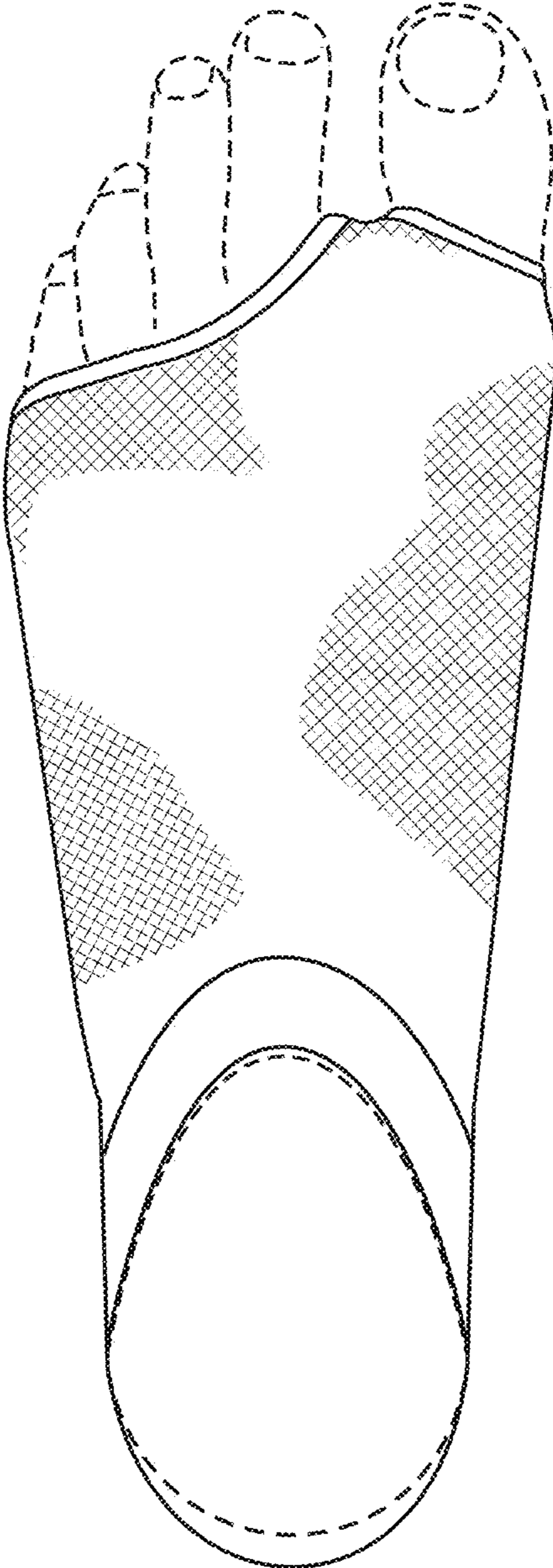

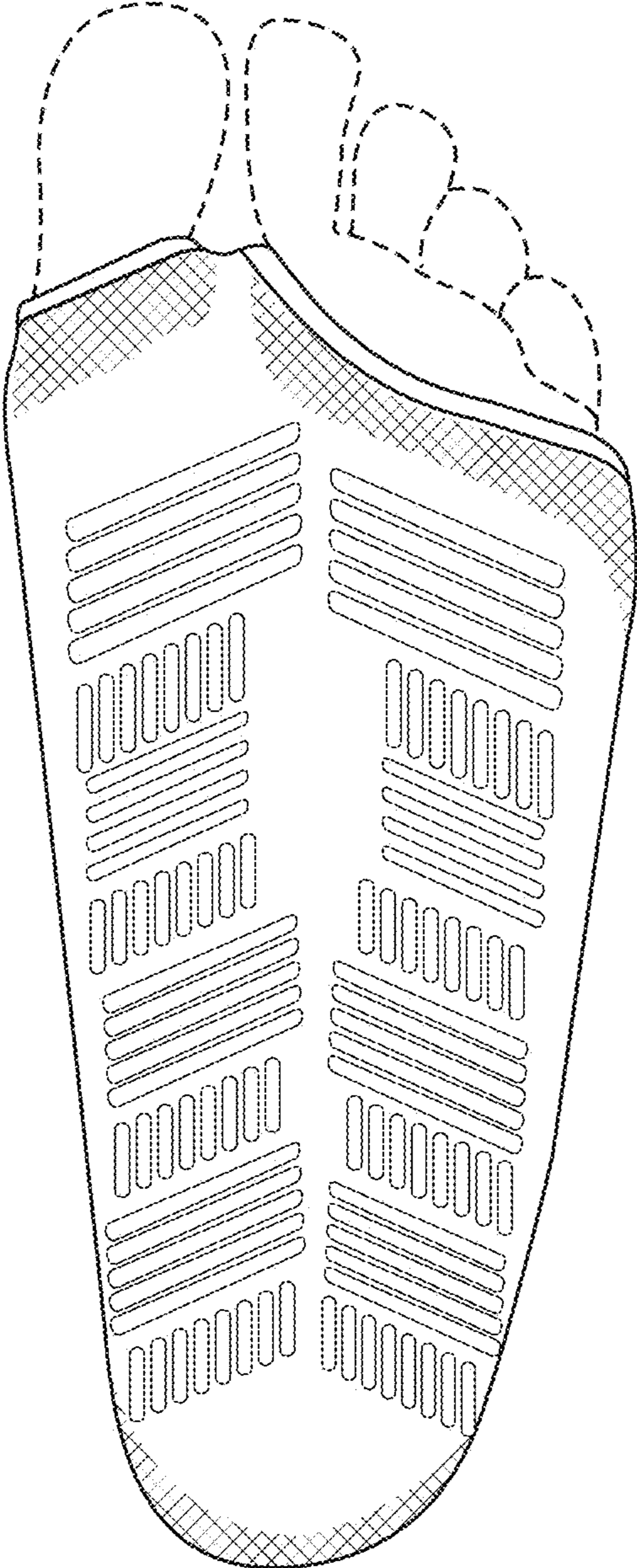

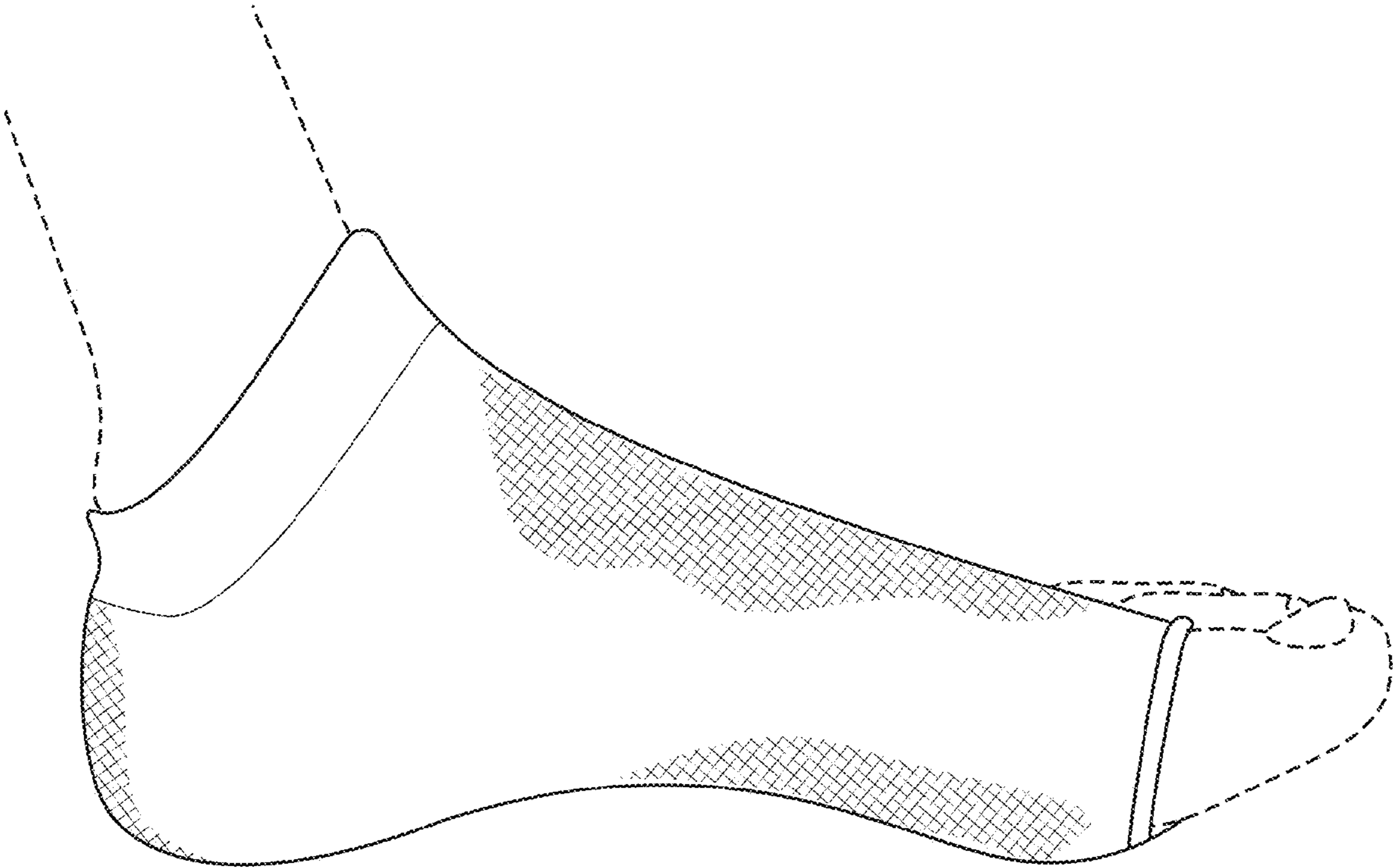

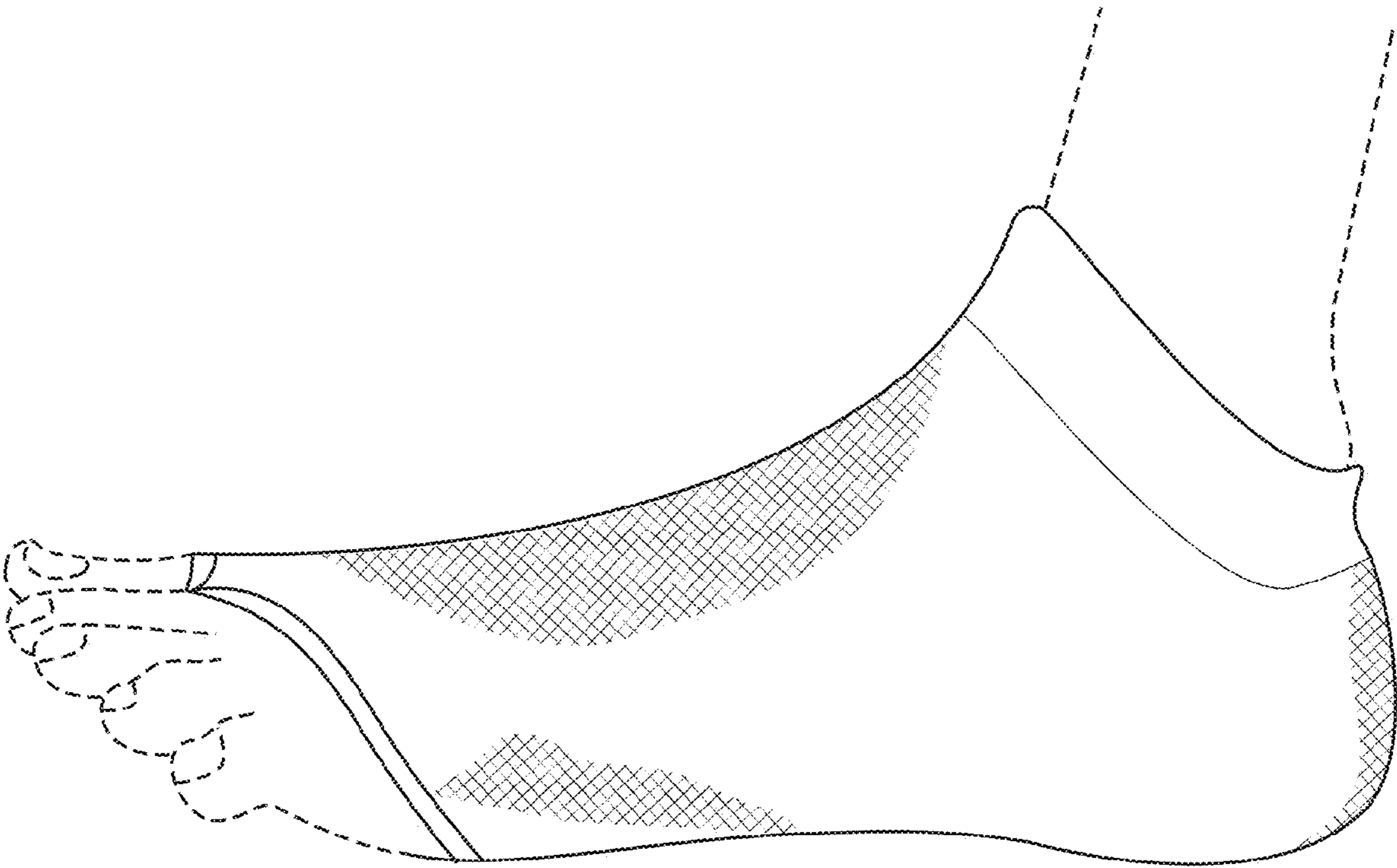

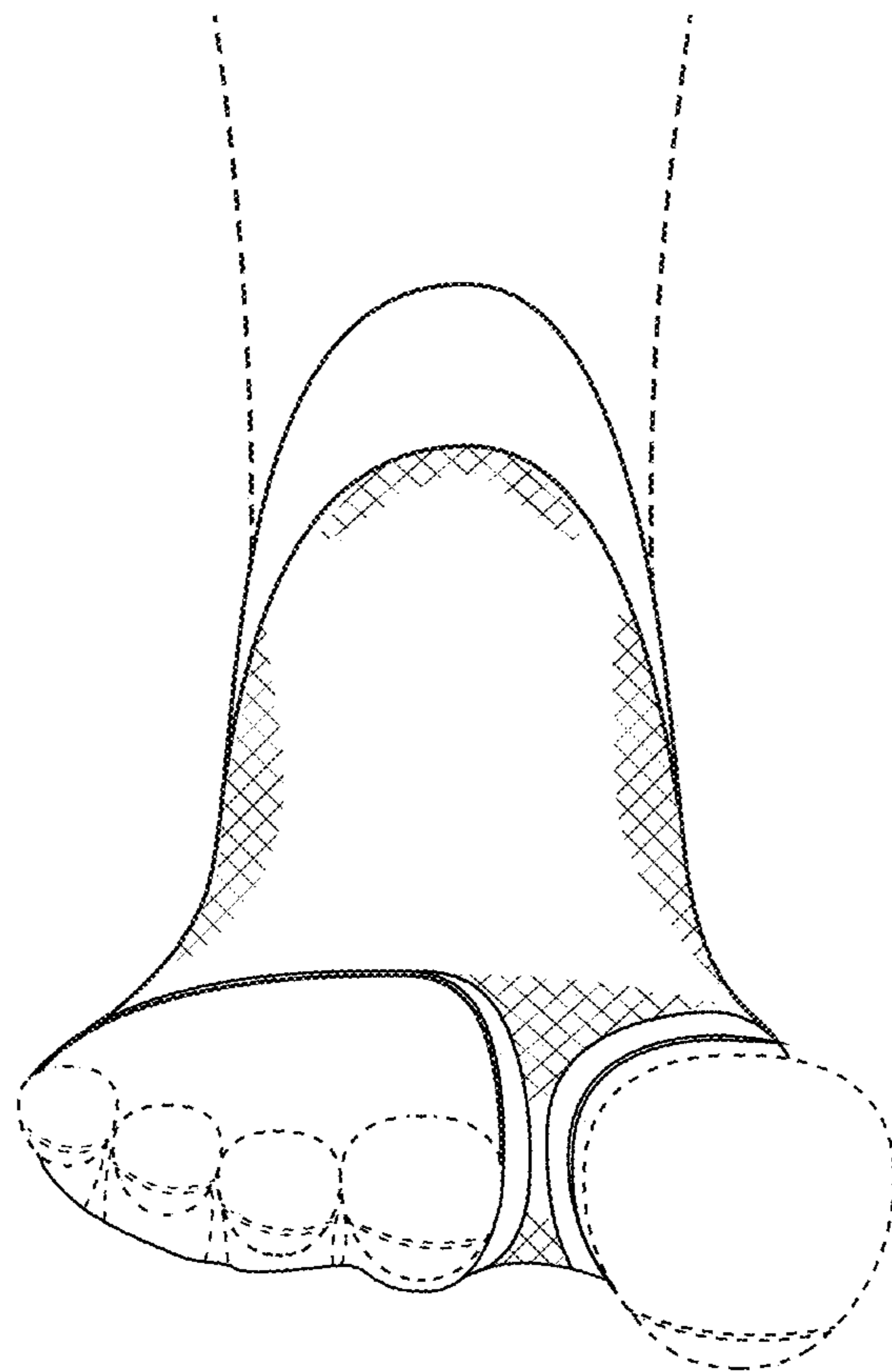

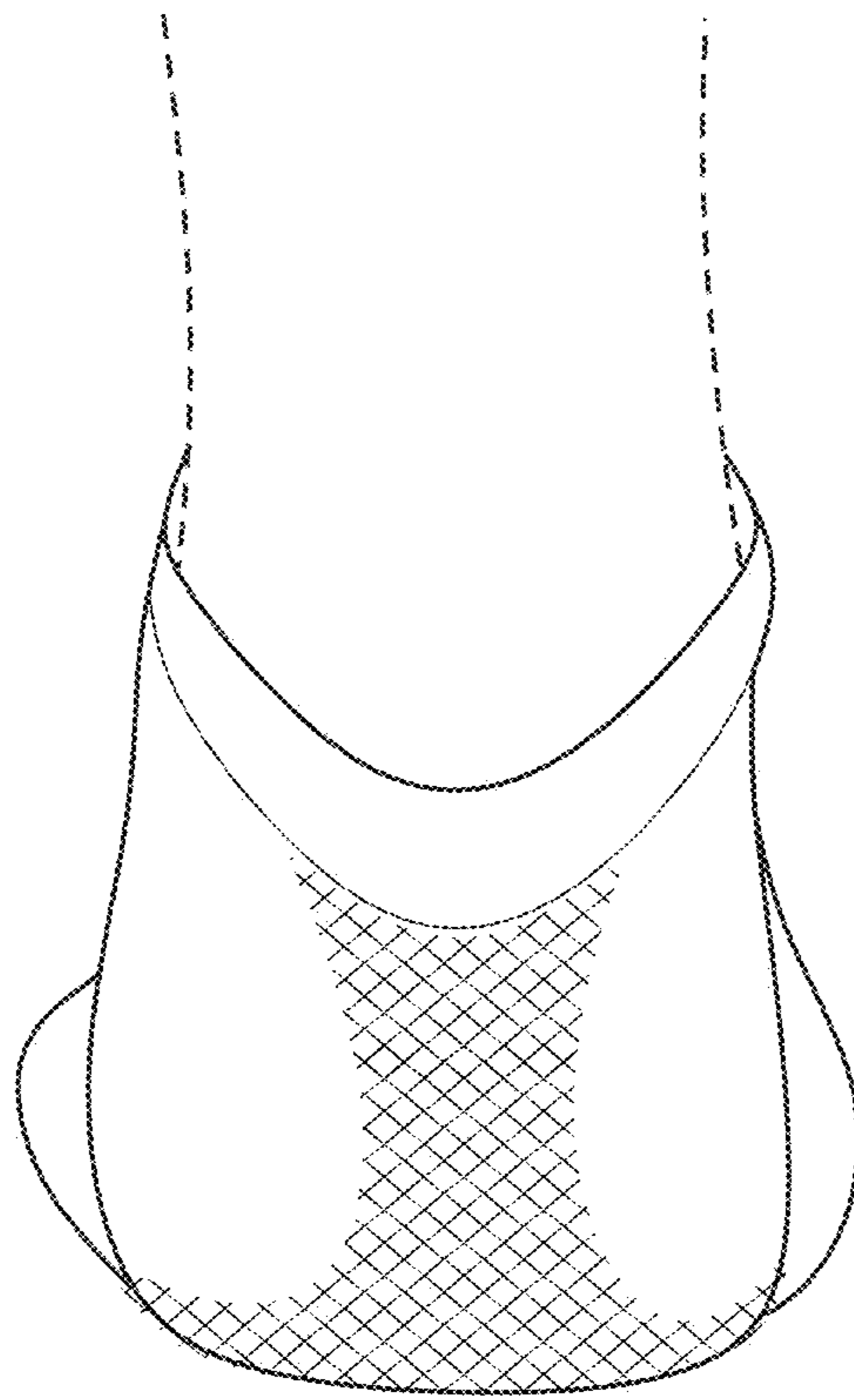
