(57) **CLAIM**

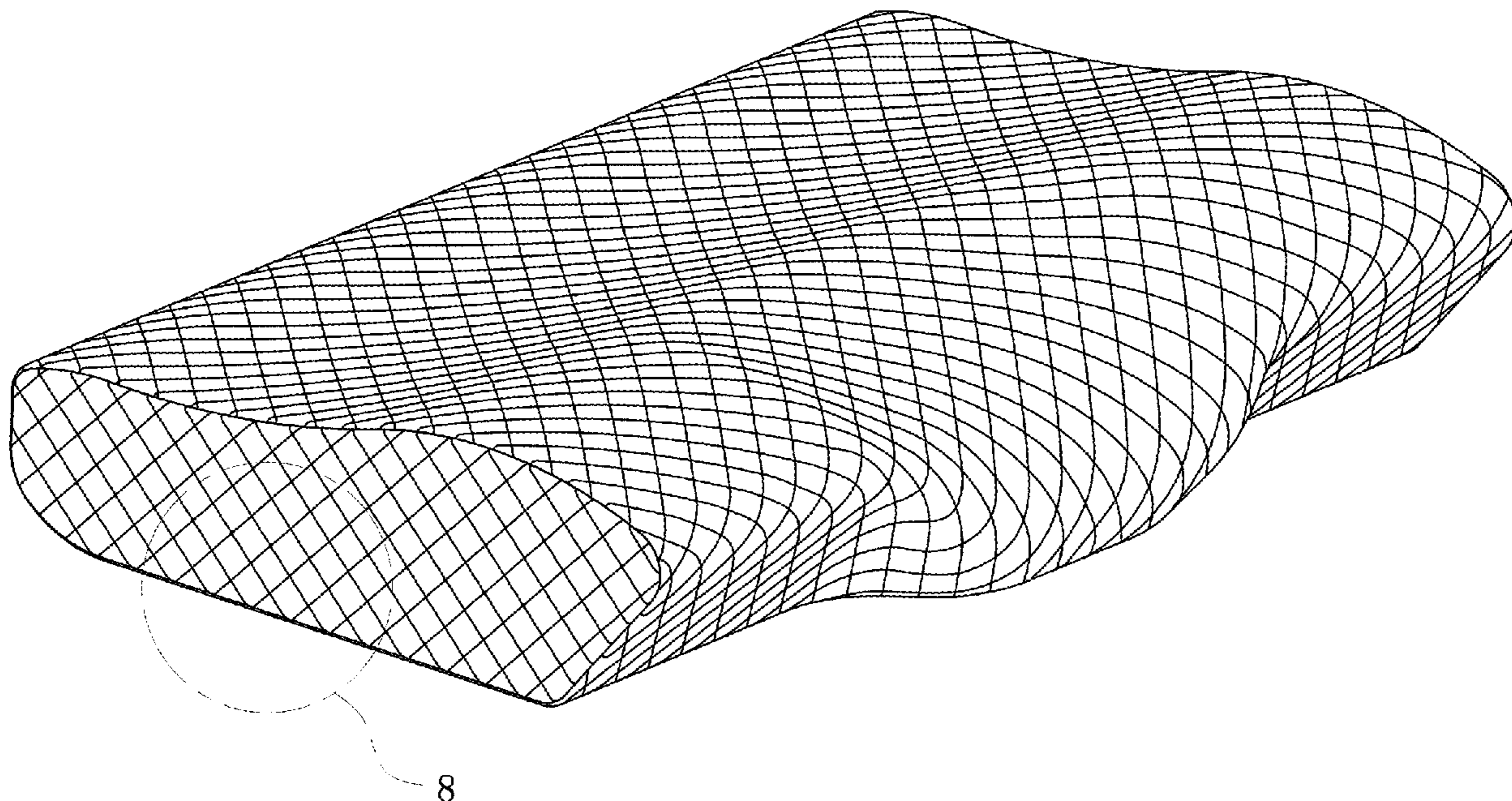
The ornamental design for a shaped pillow, as shown and described.

DESCRIPTION

FIG. 1 is a front, left side, top perspective view of a shaped pillow showing my new design;

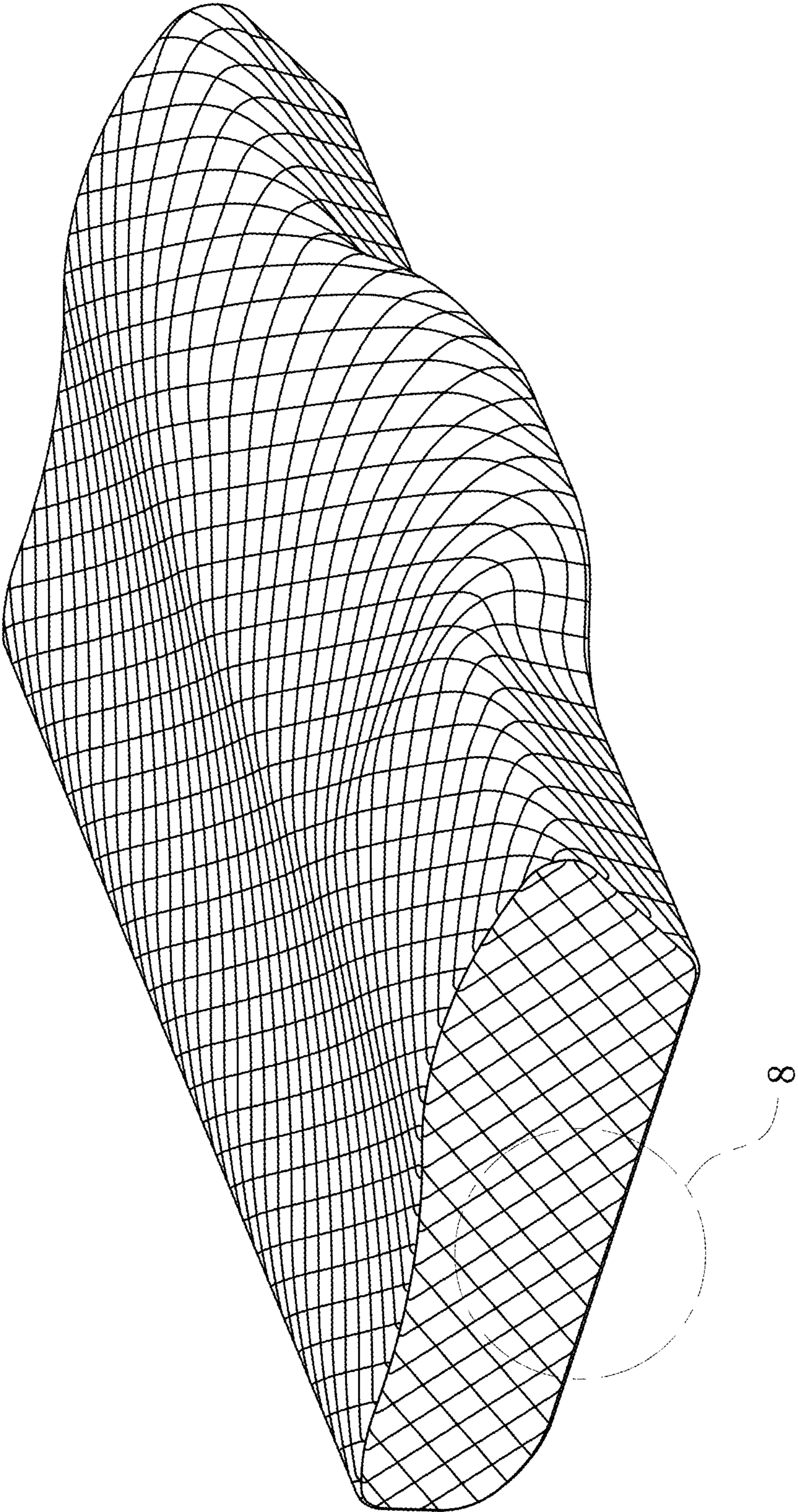

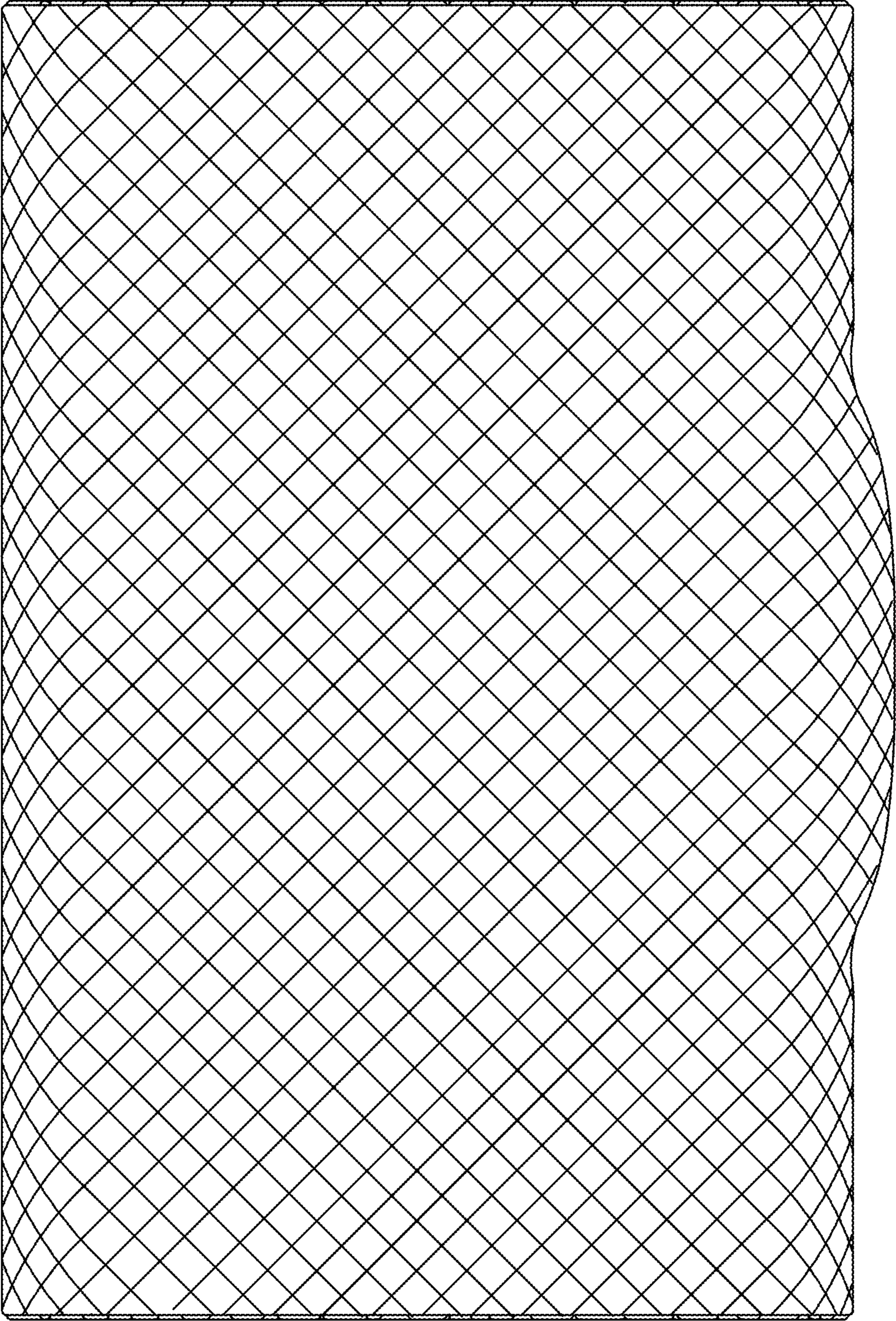

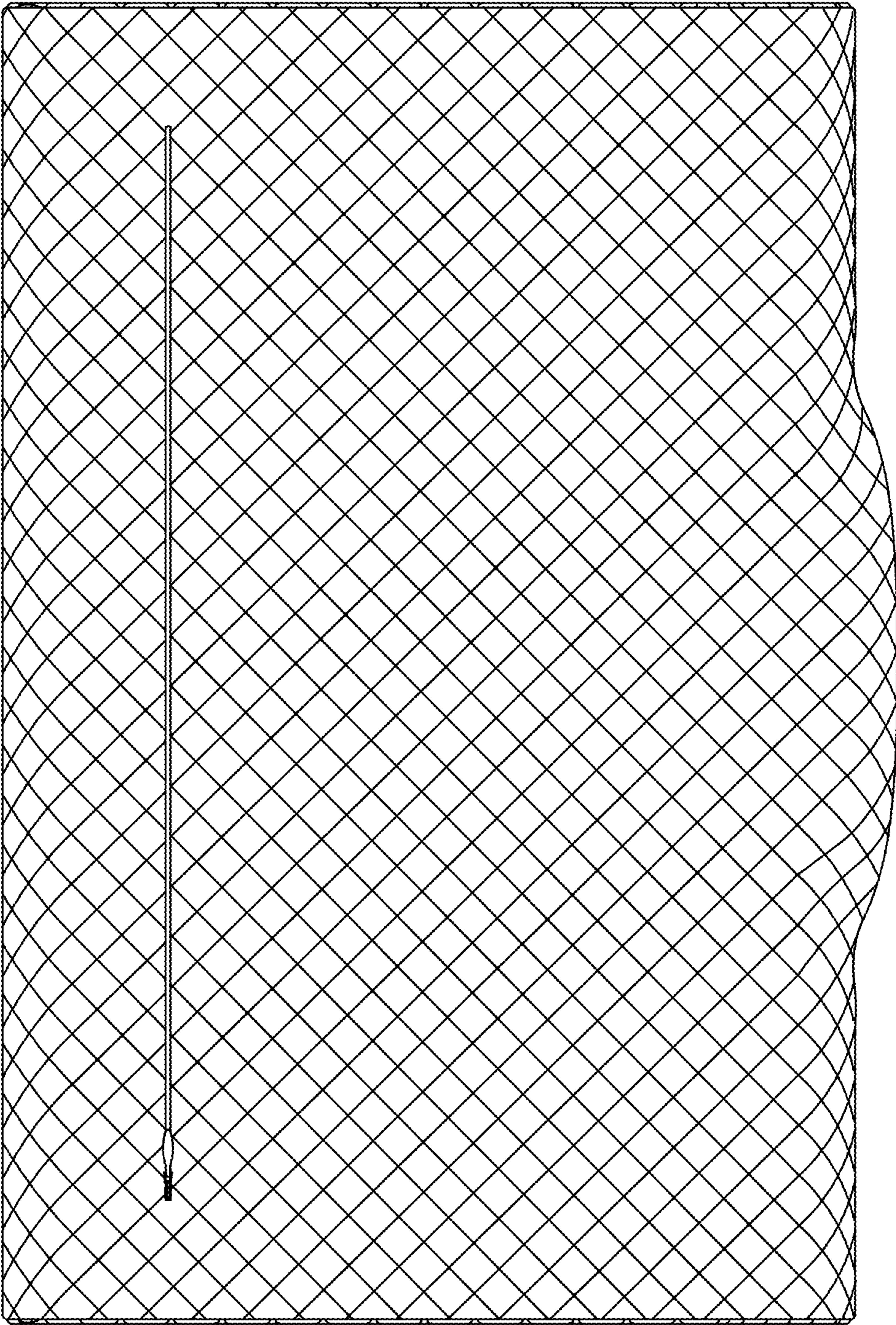

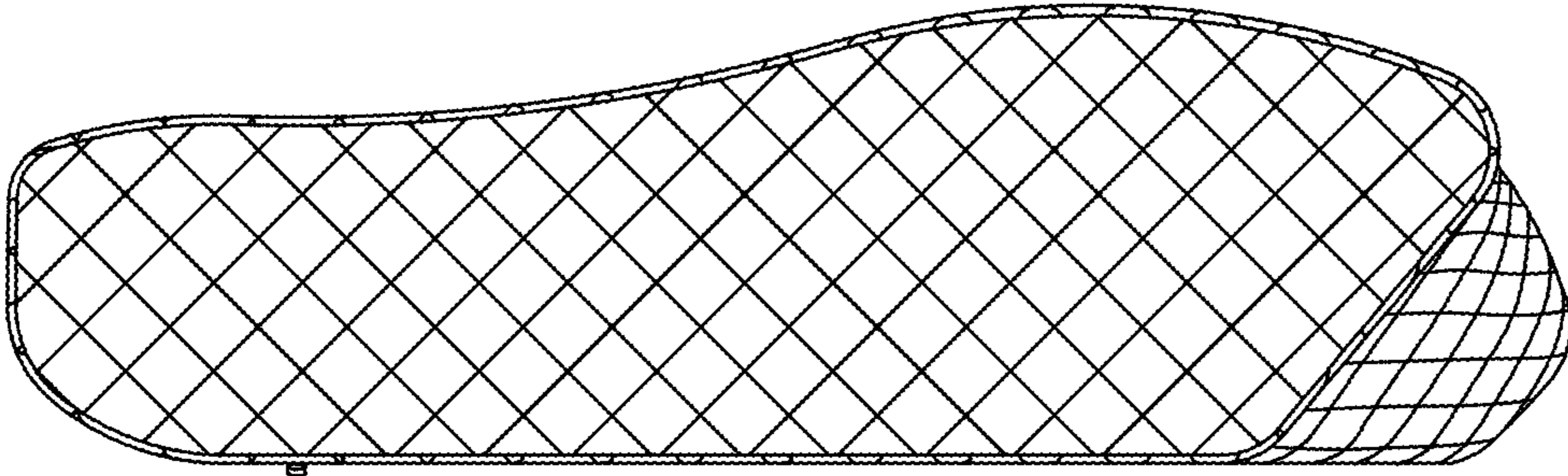

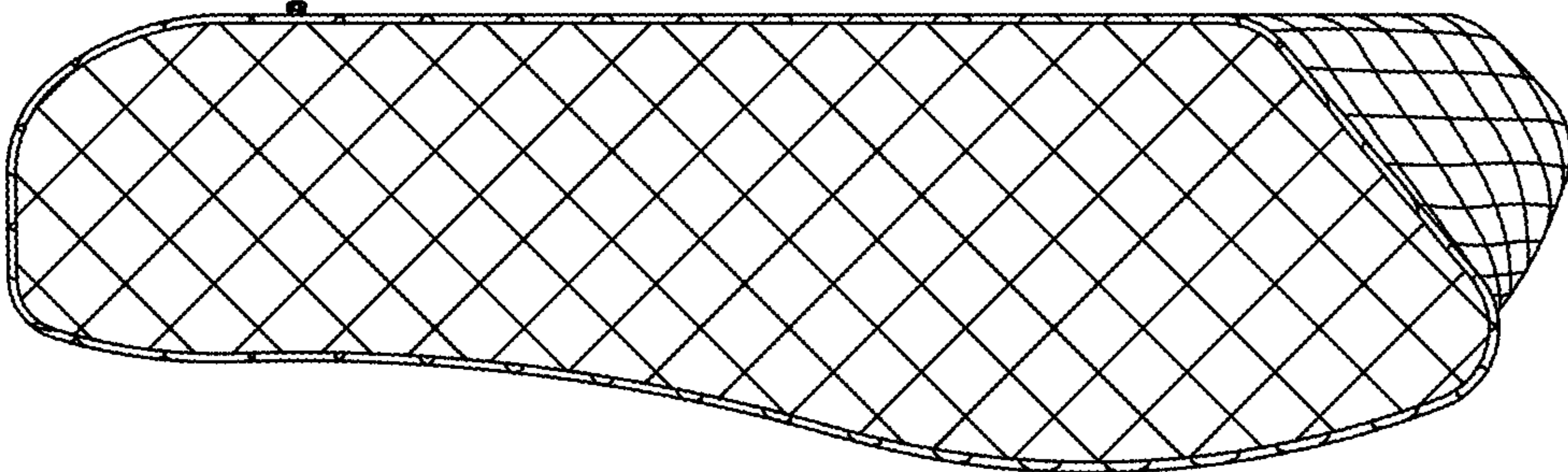

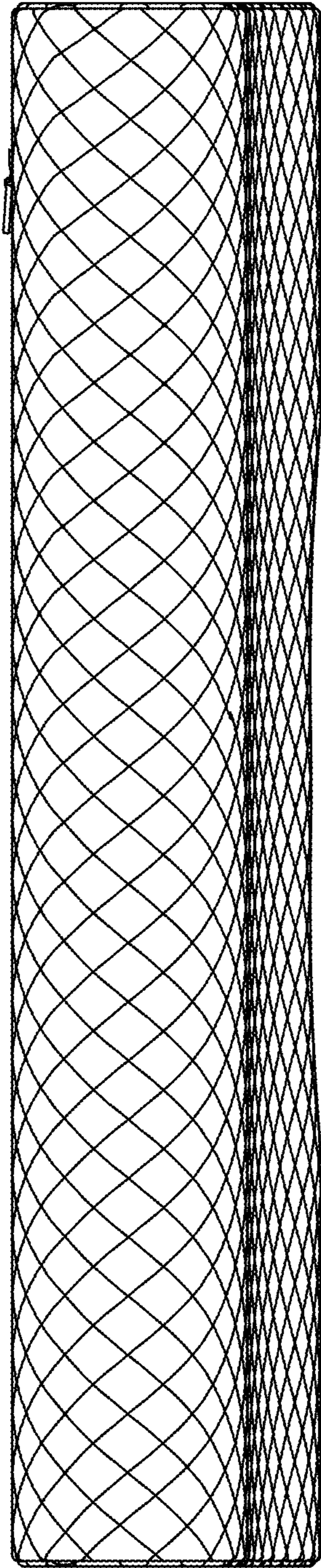

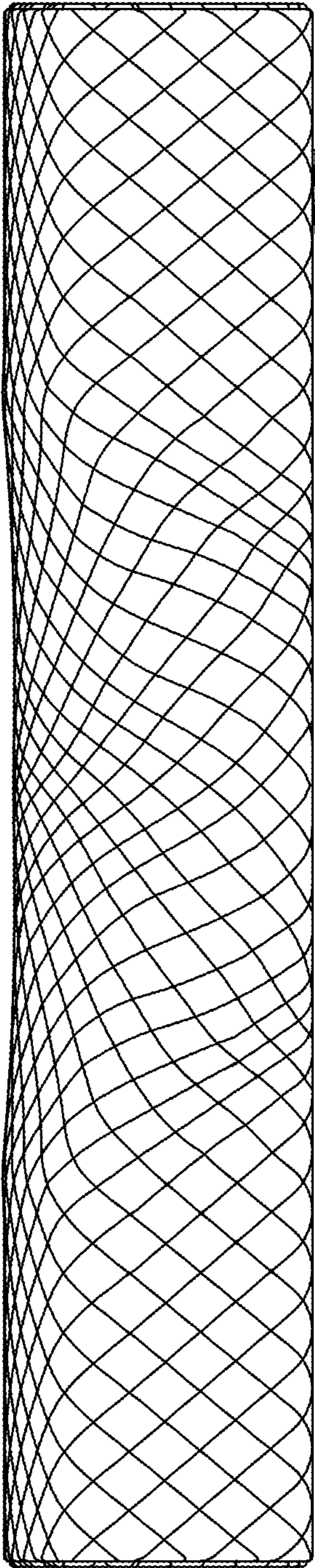

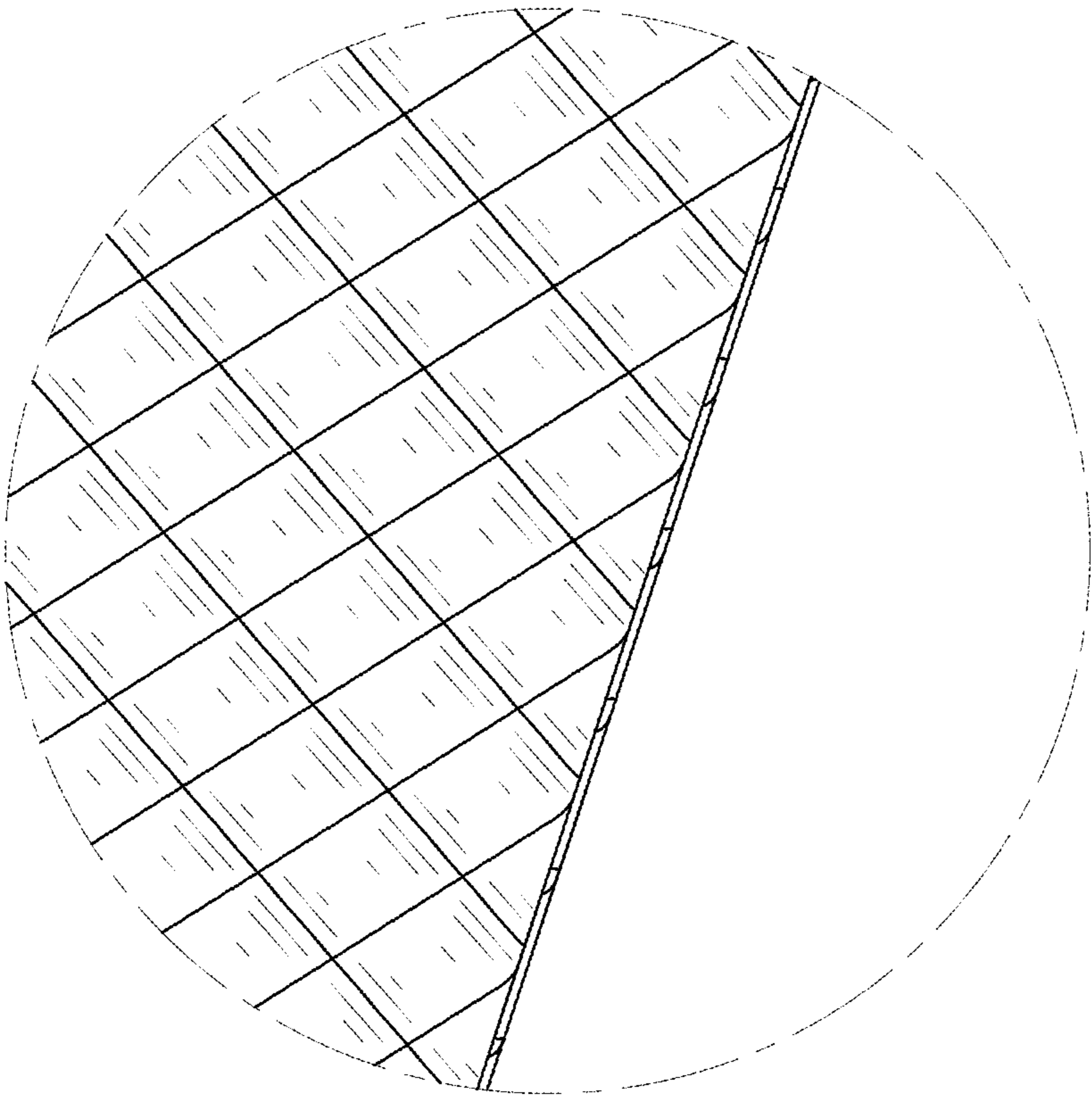
