FIG. 3 is a rear view of the electric grinder of FIG. 1.

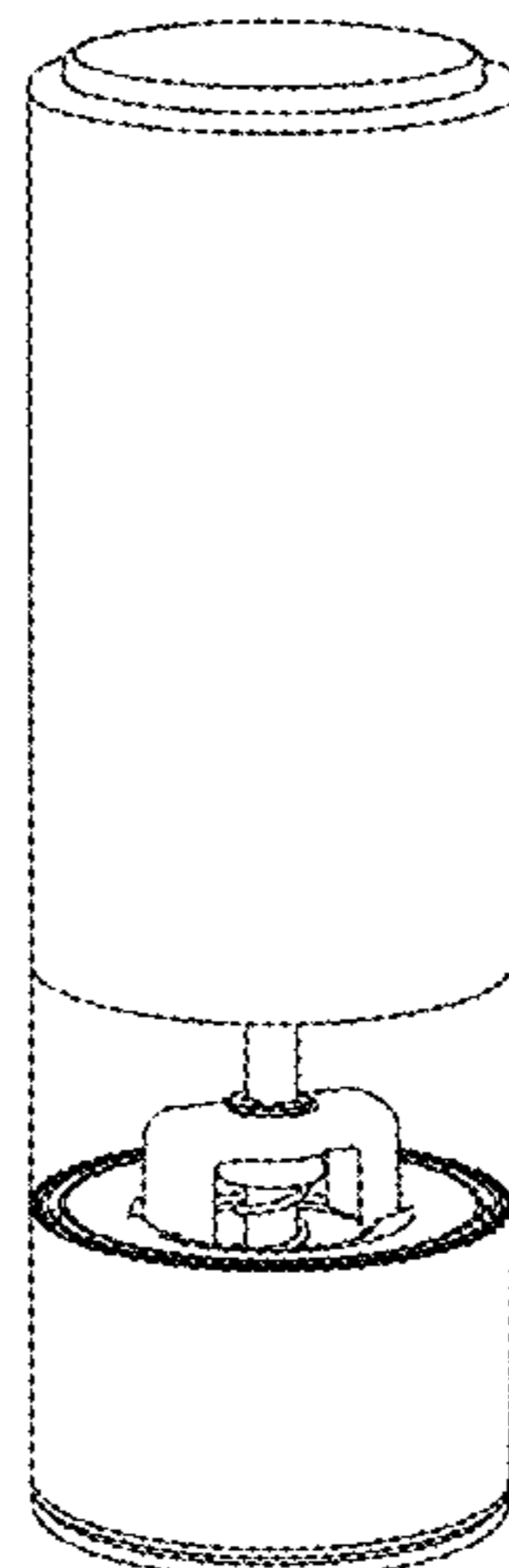
FIG. 4 is a side view of the electric grinder of FIG. 1.

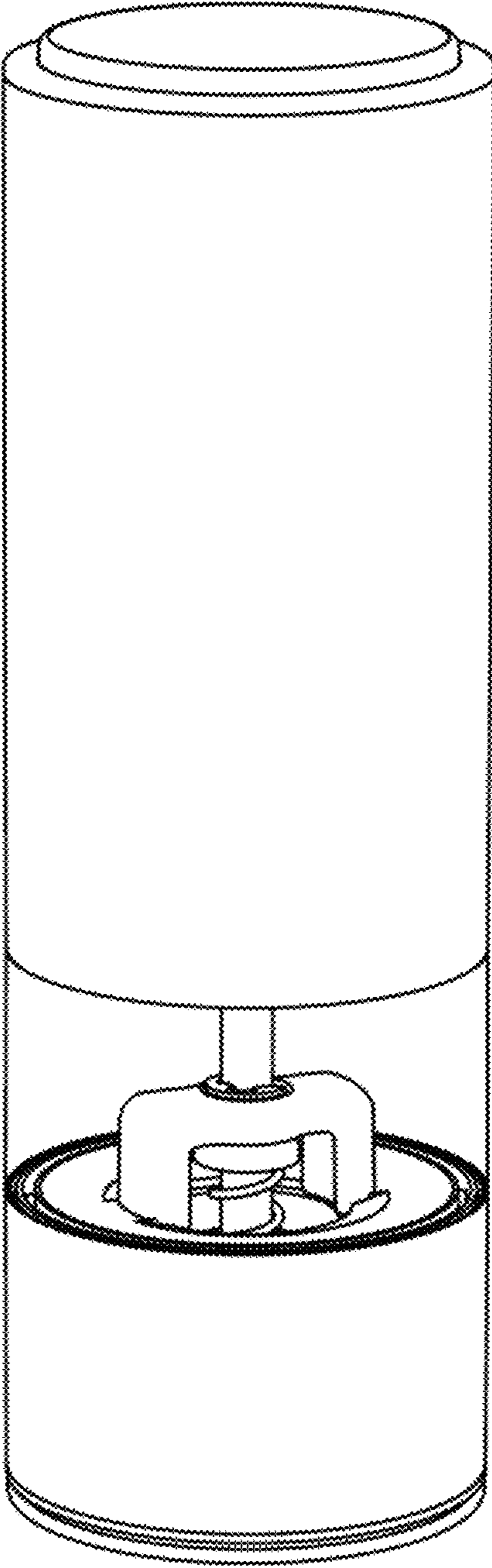

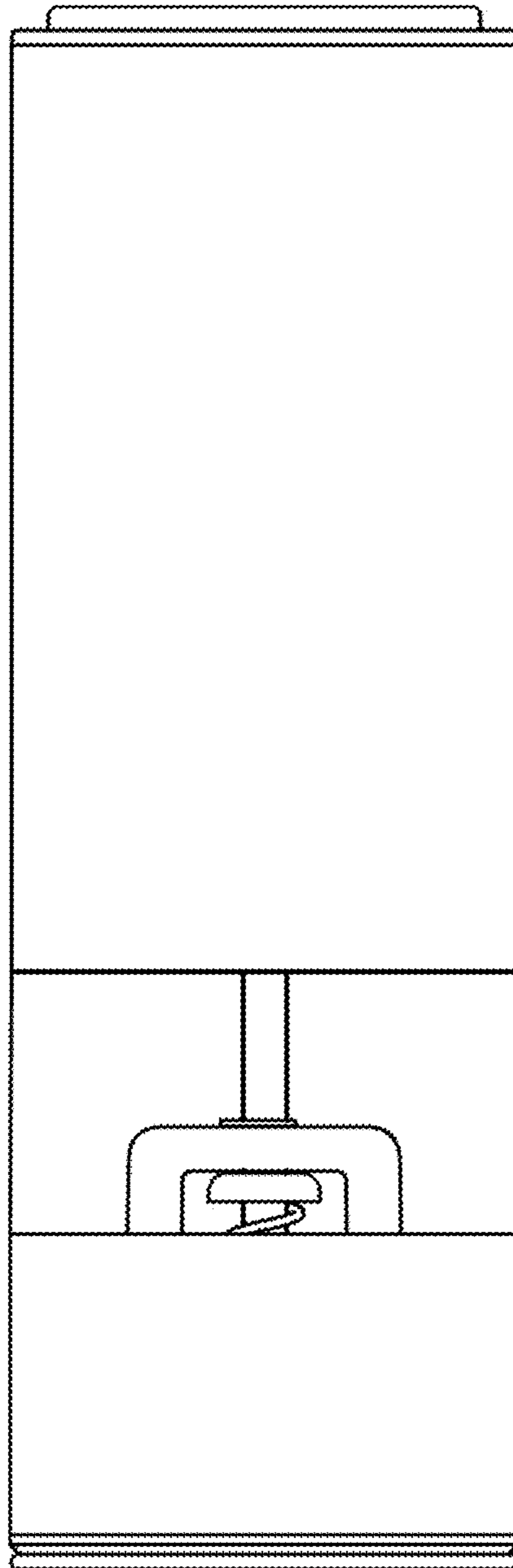

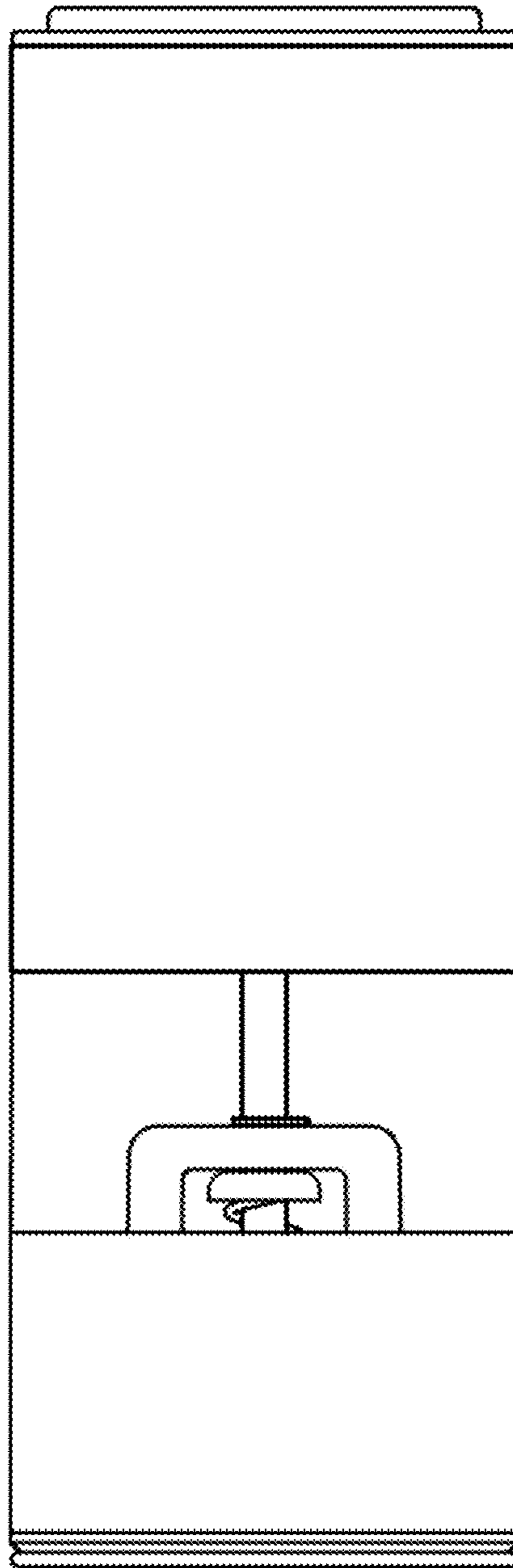

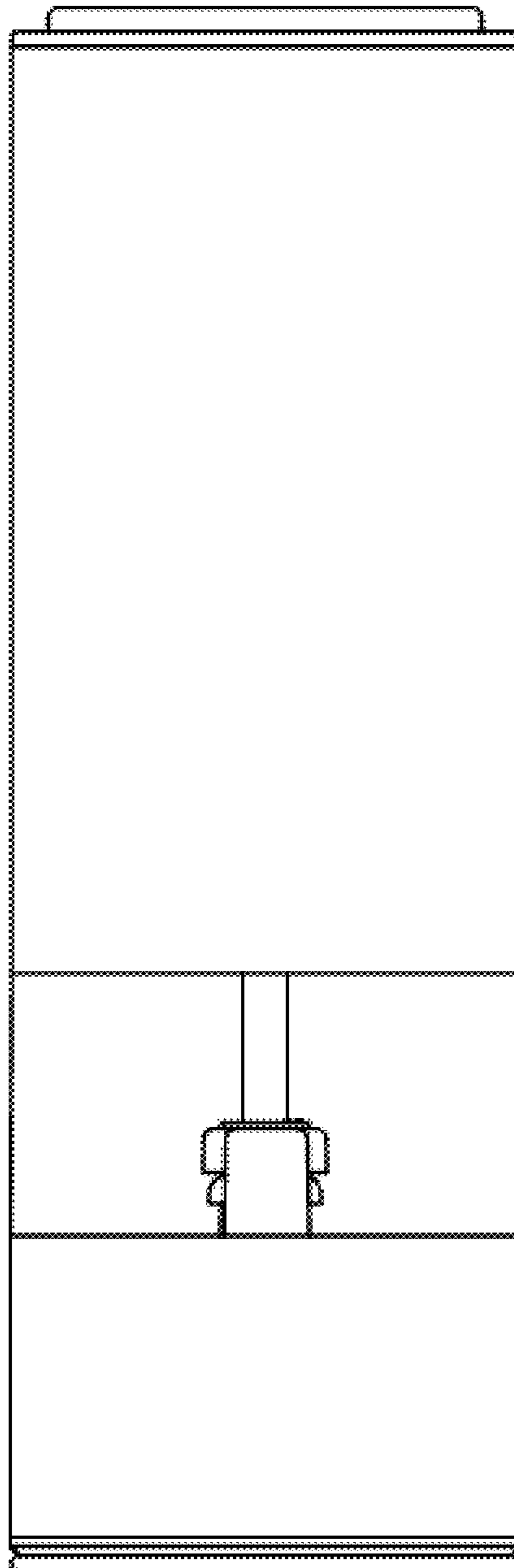

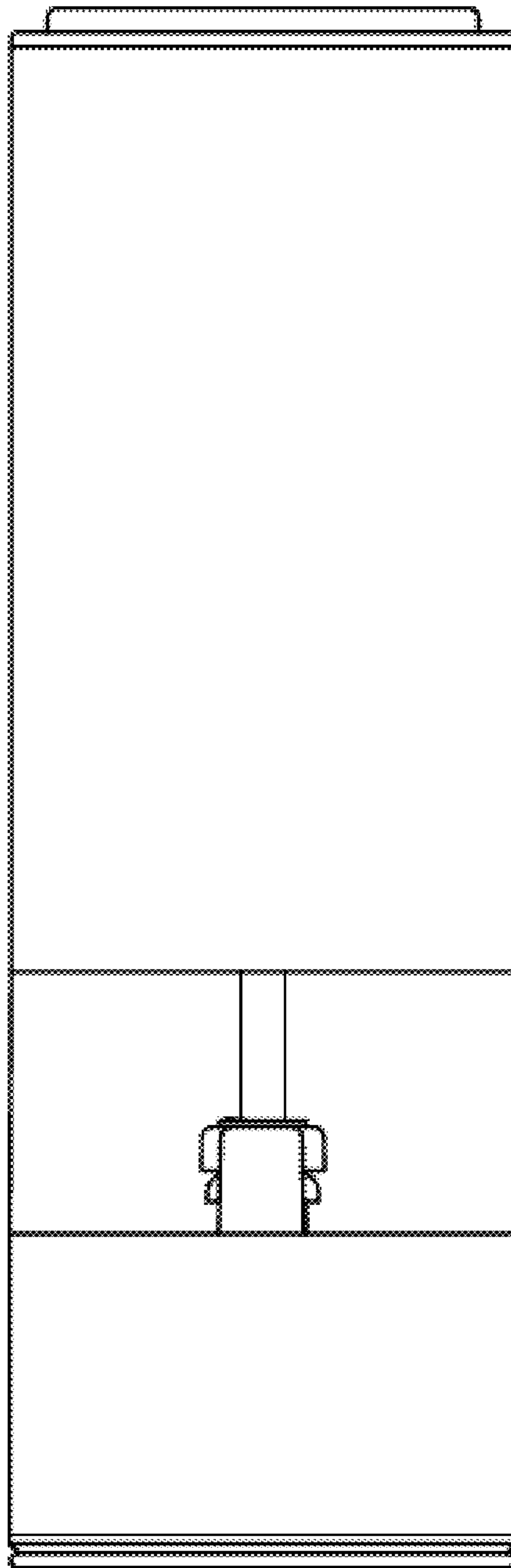

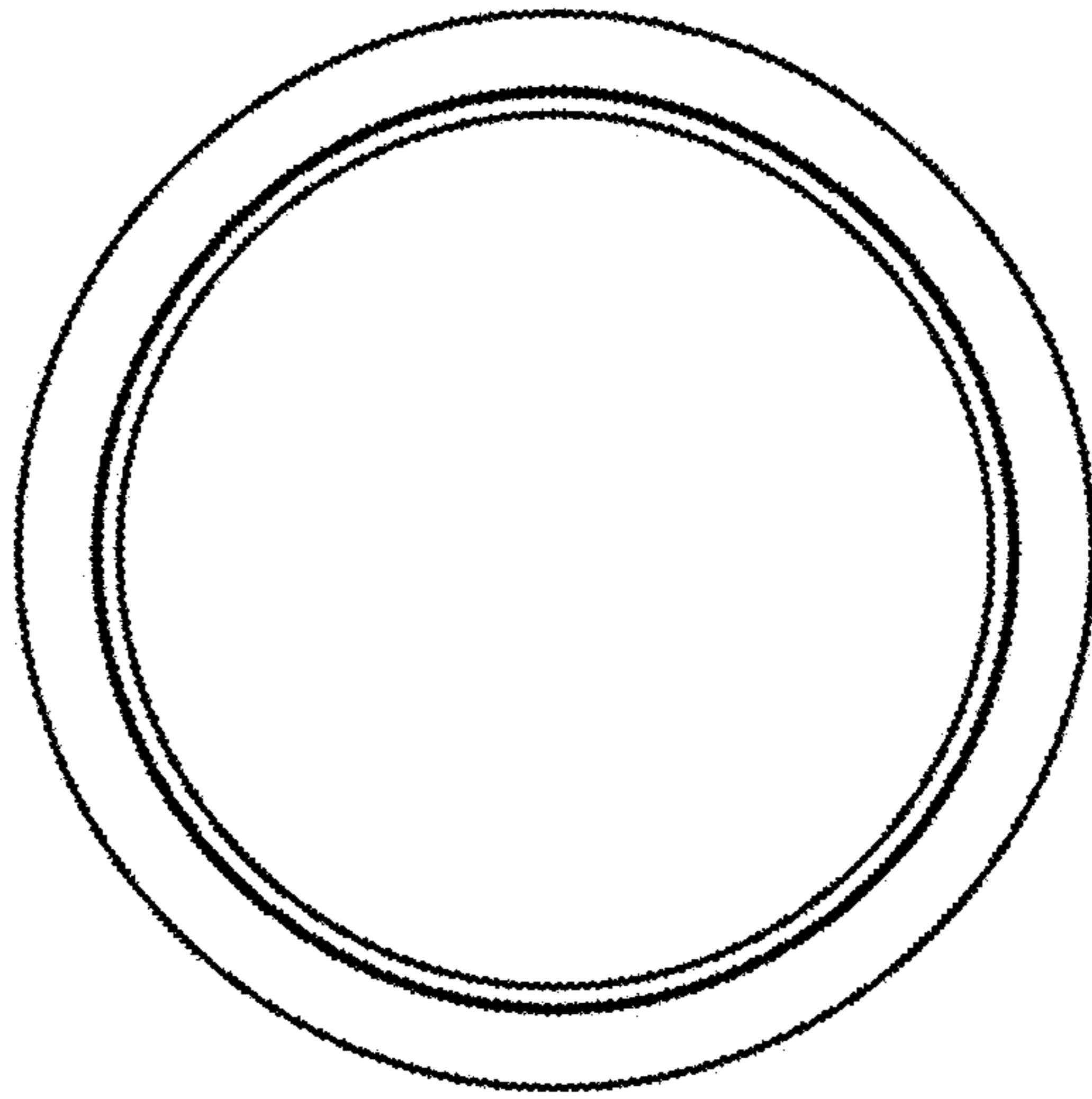

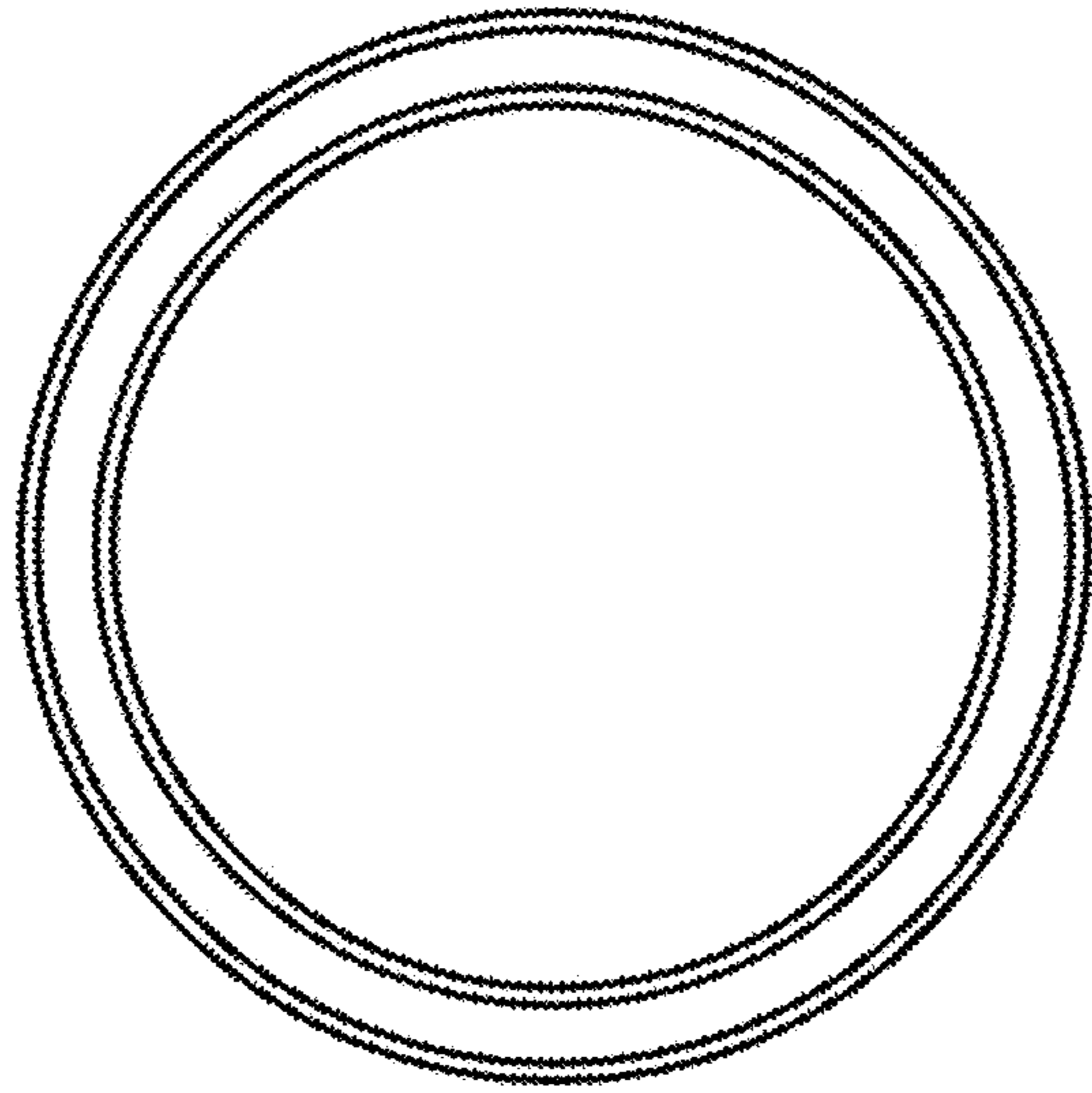
