(57) **CLAIM**

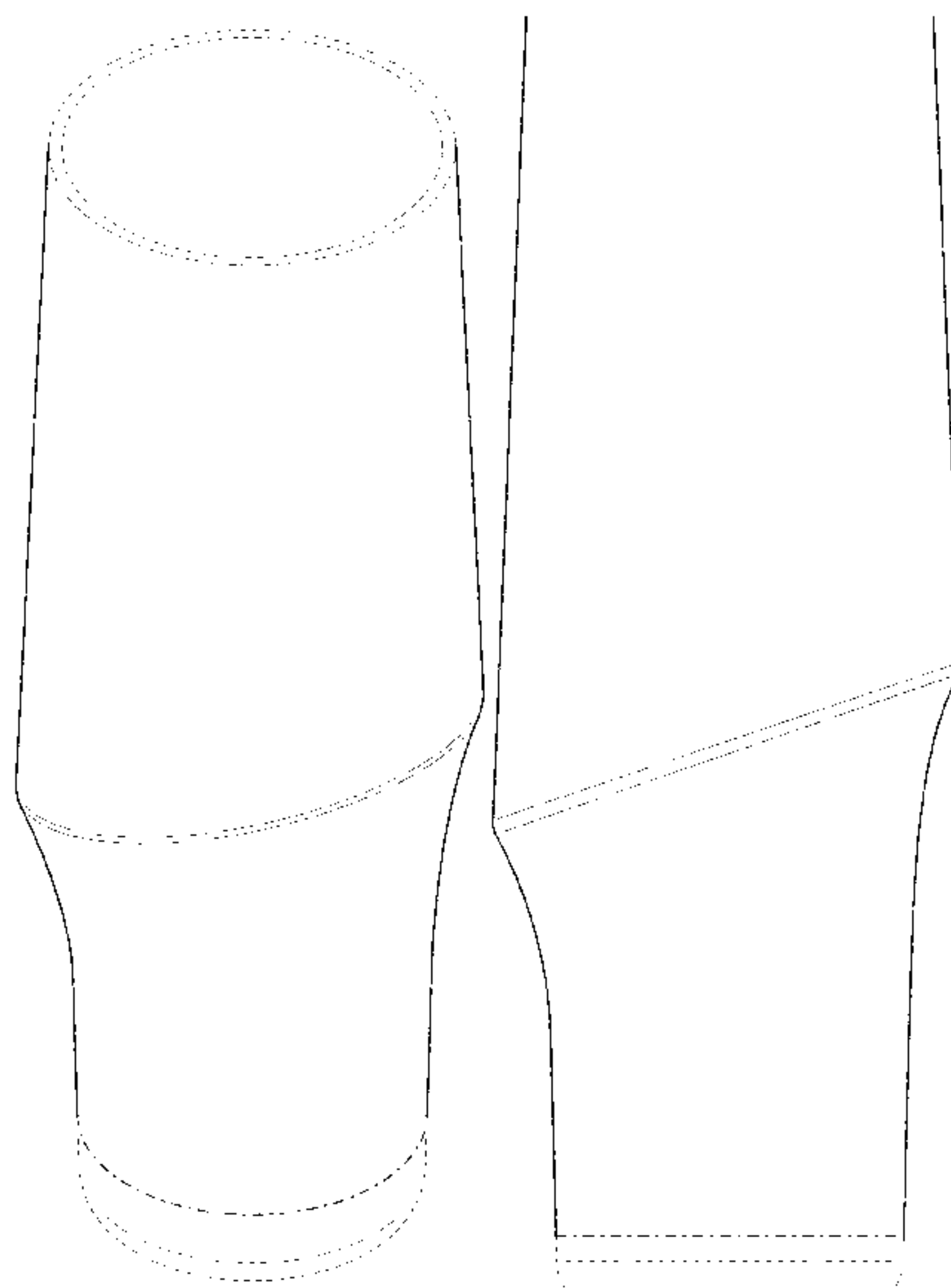
The ornamental design for a drinking vessel, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a drinking vessel showing the claimed design;
FIG. 2 is a bottom rear perspective view thereof;
FIG. 3 is a front view thereof;

FIG. 5 is a left side view thereof;
FIG. 6 is a right side view thereof;

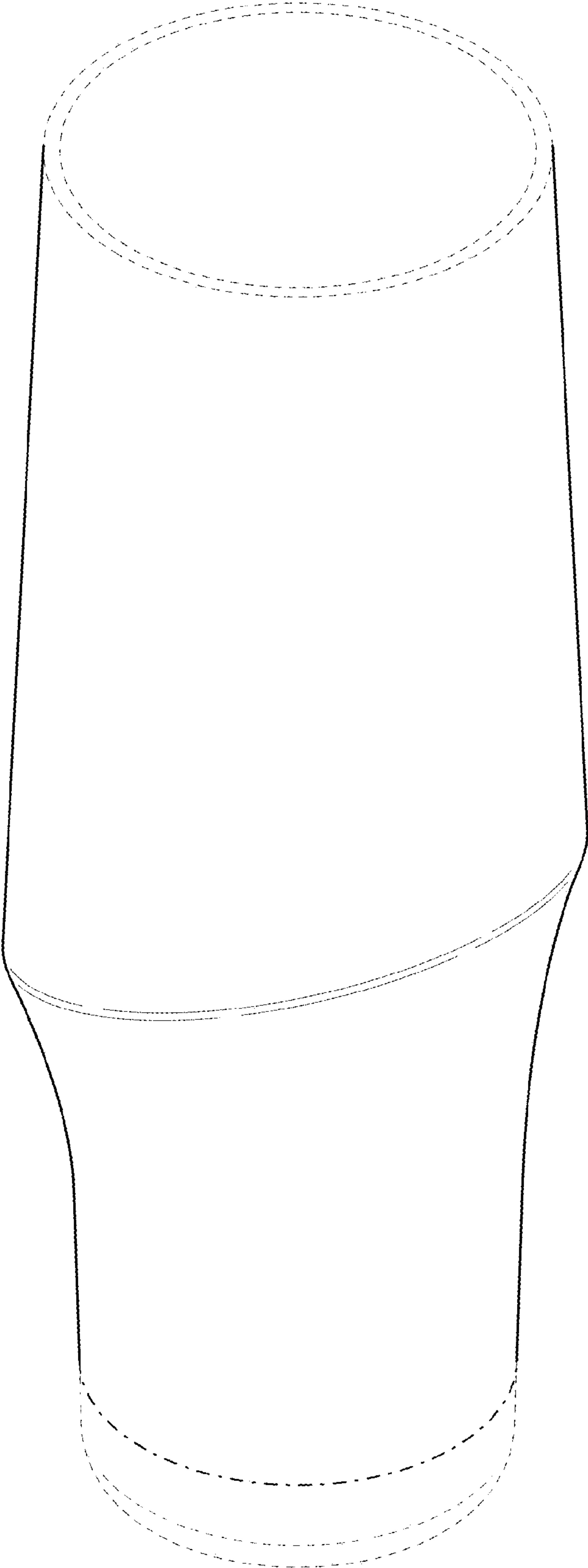

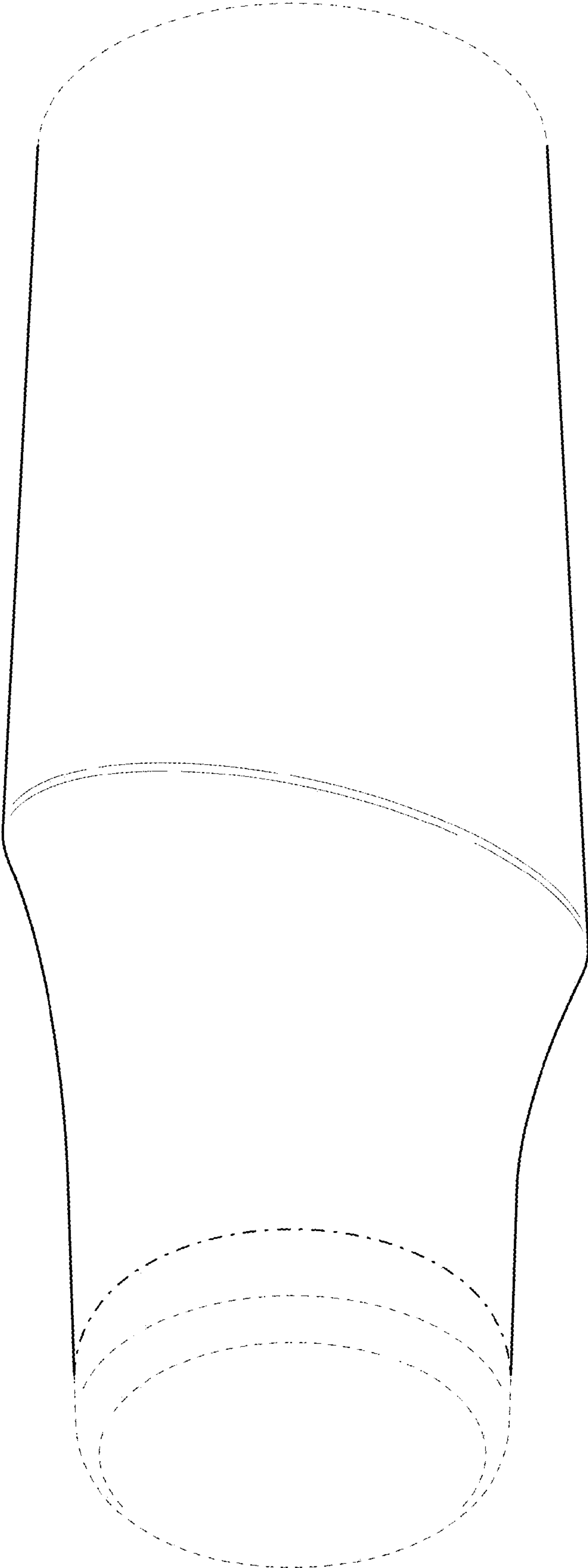

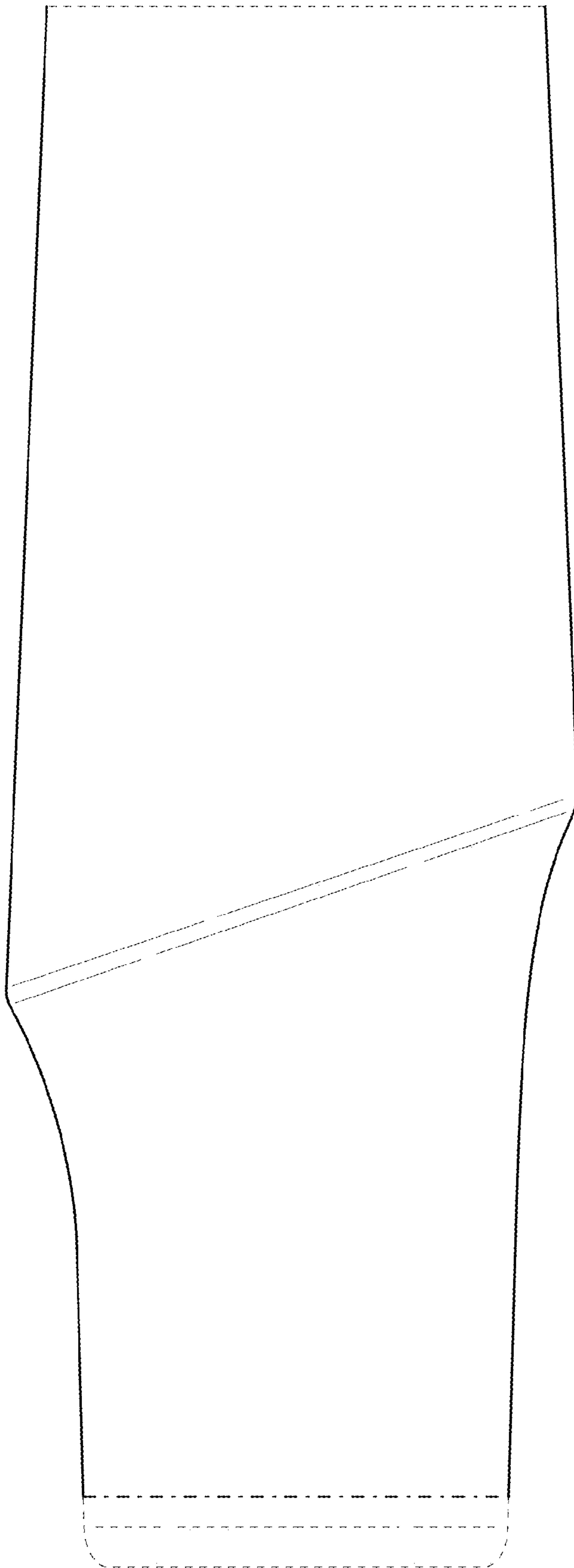

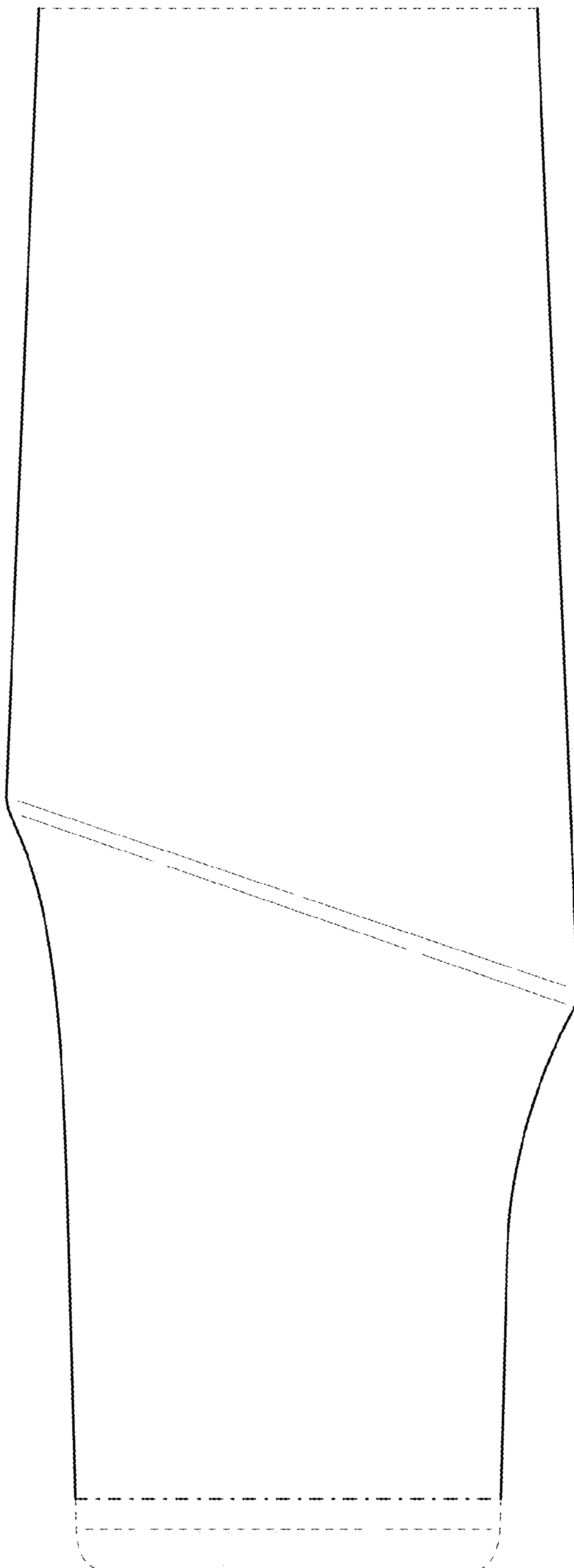

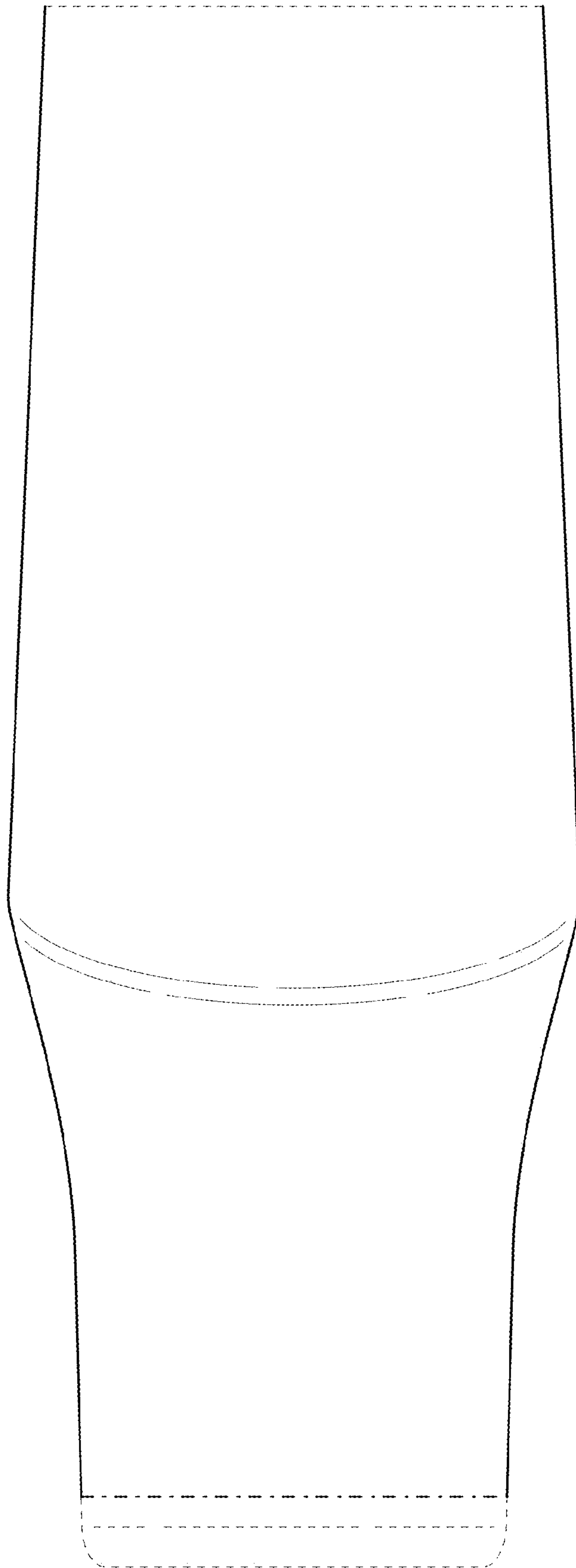

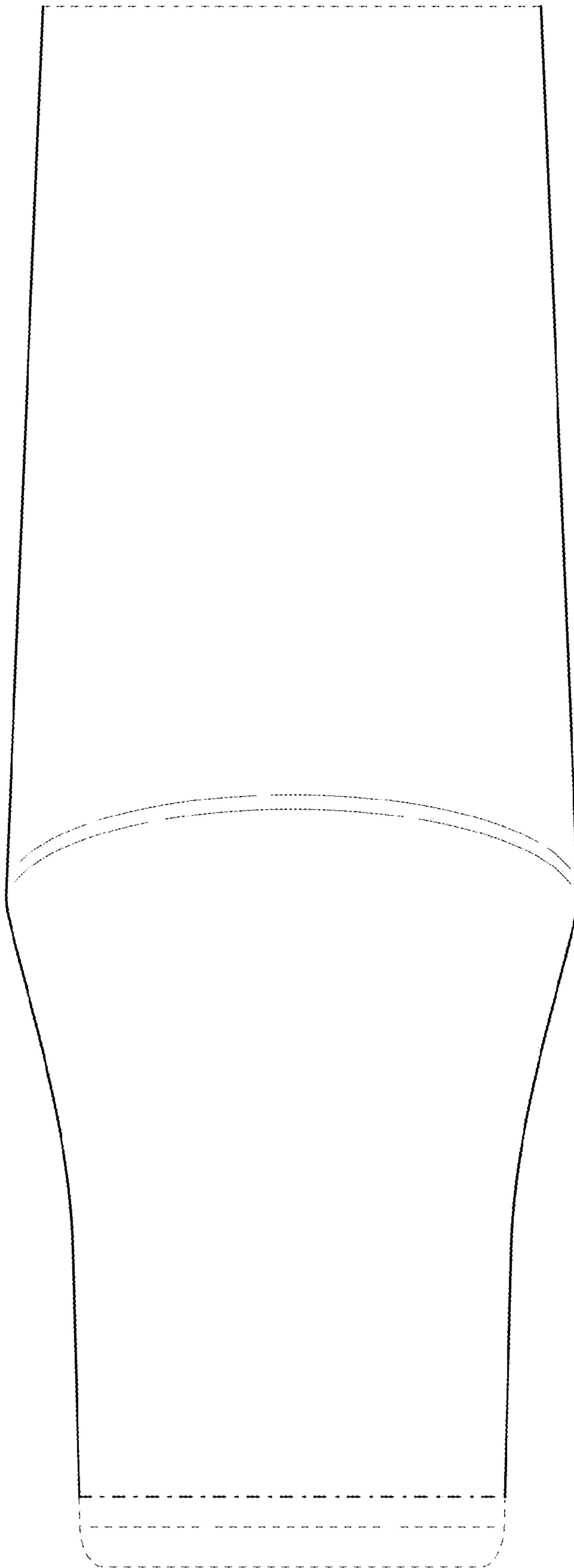

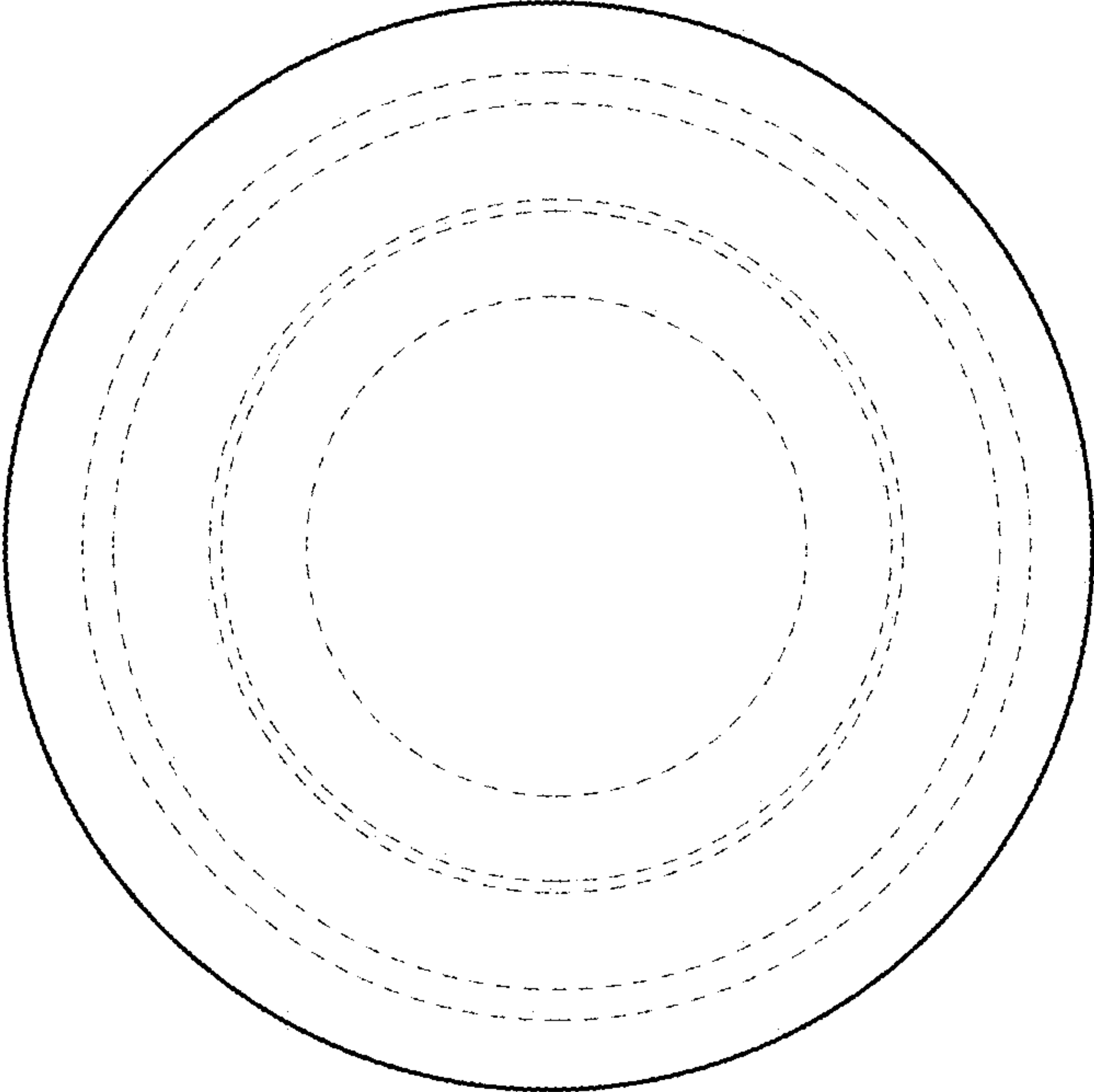

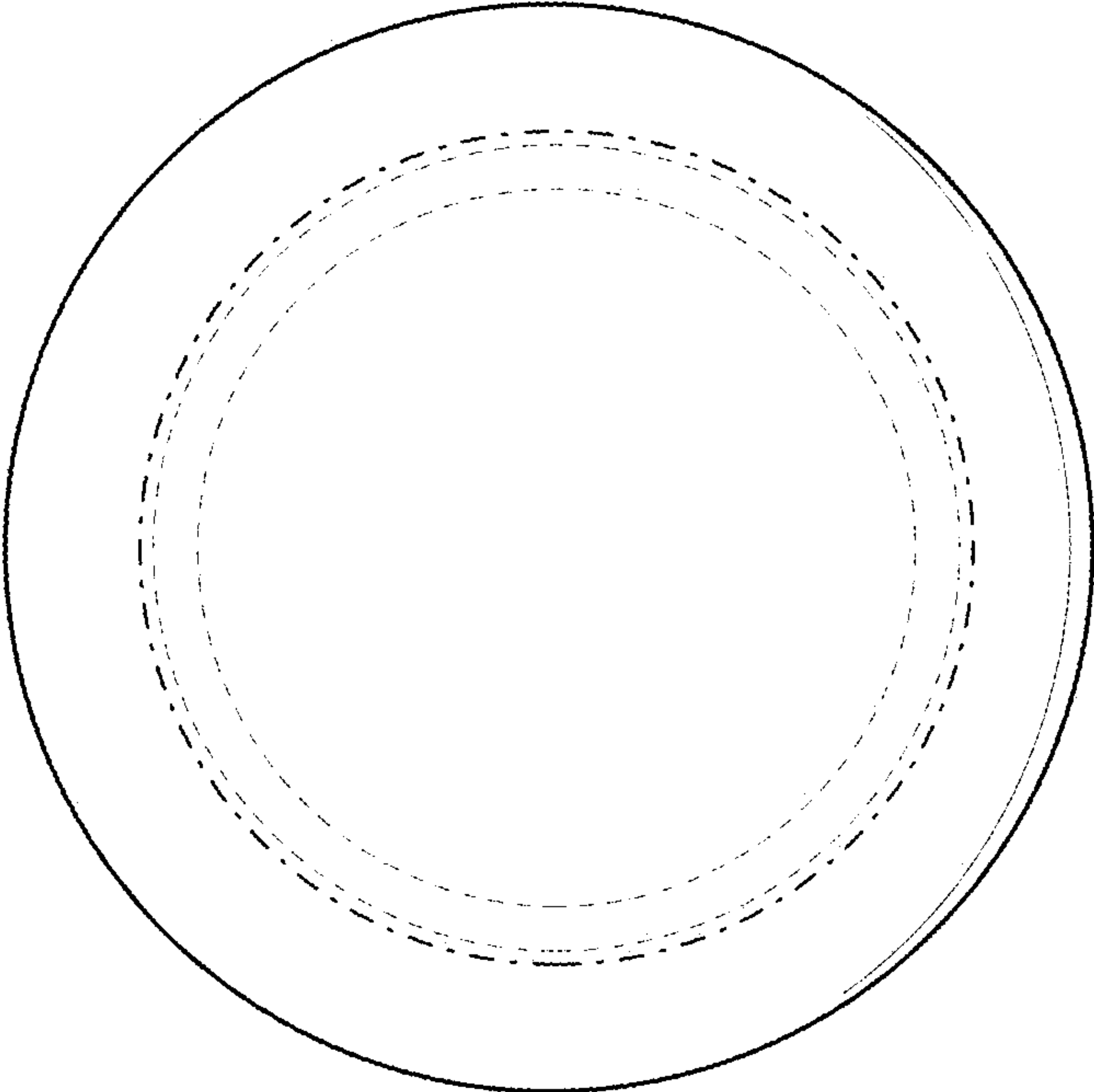
