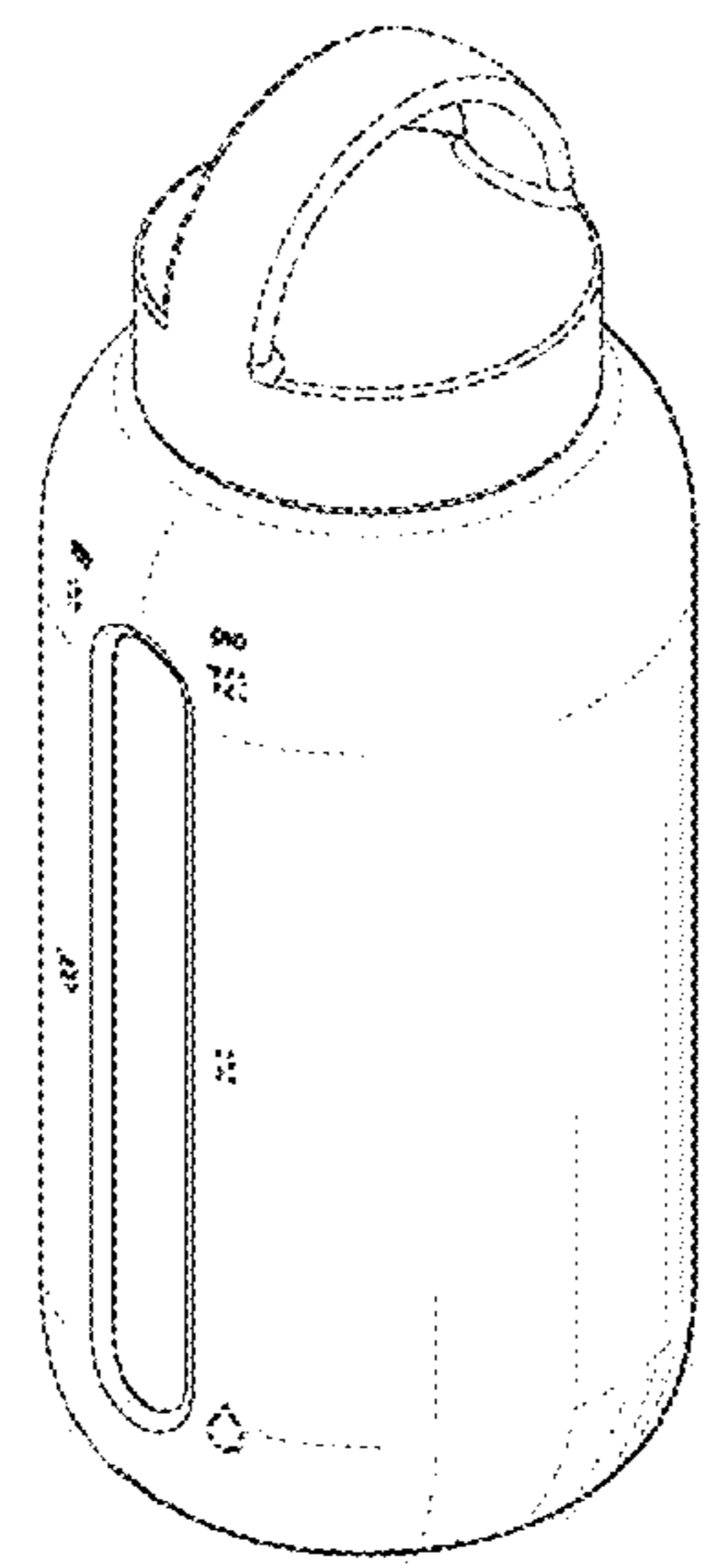

(57) **CLAIM**
We claim the ornamental design for a bottle sleeve, as shown and described.

DESCRIPTION
FIG. 1 is a top perspective view showing the bottle sleeve; FIG. 2 is a right-side view thereof; FIG. 3 is a left-side view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a front view thereof; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view thereof.
The broken lines in the drawings are for the purpose of illustrating unclaimed portions of the bottle sleeve and form no part of the claimed design.
The shading lines shown in the drawings represent the approximate three-dimensional contour of the design, and are not intended to indicate surface decoration.

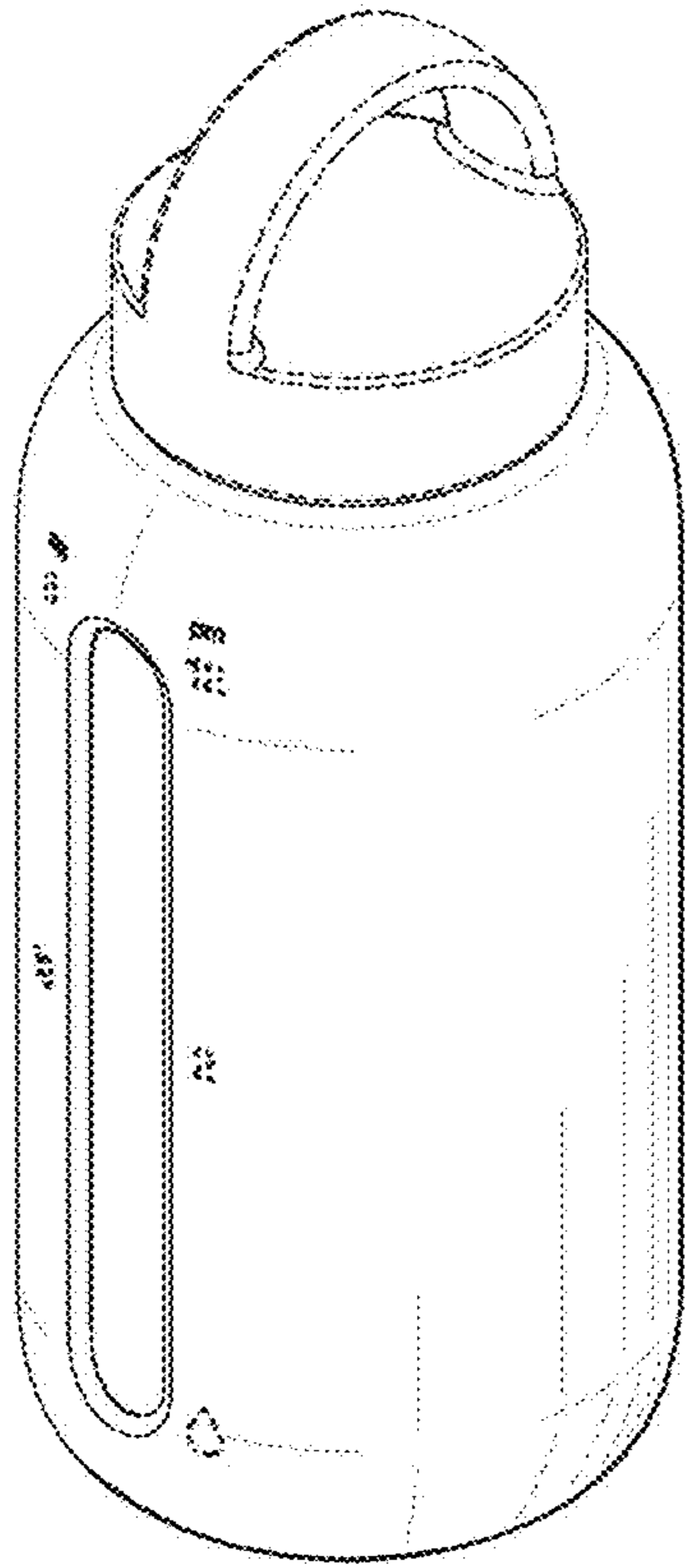

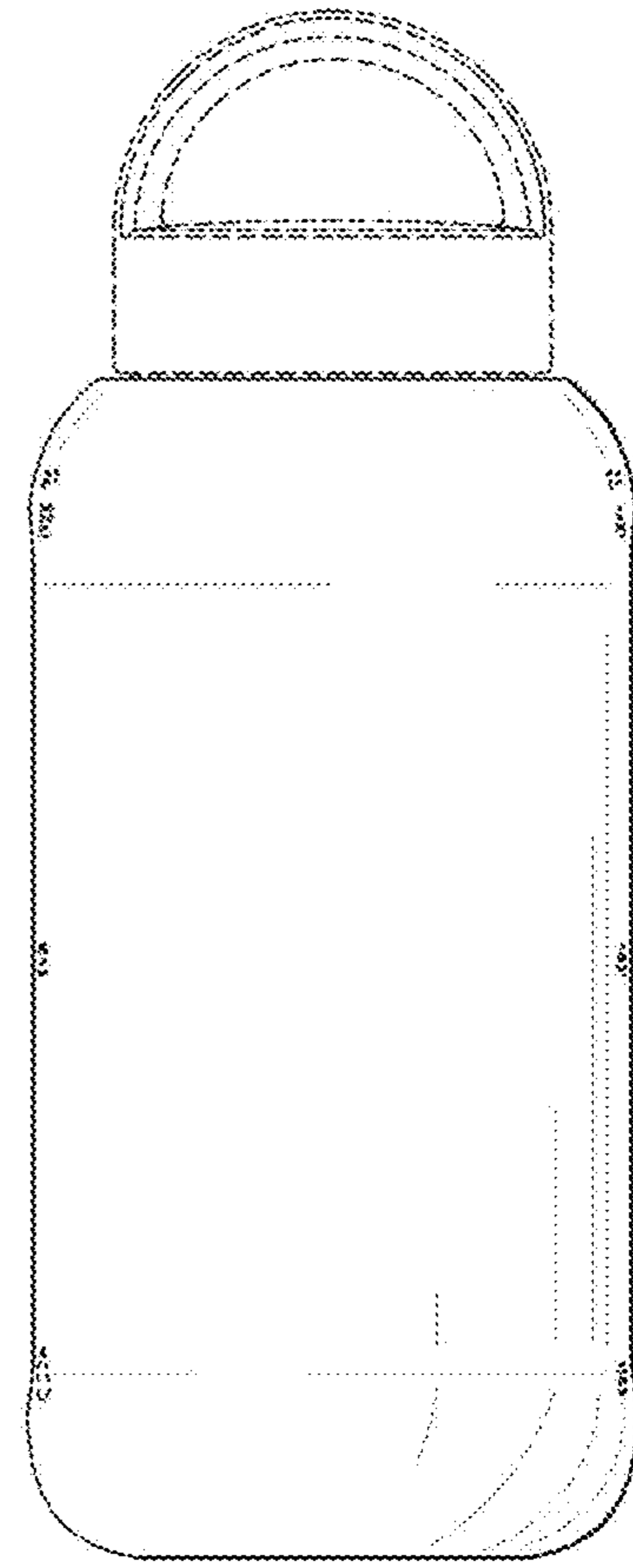

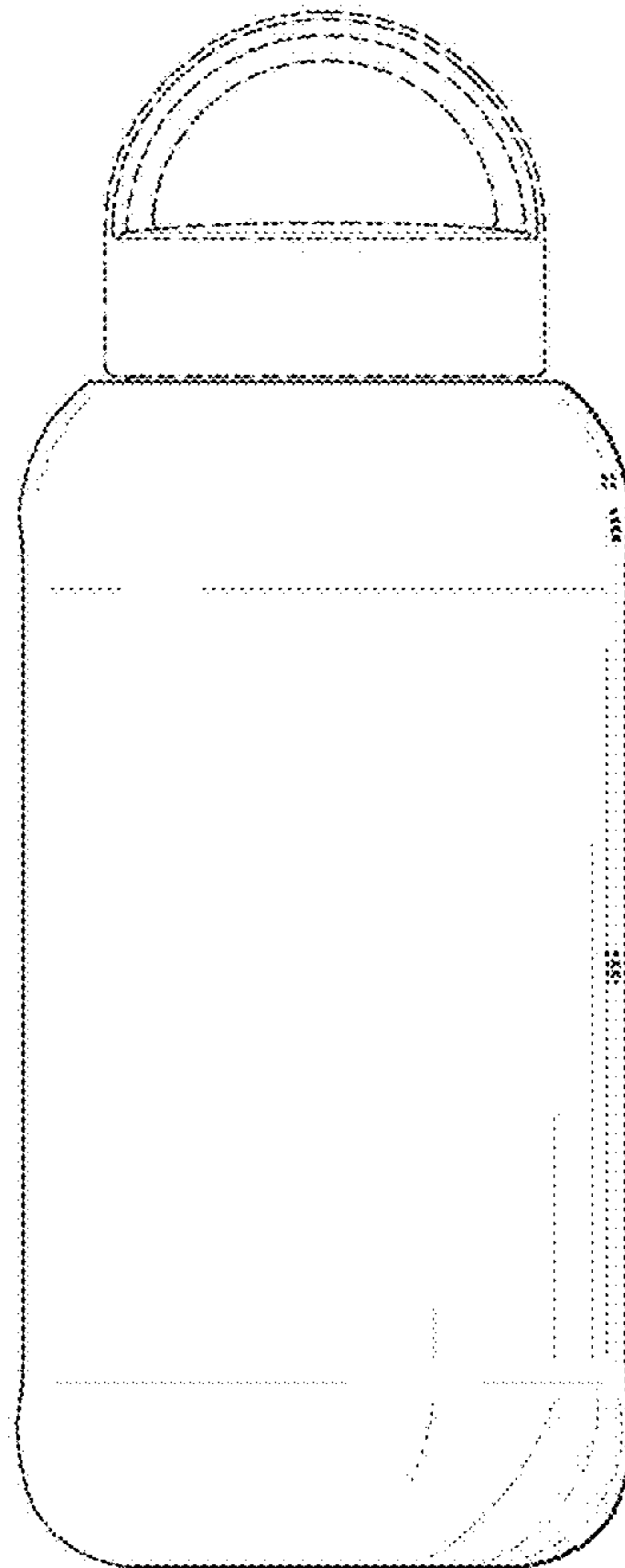

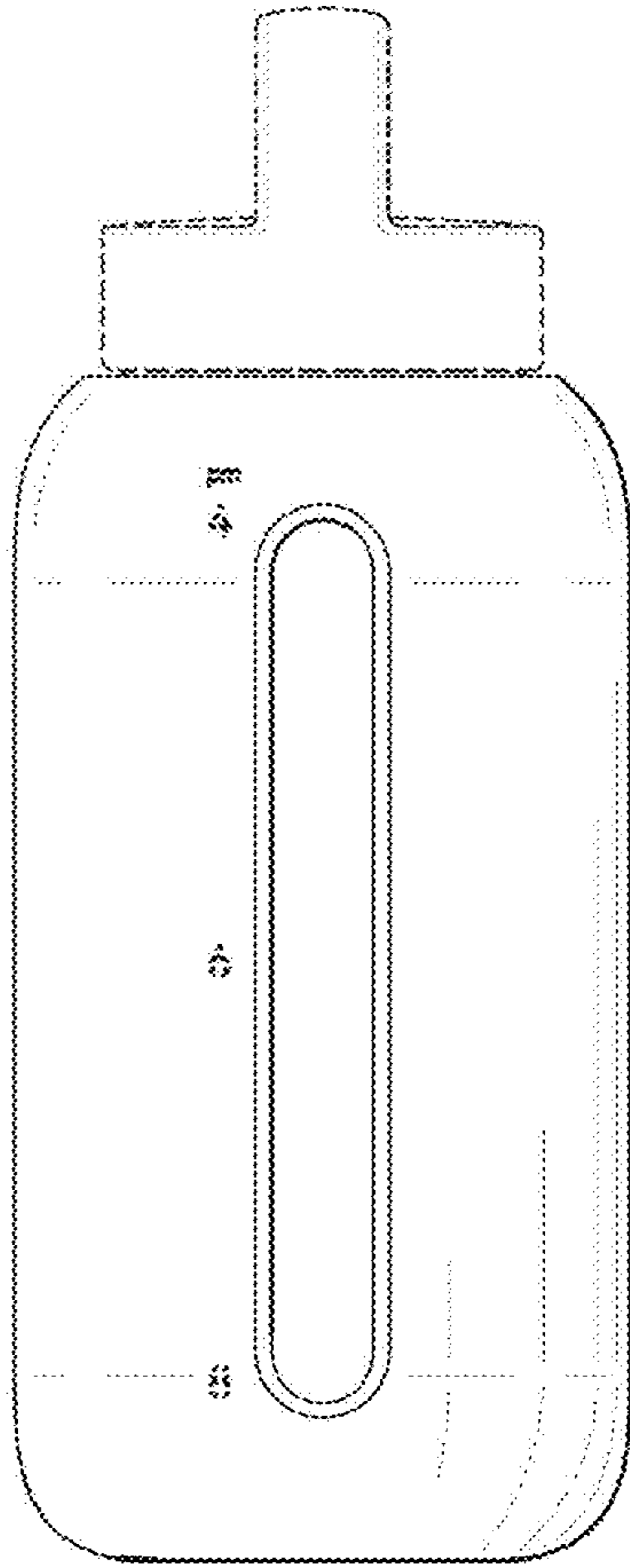

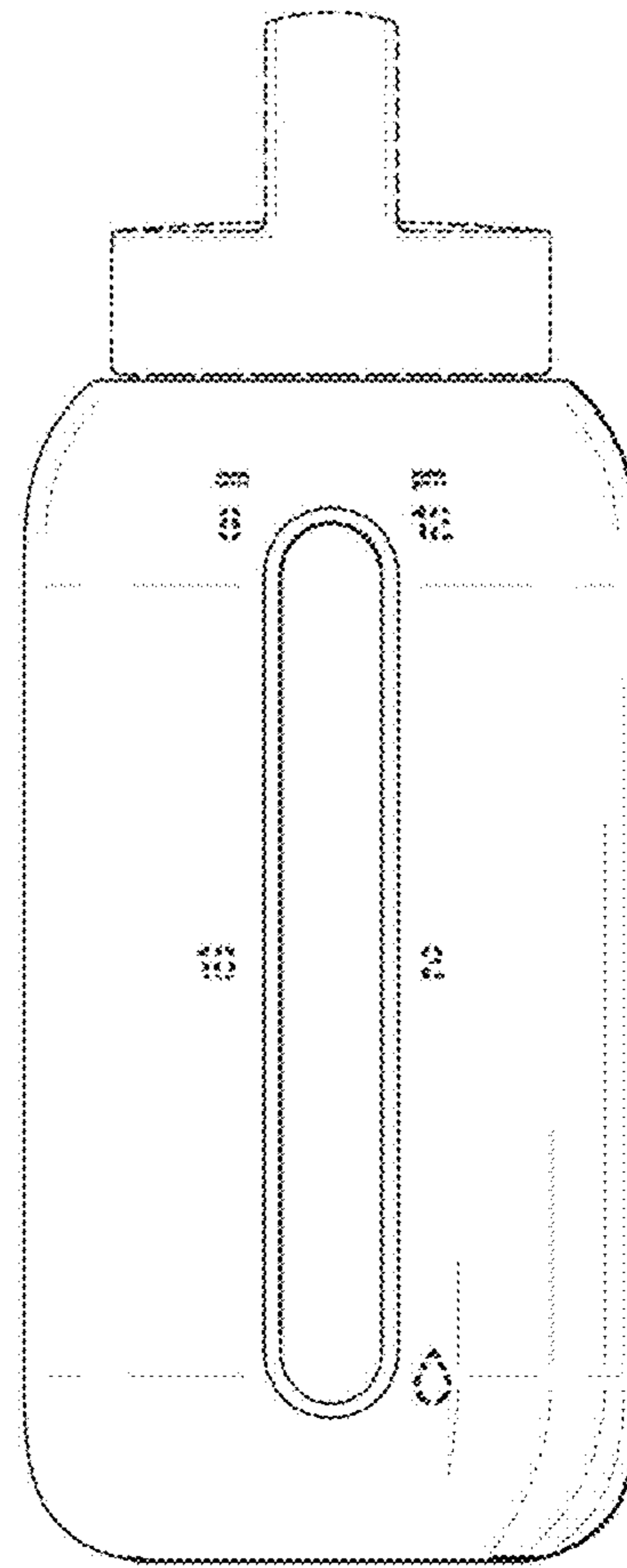

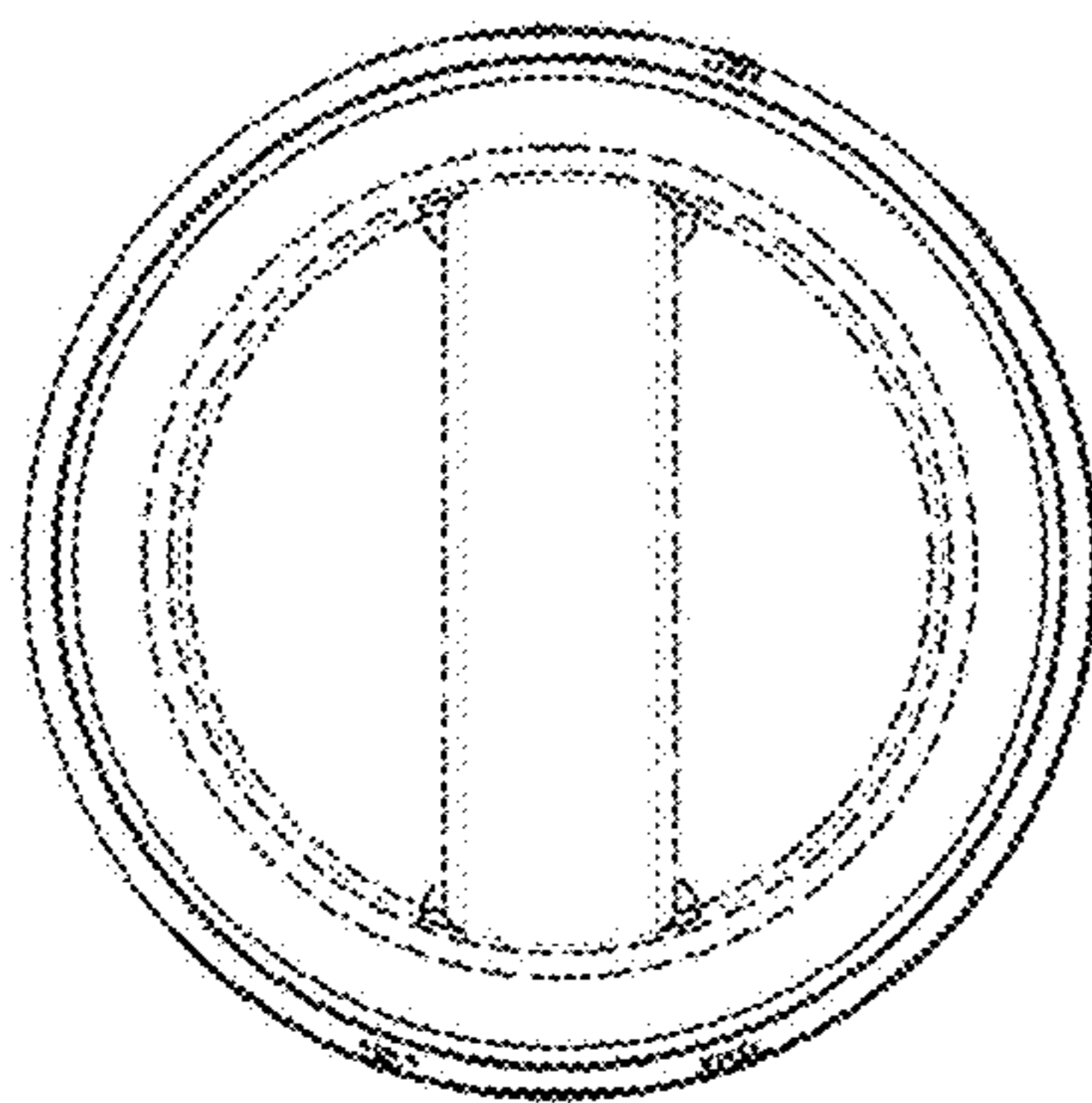

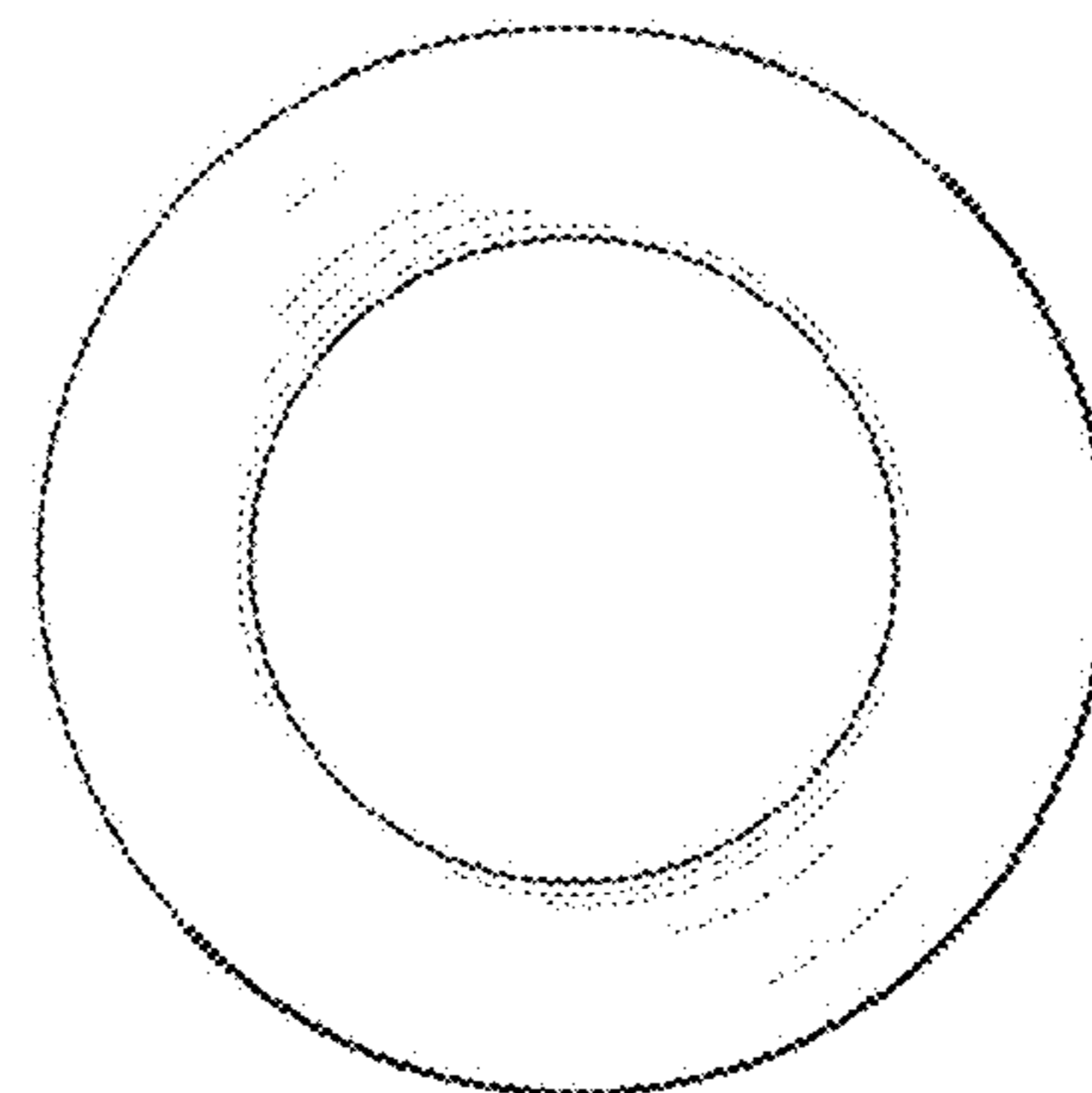
