FIG. 3 is a front view of the glass fastener shown in FIG. 1 with the back view being a mirror image of;

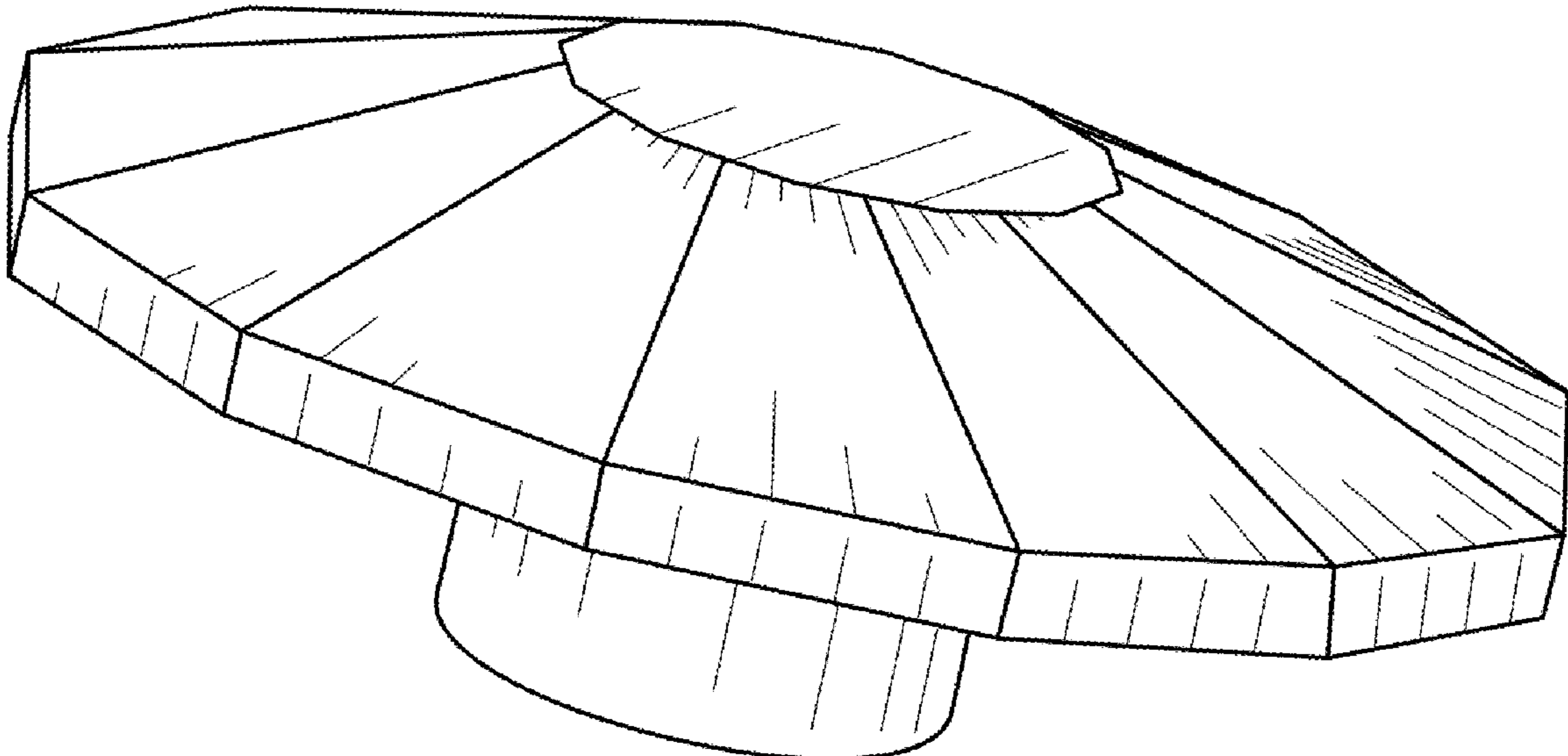
FIG. 4 is a left side view of the glass fastener shown in FIG. 1 with the right side view being a mirror image of;

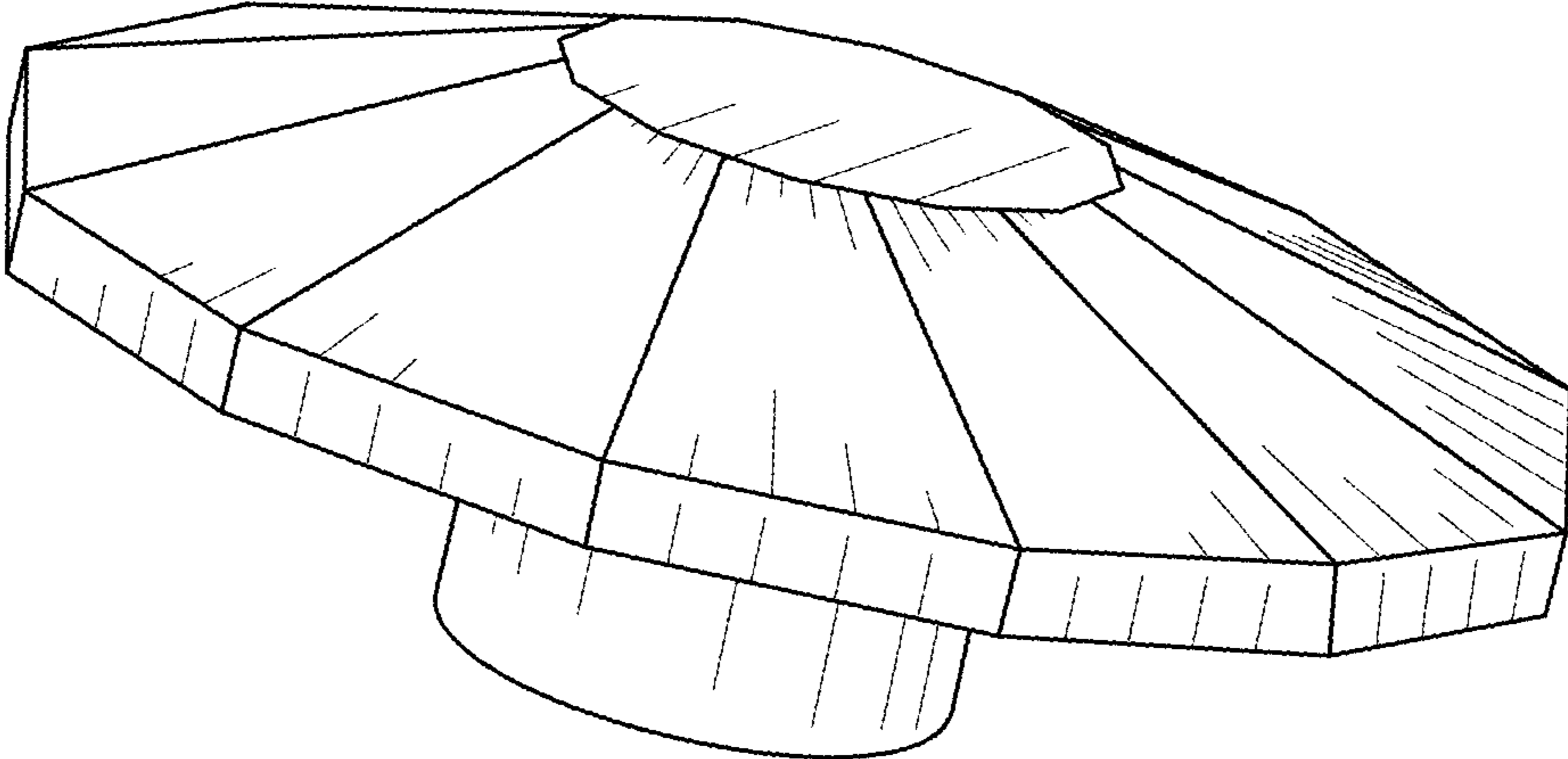

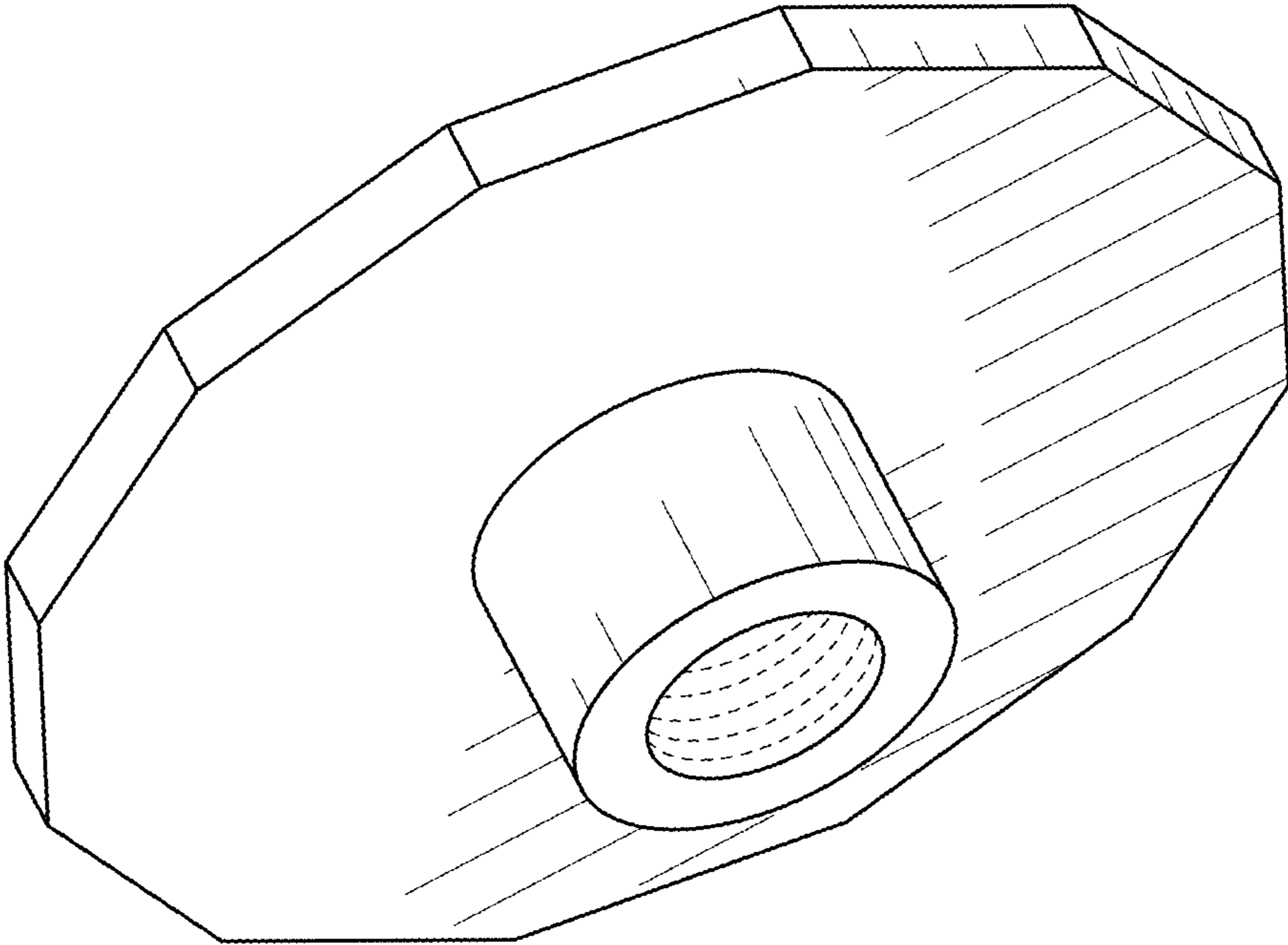

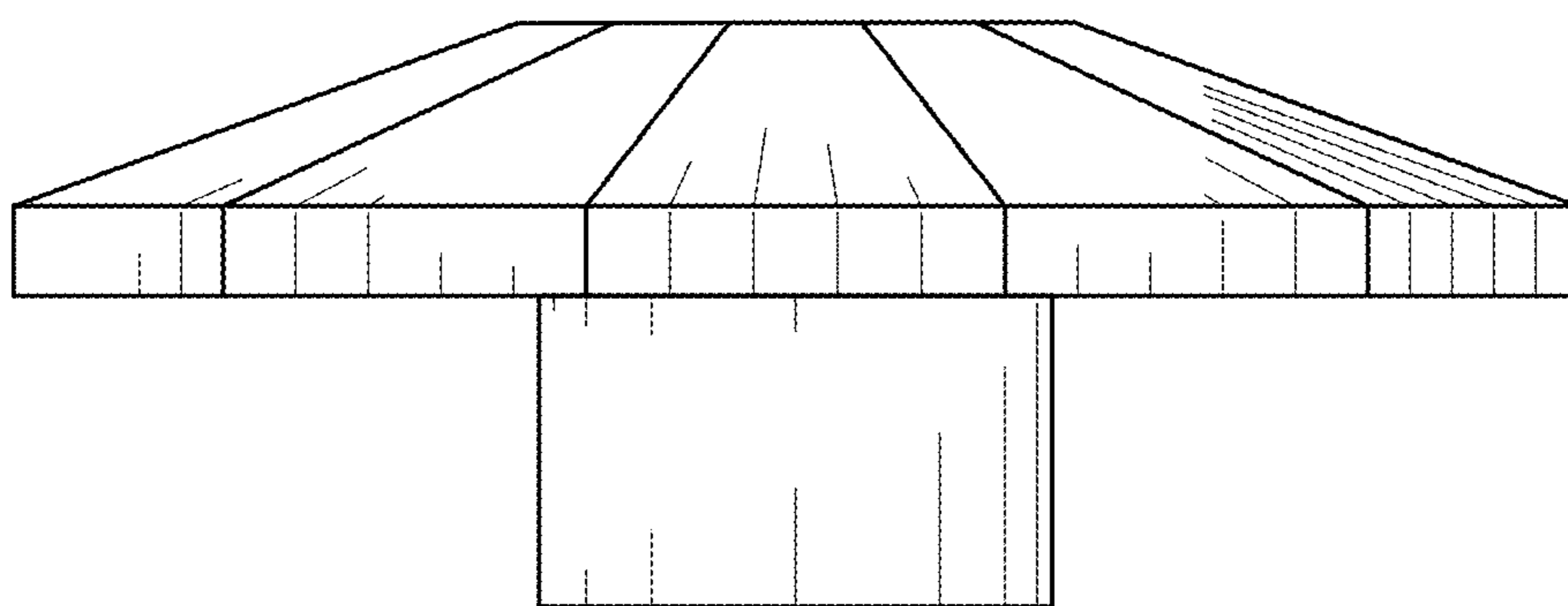

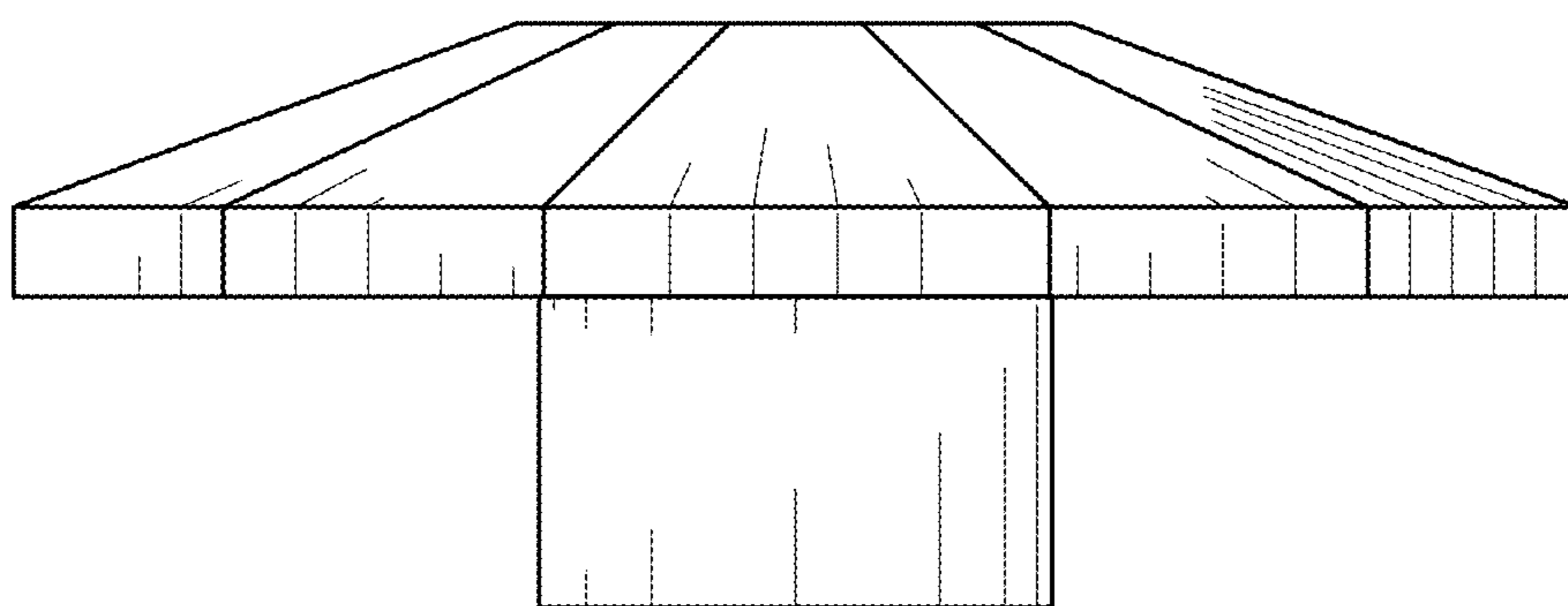

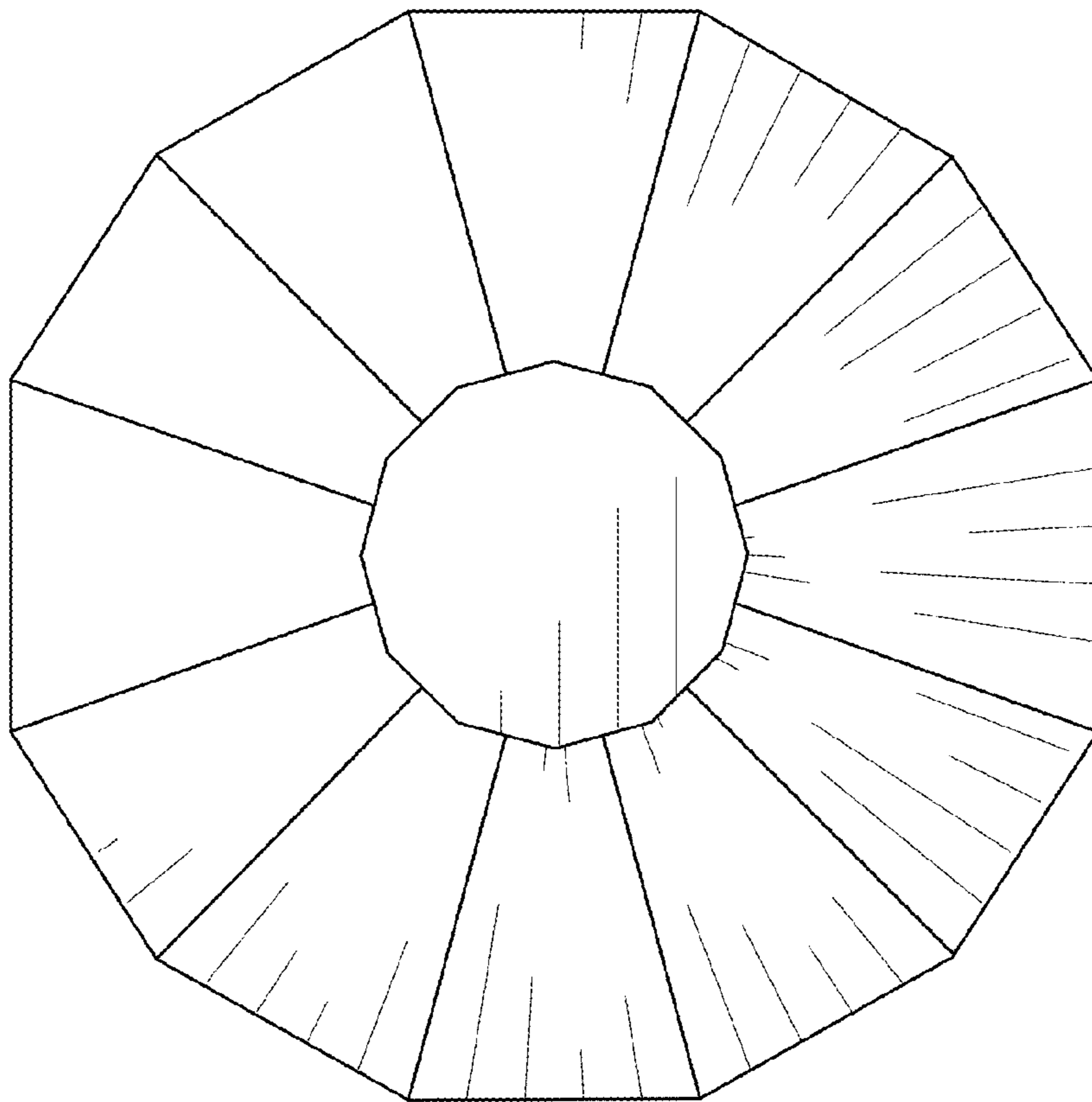

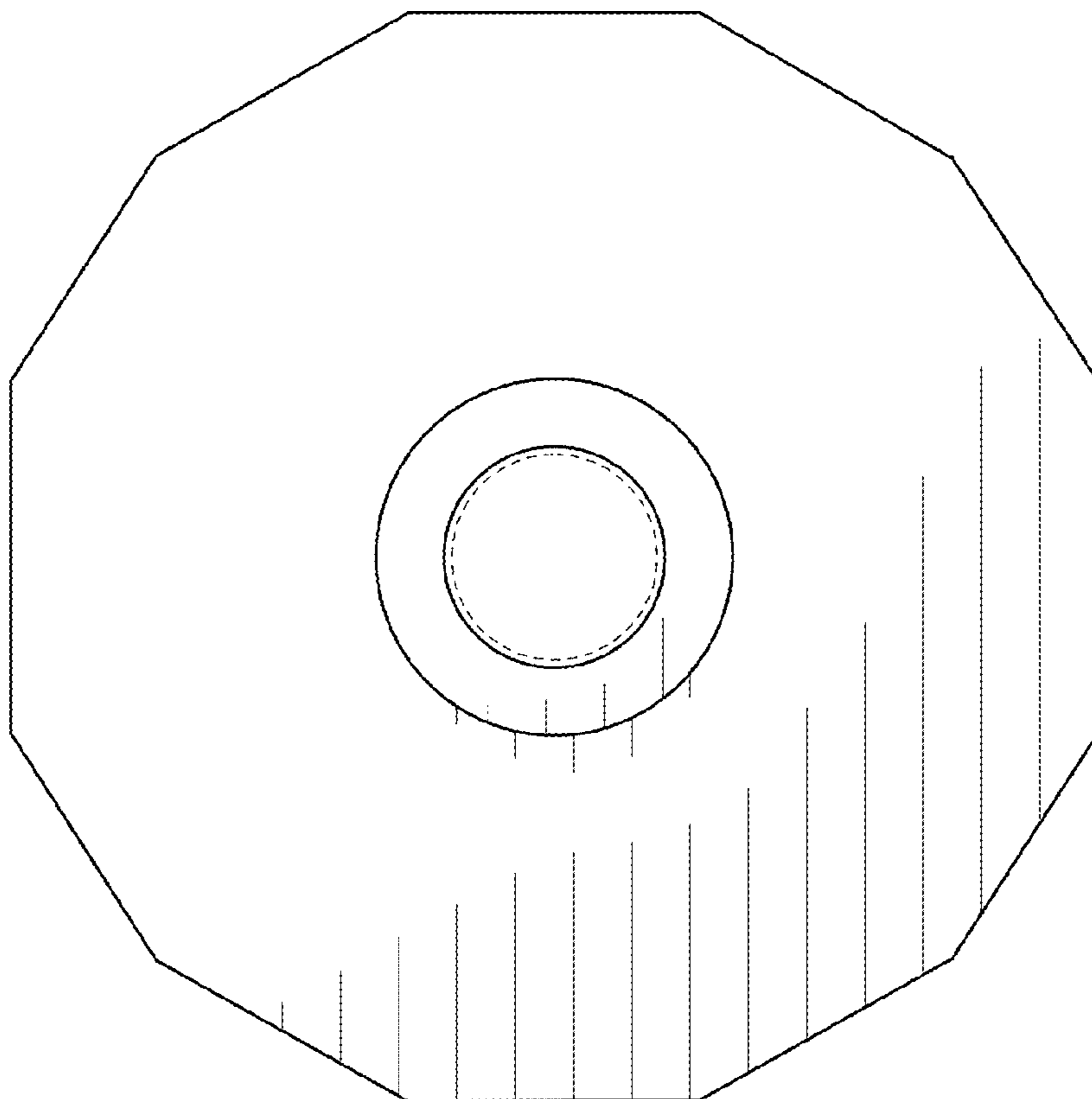
