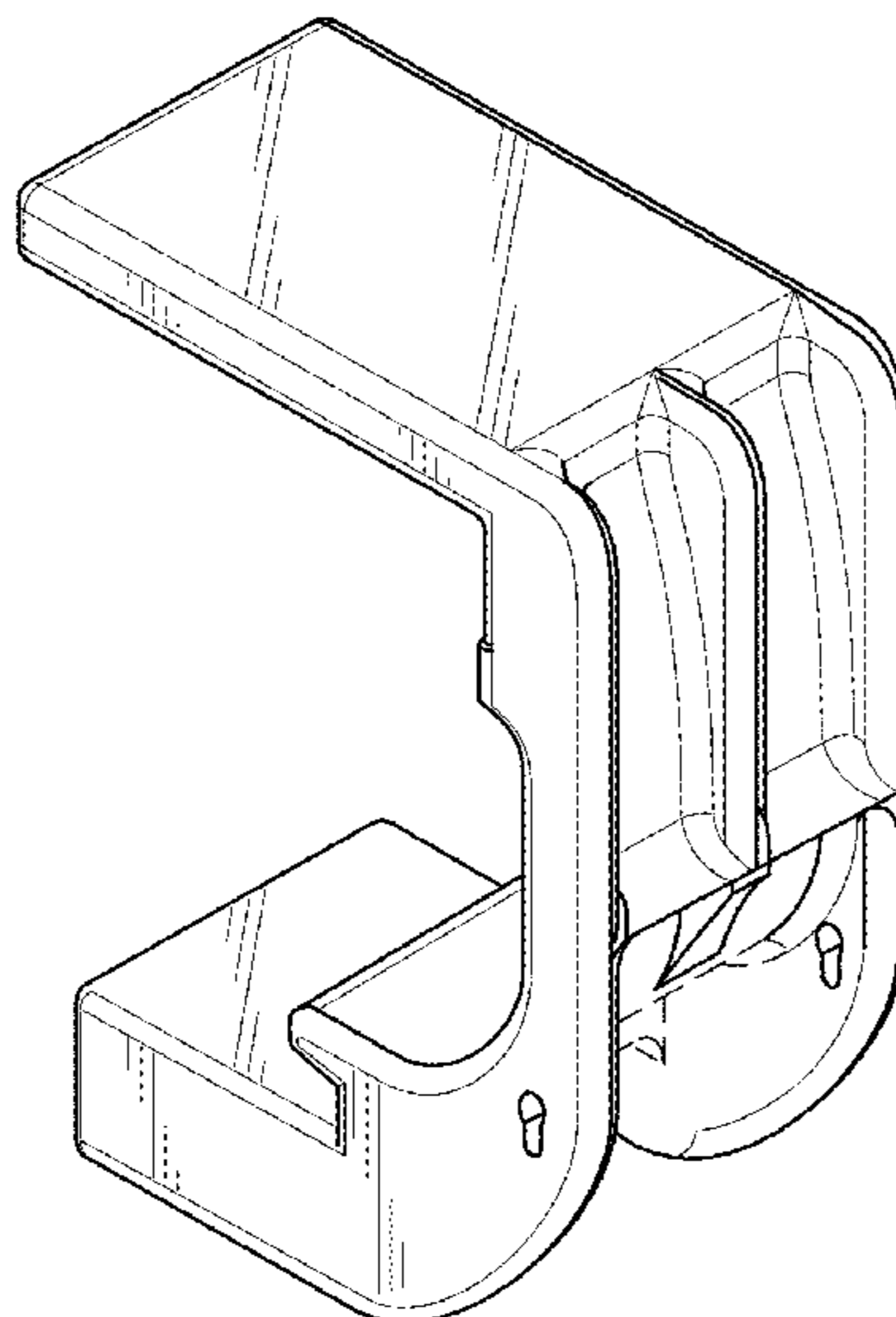
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a rear perspective view of a protection board mounting bracket showing my new design; FIG. 2 is a right side elevational view thereof, with the left side elevational view being a mirror image thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a front perspective view thereof partially broken away; and, FIG. 5 is a front perspective view thereof. 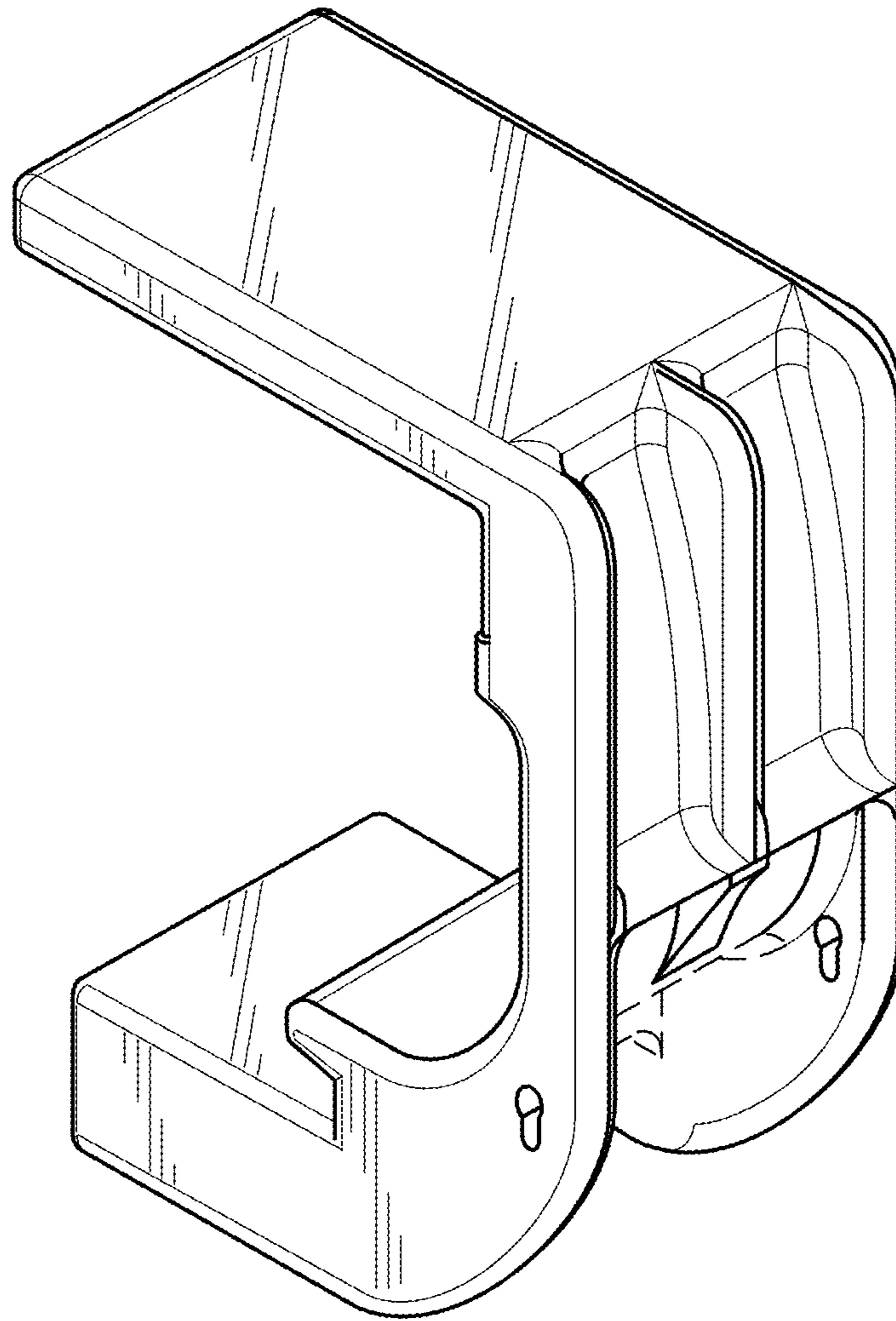

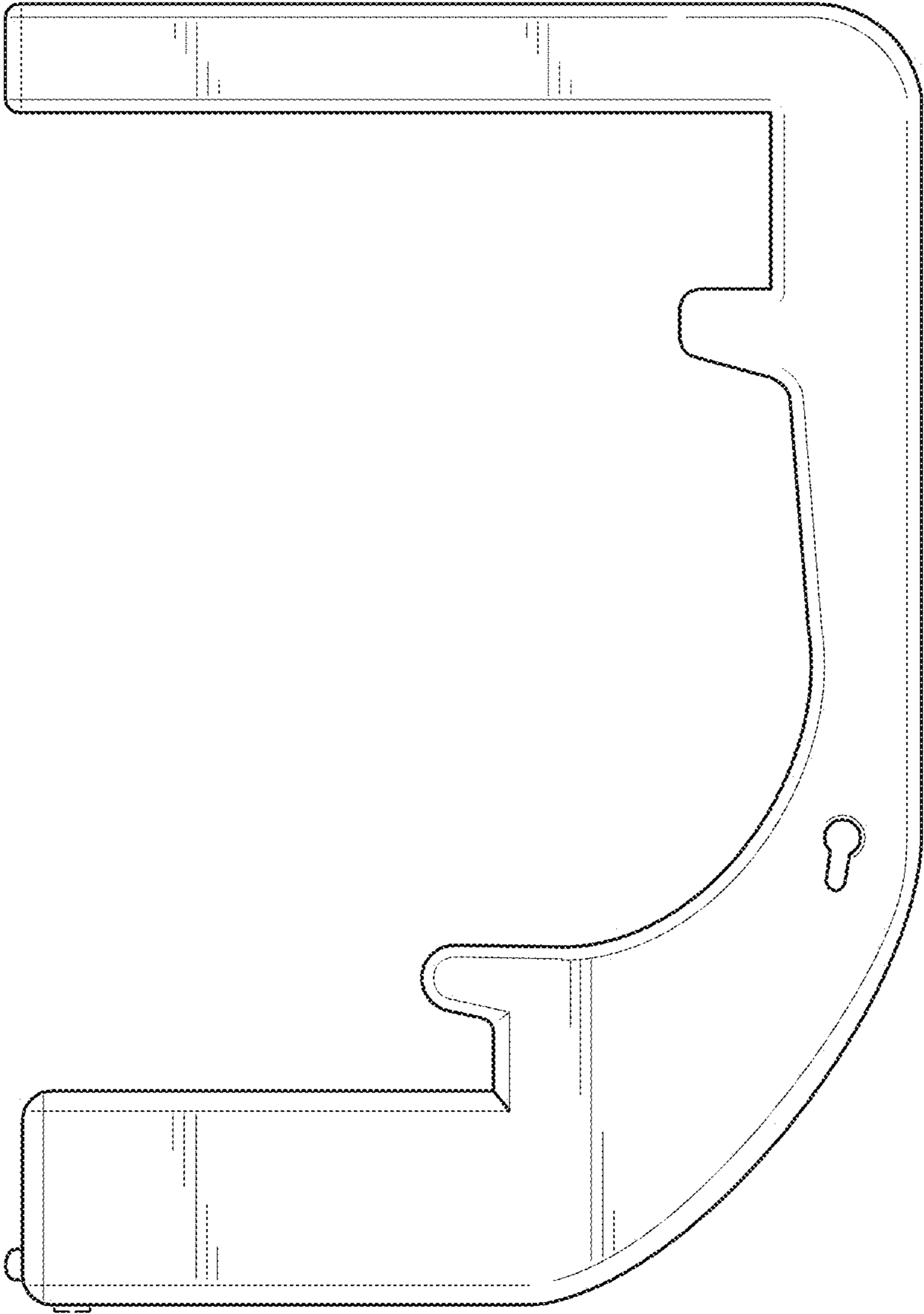

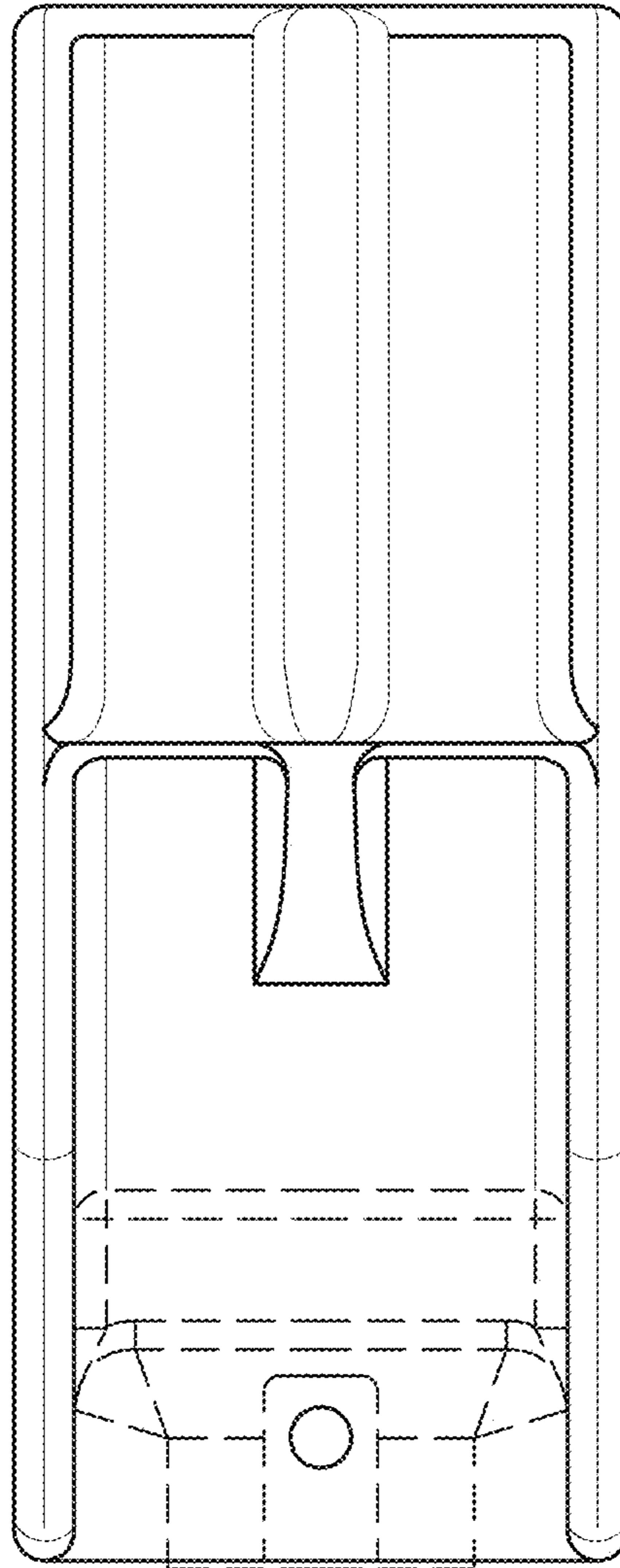

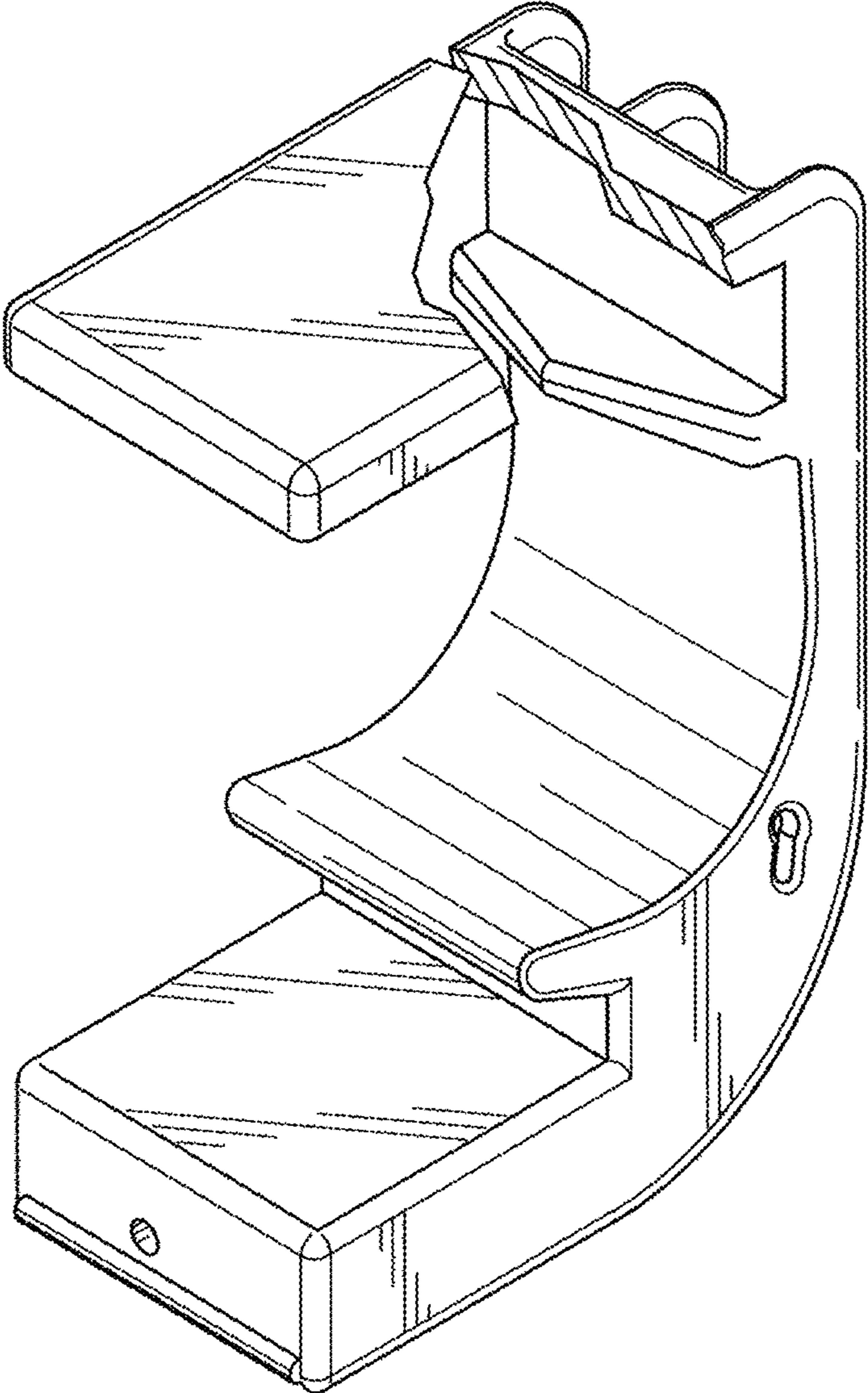

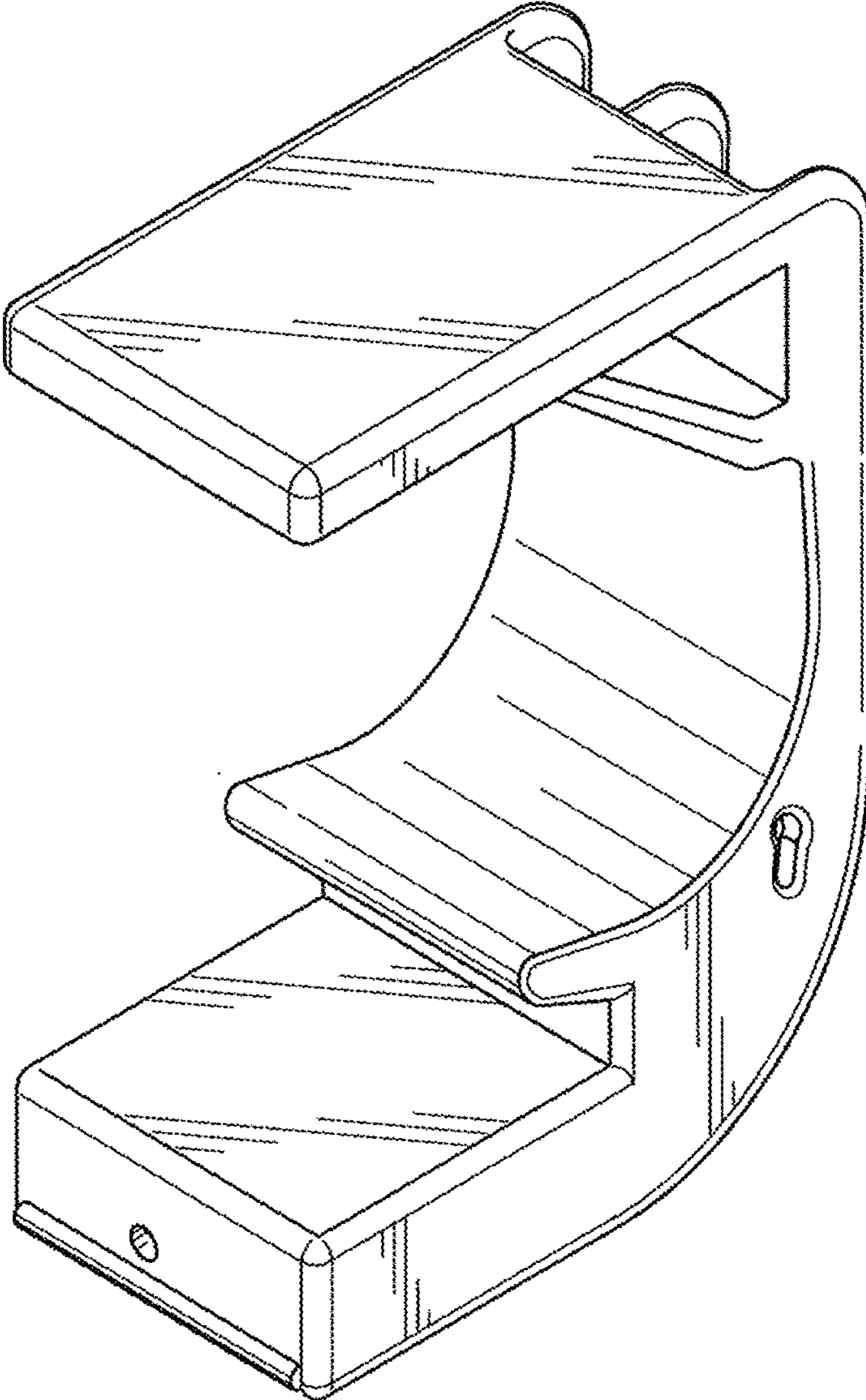
