**DESCRIPTION**

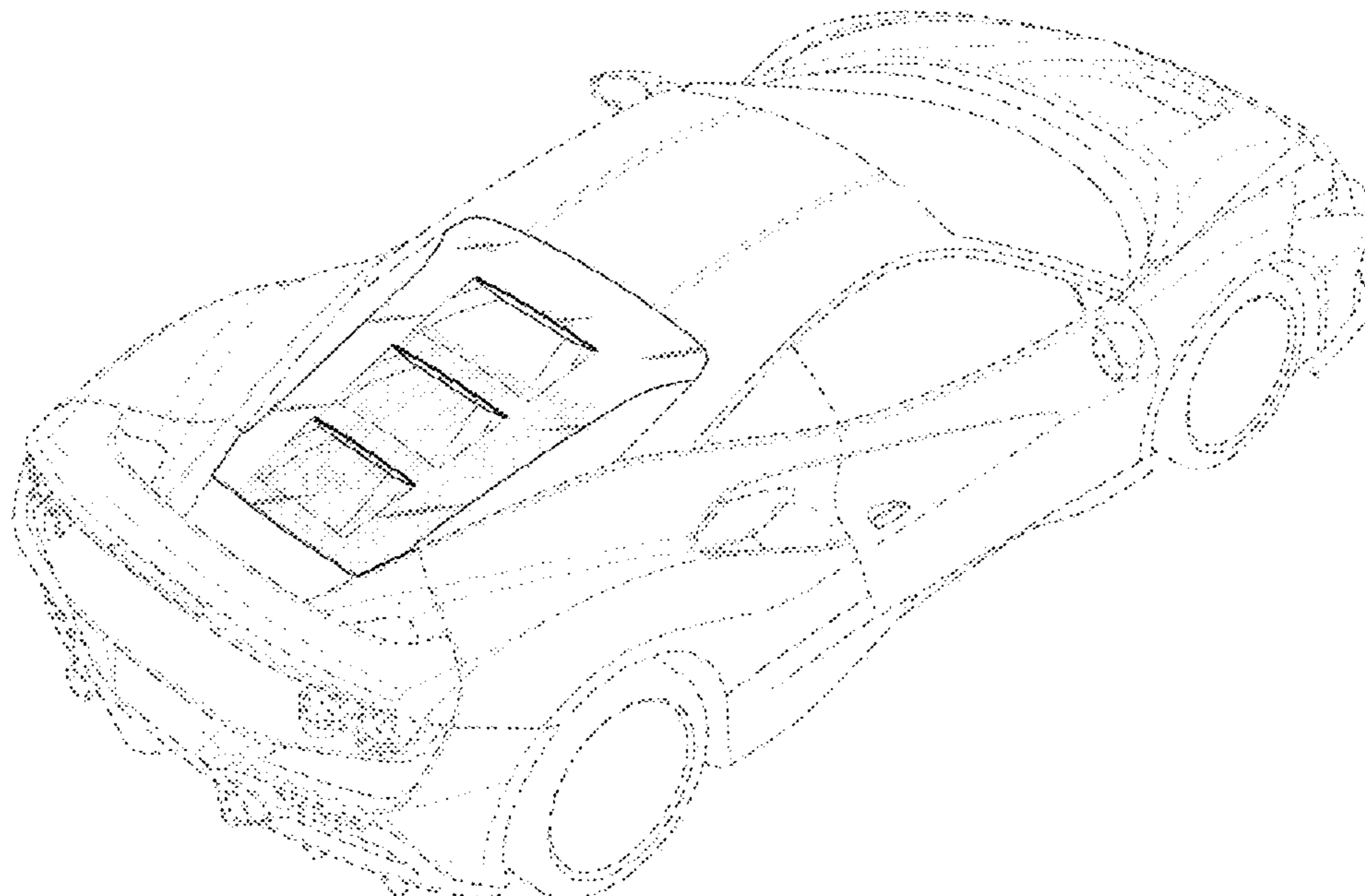

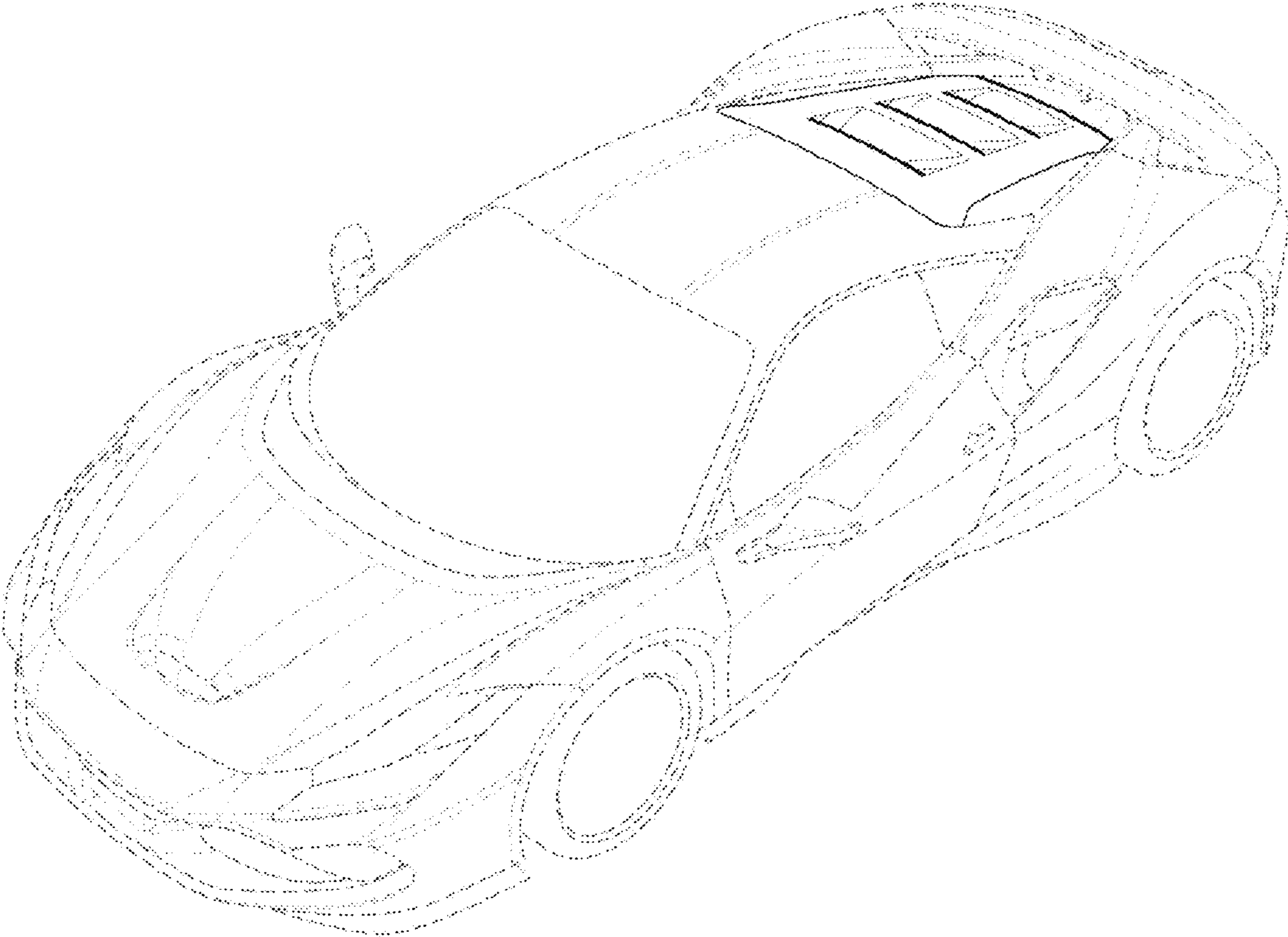

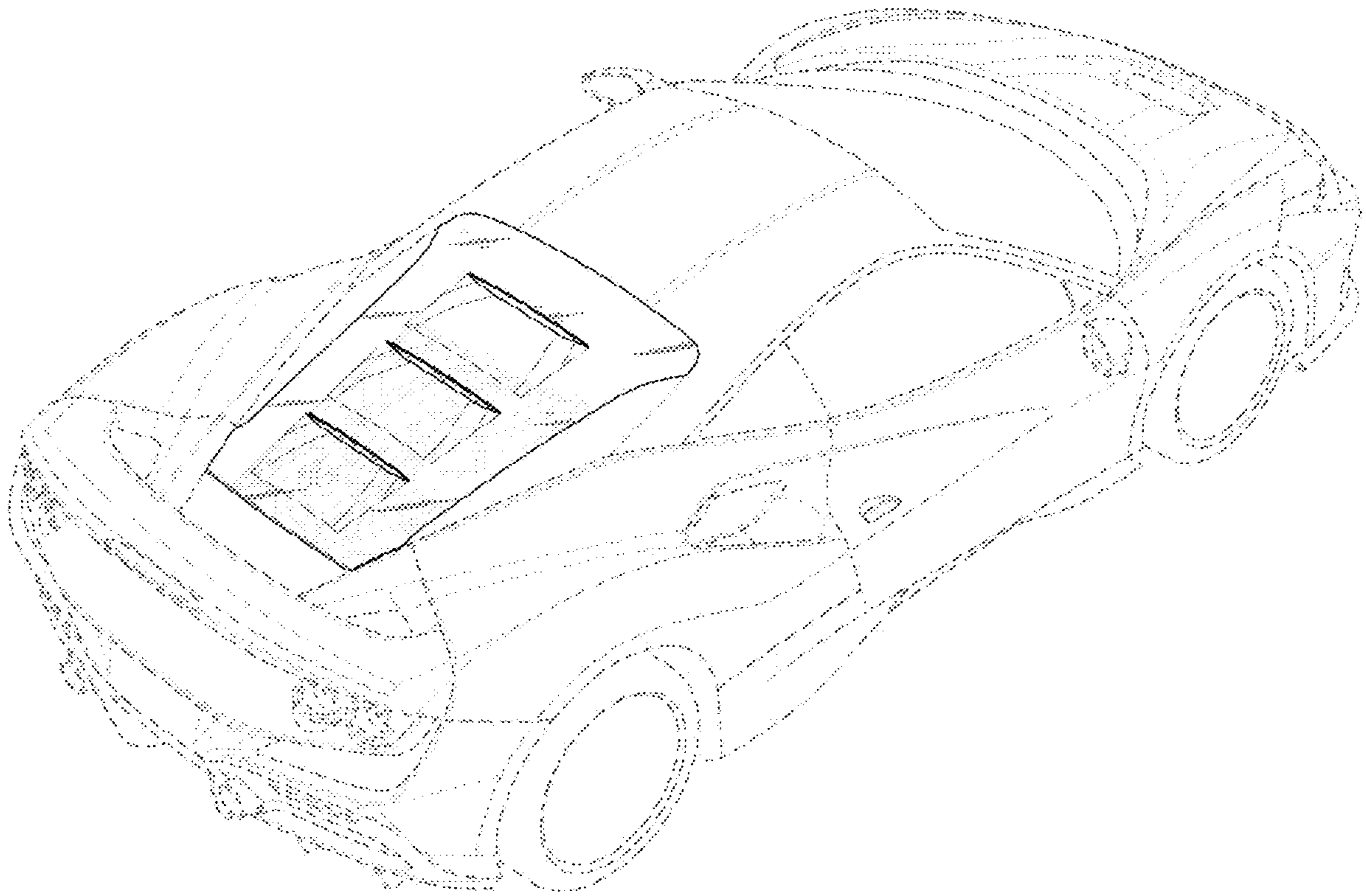

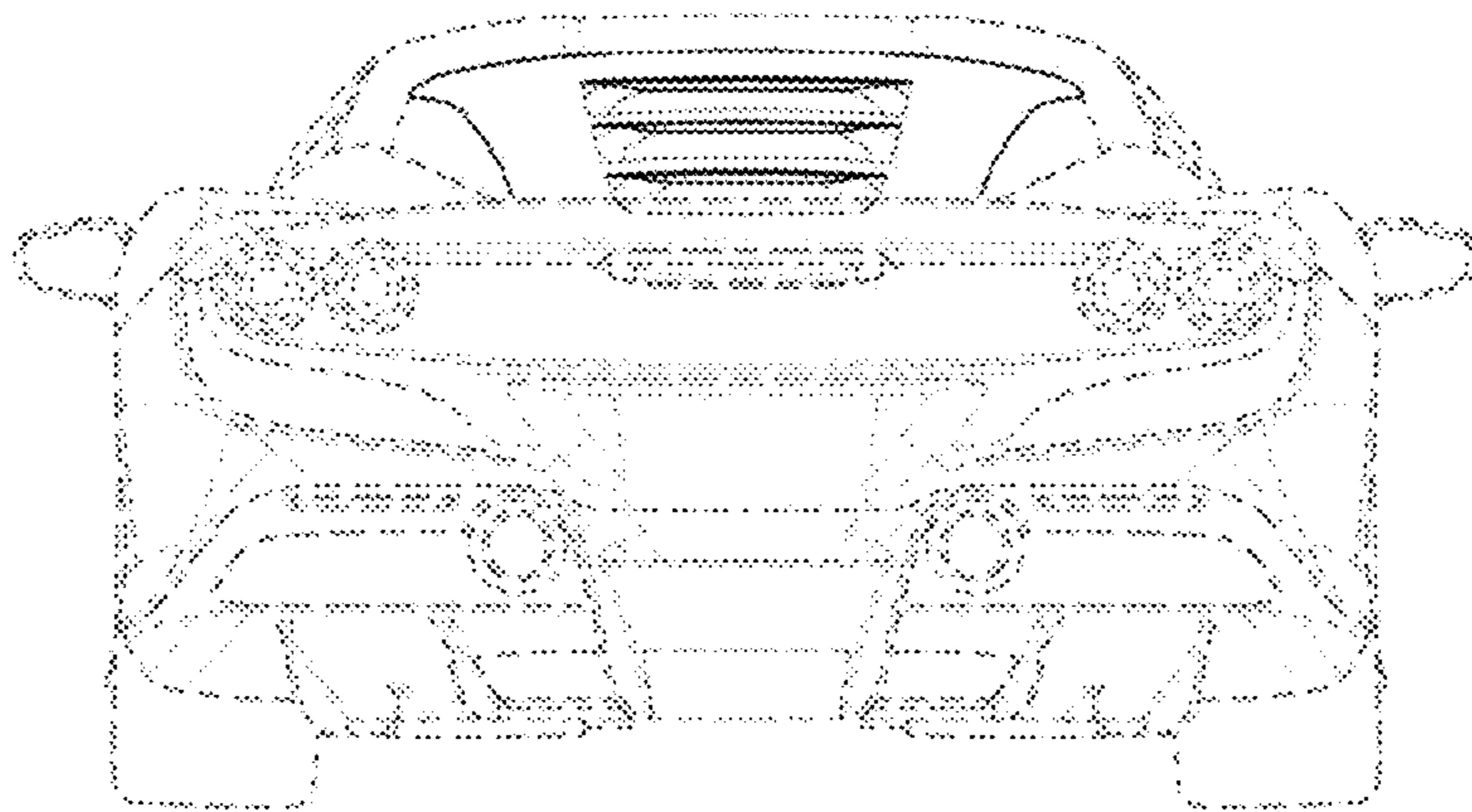

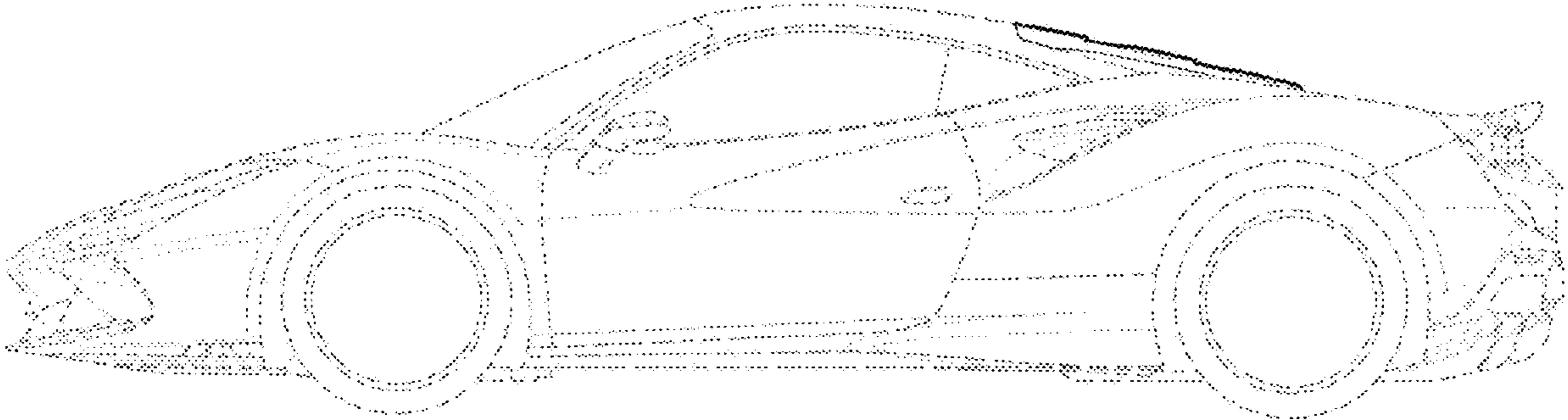

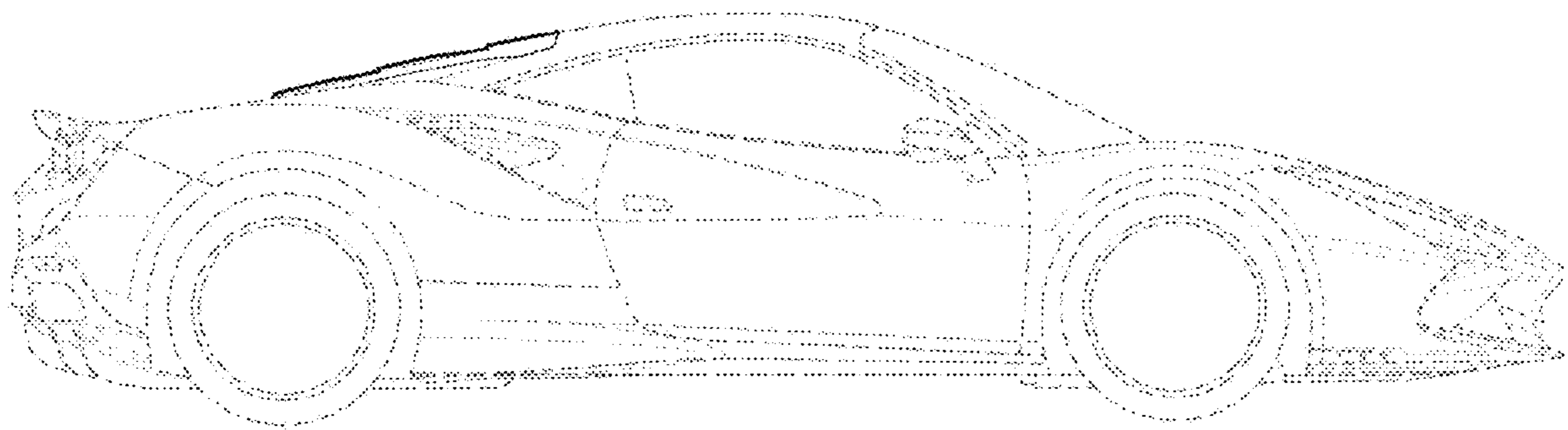
