FIG. 9 is an enlarged view of the encircled portion in FIG. 8.

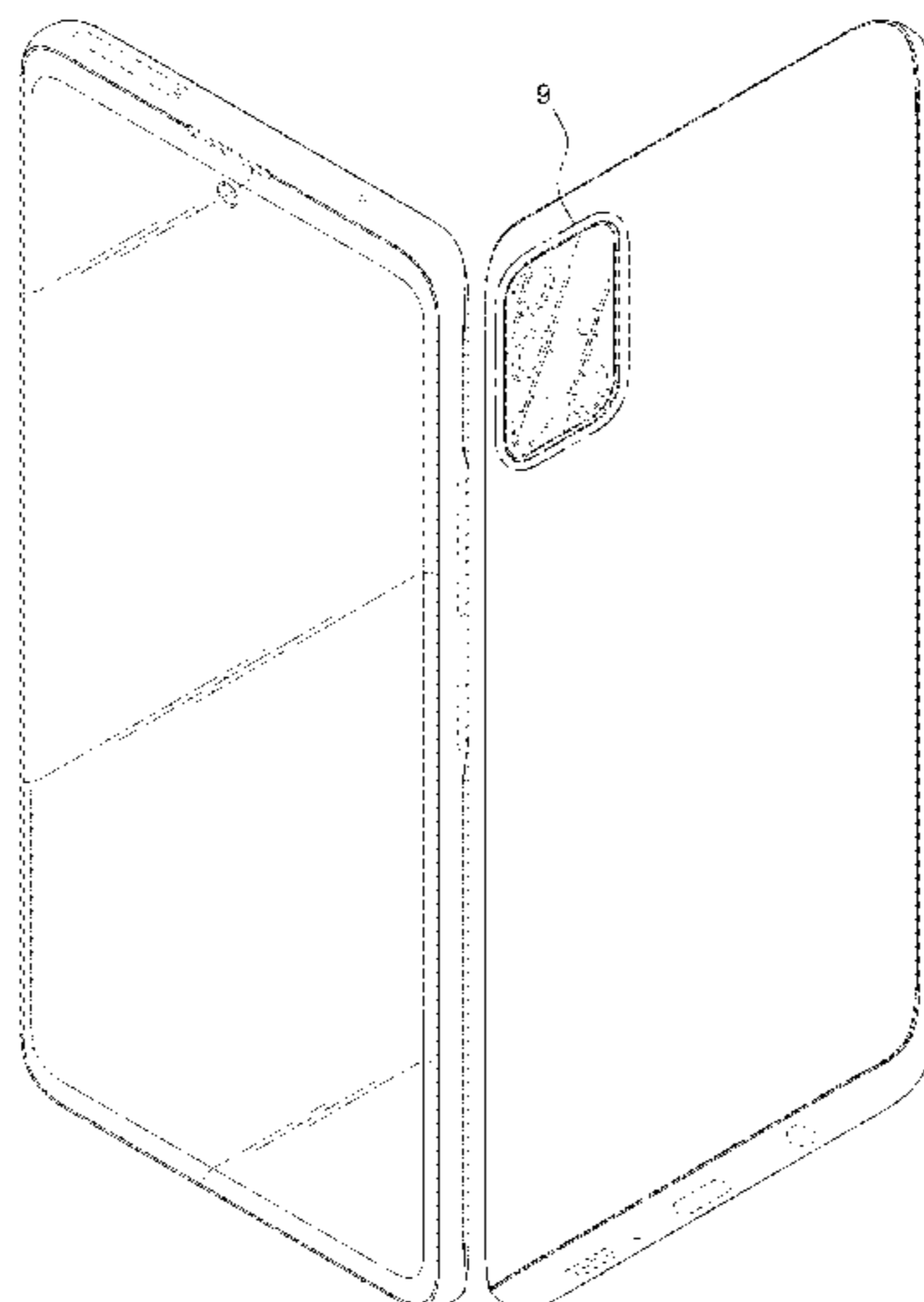

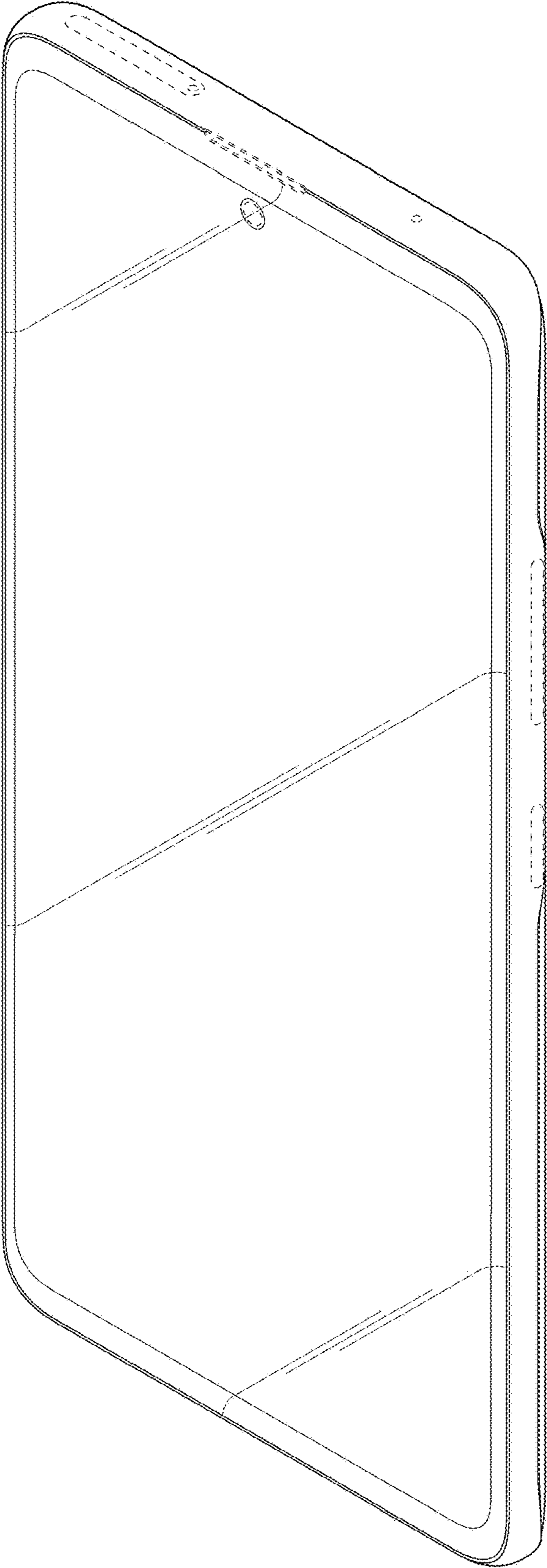

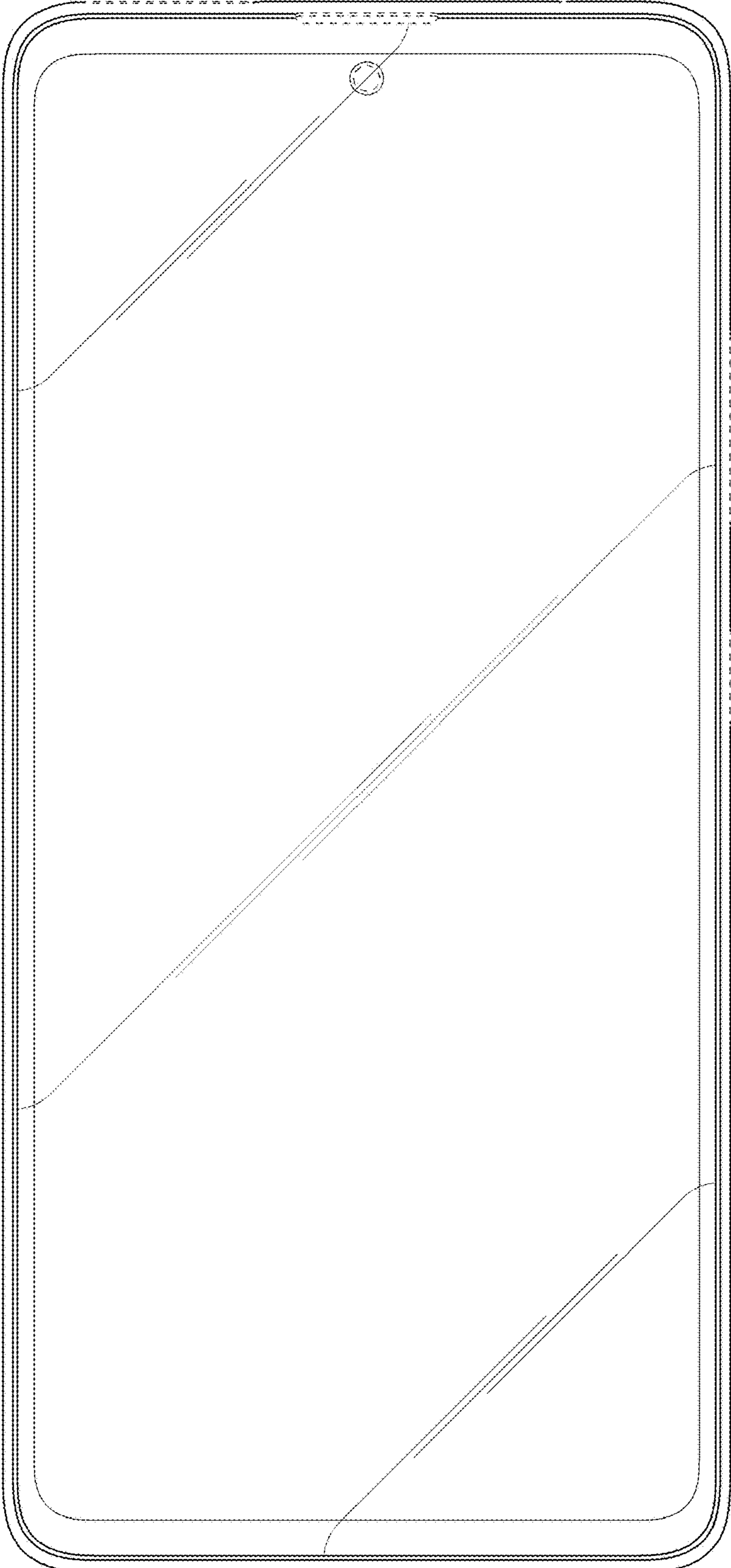

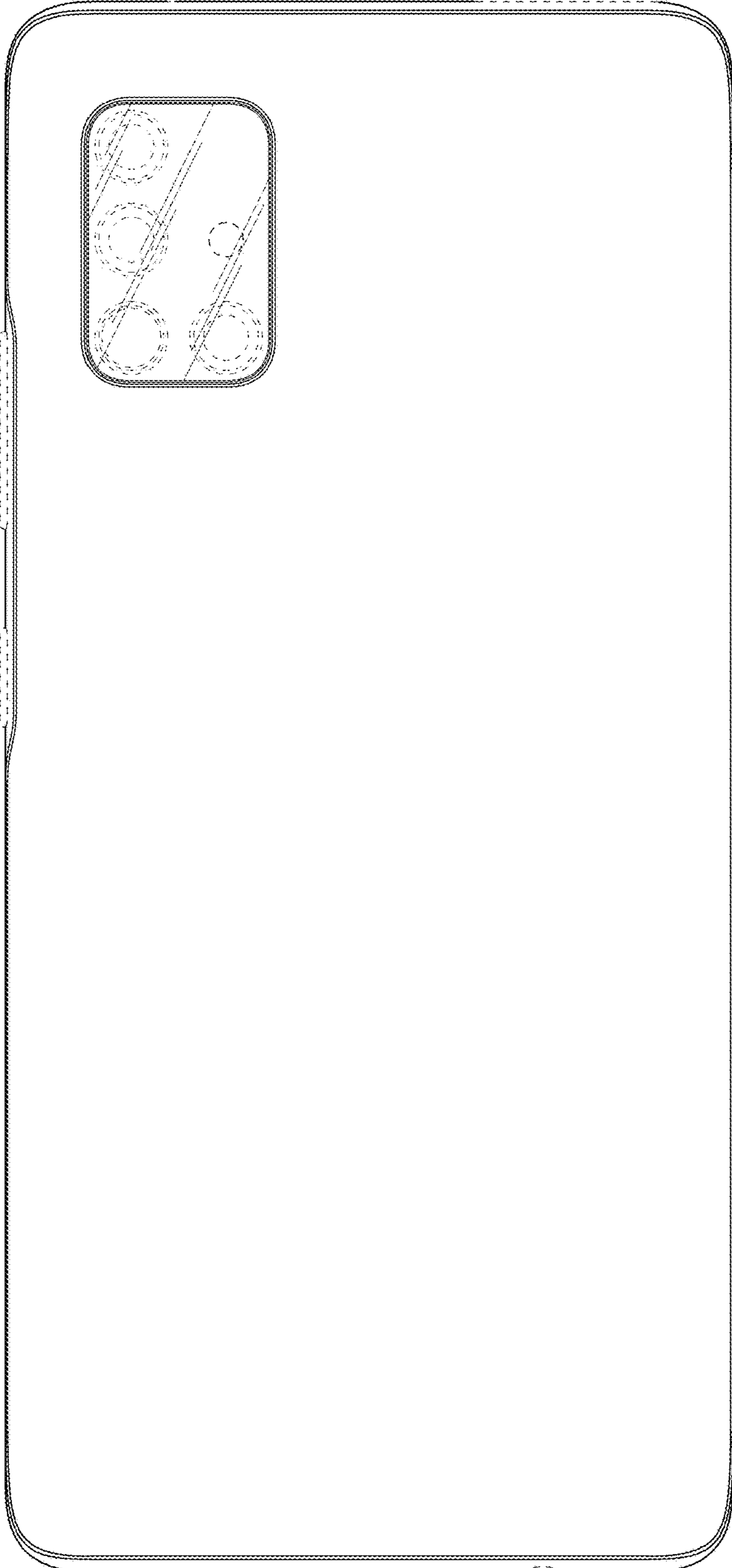

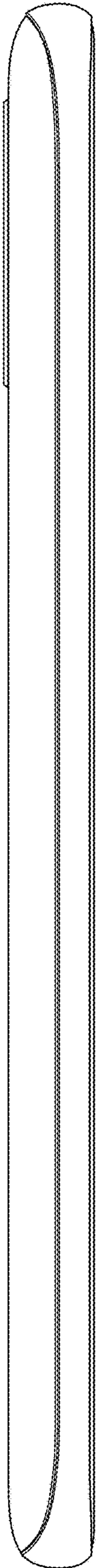

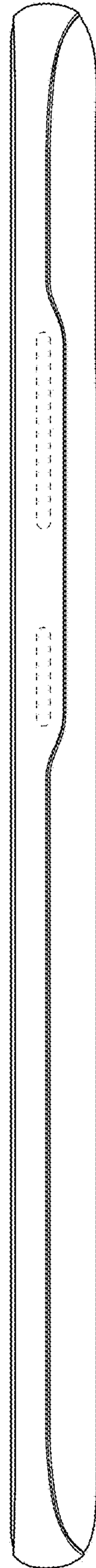

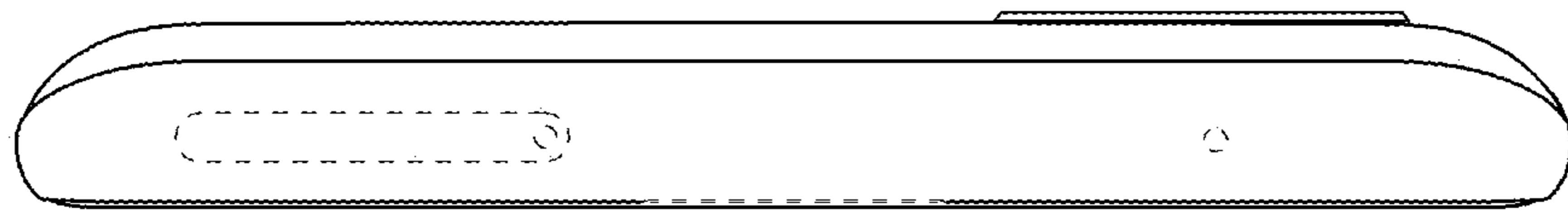

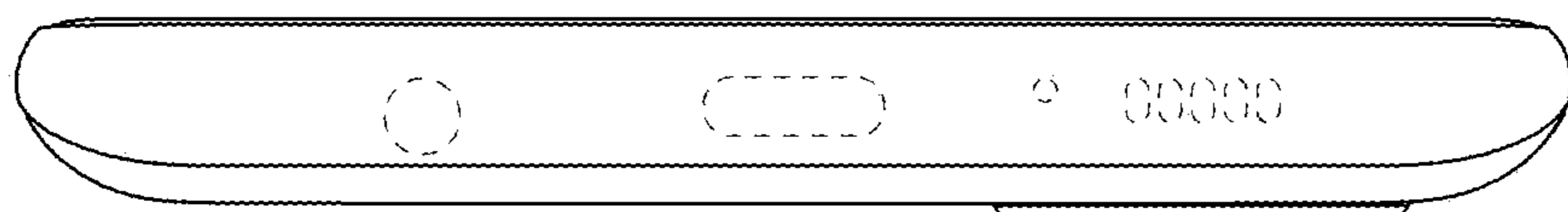

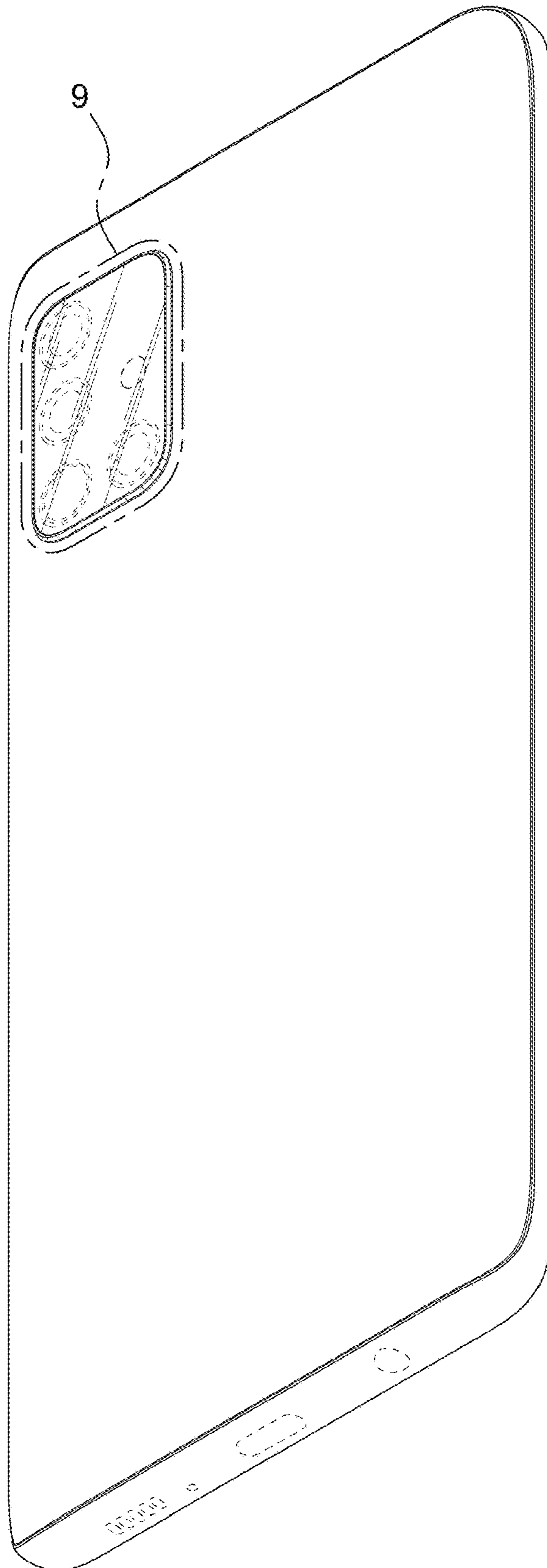
