(57) **CLAIM**

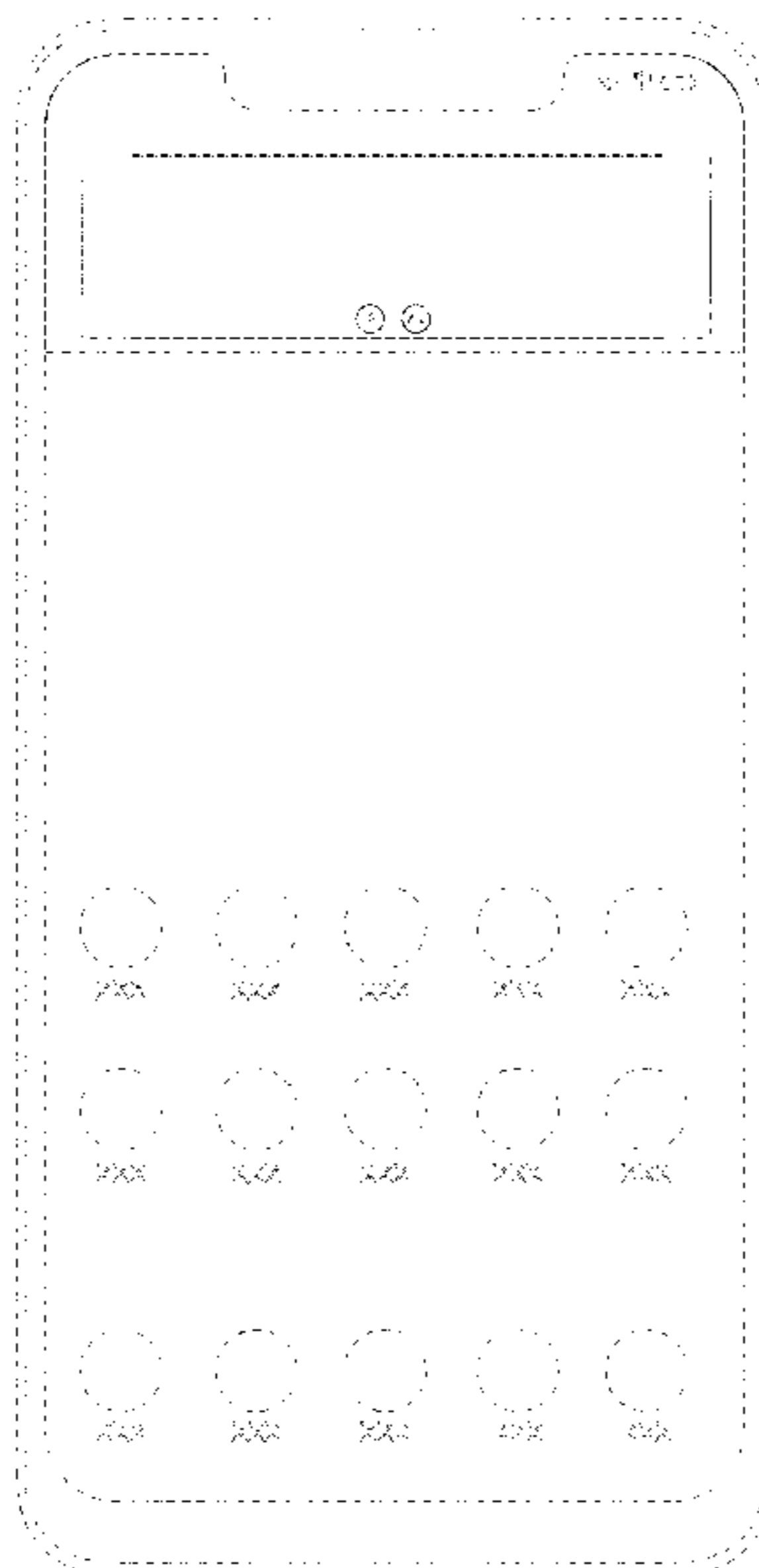
The ornamental design for a display screen or a portion thereof with graphical user interface, as shown and described.
