(57) **CLAIM**

The ornamental design for a golf chipping game, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a golf chipping game showing the claimed design

FIG. 2 is a top view of the golf chipping game shown in FIG. 1;

FIG. 3 is a bottom view of the golf chipping game shown in FIG. 1

FIG. 4 is a right-side view of the golf chipping game shown in FIG. 1;

FIG. 5 is a left-side view of the golf chipping game shown in FIG. 1;

FIG. 6 is a front view of the golf chipping game shown in FIG. 1;

FIG. 7 is a back view of the golf chipping game shown in FIG. 1; and,

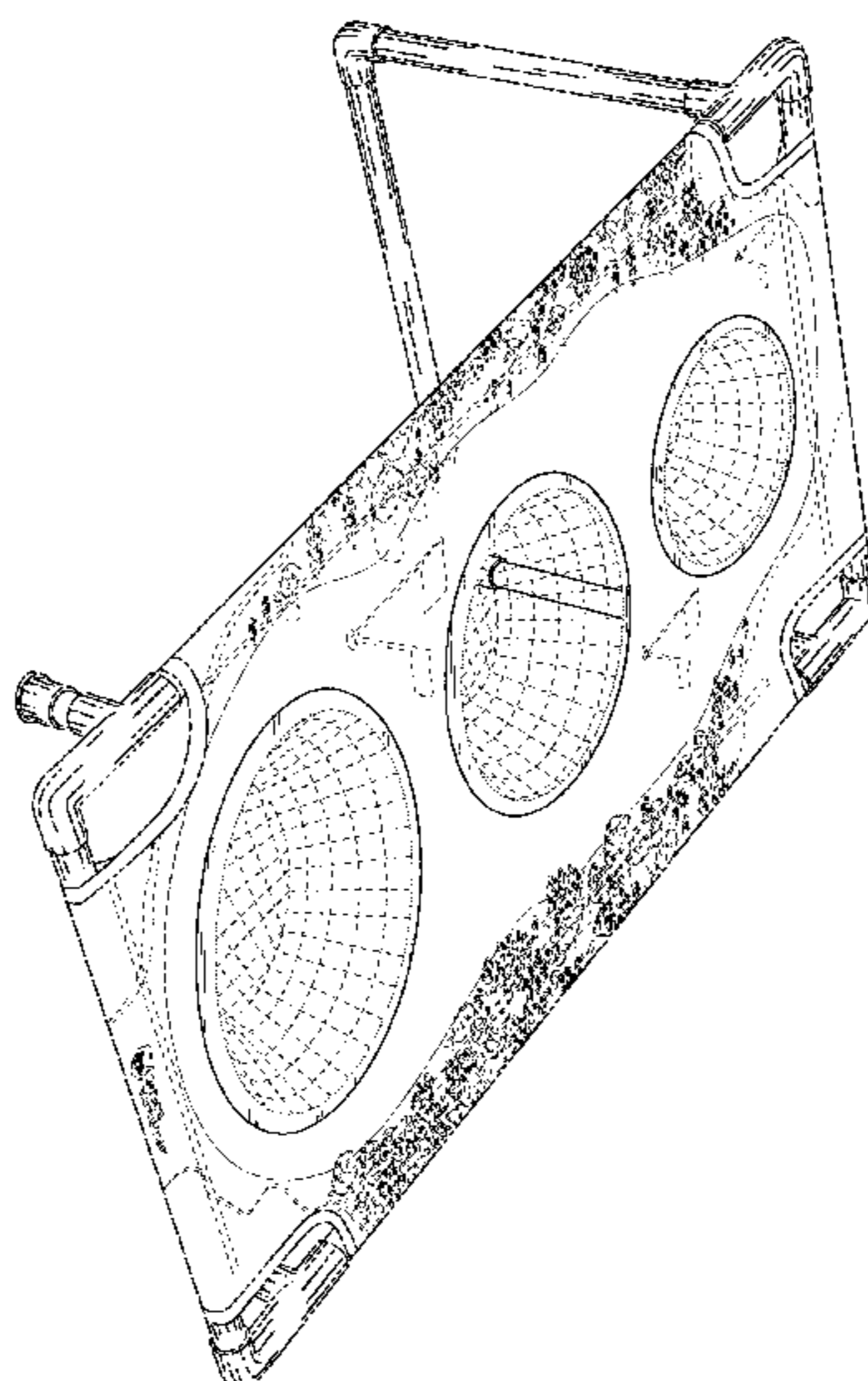
FIG. 8 is an enlarged view of the enlarged area as designated in FIG. 2.

The dash-dot-dash lines in FIGS. 2, 3, and 8 depict bounds of the enlarged portion. All broken lines showing the foliage, depict portions of the golf chipping game that form no part of the claimed design.

The long-short broken lines in FIGS. 2 and 8 depict bounds of the magnified portions that form no part of the claim. All remaining broken lines, depict portions of the golf chipping game that form no part of the claimed design.

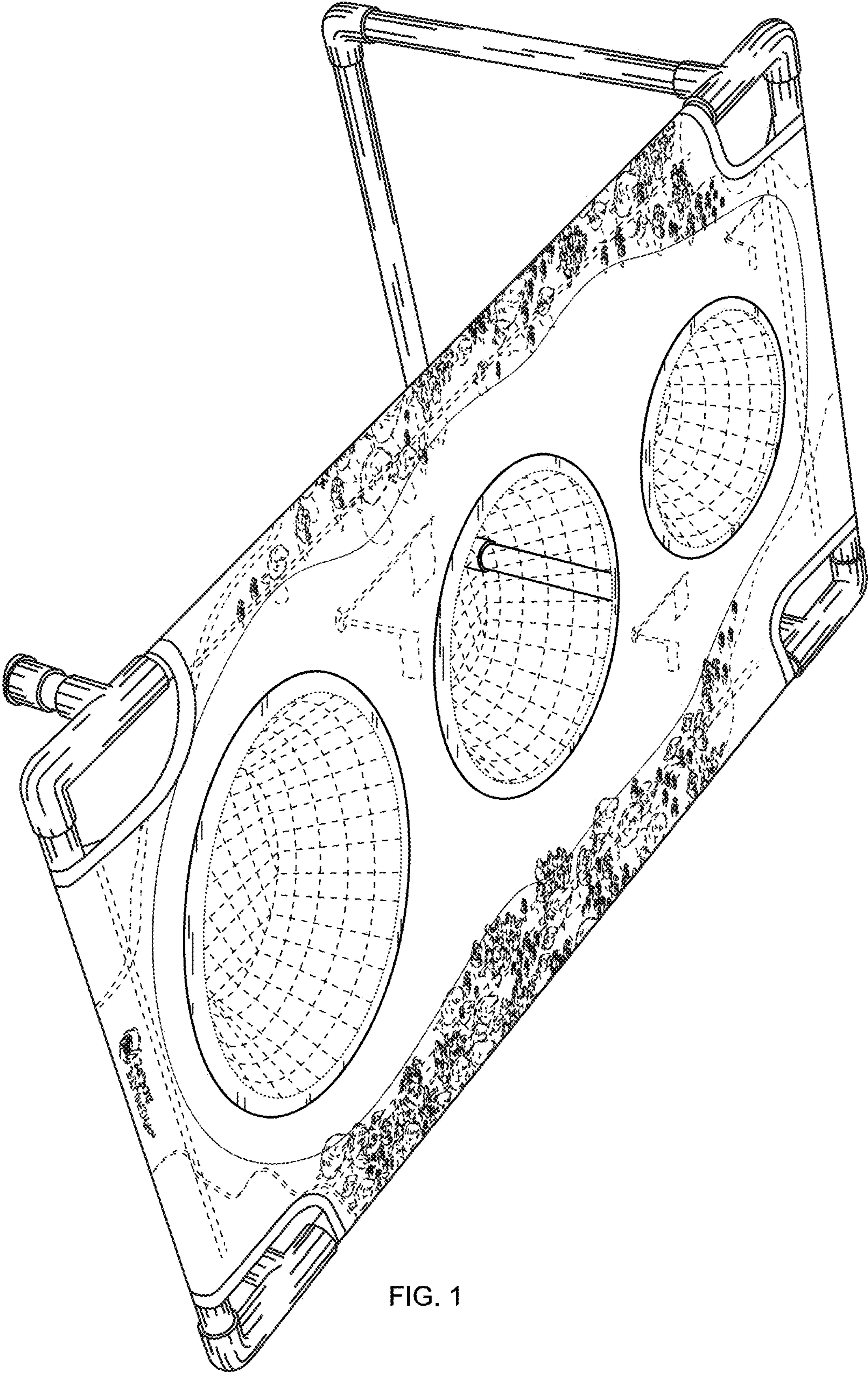

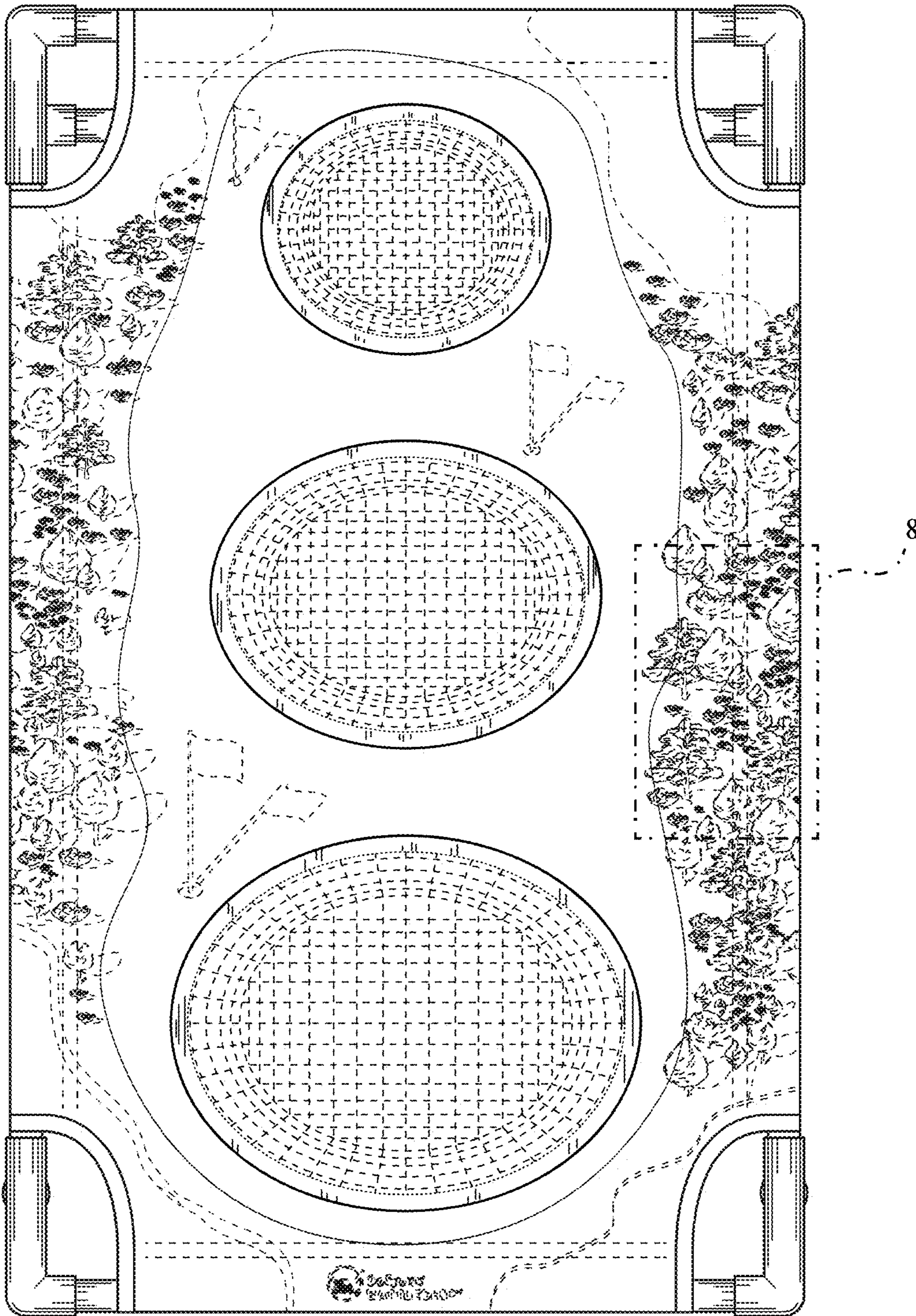

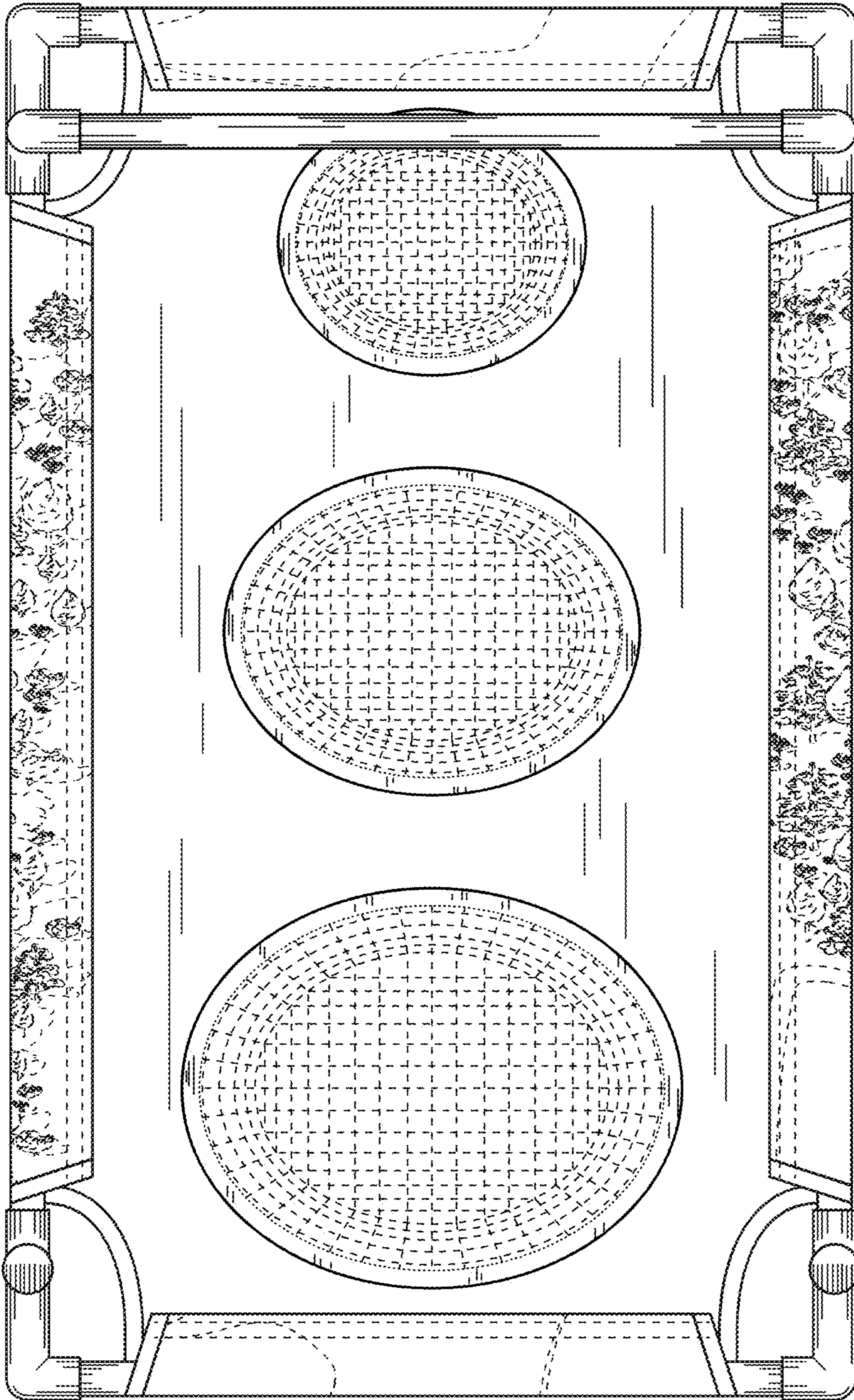

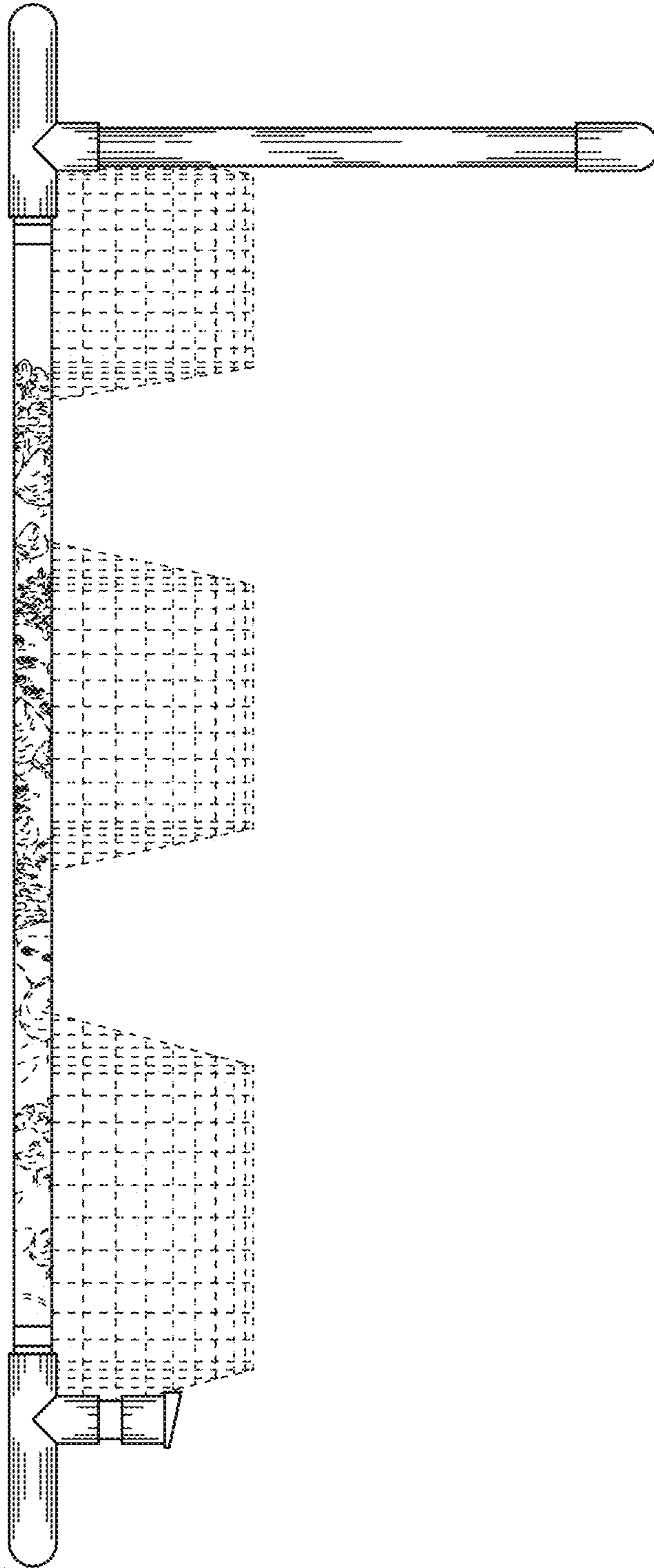

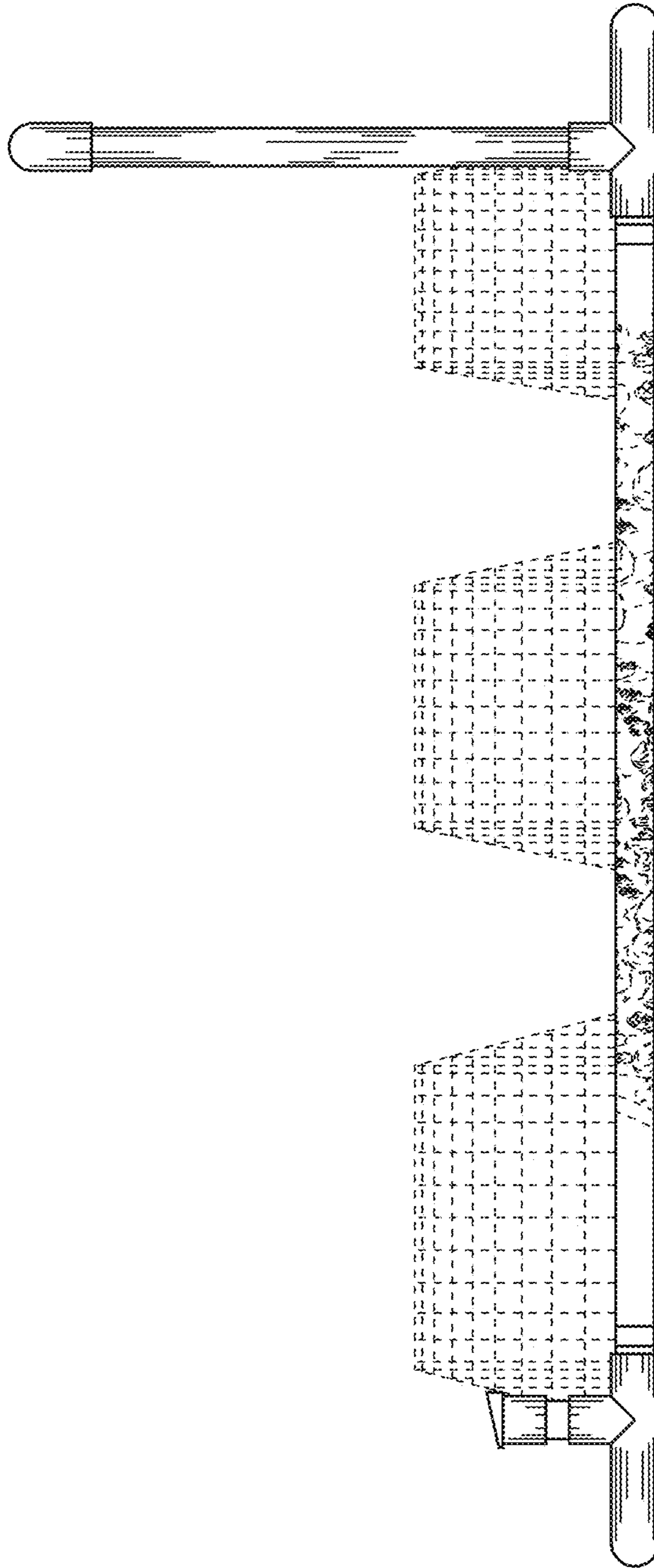

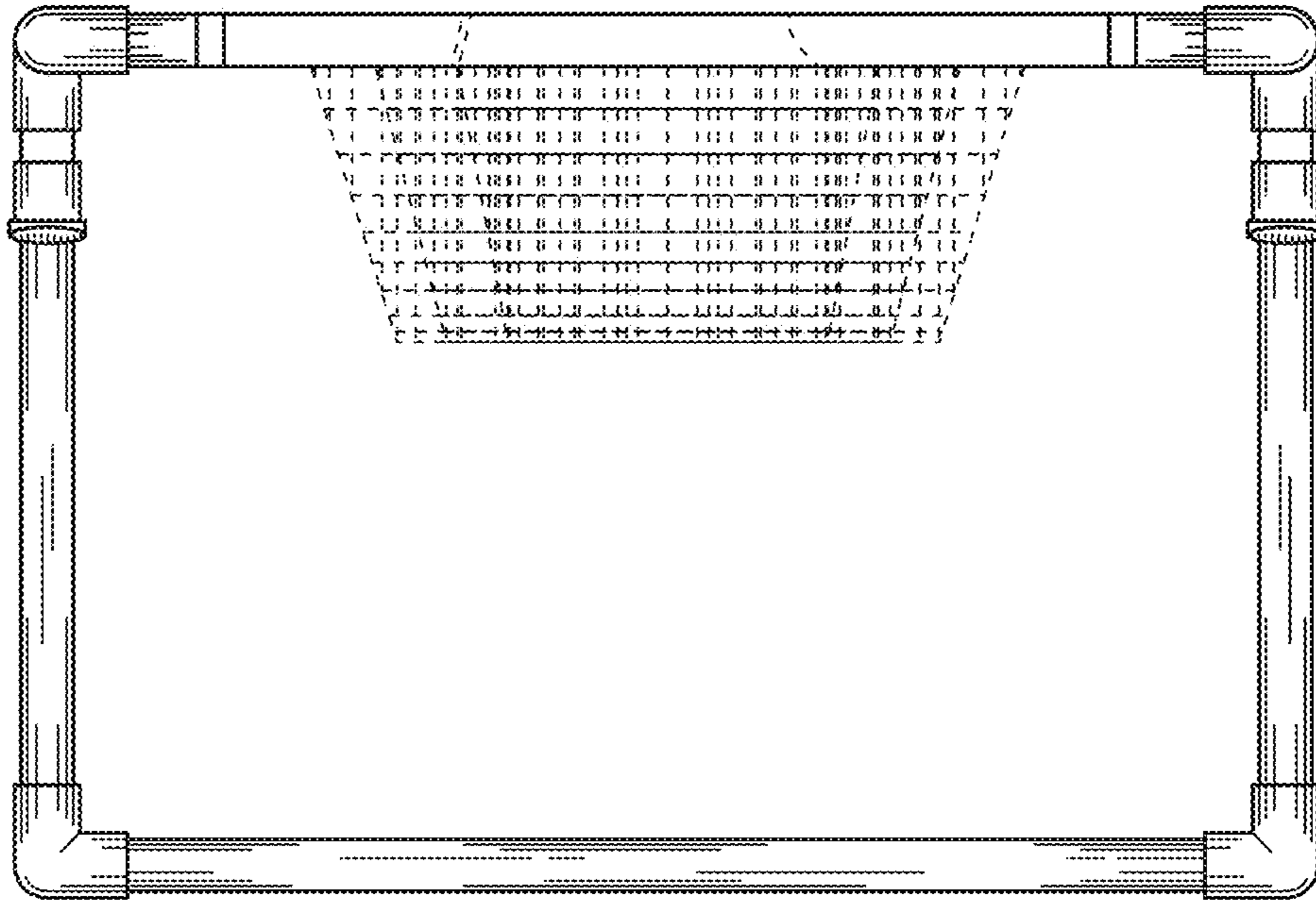

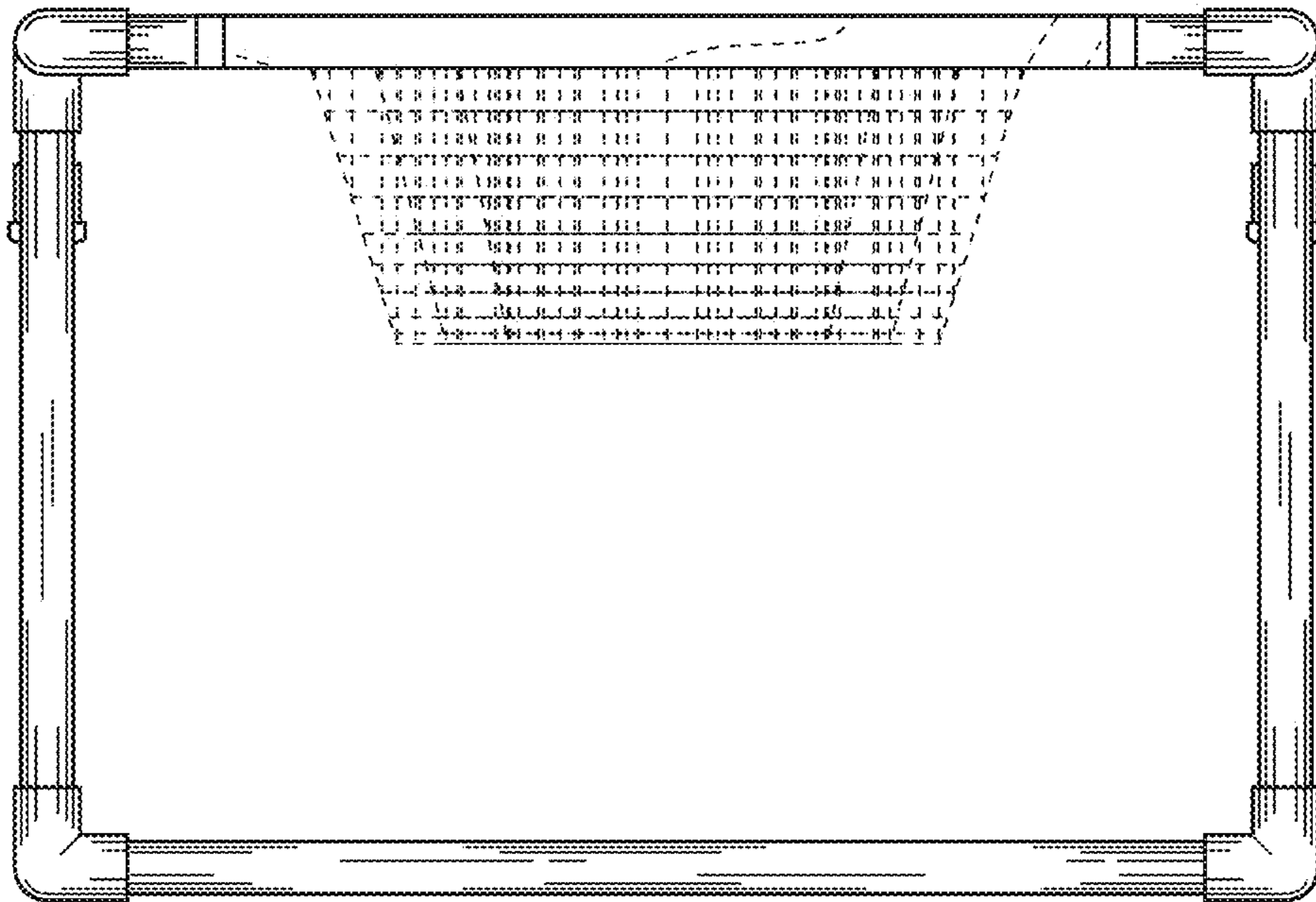
