(57) **CLAIM**

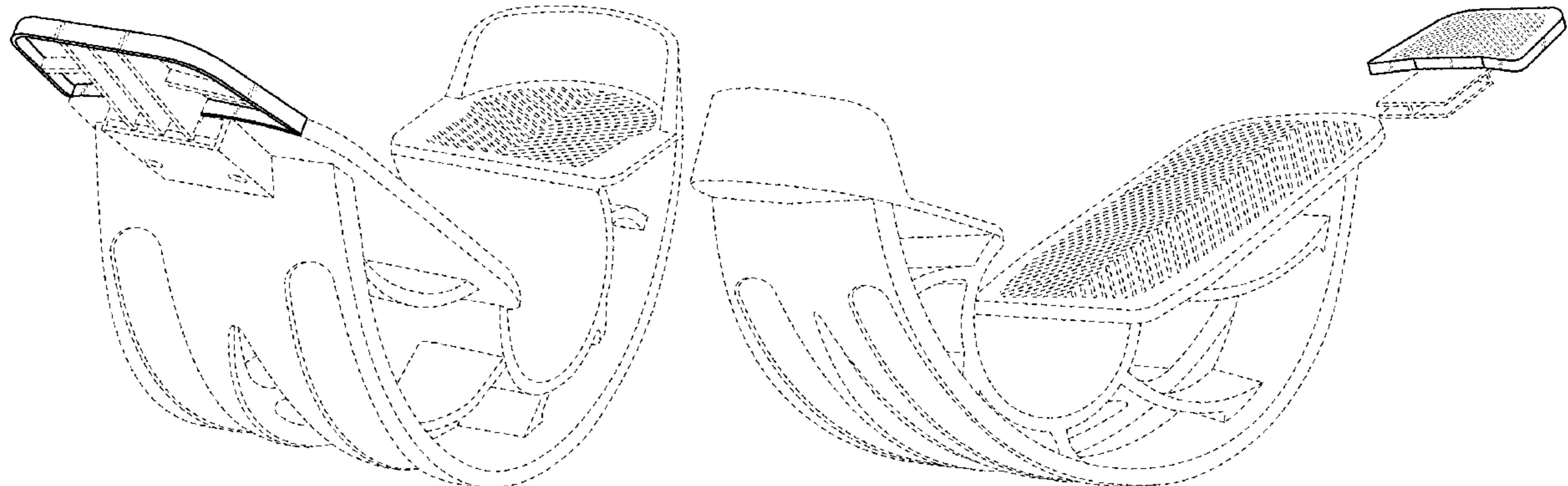
The ornamental design for a foot rocker, as shown and described.

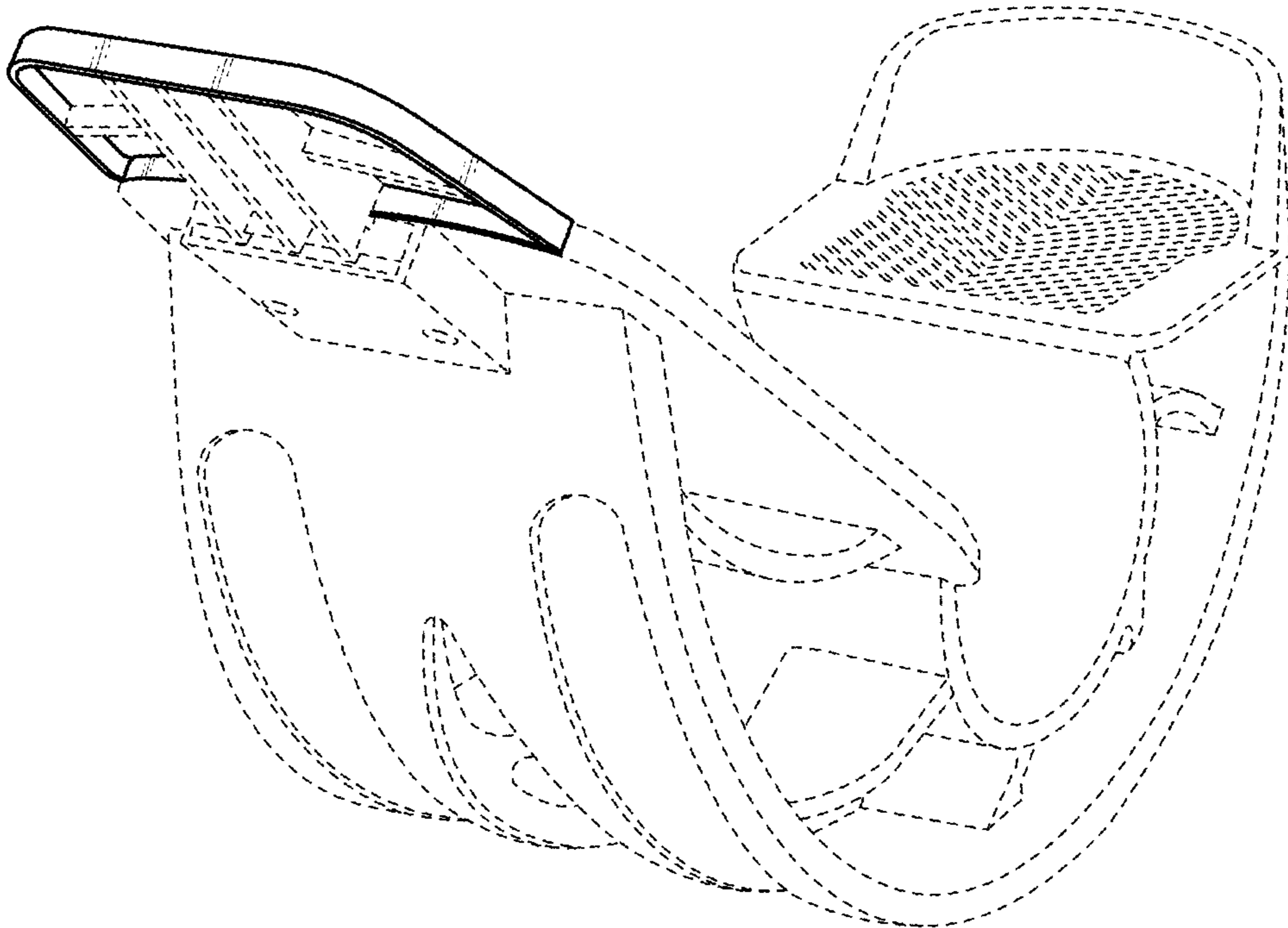

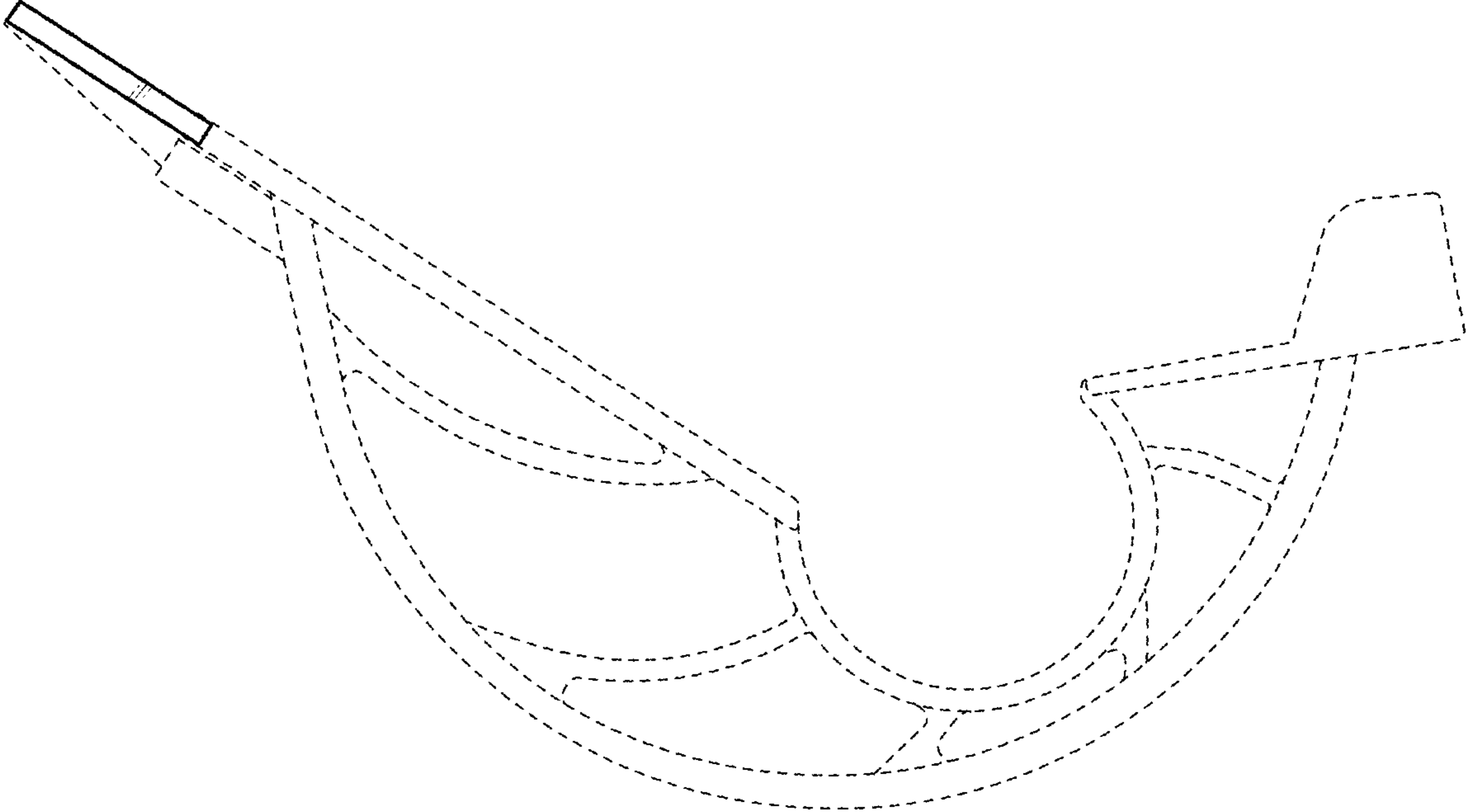

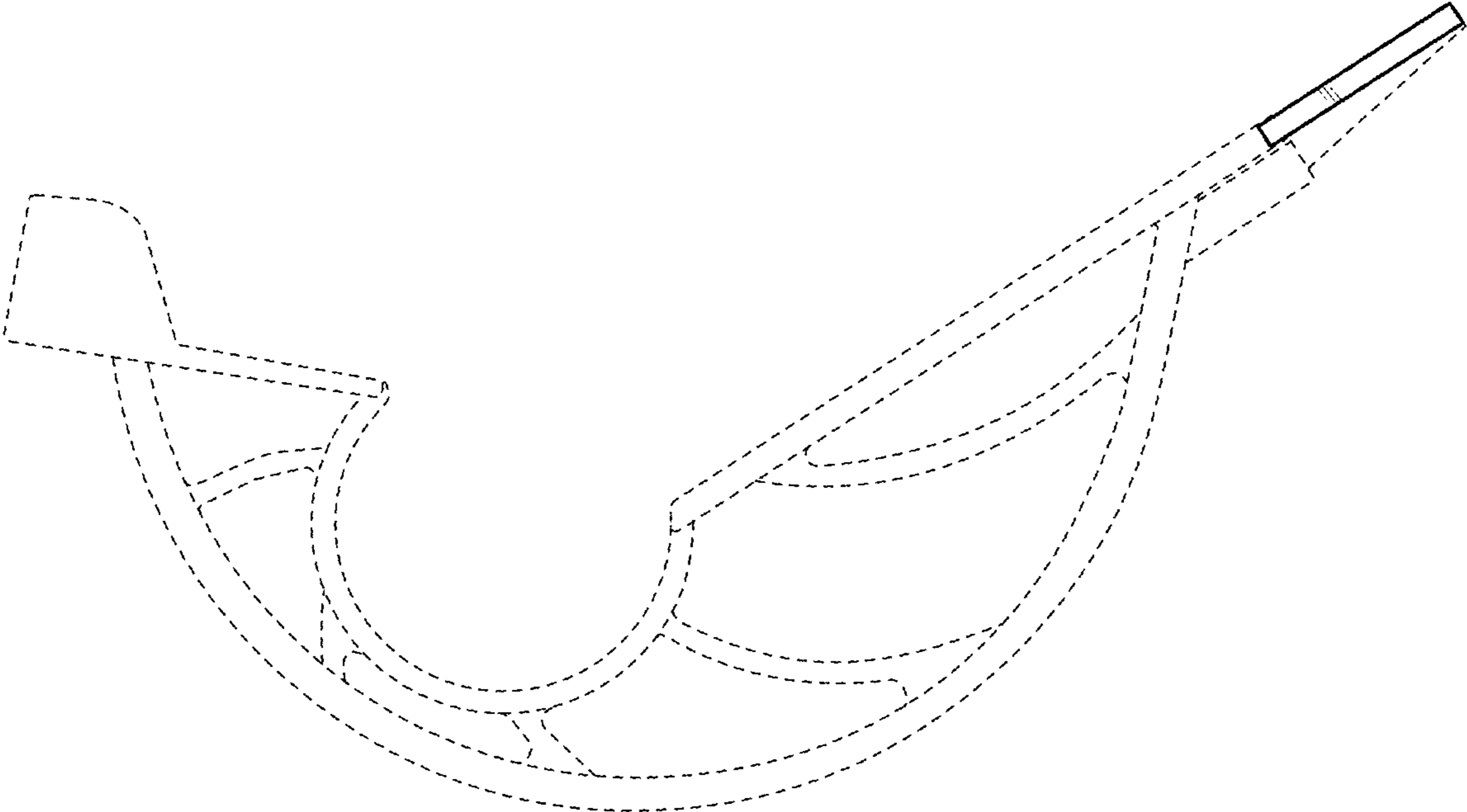

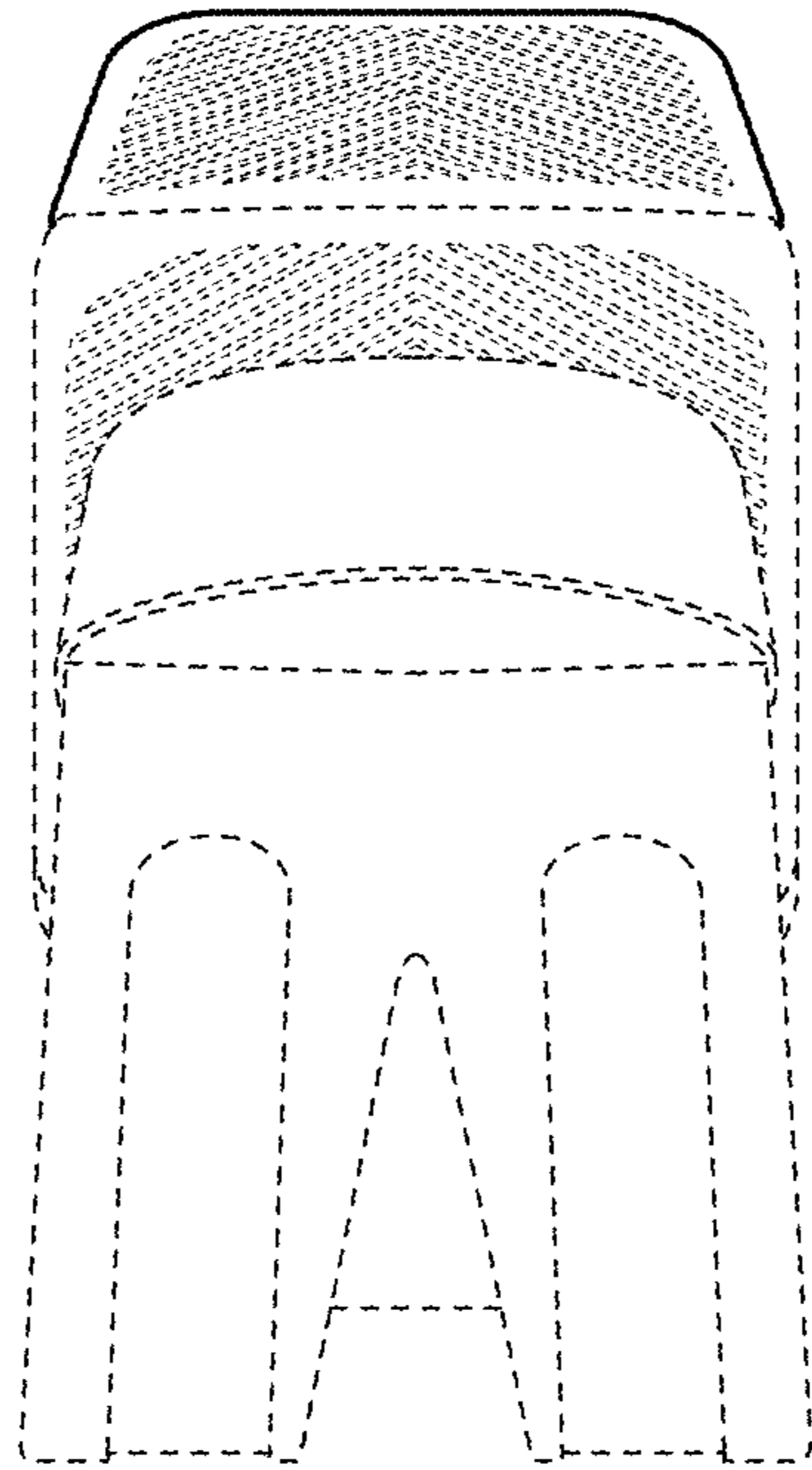

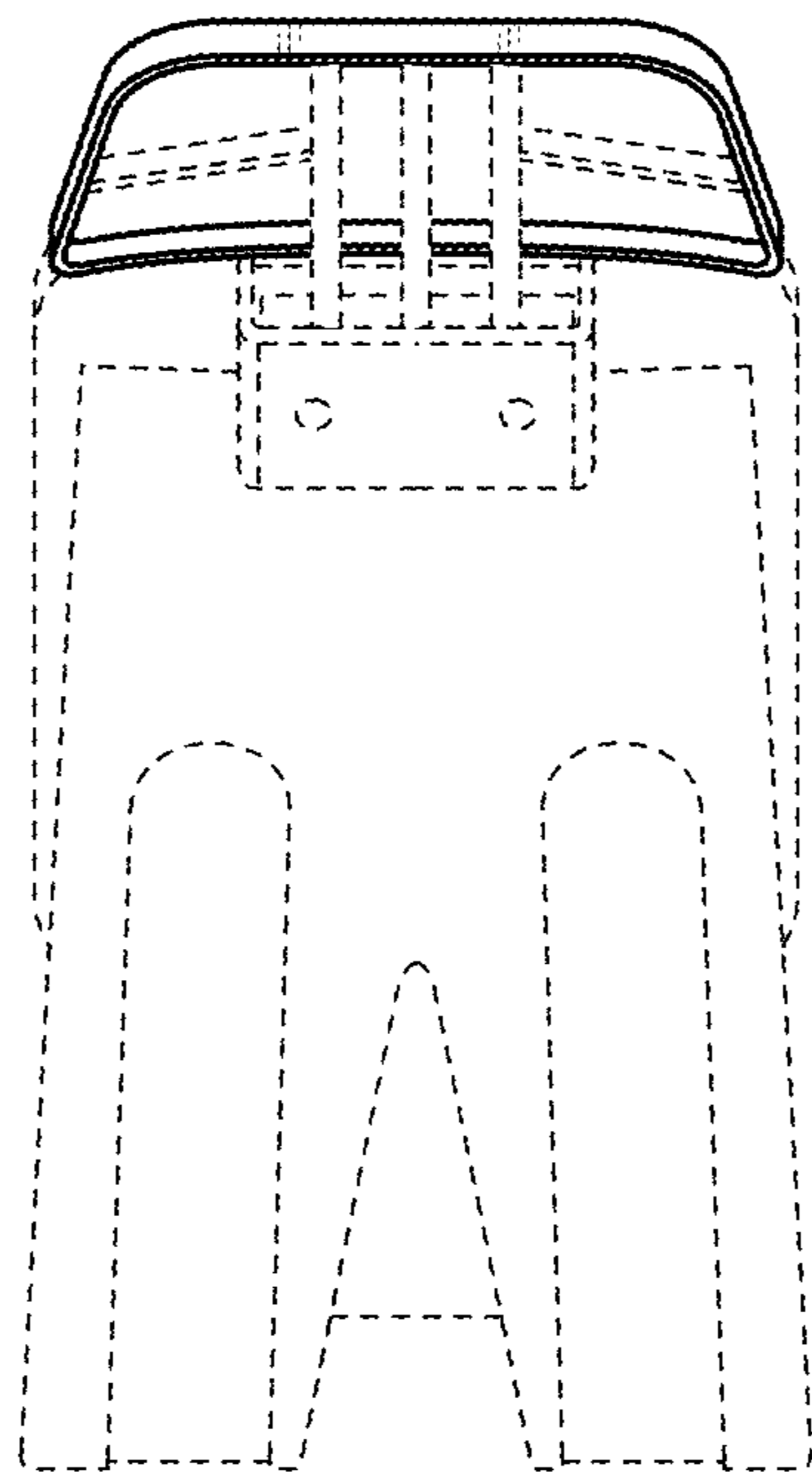

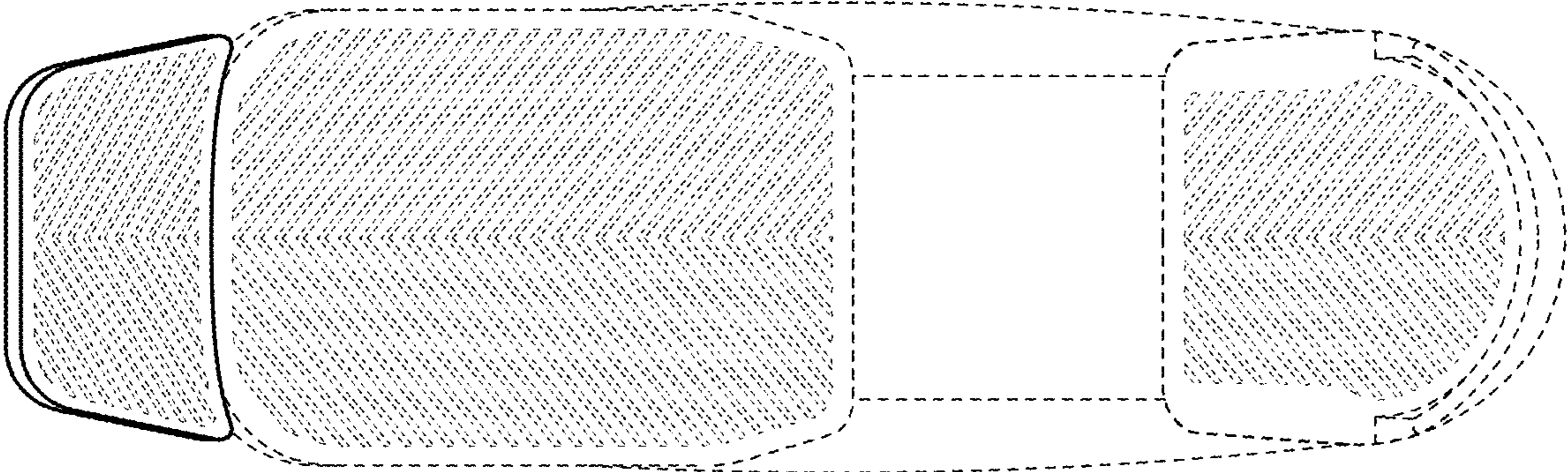

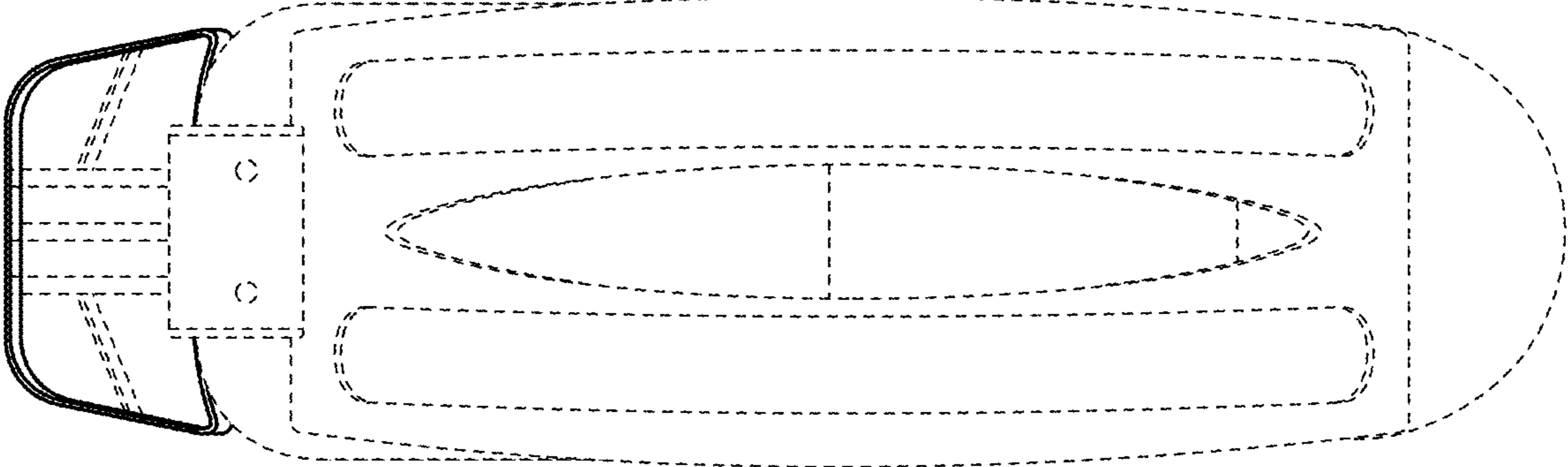

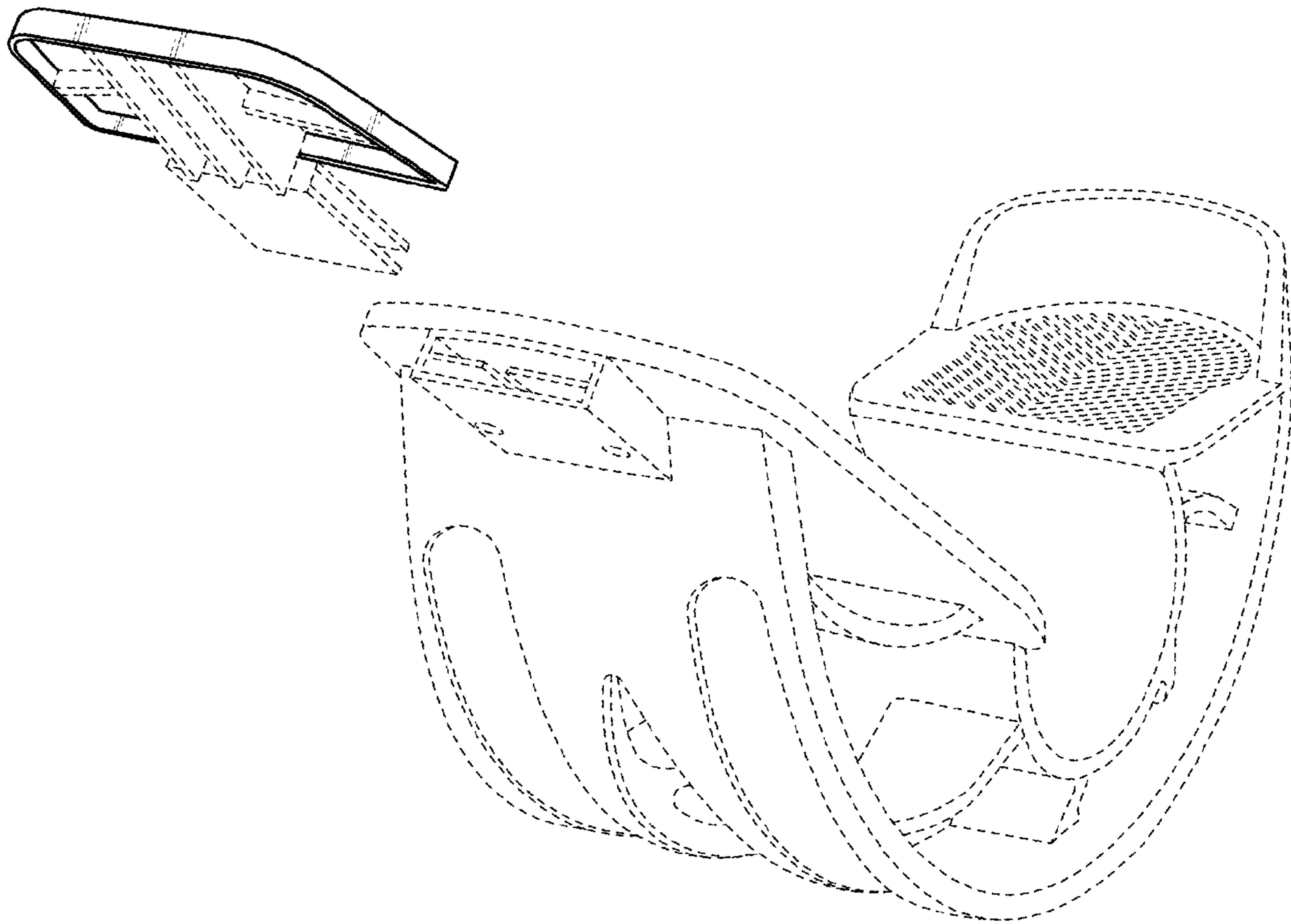

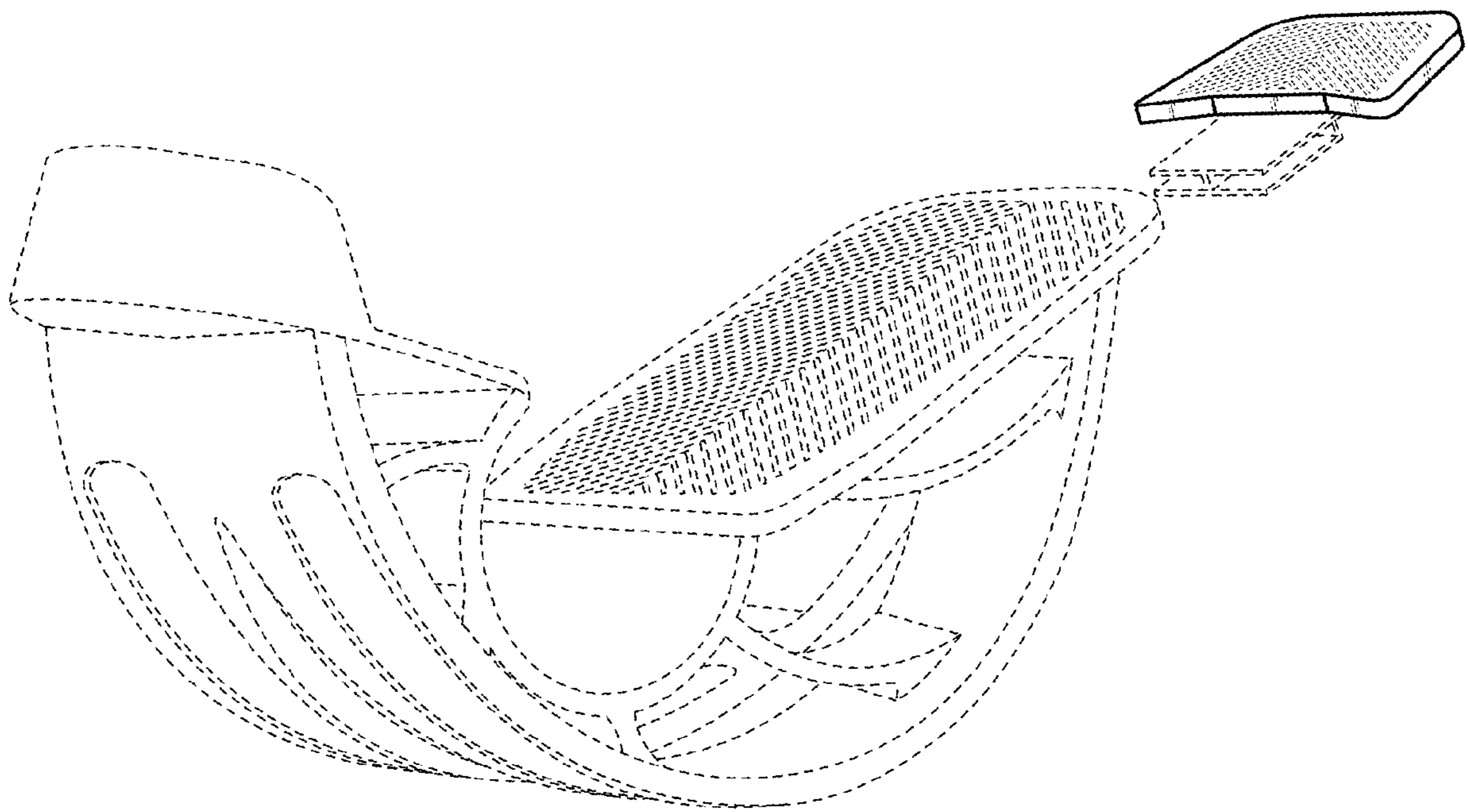
