FIG. 3 is a rear view thereof;

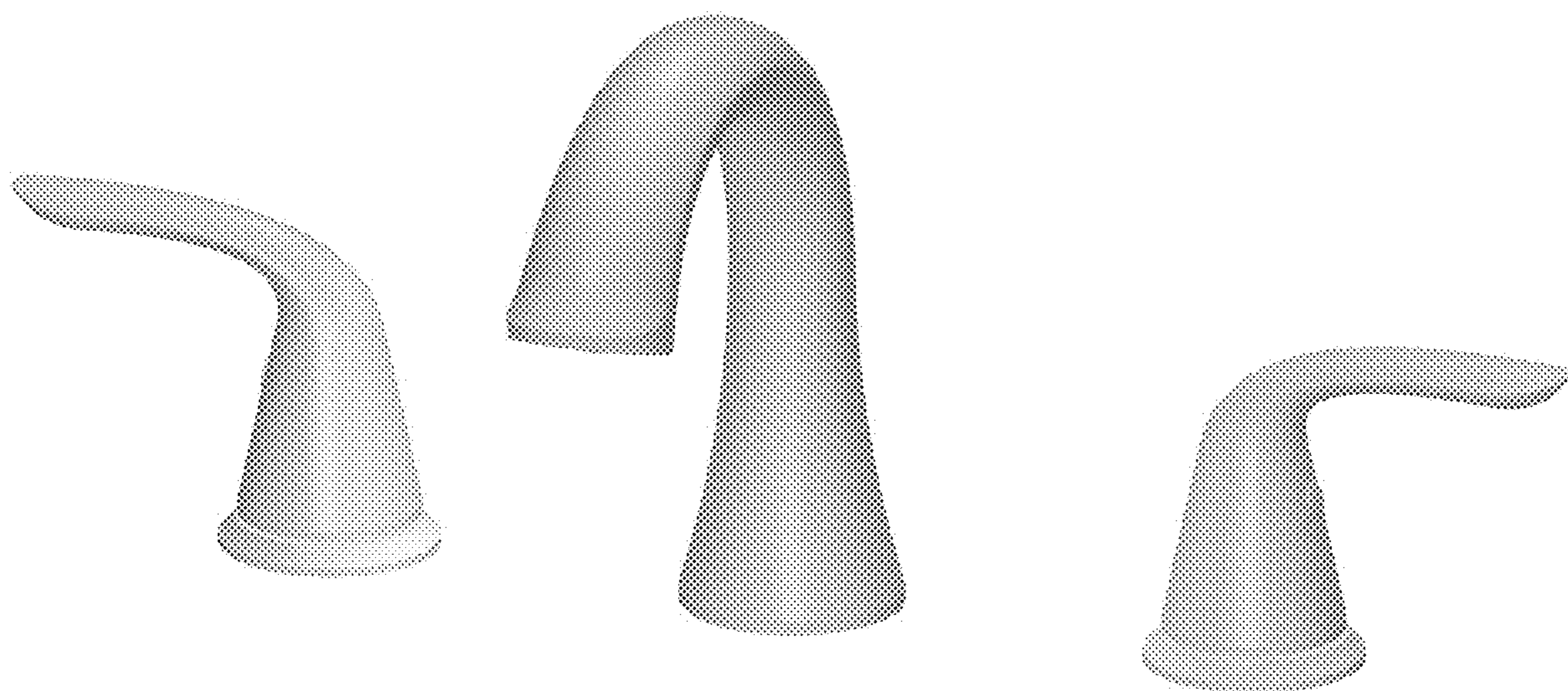
FIG. 4 is a left side elevational view thereof, the right side being a mirror image thereof; and,

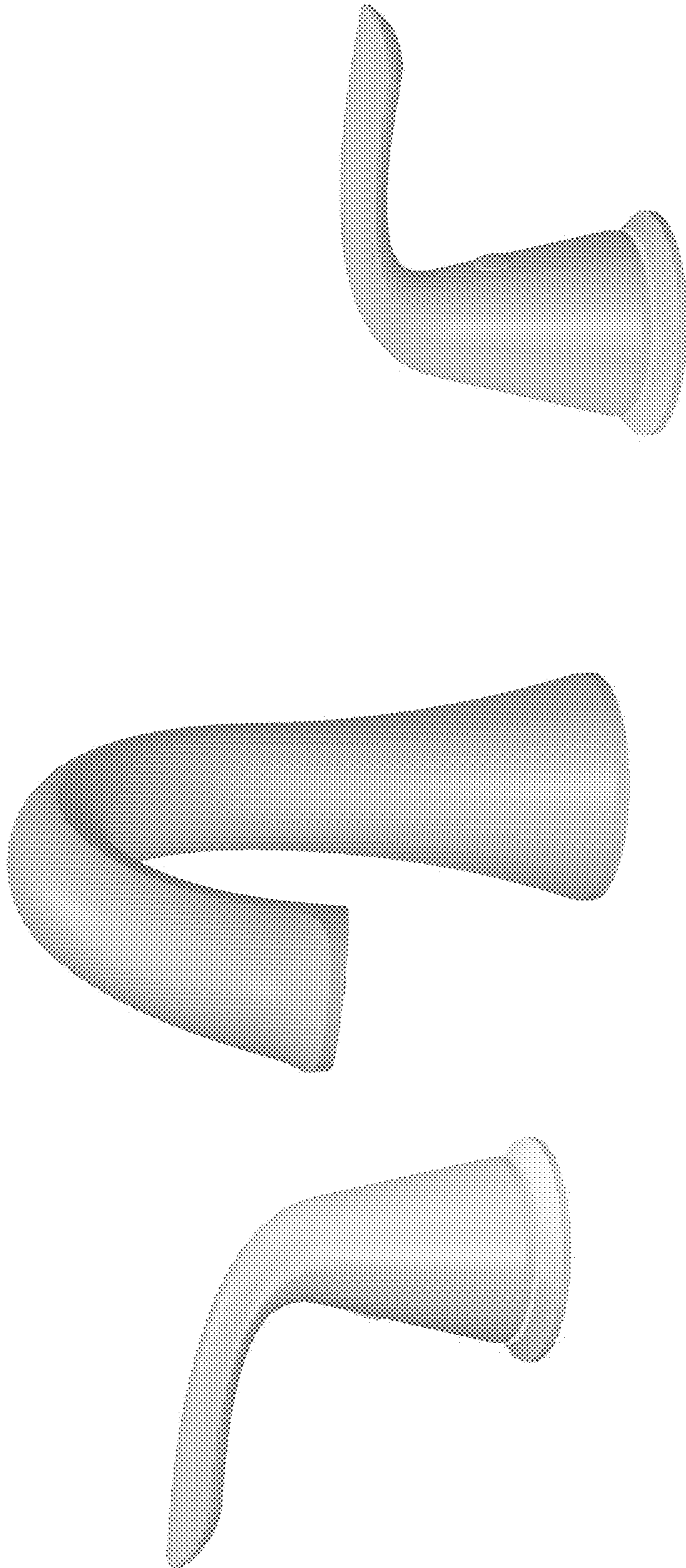

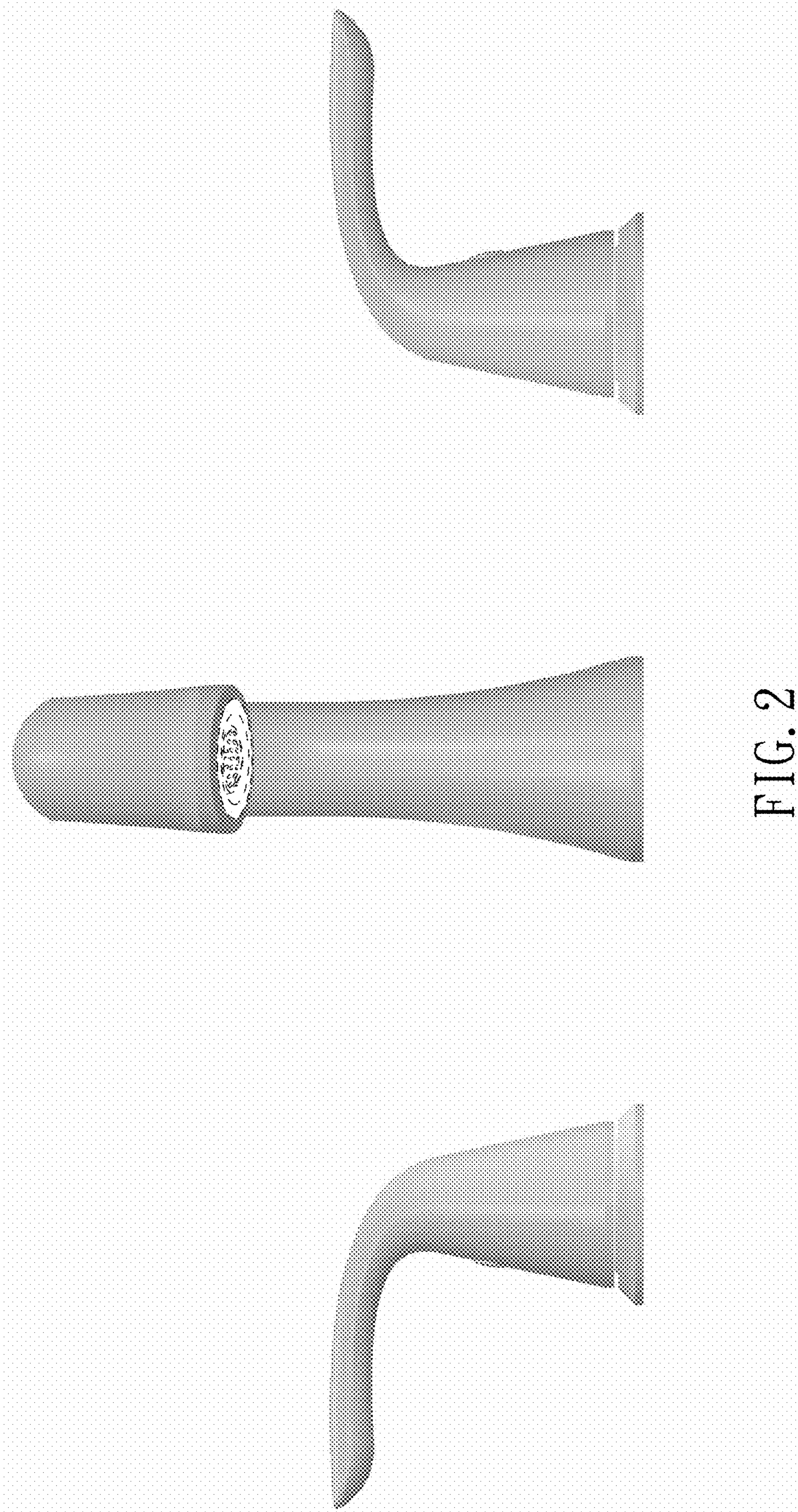

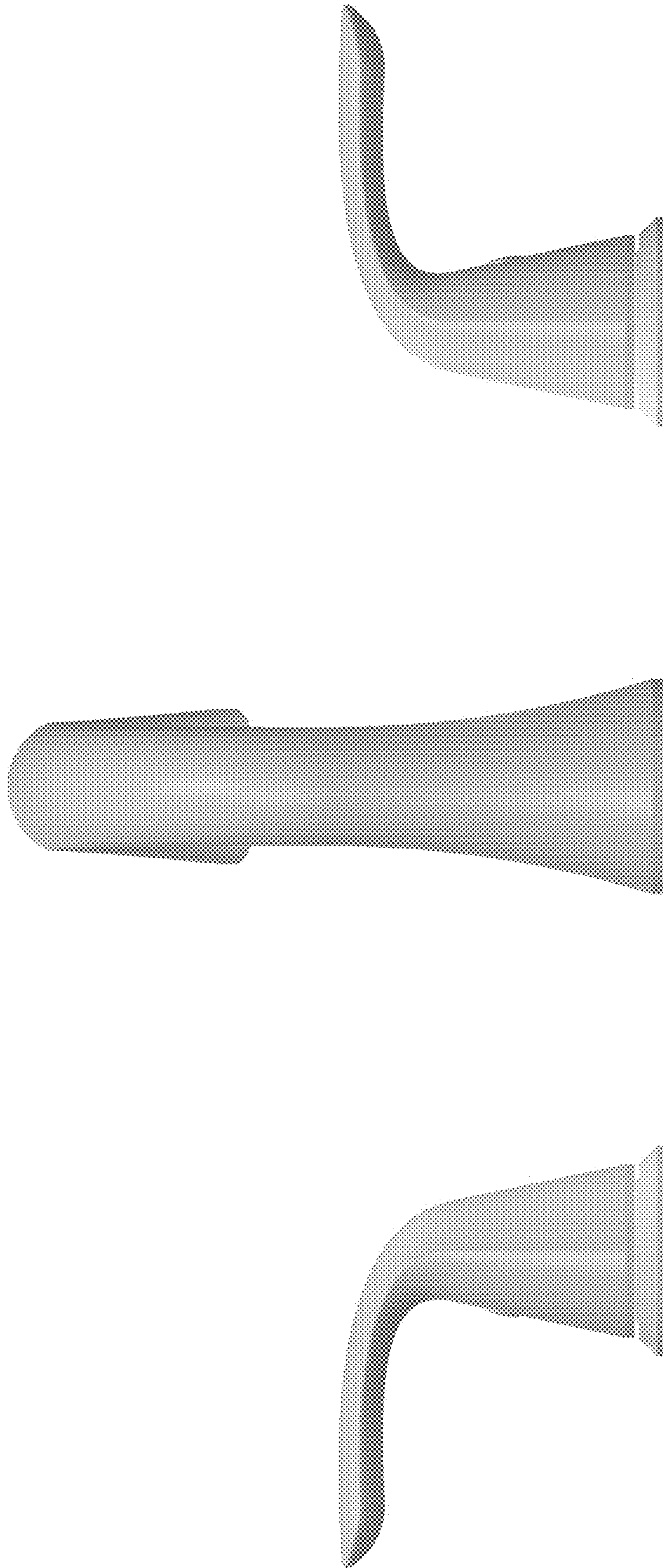

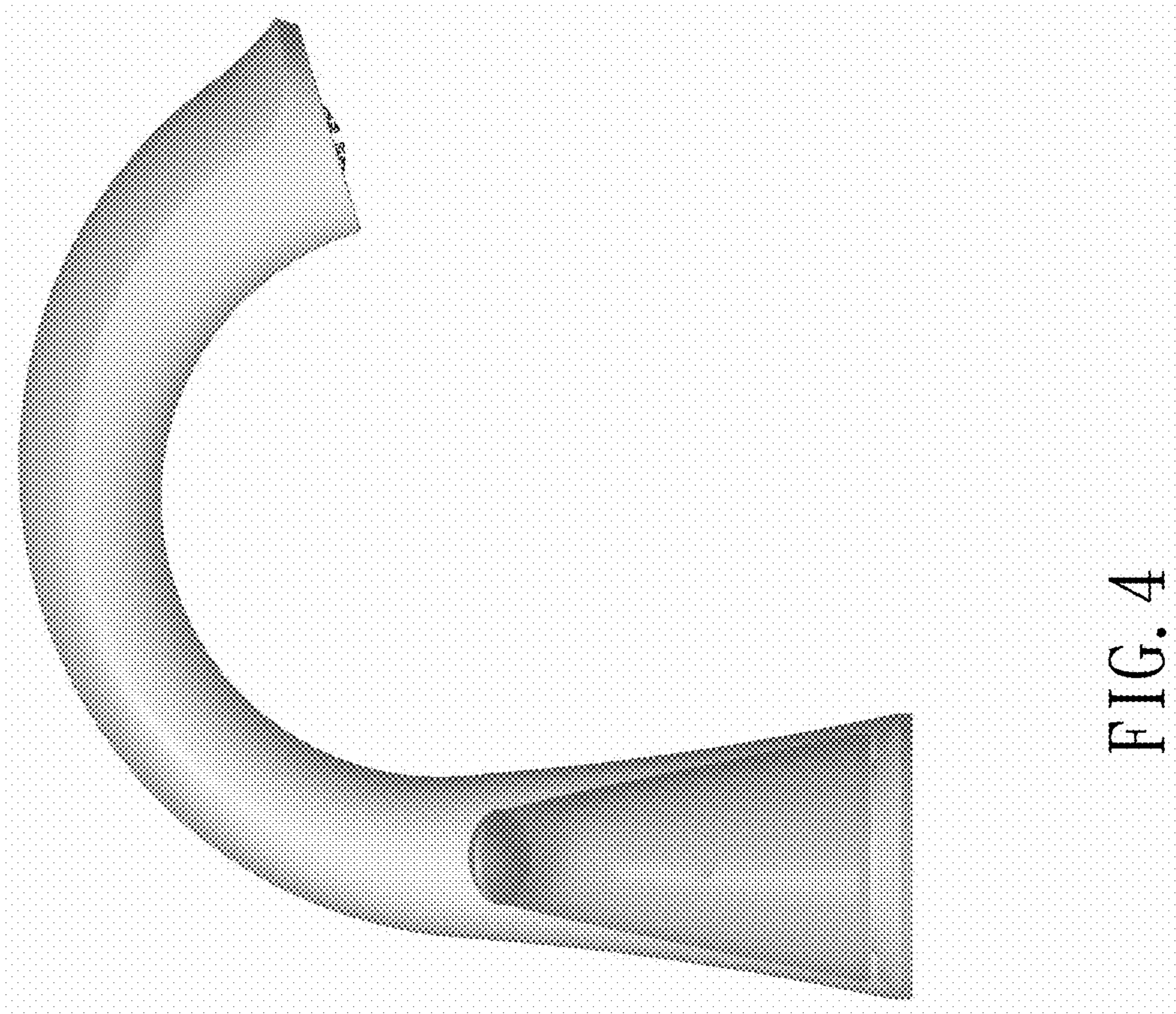

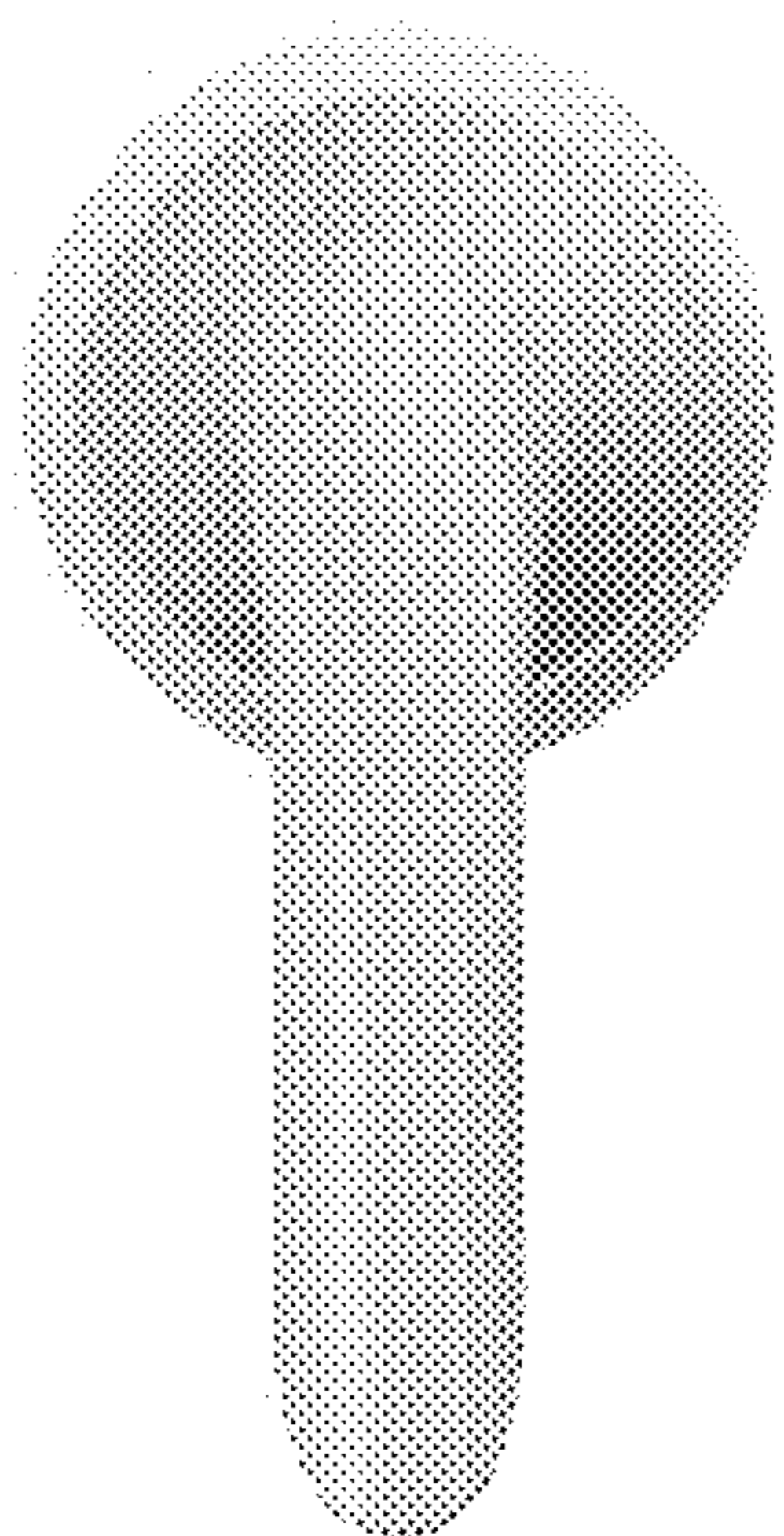
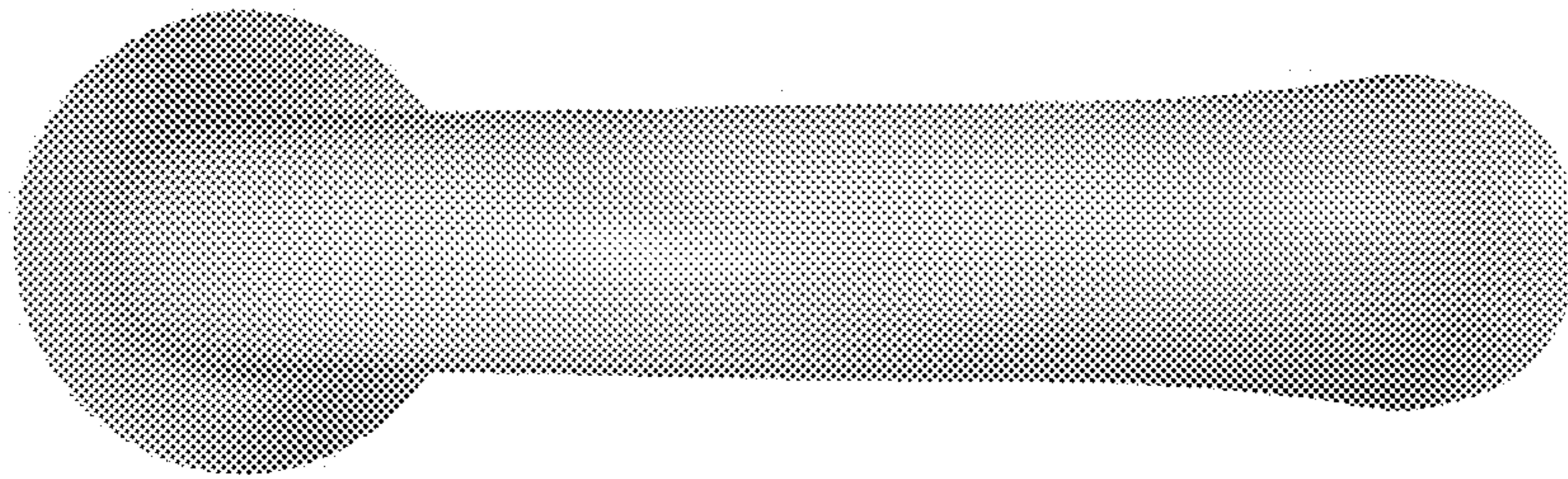
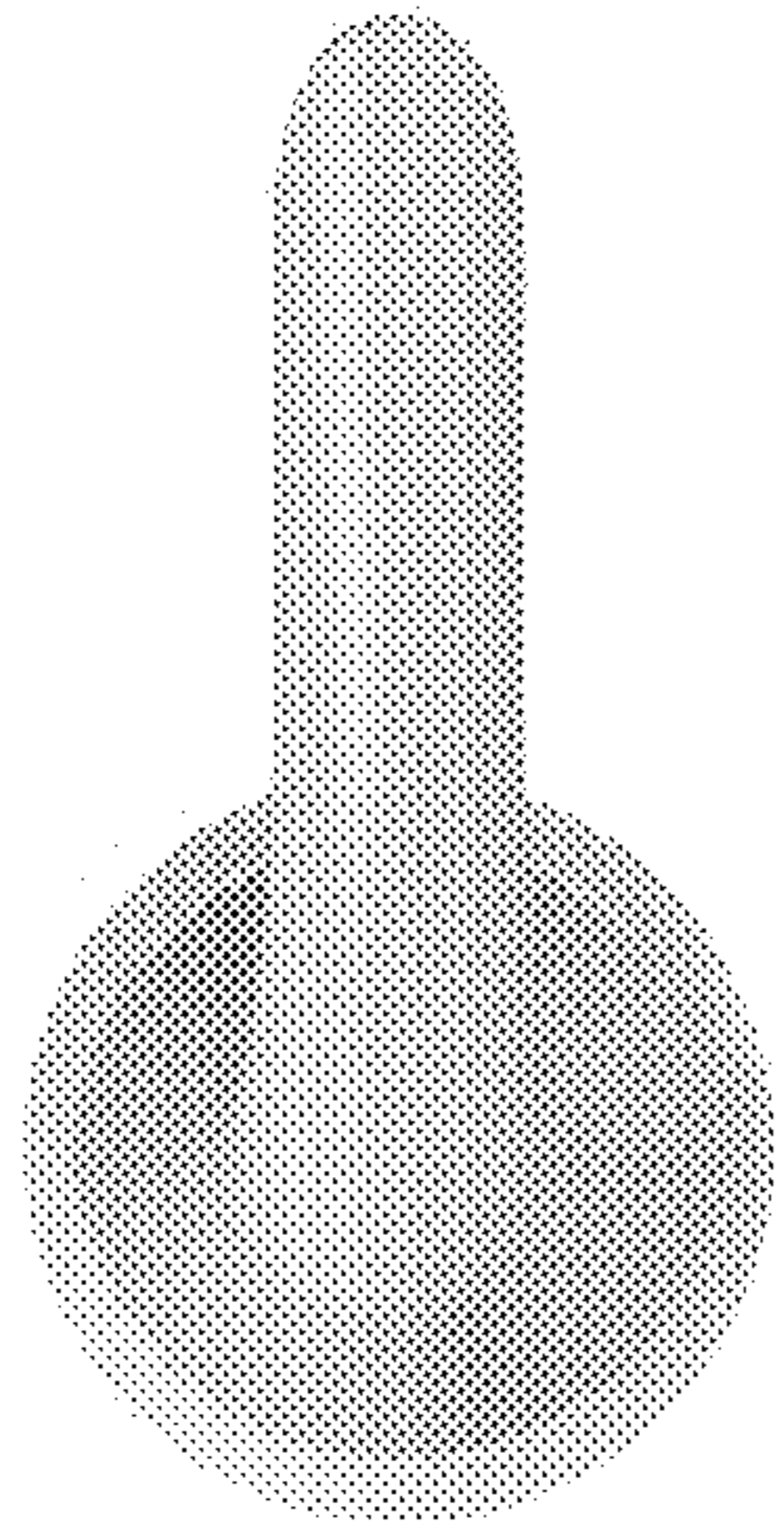
