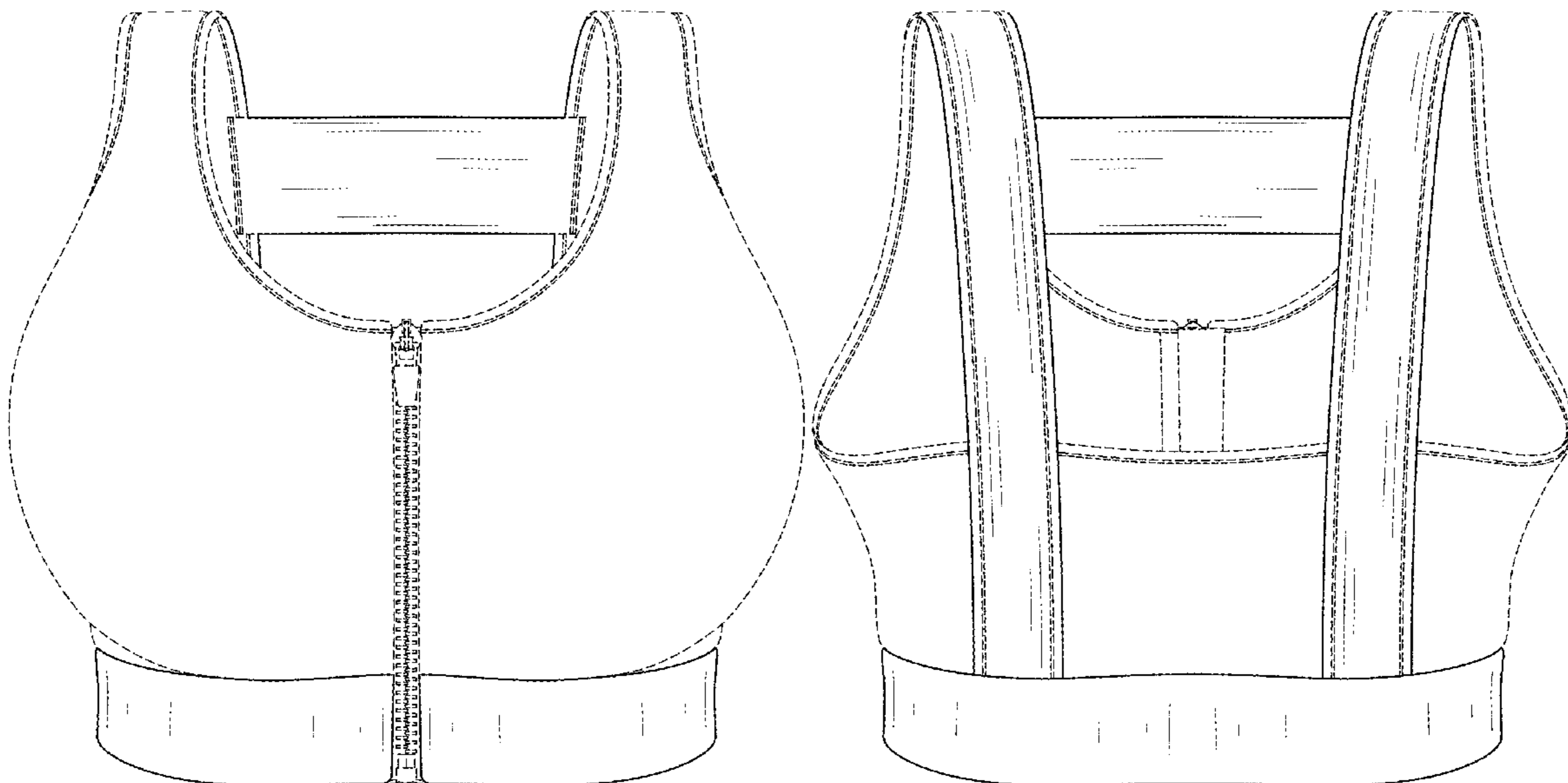
(57) **CLAIM**

The ornamental design for a bra, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a bra. FIG. 2 is a back elevation view of the bra of FIG. 1; and, FIG. 3 is an isometric view of the bra of FIG. 1. Portions of FIGS. 1 through 3 are shown in evenly spaced broken lines and dash-dot-dash boundary lines illustrating portions of the article that form no part of the claimed design.

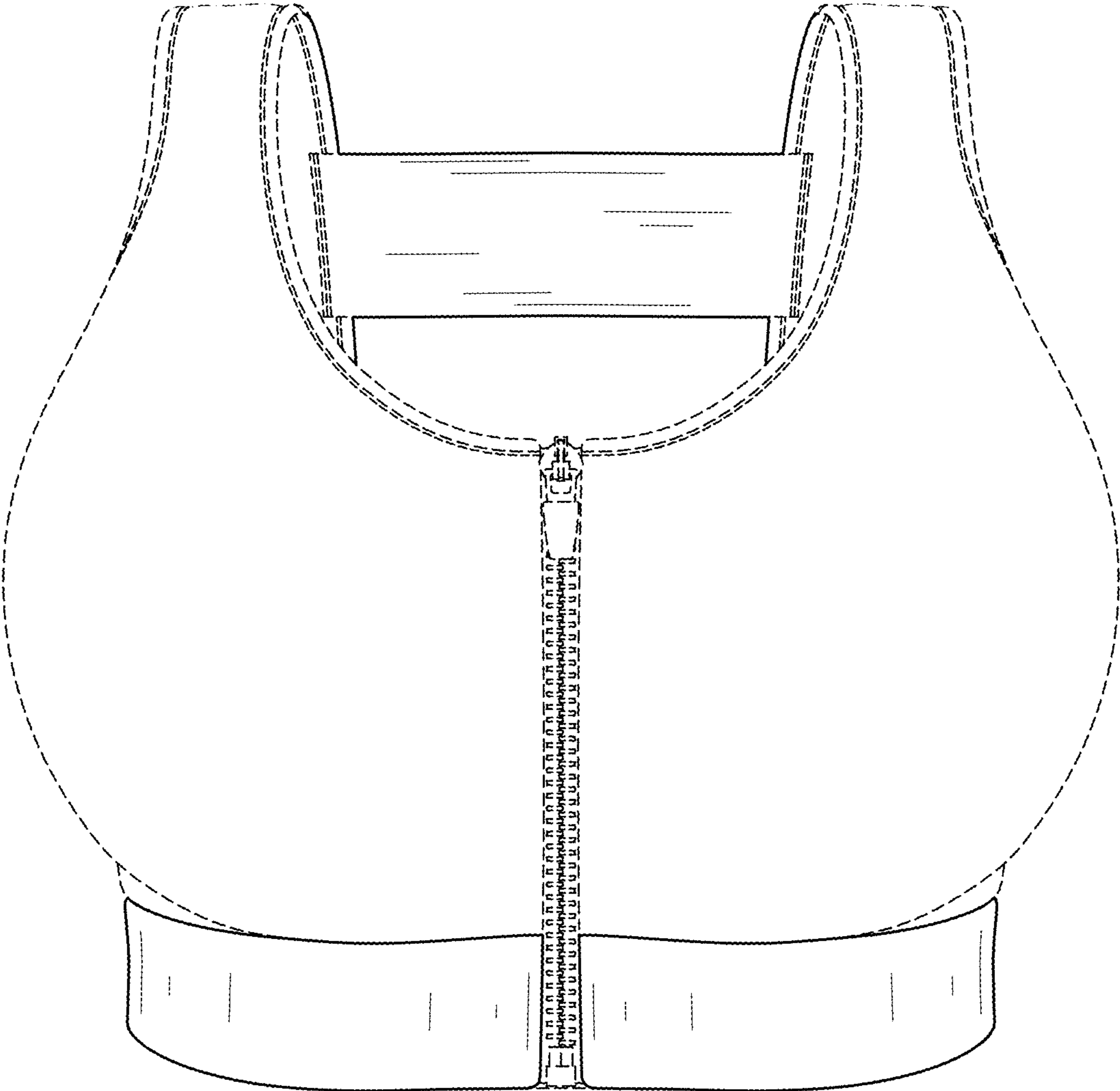

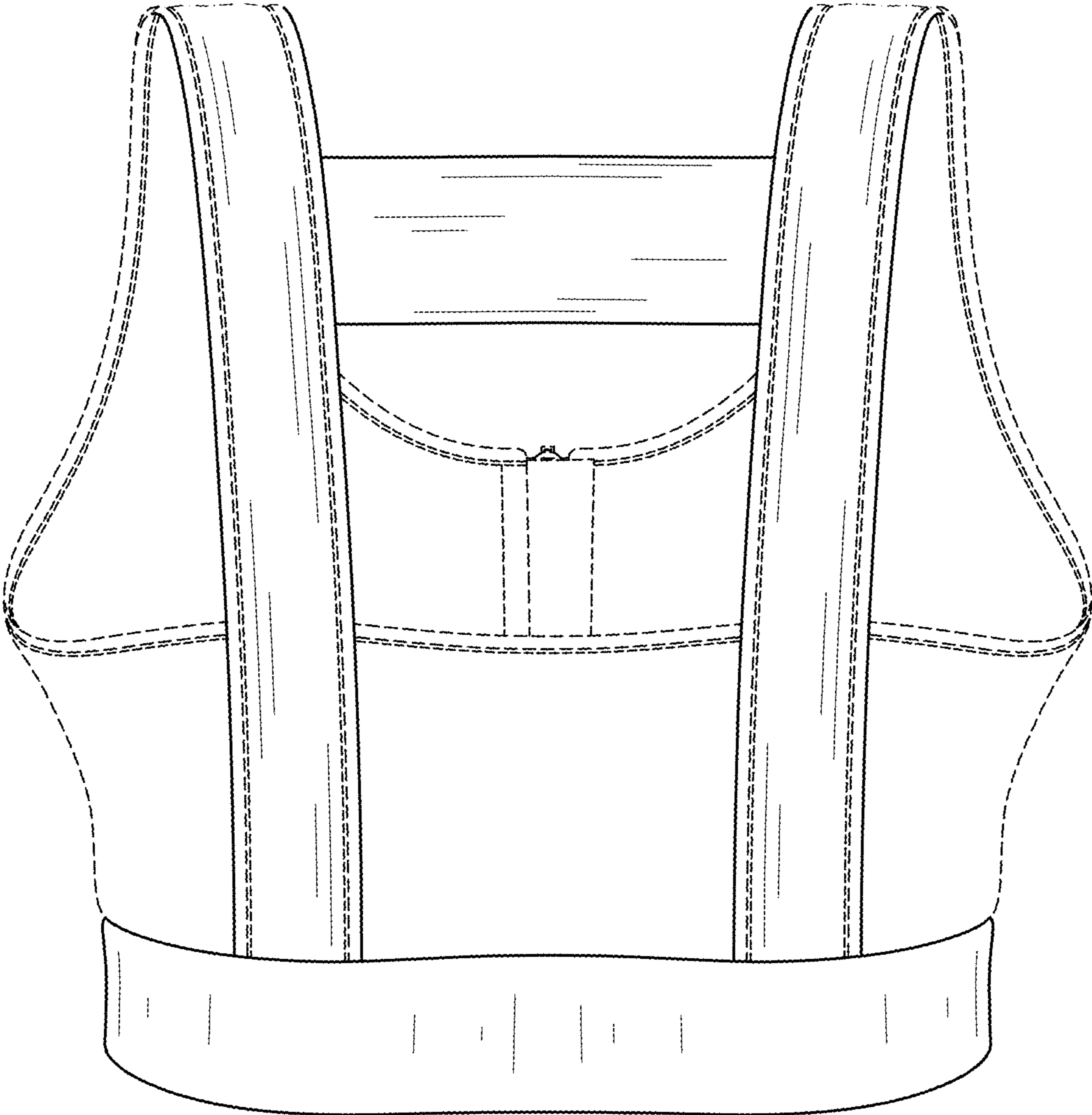

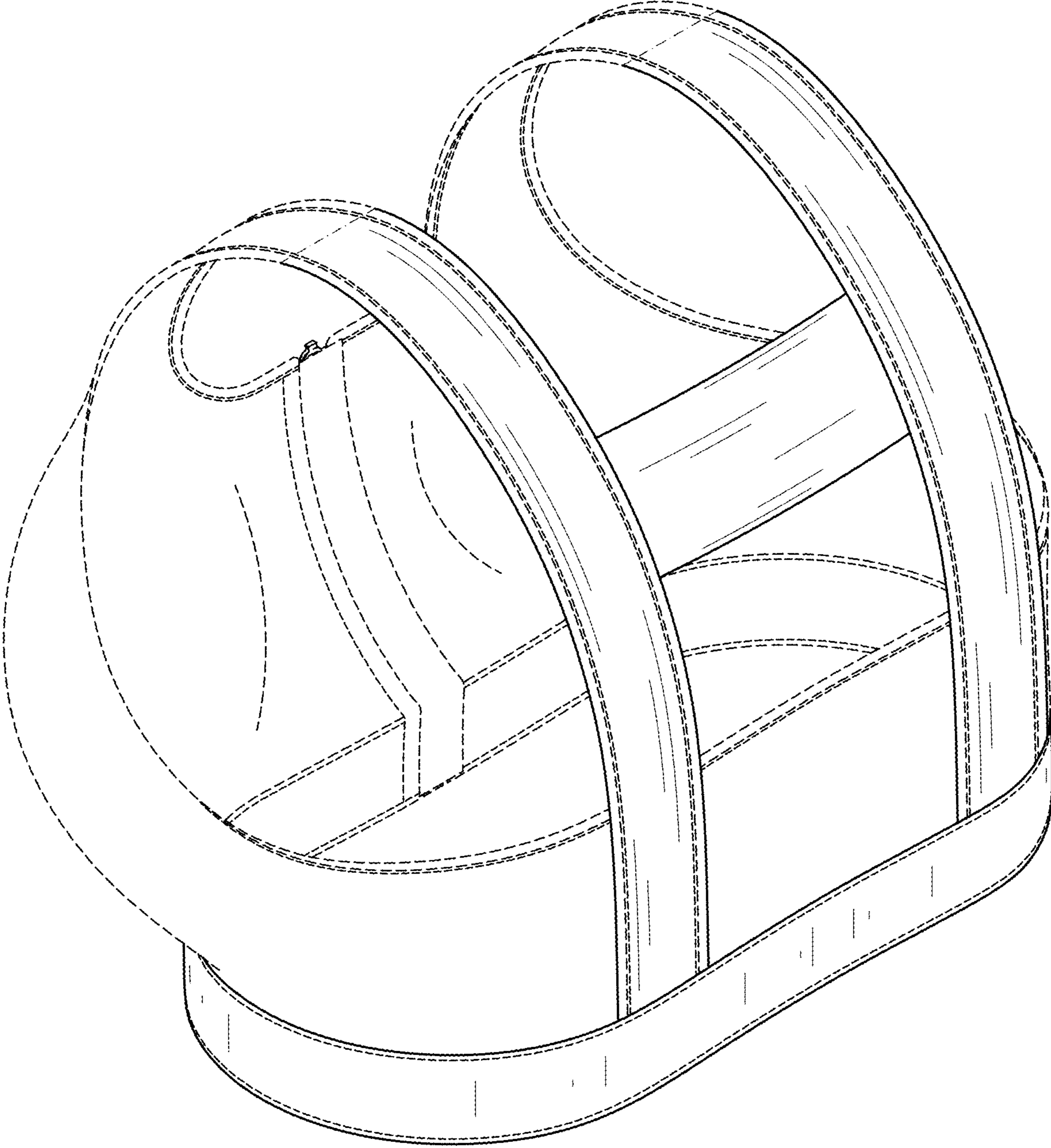
