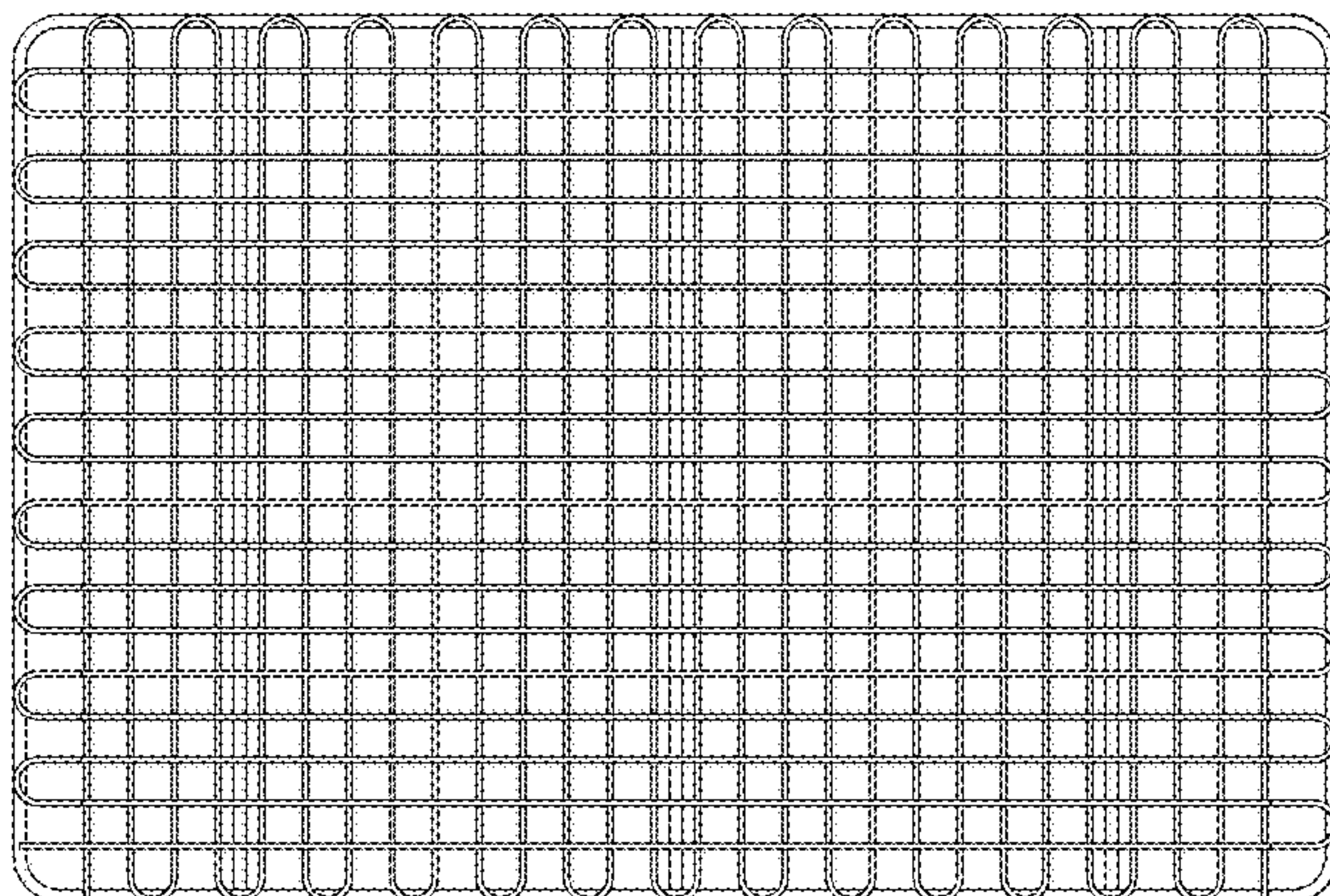
(57) **CLAIM**

The ornamental design for a food cooling rack, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a food cooling rack in accordance with the present design;  
FIG. 2 is a right side view of the food cooling rack shown in FIG. 1, the opposite side being a mirror image thereof; and,  
FIG. 3 is a front view of the food cooling rack shown in FIG. 1, the opposite side being a mirror image thereof.

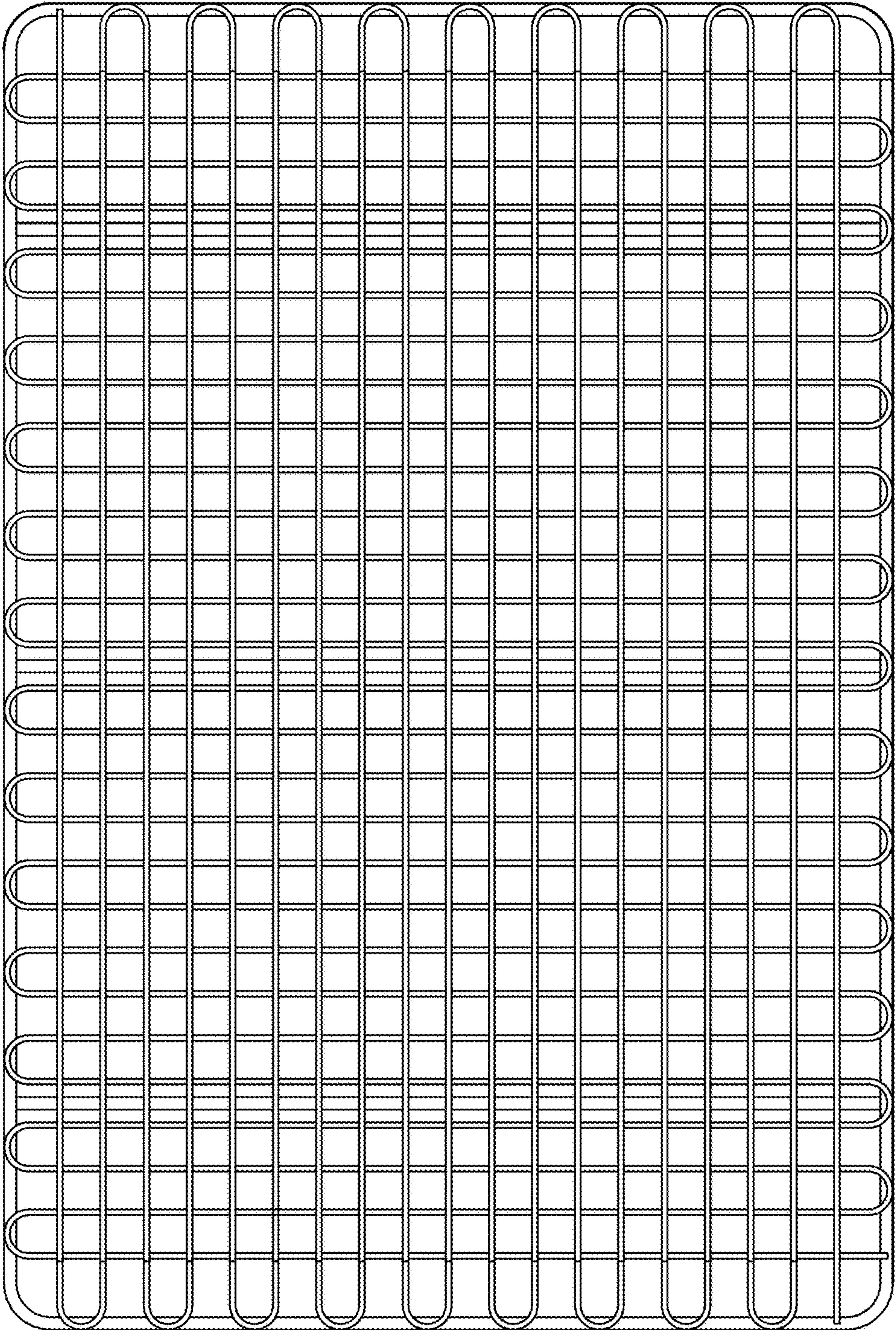

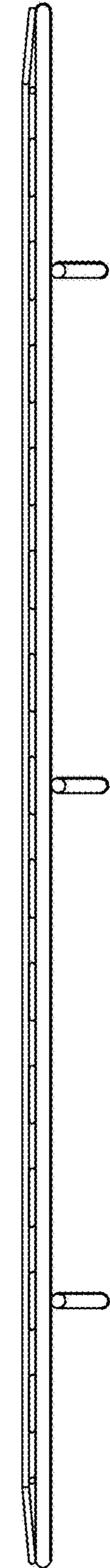
