DESCRIPTION

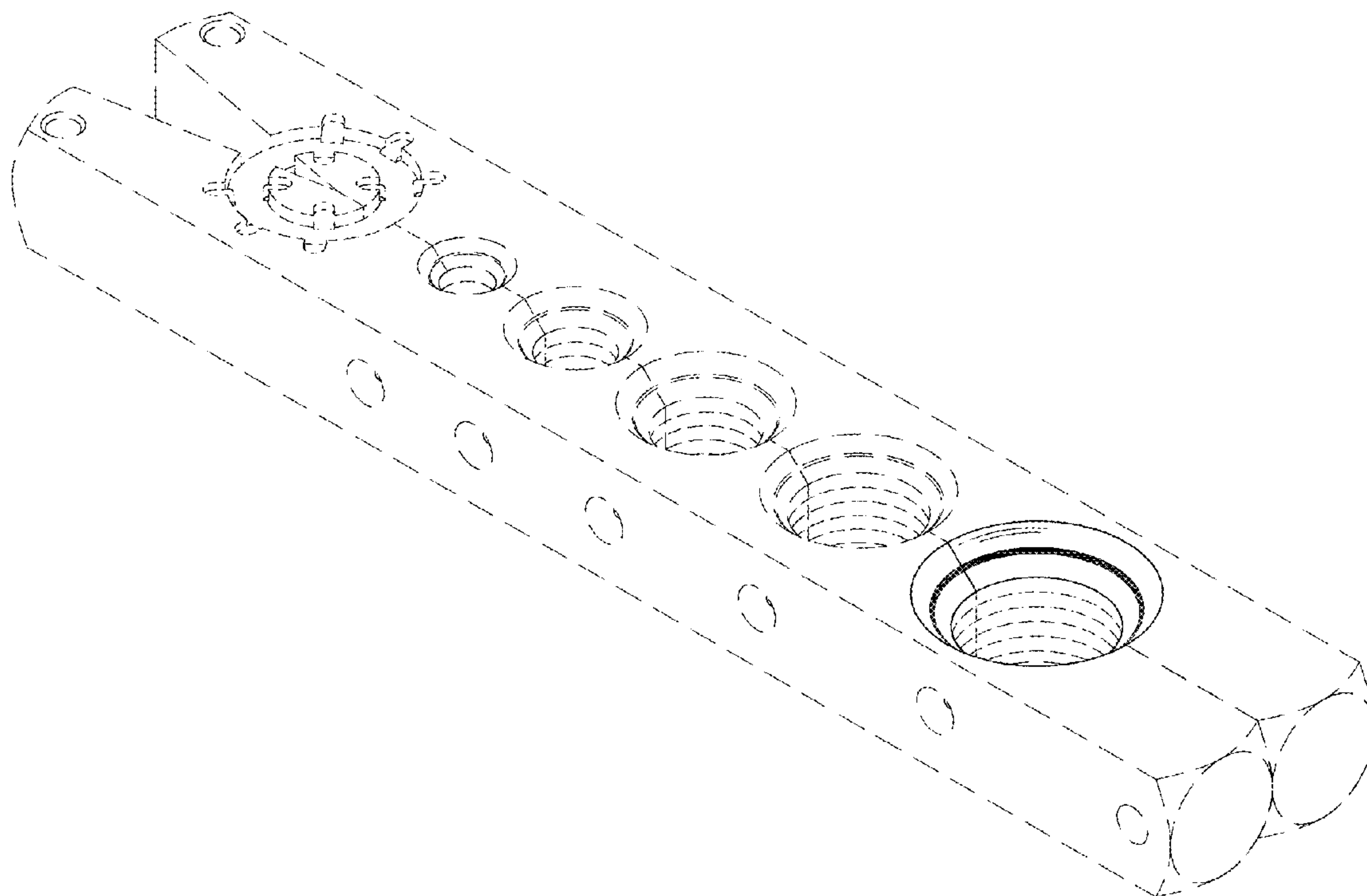
FIG. 1 is a perspective view of a pipe clamp for pipe expander showing my new design;

 FIG. 6 is a top plan view thereof; and

 FIG. 8 is a perspective view showing the state when it is opened; and,
 FIG. 9 is a schematic view of an operating state.
 The heavy line shown in FIGS. 1, 6, 8 and 9 indicates color contrast.

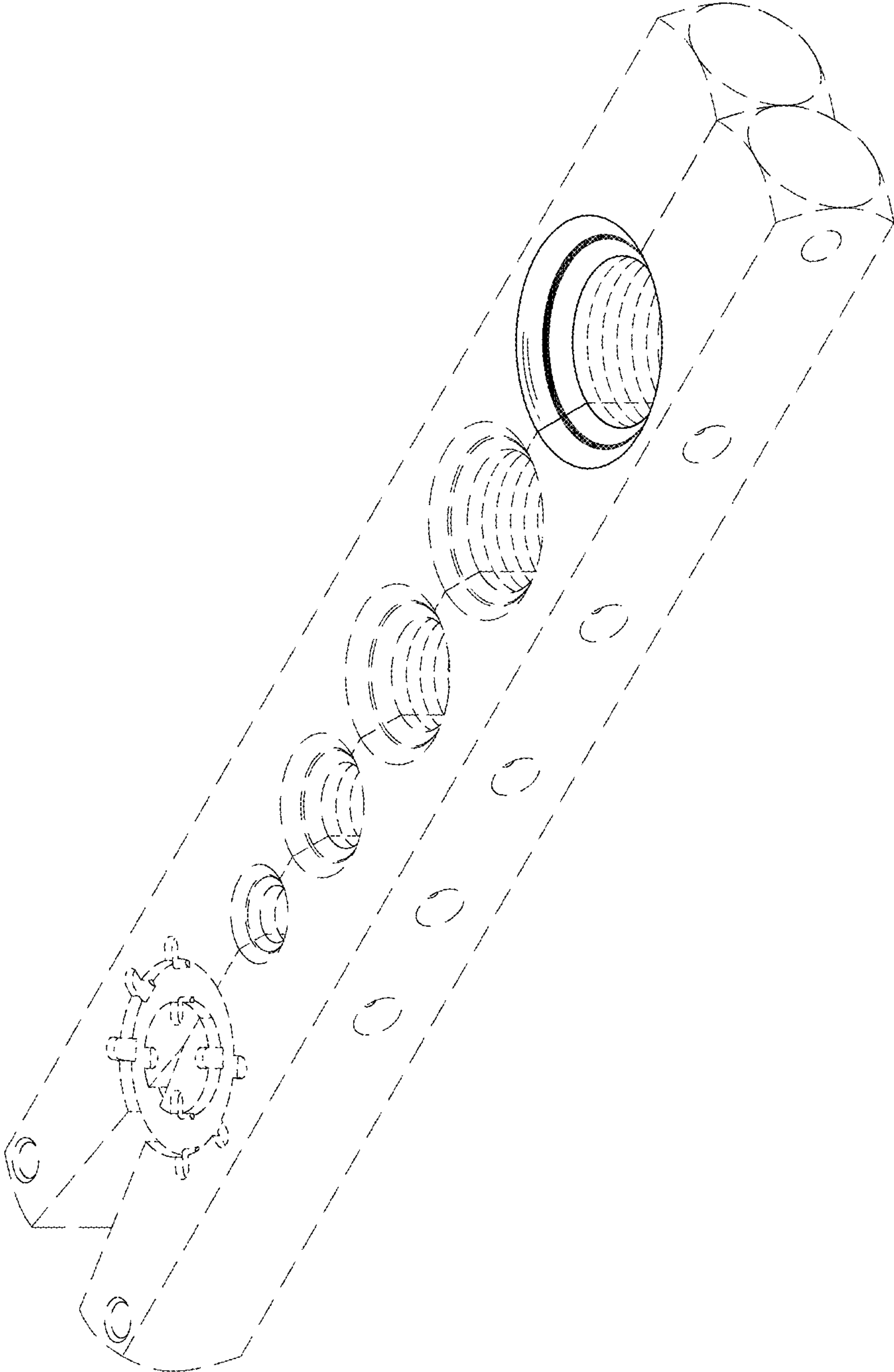

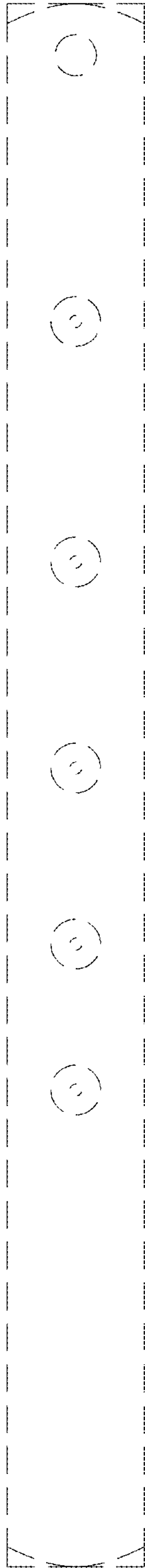

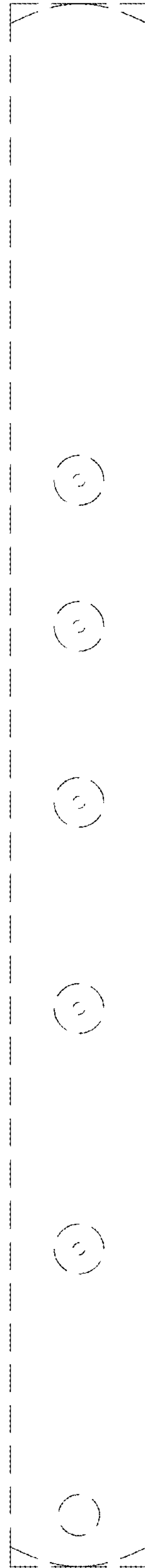

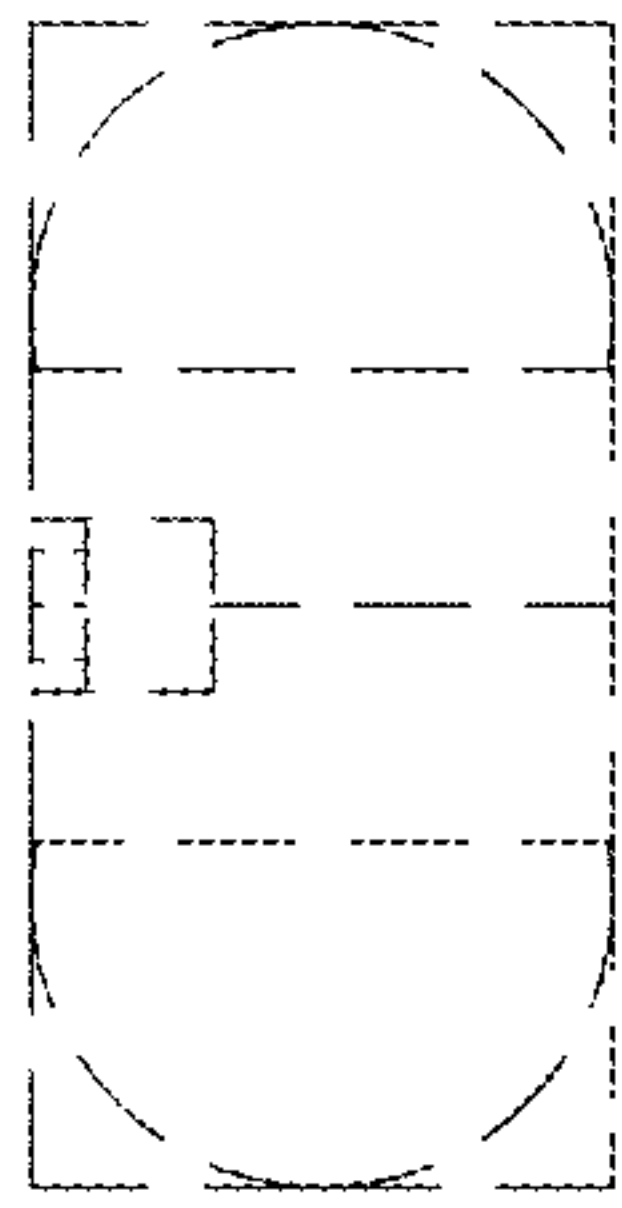

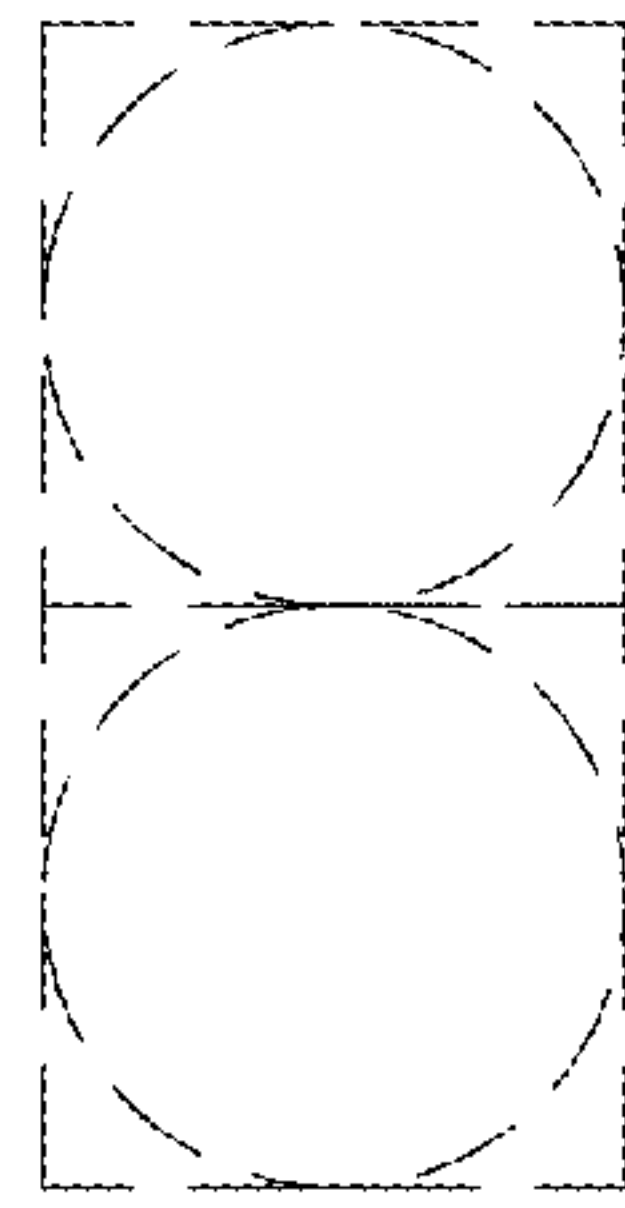

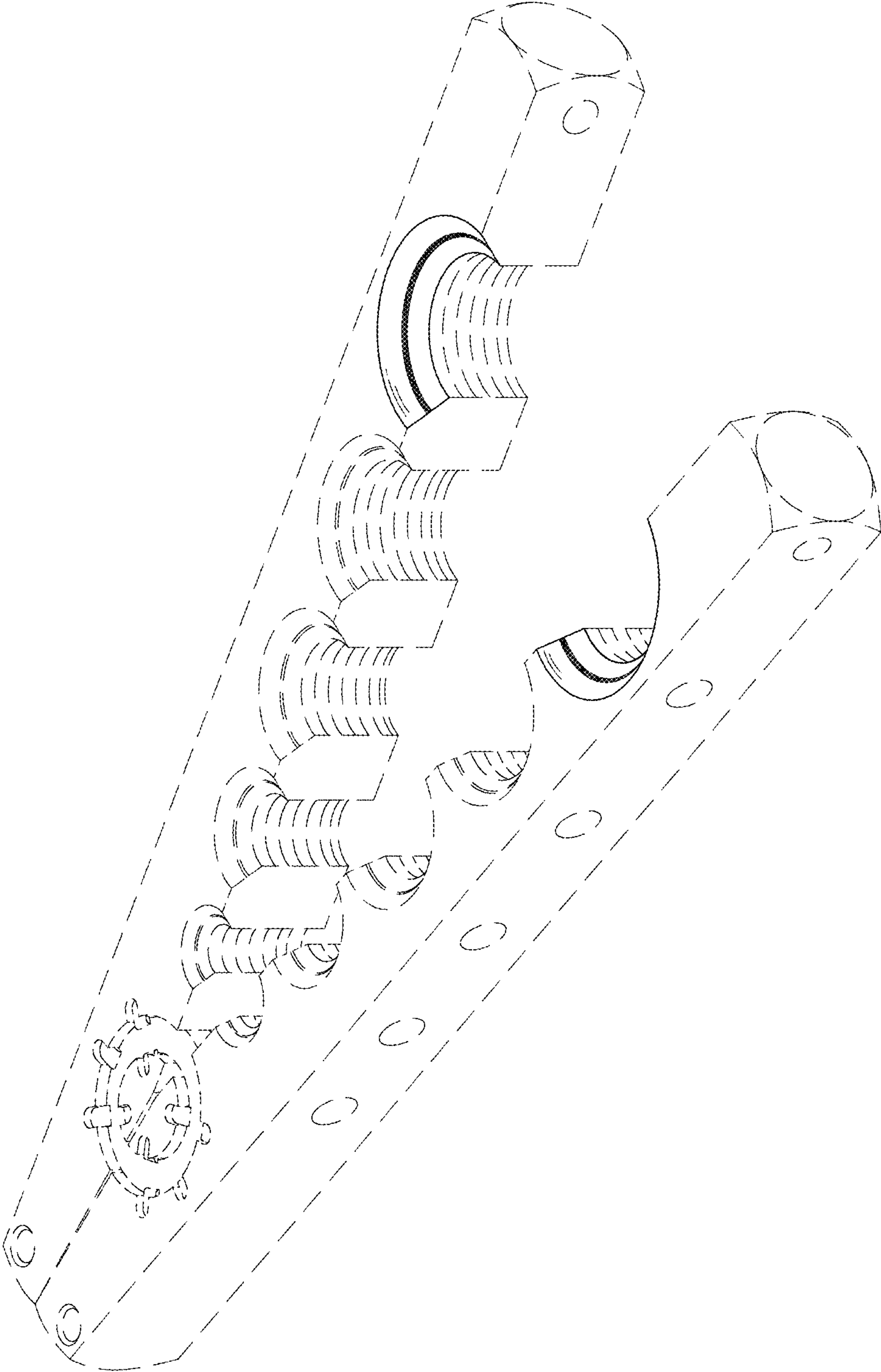

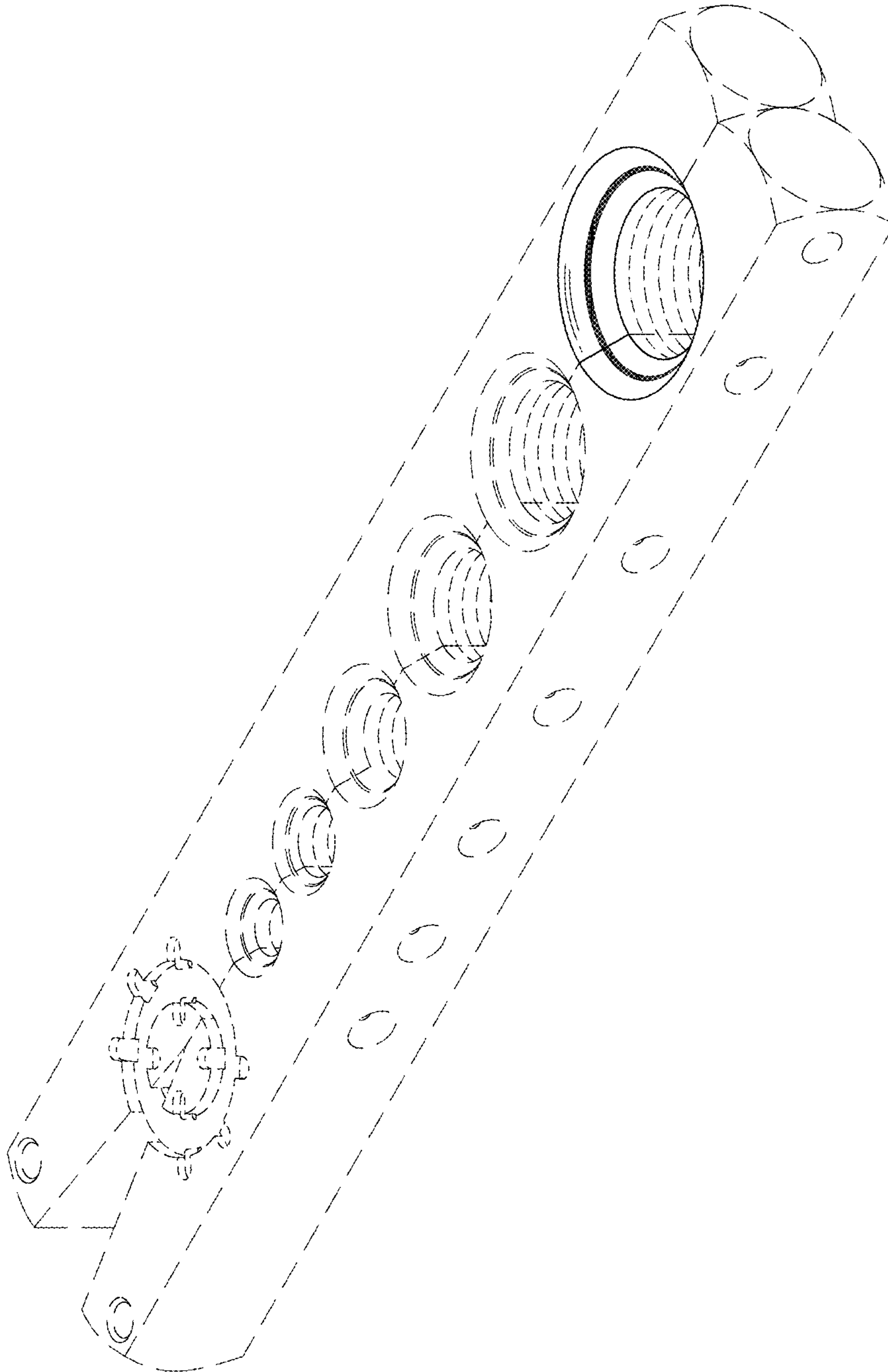
