The ornamental design for a food container, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a food container according to a first embodiment of the present disclosure in a first folded position;

FIG. 2 is an isometric view of the food container of FIG. 1 in a second folded position;

FIG. 3 is an isometric view of the food container of FIG. 1 in a first upright position;

FIG. 11 is an isometric view of FIG. 1, shown in an environment;

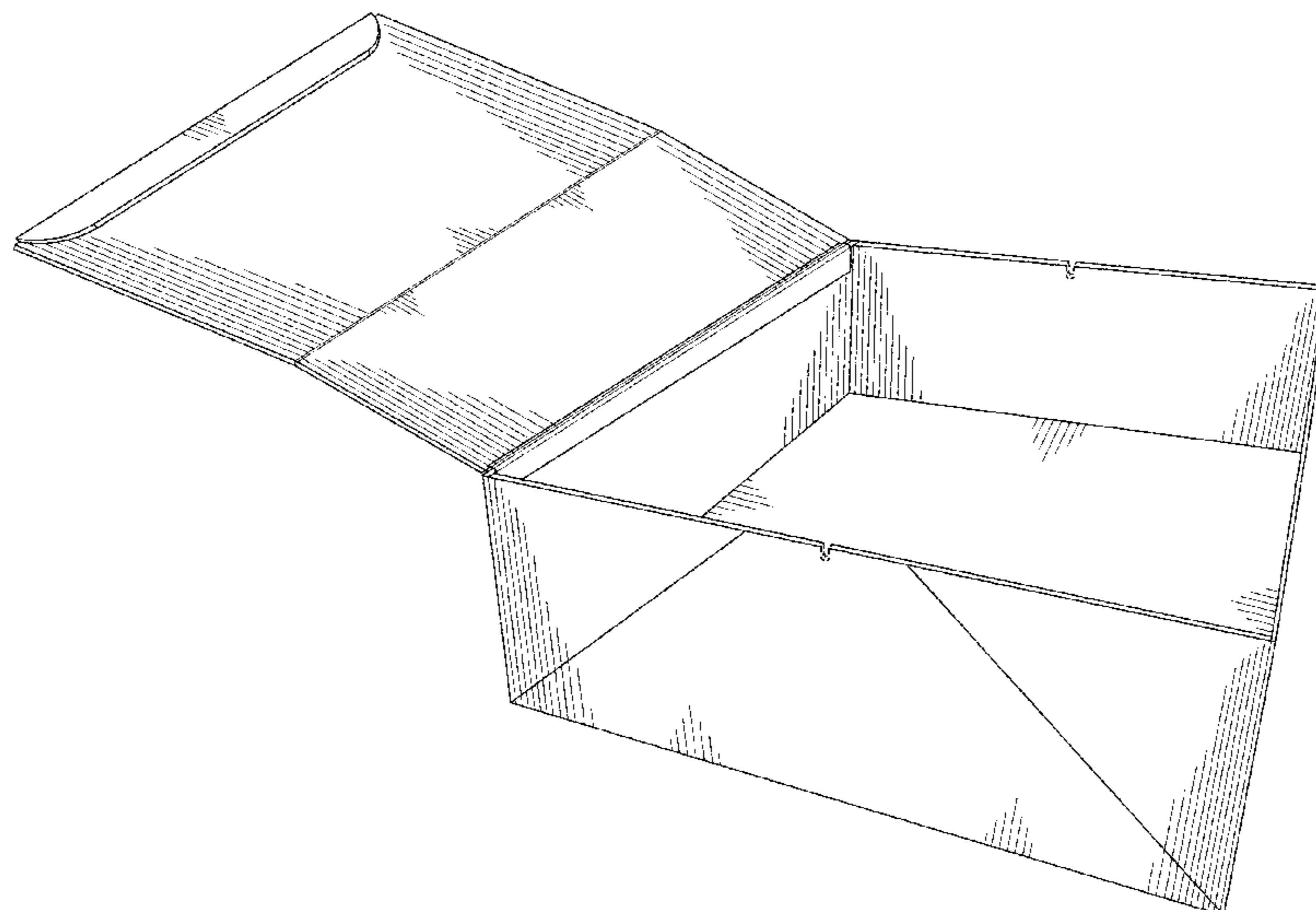
FIG. 12 is an isometric view of FIG. 1, shown in an environment;

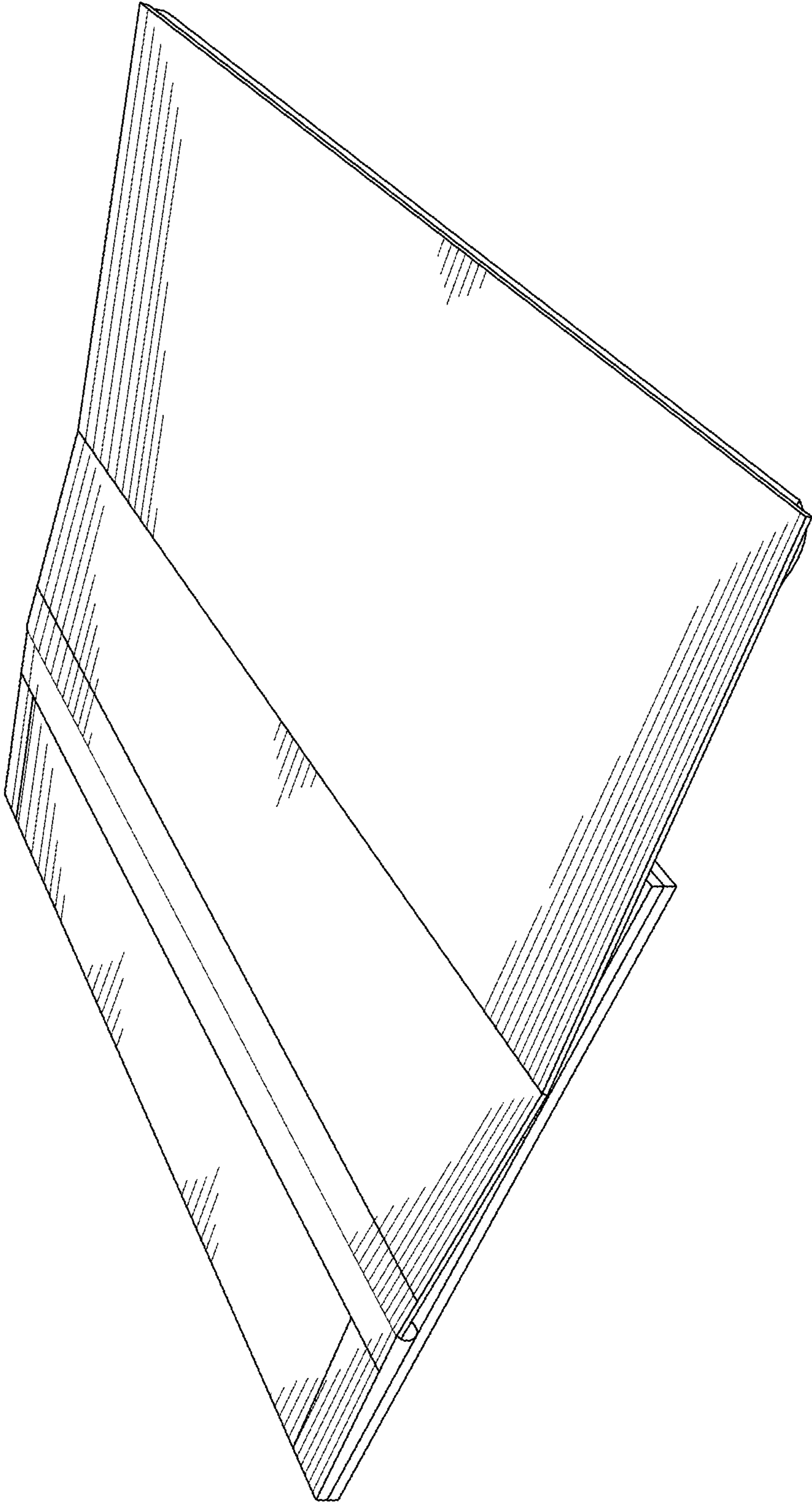

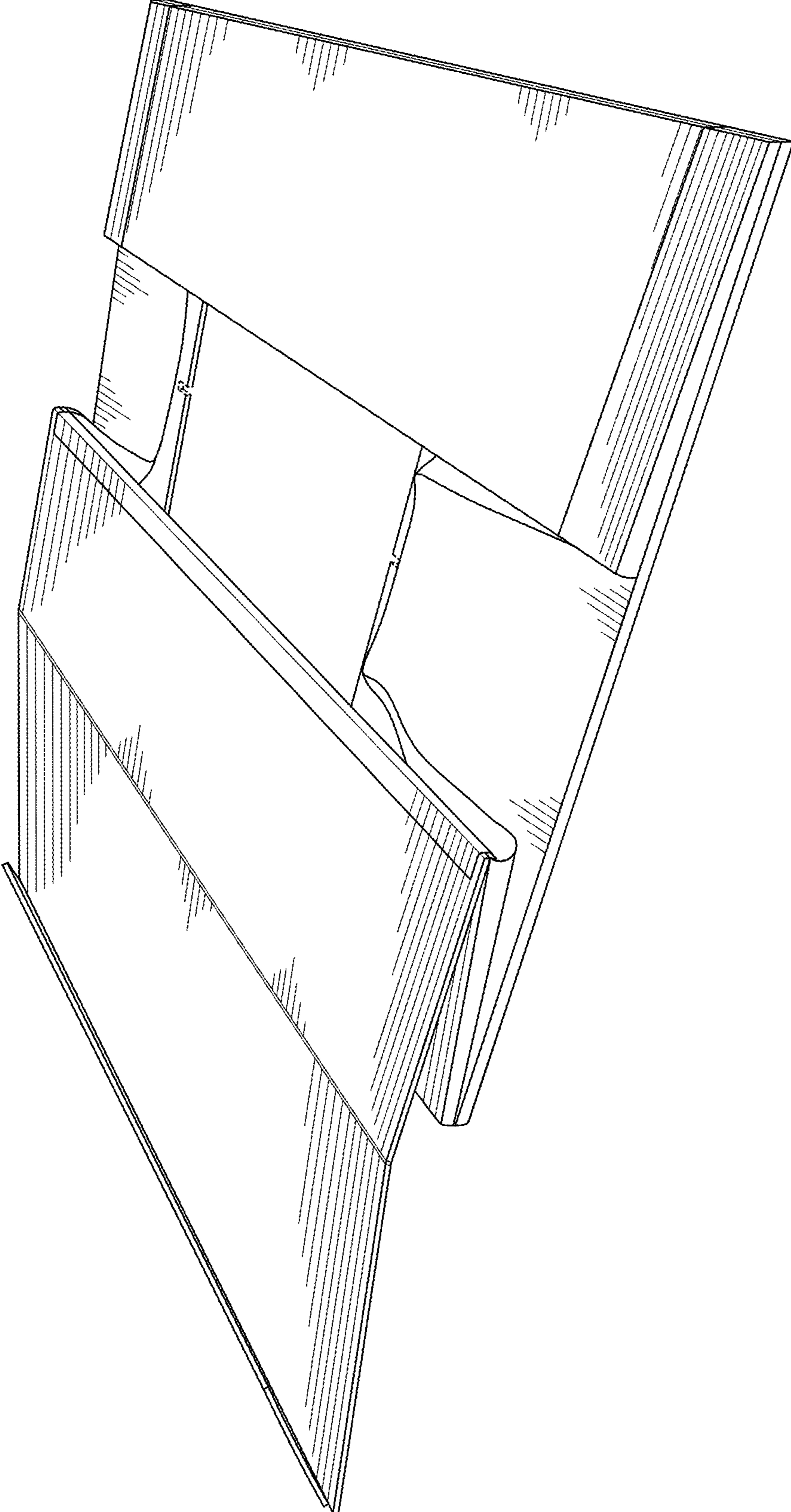

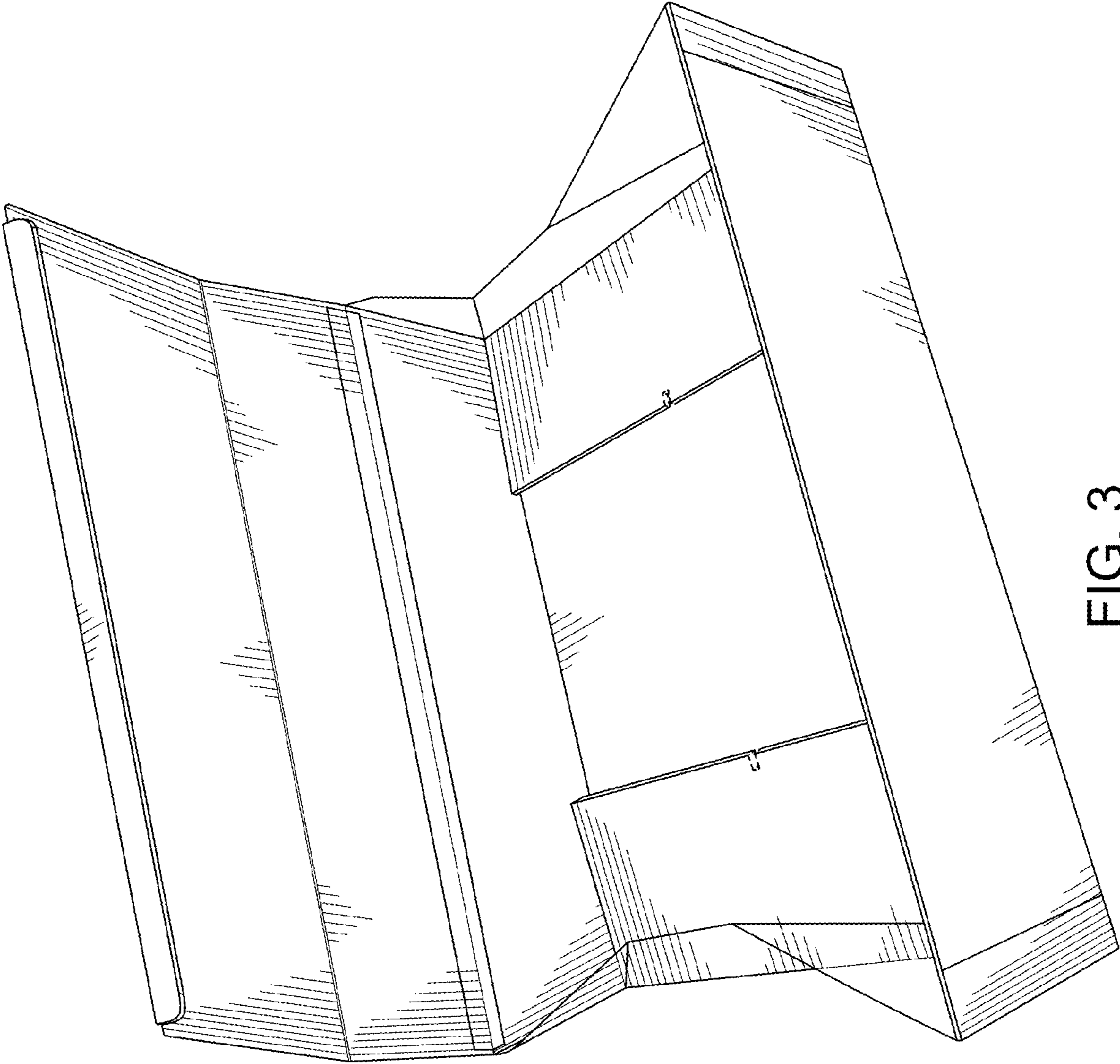

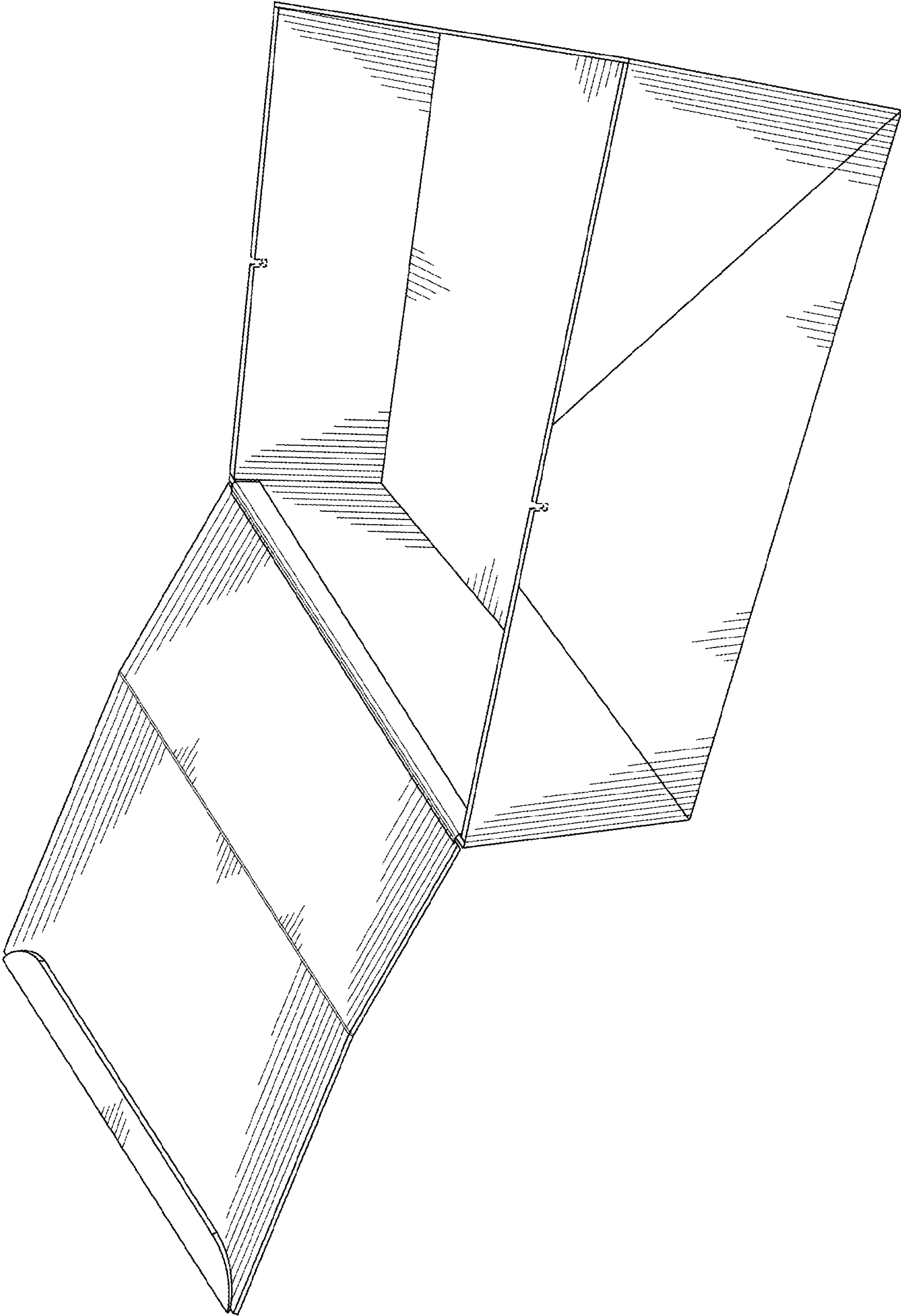

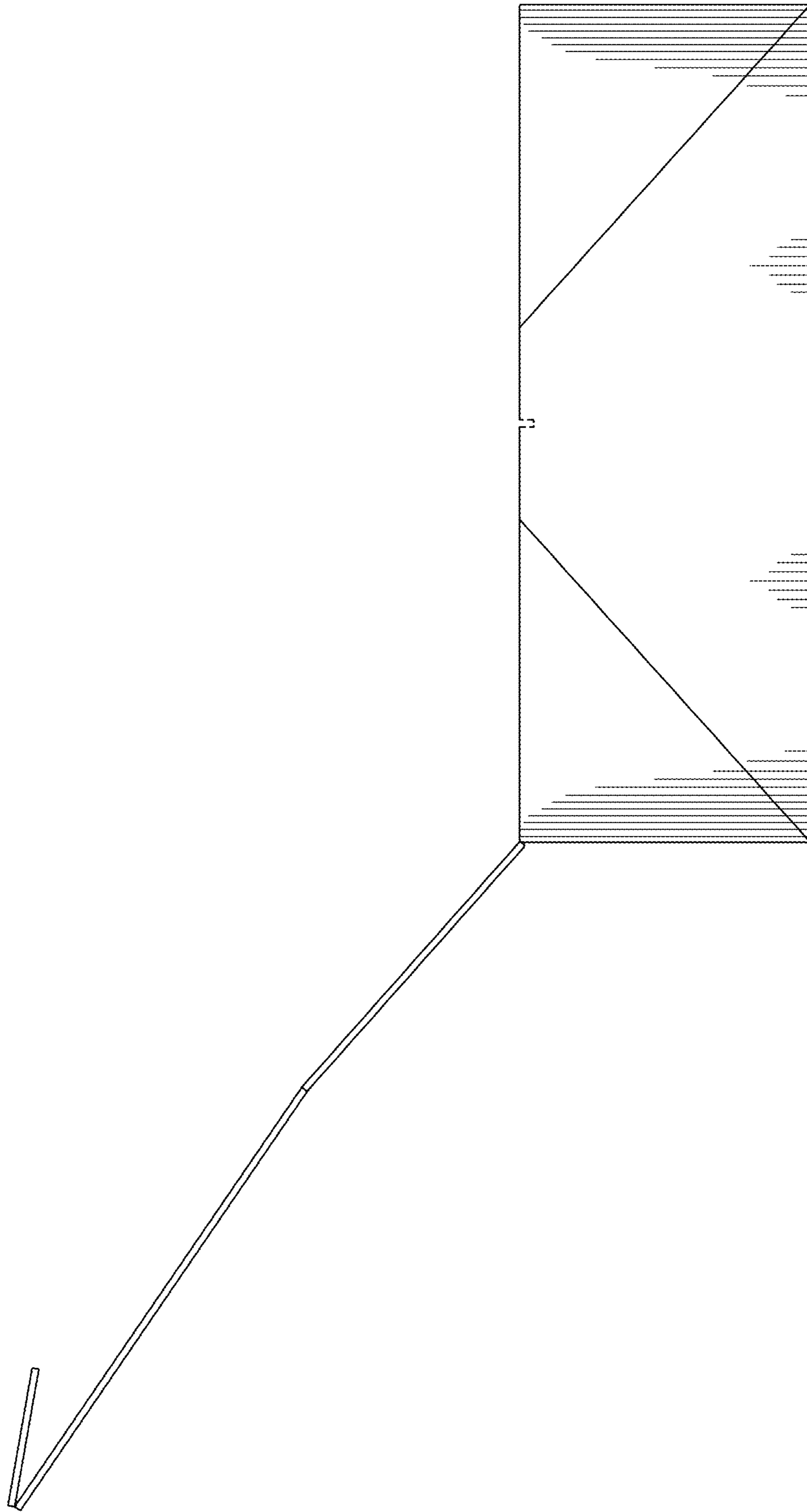

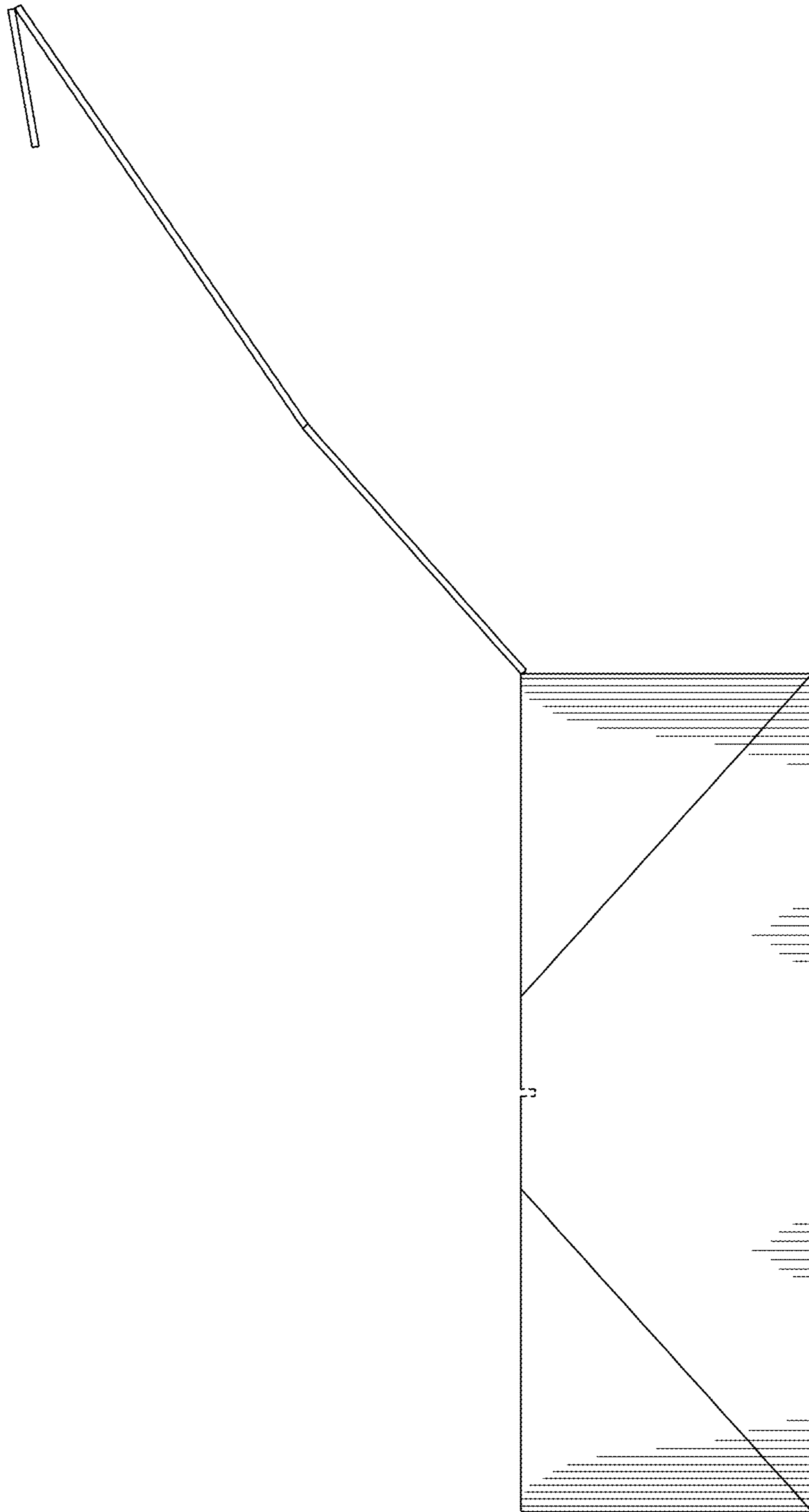

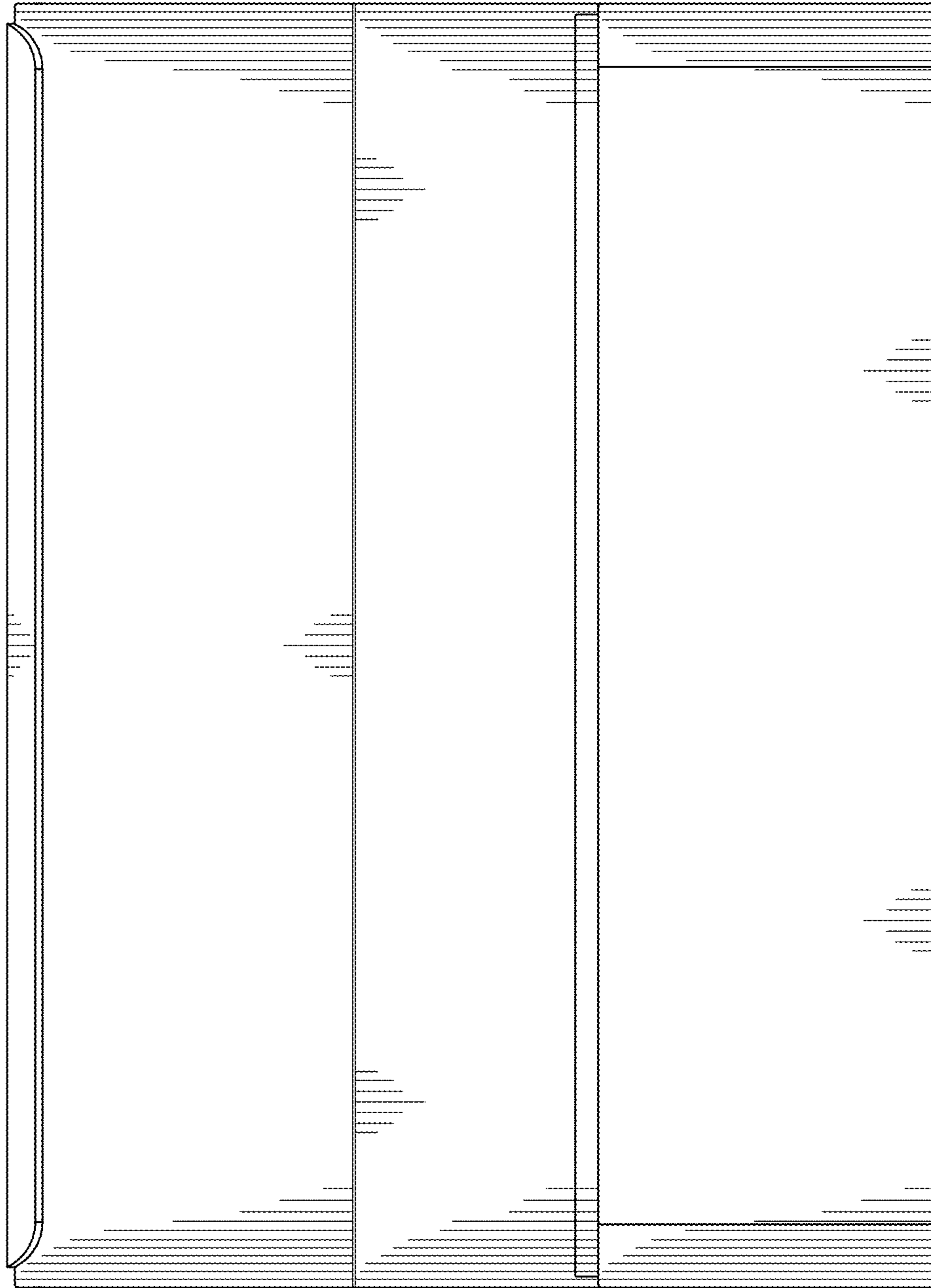

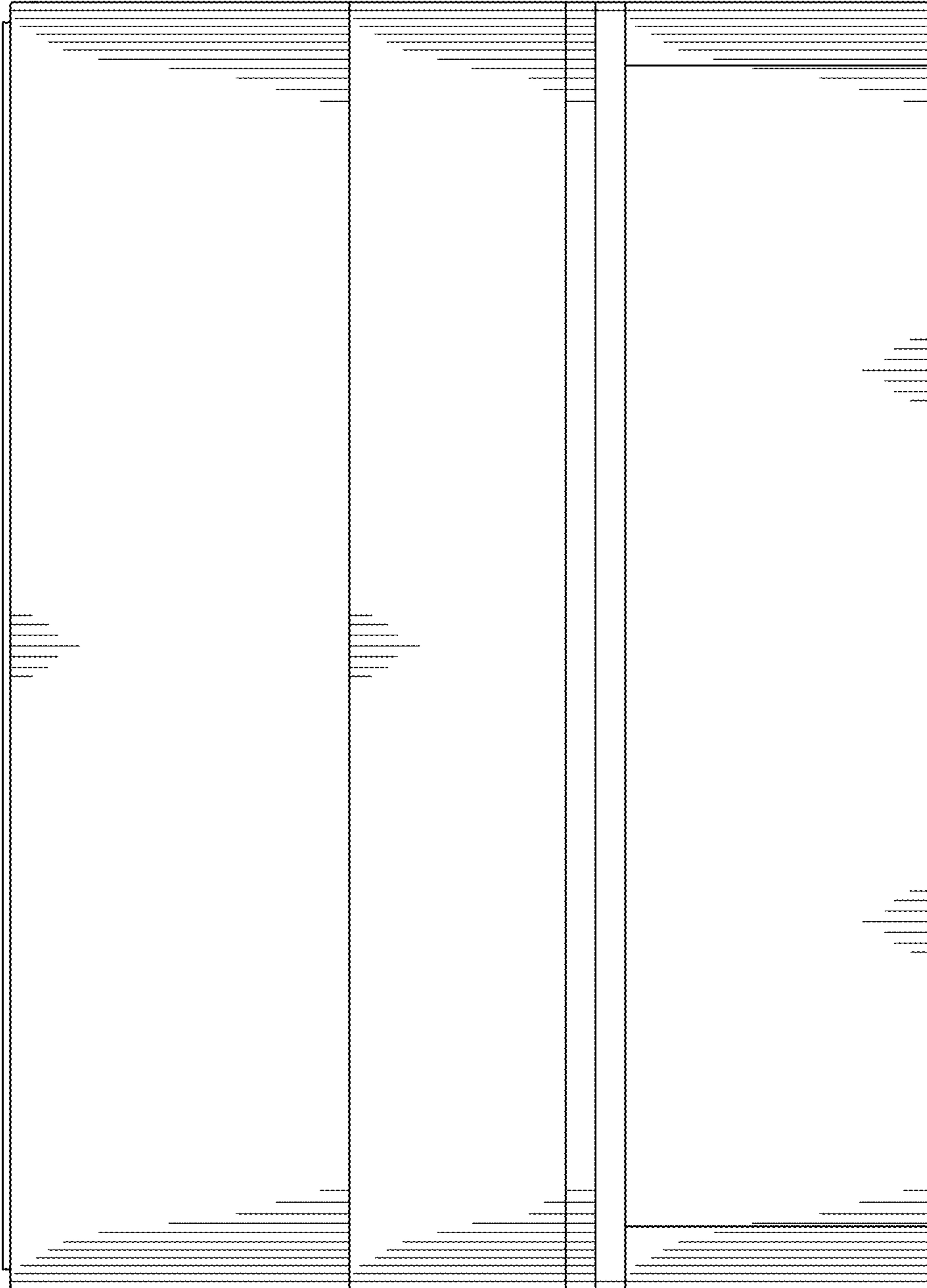

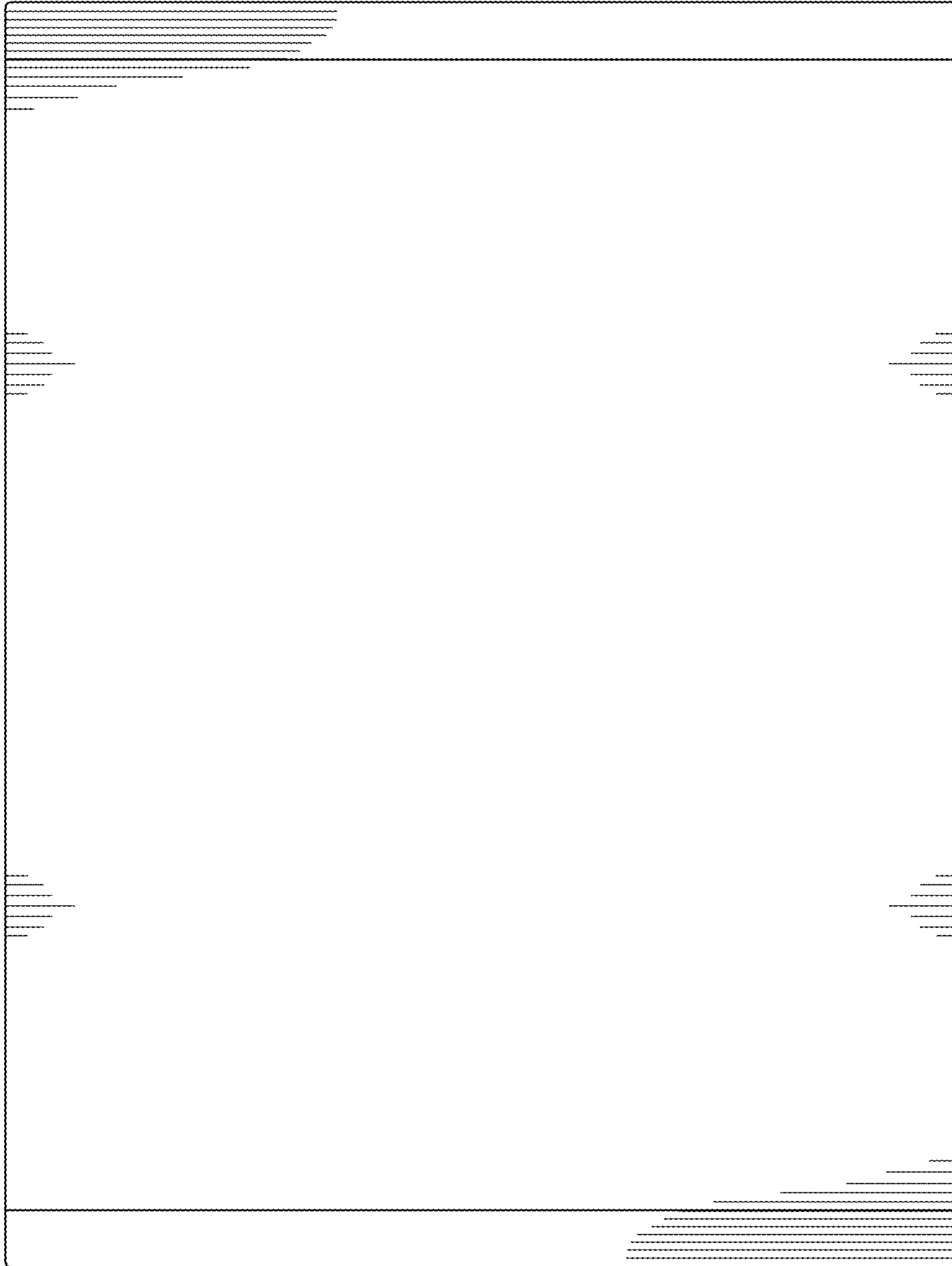

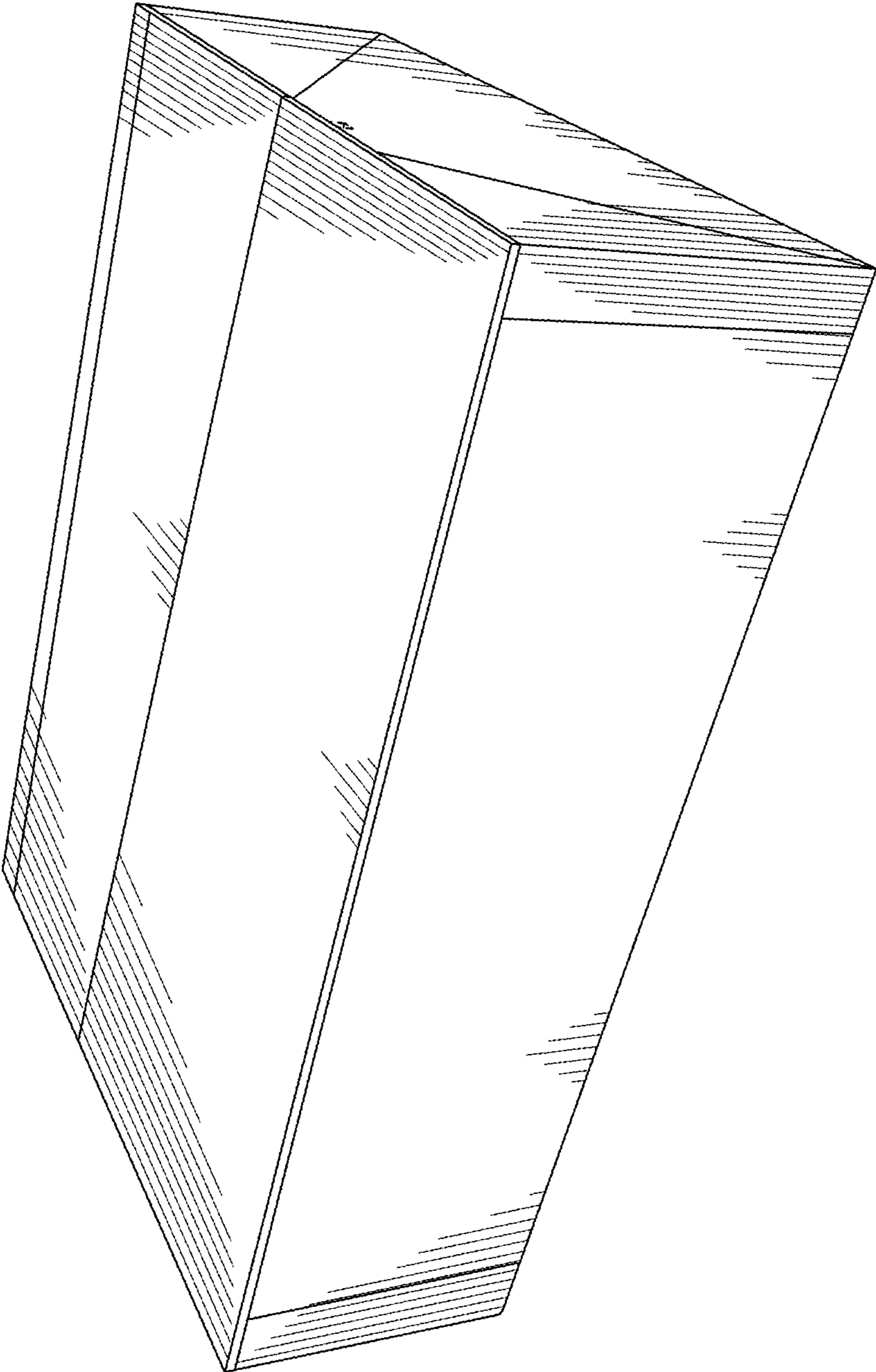

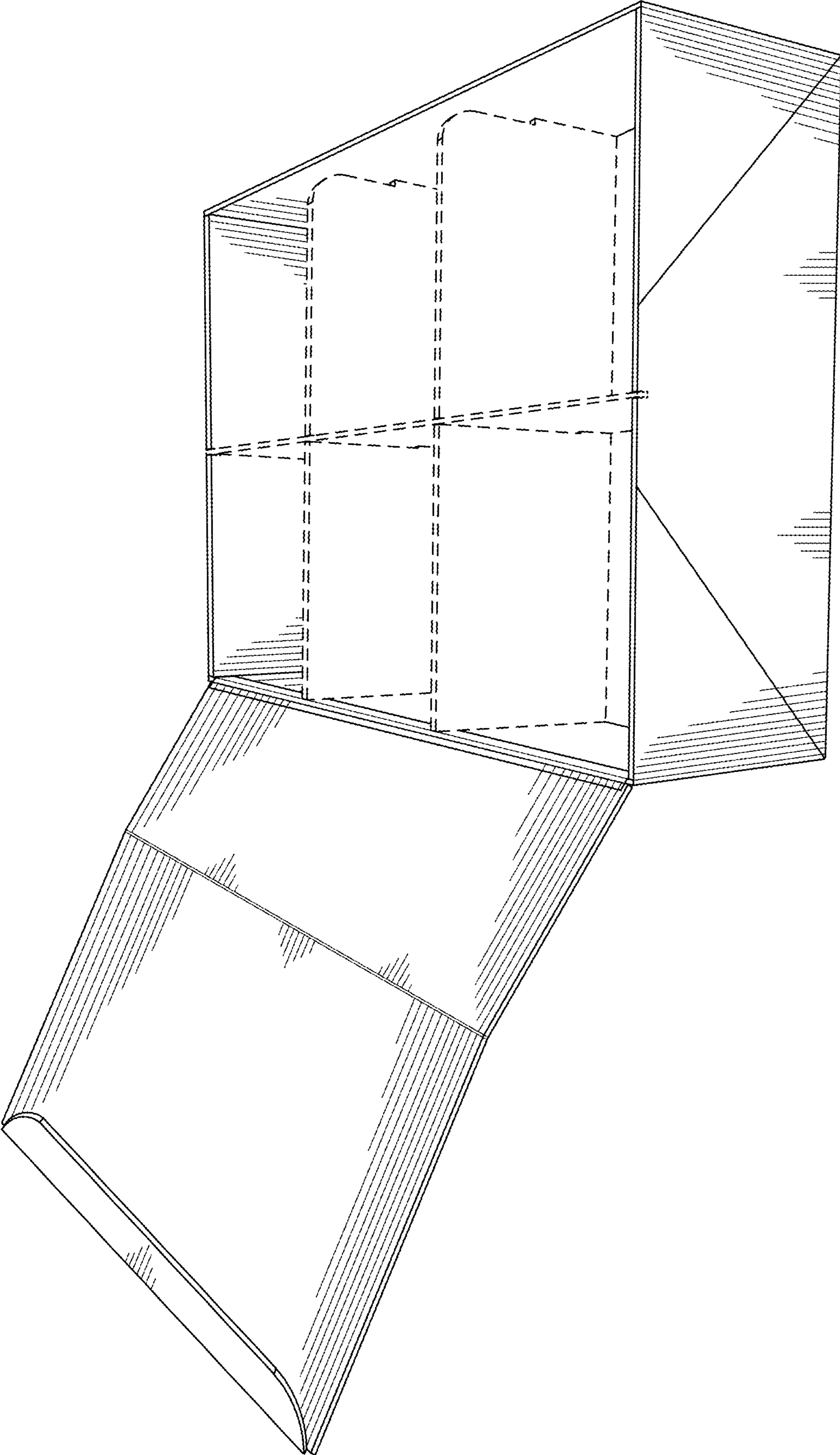

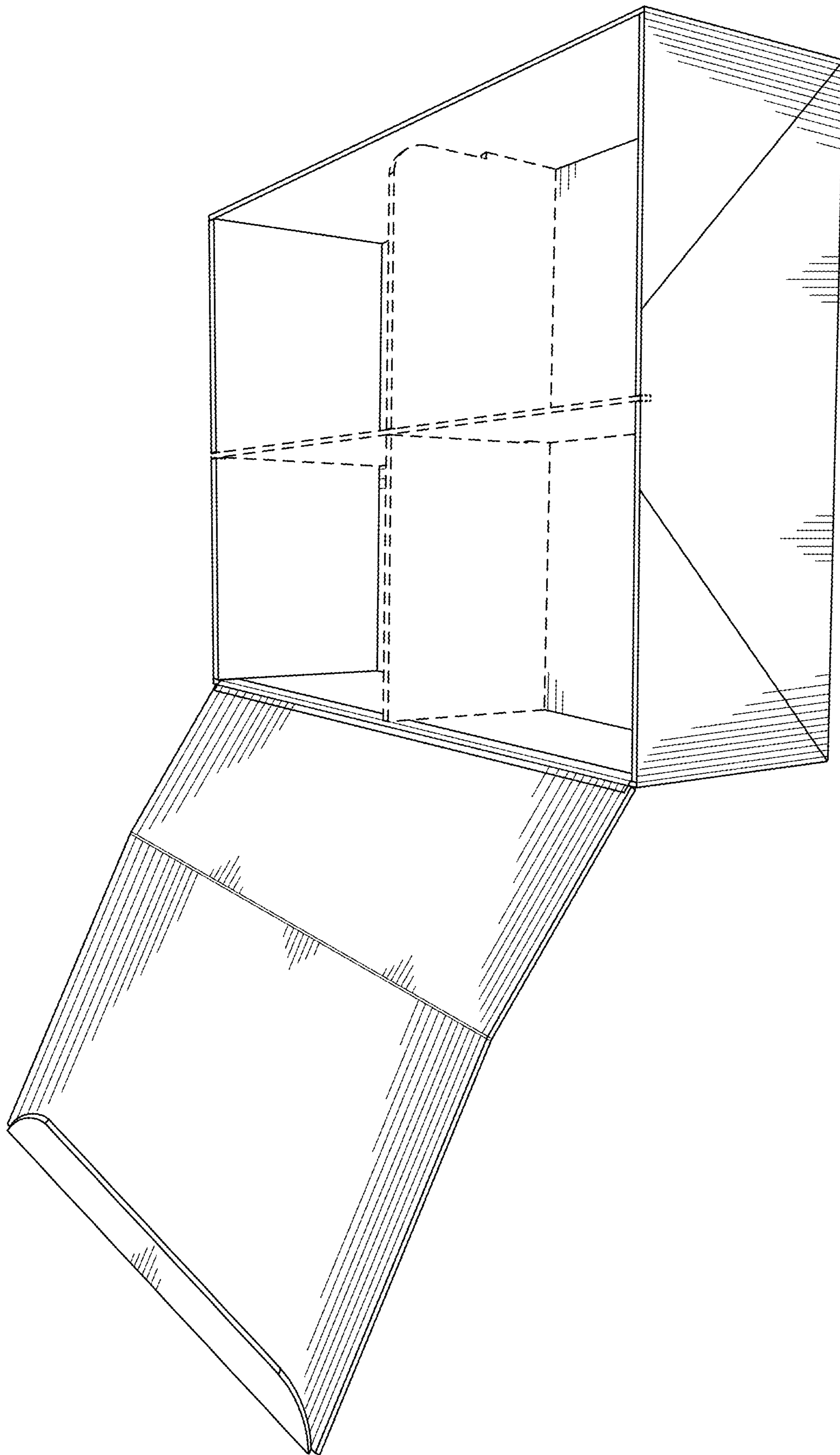

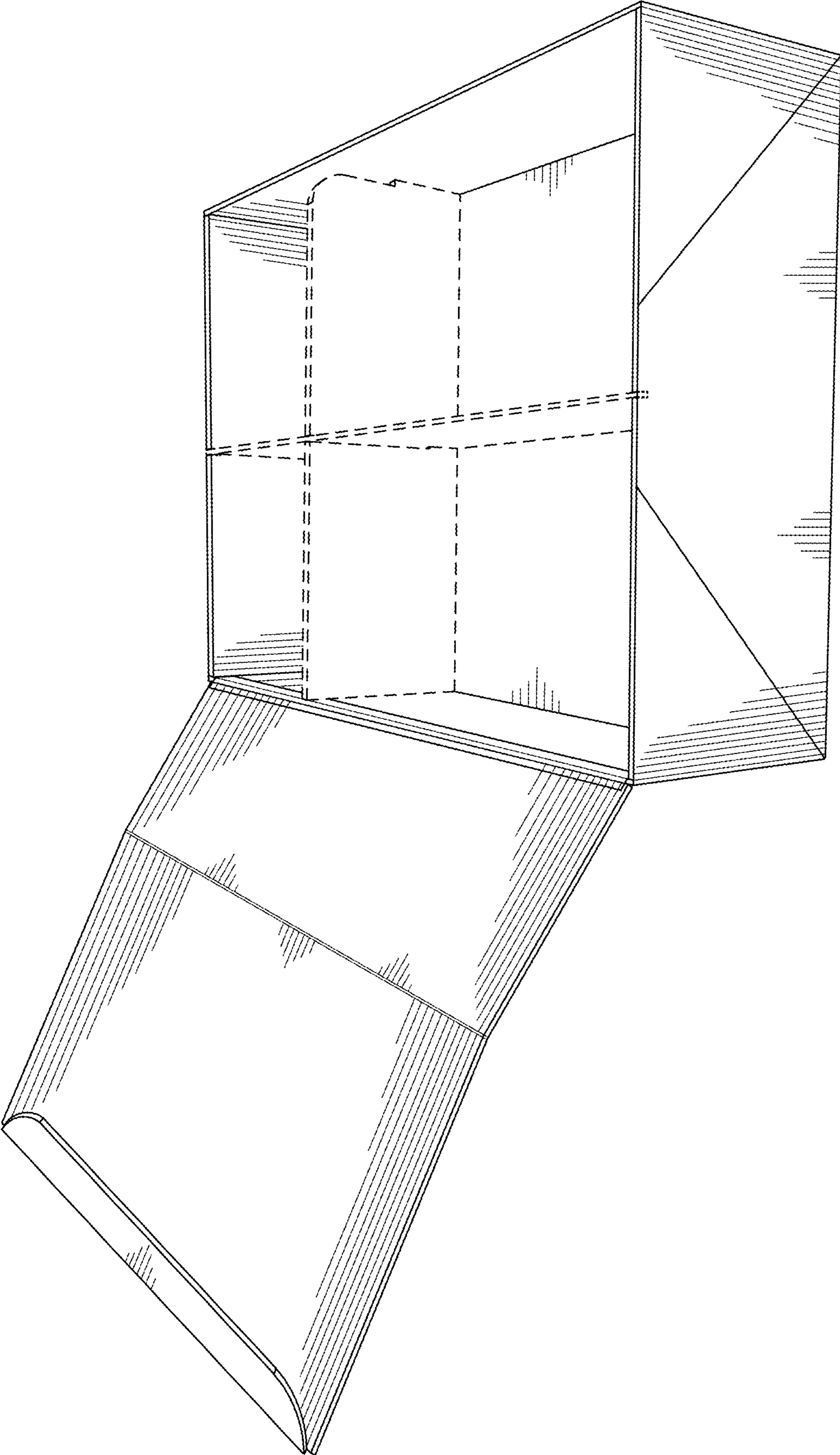

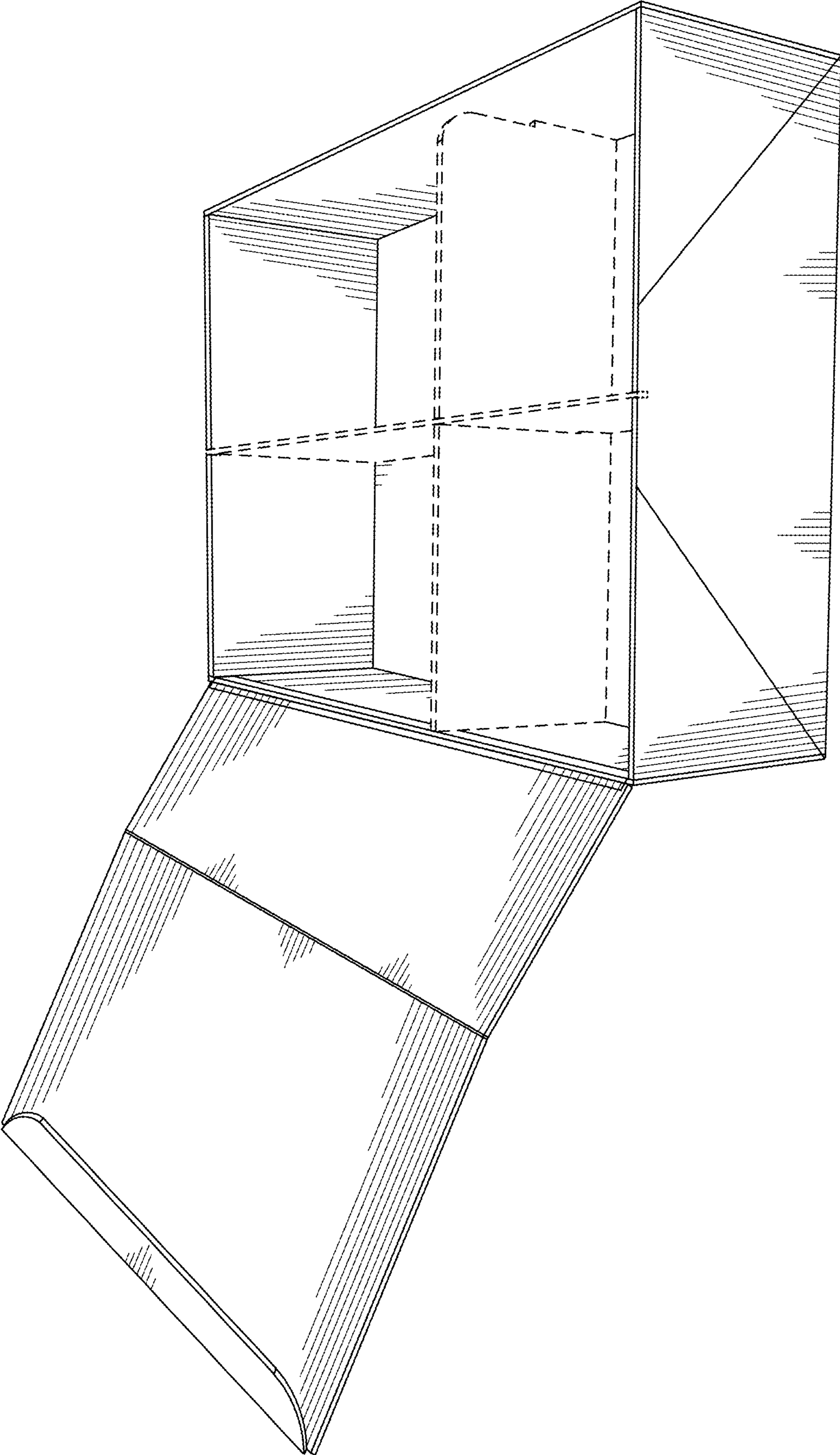
