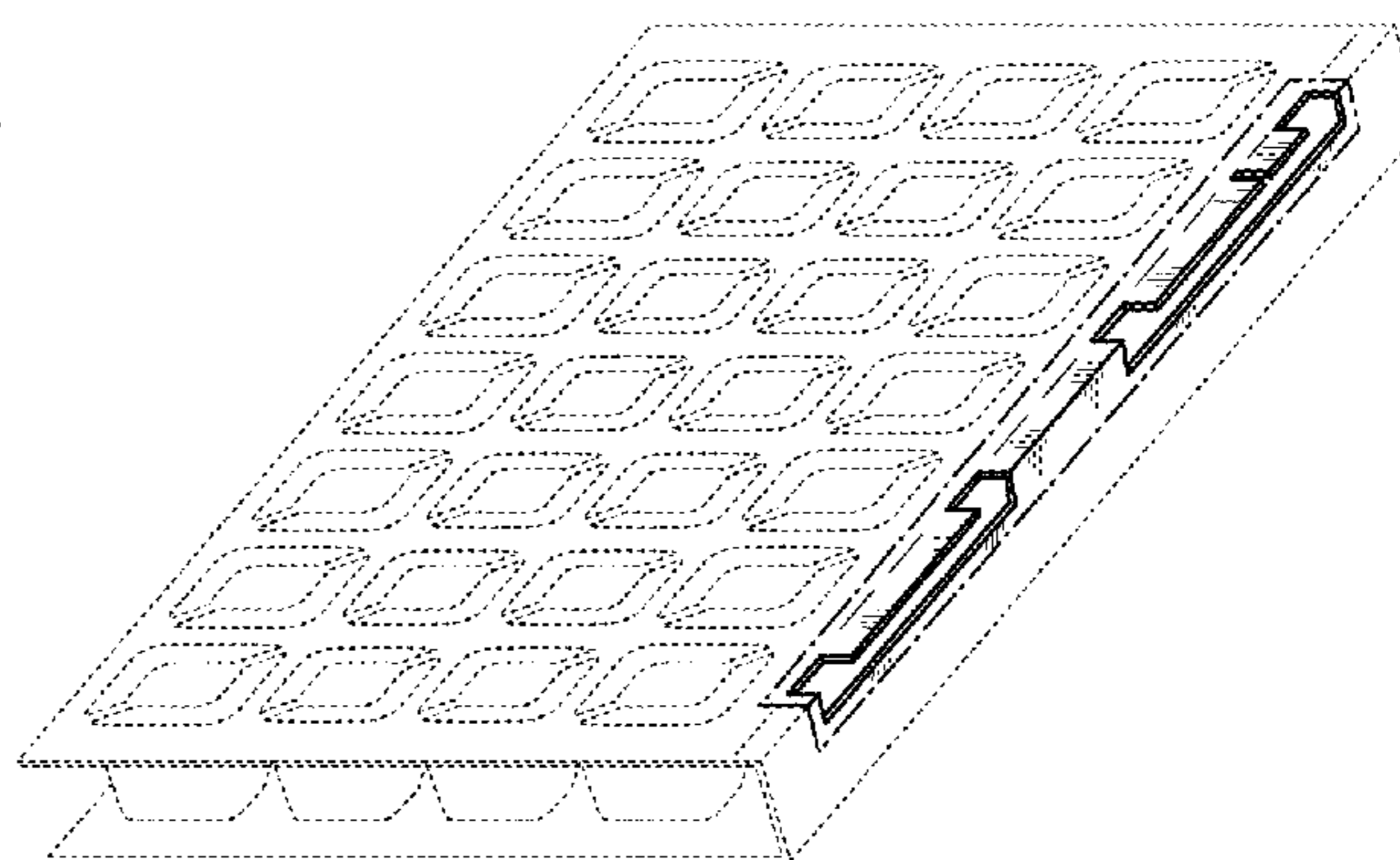
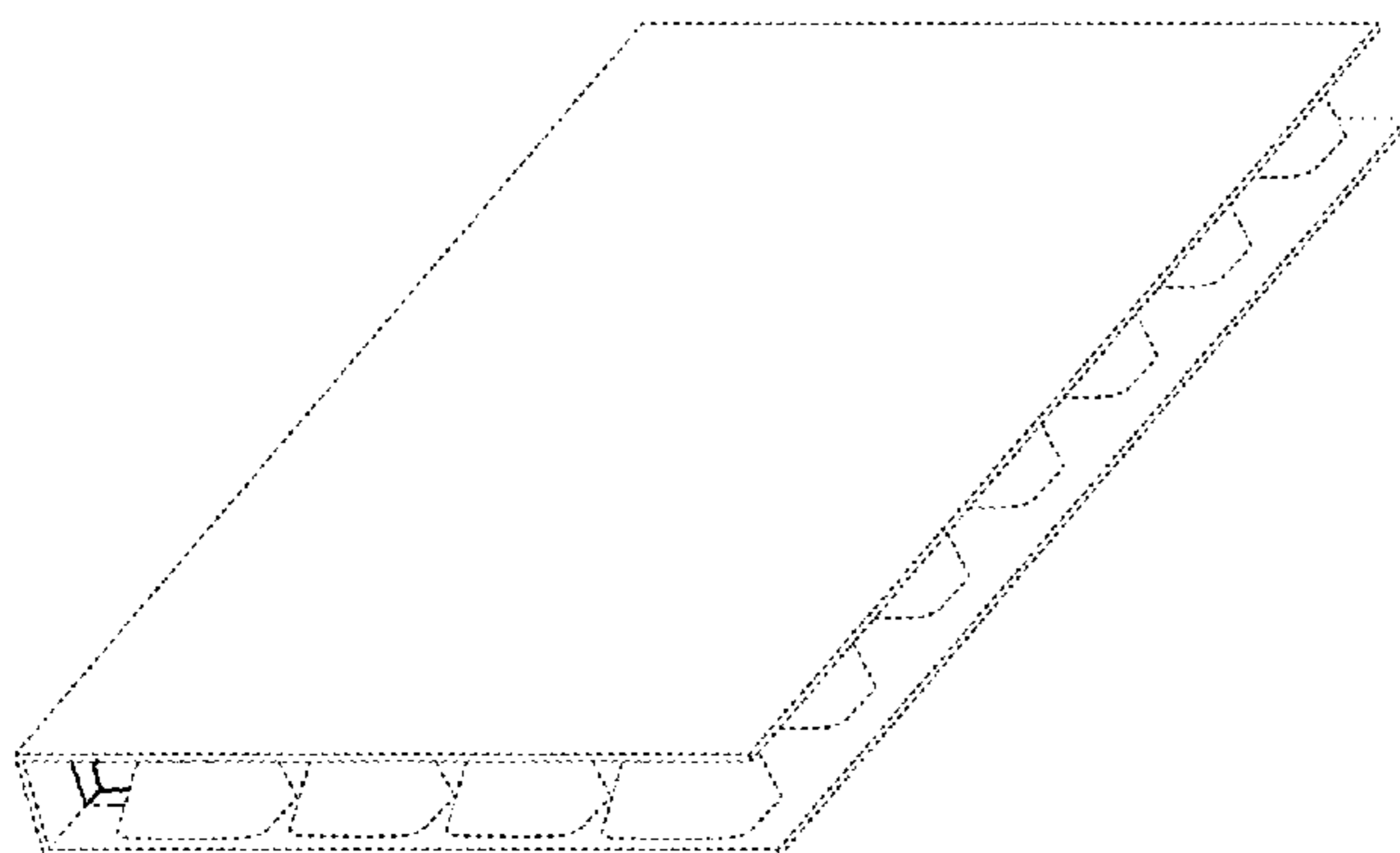
The ornamental design for a medication package, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a medication package showing our new design in a folded position;

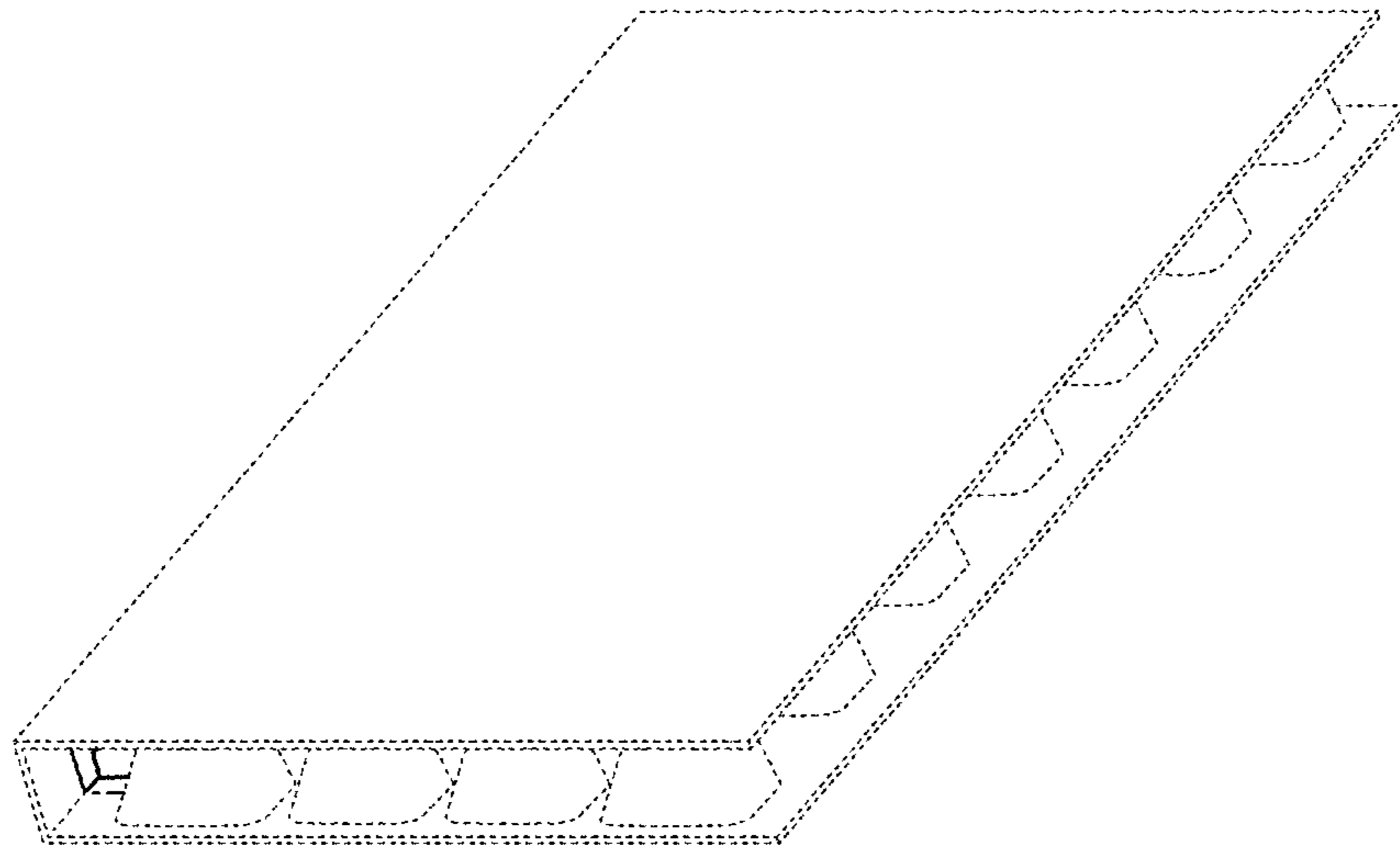

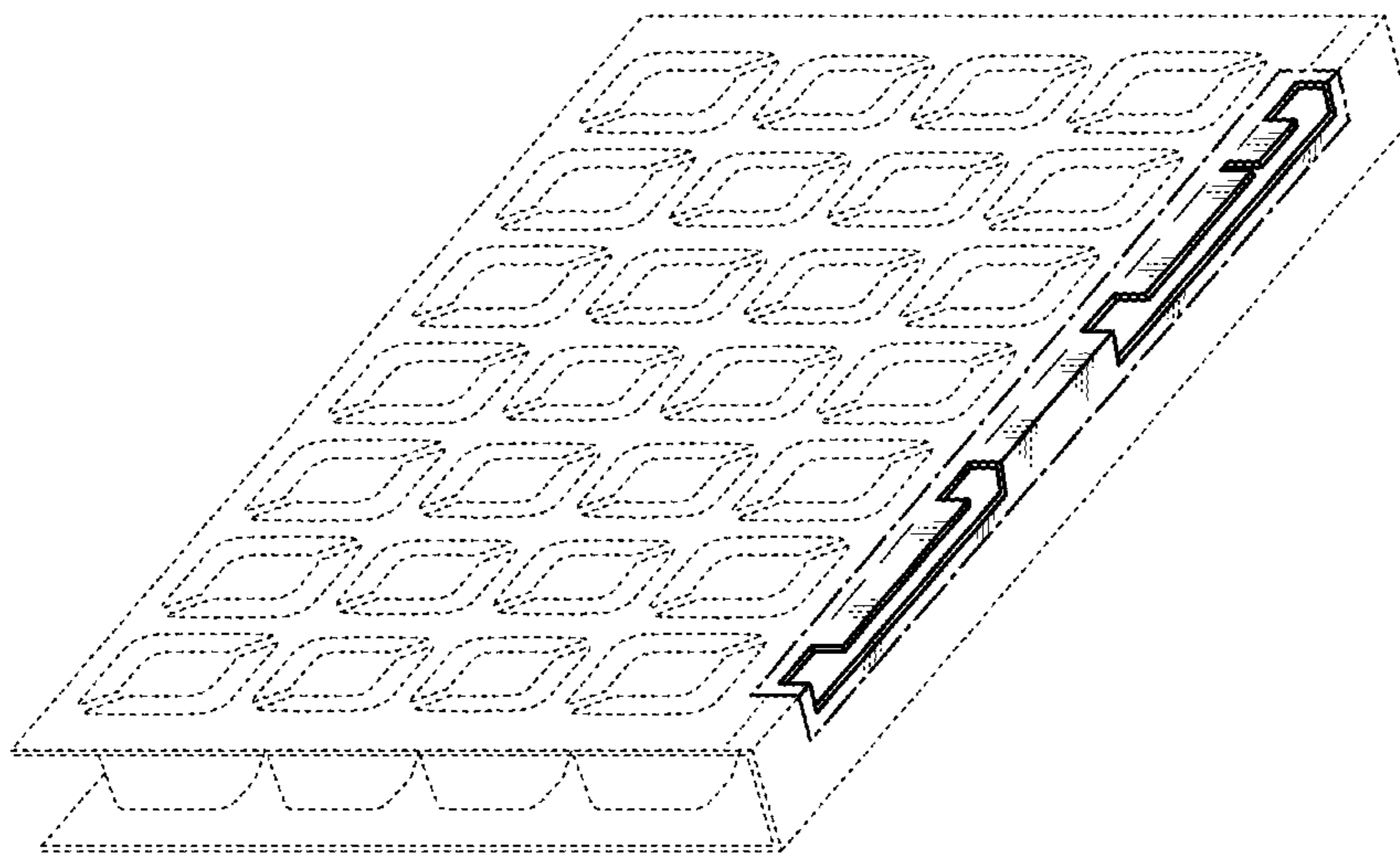

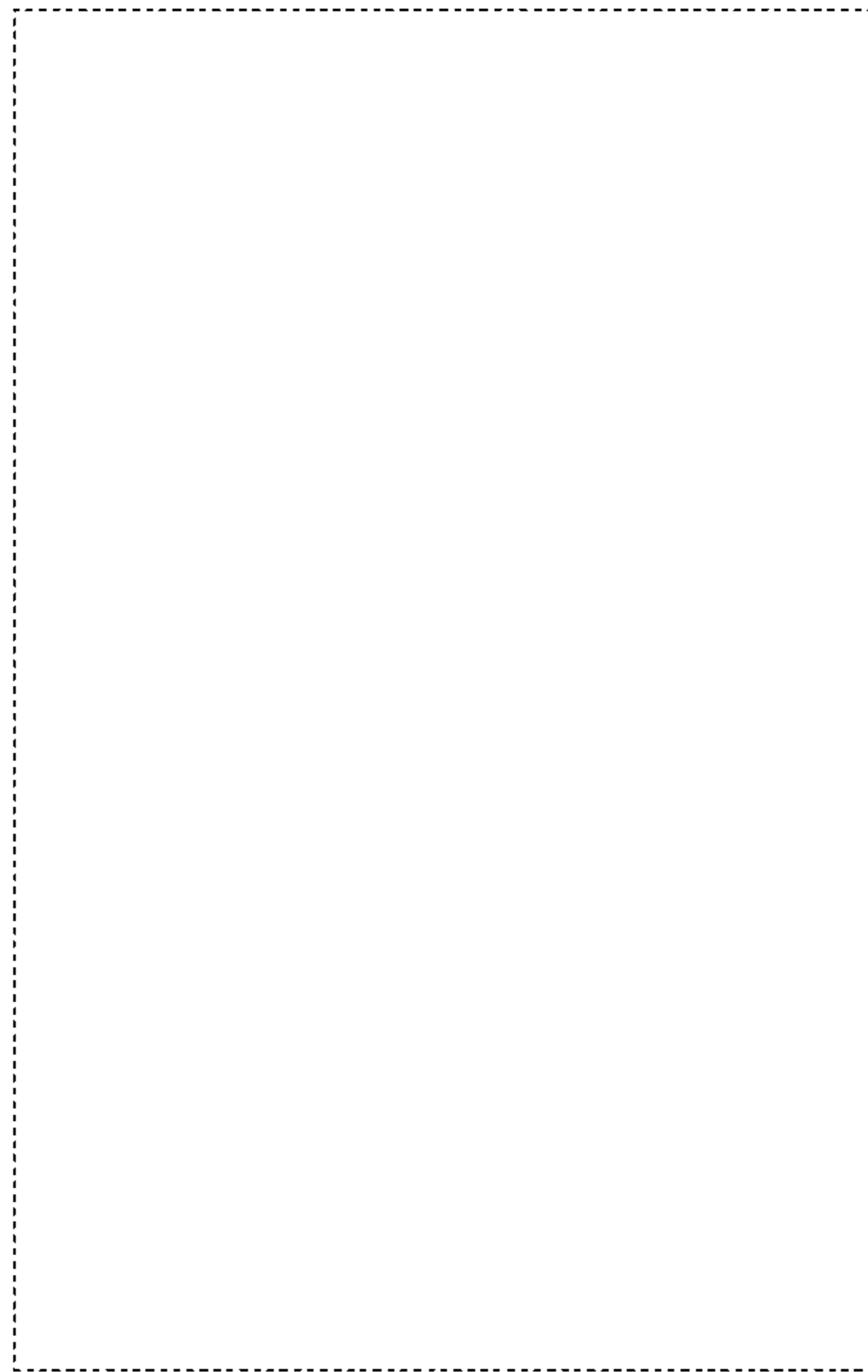

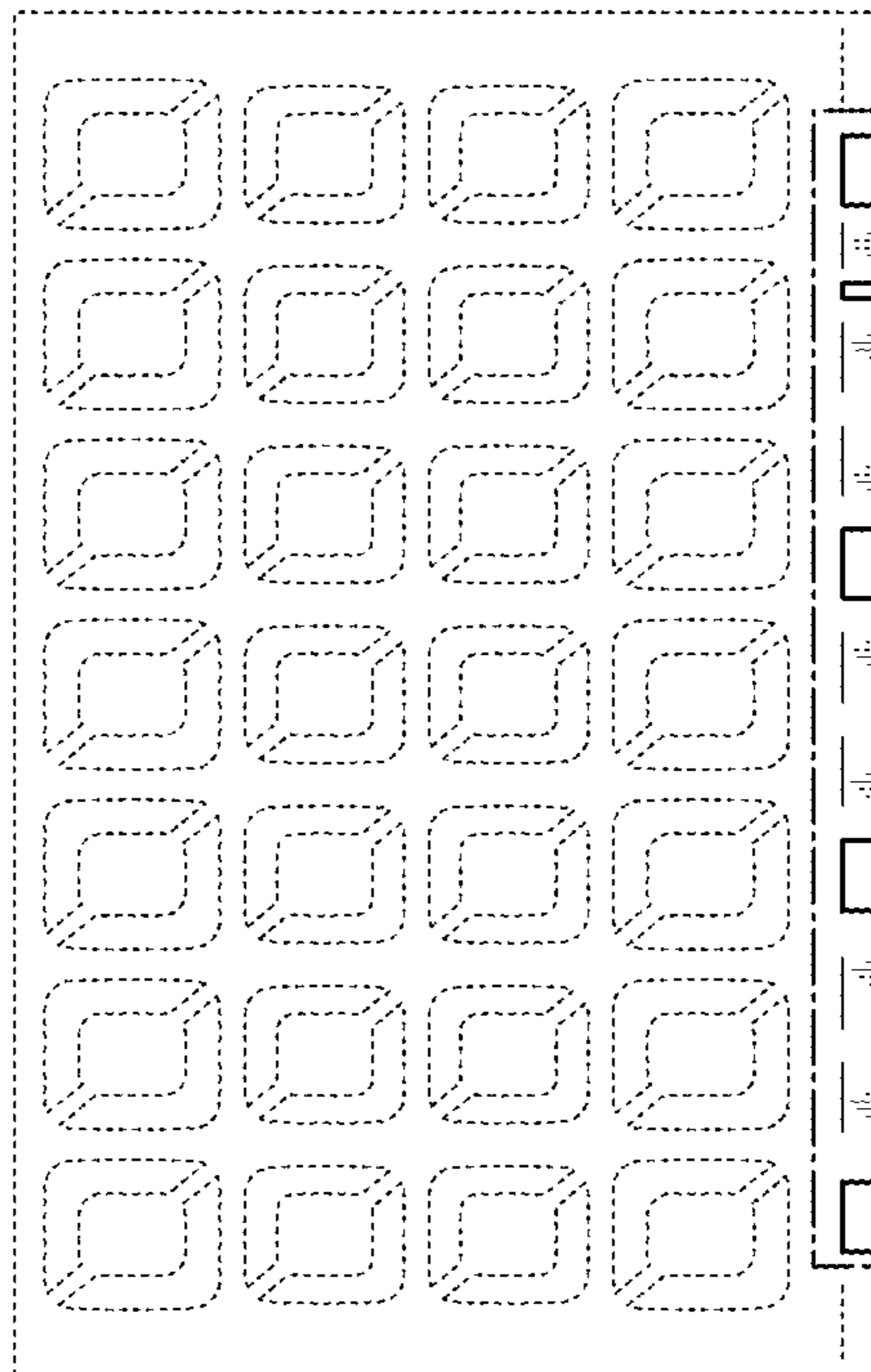

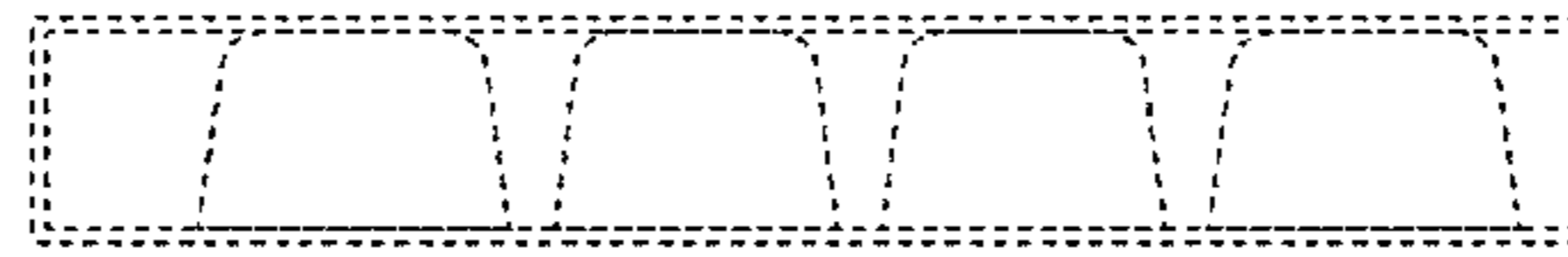

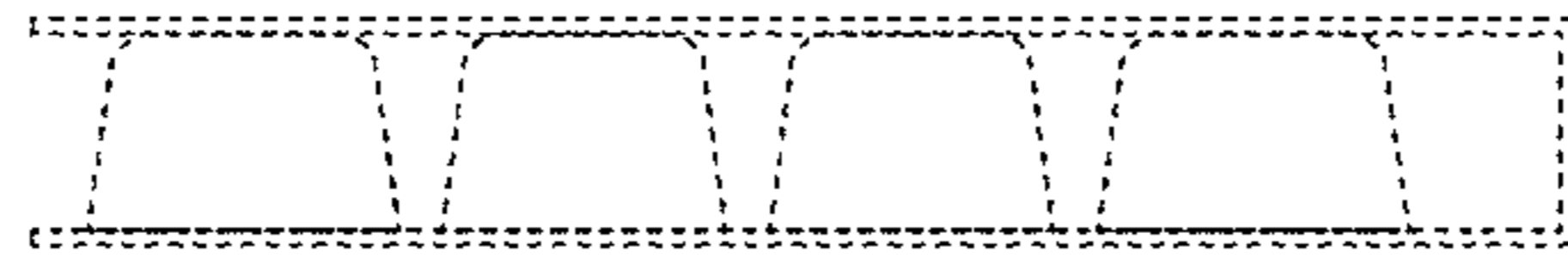

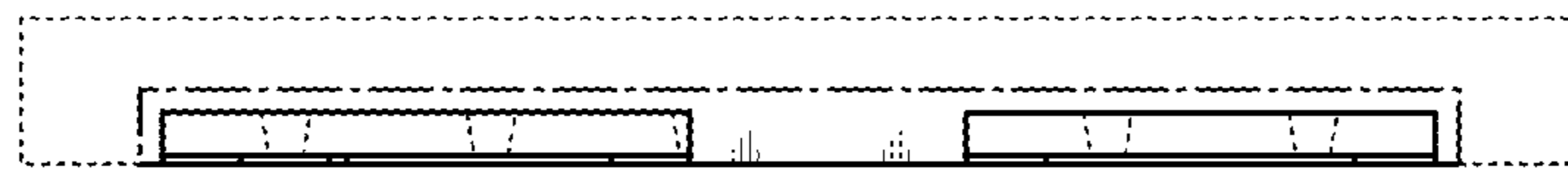

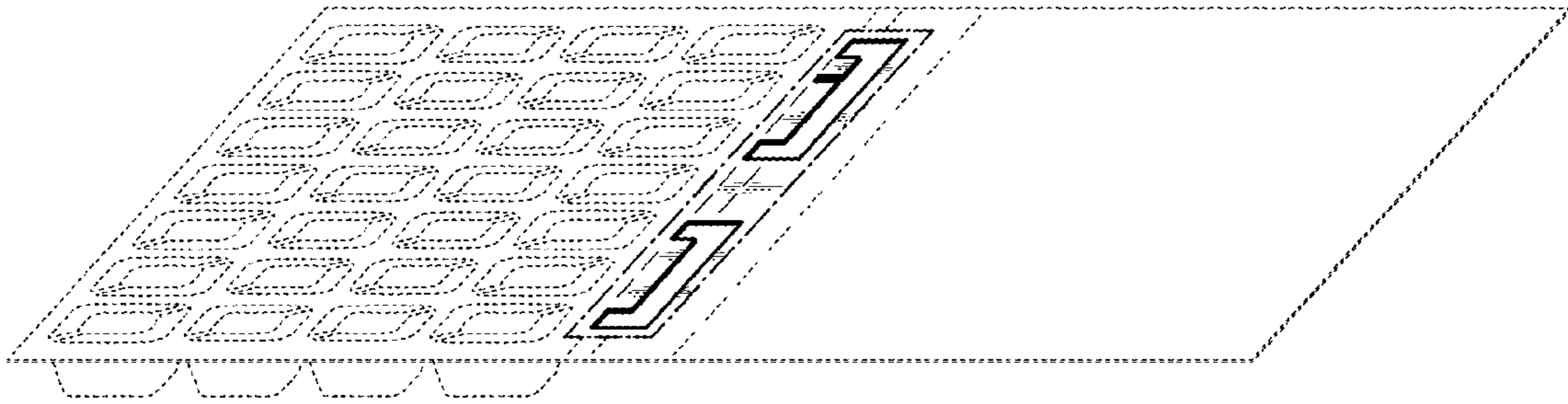

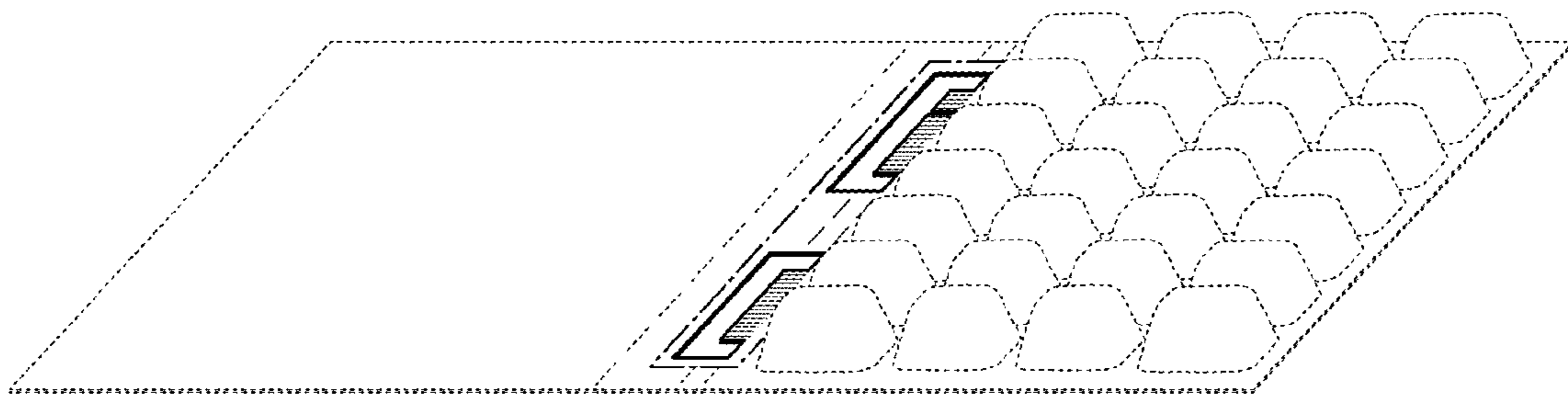

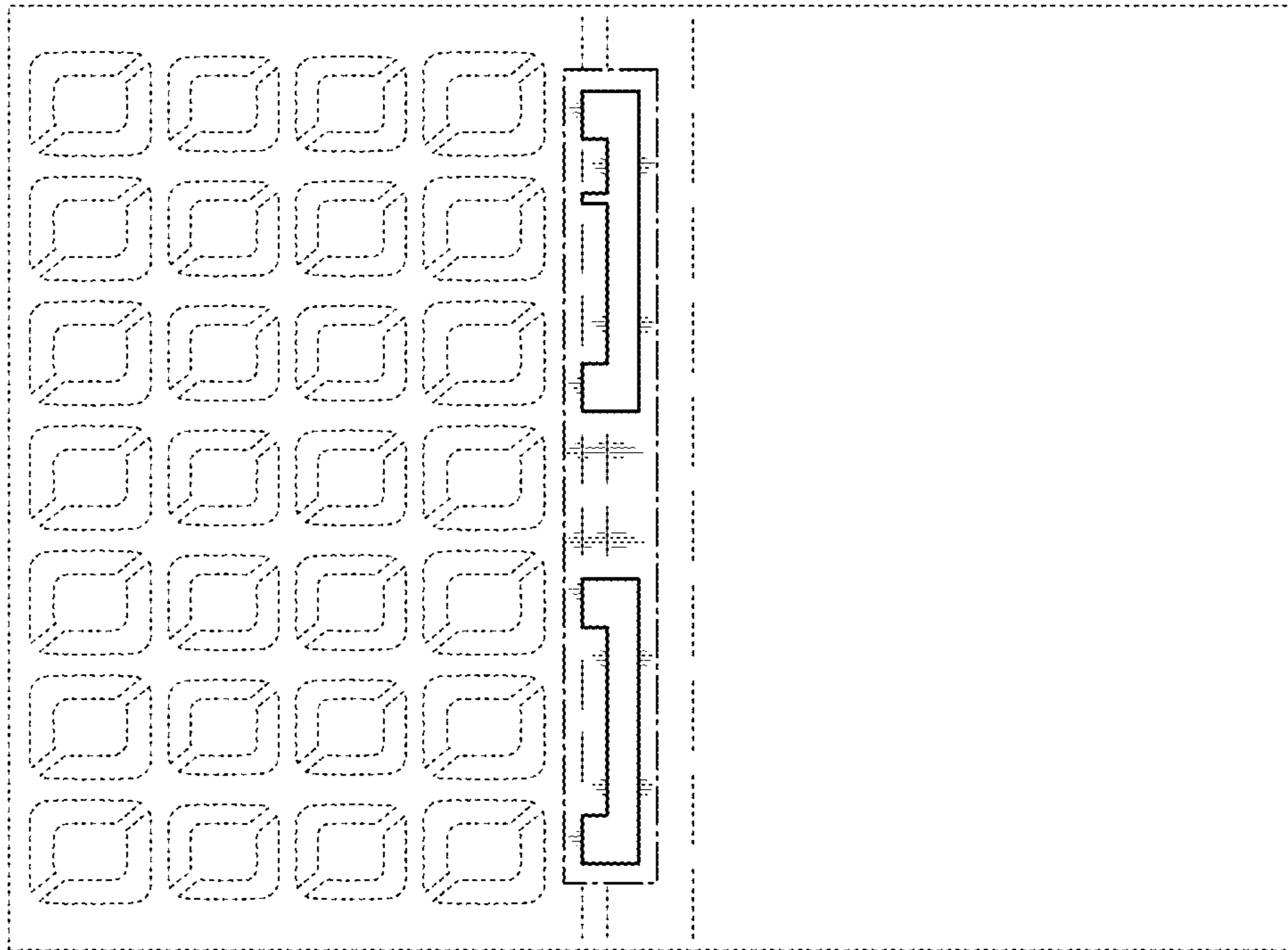

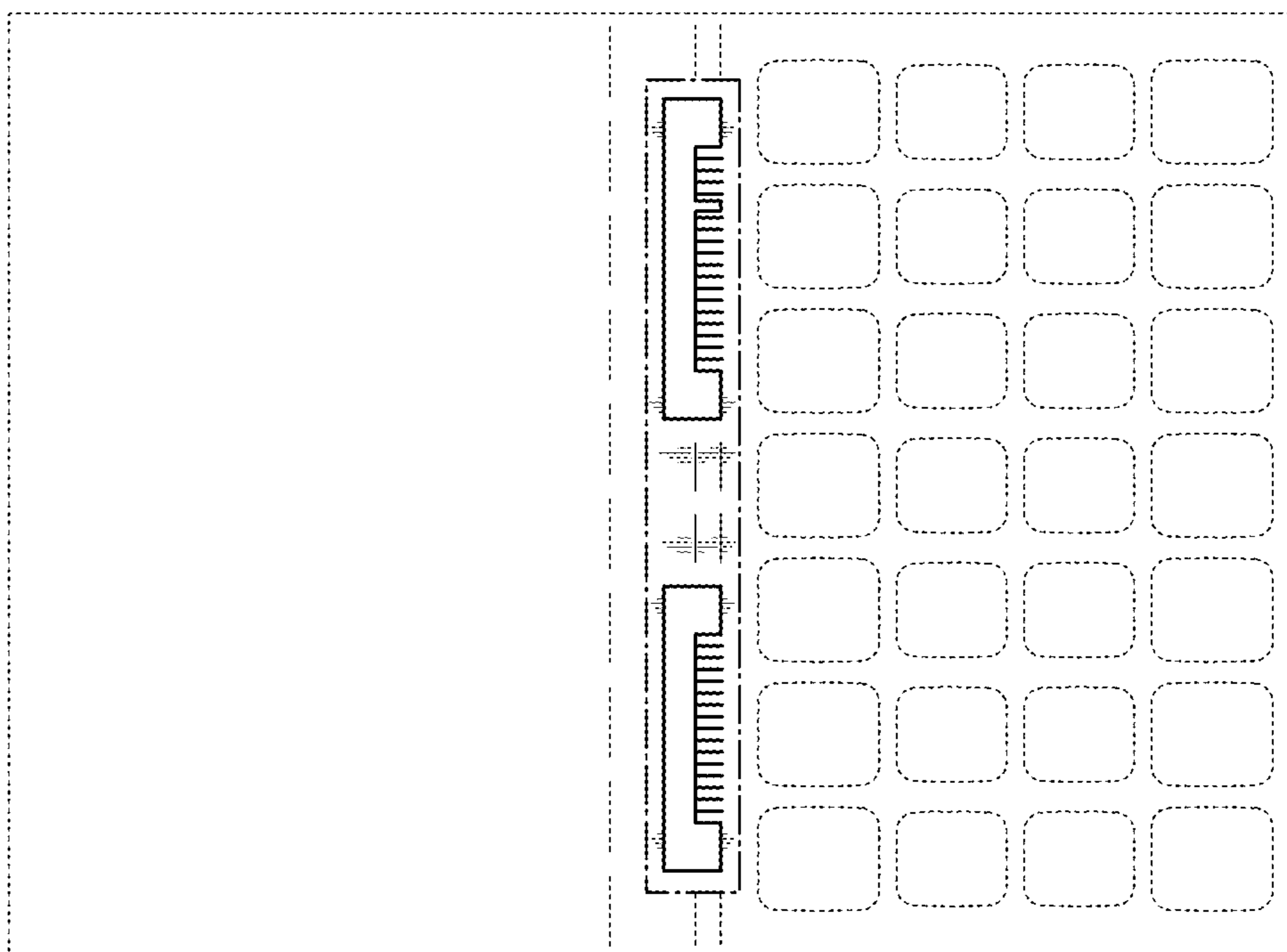

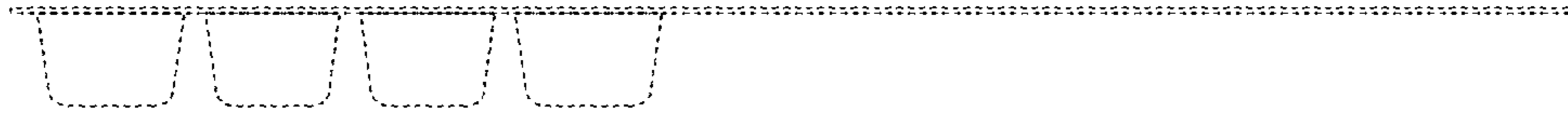

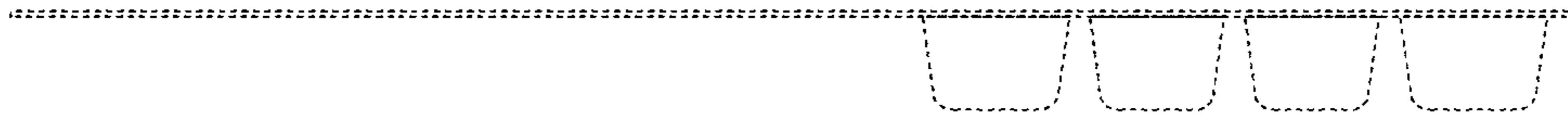
