The ornamental design for a fragrance bottle, as shown and described.

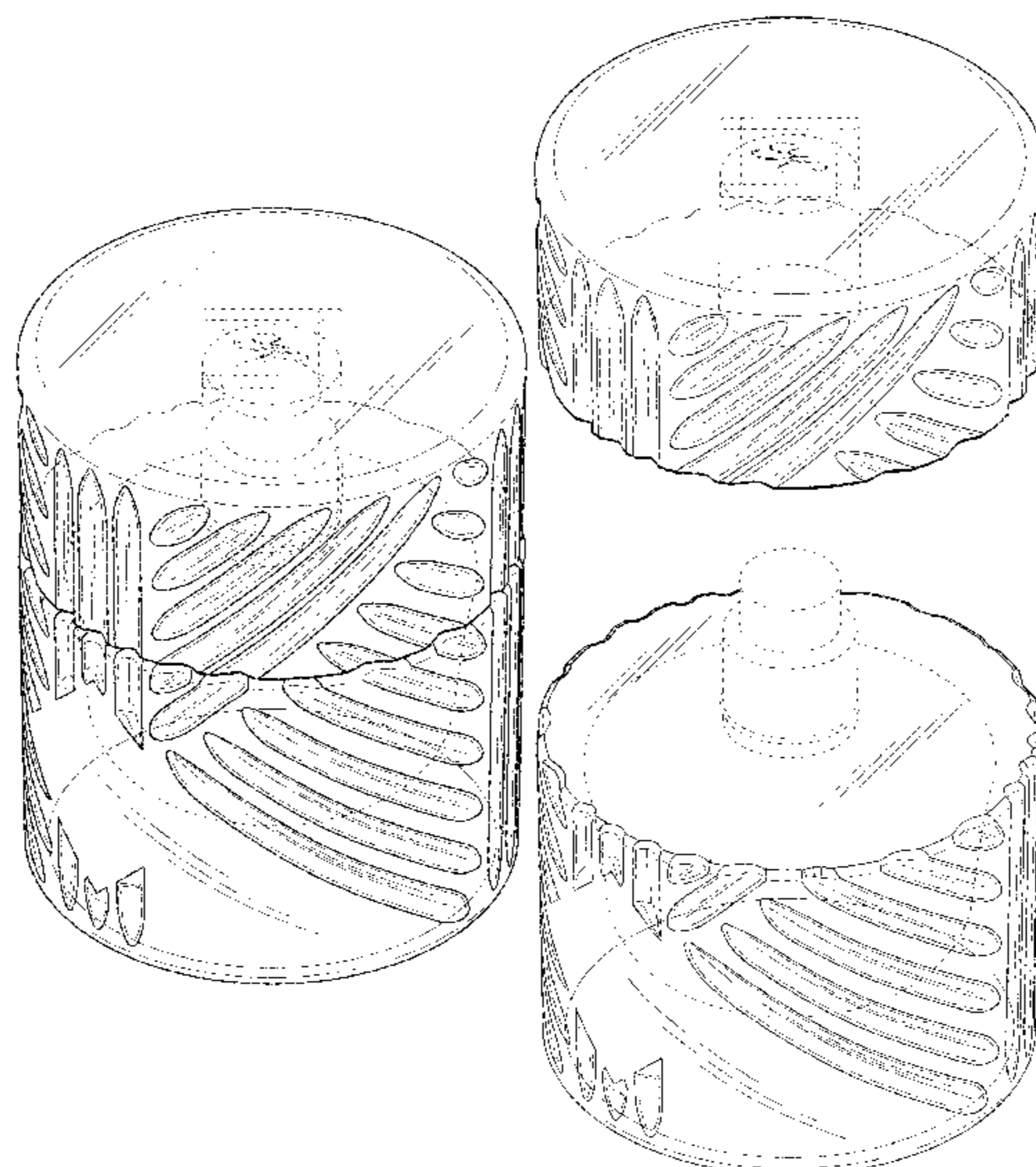
DESCRIPTION

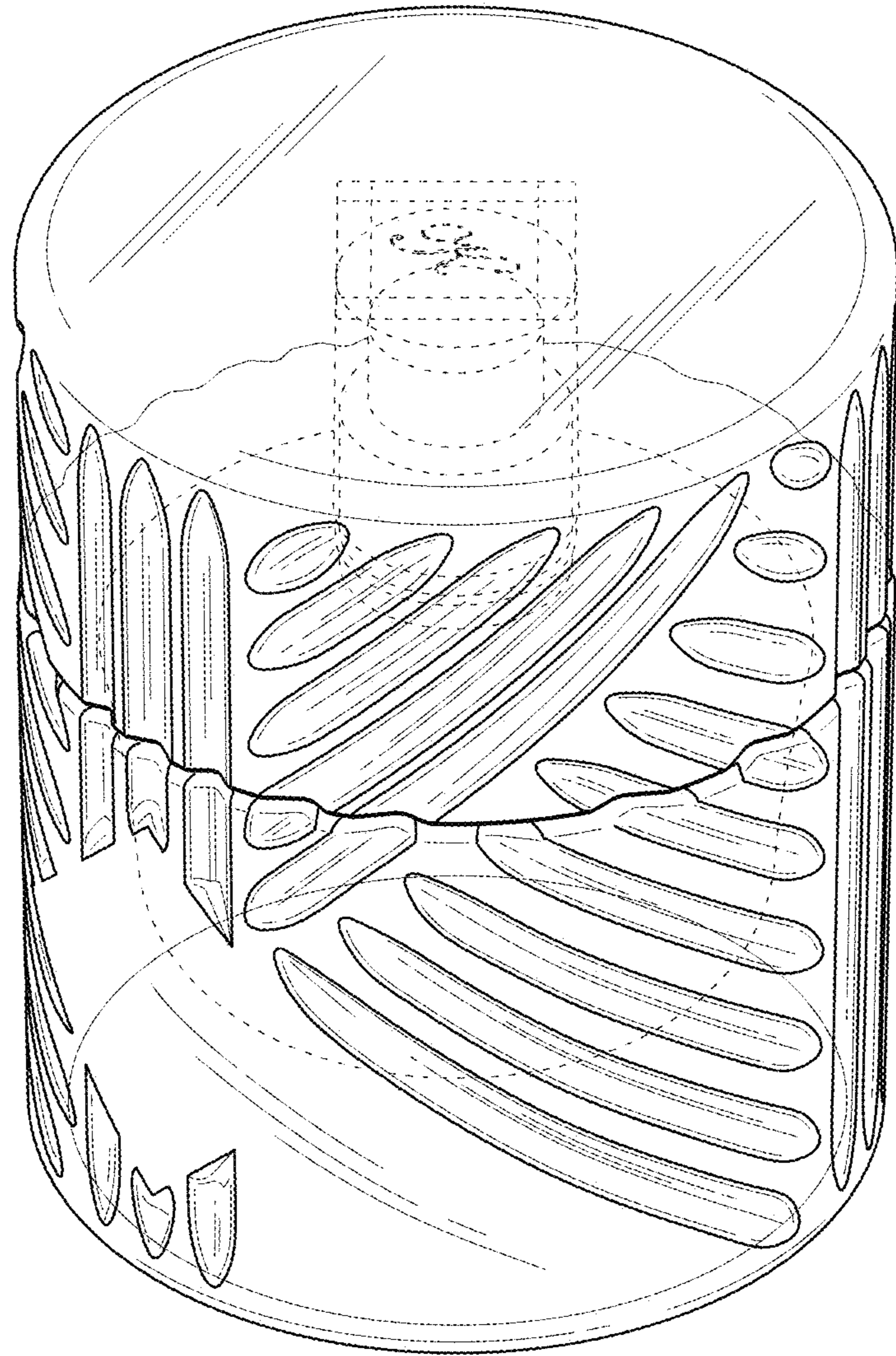

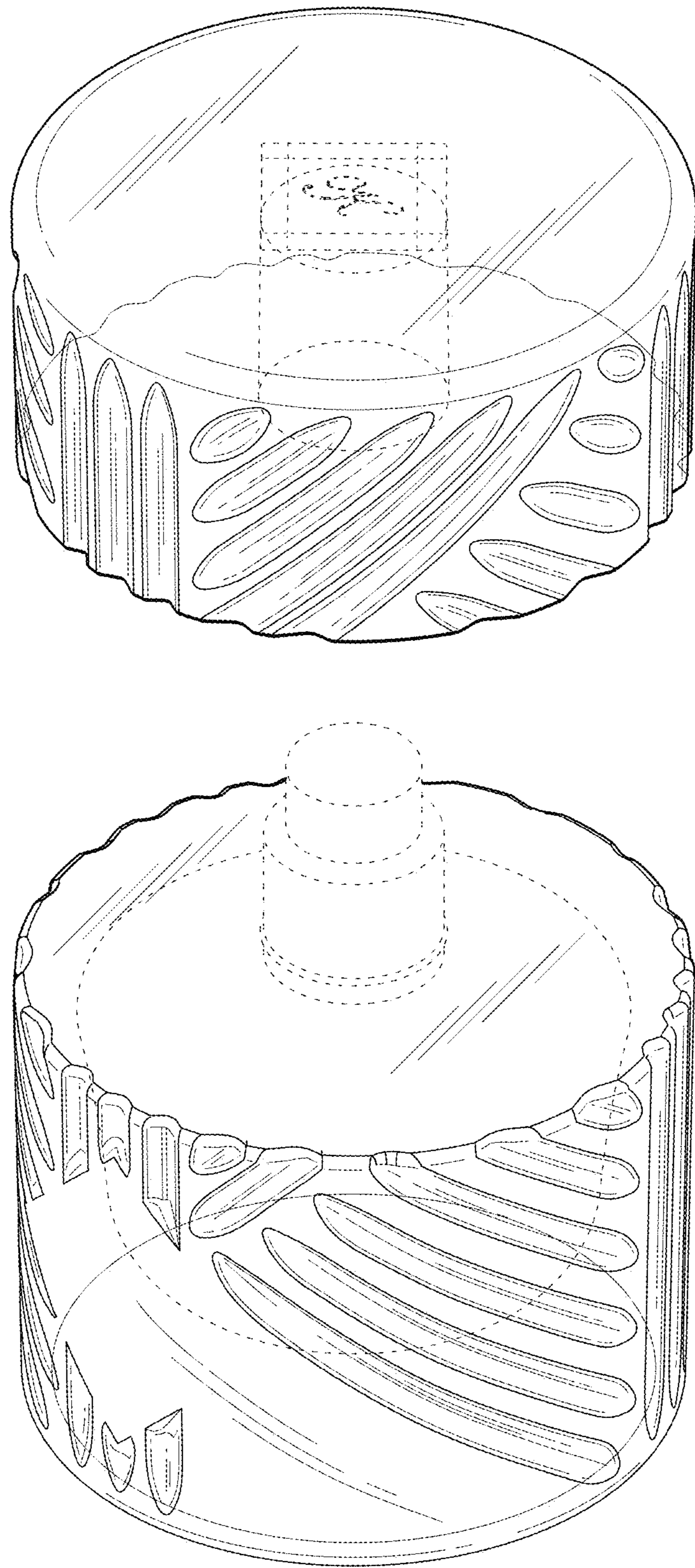

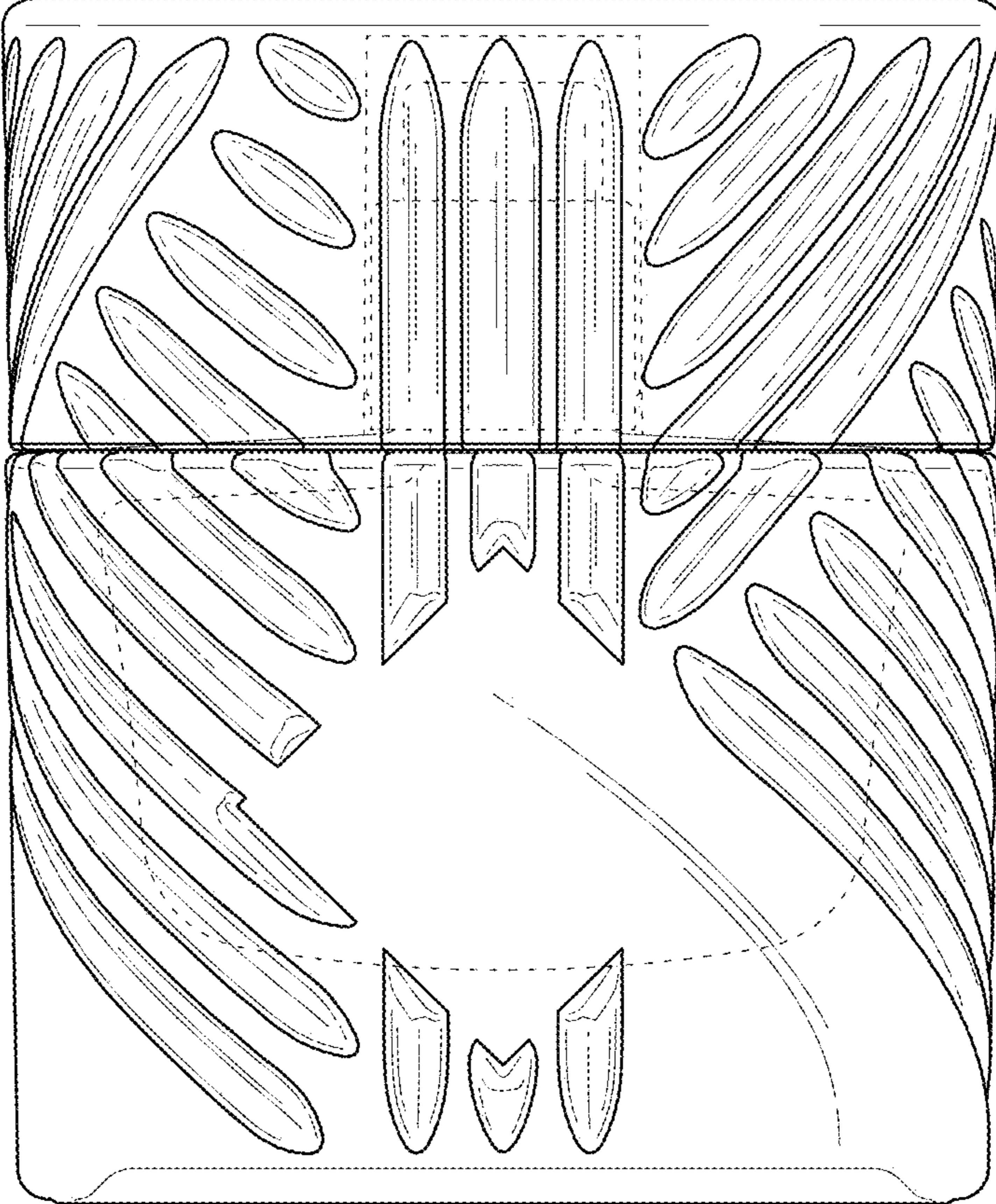

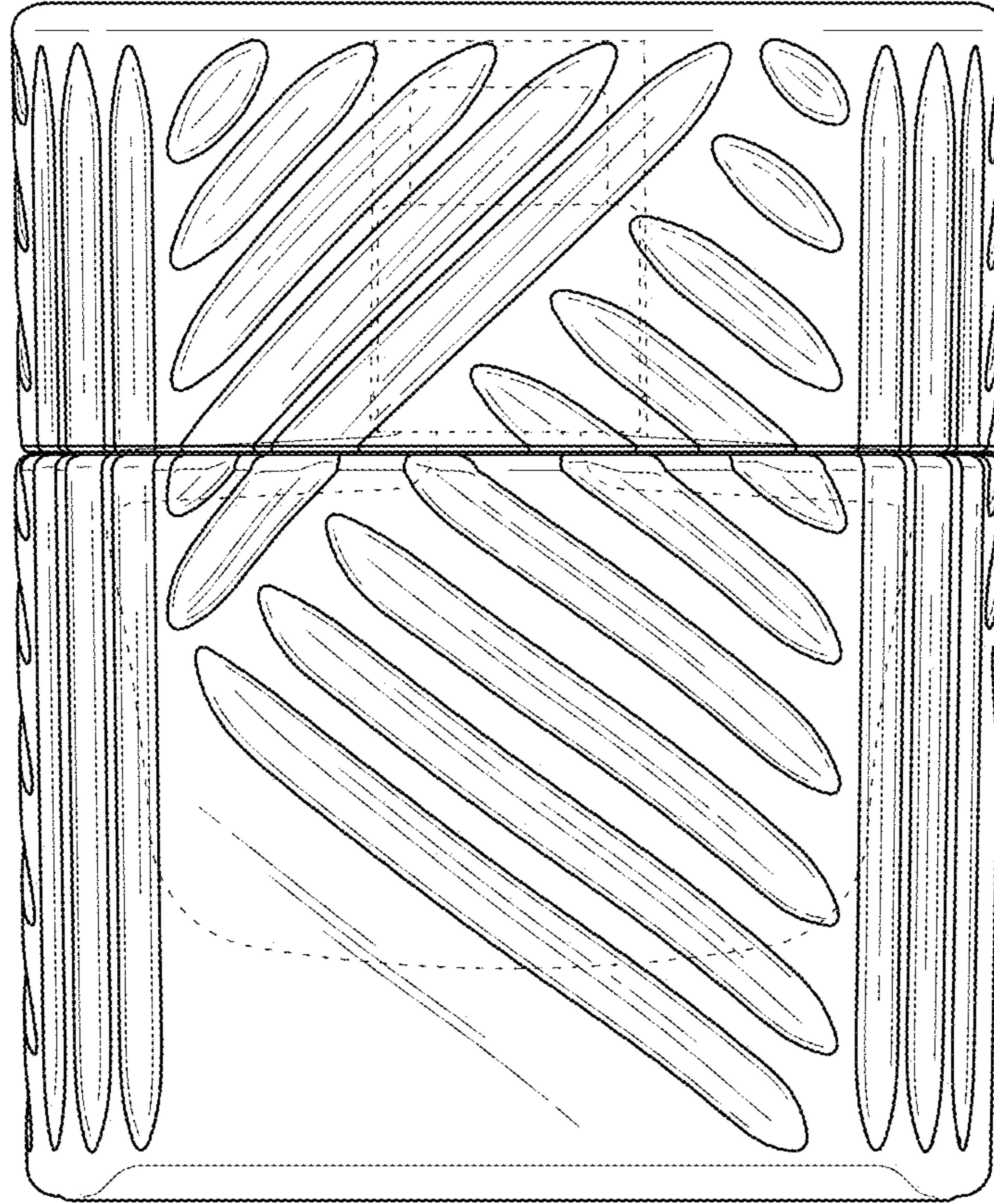

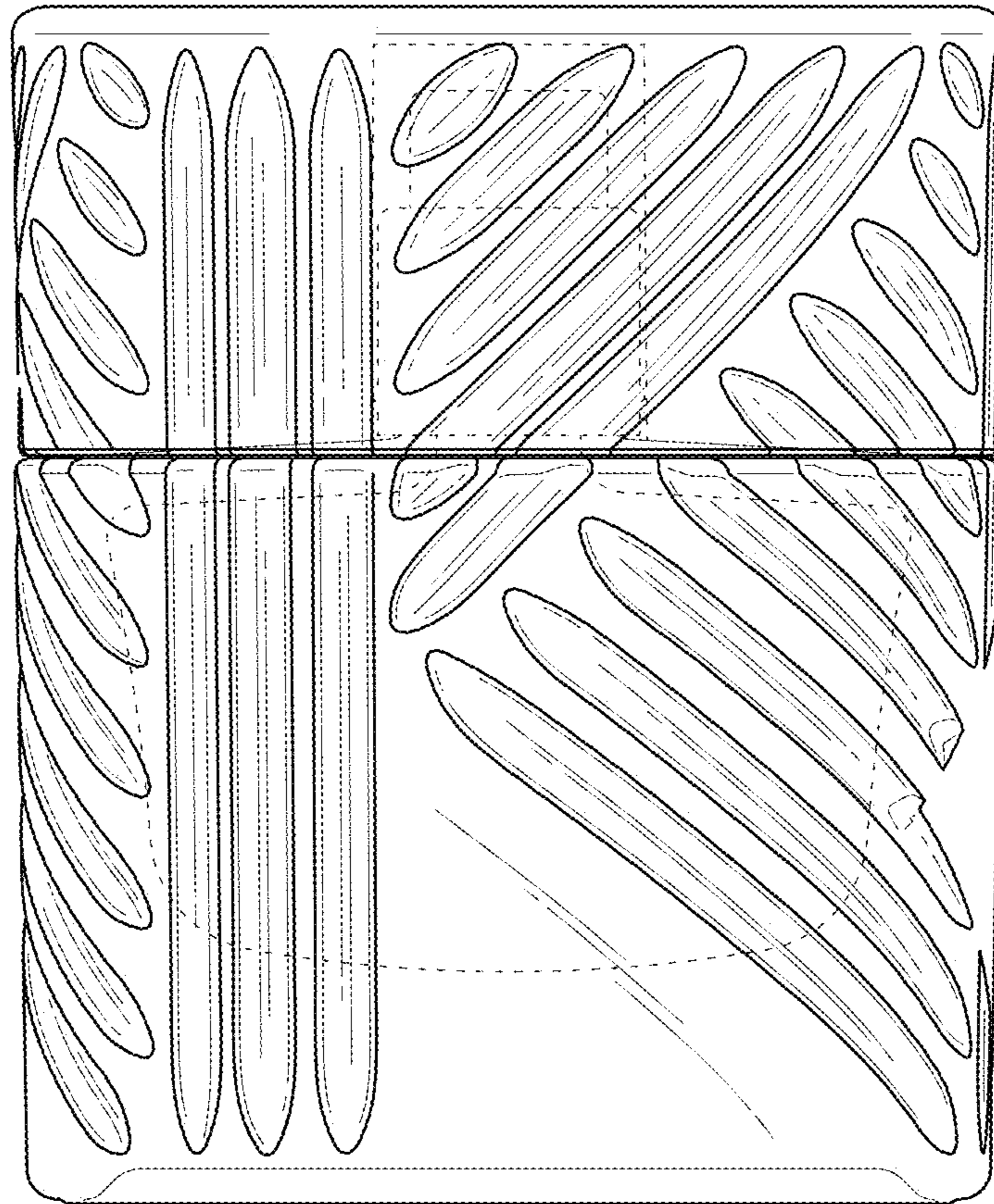

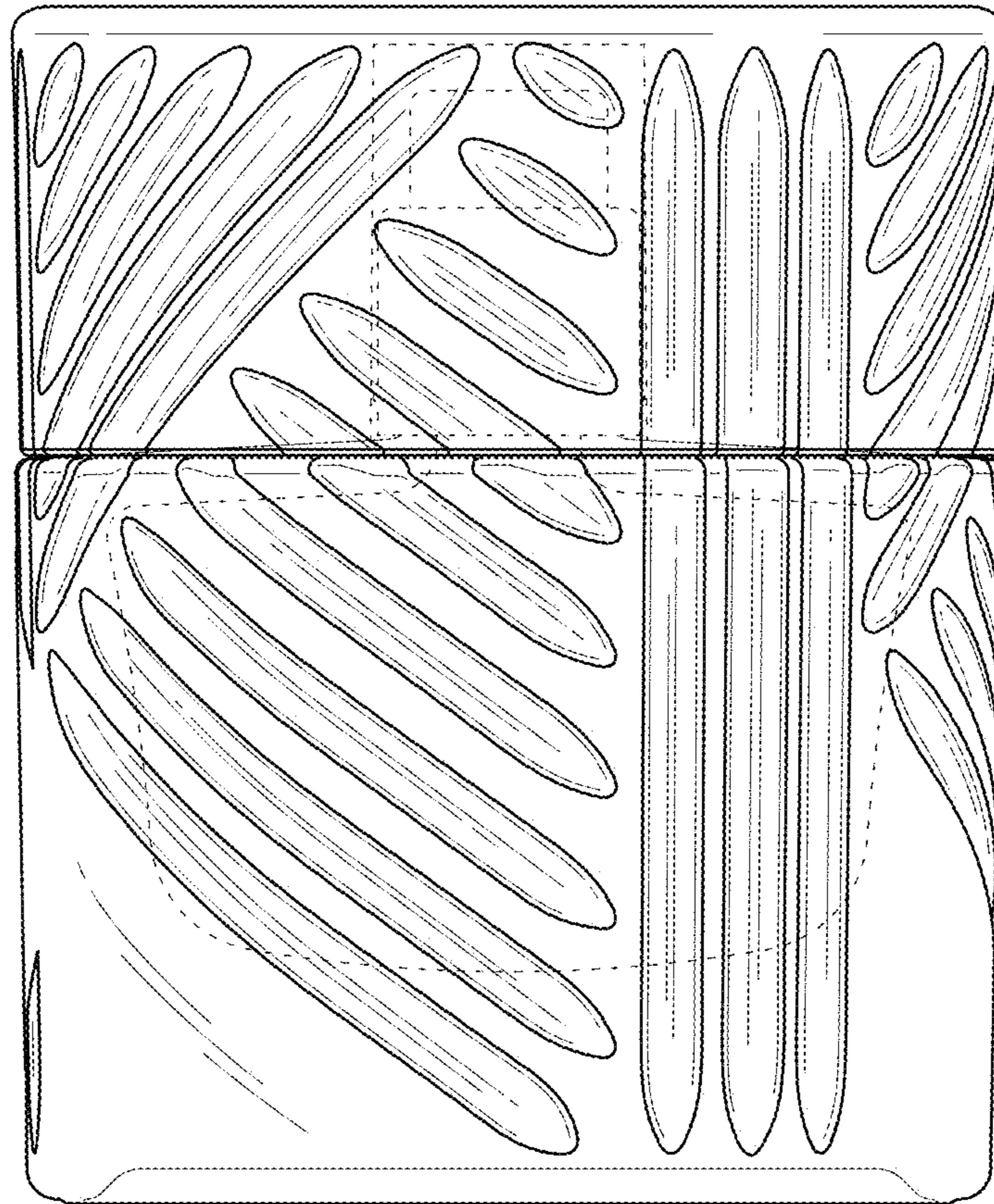

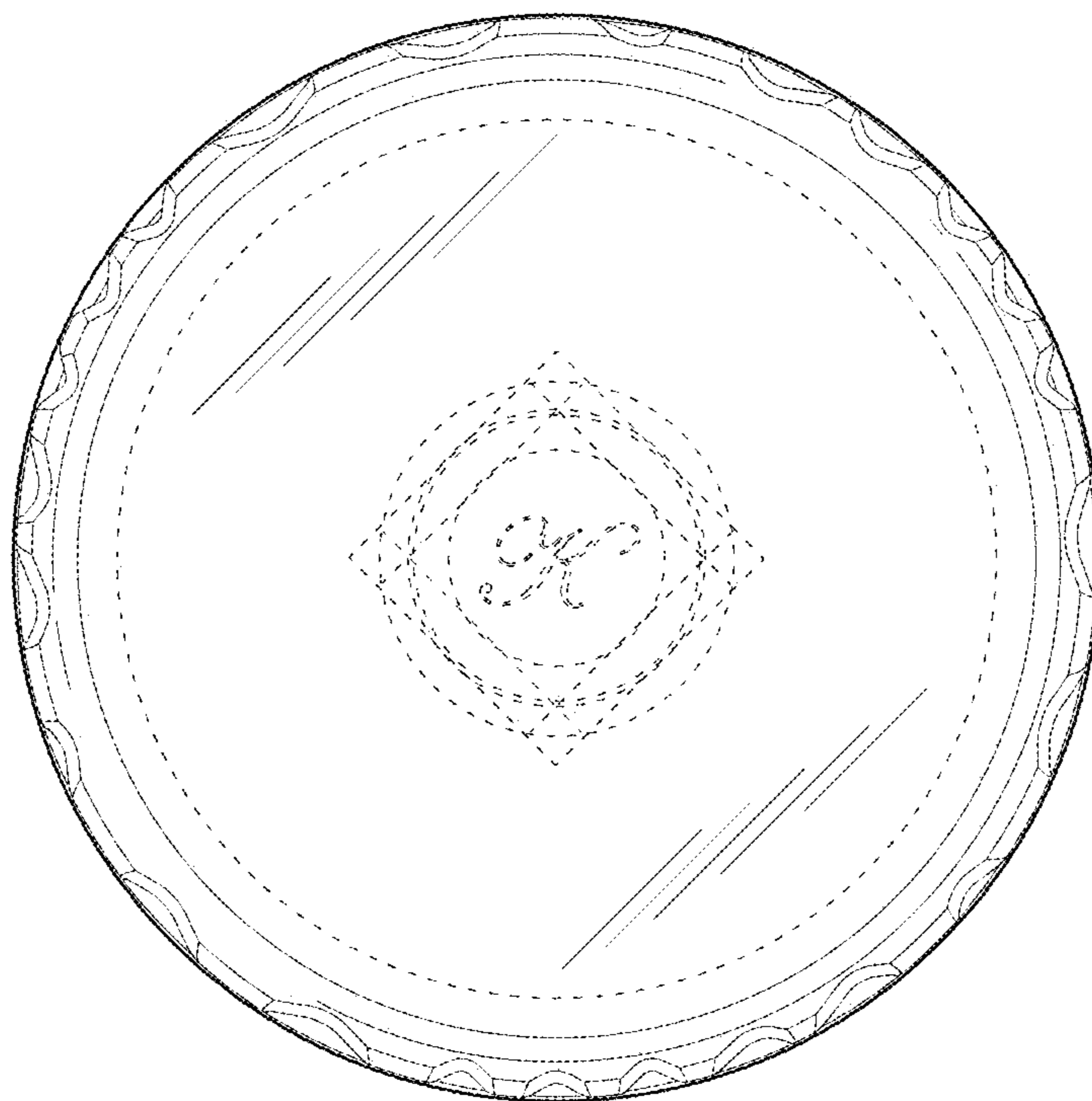

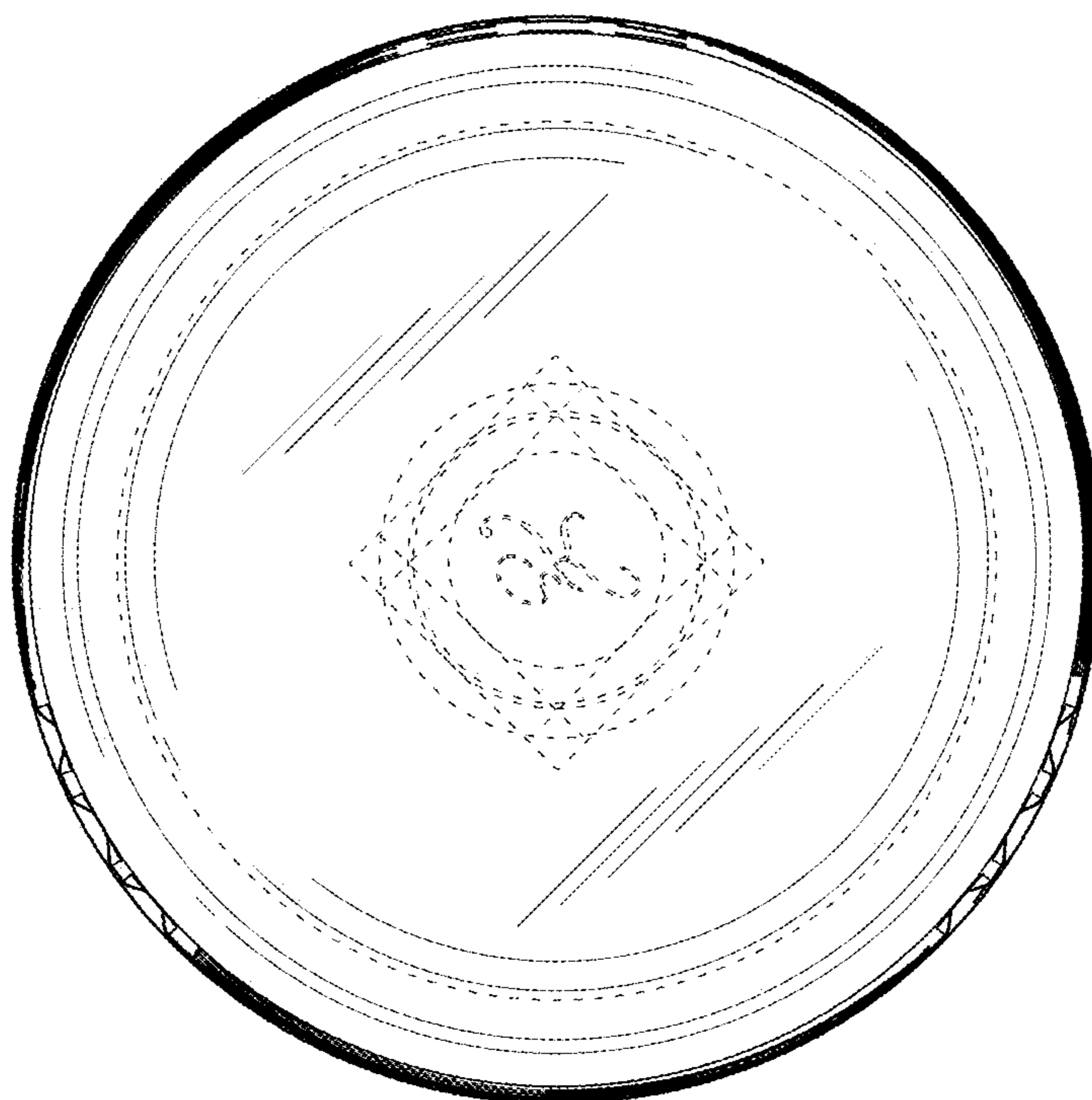
