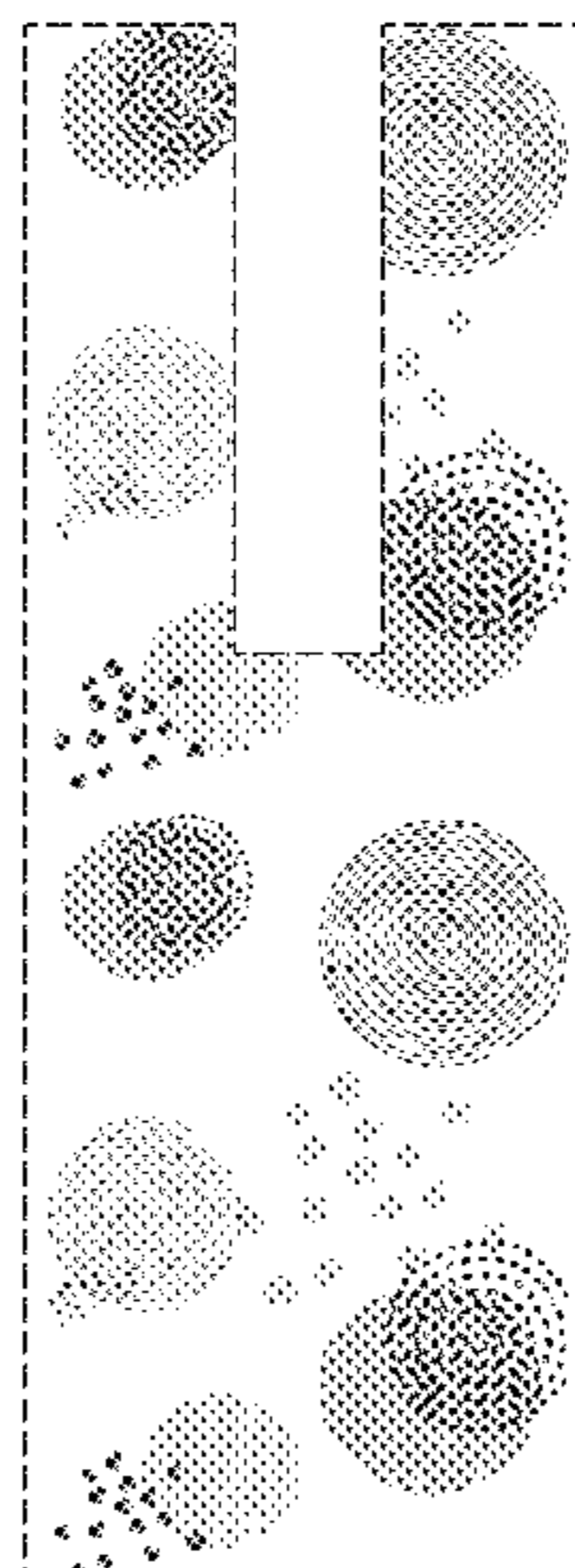
(57) **CLAIM**

The ornamental design for a bag with surface ornamentation, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a bag with surface ornamentation showing my new design, the back elevational view thereof being identical thereto; FIG. 2 is a right side view thereof in an open condition, the left side view thereof being identical thereto; FIG. 3 is a bottom view thereof in said open condition; and, FIG. 4 is a top view thereof in said open condition. The broken lines surrounding or extending across the claimed design are for environmental purposes only and

form no part of the claimed design. Differences in grayscale shading illustrate a contrast in appearance, and does not represent any particular color, material, texture or finish. The two sets of seven broken, generally parallel, slanted lines along the left side of FIG. 1 form no part of the claimed design.

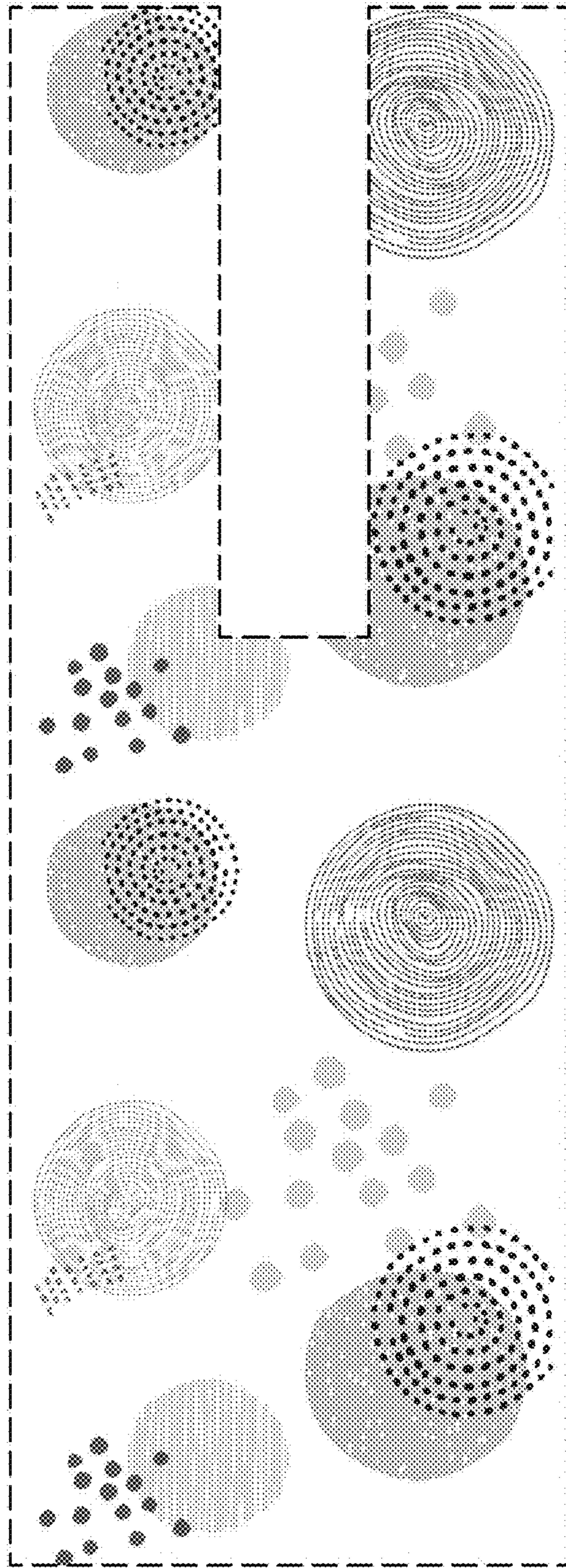

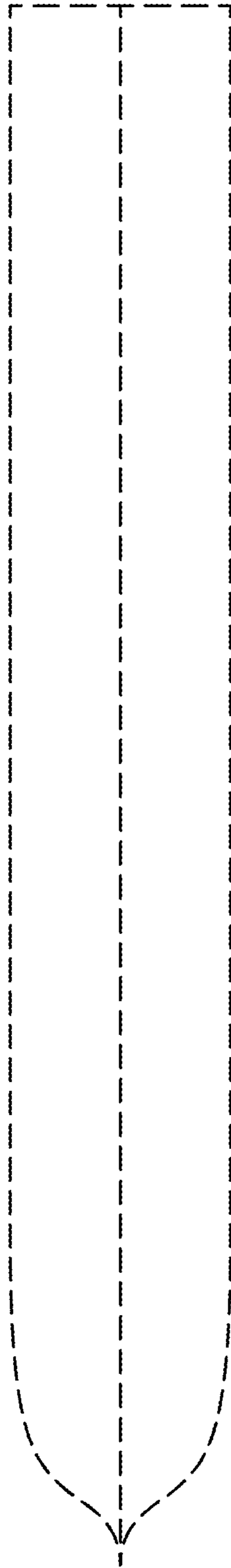

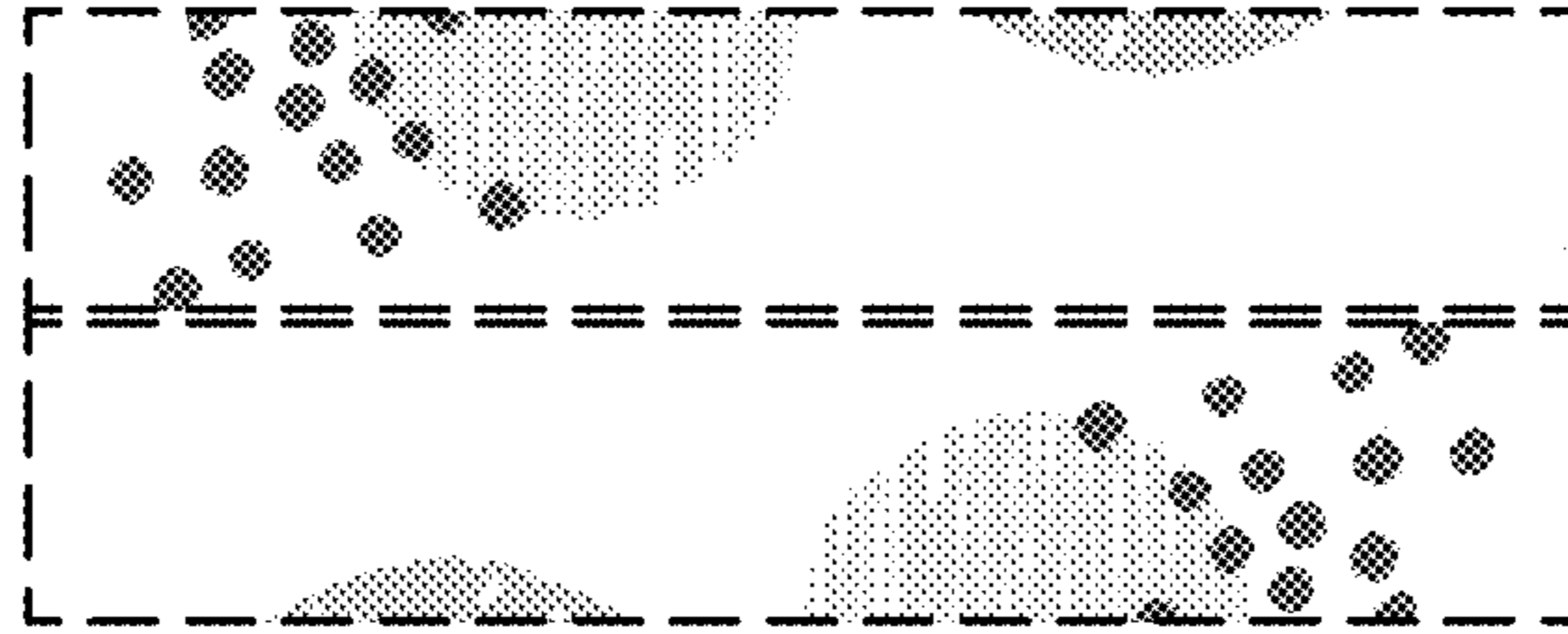

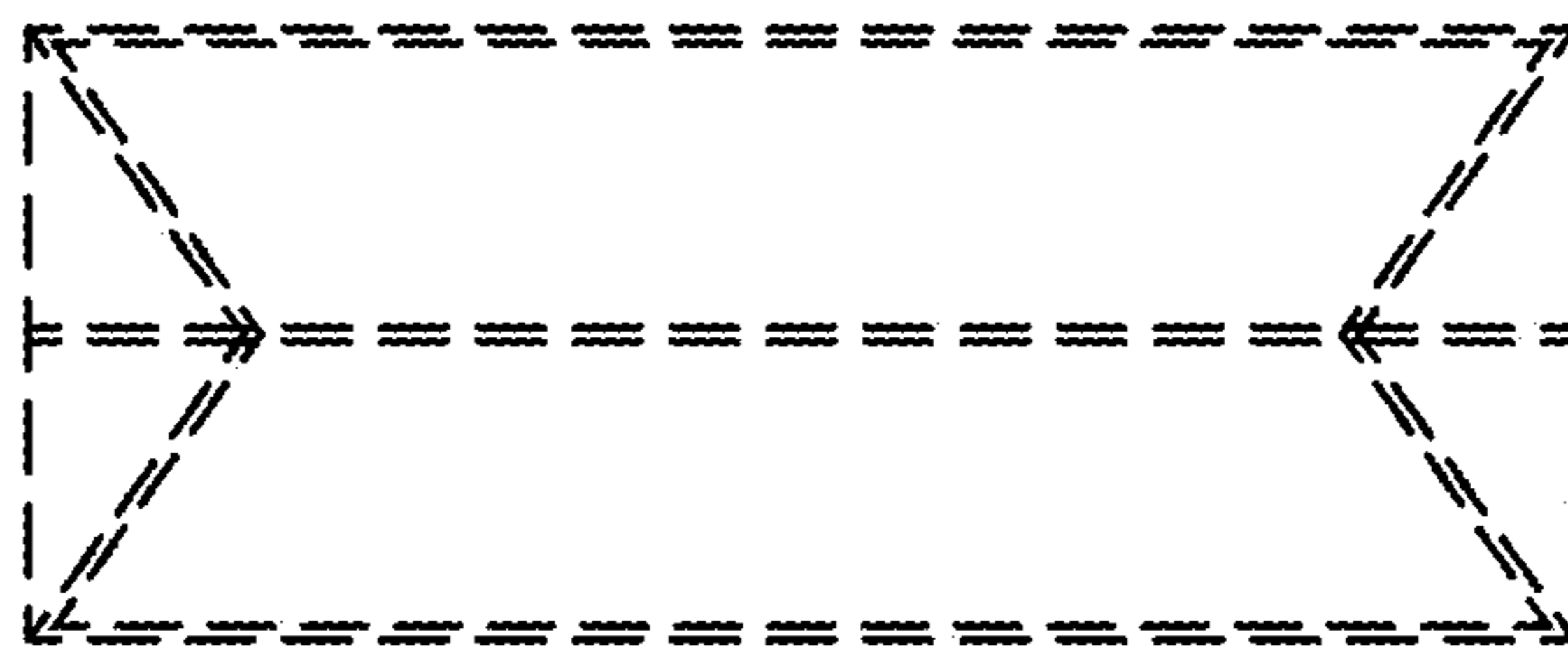
