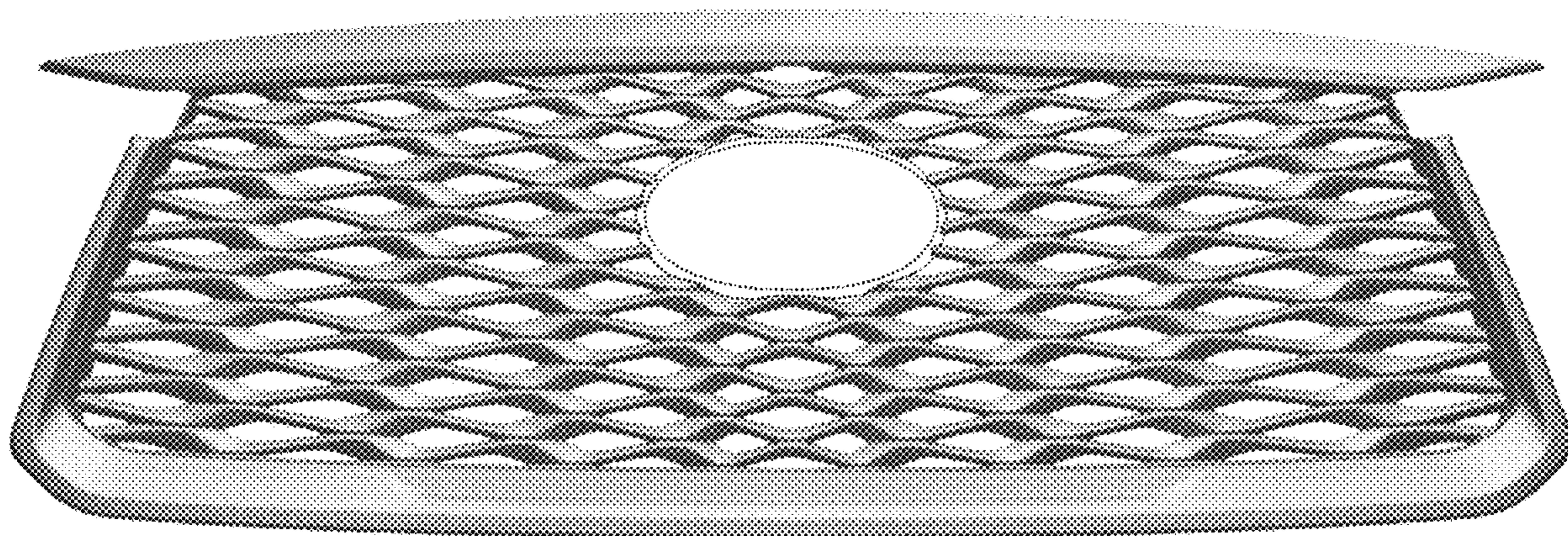
(57) **CLAIM**

The ornamental design for a radiator grille for an automobile, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a radiator grille for an automobile in accordance with our new design;

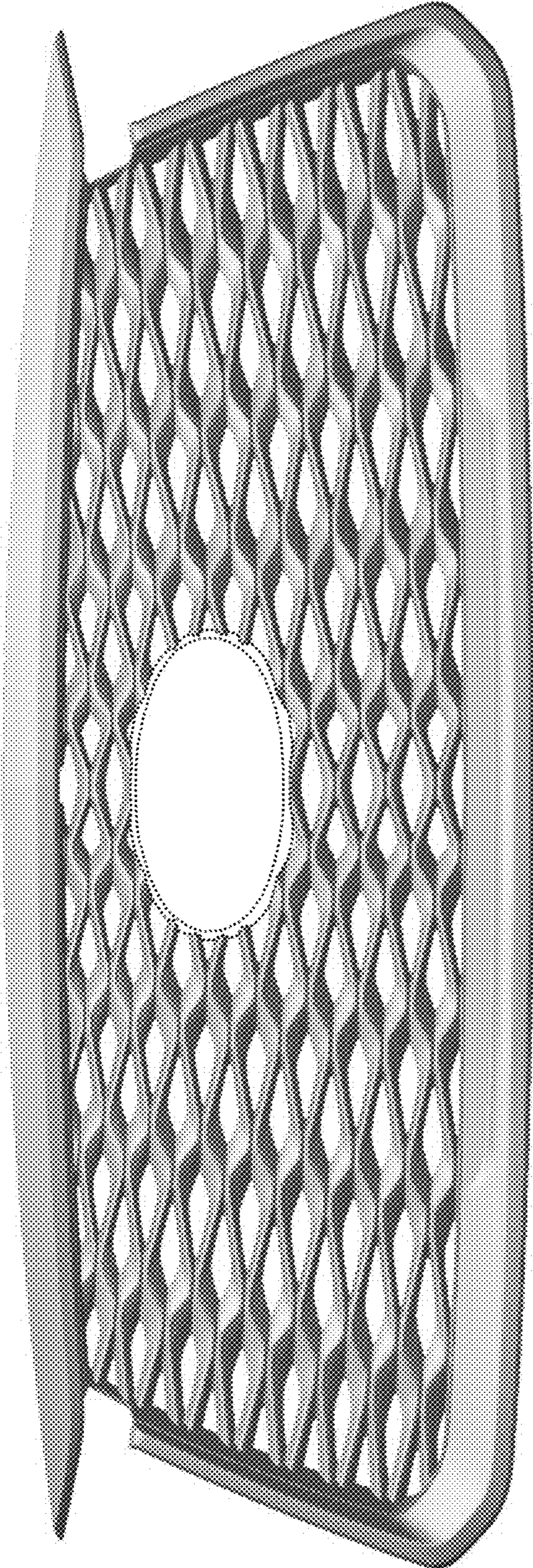

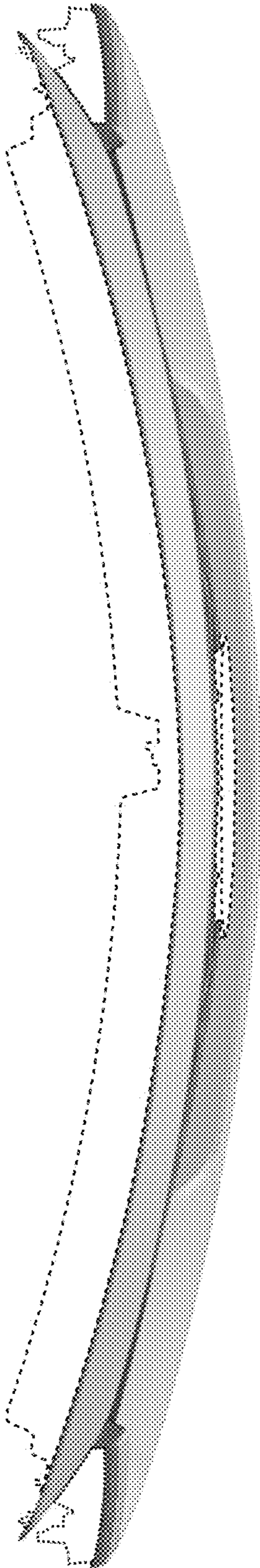

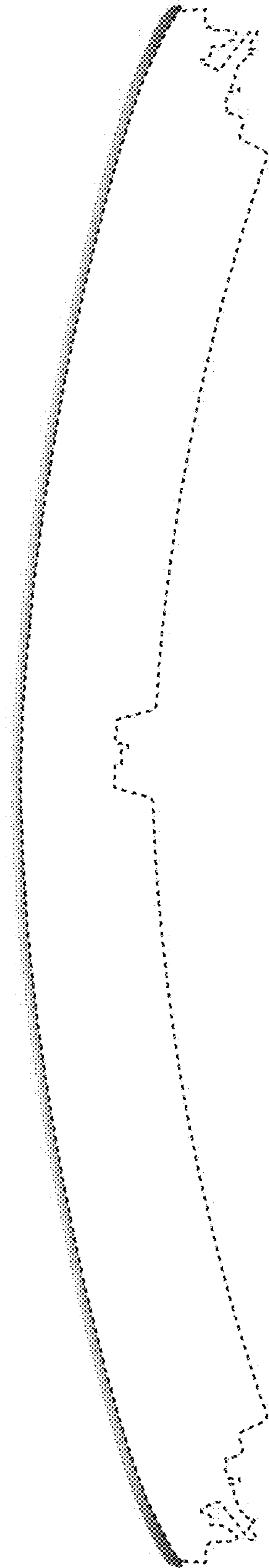

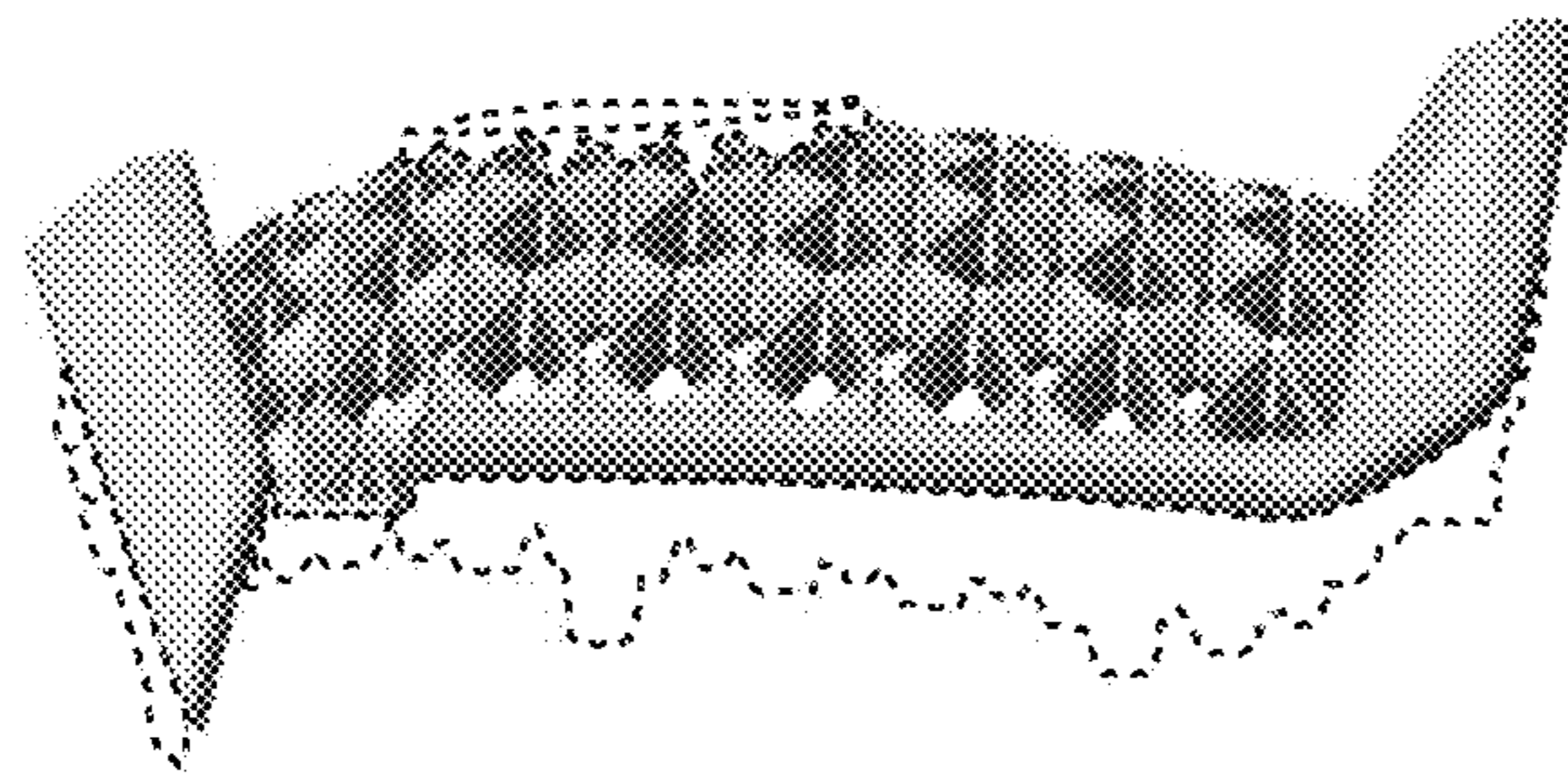

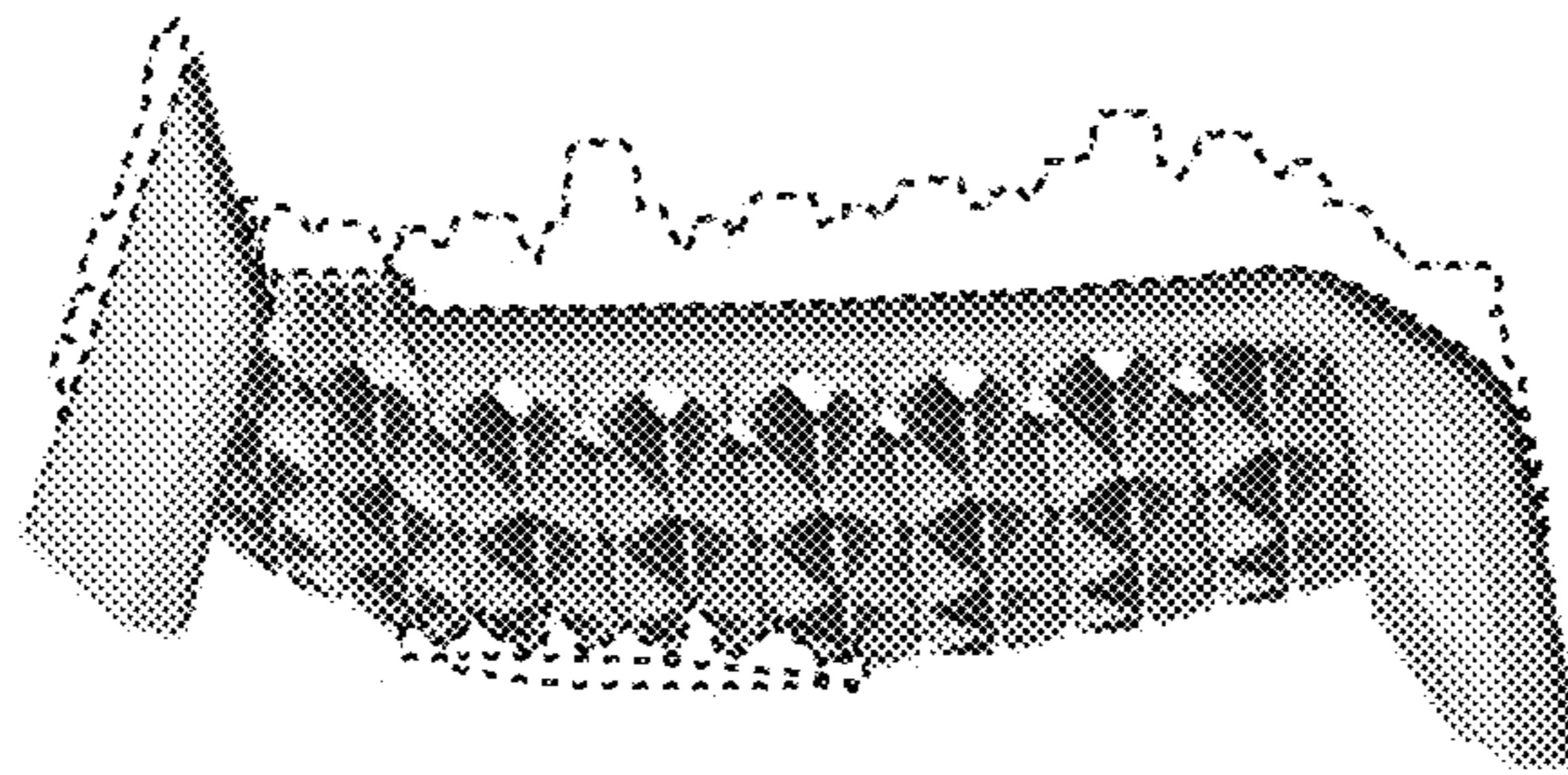

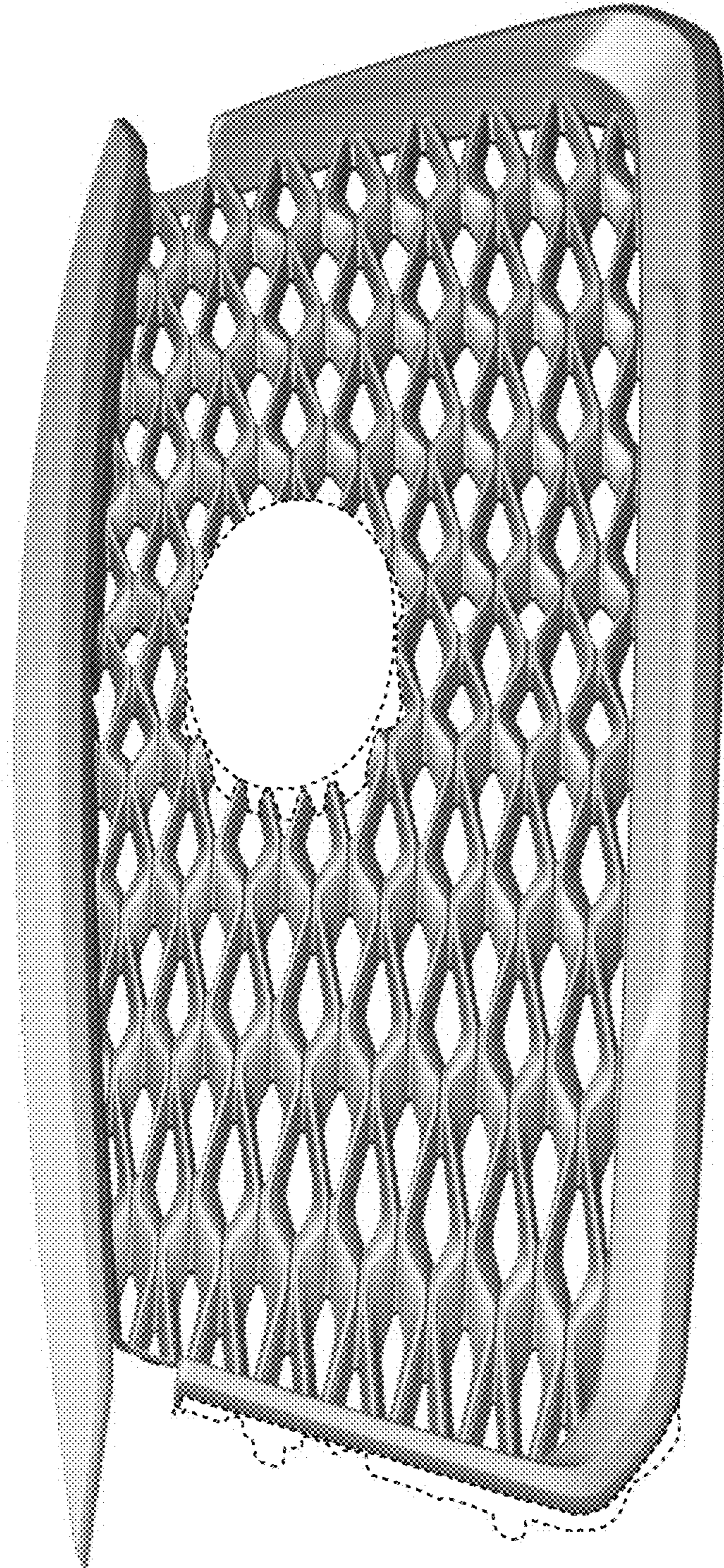

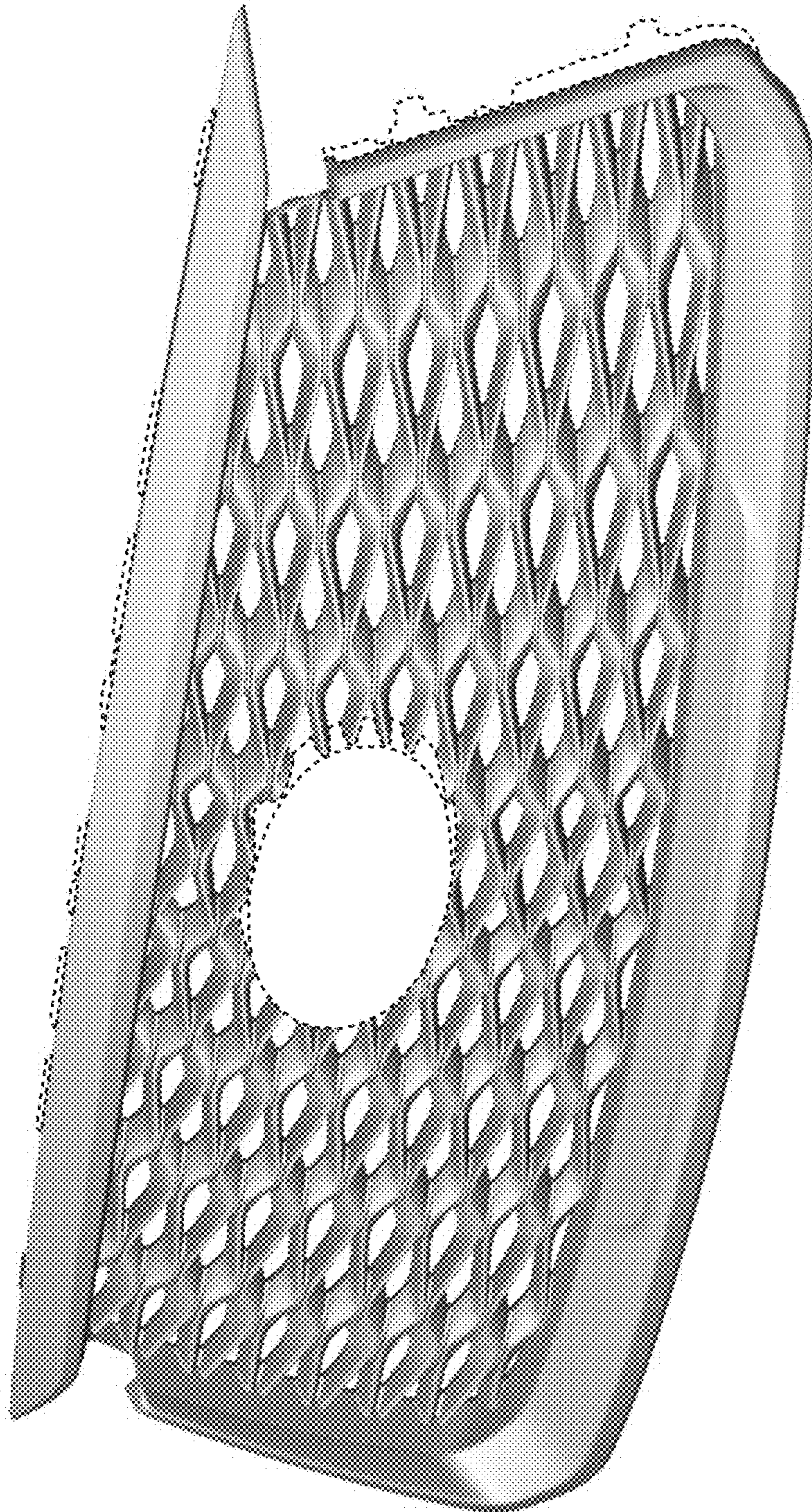
